# Honorary Mayoral Rivals Begin Run

CARMICHAEL, CA (MPG) - Enter the candidates for Carmichael's 2017 honorary mayoralty. The ruthless campaign (money buys all votes) is a Carmichael Chamber of Commerce fundraiser. Continuing the community's recent tradition of female mayors, two local businesswomen are contesting the office.

Michigan-raised Danielle Gourley is mom to a two-year-old son. She began her career as a caregiver and now directs All For You Home Care, a senior assistance agency. Off the clock, the 30-year-old runs "Socks for Seniors," a non-profit that teams with Meals on Wheels. Their efforts last year gathered 1800 pairs of new socks for elderly Sacramento feet.

As mayor, Gourley projects a year of Carmichael promotion. "I shop Carmichael, I dine Carmichael and I take my son to Carmichael events," she says. "I've started a Facebook program to feature businesses and things for people to do here." She also promises support for the homeless and a program of monthly Carmichael street cleanups.

Katie Pexa (54) owns a Farmers Insurance agency. Mother of an adopted son, the Sacramento-raised professional supports the Sierra Forever Families non-profit, volunteering to help parents through adoption processes. She is also an animal rescue activist. A US Navy veteran, former Petty Officer Pexa is committed to helping veterans find employment.

Her mayoral vision includes bringing more businesses to Carmichael, while protecting its parks and community. "Together we can achieve more," Pexa says. She plans an Octoberfest fundraiser at the Milagro Centre, hoping to establish an annual event to unite merchants and community. Protecting Carmichael's parks and community – and addressing its homeless situation -- ranks high among her civic priorities.

# **Detectives Seek Information on** 36-Year-Old Double Homicide Cold Case

SACRAMENTO COUNTY, CA (MPG)

- On Saturday, July 26, 1980, a married couple was brutally murdered in their home located in the 8100 block of Donnawood Way in Orangevale. The victims, John and Christoria Bilkei (66 and 69-years-old respectively), each died as a result of numerous stab wounds. The crime scene indicated there had been a violent physical struggle between the victims and the suspect(s) prior to their murder. Detectives also believe items of personal

property were taken from the couple's residence.

On behalf of the children and grandchildren of John and Christoria Bilkei the Sacramento County Sheriff's Department's Cold Case Team is asking for the public's help in solving this decades old case by identifying the suspect(s) who committed this senseless double murder thirty-six years ago.

vehicles such as garbage trucks.

The contract comes through a corporative agreement with Sacramento Area Council of Governments (SACOG). Through the regional fuel corporative, SACOG enables regional agencies to have competitive access to fuel source. At the request of Sacramento County, SACOG created an addendum to their contract specifically for renewable diesel at a good price point.

"Sacramento County continues to be a leader in our efforts to reduce greenhouse gas and tailpipe emissions," said District 1 County Supervisor and SACOG

Vice Chair Phil Serna. "Working with SACOG, we will take the next step in that regard and fuel our fleets responsibly, and with minimal burden on taxpayers."

"The County fleet has a substantial impact on our region through programs, services and employment," said District 3 Supervisor and SACOG board member Susan Peters. "With the switch to renewable diesel our impact will remain strong in the region, but lessen on the environment."

"We are proud that the regional fuel cooperative with SACOG allows Sacramento County to reduce greenhouse emissions so dramatically with

the use of renewable diesel," said District 2 Supervisor and SACOG board member Patrick Kennedy. "Our goal is to continue to make an impact on our region's environmental health through partnerships with our community."

"Sacramento County has one of the most sustainable public fleets in the country. The move to renewable diesel provides us large and immediate gains in carbon emissions reduction in a fiscally responsible way," said Keith Leech, Chief, Fleet Division & Parking, Sacramento County.

Because Pexa and Gourley are chums, the public won't hear attack ads or nasty politics. "It's not that kind of campaign," says Gourley. "We are business people helping other businesses people. Whoever wins, the whole community will benefit from our efforts."

The Honorary mayoralty includes neither salary nor power. The winner can expect a year of hand-shaking, ribbon-cutting and baby-kissing. "I'm already in

the business of meeting people," confirms Pexa. "I look forward to meeting many more." Both Candidates are committed to separate Alzheimer's-related charities; these will receive a portion of the funds raised by each campaign.

# SB 32 Not Good for Californians, Economy

SACRAMENTO, CA (MPG) - The California Legislature voted to extend greenhouse gas mandates today by passing Senate Bill 32. The measure, if signed by the Governor, would require the California Air Resources Board to impose regulations to ensure statewide greenhouse gas emissions are reduced to 40% (or higher) below the 1990 levels by December 31, 2030. Vice Chair of the Senate Budget Committee, Senator Jim Nielsen (R-Gerber) issued the following statement:

"The government will now have license to dictate the types of ovens, stoves and cars the public can buy.

"Not everybody can afford to nomic and social impacts this

drive an electric car. Our priorities are to put food on the table, and a roof over our heads and maybe, if there's anything left, to save for our family's future.

"Who can say what eco-

sweeping law will have on Californians? This government agency has failed to study the effects of their regulations on our daily lives. To grant them this extraordinary extension of authority for 14 more years will further damage our economy and destroy jobs."

# Bera Urges FDA to Take Action in Response to EpiPen Prices

EpiPens Cost Upwards of \$600 for a Single Prescription

SACRAMENTO, CA (MPG) - On August 25th, 2016, Congressman Ami Bera, M.D. (CA-7) called on the Food and Drug Administration (FDA) to take immediate action to make lower cost alternatives available in response to exorbitantly priced EpiPens from the drug manufacturer Mylan. Currently, EpiPens have a virtual monopoly on the market for emergency allergy attack treatment. In the letter, Congressman Bera asks the FDA to address processes that may limit competition and allow some companies to drastically increase prices. Today, Mylan announced they would offer additional coupons for EpiPens, but have not addressed the underlying cost.

"As a doctor, I know that in the case of an allergic reaction no time can be wasted and we can't allow anything to stand in the way of immediate access to epinephrine." said Bera. "\$600 for an EpiPen is outrageous, and Mylan must be held accountable for their pricing on a life-saving drug. That's why I'm calling on the FDA to make sure that families have other more affordable and safe options to EpiPens so that no one needs to make a choice between paying their bills or having a life-saving drug."







# **Sacramento County DA Reports**

Defendant Convicted for 1st-Degree Murder of Rio Linda Man

Sex Offender Sentenced for Multiple Child Sexual Assault Charges

Two Convicted of 1st-Degree Murder in Birthday Party Shooting

**DATE:** August 23, 2016 CASE: Jacob Wilcoxen

PROSECUTOR: Deputy District Attorney Valerie Brown, Homicide Unit

Jacob Wilcoxen was convicted by a jury of the first-degree murder of Bill Stidman. The jury also found true the allegation that Wilcoxen personally used a firearm causing Stidman's death.

Bill and Jean Stidman lived in their Rio Linda home with their two female teenage foster children. On June 15, 2014, Wilcoxen and a 17-year-old associate went to the Stideman's home with a plan to sneak into the house after the Stidmans went to bed and have sex with the two female teenagers. Mr. Stidman found Wilcoxen in the 14-year-old foster daughter's bed and confronted Wilcoxen. When Wilcoxen attempted to leave, Mr. Stidman, who was a licensed security guard and former police officer, said he was going to arrest him. Wilcoxen then pulled a concealed .38 caliber revolver and shot Mr. Stidman four times, killing him. Mr. Stidman lived long enough to give the first responding deputy basic information, and ask paramedics to tell his wife he loved her.

Wilcoxen faces a maximum potential sentence of 50 year to life in prison. Sentencing is set for October 6, 2016, at 10:00 a.m. in Department 18 before the Honorable Cheryl Chun Meegan.

**DATE:** August 23, 2016 **CASE:** James Hill

**PROSECUTOR:** Deputy District Attorney Laura Froome, Special Assault & Child Abuse

The Honorable Delbert Oros sentenced James Hill to 20 years plus 300 years to life in prison. On July 19, 2016, a jury convicted Hill of four counts of committing lewd acts upon a child. Three prior strike allegations were also found true for three separate counts of committing lewd acts upon a child in 1996. Hill has been registering as a sex offender since that time.

Between January 2014 and March 2014, Hill

was residing with family members at their home in Del Paso Heights. During that time, Hill cornered the young victim in the home and sexually assaulted her on five separate occasions. In March 2014, the victim disclosed the assaults to one of her family members.

**DATE:** August 25, 2016

CASE: Avery Hill, Kelly Thomas & Orlando

PROSECUTOR: Deputy District Attorney Eric Kindall, Homicide Unit

Avery Hill and Kelly Thomas were convicted by two separate juries of first-degree murder with personal use of a firearm and three counts of first-degree attempted murder with the personal use of a firearm. Thomas was also convicted of being a felon in possession of a firearm. Rhinehart was acquitted of all counts.

On May 10, 2014, Orlando Rhinehart was at Peregrine Park in Natomas when he noticed members of the New Money gang were at the park attending a birthday party. Rhinehart called Avery Hill, who New Money gang members suspected of murdering one of their members. Hill then called Kelly Thomas, who believed he had been shot at by New Money members before. Hill and Thomas went to the park and met briefly with Rhinehart, who proceeded to leave. Hill and Thomas then opened fire on the partygoers, killing Jacoby James and wounding six others, including a then 7-year-old girl.

A court trial will be held at sentencing on prior strike allegations for Hill for a 2008 attempted robbery and for Thomas for a 2010 burglary conviction.

If the prior strikes are found true, Hill and Thomas face potential sentences of a minimum of 100 years to life in prison. Thomas will be sentenced on September 16, 2016, at 1:30 p.m. Hill will be sentenced on November 14, 2016, at 3:00 p.m. Both sentencings will be in Department 12 before the Honorable Maryanne Gilliard.



#### A Film Review by Tim Riley **MECHANIC: RESURRECTION** (Rated R)

The studio behind British action star Jason Statham's "Mechanic: Resurrection," tagged with an R rating for "violence throughout," decided not to have an advance screening for critics.

This was probably a wise choice because the Statham action brand, evidently on full-throated display in the "Transporter" and "Crank" series, appeals to an audience indifferent, at best, to the opinions of professional couch potatoes.

I confess to enjoying the guilty pleasure of ludicrous action films that are the trademark of the charismatic Jason Statham. The absurdity of a one man army run amok taking down henchmen and thugs of all stripes can be a lot of fun.

Give credit to the British thespian for actually starring in more creative films such as "Snatch" and "Lock, Stock and Two Smoking Barrels," and that he displayed a knack for comedy in Melissa McCarthy's "Spy."

Even those predisposed to enjoy "Mechanic: Resurrection" must be reminded that Statham's role of assassin-for-hire Arthur Bishop originated in a remake of the Charles Bronson "The Mechanic" just five years ago.

Admittedly, I remember Statham's version of "The Mechanic" but not how it ended. The enjoyment of the sequel won't suffer by failure to have seen the original, where Bishop faked his death to find a new life

Indeed, this new "Mechanic" opens amidst the visually stunning beauty of Brazil's most popular seaside city that even NBC's Olympics coverage could not fully capture on such a grand

Living off the grid, Bishop now goes by the name of Santos, living on a nice boat he's only too willing to blow up if necessary to escape the clutches of nefarious actors seeking his

To be expected, trouble comes looking for him in the form of a femme fatale, dressed ominously in black, who interrupts his quiet meal at his favorite outdoor restaurant perched on a cliff high above Rio.

The mystery woman arrives with a proposition from an international arms dealer named Crain (Sam Hazeldine) that requires his services to eliminate three targets of dubious value to civil society.

To show his displeasure with an unwanted offer, Bishop is forced into the first of a series of hand-to-hand combats with a legion of henchmen that are easily dispatched while the restaurant suffers major damage.

Now that he is no safer than the average resident of a favela, Bishop relocates to a scenic, remote island in Thailand where the blue skies, clear water and sandy beaches prove most welcoming.

It is here that he reconnects with old colleague Mei (Michelle Yeoh) who now caters to the tourist trade. Bishop soon becomes enamored with a pretty, mysterious young woman named Gina (Jessica Alba) who has escaped a bad relationship.

What Bishop doesn't know is

that Gina is an unwilling pawn in Crain's sick game to get Bishop to commit to staging the deaths of three villainous people for reasons not immediately clear.

To raise the stakes, Crain has Gina kidnapped so that he can extort Bishop in carrying out the assassinations lest something terrible happen to the new love interest who only wants to get back to running an orphanage in Cambodia.

The first victim is an African warlord locked up in a prison more remote and inaccessible than Alcatraz. Bishop's job is to infiltrate the prison, make the death look accidental and then manage an impossible escape.

At this point, "Mechanic" is being to look inspired by the old "Mission: Impossible" television series, where nifty gadgets, sleight-of-hand and a huge measure of cunning and guile are required to complete the objective.

What comes next is a visit to Sydney to orchestrate the accidental demise of a vile human trafficker surrounded as usual by an army of bodyguards and ensconced in an impenetrable fortress in a high-rise penthouse.

The film's most unique ploy is how a cantilevered swimming pool protruding high above the city streets factors into an elaborate scheme of staging an amazing catastrophe.

The best victim is saved for last, this one being an arms dealer hiding out in Bulgaria in the type of villain's lair one would expect to find in a James Bond film. Indeed, Tommy Lee Jones, looking an aging rocker, shows up as a better match for

Despite the fact that he is, after all, a killer for hire, Bishop comes off the hero because he just happens to be eliminating some really, really bad people. And besides, he's always the good guy, even if compromised.

"Mechanic: Resurrection," though perhaps an imperfect vessel, is still fueled by the formula of high-octane action that makes just about any Jason Statham gritty action film something to be enjoyed on a B-movie level. ★



option, you set yourself up for a garage sale project with a mountain of pricing or a bunch of time spent on craigslist.org, both of which requires a lot of followthrough and dedication to the task.

There are different categories of clutter, but they all nag, taunt, shame, badger, heckle, scoff, jeer, and pester. You've tried to organize some of it, but most of it just gets moved around. Trying to organize clutter is like trying to get a bunch of tone-deaf people together to start a choir. You can't clean when you have clutter because you can't find your surfaces. So your house gets dirty.

Clutter is also insidious. If it's left in one place for more than 21 days, it becomes invisible and it lowers its volume, becoming white noise in the background to which you become accustomed. Have you ever noticed the relief you feel when that white noise gets turned off? Your ears are suddenly enveloped by a silence you didn't even know you were missing! You'll get that same relief when you deal with your clutter. You'll be amazed at the peace you'll feel that you didn't even know was possible!

Take a few minutes and look around you. Let what you see speak to you. Where is the most noise coming from? What's clacking the loudest? What's drumming in the background, more quietly, yet persistently? By using your imagination to add make-believe sound to your clutter, you are actually sharpening your awareness of what you want to kick out or make a place for.

You'll also begin shopping with a new awareness. Everything you bring into your home has a voice. Have fun with this new awareness. Talk back to your stuff and warn it of its pending eviction, and ask everything that comes into your life if you need it and love it. If you don't buy it, it can't talk to

is fun and enlightening. There are also those tired voices of stale, outdated ideas from a stack of old magazines, chanting, "Read us read us! See what you missed in 2006!" We keep old magazines because we paid for them, haven't read them, don't want to miss anything, and we think we'll actually take the time (at some point) to peruse their pages. Chances are really good you have last month's magazines sitting there unread too, and they're at least still current possibilities. So dump anything that's outdated. If you're still feelInternet, all the old information is archived online. Google it.

Another voice of clutter comes from the homeless. That's all the stuff you love and use, but don't have specific places to put it. It's probably stuff you've had to look for in the past. You'll catch yourself saying, "Oh, there you are! I was looking for you yesterday." Just think how much time you spend each year looking for stuff! (It's probably at least a couple of days.) It seems easier at the time to just put those items down somewhere, or out of sight in a drawer, because there's not a dedicated place to put it.

To quiet the noise from your homeless stuff, you have to establish homes for each individual voice. Cramming a voice in the wrong closet, drawer, or cupboard, the basement, the attic, or under a bed, is like hushing a gossip and putting him or her out of sight. Clutter shoved out of sight may go out of mind, but the minute you open a drawer or closet that holds an assortment of muzzled clutter, you'll be like Britney Spears opening her front door to a mob of ravenous paparazzi. It isn't pretty.

for everything and everything in its place," we'd never have to search for our glasses, car keys, purse, coat, cell phone, shoes, scis-

sors, or tweezers again. Included in the homeless clutter is what I call IPODs—Important Piles Of Decisions. These IPODS are in strategic places throughout your home where you chronically dump your indecision. They are piles of miscellaneous items that you didn't want to put away either because there was no "away" or because you were tired or just didn't want to deal with them at the time. Piles are very personal and we don't like to talk about them, but they need to be cured if we are to enjoy a peaceful home not one that's out of order.

You're not out of order when your house is in order. Start listening.
