# Hooked on Buttons

**CARMICHAEL, CA (MPG)** - Some of the most eye-popping antiques are also the smallest. At the California Button Society's May 2st1 and 22nd expo in Sacramento, you might snag a Civil War tunic fastener for under \$50. If you lust for Gainsborough-style portrait pieces, be prepared to unbutton your billfold. Via such nubbins, artisan glory of centuries past will be displayed in miniature.

And if you just want a button to replace one that popped off a shirt, one of 25 vendors will surely have a deal for you.

What astonishes at such bazaars is among poke-tray plastic bargains — the availability of seriously old stuff. A 1700s painted dog under glass bears a \$1000-plus tag. Snipped from long-ago rotted garments, such are thumb-nail masterpieces. Gemcrusted, some might have bribed Bastille guards during the French Revolution.

We often look at old buttons and imagine the stories they could tell," says Button Club treasurer Susan Rhoades. Georgian dandies risked having exquisite furbelows snatched from their vests in the streets.

They were traded, stolen and handed down in families. Says Rhoades: "Lives were lost in making them; pearl dust is toxic and mercury (for gold plating) killed many. "You learn so much about history, art and manufacturing from buttons.

At first ornamental, the ingenious use of buttons to keep cloth in check came to Europe with returning Crusaders. Manufacture took off. Mediaeval guilds protected

button makers and master artisans were sought by popes and princes. With servants to hook them up, the rich sported hundreds of buttons per garment. Portraits, pets and landscapes were painted on the tiny tidbits. Pearls, gold or diamond buttons studded stomachers. No material was too grand for the button makers' art. When the widowed Queen Victoria took to wearing jet specimens, society followed. Black cut glass is still in haute button vogue.

Through poppers, zippers and Velcro revolutionized 20th century fastening, nifty little buttons have never been undone. "People come to our show seeking that one perfect item," says Fave Wolfe. "One lady brought a vest she'd sewn: she wanted matching buttons in front. In the end, she chose four, each quite different. Who says they have to match? Our button world is full of eccentricity.'

# **Governor Brown Issues Order to Continue Water** Savings as **Drought Persists** Executive Order Aims to Make Water

Conservation a Way of Life in California

SACRAMENTO REGION, CA (MPG) - Moving to bolster California's climate and drought resilience, Governor Edmund G. Brown Jr. recently issued an executive order that builds on temporary statewide emergency water restrictions to establish longer-term water conservation measures, including permanent monthly water use reporting, new permanent water use standards in California communities and bans on clearly wasteful practices such as hosing off sidewalks, driveways and other hardscapes.

"Californians stepped up during this drought and saved more water than ever before," said Governor Brown. "But now we know that drought is becoming a regular occurrence and water conservation must be a part of our everyday life."

Californians have responded to the call to conserve water during the drought by dialing back sprinklers, replacing lawns, fixing leaky faucets, and installing more efficient toilets and washing machines. Between June 2015 and March 2016, Californians reduced water use by 23.9 percent compared with the same months in 2013 — saving enough water to provide 6.5 million Californians with water for one year.

While the severity of the drought has lessened in some parts of California after winter rains and snow, the current drought is not over. For the fifth consecutive year, dry conditions persist in many areas of the state, with limited drinking water supplies in some communities, diminished water for agricultural production and environmental habitat, and severely depleted groundwater basins. The executive order calls for long-term improvements to local drought preparation across the state, and directs the State Water Resources Control Board to develop proposed emergency water restrictions for 2017 if the drought persists.

California droughts are expected to be more frequent and persistent, as warmer winter temperatures driven by climate change reduce water held in the Sierra Nevada snowpack and result in drier soil conditions. Recognizing these new conditions, the executive order directs permanent changes to use water more wisely and efficiently, and prepare for more frequent, persistent periods of limited supply.

These new actions will help achieve a top priority in the Governor's Water Action Plan to "Make Conservation a California Way of Life." The administration will seek public input in the coming months on new water conservation and efficiency standards called for in this executive order.



# Birds of Saudi Arabia Topic at Next Audubon Meeting

SACRAMENTO REGION, CA (MPG) - If you're curious about the birds of Saudi Arabia, the best — perhaps the only — place to see them is at the May 19th meeting of the Sacramento Audubon Society.

Tourist visas are not issued by the Saudis, and few birders live or work there, according to Speaker Lou Regenmorter, who spent most of his spare time birding while working as an engineering consultant on a flood control project in Saudi Arabia.

The kingdom, five times the size of California, is not just a big desert, he points out. It has acacia savannahs, mountain juniper forests, rocky escarpments and plateaus, and expansive coastal areas. Fresh water is scarce, but there are a few reservoirs, farming operations, and wastewater wetlands that provide an additional bit of man-made habitat.

And there are lots of birds. In the three and a half years he was there, Regenmorter tallied 340 species, and that's still short of what could be found, he notes.

Resident birds include at least 10 species found only on the Arabian Peninsula, he reports. There are migrants and winter visitors from Europe and Asia, summer residents from Africa. Other special birds found in the kingdom include large populations of resident Crab Plovers and wintering Grey

Hypocolius, and a number of wintering Sociable Lapwings, a critically endangered bird.

The public is invited to the 7 p.m. meeting at the Effie Yeaw Nature Center in Ancil Hoffman Park (For directions, see sacnaturecenter.com).

There will be no charge for the program, and no park entry fee.

## **Raley's and iFoster Celebrate First Anniversary of Foster Youth Hiring Program**

Over 100 Foster Youth Hired as a Result of Initial Partnership

SACRAMENTO REGION, CA (MPG) - In conjunction with Foster Care Awareness Month, Raley's Family of Fine Stores and iFoster commemorated one year of hiring foster youth by hosting 1,000 foster youth at the River Cats game at Raley Field on Saturday evening. The event marked the largest group of foster youth ever assembled for such a celebration.

"We are so grateful to Raley's for being the first company to work with iFoster to develop our training program and hiring our youth," said Serita Cox, Executive Director of iFoster. "We are expanding to other companies and regions as quickly as we can to meet demand, both from foster youth seeking permanent employment and employers seeking pre-qualified, eager to work talent."

In the past year, Raley's has hired 17 foster youth, with several more candidates

currently under consideration. Subsequently, 10 companies have joined Raley's in employing foster youth who are aging out of the system, resulting in gainful employment for over 100 youth in Placer and Los Angeles Counties, with a 100 percent hiring success rate and 90 percent retention rate through their first 6 months on the job. Nine more companies are in the process of joining the program.

"We challenge other retailers to join the Foster Youth Hiring Program! It's a win-win for the youth and business," said Mark Foley, Raley's Senior Vice President of Human Resources & Labor Relations. "Providing employment opportunities to these young people is enhancing our workforce with dedicated, hardworking employees who in turn, inspire their fellow team members."

Many emancipated foster youths lack a supportive network

of adults. Within the first 2 to 4 years after "aging out" of the system, an estimated 50 percent of these young adults are unemployed, 70 percent are on public assistance and 50 percent will experience homelessness.

The foster youth hiring program reaches beyond giving foster youth and their families a life changing opportunity. For every youth put on the path to independence, the program saves society an average of \$1 million in lost contribution.

May is National Foster Care Month, a month set aside to acknowledge foster parents, family members, volunteers, mentors, policymakers, child welfare professionals and other members of the community who make a meaningful difference in the lives of the nearly 400,000 children and youths in the foster care system.







# Sacramento County **DA Reports**

Defendants Include Couple Found Guilty of Second-Degree Murder of 1-Month-Old Son

CASE: Terry Scott & Ashleigh Smith PROSECUTOR: Deputy District Attorney Jeff Hightower, Homicide Unit

Terry Scott and Ashleigh Smith were convicted by jury of second-degree murder and assault on a child causing death.

Scott and Smith chronically abused their son, Tyrese, since his birth on April 26, 2014, until his hospitalization on July 24, 2014. Tyrese struggled to survive for two days before succumbing to his injuries. Tyrese had multiple brain traumas, 10 broken ribs in different stages of healing, eyeball hemorrhages, and a hemorrhaged testicle.

Scott and Smith face a maximum potential sentence of 25 years to life in prison. Sentencing is set for June 10, 2016, at 9:00 a.m. in Department 15 before the Honorable Kevin McCormick.

CASE: Quoc Pham & Amro Farhat PROSECUTOR: Deputy District Attorney Sonia Satchell, Human Trafficking

Twenty-eight-year-old Quoc Pham was convicted by jury of human trafficking, pimping a minor, and pandering a minor. Twenty-eight-year-old Amro Farhat was convicted of pimping a minor, pandering a minor, two counts of oral copulation of a minor, child pornography, and unlawful sexual intercourse with a victim more than three years younger.

The 16-year-old victim was a runaway from Contra Costa County. She came to Sacramento with a friend, who introduced her to Pham. Pham forced her to work as a prostitute on the stroll. He then took her to meet his friend, Farhat. Farhat took pictures of the victim and posted a prostitution advertisement on a website. Farhat also booked a room at the Travelodge so the victim could do dates. The victim was able to call her

mom, who contacted law enforcement.

Pham faces a maximum potential sentence of 14 years, 8 months in prison. Faraht faces a maximum potential sentence of 8 years in prison. Sentencing is set for May 26, 2016, at 4:00 p.m. in Department 14 before the Honorable Donald Currier.

**CASE:** Ernest Salmons

PROSECUTOR: Deputy District Attorney Thomas Asker, Homicide Unit

The Honorable Ernest Sawtelle sentenced Ernest Salmons to 15 years to life in prison. On March 8, 2016, a jury convicted Salmons of second-degree murder.

Salmons was cellmates with Edward Larson at the Sacramento County Jail. On December 14, 2014, Salmons informed jail staff that Mr. Larson was not moving. Mr. Larson was cold to the touch and stiff. Medical personnel responded immediately, but efforts to revive Mr. Larson were futile. There was no apparent evidence of a struggle or blood in the cell. When the cell was processed with a latent blood reagent, significant blood traces were revealed, including a large pool of blood on the floor along the wall next to the bunk. Blood collected and tested by the District Attorney's Crime Lab confirmed it was Mr. Larson's blood.

The coroner concluded Mr. Larson died from blunt force injuries inflicted by an assault. Among other injuries, Mr. Larson suffered lacerations to the liver, and sustained nine broken ribs on his right side and seven broken ribs on his left side.

In an interview with detectives, Salmons indicated he slapped Mr. Larson twice with an open hand and kicked him once. He stated Mr. Larson hit his head a few times by his own volition.

# Small Business Employment Weakens in April

## NFIB Data Shows That Small Business Owners Are Trying to Hire, but Cannot Find Qualified Workers

large portion of small business owners reported that they were hiring or trying to hire, yet job creation turned slightly negative in April, according to the Jobs Report released today by the National Federation of Independent Business (NFIB).

"For the first four months of 2016 job creation has been stagnant," said NFIB Chief Economist William Dunkelberg. "Month after month we see no strong direction in our jobs report. This month hiring activities increased, but apparently applicants are not qualified for the open positions."

NFIB/CA State Executive Director

SACRAMENTO REGION, CA (MPG) - A Tom Scott added, "This is troubling news for small businesses especially here in California. Facing a shortage of qualified workers, small businesses will see labor costs increase, further adding to the cost of doing business in this state."

> The average employment change during the month of April decreased to an average loss of 0.08 workers per firm. Twelve percent reported increasing employment an average 2.2 workers per firm while 13 percent reported reducing employment an average of 3.5 workers per firm. Up 5 points, 53 percent of owners reported hiring or trying to hire. Of those trying

to hire, 87 percent reported few or no qualified applicants for the positions that they were trying to fill. Twelve percent of owners cited the difficulty of finding qualified workers as their Single Most Important Problem, a high reading for this recovery. Twentynine percent of all owners reported job openings that they could not fill in the current period, which is up 4 points. A seasonally adjusted net 11 percent plan to create new jobs, up 2 points from

"For several months, owners have been reporting that finding qualified workers is the third 'Single Most Important Business Problem' behind taxes and government regulations and red tape," Dunkelberg continued. "Small business owners want to hire and that is clear from our data, but they're scrambling to find applicants to fill open positions."

He also predicts that the April jobs number will remain weak, close to the 200,000 mark with little change in the unemployment rate.

NFIB's April Jobs Report is based on the NFIB monthly Small Business Economic Trends survey. The survey was conducted in April and reflects the response of 1644 small businesses. The full Small Business Economic Trends report will be released on Tuesday, May 10th. For more than 70 years, the

# The Fuzzy Accounting Behind Renewable Energy's Falling Prices

Fans of the renewable energy industry like to boast that the costs of solar and wind power are dropping. What they never mention is where most of those "savings" are coming from — American taxpayers.

Just listen to President Obama's most recent State of the Union address: "Wind power is now cheaper than dirtier, conventional power [and] solar is saving Americans tens of millions of dollars a year."

The American Wind Energy Association claims "wind energy is one of the most affordable forms of electricity today." And the Solar Energy Industries Association proudly notes that "the cost to install solar has dropped by more than 73 percent."

But these stats only show one side of the ledger. According to the U.S. Energy Information Administration, federal subsidies — including direct expenditures. tax breaks, and research and development — for solar power totaled \$5.3 billion in 2013, the most recent year of data. Wind power pocketed \$5.9 billion. Combined, renewable largesse grew nearly 40 percent between 2010 and 2013.

Now that Congress has renewed the Production Tax Credit for wind energy, taxpayers will be on the hook for supporting renewables for years to come.

Renewable energy defenders point out that fossil-fuel producers are also subsidized by the federal government. But those subsidies are miniscule compared to wind and solar. In fact, the government now subsidizes solar 345 times more than coal, natural gas, and oil. Wind is subsidized over 52 times more than the more conventional fossil fuels.

And that's just at the federal level. State and local governments provide lots of tax breaks and other economic support for renewables

Researchers at North Carolina State University track 40 different state and local clean energy programs. The Center identified 1,261 rebate provisions, 84 property tax incentives, 52 sales tax incentives, 42 personal tax credits, and 9 tax deductions. In addition, the Center found 49 laws requiring electricity companies to incorporate renewable energy.

On top of that, ratepayers may be forced to pay more for their

Such tax breaks, subsidies and mandates mask the true cost of renewable energy. Economists at Utah State University confirmed this last year, writing, "Because federal and state subsidies are intrinsic to the success of wind energy, calculations that do not include subsidies return a cost of wind energy that is artificially low."

The existence of this vast

subsidy system prompts an important question: Could wind and solar survive on their own?

Warren Buffet doesn't think so: "[O]n wind energy, we get a tax credit if we build a lot of wind farms. That's the only reason to build them. They don't make sense

without the tax credit." Proponents counter that the wind and solar industries create jobs. According to the Solar Foundation, the number of solar jobs in the United States reached 208,000 in 2015. The American Wind Energy Association claims its industry employs 73,000

But those figures pale in comparison to oil and gas employment, which supports 9.8 million jobs. And that figure doesn't account for all the fossil-fuel positions that wind and solar have eliminated because electricity generators are forced to switch from fossil fuels to renewables

Before wind and solar advocates boast about how affordable their preferred energy sources have become, they need to factor in the massive taxpayer largesse propping up the renewable industry. After accounting for both sides of the ledger, anyone can see that renewables cost far more than they


# **Governor Brown Announces Appointments**





# Governor Brown Issues Order to Continue Water Savings as Drought Persists

#### **Use Water More Wisely**

The Department of Water Resources (DWR) and the State Water Board will require monthly reporting by urban water suppliers on a permanent basis. This includes information regarding water use, conservation and enforcement. Through a public process and working with partners such as urban water suppliers, local governments and environmental groups, DWR and the State Water Board will develop new water use efficiency targets as part of a long-term conservation framework for urban water agencies. These targets go beyond the 20 percent reduction in per capita urban water use by 2020 that was embodied in SB X7-7 of 2009, and will be customized to fit the unique conditions of each water supplier.

The State Water Board will adjust emergency water conservation regulations through the end of January 2017, in recognition of the differing water supply conditions across the state, and develop proposed emergency water restrictions for 2017 if the drought persists.

#### Eliminate Water Waste

The State Water Board will permanently prohibit wasteful practices, such as hosing off sidewalks, driveways and other hardscapes, washing automobiles with hoses not equipped with a shut-off nozzle, and watering lawns in a manner that causes runoff. These temporary prohibitions have been in place since emergency water conservation efforts began in July 2014.

The State Water Board and DWR will take actions to minimize water system leaks across the state that continue to waste large amounts of water. DWR estimates that leaks in water district distribution systems siphon away more than 700,000

# **Pedestrian** Dies After Reind Hit Iu Crosswalk

CARMICHAEL, CA (MPG) - On May 7th, 2016, at approximately 11:42 pm, Bakari Deante Stafford (23) of Sacramento was driving a 2000 Ford Explorer southbound Watt Avenue, north of Marconi Ave. at a high rate of speed. Jesse Thomas Hill (27) was walking eastbound in the south crosswalk of the intersection of Watt Ave. and Marconi Ave. Mr. Stafford attempted to make a left turn in the Ford to eastbound Marconi Ave. and lost control of the vehicle. The vehicle spun out of control in a southerly direction and struck Mr. Hill as he walked in the crosswalk. The vehicle continued out of control, struck the raised center median and rolled over several times before coming to rest in a parking lot on the southeast corner of the intersection. Mr. Hill sustained fatal injuries and died at the collision scene. Mr. Stafford was transported to UC Davis Medical Center with minor injuries.

#### Strengthen Local Drought Resilience

In consultation with urban water suppliers, local governments, environmental groups and other partners, DWR will strengthen standards for local Water Shortage Contingency Plans, which are part of the Urban Water Management Plans that water districts must submit every five years. Under new strengthened standards, districts must plan for droughts lasting at least five years, as well as more frequent and severe periods of drought. These plans must be actionable, so that districts can turn to them to guide their drought response.

For areas not covered by the Water Shortage Contingency Plan, DWR will work with counties to improve drought planning for small water suppliers and rural communities.

#### Improve Agricultural Water Use Efficiency and Drought Planning

DWR will update existing requirements for Agricultural Water Management Plans so that irrigation districts quantify their customers' water use efficiency and plan for water supply shortages.

Current law requires agricultural water districts serving 25,000 acres or more to file such plans. The executive order increases the number of irrigation districts who

must file water management plans by lowering the threshold to irrigation district serving 10,000 acres or more. DWR will check the plans to ensure they quantify conservation efforts and adequately plan for water shortages.

DWR will work with the California Department of Food and Agriculture in seeking public input on the updated standards, with a public draft made available by the end of this year.

To ensure compliance with these new targets and water management plan requirements, DWR, the State Water Board and the California Public Utilities Commission will work together to develop methods which could include technical and financial assistance, regulatory oversight and enforcement mechanisms.
