CARMICHAEL, CA (MPG) - Carmichael Elks Lodge presents their fourth annual Classic Car Show. This event will roll in the classic collectors — vintage years 1919 through 1975. Make sure to fuel up beforehand, as the event will rev its engine from 8 a.m. to 2 p.m.

test, from many of the local car clubs, for your viewing pleasure. This year, the Lodge anticipates more than 100 cars will be scattered throughout the property, as well as various car parts and merchandise vendor booths.

For early-birds that want to enter their cars and get the best shady parking spots, it is recommend that you arrive at sunrise — parking starts at 7 a.m., but the motto

at the show is "those who arrive together park together." Some show up well before 7 a.m., others arrive much later. Just be sure to be there by 10 a.m., as events start then. The gates open to the public at 8 a.m. Lunch starts around 11:30 a.m., and judging around 1:30 p.m.

Speaking of lunch, one of the coolest vendors in town, Drewski's Hot Rod Kitchen, will be serving up delicious eats. The Hot Rod Kitchen will whet appetites with their famous tots served with rosemary and garlic, their pulled pork mac n' cheese will also be on the menu, along with their must have S'moreski (a whipped marshmallow, Nutella, graham cracker, mouthwatering combo). This is the first year the Hot Rod

Kitchen will be at the show, and it's sure to be a highly appreciated addition.

While early registration for cars has already passed, you can register all the way up to the day of the event. Day of show entrants pay the \$5 regular Continental breakfast price, including coffee service.

The purpose of the show is to raise funds for the Lodge Beautification Project that will allow the Carmichael Elks to increase memberships and provide more capacity to hold charitable events for the benefit of the community. All cash donations and/or unique raffle prize donations are gratefully accepted! Last year, donated bottles of wine and spirits were raffled off and that raffle netted \$100 for the Lodge's fund!

Raffle prizes, guessing games, 50/50 drawing, and kids' activities all make this event a fun time for the whole family. This year, the show will have a "Guess the Running Time" game, where a VW engine will be ran without oil in it. It's Pothole "Sweep" Time Again



There are over 5,200 lane miles of paved roadways in the County's unincorporated area and it's inevitable that somewhere in this large infrastructure of streets there will be potholes.



The Sacramento County Department of Transportation (SACDOT) will start its "Spring 2016 - Pothole Sweeps Week," on Monday, April 18th, 2016. This is an intensified effort to identify and repair potholes, and is part of continuous efforts to improve preventative maintenance activities for unincorporated area roadways. Pothole sweeps weeks are performed twice each year: in late spring to repair potholes caused by inclement weather; and in early winter to ready road surfaces for the storm season.

Residents are encouraged to contact Sacramento County concerning potholes on neighborhood streets. To report a pothole residents can call 311 (or 875-4311) or report online at www.311.saccounty.net. This County-wide effort will begin in the Arden Arcade community -- which is the center of our service area -- and will continue through the remainder of the unincorporated area.

There are over 5,200 lane miles of paved roadways in the County's unincorporated area and it's inevitable that somewhere in this large infrastructure of streets there will be potholes. SACDOT's policy is to: "Repair all potholes as soon as possible." The Pothole Sweeps Week program enhances ongoing pavement maintenance activities, which include SACDOT crews who are sent into the field Monday through Friday each week to specifically repair potholes. Some facts about potholes in Sacramento County:

- •Potholes Reported To Customer Service Annually = 970.
- •Potholes Repaired Annually = 41,000.
- •Potholes Repaired Per Month = 3 400
- Annual Cost for Pothole Repair
 = \$2.8 million.
 Square feet of potholes repaired
- annually = 94,000. •Repair Cost Per Square Foot =
- \$30.
- Repair cost per pothole = \$68.
 Reported potholes are typically repaired within 72 hours



CHP Officer Critically Injured After Assault With a Vehicle

SACRAMENTO REGION, CA (MPG) - On April 7th, 2016, at approximately 1:05 pm, North Sacramento CHP Motorcycle Officer Michael Ericson encountered a 2001 Ford F350 pickup truck in the center divider of westbound Interstate 80, east of Madison Ave. The driver intentionally assaulted Officer Ericson with the 2001 Ford F350 pickup truck and fled the scene.

The pickup truck was abandoned in a construction zone westbound I-80, near Northgate Boulevard where a second pickup truck was stolen. The driver again fled westbound I-80 where CHP officers located and initiated a pursuit of the stolen pickup truck. As the pursuit

traveled through Solano County, CHP deployed a spike strip disabling a rear tire. The suspect stopped the stolen pickup truck on westbound I-80, east of Lyon Road, where he vas taken into custody by CHP

The suspect was identified as Austin Barry Scott, 28 years of age, of Reno, Nevada. He was transported by ambulance to the North Bay Medical Center. Scott exhibited the symptoms of drug intoxication at the time of the arrest. It was determined the 2001 Ford pickup truck, used in the assault on Officer Ericson, was reported stolen in Reno, NV on 4/7/2016. Following a medical clearance, Scott was transported for questioning by investigators and subsequently booked into Sacramento County Jail on the following charges:

As a result of this assault, Officer Ericson sustained major injuries and was transported by air ambulance to U.C. Davis Medical Center. At this time, he is in critical condition. Officer Ericson is a 17 year veteran of the CHP. He has worked in San Francisco, Napa, Solano, and North Sacramento. He has been assigned to the North

Disney's Latest 'Jungle Book' an Instant Classic

SACRAMENTO REGION, CA (MPG) - If it was paid to just an animated Disney classic, respect from the new live-action adaptation of "The Jungle Book" would be impressive enough. But under the tender, loving care of director Jon Favreau ("Elf," "Iron Man"), the latest remake procreated by Walt Disney's golden vault generously hands out nods of admiration and deference to other source

Foremost is Rudyard Kipling's cherished collection of stories. Dating back to 1893, these tales introduced readers to the adventures of Mowgli, an abandoned "man-cub" who is raised by wolves in the Indian jungle. Secondarily are the countless species of animals that adhere to what the Bombay-born English writer called the "law of the jungle," a general moral code to maintain order in the wild.

Innumerable as adaptations of the Indian jungle-set adventure are, film-wise as early as 1942, the world should make room for at least one more. The blend of CGI animals and landscapes with a real-life Mowgli (newcomer Neel Sethi, the film's only non-animated character) is not



only seamless, but the fact that the entire movie was "filmed in downtown Los Angeles," as a title card at the close of the end credits reads, makes this wildly entertaining, fast-paced picture even more

Fans of Disney's beloved 1967

animated treasure should rejoice; the new iteration isn't one of those cash cow-exploiting modernizations, but a high-tech homage to the family movie that gave us such classic tunes as "The Bare Necessities," "Trust in Me," and "I Wan'na Be Like You." In fact, each

of those songs is dusted off in one fashion or another — maybe not as magically and comically as when fun-loving Phil Harris, slithering Sterling Holloway and swinging Louis Prima lent their pipes, but Bill Murray, Scarlett Johansson, and Christopher Walken fit in nicely for a darker, more realistic version right for these times.

Perhaps "The Jungle Book" (opened April 15th) can thank "The Lion King" for preparing

audiences for a less-silly version of what we grew up with. A flashback of when Mowgli becomes orphaned at the claws of merciless Bengal tiger Shere Khan (Idris Elba) is similar in nature to when Simba loses his dad Mufasa in that other jungleset Disney movie. But scarier run-ins lay ahead as the sage black panther Bagheera (Ben Kingsley) guides a reluctant Mowgli to the "man village"

to lead a more normal life now that he's 10-years-old and, more importantly, is on top of Shere Khan's hit list. This rendering of King Louie, the self-proclaimed "jungle VIP," is also more foreboding this go-around as a Bornean orangutan-resembling Gigantopithecus (picture a Tangcolored King Kong) deliciously voiced by Walken playing up his off-kilter, New York tough guy speech pattern. 4 ½ of 5 Stars.★



In Alcoholics Anonymous (AA) it speaks of the four defenses an alcoholic uses while he/she continues to drink. In Get Your Act Together, I wrote how SHEs (Sidetracked Home Executives) use the same defenses to remain in a mess.

There is really no difference except for the outcome... drunk or disorderly. Like an alcoholic, once a SHE stops using the four defenses, she is then able to change. Could one of these defenses be holding you back from the life you want to live?

You probably don't deny you're in a mess, but I know when I was living in chaos, I acted like it didn't, bother me. Haven't you heard the classic messy person's excuse for a messy desk say, "I know where everything is on my desk!" Yeah right! Denial! I also remember a constant desire

to get out of the house and go play. My three kids and I spent much of our time outside where I didn't have to face the mess in the house. While at the park it was easy to deny I had a problem, but I always had to come home to the truth.
