#### **Carmichael's** Fourth of **July Salute** to America's **Patriots**

CARMICHAEL, CA (MPG) -"We were young, strong, and brave facing incredible danger," said Lt. Col Jim Grey, Grand Marshal for the Carmichael Elks 57th annual Fourth of July Parade, which will kick off at 10:30 a.m.

Movies such as Twelve O'Clock High with Gregory Peck and Memphis Bell help characterize Jim Grey's courage and the courage of fellow B-17 crew members. High casualties marked B-17's crews, yet Jim Grey survived 30 missions. Jim Grey's 381st lost 1,340 men, one of every six men.

During WWII, 38% or 94,565 B-17 "Flying Fortress" crew members were killed, wounded, MIA, or taken prisoner. During one mission, Nazis shot down three B-17s from his group and a burst of flak shattered the nose of his #3 engine. Later in the 1950s, he flew a B-29 right through the center of a mushroom cloud from an atom bomb. He then retired after 22 years of service to his country to become a successful banker and realtor in Sacramento.

The Carmichael Elks Fourth of July Parade gives a "Salute to America's Patriots," honoring Carmichael's own Jim Grey and fellow patriots along Fair Oaks Boulevard from Marconi Avenue to the Elks Lodge at 5631 Cypress Avenue.

## **Volunteers** Plant **Trees to Provide Native Habitat**

SACRAMENTO REGION, CA (MPG) - A stark contrast between obsolete technology and urgent wildlife care brought volunteers to the non-profit Wildlife Care Association to join SMUD, the Sacramento Tree Foundation, Southside Rental Equipment, and Messenger Publishing Group to transform the former radar dome on the west side of McClellan Park on Saturday, June 13th. The old technology "palace" now houses the non-profit Wildlife Care Association, providing intake, care, and release for displaced or injured wildlife in the Sacramento region.

As part of the long termchange at the two-acre site, 20 trees were planted to provide shade, native habitat, a windbreak, an onsite outdoor natural education area, and to improve the public appeal of the old tech facility. A program of SMUD and the Sacramento Tree Foundation, the droughttolerant native trees offer a natural way to soften the harsh former-USAF facility to meet its current need in providing the essential and unique resource for the region's wildlife. "Gray" or recycled washing machine rinse water will be used to help establish the trees after planting.

Everything from hummingbirds to coyotes in the region is sent to the volunteers at Wildlife Care Association where they are cared for and released back to the environment. Volunteers are always needed, as 98% of the effort comes from caring volunteers, and 88 cents of every dollar donated goes to wildlife recovery and release.




## **Milagro Hosts Hard Hat Tour**





It has come to our attention that the headline in last week's story, "ACS Shops Mark Milestone: Local Store is Top Fundraiser, Raises Almost *\$14K," may have been misleading.* 

Since its opening, Sacramento's Discovery Shop (2708 Marconi Avenue) is credited with \$12 million through sales of "gently used" goods. This 30-year total makes it the top fundraiser of all 40 California stores.

The milestone weekend discussed in the story

was a fundraising record for the store. On Friday alone, 237 visitors gleaned bargains from store shelves. By the time doors closed on Sunday, nearly 700 people (more than double the normal weekend count) had passed through, and close to \$14,000 had been raised through sales.

#### PICKS OF THE WEEK



Sean Penn in "The Gunman"

"Get Hard" (R) - A hapless, filthy-rich financial type, James (Will Ferrell), is headed to prison for some white-collar crimes, so he enlists a hardened criminal to help him prepare for the joint. Except that the "hardened criminal" isn't anything of the sort. Darnell (Kevin Hart) has actually never been in trouble; James just assumes he knows about prison because he's black. Darnell gladly accepts money from a rich idiot asking for prison lessons, and a series of unfunny exploits unfold.

Directed by Ethan Cohen ("Tropic Thunder"), the movie abandons all hope of parody, and really doubles-down on the butt jokes and racial humor. The butt jokes are thin from the start and end up spread across the entire film. Dumb jokes can be used in a smart way, but don't expect that here.

"While We're Young" (R) - Josh and Cornelia (Ben Stiller and Naomi Watts) are a 40-something childless couple who love their lives in New York City. They befriend a younger couple, Jamie and Darby (Adam Driver and Amanda Seyfried), bright and active 25-year-olds who resemble a hyper-cool version of Josh and Cornelia's younger selves. Josh and Cornelia seem to gain youth from trying to keep up with their vibrant counterparts, but the cross-generational friendship presents some complicated questions for the older couple, who look at their future with consternation. Director Noah Baumbach is rather good at making a petty and neurotic Ben Stiller character into something relatable. The movie is full of warm, good humor and great chemistry between leads. Where things fall short is in the final third of the film, when charm has to struggle

against plot shifts.

"The Gunman" (R) - It's Sean Penn's turn to conduct the Over-50 Pain Train, as the well-established dramatic actor takes a dip into the action genre. Penn plays Jim, a former international operative who was set up by his jealous friend, Felix (Javier Bardem). Baddies start coming for Jim, so he starts investigating -- mostly with his fists and guns. Pierre Morel, director of Taken" -- the crash that started this five-lane pile-up of samey old-guy action-flicks -- does not make lightning strike a second time. The dialog is terse but not interesting, the fights are brutal

*"Treading Water"* - Born with a disorder that gives him a permanent perfume of fishiness, awkward teenager Mica (Douglas Smith) has always had trouble connecting with people. He lives in a gaudy house-museum dedicated to the famed Mexican singer Guillermo Garibai. He takes frequent baths with strong soap. His best chance at socialization comes at the swimming pool, where his fragance isn't so strong. It's there that he makes a connection with a gorgeous and alarmingly interested -girl from his past (Zoe Kravitz). Unfortunately, all of this underdog coming-of-age business is smothered under the movie's own obsession with jamming in as much quirkiness as time will allow.

## Gala Breaks Record

Annual Fundraiser Benefits Sacramento Homeless Women and Children

SACRAMENTO REGION, CA (MPG) - More than 400 community members raised record-breaking dollars for local homeless women and children while mingling with nearly 100 graduates of the program at Women's Empowerment's 14th annual Celebration of Independence Gala in May. The event raised \$184,000 through ticket sales, silent and live auctions, and a Fund-A-Dream appeal for the group's child development center. Graduates attended the program in formal gowns, and many of the women were sponsored by community members to attend the event.

The event honored the group's 1,223 graduates at the Red Lion Woodlake Hotel in Sacramento. Guests enjoyed a formal dinner, silent auction, live auction by Keith McLane of KLM Auctions, live music, and presentations from the graduates. Last year's event raised \$160,000.

"It's encouraging to watch this community hold steadfast in its support to break the cycle of homelessness for women and children, but to see it continue to grow each year is phenomenal," said Lisa Culp, executive director. "This is a community that understands we are offering an effective solution to the problem of homelessness in the Sacramento area: empowering women who are homeless to find jobs, homes, and a healthy lifestyle for themselves and their children.'

Women's Empowerment offers the most comprehensive

job-readiness program in the Sacramento area designed specifically for women who are homeless and their children. The 2014 Organization of the Year has graduated 1,223 homeless women and their 2,648 children. Last year, 89% of graduates found homes and 88% found jobs or enrolled in school or training. The program combines self-esteem courses, job training, health classes, and support services to help homeless women across diverse ages, races, and cultures. Fond Dad memories. For all he had on his plate, he was a damn good dad.

That includes your hard-earned money. When firework stands, run by fundraising non-profits, open for business starting June 28th, consumers will be faced with the usual pricey and patriotic puzzlement. What's new? What's loud? What's colorful? How long does it last? What gives me the most bang for my buck?

Messenger Publishing Group has the answers,

having put every new state-approved firework from TNT and Phantom to the test. Our annual fireworks buyers guide also includes returning favorites that scored at least 4 of 5 stars on a scale that factors performance, value, duration, and distinctiveness. Every firework sold individually in California has been rated for the guide since 2003, so whatever isn't listed wasn't forgotten-it just didn't make the grade. Judges this year included firefighters of Sacramento Metropolitan Fire District, Station 65 in Rancho Cordova, where the test was conducted. #### The End of the Clinton Coalition

Every time Hillary Clinton makes a left-wing policy pronouncement, it is, in effect, another eulogy marking the death of the coalition and style of politics that twice made her husband president.

Bill Clinton got elected by peeling off working-class whites and suburbanites from the Republican Party, while holding traditional Democratic voters. He made significant geographic inroads, winning a handful of Southern states both in 1992 and in his 1996 reelection, when he narrowly won the popular vote in the region as a whole.

This is all very interesting, but the Clinton coalition is rusty and up on blocks in some overgrown backyard like the El Camino pickup he once

boasted about. And Hillary knows it. Who is pushing Hillary to the left? Hillary is. It's sheer electoral necessity.

> As Sean Trende of the website RealClearPolitics puts it, President Barack Obama has narrowed but deepened the Clinton coalition.

> He blew the doors off it among base Democratic voters. As Philip Klein of the Washington Examiner points out, Democrats had won the 18- to 24-yearold vote by 11.5 points on average and the 25- to 29-year-olds by about 7 points on average from 1992 to 2004. Obama won those groups by more than 30 points in 2008 and 20 points in 2012.

He outdid himself among minorities, liberals and upper-class suburbanites. Obama, Klein notes, amped up not just his margin among African-American voters, but their turnout. Elsewhere in the former Clinton coalition, though, his support collapsed, with older and blue-collar whites continuing to flee the Democrats.

Even if Hillary wanted to try to recapture those kinds of voters, it's not clear that she could, and the effort would risk alienating the Obama supporters she needs.

So the question for Hillary is whether a 67-year-old candidate who's not a racial minority or particularly exciting can re-energize the electoral coalition defined by a youthful African-American who rose to prominence on rhetorical flights of fancy about hope and change. She's certainly not going to do it by recapitulating the politics of Bill. He hewed to the political center. He played defense on cultural issues. He balanced the budget (at the insistence of a Republican Congress). He touted, at least after his first two years, smallscale government programs of symbolic significance. He was tough on crime and relatively hawkish.

Everything indicates she's going to do and be the opposite. Hillary will make herself a paladin of the left, and hope to energize and frighten the constituent parts of the Democratic base enough to walk the treacherously narrow electoral path of President Obama.

This is the price of victory Obamastyle. Despite his rhetoric of unity, Obama depends on a politics that writes off much of the country and depends on turning out voters already inclined to support him. It is less a politics of persuasion than of mobilization.

For Hillary, this means the centrism and practicality of her husband have to be jettisoned, so what remains from the Clintonism of yore is mostly the shady dealings and shameless insincerity. But she really has no choice. It's go left or go home.

Many dogs do get excited and boisterous in new places, and bark or jump. Even if their owners don't see their behavior as dangerous or aggressive, other owners and their dogs may take it the wrong way. Again, consistent training in basic behavior commands can be a big help.

Another way to really acclimate your dog to travel is ... well, travel. Start with short day trips to fun places like parks, and then work your way up to longer, more ambitious destinations.



The Report has been made, filed with the Secretary/Clerk of the Board and duly considered by the Board and is hereby deemed sufficient and preliminarily approved. The Report shall stand as the Engineer's Report for all subsequent proceedings under and pursuant to the foregoing resolution.

SECTION 3. It is the intention of this Board to levy and collect continued assessments within the Assessment District for fiscal year 2015-16. Within the Assessment District, the existing and proposed improvements (the "Improvements") are generally described as the: installation, maintenance and servicing of public facilities, including but not limited to, landscaping, sprinkler systems, park grounds, park facilities, landscape corridors, ground cover, shrubs and trees, street frontages, playground equipment and hardcourt areas, senior and community centers, drainage systems, lighting, fencing, entry monuments, basketball courts, tennis courts, running tracks, swimming pools, other recreational facilities, security patrols, graffiti removal and repainting, and labor, materials, supplies, utilities and equipment, as applicable, for property owned and maintained by the Carmichael Recreation and Park District. Installation means the construction of recreational improvements, including, but not limited to, land preparation, such as grading, leveling, cutting and filling, sod, landscaping, irrigation systems, sidewalks and drainage, lights, playground equipment, play courts, recreational facilities and public restrooms. Maintenance means the furnishing of services and materials for the ordinary and usual maintenance, operation and servicing of said improvements, including repair, removal, or replacement of all or part of any improvement; providing for the life, growth, health and beauty of landscaping; and cleaning, sandblasting and painting of walls and other improvements to remove or cover graffiti. Servicing means the furnishing of electric current or energy for the operation or lighting of any improvements, and water for irrigation of any landscaping or the maintenance of any other improvements

**SECTION 4.** The Assessment District consists of the lots and parcels shown on the assessment diagram of the Assessment District on file with the Secretary/Clerk of the Board, and reference is hereby made to such diagram for further particulars.

**SECTION 5.** Reference is hereby made to the Report for a description of the Improvements, the boundaries of the Assessment District and the proposed assessments upon assessable lots and parcels of land within the Assessment District. The Report identifies all parcels which will have a special benefit conferred upon them and upon which an assessment will be imposed.

**SECTION 6.** The assessments include an authorized annual increase equal to the change in the San Francisco Bay Area Consumer Price Index ("CPI"), not to exceed 3% (three percent) per year without a further vote or ballot proceeding. The change in the CPI in 2014 was 2.67%. Therefore, the maximum authorized assessment rate for fiscal year 2015-16 is \$46.06 per single-family equivalent benefit unit.

**SECTION 7.** The estimated fiscal year 2015-16 cost of providing the Improvements is \$4,978,683. This cost results in a proposed assessment rate of \$44.82 per single-family equivalent benefit unit for fiscal year 2015-16, which is less than the maximum authorized assessment rate.

**SECTION 8.** Notice is hereby given that on June 18, 2015, at the hour of 6:00 p.m. at the Carmichael Recreation and Park District located at 5750 Grant Ave, Carmichael CA, the Board will hold a public hearing to consider the ordering of the Improvements, and the levy of the continued assessments for fiscal year 2015-16. The Secretary/Clerk of the Board is hereby authorized and directed to cause a notice of the hearing to be given by publishing a notice once, at least ten (10) days prior to the date of the hearing above specified, in a newspaper circulated in the District.




