Celebrating Beer Week



Sacramento is now a boomtown for craft beer and fans are happily drinking it down. The success of Sacramento Beer Week comes from the hard work of the local craft beer community.

SACRAMENTO REGION, CA - (MPG) The 4th Annual Sacramento Beer Week will be held from February 22nd until March 3rd, 2013. Throughout the Sacramento Valley, breweries, pubs, restaurants and other beer-loving businesses will celebrate Sacramento craft beer culture and Northern California's legacy as the birthplace of the

modern craft beer movement. Last year, more than 100 businesses hosted beer tastings, tap takeovers from visiting breweries, beer dinners, food pairings and more. SBW is anchored by the Capital Beerfest on March 2nd at Cal Expo, where thousands of beer fans will sample from almost 100 breweries to benefit the Runnin' for Rhett Foundation. New fea-

tures this year will include a

cocktail competition from the Sacramento Bartenders Guild and several exclusive collaborative beers from local breweries. A new beer magazine, Hops to Table, has been introduced to chronicle Sacramento's craft beer scene

Sacramento Beer Week organizers have also introduced a local campaign to promote responsible drinking.

"Drink Safely Sacramento will use social marketing strategies to reduce the harm from drinking alcohol," says Dan Scott, founder and executive director of Sacramento Beer Week. "We aim to make Sacramento safer, improve people's lives and maybe even save a few."

Sacramento has ten beer producers within city limits, another fifteen less than an hour away

and eight new regional breweries scheduled to open in 2013. "Sacramento Beer Week and the caliber of locally-produced craft beers are yet another example that help to illustrate the reality of Sacramento's designation as the Farm-to-Fork Capital of America," said Steve Hammond, president and CEO of the Sacramento Convention & Visitors Bureau. "The region's heritage of quality craft beer production is second to none and, as showcased during Sacramento Beer Week, provides an additional element to the culinary reputation that continues to grow both inside and outside of the Sacramento region."

Glynn Phillips, owner of Rubicon Brewing and President of the Northern California Brewers Guild, was an early supporter of the event. "Sacramento Beer Week has helped to elevate the presence and importance of craft beer in our region. Rubicon has been here for 25 years and I am still surprised at how many people learn of our beer through Sacramento Beer Week." Scott credits the collaborative nature of the craft beer industry. CARMICHAEL, CA – (MPG) If success is lovelier the second

time around, the Mira Loma High School's dance drill team won't leave it at that.

The Carmichael and Arcade teenagers will next month spin and kick-line their way to Southern California for a third bid at the national title they've twice snared. Among competitors, Mira Loma is the team everyone wants to beat.

"The contest has changed us as people and dancers," says the troupe's Captain, Ilaria Quincy-Reed (17). "We don't take anything for granted. Winning twice just makes us want to work harder." A senior, Ilaria will this year contest her third Nationals. "Winning was always our team's wish." She recalls. "We never thought it would happen. Then

Team Secretary Avni Nadir (16) describes the 2011 victory: "We all held hands, listening for the results, crying," she says. "It was our proudest moment. You compete for trophies but the real fun is bonding with people who share your passion. It makes you really feel like a dancer"

More kudos came on home campus. "We were allowed to carry our trophies around school and wear our medals," said Dorothy Li (16). "Everyone was happy and proud of us. Even the teachers showed us more respect

Lest anyone think triumph

breeds swollen heads, Mira Loma's champions are among the most courteous and popular students in San Juan School District.

"Our coaches instill the need for us to stay humble," says Secretary Avni. "If someone compliments us, we take the time to thank them," The first Asian Indian to drill for Mira Loma, her fluidity comes through years of Bollywood dancing. "When I first made the team as a junior, I was amazed by how welcome the seniors made me feel," she says. "My parents didn't approve at first; it meant so many hours away from study. Now they are behind me 100 per cent."

When each school year starts, 19 drill team spots are hot tickets at Mira Loma. Fifty or more students try out; even seasoned champions must re-audition. No size or weight restrictions apply but tattoos are taboo and chosen dancers must maintain no less than a 2.5 GPA score. "It was my dream try out when I reached high school," says rookie Ines Dias (15).



gets results. It gives you that extra push to make the school proud."





Why Did My Tax Preparer Not Use My Deductions?

That reminds me of a lady who was unhappy when the IRS disallowed the exemption she took for her pet. "But I have been claiming seven of them in the past years," she protested. Similarly many taxpayers seem to think that they are entitled to deductions for their food and living expenses.

I had a call the other day from someone who was unhappy with her tax preparer. "He seems not to know his business. She started telling me that he did not take any of her expenses for her food and commuting to work.

Needless to say that her tax preparer was correct in not deducting those personal expenses on her tax return. Personal Expenses are not deductible. Only expenses used in generating the income (except for commuting) are deductible.

Maybe it will help just to visit the issue briefly. If you are a business such as a corporation or a proprietor, you are entitled

particles into the joint.

That reminds me of a lady ho was unhappy when the LS disallowed the exemption e took for her pet. "But I have ten claiming seven of them in to deduct your expenses that are used to generate your income. That seems commonsensical. The problem becomes a little twisted for wage earners.

In the good old days wage earners (people with w-2) used to be able to deduct their first dollar of business expenses. Then smart politicians who are bent on complications employed their twisted minds and decided to make life miserable for citizens and possibly for themselves.

Now employee business expenses have to pass two hurdles. The first hurdle is a percentage of adjusted gross income you have to jump over which they call a floor. You theoretically can deduct any amount above this floor. I say theoretically because we are not out of the woods yet.

After you successfully manage to jump the hurdle of the percentage of adjusted gross income and you have a dollar or two available now for deductions, the IRS will tell you these deductions can only be used among the itemized deductions. So if you don't have enough itemized deductions, the poor dollars that you have just liberated succumb to the shackles of the congress genius and they die forever.

Can't we just live a simpler life? Taxes made simple or better yet no income tax but a sales tax system. You buy and you pay your taxes. NO more tax returns.

Summary: Only business expenses are deducted. Wage earners cannot deduct personal expenses. Employee business expenses are deductible but hardly.

Taxpayers Fleeced by Bad Accounting at State Parks

SACRAMENTO COUNTY, CA – (MPG) State Senator Jim Nielsen (R-Gerber) issued the following statement regarding the State Auditor's report, Department of Parks and Recreation, Weak Procedures Have Led to Inconsistent Budgetary Reporting and Difficulties in Measuring the Impact of Efforts to Keep Parks Open:

"For years, top officials at the Department of Parks and Recreation have ignored established accounting guidelines in its reporting to hide money from the public. "With nearly 4,000 employees and a budget of \$574 million, State Parks officials still cannot tell the public how much it costs to operate a specific park.

"Last year, top-ranking officials arbitrarily selected 70 parks for closure. They cannot 'justify the reasonableness of the selections.' "This is yet another blatant example of budget gamesmanship. I have tried to correct these

accounting gimmicks during my tenure as Vice Chair of the Assembly Budget Committee. Top bureaucrats continue to thumb their noses at taxpayers, incapable of reforming the practices of their departments. "I will aggressively examine these accounting manipulations in the budget hearing process to bring an end to these abuses in government that are costing taxpayers tens of millions of dollars.





Dear Dave,

My mother-in-law has a serious credit card problem. She can't afford stuff, but she shops anyway, acquires more and more credit and thinks she'll pay for it all later somehow. Her husband has bailed her out a few times, but he's unwilling to do it anymore. My wife and I, and her sister, want to address this issue, but where do we start?

Dear Jonathan,

First of all, you need to stay out of the discussion. This is something for her daughters to handle, and her husband needs to be part of it, too. He's closer to this and feels the effects more than anyone else in the family.

They need to sit down with her in a closed setting, where there are no interruptions, no television and no one else. Start with the fact that they love her and care about her deeply. This part is really important. But they also have to walk through what's going on, and let her know they're tired of watching her destroy herself and her marriage with this immature and irresponsible behavior.

Everyone involved should understand going in that they're likely to receive a volatile,

angry reaction from this lady. Sometimes people get ticked off when they hear the truth, especially when it's connected to their own misbehavior. It may even be a good idea for your wife, her sister and your fatherin-law to get some advice from a family counselor beforehand. What we're really talking about here is an intervention.

If she were a drunk, you'd want to try and make her see how alcohol was hurting her and the relationships she has with her family. Basically, she has a credit card addiction, and it's wreaking havoc on her marriage and their financial well-being. Show as much love and understanding as possible, but someone has to say something and draw a line in the sand. Otherwise, this behavior will eat everyone alive! - Dave

Closing Whole Life

Dear Dave,

I want to get out of my whole life policy. Should I formally close out the old policy, or just stop paying the premiums? - Anonymous

Dear Anonymous,

Close out the old policy once you have a good, term life

insurance policy in place. I recommend 15- to 20-year level term insurance equal to 10 to 12 times your annual income. For instance, if you make \$40,000 a year, you should have \$400,000 to \$500,000 in coverage.

Term life insurance is much less expensive than whole life. Plus, did you know that you lose the part of your whole life policy known as the "savings plan" or "cash value" when you die? They only pay the face amount of the policy. So, close it out and stop pumping money into that thing!

But don't leave yourself uninsured. Make sure you have the proper coverage in a term policy first. There is never a good time to save money inside a rip-off, whole life, cash value insurance plan!



IDENTITY THIEF (Rated R)

Identity theft is a serious problem. Just ask any victim. But there's no topic too serious that can't be turned into a comedic adventure, given the right script.

Starring Jason Bateman and Melissa McCarthy, "Identity Thief" offered high expectations for some gut-busting laughs in a screwball comedy exploring the clash of diverse personalities.

As written by Craig Mazin ("The Hangover Part II") and directed by Seth Gordon ("Horrible Bosses"), the upshot of "Identity Thief" is a more formulaic comedy, having something more in common with "The Guilt Trip."

Still, there is laughter to be found here, if mainly because the plus-size Melissa McCarthy, much like she did in the insanely funny "Bridesmaids," has a knack for stealing scenes.

For "Identity Thief," McCarthy's Diana is a big-haired, white-trash fraudster living in a small house in Winter Park, Florida crammed full of ceramic junk and other ill-gotten gains.

A compulsive hoarder with bad taste, Diana lives it up at local spas, hair salons and local bars where she buys everyone rounds of drinks, all the while maxing out the credit cards of her victims.

Her latest casualty is a poor schmuck with the gender-neutral name of Sandy Bigelow Patterson (Jason Bateman), a Denver family man with a pregnant wife (Amanda Peet) and two small children.

The film has no problem straining credibility right from the very start. You'd think that Sandy, an accounts supervisor at a large investment firm, would know

better than to give out his vital information over the phone to a telemarketer.

Struggling to support his family and tired of dealing with his horrible boss (Jon Favreau), Sandy's fortunes look up when he's invited to take an executive position with an upstart competitor.

And yet at the same time, all that he has worked for is suddenly threatened, after a gas station attendant tears up his maxed-out credit card and the police arrest him for having skipped a court date in Florida.

Though some of the problems are sorted out, a Denver detective (Morris Chestnut) informs Sandy that his legal troubles could go on for many months because the culprit resides in another state.

Given a week by his impatient new boss (John Cho), Sandy travels to Florida to confront Diana and to bring her back to Denver so that her testimony can clear him of still pending charges.

Needless to say, the fake Sandy is not willing to help the real one get his life back, and so a few fights are in the offing, resulting in the destruction of his rental car and harm to various body parts.

Diana becomes more agreeable to Sandy's plan to leave Florida when a pair of assassins (Genesis Rodriguez and T.I. "Tip" Harris) is gunning for her because she sold them phony IDs and credit cards that don't work.

To add to her woes, Diana is also being pursued by a redneck bounty hunter (Robert Patrick), so crazed and unhinged in his chase that he's a greater threat than the hired killers.

The road trip to Denver proves to be a test of wills between the straight-laced nebbish and the wild child of reckless behavior. Many fights, some physical, ensue.

At times, the mind games played by Diana are amusing. But when she hooks up with an overweight cowboy named Big Chuck (Eric Stonestreet), it proves humiliating for Sandy and uncomfortable for the audience.

The story offers some momentary promise when Sandy resorts to unsavory tactics directed at his former corporate boss. Unfortunately, Jon Favreau's villainous Harold Cornish does not return to the action.

"Identity Thief" has its moments of fun, and yet it doesn't quite fully connect in the possibilities of an odd-couple road movie. It aimed for "Due Date" territory and proved about as engaging as "The Guilt Trip."

Nevertheless, "Identity Thief," though stitched together with the standard comedic blueprint, presents enough amusement, thanks to the talents of Melissa McCarthy and Jason Bateman.

Triplets Make Local District History

CARMICHAEL, CA - (MPG) When Cheryl Jacobsen delivered her triplets - Patrick, Sean, and Kenneth-little did she know they would be the first set in the Boy Scouts of America's Pony Express District (Golden Empire Council) to earn the highest ranking of Eagle Scout. They almost didn't get there.

This past summer, Assistant Scoutmaster Bryce Holladay visited their home to remind them that the door would be closing when they became eighteen. They only had three or four months to earn their remaining badges, complete the Eagle Scout Service Project, get it written up, interview, and receive approvals from the scoutmaster, charter leader, and sponsors. Were they up for it?

"They said 'yes,'" recalls Holladay. "They followed through with it. They set that goal."

When the boys were born, the Jacobsens already had a twoyear-old daughter. With a sudden family of six, they needed assistance. Cheryl's grandmother flew out from Colorado and staved the first three months until Cheryl returned to work. The kids' father quit his job to be a full-time dad, until the boys entered kindergarten. He then worked part-time, so he could be there for them before and after school.

Initially, the school advised the Jacobsens that it would be easier for them and teachers if the triplets remained together in the same classroom. Cheryl, however, dis-

agreed with their assessment. "I asked if it was possible to separate them. I felt they were already sharing a birth date, and I wanted them to have their own individuality, and friends." Mom

They've all been active in track and field, and cross-country, with Patrick adding wrestling to his curriculum, until an injury cut it

The boys didn't enter the Boy Scouts until age thirteen, but they have thoroughly enjoyed the experience.

Patrick's favorite aspect has been "trying new things." He says, "The personal management badge was the toughest. You have to keep track of what you spend and don't spend of your money for 30 days. It was hard to keep track sometimes."

He built an information kiosk booth at Will Rogers High School for his Eagle Scout Service Project.

After high school graduation, he plans on pursuing a nursing career.

Sean says about the Scouts, "I thought it was going to be somewhat boring when I first joined, but there is so much fun stuff. Scout Camp is where you have fun all the time. For the wilderness survival skills we had to make our own fire, and learn different signaling. We had to go out for a night with just our clothes and a water bottle, and build our own shelter."

For his project, he created a drip irrigation system for the garden at nization, and to demonstrate our Will Rogers Middle School. "We only had 30 days. It was a project that was efficient, quick, and would help a lot of people."

After graduation, he plans on following his grandfather's footsteps by joining the Air Force.

Kenneth says people might be surprised to learn how hard working the Scouts are - "When we sign up for something, we get it done." His favorite merit badge was leather work. "It was probably the easiest, and most fun. We made belts and little neck ties." He agrees with Patrick that earning the personal management was the most challenging. "One of the things took me forever to get it right. There are a lot of steps to get to a point."

Kenneth repaired bleachers at Del Campo High School for his project, which involved raising money. "The regular wood would just break easy again, so we bought pressure treated wood, which is a little more expensive."

He had planned on joining the Coast Guard after graduation, but faced a two-year waiting list. "So, I'm shooting for the Air Force right now, and to become a mechanical engineer. I think it would be really fun working on airplanes; getting to know how to build them."

The Court of Honor – the award ceremony – is set for March 10, 2013 at 7:00 p.m. at the Church of Jesus Christ Latter Day Saints at the corner of Garfield and Locust in Carmichael.

Recent Cases of Interest

CASE: Anthony Arinaga (02/15/13)

PROSECUTOR: Deputy District Attorney Alan Hengel, Insurance Fraud Unit District Attorney Jan Scully announced that 34-year-old Anthony Arinaga admitted to a felony charge

of vehicular arson with the intent to defraud his auto insurance company, a strike under California's Galt resident Anthony Arinaga had a vehicle which needed frequent and costly repairs. Arinaga and

a friend, Laura Perry, decided they would destroy his car. Arinaga would then file a false stolen vehicle police report and false insurance claim. Arinaga believed his scheme would eliminate having to pay for additional costly car repairs and that he would instead receive payment from his auto insurance company for the value of his car.

The morning of September 11, 2011, Arinaga and Perry drove separate cars to a remote area near Stockton. Once there, Arinaga set his car on fire and immediately left with Perry who drove him home. Later that morning, Arinaga called the Galt Police Department and said he had just discovered that his car had been stolen. A Galt police officer went to Arinaga's home to take a stolen vehicle report. Both Arinaga and his wife, Christina Arinaga, initially told the officer that their car had been stolen. After further questioning by the officer, they both admitted lying about their car being stolen.

Anthony Arinaga faces a sentence of 180 days in jail and formal probation. Sentencing is set for March 15, 2013 in Department 8 of the Sacramento Superior Court.

CASE: Haywood Luster (02/15/13)

PROSECUTOR: Deputy District Attorney Matt Chisholm, Elder Abuse Unit

District Attorney Jan Scully announced today the Honorable Kevin McCormick sentenced 50- yearold Haywood Luster to 17 years and 4 months in prison. Last month, Luster pled to three counts of robbery with an elder victim enhancement.

In the summer of 2012, Luster robbed seven women ranging in age from 76 to 93. Luster followed the women home from two grocery stores in the Arden area. When the victims arrived home and began taking groceries into their houses, he struck them from behind and stole their purses. None of the seven victims were able to identify Luster because the attacks were a surprise and executed quickly. During the last robbery, an alert neighbor witnessed the robbery and chased Luster back to his car. After the neighbor provided a detailed description of the car, the Sacramento sheriff's robbery detail searched the area for hours and apprehended Luster in the car.

All of the victims escaped serious injuries, but many of the victims have lost their sense of security, independence and will no longer leave their homes alone. In Luster's statement to probation, he admitted targeting elderly women because he thought they were easy targets.

Deputy District Attorney Matt Chisholm states, "Thanks to the tireless work of Sacramento Sheriff's Detective Jason Lonteen and the watchful eyes of caring neighbors, this defendant is no longer wandering our streets targeting some of the most vulnerable people in our community."

CASE: Ignacio Bulahan (02/13/13)

PROSECUTOR: Deputy District Attorney William Satchell, Gangs & Hate Crimes Unit

District Attorney Jan Scully announced that the Honorable Maryanne Gilliard sentenced 37-year-old Ignacio Bulahan for the May 19, 2004 murder of Thyotis Jackson. Last month, Bulahan was convicted by jury of first degree murder. Bulahan received a sentence of 25 years to life in prison plus 1 year for the use of a deadly weapon.

The homicide was unsolved until 2010 when an individual came forward with information that assisted the Sacramento Police Department in linking the murder to Bulahan.

Lavender-3 drops Peppermint-3 drops Clary Sage-1 drop Finish filling a one ounce drip bottle with sweet almond oil. Roll bottle to mix. Rub a few drops of the blend on palms and cup hands over nose. Inhale.






