



# **Leaving For Las Vegas**



Close to 700,000 California residents have chosen to look at the Golden State in their rear-view mirrors one last time.

Gas in Vegas is a dollar cheaper a gallon than in the Golden State, or so a friend and recent LA transplant tells me. He went on to say the top tax rate in California is over 13%, while, of course, Nevada has no state income tax. Over dinner at Del Frisco's, he explained how industries are being ruined by runaway government in his old home state. Nevada would surely benefit from businesses making their escape. Plenty of people are leaving California — nearly 700,000, I read somewhere — however, my friend says these 700,000 have been replaced by an equal amount of uncounted "illegals," as he put it. The California legislature has democratic supermajorities in both chambers, and of course, California voters have determined that what ails their great state can be fixed with the return of Jerry Brown to the governor's mansion. But what really ails California, like many other states, is mathematics. The state's inflow doesn't cover its outflow. Like Greece, California can't print its own currency (although it does resort to IOUs occasionally). Gov. Brown was stunned to find a \$28 billion "wall of debt" when he took office.

with so much going for it? California is one of many despotic states that are losing residents in favor of those that are less despotic.

In general, state governments don't seem to be the best negotiators when putting together pay and retirement packages. There's something about spending someNapa, California. Ms. Agcaoili kept her nose to the Freudian grindstone for 30 years, not taking vacation, and now she's cashing in. She makes no apologies, telling Bloomberg, "It was my prerogative, I did not go on vacation." End of interview.

But in the private sector, vacation is a use-it-or-lose-it proposition. Or maybe a few weeks can be banked, but not 72 weeks like Ms. Agcaoili had, who pulled down \$2.4 million in pay from the state since 2005. And there should be no fear that Ms. Agcaoili will be dining on cat food in her retirement: The California Public Employees' Retirement System (CalPERS) will be paying her \$199,000 a year in pension payments. Since the state is so short on money, employees have actually been encouraged not to take their vacations. In fact, the state is happy to accommodate them, because filling in for vacationers is costly. "Requiring employees to take all of their leave would have increased overtime costs at state prisons and hospitals, lowered reimbursements in tax collection and other fee-generating programs, and reduced services in other settings," state of California HR man David Gay told Bloomberg. Prison guards in California can now accrue unlimited vacation time courtesy of Gov. Brown. According to California's nonpartisan Legislative Analyst's Office, the average prison guard has accumulated 19 weeks of

unused vacation, a liability estimated at \$600 million. These are the same prison guards that received a 34% raise in pay from Gov. Gray Davis when he was in office.

"Of the 100 biggest payments in 2011 in the dozen [most populous] states, all but 10 went to California state workers. The

### **DWR Increases** Water Delivery Estimate for 2013

SACRAMENTO REGION, CA-(MPG) The Thanks to early season storms, the Department of Water Resources increased on December 21st its water delivery estimate for calendar year 2013 from 30 to 40 percent of requested State Water Project water. The delivery estimate - or allocation - of SWP water is expected to further increase as more winter storms roll in.

The state normally receives more than 90 percent of its snow and rain from December through April. Storms last month and those currently sweeping California have replenished reservoirs and deepened the mountain snowpack that normally provides a third of our water as it slowly melts in the spring and early summer.

Lake Oroville in Butte County, the State Water Project's principal storage reservoir with a capacity of 3.5 million acre-feet, is at 67 percent of capacity, 107 percent of normal for the date. Shasta Lake north of Redding, the federal Central Valley Project's principal storage reservoir with a capacity of 4.5 million acrefeet, is at 68 percent of capacity, 109 percent of normal for the date.

The mountain snowpack today holds 93 percent of average water content for the date. Just a normal winter will significantly increase today's allocation of 40 percent of the slightly more than four million acre-feet requested by the 29 public agencies (State Water Project Contractors) that supply SWP water to more than 25 million Californians and nearly a million acres of irrigated farmland.

one else's money that makes one less careful than if spending his own

"It starts with the governor and the legislature and wanders down the line. These people are playing with the taxpayers' money," said Steven Frates, research director of Pepperdine University's Davenport Institute.

States paid out more than \$711 million to 111,000 people who left jobs as employees of the 12 most populous U.S. states last year for unused vacation and other paid time off, according to payroll data on 1.4 million public workers compiled by Bloomberg.

Employees from California accounted for 39% of that total. Since 2005 the Golden State has shelled out \$1.4 billion for unused vacation and other paid time off. That kind of money would put a lot of cops on the beat and teachers in classrooms. Instead, this taxpayer dough is ensuring cushy retirements for government workers who are no longer on the job.

For instance, the state of California cut a \$608,821 check to psychiatrist Gertrudis Agcaoili, who retired last year from a state mental hospital in

average payout for the top 100 was \$178,267, in addition to regular wages," says Bloomberg.

There's a rule limiting the accrual of unused leave to 640 hours, but everyone ignores it. Well, evidently, as Bloomberg reports, unused leave grew from \$1.4 billion in 2003 to \$3.9 billion in 2011.

Paying out for the accrual of unused leave would bankrupt a private company. While government workers are always believed to be underworked, many assumed they're underpaid as well. Not hardly, as Michael B. Marois & Rodney Yap explain:

"The lump-sum retirement payments, seldom granted in private industry, mirror a broader trend in which California's public employees receive far more than comparable workers elsewhere in almost all job and wage categories, from public safety to health care, base salary to overtime. California, the world's ninth- biggest economy, has set a pattern for lax management, inefficient operations, and outof-control costs, the Bloomberg data show."

The final SWP allocation this calendar year (2012) was 65 percent of requested deliveries. The final allocation was 80 percent in 2011, up dramatically from the initial allocation of 25 percent. The final allocation was50 per-

cent in 2010, 40 percent in 2009, 35 percent in 2008, and 60 percent in 2007. The last 100 percent allocation – difficult to achieve even in wet years because of Delta pumping restrictions to protect threatened and endangered fish - was in 2006.

### Annual "Campaign for the Community" Raises \$6 Million for Nonprofits Throughout Northern and Central California

### SBA Economic Injury Disaster Loans Available to California Small Businesses

SACRAMENTO COUNTY, CA - (MPG) Small, nonfarm businesses in 30 California counties are now eligible to apply for low-interest federal disaster loans from the U. S. Small Business Administration (SBA). "These loans offset economic losses because of reduced revenues caused by the drought that began on January 1, 2012, in the following primary counties," announced Alfred E. Judd, Director of SBA's Disaster Field Operations Center-West. Primary California counties: Amador, Merced, San Luis Obispo, Sonoma, Ventura and Yolo; Neighboring California counties: Alpine, Calaveras, Colusa, El Dorado, Fresno, Kern, Kings, Lake, Los Angeles, Madera, Marin, Mariposa, Mendocino, Monterey, Napa, Sacramento, San Benito, San Joaquin, Santa Barbara, Santa Clara, Solano, Stanislaus, Sutter and Tuolumne.

"SBA eligibility covers both the economic impacts on businesses dependent on farmers and ranchers that have suffered agricultural production losses caused by the disaster and businesses directly impacted by the disaster," Judd said. Small, nonfarm businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private, nonprofit organizations of any size may qualify for Economic Injury Disaster Loans (EIDLs) of up to \$2 million to help meet financial obligations and operating expenses which could have been met had the disaster not occurred. "Eligibility for these loans is

"Eligibility for these loans is based on the financial impact of the disaster only and not on any actual property damage. These loans have an interest rate of 4% for businesses and 3% for private, nonprofit organizations, a maximum term of 30 years, and are available to small businesses and most private, nonprofits without the financial ability to offset the adverse impact without hardship," Judd said.

By law, SBA makes EIDLs available when the U. S. Secretary of Agriculture designates an agricultural disaster. Secretary Tom Vilsack declared this disaster at the request California Governor Edmund G. Brown, Jr.'s designated representative, Mark Ghilarducci, Secretary of California Emergency Management.

Businesses primarily engaged in farming or ranching are not eligible for SBA disaster assistance. Agricultural enterprises should contact the Farm Services Agency (FSA) about the U. S. Department of Agriculture (USDA) assistance made available by the Secretary's declaration. However, in drought disasters nurseries are eligible for SBA disaster assistance. Applicants may apply online using the Electronic Loan Application (ELA) via SBA's secure Web site at https://disasterloan.sba.gov/ela.

Disaster loan information and application forms are also available from SBA's Customer Service Center by calling SBA toll-free at (800) 659-2955, emailing disastercustomerservice@sba. gov, or visiting SBA's Web site at www.sba.gov/services/disasterassistance. Individuals who are

deaf or hard-of-hearing may call (800) 877-8339. The deadline to apply for these loans is August 19, 2013. SBA Field Operations Center–West, P.O. Box 419004, Sacramento, CA 95841

In addition to Ms. Agcaoili, other state employees are cashing in big. A highway patrol officer collected \$484,000 in pay and pension benefits while 17 employees received checks of more than \$200,000 for unused vacation and leave. According to Bloomberg's data, the best-paid staff in other states earned far less for the same work. But California is hardly alone with inflated government salaries. Firemen in Clark County, Nev. (Las Vegas), routinely make well into six-figure salaries and overtime pay. The first several pages of these salaries compiled in 2009 by Las Vegas Channel 8 are firefighters making well over \$100,000.

Ms. Agcaoili is 79, but many cops and firefighters retire in their 50s, collect nearly 100% of their salary as a pension, and then start new careers. This leaves cities and states to pay for two or three cops to have only one on the beat.

The math just does not work. The clock is ticking on California. People are fleeing. Soon it will not be so golden.






### F. Scott Fitzgerald's Classic "The Great Gatsby" Discussed at Sacramento Central Library Series



There is no reason why you can't do something you love. If you are not happy with your current job, you should explore changing direction to something that makes you happy and that you find satisfying.





### *Helping the Correct Way* Dear Dave,

I'm trying to help my son and daughter-in-law by encouraging them to get out of debt and live on a budget. It hasn't been a problem to give them money when they've asked in the past, but I'm afraid they're still in a mess. How can I make sure I'm doing the right thing?

Dear Margaret,

The first thing you need to do is sit down and have a serious, loving talk with them. If they've asked for money before, and it has become something of a trend, you have a right to know more about their circumstances. In addition, they need to understand that opening up and being honest about their situation and behavior is a requirement for them to receive more of your help.

I know you guys love each other, but be prepared for them to get defensive. Lots of times people are embarrassed to talk about their mistakes, no matter how nicely you approach things. They may decide not to answer any questions and that it's none of your business. That's fine, too. Just make sure they understand Mom won't open her checkbook unless they open up about their finances.



Dear Allison,

This isn't about you being nosy or controlling. It's about making sure you're not giving a drunk a drink and further enabling any misbehavior. Then, if they're willing to talk, and as a result, you feel they truly need help, make sure any money you give them is a gift, not a loan.

I know it hurts to see them go through rough times, Margaret. But if they're acting irresponsibly with money, they need to suffer the consequences of their actions. That, along with your love and advice, can help them turn the corner and win with money

#### A Dated Offer

Dear Dave,

I have one bill left from an emergency room visit earlier this year, and I'm trying to settle with a collections agency. They're willing to accept half of the \$930 owed, but they want me to pay online or by phone, and I don't feel safe doing that. What should I do?

If they're willing to lower the bill by half, then you need to get that in writing. If you don't have it in writing, you don't have a deal. And whatever you do, don't give them *any* form of electronic access to your money. I've seen too many collectors lie to people

about "agreements," then go in

and raid their accounts. Just tell them to send you, by email or regular letter, a statement saying that \$465 will be accepted as payment in full for the debt. Also, tell them you'll turn around the day you receive this letter and send them a cashier's check for that amount. Until then, they can go jump in the lake!





### What Should Be Done About the Fiscal Cliff

#### Commentary By Dr. Tracy C. Miller

Everyone is talking about the "fiscal cliff"-the likely impact of the expiration of the Bush tax cuts and the planned cuts in government spending that are part of Budget Control Act of 2011. Much discussion about the fiscal cliff, and its likely consequences, however, is misleading. The media have emphasized how a tax increase or cut in government spending will reduce overall spending in the economy so that firms have to cut back production and lay workers off. We should be much more concerned about how the fiscal cliff affects investment and entrepreneurship than how it affects aggregate spending. This is why allowing tax rates to rise, especially on the rich, will do more harm than good.

Republicans and Democrats claim that they want to reduce the government deficit, which (some argue) would require some

combination of tax increases and government spending cuts. Many are convinced that both the government and also American families need to spend more to bring the rate of unemployment down. If taxes are increased, households and businesses will reduce their spending. This reduction in private spending, especially when combined with a reduction in government spending, may cause a recession.

Although increasing taxes and cutting government spending may have negative short-run effects, a more fundamental question is how the U.S. economy can return to a faster long-run rate of growth that will make it possible for the millions who are now unemployed to return to work. Contrary to popular belief, the primary reason for the poor performance of the U.S. economy is not that Americans are spending too little. It is rather that businesses are not investing enough in capital equipment and are not willing to hire people

because of uncertainty about the future of the economy. Reducing government spending and borrowing, particularly if the spending cuts are permanent and not temporary, may actually give people greater confidence to invest and start businesses.

The biggest problem with raising taxes is not that people will spend less. Higher tax rates influence the incentive to work and invest. If entrepreneurs and investors expect the government to take 40 cents or more out of every additional dollar they earn, many are going to be less inclined to take the extra risks associated with expanding their businesses and hiring more workers. If, however, the government were to increase its tax revenue by eliminating loopholes in the tax code, the incentive to work and invest would be affected much less than by an increase in tax rates. Certain provisions in the tax code, like the mortgage interest deduction, reward people for

doing things that do not help and may actually hinder the long-run growth of the economy. Incentives are the key to a healthy economy, so tax increases are most harmful if they reduce incentives to work and invest, which happens when government requires workers and investors to pay a higher percentage of each dollar earned.

Why can't the two sides compromise for the sake of being fiscally responsible-combining moderate tax-rate increases with spending cuts? The debt of the federal government is so large that the token spending cuts being considered by politicians of both parties will do little to prevent government bankruptcy. If the federal government used accounting standards that businesses use, it would record government debt as much higher than the official figure of \$16-plus trillion. The reported federal government debt excludes trillions of dollars of unfunded Medicare and Social Security benefits that

workers expect to receive when address the long-run debt problem they retire in exchange for the taxes they paid during their working years. If a compromise could be reached that involved cuts in promised Social Security and Medicare benefits large enough to make those programs sustainable, it might be worth considering.

A tradeoff exists between shortterm stimulus of the economy and long-term growth. It may be that cutting government spending would slow the growth of the economy in the short run, but that is not a foregone conclusion. The resulting reduction in government borrowing would mean that more of the money people save would be available to finance private investment. Increased investment would lead to more and higher-paying jobs.

Continuing to postpone steps to drastically reduce government spending, though it may modestly help the economy in the short run, is not the answer. Raising tax rates, however, will do little to

of the U.S. government and may just make it easier to delay needed spending reductions. Limiting the share of income taken in taxes and cutting government spending will encourage firms to invest in capital and hire more workers, especially if combined with steps to roll back some of the recent increases in regulation of health care and the financial system, which have contributed so much to uncertainty about the future.



### Sacramento County DA Reports Recent Cases of Interest

#### CASE: Joseph Maggard (12/21/12)

#### PROSECUTOR: Deputy District Attorney David Brown

District Attorney Jan Scully announced today that a jury found true the allegation that Joseph Maggard is a Sexually Violent Predator (SVP). The Honorable Judge Nunley ordered Maggard to be committed to the custody of the California State Department of Mental Health for an indeterminate period of time in confinement and treatment.

Maggard has a lengthy criminal history of violent sexual assaults against many different women over a period of decades. He was incarcerated both in the 1960s and the 1970s for violent sexual assaults. Each time he was released from prison, he reoffended in a sexually violent way. During the summer of 1980, Maggard terrorized Sacramento by engaging in a series of rapes. The media dubbed him the 'jogger rapist' due to the clothing he wore. In that series of rapes, he was convicted of various forcible sex crimes against four different women and served a lengthy prison sentence.

Before Maggard was to be released into the community, the Sacramento County District Attorney's Office filed a petition to have Maggard declared a Sexually Violent Predator under California law. The law is aimed at protecting society from, and providing treatment for, that small but extremely dangerous group of sexually violent predators who have diagnosable mental disorders and who are determined to be unsafe if released into the community.

Deputy District Attorney David Brown commented, "I would like to thank the jury for their time and hard work. I recognize that the testimony was very difficult to listen to at times.

Their verdict helps ensure that Sacramento is protected from this individual engaging in future violent sexual offenses."

#### CASE: Gary Baker (12/20/12)

District Attorney Jan Scully announced that today her office has filed a complaint against Sacramento Police Officer Gary Baker on charges of rape, assault with intent to commit rape, forcible oral copulation (two counts), attempted forcible oral copulation, and sexual battery.

Sacramento City Police detectives arrested Baker pursuant to warrant and booked him at the county jail. Bail has been set at \$1 million.

#### CASE: Belisa Serna-Mayorga (12/18/12)

District Attorney Jan Scully announced today an arrest warrant was issued for Belisa Serna-Mayorga. Serna-Mayorga was formerly the council operations manager for the Office of the Mayor of the City of Sacramento. Sacramento City police detectives arrested her and booked her at the county jail. Bail has been set at \$50,000.

Serna-Mayorga was issued a Sacramento City bank purchasing card to be used solely for City business. It is alleged that from July 2009 to June 2012, Serna-Mayorga used the card for personal items totaling over \$19,000. Among the illegal charges were two Disneyland trips for her and her family in December of 2010 and June of 2012; hotels in Bodega Bay and Monterey; clothing; makeup; restaurants; grocery bills; and numerous iTunes games, music, movies, and entertainment applications.

In June of 2012, when an internal audit revealed Serna-Mayorga had not been submitting the required paperwork documenting her purchases, she admitted that numerous charges were personal. On June 28, she wrote two checks to the City of Sacramento totaling \$3,029.17 for food and travel related purchases. Shortly thereafter (July 18) Serna-Mayorga wrote another check to the City for \$6,000 to cover additional personal expenses she had charged. However, stop payments were placed on all three checks before the City could submit them for deposit, and in any event Serna-Mayorga's checking account did not have the funds to cover the checks. The investigation found that for some of the accounting documents she had submitted to justify her purchases, the signature of the mayor's chief of staff, Kunal Merchant, was forged.

Serna-Mayorga has been charged with felony offenses of misappropriation of public funds, grand theft of public funds, forgery, and making or drawing worthless checks. The maximum punishment that may be imposed for these offenses is six years, eight months in state prison.



## Carmichael Event to Honor VIP and Local Achievers


