# Jump Again

SACRAMENTO REGION -Average retail gasoline prices in Sacramento have risen 25.8 cents per gallon in the past week, averaging \$4.00/g yesterday. This compares with the national average that has increased 5.4 cents per gallon in the last week to 3.67/g, according to gasoline price website SactoGasPrices.com.

Including the change in gas prices in Sacramento during the past week, prices yesterday were 32.9 cents per gallon higher than the same day one year ago and are 41.6 cents per gallon higher than a month ago. The national average has increased 24.8 cents per gallon during the last month and stands 5.7 cents per gallon higher than this day one year ago.

"The national average has spiked 25-cents per gallon just in the last month, thanks to an onslaught of refinery problemsmainly in the Great Lakes and California," said GasBuddy.com Senior Petroleum Analyst Patrick DeHaan. "While these situations are temporary in nature, it goes to show this nations dependence on domestic refineries. While oil prices have gained in recent days, there is some light at the end of the tunnel for motorists: driving season will be over in less than a month and soon thereafter the EPA also relaxes gasoline mandates, meaning cheaper winter fuel," DeHaan said.

GasBuddyoperates SactoGasPrices.com and over 250 similar websites that track gasoline prices at over 140,000 gasoline stations in the United States and Canada. In addition, GasBuddy offers a free smartphone app which has been downloaded over 20 million times to help motorists find gasoline prices in their area.



# Shed Fire Threatens Duplexes

SACRAMENTO – On August 8, 2012 at 2:45pm, Metro Fire responded to a reported structure fire at 4724 River College. Crews arrived to find heavy smoke coming from the rear of a single story residential home. Crews made access to the back of the home to find a small shed, approximately 6 feet by 8 feet in size. The shed was fully engulfed in flames with potential fire spread to two nearby duplexes.

Fire crews quickly doused the flames and extinguished the fire.

The shed and contents were a total loss. However, damage to the nearby duplexes was limited to minor exterior heat damage only. Nobody was home upon arrival of fire crews and nobody was injured in the blaze. The cause of the fire is still under investigation.



# **Brokering A Better Healthcare System**

The Supreme Court recently affirmed that President Obama's health reform law is indeed constitutional. Supporters of the measure have rejoiced that America may finally be on its way toward achieving universal health coverage.

Unfortunately, the newly upheld law undermines one of the chief means of expanding access to affordable coverage, particularly among small businesses — by threatening to put thousands of insurance agents out of work.

The Affordable Care Act (ACA) requires insurance companies to devote no more than 20 percent of premium dollars to administration and profit. This "minimum medical loss ratio" may seem like a reasonable way to ensure patients get their money's worth.

But it puts the jobs of insurance agents at risk - to their detriment and that of their customers.

Last year, the Department of Health and Human Services ruled that insurers had to count commissions paid to agents as administrative costs.

Insurers responded by slashing commissions. The Government Accountability Office found that commissions for many agents were cut by 50 percent.

Consequently, some agents are leaving the business or downsizing, laying off employees just to keep their doors open. Already, one in five has done so. And that number will likely grow.

Ironically, just when many consumers would benefit from brokers' expert counsel on the healthcare law and its benefits, that same law is winnowing their ranks.

Treating agents as mere

anyone who's had to buy insurance on their own. Or ask the 75 percent of small businesses who rely on brokers — including many who use them as de facto human resources departments.

Independent agents do more than just sell insurance policies. They help consumers navigate a rapidly changing marketplace and secure the best coverage at the most affordable price. They don't work for insurance companies but for their clients, often serving as consumer advocates when billing and claims issues arise.

The National Association of Insurance Commissioners which represents state insurance regulators — has called agents "essential" to a functioning, consumer-friendly marketplace.

Take the case of John Walley, an Alabama-based agent. Upon meeting with an 80-year-old client, Walley discovered that she was living alone in a disheveled trailer and spending nearly a quarter of her \$400 monthly income on Medicare premiums. Walley applied for Medicaid for his client, which waived her \$96.40 monthly deductible. He also enrolled her in a Special Needs Plan that exempted her from paying the deductibles and co-pays that kept her from seeing a doctor for 15 years.

Or consider New Jersey agent Thomas Kohler, who intervened on behalf of his client in a hospital billing dispute — and succeeded in lowering the client's medical bill from \$7,000 to \$3,000.

Defenders of the medical loss ratio claim that brokers won't be needed once the health insurance exchanges mandated by the ACA are up and running in 2014. Consumers will then be able to pick from a menu of health plans

overhead is a mistake. Just ask on a government website, they say.

> But shopping for health insurance is more complicated than buying a pair of shoes online. Consumers are often confused by pages of legalese describing benefits, deductibles, and provider networks. Some may be inclined to make choices based solely on price, which might not be the wisest course.

> More importantly, unlike a pair of shoes, a consumer will only find out if the policy "doesn't fit" when he's sick or injured when it's too late.

> In its own programs, the federal government has experienced how difficult it can be to expand access to insurance without agents.

> Consider the health law's temporary Preexisting Condition Insurance Program, which was supposed to provide coverage to "high-risk" consumers.

The law initially gave agents no role to play in attracting people to the program. Not surprisingly, very few signed up. Just 18,000 had done so by March 2011 — less than 5 percent of the 375,000 that federal officials expected by the end of 2010.

So the feds enlisted the help of agents. Immediately, enrollment climbed — by 400 percent over the past year and 24 percent over the last few months.

Lawmakers have historically recognized the importance of agents and brokers. And they must continue to do so. Otherwise, brokers will vanish from the marketplace. That would be bad news not just for the patients who depend on them as advocates — but for the broader job market, too.

Recent cases of interest

#### CASE: Carlos Martinez-Palacios (08/06/12)

**CONTACT: Deputy District Attorney Caryn Dubke, 874.7310** 

District Attorney Jan Scully announced today that 25-year-old Carlos Martinez-Palacios was convicted by jury for the transportation of methamphetamine and possession for sale of methamphetamine.

On October 18, 2011, a Sacramento County Sheriff's Department detective assigned to the California Multi-Jurisdictional Methamphetamine Enforcement Team (CAL-MMET) conducted a traffic stop. The deputy received consent to search the car, which revealed 1¼ pounds of methamphetamine.

Martinez-Palacios faces a maximum sentence of 4 years in jail. Sentencing is scheduled for September 6, 2012 at 1:30 p.m. in Department 37 before the Honorable Ben Davidian.

#### CASE: Jessie Moore (08/07/12)

#### CONTACT: Deputy District Attorney Jeff Harry, Domestic Violence Unit, 916.874.5873

District Attorney Jan Scully announced today that the Honorable Raoul Thorbourne sentenced Jessie Moore to 32 years to life in prison. Last month, Moore was convicted by jury of attempted voluntary manslaughter and the use of a firearm allegation, discharging a firearm into a vehicle and the allegations of discharging a firearm causing great bodily injury and personally inflicting great bodily injury in a domestic relationship, and being a felon in possession of a firearm.

On August 12, 2010, Moore drove his car to the victim's friend's house on Sea Forest Way to retrieve money he believed the victim stole from him. Once arriving at the house, he parked his car outside in the street. The victim and her friends exited the house, got into the friend's car, pulled the car out of the driveway, and drove down the street. Moore pulled up next to the passenger side of the vehicle and screamed at the victim to give him his money. He then immediately pulled out a large caliber revolver, aimed it at the victim's head, and fired five to six shots into the vehicle. One of the bullets struck the victim in the right rear shoulder and became lodged in her left rear shoulder. Moore then fled the scene and was arrested seven months later in Redding, California.

#### CASE: Patrick Enloe (08/06/12)

District Attorney Jan Scully announced that Patrick Enloe was convicted by jury of forcible rape, oral copulation, sodomy, sexual penetration, and kidnapping to commit another crime.

Over a four year time span, Enloe lured multiple women into his vehicle under the pretense of prostitution and drove them to an isolated area where he sexually assaulted them. With the hard work of the Sacramento Police Department and Sacramento County Sheriff's Department, a serial rapist was removed from the streets.

Sentencing is set for September 7, 2012 at 10:00 a.m. in Department 21 before the Honorable Steve White.

#### CASE: SSD Deputy Kelly Smith (08/06/12)

#### **CONTACT: Assistant District Attorney Albert Locher, 874-6150**

District Attorney Jan Scully announced today that 43-year-old Kelly Curran Smith was sentenced by the Honorable Kevin McCormick following her convictions for identity theft and unlawful possession of a controlled substance.

While a deputy with the Sacramento County Sheriff's Department, Smith befriended the 90-year-old victim. Smith ordered and acquired Hydrocodone (Vicodin) using the victim's prescription information she obtained during a visit.

Smith has enrolled in a drug diversion program on the unlawful possession of a controlled substance charge. She was placed on five years of probation and ordered to serve 120 days on the identity theft charge.

#### CASE: Andrey Bernik (07/27/12)

#### **PROSECUTOR:** Deputy District Attorney Kevin Greene

District Attorney Jan Scully announced today that the Honorable Troy Nunley sentenced Andrey Bernik to 45 years to life in prison.

In November 2011, Bernik was convicted by jury of second degree murder for the April 2006 shooting death of Yury Dovgan. The jury also found true the special circumstance of shooting from a motor vehicle and personal use of a firearm causing death.

#### SUBJECT: IHSS/SEIU Protestors (07/26/12)

District Attorney Jan Scully announced today that her office has declined to file charges against the group of protestor cases arising out of protests over budget cuts to the In-Home Supportive Services (IHSS) program.

Scully stated that although the protestors technically violated the law by their conduct at the Capitol, they were not violent and did not resist arresting officers.

In this time of limited resources for the District Attorney's Office, the county, and the courts, these cases do not warrant prosecution and so prosecution is declined in the interest of justice.

Scully complimented the CHP on their professionalism in handling the protestors and stated the arrests were appropriate to address the protestors refusal to leave the Capitol building.







A Film Review by Tim Riley TOTAL RECALL

(Rated PG-13)

If you remember, "Total Recall" starred Arnold Schwarzenegger and Sharon Stone in a science-fiction thriller, based on a Philip K. Dick story, about a man with erased memories that come back and trigger all sorts of mayhem.

The new "Total Recall," to be sure, is a remake of the 1990 film, but there a lot of differences, which I will not dwell on because my memory has pretty much failed me and, well, it is time to move on.

What is new is the setting of Earth, in the not-so-distant future, where chemical warfare has rendered most of the planet uninhabitable, with the exception of Australia and the United Kingdom.

Australia is called the Colony because it is a suburb for migrant workers, while the British islands are now called the United Federation of Britain (UFB), the upscale city center, home to the elite and government leaders.

Colin Farrell's Douglas Quaid works in a factory that assembles the robotic police force known as Synthetics, droids that look like cheap imitation Imperial storm troopers on loan from "Star Wars."

Living in the Colony, Douglas commutes to his job in an elevator-like chamber that rockets through the Earth's core in mere minutes. It's a nifty contraption that might be used as a selling point for high-speed rail, though

overruns. The landscape in the squalid Colony is reminiscent of the bleak world of "Blade Runner," but here the drab architecture is so gray that it recalls the Stalinist era of unappealing public housing.

In science-fiction movies, life in the future hardly ever looks very promising. I guess if it really looked like a utopian dream, it wouldn't seem all that intriguing or result in a compelling story.

Unfortunately, familiarity with the theme of "Total Recall" does not make for an entirely persuasive account of one man's struggle against the governmental leviathan. But it's still fun to see a dogged guy take on the villains.

But for recurring nightmares, Douglas would probably remain comfortable coming home at the end of the day to his attractive bride Lori (Kate Beckinsale).

Yet, something nags at his conscience, and he pays a visit to Rekall, a company that offers to create pleasant memories with the help of a chemical implant.

The session goes horribly wrong when the Rekall process triggers Douglas' repressed memories of his past life as a secret agent.

Alarm bells go off and the UFB security forces descend on the laboratory. When the dust settles, Douglas has killed about two dozen federal agents in a big shootout.

Forced to go on the run, Douglas quickly learns that there are very few people he can trust, least of all his wife, who turns out to be a highly-trained UFB operative skilled in martial arts and all sorts of weaponry. That Douglas is considered a person of interest to the government controlled by Chancellor

ment controlled by Chancellor Cohaagen (Bryan Cranston) is something of a puzzle, because we are not entirely sure for what side Douglas was once a spy.

Because the government run by Cohaagen is so autocratic and ruthless, there is the inevitable resistance movement that the Chancellor's minions are relentlessly seeking to destroy.

The rebel leader is identified as Mathias (Bill Nighy), who is so well-hidden that not even his own operatives know the actual location of his hideaway.

Once on the lam, Douglas is aided in a getaway in a thrilling high-speed levitated auto chase by rebel commander Melina (Jessica Biel).

Apparently, Douglas and Melina had a previous history together, but the chases and confrontations with the opposite forces leave little room or time to rekindle the old romantic flames.


"Total Recall" is heavy on action and great special effects, leaving insufficient time for existential reflection on the troubling implications of the dystopian universe in which the oppressed are trapped under the thumb of the evil Cohaagen.

Fear not, this film is, above all, filled with graphic action and brutal violence, and Douglas Quaid becomes an effective action hero, albeit one without any special or unusual powers.

Visual effects, large and small, represent remarkable feats in "Total Recall," from the complex moving parts of the elevator systems to the simple glowing cell phone implanted in Douglas's right hand.

It matters not at all that logic is sometimes missing, because the end game, sought by director Len Wiseman, is to deliver the action goods.

Well, the director succeeds, even though few of us may recall his movie to any great degree mere weeks from now.

Every once in a while, California's voters think they are doing the right thing, but the results do not turn out to be what was intended. This will be the case if they pass the food labeling ballot initiative. Supporters of this initiative recently submitted enough signatures to place it on the ballot this fall.

The trial lawyer who wrote this little gem would like it to be called the California Right to Know Genetically Engineered Food Act. This is likely what will appear on the ballot this fall and on the surface, it would appear to be right in California's wheelhouse.

However, if an initiative is written by a trial lawyer you might want to take a closer look. I certainly understand that people want to know whether the food they buy contains genetically engineered ingredients, but there are two things about this initiative that make me wonder whether this is about knowing what is in your food or actually just a method of creating more ways for trial lawyers to sue.

The Law of Unintended Consequences:

First, if this initiative was about informing consumers about ingredients, why does it exempt milk, cheese, eggs, beef, pork, chicken, alcohol and food sold in restaurants? It seems strange that the author claims to want to prompt a serious discussion about food yet some of the products people are most concerned about are exempted.

Second, buried deep in the initiative under the "enforcement" section is one of the oldest trial lawver tricks of the trade: a private right of action, which allows any person to file a lawsuit alleging a violation of this initiative. No government agency will enforce this initiative; it will be a group of lawyers. And what is even more stunning is that, in the words of the initiative, the individual who sues, "shall not be required to allege facts necessary to show, or tending to show, lack

show, or tending to show, irreparable damage or loss, or to show, or tending to show, unique or special individual injury or damage.'

What does that exactly mean? It means lawyers can sue anyone selling food without showing that they even violated the law. Under the guise of informing consumers about their food, lawyers wrote this initiative to create a new way to sue small businesses, small family farmers and small grocers. Plaintiffs' attorneys will use this law to file lawsuits and force these small businesses into quick settlements.

We have seen this already with predatory lawsuits alleging violations of the Americans with Disabilities Act. We wanted more access and instead we have gotten more lawsuits. We saw this with Proposition 65. We wanted clean drinking water and instead we have gotten a bunch of trial lawyers shaking down small businesses for quick settlements.

The last thing California needs right now is more lawsuits. Our state is reeling from one of the worst economic periods in its history. Court funding has been slashed. This initiative means one thing: more lawsuits.

This is just another vehicle for greedy trial lawyers. You have a right to know.


