Get Ready for the **Annual Parkway** Half Marathon SACRAMENTO REGION -

Sacramento Friends In Training (SacFit) and Capital Road Race Management (CRRM) announced recently that the Sixth Annual American River Parkway Half Marathon-a leading fundraising running event for the benefit the American River Parkway – will host over 4000 participants and 300 volunteers this weekend.

Women's Empowerment Program **Celebrates 900th Success Story**

SACRAMENTO REGION -Twenty-nine women graduated from Women's Empowerment's job-readiness program for women who are homeless on March 22, including the group's 900th graduate, Stacey Jackson, age 53. Jackson is now in housing and enrolled in Paratransit Inc.'s vehicle operator training program.

'Women's Empowerment showed me that you can do things and make changes after 50," Jackson said. "I am now very proud to see what I see when I look in the mirror. The changes I've gone through have shed a whole new light on my life."

Jackson was born in Missouri to a low-income military family that mostly at rice and beans. She and her sisters slept in one room while her brother slept in the living room. She married, and 31 years later, her husband left her. She lost her house and turned to Women's Empowerment for help. At Women's Empowerment, she drew on her father's work ethic and encouragement to continually "better themselves."

"At orientation, I was asked why I wanted to come to Women's Empowerment," Jackson said. "I told them I have too much talent and too many skills not to share myself with the world."

More than 200 community members, including graduates mentors and families, attended the graduation where each graduate shared her story and future plans through poetry, songs and speeches centered around the theme, "diamonds in the rough." Each woman received a donated gift bag filled with

SACRAMENTO REGION -Foreign high school students are scheduled to arrive soon for academic year homestay programs, and the sponsoring organization needs a few more local host families. The students are anxiously awaiting news of their new families. This is the last chance for these young ambassadors to fulfill their life-long dreams, and their placement deadlines are rapidly approaching.

According to Pacific Intercultural Exchange (P.I.E.) President, John Doty, the students are all between the ages of 15 and 18 years, are English-speaking, have their own spending money, carry accident and health insurance, and are anxious to share their cultural experiences with their new American families. P.I.E. currently has programs to match almost every family's needs, ranging in length from one semester to a full academic year, where the students attend local public and private high schools.



DMV: "Ask George"

Expert Answers to Common DMV Questions



By George Valverde – Director, California Department of Motor Vehicles Do you have questions about general driving related requirements like registration and insurance?

Are you unclear about laws and restrictions related to driving?

The California Department of Motor Vehicles has answers.

"Save Time by Going Online," at www.dmv.ca.gov.

Q: I am moving out of state. I know my California vehicle registration is due soon. Should I notify the California DMV that my car will no longer be in the state?

A: As with any time you move, you should report this change of address to the California DMV using a Change of Address form that can be found at www.DMV. ca.gov. Please also notify DMV, in writing, to report that the vehicle was removed from California and will be registered in another state or country. Your letter must include the following information:

· California License plate number,

· Vehicle identification number, and · Date vehicle left California (MM/ DD/CCYY), and mail to: DMVPO Box 942869, MS

C271Sacramento, CA 94269-0001 A status will be added to the vehicle record to prevent billing notices from being mailed.

Q: Is it possible to "remove" points from your driving record?

A: Points are not something you want on your driving record,

and they can be assigned as a result of collisions or traffic tickets. Generally, collisions where you are at fault are one point and tickets are between one and two points. The only way to remove points from a driving record is to wait.

Most points stay on your record for three years. Depending on severity, points may stay on your record for up to 10 years. If you receive a traffic citation, some courts will allow you to attend traffic violator school to keep a point from being added to your record. To avoid accruing points, always follow the traffic laws and avoid reckless behavior. Be certain that you are driving defensively and never distracted while on the road. Keep this advice in mind, and you will be able to keep points off of your driving record! For more detailed information about points on your driving

record, visit www.DMV.ca.gov. Q: I received a letter stating that my Personalized License Plate request was denied. Why wasn't I informed of this when I placed the order online?

A: When ordering a Personalized License Plate online, a general search of our records allows the order if the plate configuration is available. However, specific regulations require DMV to review every order and ensure that the plate does not violate these regulations. This manual process is not done when your plate is ordered. When the review is complete, a final determination regarding the acceptability is made and the customer is notified. For more information on specialized plates, please visit www.DMV.ca.gov.

The DMV is a department under the Business, Transportation and Housing Agency, which is under the direction of Acting Undersecretary Traci Stevens. The DMV licenses drivers, maintains driving records. registers and tracks official ownership of vehicles and vessels, investigates auto and identity-related fraud, and licenses car dealers, driving schools, and traffic violator schools. Obama's Monumental Misunderstanding

President Obama recently complained about the possibility of the Supreme Court striking down Obamacare. He used the term "unprecedented" and was critical of "judicial activism" engaged in by "unelected" judges. In so doing, he showed his monumental misunderstanding of American government, which should be of concern to every American who values constitutional government.

Let's take each claim in turn. The first is the assertion that if the Supreme Court were to find the healthcare law to be unconstitutional, it would be acting in an unprecedented way. As my beginning undergraduate constitutional history students know, the Court has struck down all of or parts of federal enactments for over 200 years. Beginning with the best-known constitutional case in American history in 1803, Marbury v. Madison, Supreme Court justices established themselves as members of that branch of government whose province it is to strike down any legislation that is repugnant to the higher law of the Constitution. Ever since, when necessary, the Supreme Court has acted in that capacity. The latest U.S. Government Printing Office tally of Congressional acts declared unconstitutional by the Supreme Court through 2002 lists 158 pieces of legislation

struck down. If one adds state and local laws found unconstitutional by the Court, the number is over 1,300.

The president also complains that the judges who threaten his Affordable Care Act are "unelected." Of course, Obama knows full well that Supreme Court judges, as with all federal judges, must be appointed by the president of the United States, an elected official. Further, all federal judges must be confirmed by action of the Senate, also made up of elected officials. The idea that no elected officials play a part in choosing Supreme Court judges is fiction. What is more perplexing about the president's statement is that he himself has appointed two Supreme Court judges. If he were to be elected for a second term, he would likely have the opportunity to appoint another Supreme Court judge, meaning that he would have appointed one third of the Court. Also, what the president refuses to recognize is that the Founders did not intend the federal government to be constituted entirely by direct popular election. The government is to be made up of a mixture of elected and appointed officials to resist, among other things, the power of short-lived majorities to destroy long-standing constitutional protections.

Finally, President Obama argues that if the Supreme Court found his healthcare law unconstitutional, it would be an

example of "judicial activism" long condemned by conservatives. Again, the president sees any legitimate restraint on his ideological agenda as unwarranted. The careful consideration of whether a piece of legislation is consistent with the powers granted to the legislative branch by the Constitution is not judicial activism. It is doing what the Court is called upon to do restrain attempts by any branch to usurp power. Real judicial activism occurs when the Court concocts "new rights" which are not found in the Constitution nor approved by any legislature, such as in Roe v. Wade.

President Obama is wrong on all three counts. If the Court strikes down Obamacare, it will be nothing new, and it will not be the product of judicial excess.

2. Perfect Persimmons



IRS Tax Resolution or Tax Problem Complication

The relationship between the IRS and taxpayers who have tax problems is parallel to a citizen relationship with government, any government. It is a powerful Leviathan vs. a helpless governed. Anyone who is calling for additional power to the government should be the first put to hang by the very government he is advocating for.

What is a government anyway? A government is any police officer in the street. One that has the power to book you to later release you "because there was no charges to be pressed." It is any one in EPA, any one in immigration department, the CIA and the IRS.

It is a relationship between a citizen vs. citizen. One of the two has worn a uniform that gave him Devine mandate to be superior. One citizen who can be making mistakes and may apologize, at best, and moves on. The other citizen apologizes to be scoffed off and laughed at, "Don't you know that we need evidence. We need papers." Apology does not avail the hapless citizen, the normal citizen, the governed citizen. He needs to prove, always prove, apology won't do.

I submitted a package that was subject to an IRS audit. The package was left there somewhere in a stack somewhere in an office corner without being acted on. The IRS is tying up over four hundred thousand dollars to

be held from the taxpayer until the IRS makes a decision on the case. You would think they will after one conference with them to have a tax resolution, after two conferences, after even ten conferences? Ten conferences did not do the trick. They would not start the tax audit and they would not allow the money to be released.

ten months later and complain upon compliant, they finally assigned the case to an auditor after taxpayer advocate gets into the picture to start the tax audit. The auditor, mighty, dignified and superior as always, wanted some papers which I have previously given to the IRS (I sent all my documents twice because they lost the original documents or they don't want to look for it.) Then with full authority, the auditor in charge of the tax audit gives me a deadline of one week to send the documents.

Now I want to get this right. You have had the documents for several months without even looking at it. After I beg and scream murder to everyone that would listen, you give me one week? I will be happy to comply with the week. Actually I welcome the speed.

But you would think there may be an apology and some consideration to allow taxpayers a space to comply, especially after the long negligence on their part. This is the government that







AMERICAN REUNION

(Rated R) For today's youth market, the delectably humorous "American Pie," though familiar in pop culture, will not be as fresh as, let's say, baked goods straight from

The sexual frustrations of high school seniors in 1999 was the foundation for plenty of raunchy humor, and by contemporary standards, "American Pie" is now almost dated.

In the intervening years, we've been subjected to the crude humor generated by Judd Apatow's school of comedy, from "Superbad" to "Knocked Up" to "Bridesmaids," just to name a prominent few.

Now, for no apparent reason other than to cash in on the good name of the "Pie" franchise, along comes "American Reunion," which wants to recapture some of the original film's underlying sweetness. And in spite of the misfires of previous sequels, it actually does.

Yet, the modern climate almost requires descending to the elemental nature of crude humor, whether brilliantly realized in "The Hangover" or uncouthly hewing to "American Pie's" unfortunate straight-to-video disasters.

"American Reunion" is a gamble by any measure, as its focus on a high school reunion that takes place, oddly enough, 13 years later is a sign of something

To enjoy a sequel happening so many years later, "American Reunion" demands familiarity with all the lovable characters, from the Stifmeister and Finch

to Jim's dad and Stifler's mom. The nominal protagonist is the awkward good guy Jim Levenstein (Jason Biggs), who married his high school sweetheart Michelle (Alyson

Hannigan). Now, they have a toddler son, but a sex life gone stale.

Jim, of course, remains famous for a viral YouTube posting of his sexual antics in his school days. A return to East Great Falls for the reunion will rekindle a lot of memories, many of them embarrassing.

The reunion brings together the other familiar old school pals. Finch (Eddie Kaye Thomas) travels the world on his motorcycle, and we wonder if we will reunite with Stifler's mom (Jennifer Coolidge), who remains as lustful as ever.

Kevin (Thomas Ian Nicholas), now also married, is an architect. The flamboyant Oz (Chris Klein) has found his place as a sportscaster and competitor on "Celebrity Dance-Off."

Both Kevin and Oz, one married and the other in a committed relationship, find some old passions rekindled when their former loves, Vicky (Tara Reid) and Heather (Mena Suvari) respectively, also show up.

Only Stifler (Seann William Scott), eternally crash and rude, with his wicked smile expressing unrestrained mischief, lingers in a state of perpetual adolescence.

Whether it is doing something unspeakable to someone's beer cooler or hitting on high school girls by faking interest in "Twilight," Stifler continues to be game for adventure and temptation.

Come to think of it, Jim's dad (Eugene Levy), always ready to give his son unwanted advice on sexual matters, is a comforting constant presence, because he's so damn funny.

Some of the best humor involves the discomfiting and embarrassing situations that usually ensnare the often inept and clueless Jim, even now that he's all grown-up.

A classic case is when Jim ends up in a compromising position with the drunken, naked body of the hot 18-year old neighbor Kara (Ali Corbin) that he used to baby-sit.

As Jim tries to get Kara back up into her bedroom undetected, Oz, Stifler and Finch fumble through clumsy efforts to preoccupy Kara's parents from discovering an unpleasant truth.

The agreeable reality of "American Reunion" is that, even if it is an irrepressibly ribald comedy with plenty of coarse gags, it is just outright funny.

To fully appreciate the bawdy humor one must be familiar with the "American Pie" franchise, but only the films that made it to a theatrical release.

Faldo thought it was pretty darn cute when "Ooo, Ooo" Oosthuizen, after he made just the fourth double-eagle ever at The Masters, flipped his famous golf ball to a fan in the well-behaved crowd without incident. Contrasting that to what would happen at a baseball game, St. Faldo said, 'That was pretty civilized."

But, be honest — what gets you more worked up, more excited, a nice, soft touch on a subtle, 12-foot putt for par, or... a Gordie Howe hat trick?

Well, I was pretty relaxed in the recliner watching the golfers. But when the San Jose Sharks had two Howe specials in their 6-5, shootout victory over the L. A. Kings last week, I got up to toast them with another beer. Two guys each with a goal, an assist and a fight in the same hockey game deserves as much.

The Sharks, almost given up for dead in the playoff push at the end of the season, had to win seven of their final nine games, including the last two in exciting overtime fashion over the Kings, to claim the seventh postseason seed in the Western Conference. Their string of five straight Pacific Division titles was broken by Phoenix, but they reached the playoffs for the seventh consecutive season.

Those last Kings' games were like playoff games and there's not many things in sports more intense than playoff hockey. End-to-end, fast, physical, skilled non-stop action with a lot on the line — and they are doing it all on ice skates! It just grabs me a little more than some country-clubber strolling up the fairway in his plaid slacks.

The fights aren't usually as they were in "old-time hockey," though they do still go over the top once in awhile. It's a physical, intense sport and sometimes emotions can run pretty high, and maybe the gloves will come off. That's so uncivilized, but exciting — darn it.

I haven't seen any hockey players crying when they win, or lose.





A Case in Point

The Case of the **Unlucky Driver**

There's a tug-of-war in society between technology, which changes rapidly and constantly, and the law, which changes gradually and infrequently. Technologies such as cell phones or "tweeting" alter the social patterns of everyday life. The law struggles to catch up and stay relevant.

That's brings us to the story of Carl Nelson, the unlucky driver.

Mr. Nelson was driving his car in the city of Richmond, California on the morning of December 28, 2009. He stopped at a red light and decided, like many of us, to make use of the waiting time. Mr. Nelson opened his "flip-style" cell phone and began dialing to check email.

At this precise moment, a police officer pulled up on a motorcycle directly next to the driver-side door. The officer saw Mr. Nelson holding a cell phone to his ear and dialing. Mr. Nelson looked over, saw the police officer, removed the cell phone from his ear and closed it. We don't know Mr. Nelson's thoughts at this point, but they probably consisted of a two-word expression beginning with "Oh."

When the light turned green and Mr. Nelson drove through the intersection, the officer pulled him over and ticketed him for using a cell phone while driving. In traffic court, the ticket was upheld and a fine of \$103 was levied.

Most people would have given up and paid the \$103. Mr. Nelson, however, was sufficiently disturbed that he retained California Appellate Court, First District, agreed to hear the case.

Mr. Nelson's lawyer made an interesting argument. He acknowledged Vehicle Code, Section 2313(a), which says, "A person shall not drive a motor vehicle while using a wireless telephone unless that telephone is specifically designed to allow hands-free listening and talking...'

That's the key, argued the lawyer. Mr. Nelson wasn't driving a motor vehicle. He was stopped at a red light and posed no risk to anyone. To quote the legal lingo: "The term 'drive' requires evidence of volitional movement of the motor vehicle as an element of the offense.'

To use a cell phone while stationary was no more hazardous than various other things people do while waiting for a light to change - putting on makeup, eating a messy sandwich, reading a map, or changing radio stations, according to the argument.

The lawyer cited a 1991 decision, Mercer v. Department of Motor Vehicles. Police found a man asleep over the wheel of a car that was legally parked at the curb. The car had its lights on and engine running. The defendant was fined for driving under the influence – but on appeal the fine was overturned. Yes, Mercer was drunk; however, when police observed him, he wasn't driving. He was legally parked and asleep.

That gets us back to the Nelson case. When the Court announced a law firm and appealed. The its decision, it turned out that Mr. Nelson's luck hadn't improved. He lost again.

"Driving" a car, said the decision, meant the same as "operating" a car. The court cited various cited California laws that used the words "drive" and "operate" interchangeably.

The drunk driver in Mercer was in a different situation. Mercer wasn't going anywhere, nor was he about to. However, drivers at a red light are still "operating" a car, and could pose a hazard if distracted - by their feet letting up on the brakes, for example, or by failing to promptly move as required by the traffic laws.

If Mr. Nelson wanted to use a cell phone at a red light, the Court concluded, he should install a hands-free wireless system and be in compliance with the law.

My guess is that California will have more litigation like this. What if I am stuck in dense traffic and call home to alert my family? What if I am in line at the McDonald's drive-thru and use the time to check email or call the office? Technology and law are destined to continue skirmishing in the courtroom.
