Abused Birds Need Your Rescue

CARMICHAEL – Mickaboo Companion Bird Rescue (www.mickaboo.org) is a non-profit Northern California animal rescue, focusing on the intake and rehabilitation of unwanted, neglected, and abused companion birds. The term "companion bird" means essentially any pet bird in someone's home. Mickaboo has almost 300 birds currently available for adoption, ranging from perky little budgies to large majestic macaws.

Birds that come to Mickaboo have often been neglected and otherwise mistreated. Many are ill, with owners unable or unwilling to pay for urgently needed medical care. Monthly veterinary bills run upwards of \$15,000.

Mickaboo provides a spectrum of services to people and birds including: Bird care education, Foster care for surrendered birds, Avian vet care, Outreach to highlight the plight

of homeless birds, Adopter recruitment and support and Behavioral consultation.

Mickaboo is hosting a free adoption fair on Sunday, March 18, 2012, 11 am - 4 pm at the Carmichael Public Library, 5605 Marconi Avenue, Carmichael. Take advantage of this chance to meet and greet some of the many birds that are up for adoption. Bird care supplies and a free basic bird care class will be available.

PEG O' MY HEART

CARMICHAEL – Affectionately nicknamed "Snookums" by her mother, Margaret "Peg" Aldrich was born December 14, 1910, in Pearce, Colorado.

She was four years old when her father decided to leave Colorado and his job as a policeman, and follow the old Oregon Trail in a camp wagon, with a cow trailing behind. They had traveled through most of Idaho, when her father commented, "We just passed through the land of milk and honey."

Initially landing in Boise, they moved to Twin Falls, and then the west end of the county onto a sheep farm, where her father worked for a rancher.

"It was a hardship," recalls Peg. "It was a big, big ranch. We had lots of rattlesnakes. It was scary."

Her father used a walking plow, raising carrots and feed for the sheep. "We had thirty-five

bum lambs (rejected or abandoned by their mother). We had a donkey they called "the guard." If you had a band of sheep, there was always a donkey with it.

One day, I said, 'You know, I think there's a coyote out there.' 'Why do you say that?' I said, "'Well, the cow is licking this little coyote.' But, she just had a calf."

Her mother belonged to the Ladies Aide, sang hymns, like "Sweet Bye and Bye," and sewed everything by hand, since she didn't have a machine. She had immigrated from Sweden at age 18, but never quite lost her accent. "I didn't notice it too much," says Peg, "but I would hear people say, 'I can't understand Mrs. Rogers.'"

Peg started school at age five. "We didn't have kindergarten in those days. It wasn't a big school – four rooms. My brother and I walked two and a-half miles to get there, until we finally rode with a group of young people in

a buggy. We thought that was wonderful."

During the summer, the kids swam in the canal, and in the winter they skated on it. Neighbors would get together for cookouts.

Peg's chores included feeding and taking care of the chickens. "I'd get 500 baby chicks in the spring." She also "shocked" the wheat, and made cottage cheese. "The milk sours and clabbers enough to make it kind of quiver. You heat it on the stove, and whey comes out of it."

During the winter, the men would saw big chunks of ice and bury them in the straw to keep things from spoiling too much."

She fell in love with "good looking" Bill Aldrich, who worked on the farm. They enjoyed a simple wedding on March 5, 1930. After moving to Buhl, Idaho, they welcomed daughter Barbara.

National Pancake Day Returns

SACRAMENTO REGION – For the seventh consecutive year, IHOP restaurants nationwide will offer each guest a free short stack of its famous buttermilk pancakes on National Pancake Day in an effort to raise awareness and funds for Children's Miracle Network Hospitals.

For every short stack of buttermilk pancakes served on National Pancake Day, IHOP guests are invited to make a voluntary donation to Children's Miracle Network Hospitals. Sudden Cardiac Arrest Survivors, Savers Reunite at Mercy San Juan Medical Center

SACRAMENTO – They are members of a unique club. When someone experiences sudden cardiac arrest outside of a hospital setting, American Heart Association statistics show that only about 8 percent survive. These survivors live to see their family and friends only because they were fortunate enough to have someone nearby who knew exactly what to do.

On Feb. 13, the Mercy Heart & Vascular Institute hosted its first Sudden Cardiac Arrest Survivors Reunion at Mercy San Juan Medical Center. The event gave seven sudden cardiac arrest survivors the opportunity to share time with people who had saved them. Their savers knew either how to perform CPR or had access to an automated external defibrillator (AED) needed to shock their heart back into a rhythm, so the patients had a fighting chance once they reached the hospital. Survivors were also reunited with the nurses and doctors who cared for them in the hospital.

The American Heart Association was on hand to stress the importance of knowing CPR and to award special framed certificates to the 11 savers in attendance.

Included among the sudden cardiac arrest survivors were area residents:

Stanley Hatfield, 71, of Fair Oaks
The day after Thanksgiving in 2009, he suffered sudden cardiac arrest while driving through the parking lot of Northridge Country Club. He drove across the 15th fairway before his car came to a halt. Kerry Gordon came upon him and administered CPR. Northridge General Manager Rink Sanford stepped in and took over CPR. Paramedics arrived and defibrillated him. He went to Mercy San Juan, was put in

hypothermia protocol and eventually received a stent and then quadruple bypass surgery. Now he's back to a full active life.

Louis Mahinay, 65, of Citrus Heights
In August 2010, he collapsed after the third inning while playing softball at Sacramento Sports Complex. Umpire Tom Bussey immediately started chest compressions. Luckily, his softball league mandates that every team includes an EMT-trained player. Fellow player John Mohamed (an EMT) helped with mouth-to-mouth resuscitation while Bussey continued chest compressions. An AED was used by another player. Paramedics arrived and took him to Mercy San Juan. He received two stents and then received an implantable cardioverter defibrillator. He's back to playing softball 2-3 times per week.

Taxes Not the Answer for California's Economy

SACRAMENTO – This month marks Presidents Day, and as we celebrate Lincoln's birthday it's timely that we look at the tax farce troubling his home state of Illinois. Last year, in a move that must have left legislative Democrats dizzy with admiration and envy, the Illinois legislature jacked personal income tax rates up by 67 percent and corporate tax rates up by nearly 50 percent. Despite assurances that were made when the taxes were passed, the legislature still has not closed their budget gap, and they won't until they get the political will to control their spending.

Let Illinois be a lesson to everyone who believes in the magical powers of tax increases. They do not occur in a vacuum. Unless governments have the discipline to rein in spending – which California certainly does not – tax increases just enable more extravagant spending plans and takes money away from the working families who have earned it.

California's problem is not that the people are taxed too little, but that the government spends too much. We have to examine every possible avenue for saving money so that we can keep providing core government services, such as education and public safety, at a price we can afford.

For example, why does California have a full-time legislature? Texas and more than 40 other states do just fine with part-time legislatures that meet far less often than California's and where the legislators make far less than we make every year.

Besides the savings, it's a good idea to get legislators away from the Capitol cocoon more often and out in the real world, living and working under the rules they pass in Sacramento. I own a business and I'm constantly frustrated by the maze of regulations that grows and changes with every legislative session. I know how hard California makes it for businesses to succeed.

In my business I can't just keep spending and spending and then force my clients to pay more and more to cover my spending. When times are tight, I have to cut back, find ways to save money, provide the same services more efficiently. Government should be taking that same approach, when unemployment is eleven percent and state government is running multi-billion dollar deficits. Now is not the time to be growing government.

But, incredibly, Governor Brown's budget plan spends \$6 billion more in 2012-13 than in 2011-12.

And to pay for it, Governor Brown and the Democrats want to pass the

bill along to their customers. The Governor is pushing for a five-year, \$35-billion tax increase. Sales taxes and income taxes will go up during those five years, costing families precious dollars that they could use for groceries, vacations, school clothes and thousands of other necessities that are already hard to afford in our high-cost, highly regulated state.

Let's take a private-sector approach before we shake down taxpayers any further. How about putting a stop to the \$100 billion-plus High Speed Rail plan that will soak up billions of dollars a year for decades? How about allowing schools to contract with the private sector to provide services like transportation or food service?

I oppose Governor Brown's call for higher taxes. State tax rates went down last year but state tax revenues are growing and are expected to continue growing for the next several years. This indicates that our economy – slowly and precariously – is moving forward. Let's not kill that momentum by larding on even higher, unnecessary taxes

Governor Brown Served with Summons in Second Amendment Lawsuit

Motion for Preliminary Injunction to be heard in April

SACRAMENTO – On Thursday, February 16th Governor Brown was formally served with a Federal Summons requiring him to explain to the Court why California's ban on openly carrying a loaded firearm in public places should not be overturned.

The Governor has 21 days to file his answer with the court, his

deadline is March 9th.

The following week, a motion for a preliminary injunction will be filed by the Plaintiff in the lawsuit, Charles Nichols – President of California Right to Carry a Second Amendment Advocacy group.

The hearing on the motion for the preliminary injunction will take place in early April. If the injunction is granted, California's 1967 ban on openly carrying a loaded

firearm can no longer be enforced until the Federal Court judge issues his final decision in the lawsuit.

California's recently enacted ban on openly carrying unloaded handguns would also be rendered unenforceable.

If the preliminary injunction is denied, Mr. Nichols will immediately appeal the denial of the injunction to the 9th Circuit Court of Appeals.

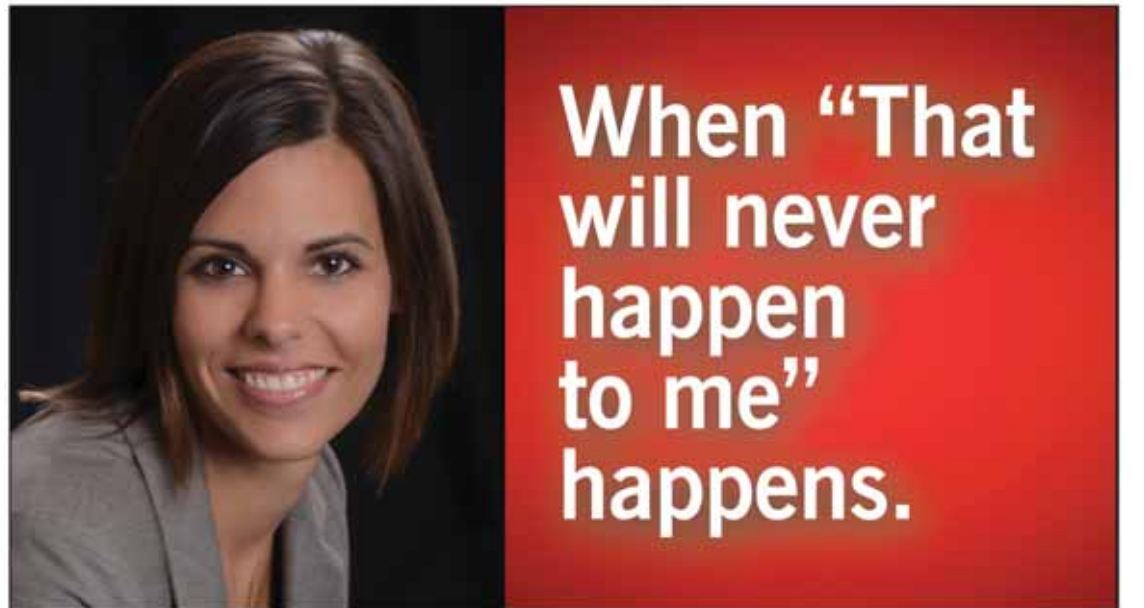

Why Mitt Romney?

He's ready to rebuild American success

The time has come for the Republican Party to close the deal. I believe Mitt Romney is the best choice for the presidency. Let me tell you why.

To begin with, like me, Mitt is a businessman, not a career politician. In other words, he's accomplished far more in his life than collecting campaign cash from special-interest groups and making promises at press conferences with the help of a teleprompter.

Mitt played an instrumental role in starting or managing such job-creating giants as Domino's Pizza, the Sports Authority, Staples and many other firms. He single-handedly saved the 2002 Winter Olympic Games from financial ruin and turned it into one of the best competitions in living memory. Amazingly, he governed blue-state Massachusetts as a conservative, balancing its out-of-whack budget while cutting taxes, feats carried out despite a Democratic-controlled legislature.

Mitt has what it takes to turn the country around. And he has laid out a plan to do just that.

Right now, China is cleaning America's clock. The Chinese are building the world's largest

airports, biggest ports, a powerful military and the best of everything. And we're paying for it all by purchasing their products. We're buying everything they make because they keep their currency artificially low, giving them an annual windfall of some \$250 billion. They are holding the yuan at a level at which it is impossible for us to compete.

Mitt Romney not only understands all this, he has thought through the policies we need to begin to set things right. Unless China changes direction, he has pledged to have the Treasury Department designate China as a currency manipulator on Day One of his administration. We can then impose duties on China's unfairly priced products. The Chinese will get the message faster than an ICBM. As Mitt has said, "We don't want a trade war, but neither can we accept our current trade surrender."

Fixing our trade relations with China is just one part of Mitt's comprehensive plan to get America back in gear. The Obama administration seems to have accepted record high unemployment as the new normal. But it is not acceptable to me, and it is not acceptable to Mitt that nearly 24 million Americans are unemployed, underemployed or no longer even looking for work. Mitt's jobs plan will create millions of jobs over four years, and I will be out there myself doing some of the hiring.

Some people call Mitt's jobs plan conservative. I happen to know something about creating jobs, and I call it common sense. Middle-income Americans deserve far better than the slow-growth and no-growth policies President Obama has put in place. They need a president who will make it possible for all Americans to get a bigger slice of a growing

pie rather than crumbs handed out by Washington. Mitt understands that government needs to get out of the way if American business is to do what it does best: innovate, make the products that people around the world want to buy, and hire American workers.

Right now, government regulations cost us annually \$1.75 trillion. They constitute a stealth tax that is larger than the amount the Internal Revenue Service collects every year from corporations and individuals combined. In just three years, Mr. Obama has added hugely to the annual regulatory bill. Mitt is going to pare that back and make sure every single regulation has benefits that outweigh costs and that they don't kill U.S. jobs.

Mitt also is going to rein in Mr. Obama's out-of-control spending and bring the federal budget back into balance. He's laid out the government programs that he's going to eliminate and cut. He's determined to trim the bloated federal workforce. That's going to take a lot of hard work and the negotiating skills of a successful businessman. It's precisely why we need someone with Mitt's financial background and business experience to run the country.



Peg was impressed with Lindbergh, but Amelia Earhart not so much. "We were not happy with her. She was a little bit overbearing and kind of imposing."

The movie theater had just one show a week, but she also enjoyed listening to Amos 'n Andy on the radio, tole painting, horseback riding, Bridge, bowling and sewing crafts, such as embroidery, crochet and knitting.

"At one time, Bill and I belonged to a dance club. It was for married couples. Different kinds of dances, like the waltz."

The family enjoyed picnics and spending the night in Hot Springs. Although they tried

Snake River, her 78-year-old father's boat capsized as he leaned over the side. Weak from stomach surgery, he floated on his back, letting the current carry him until he could grab onto some reeds. "He always told me not to panic if I got caught in a river. The current will carry you to safety."

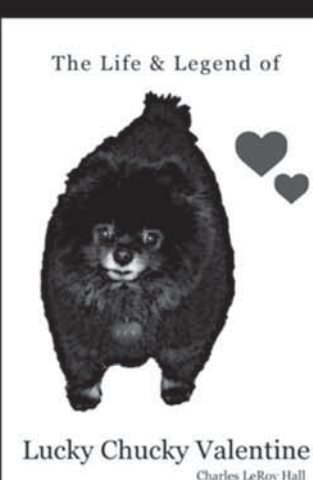

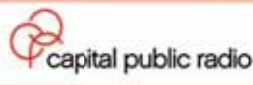

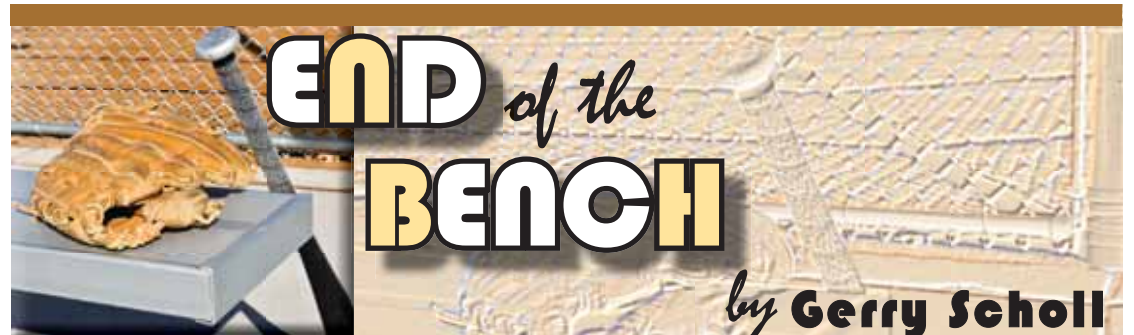

Of Rivalries and The Zone

Two of my favorite things in sports are rivalries and The Zone.

With the limited number of hours in a day to tune into sports, I always prefer to zero in on the classic matchups — the rivalries.

There have been a lot of rivalry games in college basketball lately. I really like the college game, and I don't care what anybody else says. Many on-air personalities make a habit of ripping college hoops and the quality of play. Sure, it's not up to professional standards, but I like following my favorite teams, St. Mary's and Cal, and the rivalry games still make it an attraction for me. And, I'm often rewarded with some classic games.

St. Mary's, back in the days when they were rarely good, it was all about beating USF and Santa Clara. Now, under coach Randy Bennett, the Gaels have been good and that has spawned a great rivalry with Gonzaga. there is Stanford, of course, and UCLA and Arizona (all despicable foes), but the one I like is with Oregon. It seems every time I watch the two face off it's a great game, including last Thursday's 86-83 thrilling Cal victory.

I'll scour the weekly listings for the best matchups and, I have to admit, I get a good charge out of the North Carolina/Duke feud. Duke won the last meeting a couple weeks ago, 85-84, with a late comeback and a buzzer-beater shot.

As for our area pros, the Sacramento Kings and Golden State Warriors are two lousy teams lost in the ozone again, but when they play each other it is usually pretty good. Or, take either playing against the L.A. Lakers and it could be good because our loveable losers usually raise their level of play, though they usually lose.

Raising the level is all about that over-used word in sports, focus. Focus is all about trying to get into The Zone. The Zone is tunnel-vision, total focus on the task at hand. Everything is clicking. The basketball is part of your hand and the hoop is as big as the ocean. Teammates are like siblings, you are familiar with their every move. You block out all distractions, but absorb the positive influences and vibes of teammates and fans osmotically.

Jeremy Lin is in The Zone. The New York Knicks' young point guard phenom has it all going (except for a few too many turnovers). Lin has broken through from the fringes of the NBA to create Linsanity

throughout the basketball world. On the verge of being cut by a third team this season, he seized an opportunity for playing time and made a sensation out of it. His "game" has been compared to two-time league MVP Steve Nash. Don't get too carried away too soon.

All the well-known rage these days, Lin has led the Knicks back from oblivion and to a 8-1 record since taking over his position, setting a number of records for a beginner along the way. Sunday it was The Kid versus Kidd, Hall of Fame-bound point guard of defending champion Dallas, Jason Kidd. After Lin went for 28 points and 14 assists in a 104-97 comeback victory, Kidd quickly made it over to the new kid on the block to offer a hug of congratulations and encouragement.

Lin, the Palo Alto High and Harvard grad, has gone from sleeping on couches to the tip of everyone's tongue, Saturday Night Live and David Letterman's Top Ten in a couple weeks. In a TV interview he said spending most of last year at the end of the bench for Golden State "brought me to tears." That could do that to anybody. Now he's all smiles on T-shirts everywhere.

It will be most interesting to see if it all continues when injured superstar Carmelo Anthony returns to the Knicks' lineup and infiltrates The Zone — it can be a delicate thing. Regardless of what happens, it was terrific watching Lin light up Kobe Bryant and the Lakers for 38 points during his rise to fame. Linsational!!

Flood Board Outlines Process, Timeline for Review, Adoption of New Central Valley Flood Protection Plan

SACRAMENTO – The Central Valley Flood Protection Board today began a five-month process of reviewing the draft Central Valley Flood Protection Plan, with adoption scheduled for June 2012. Officials of the Department of Water Resources made a detailed presentation of the sweeping plan to improve Central Valley flood safety at the Board's morning meeting in Sacramento. Jay S. Punia, Board Executive Officer, then briefly outlined steps in the review process, which welcomes input and comments by stakeholders and members of the public.

The plan and instructions for submitting comments may be accessed at www.water.ca.gov/cvfmp)

An important date is Friday, Feb. 24, the next regularly scheduled Flood Board meeting, when the public may make recommendations for key plan areas the Board should focus on in its review. On March 23, the Board agenda will include a review of the plan's environmental documentation. During April, the

public will have an opportunity to comment at two public meetings sponsored by the Board, and perhaps at a third.

Dates will be announced shortly and will be posted to the Board website. Likely locations include Sacramento, Marysville and Stockton. Regular Board meetings are scheduled for April 27, May 25 and June 22 with final Board adoption required by June. All the regular Board meetings during this five-month period are scheduled for the Resources Building at 1416 Ninth Street in downtown Sacramento.

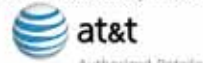

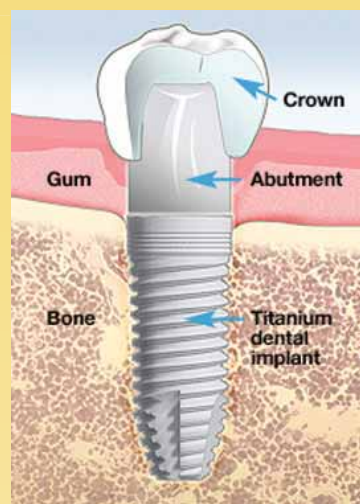

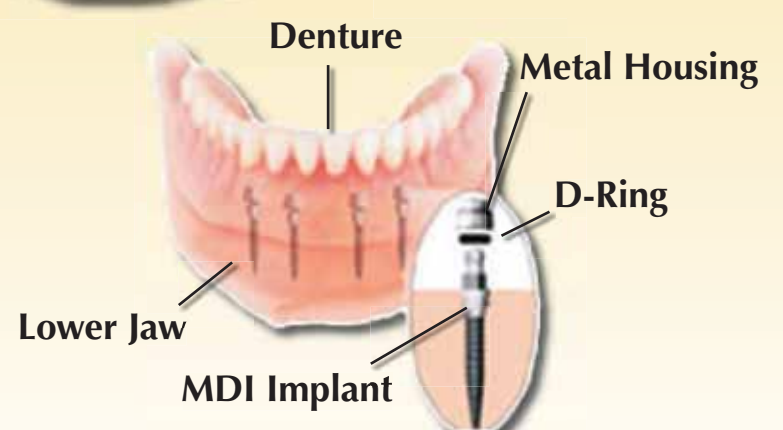
