Whitman Wins Nomination

Meg Whitman trounced the rest of the field with an astounding 64.2% of the votes for the Republican nomination for Governor of the State of California in last night's primary election, distancing herself early on from Steve Poizner by approximately 37%. Former Governor Jerry Brown received 84.1% of the Democratic vote for their nominee.

In her acceptance address for the nomination, Meg Whitman said "We begin a new journey together tonight. We have it in our power to build A New California. There is a clear choice in this election. California is in crisis. And we certainly cannot save California's future by repeating the failures of the past.

It's time for a different style of leadership. A new beginning. Not glitz, not glamour, not glibness, but guts. A governor with the guts to do the hard work required to turn California around!

Together we can end Sacramento's war on job creation and make California a great place to grow a small business. We can force the politicians to stop spending more than taxpayers can afford. And we can stand up to a bureaucracy that puts its own growth and power above classroom teachers and good education."

Carly Fiorina won the Republican nomination for U.S. Senate by gaining 56.5% of the vote. Tom Campbell finished second with 21.8%. Fiorina garnered 952,072 votes, with 30,369 coming from Sacramento County. Fiorina will take on Barbara Boxer, Democrat, in the November election. It is expected to be the greatest challenge to Boxer's seat in the Senate to date. Boxer won the Democratic nomination with 80.5%

Sacramento County The Sheriff race will face a run-off in November, as Scott Jones gaining 45.65% and 49,225 votes to Jim

12.03% and 12,971 votes.

In one of the hardest fought nomination races, the State Assembly Fifth District, Andy Pugno, receiving 13,030 votes, out-distanced Donald Thompson who received 5,235 votes, Suzanne Jones who received 3,764 votes, Craig DeLuz who received 3,497 votes and Mike Edwards who received 3.201 votes. Richard Pan defeated Larry Miles for the Democrat nomination, 10,646 votes to 6,359.



Huber Bills to Streamline Government Pass Assembly

Sacramento -- The California Assembly, today, an overwhelming, bipartisan vote, passed two far reaching governmental reform measures, authored by Assemblymember Alyson Huber. The legislation if implemented will push government to identify waste, duplication and inefficiencies in state departments and agencies.

AB 1659 and AB 2130 create a process to conduct, comprehensive and regular review of the state's boards, commissions, and departments. agencies

"For many years the legislature and the Governor have created governmental entities that were designed to solve particular problems," Huber said. "I think the time has come for us to review each of these bureaucracies, keep the ones that work and eliminate those that have outlived their usefulness. This will ensure taxpayers that their money is being spent wisely."

AB 1659 would take existing legislative resources and re-direct them to the Joint Sunset Review Committee which would conduct a comprehensive analysis of state government agencies to determine if the agency is still necessary, should be reorganized or is cost effective. In order to compel action on recommendations, it is the intent that automatic sunset dates would be established for entities

scheduled for review. Prior to the committee's recommendation each agency scheduled for sunset would be required to submit a report to the committee. Then, the committee would take public testimony and evaluate the agency prior to the agency's scheduled sunset.

AB 2130 serves as starting point to define which government entities will be subject to the Committee established by AB 1659 and sets the sunset timetable for the first years of reviews.

Senator Mark DeSaulnier (D-Concord) and Assembly member Roger Niello (R-Fair Oaks) are co-authors of both bills.

As far back as 1989, the Little Hoover Commission issued a report, entitled Boards and Commissions: California's Hidden Government, which found that, "California's


multi-level, complex governmental structure today includes more than 400 boards, commissions, authorities, associations, councils and committees. These plural bodies operate to a large degree autonomously and outside of the normal checks and balances of representative government."

The Commission concluded that "the state's boards, commissions and similar bodies are proliferating without adequate evaluation of need, effectiveness and efficiency."

Numerous other states have a sunset review function. Texas, for example, created its Sunset Advisory Commission in 1978, with total savings achieved by the Commission equaling roughly 5% of the state's budget.

With the Legislature that is often gridlocked by intense partisanship Assemblymember Huber said that she is very encouraged by the bipartisan support that her measures have received stating, "making government work more effectively and cutting unneeded bureaucracy shouldn't be partisan. It is our duty to spend the public's money wisely and I hope my legislation is the start to implementing an improved system of common sense governmental oversight."





While side-to-side spinal curves, such as scoliosis, are abnormal, front-to-back curves are normal and essential to spinal health. curve is lost, the neck will begin to straighten, causing a condition "cervical kyphosis."

Cervical kyphosis, often termed "military neck," can progress to the point where the curve in the neck actually reverses, going in the opposite direction from its normal, healthy state. The reversal is also known as forward head posture (FHP).

FHP can cause vast degenerative effects on the neck, such as osteoarthritis, chronic pain, limited range of motion and increasing risk of arm or hand pain. The good news is that FHP may be reduced, or even corrected in many cases. Because of the amount of time most people spend hunched over desks and computers, FHP is one of the most common findings in the American population due to excess time on the internet, watching television, texting and video game use.

Arthritis

When the neck has a normal curve, the weight of the head is balanced and muscles endure only minimal strain. However, if the neck is straight or in a FHP position, constant strain is placed on joints. Joints that are strained continuously are predisposed to arthritis and degenerative disc disease which can even begin at early ages. 

QB Daunte Culpepper Signs with Mountain Lions

Sacramento -- Quarterback
Daunte Culpepper has signed with
the Sacramento Mountain Lions
of the United Football League.

Culpepper will be reunited with his former Minnesota Vikings head coach Dennis Green, who will lead the Mountain Lions into the second UFL season, which kicks off this fall. Green previously selected Culpepper, who is a three-time NFL Pro Bowler and also played for the Miami Dolphins, Oakland Raiders and Detroit Lions, with the 11th pick of the 1999 NFL Draft.

"My goal for this year was to get on the field and play football," said Culpepper, who threw for 24,153 yards and 149 touchdowns during a stellar NFL career. "When the opportunity came for me to sign with the UFL and play for coach Green in Sacramento I could not resist. I am impressed with his approach to the game and to his players.

"I am also excited to be reunited with my college coach Mike Kruczek as the offensive coordinator. I am expecting to have a lot of fun running a wide-open offense and being a part of the United Football League. California here I come!"

Coach Green said: "Bringing a player of Daunte's caliber to the Mountain Lions is a major step forward not only for the team but also for the UFL. He is a player who will excite the fans here and will be an integral part of the team we are building that we hope can bring a championship to Sacramento. On a personal note, I am delighted to be reunited with Daunte."

Culpepper's arrival in Sacramento will also create a rivalry with last season's defeated UFL Championship Game finalists the Florida Tuskers. The quarterback enjoyed a standout college football career under Kruczek at the University of Central Florida, where he rewrote the UCF record

books. On October 21, the Ocala, FL, native will return to his home state to face the Tuskers at the same Florida Citrus Bowl venue where he rose to prominence with the Knights.

Among his career highlights, in 2004 Culpepper passed for a league-leading 4,717 yards, a Vikings-record 39 touchdowns and was named to his third career Pro Bowl. He also broke Dan Marino's NFL record for combined passing and rushing yards, amassing 5,123 total yards. His 2,323 rushing yards from 2000-2004 also made him only the fourth quarterback in NFL history to run for more than 2,300 yards in a five-season period.

In the NFL, Culpepper was named the starter in 2000 and led the Vikings to a 7-0 mark, eventually finishing 11-5 with a berth in the NFC Championship Game, losing to Las Vegas Locos head coach Jim Fassel's New York Giants.

PROP 17 - No 52.1% 2,004,410 votes - Yes 47.9% 1,848,768 votes

A NO vote on this measure means: Insurers could provide discounts to their long-term automobile insurance customers, but would continue to be prohibited from providing

such discounts to new customers switching from other insurers.

MARMADUKE (Rated PG)

Owen Wilson and George Lopez, two actors with distinctly different comedic styles, create a strange pair in their leading roles for a buddy movie. The reason that the coupling of these two buddies in "Marmaduke" is so unusual is that they are the voices for the Great Dane Marmaduke and the housecat Carlos. Wilson's big slobbering canine confines his affection for Lopez's furry feline pretty much in the presence of the Winslow household, a typical Midwestern two-parent family with three kids.

As most people know, "Marmaduke" is based on the longrunning comic strip, but takes great liberties with the usual storyline. First of all, both Marmaduke and Carlos are talking animals, with the big dog in particular constantly blabbing as if he was desperately in need of acceptance. Marmaduke talks not only to all his four-legged pals and acquaintances but also speaks directly into the camera, sharing his deep thoughts and observations with the audience. Owen Wilson was the obvious pick

for this assignment. Someday we should see the loquacious actor as a U.S. Senator leading a filibuster.

The film opens with the Winslow family living in Kansas, where Phil (Lee Pace) is recruited by a pet food company based in Orange County. With his wife Debbie (Judy Greer) and three kids in tow, Phil makes the move west, taking the two household pets along. Phil's new boss is eccentric dog-lover Don Twombly (William H. Macy) who feels his best work is performed barefoot at the local dog park. Of course, Marmaduke, with his bad habit of getting into trouble, proves a disruptive presence, namely because he is smitten with Twombly's purebred collie Jezebel (Stacy Ferguson, aka Fergie). However, he falls in with a group of lovable mutts, including Mazie (Emma Stone), the wise Raisin (Steve Coogan) and the extremely nervous Giuseppe (Christopher Mintz-Plasse).

There's not much of a plot to "Marmaduke" other than the big dog getting into virtually nonstop trouble. At the dog park, he challenges the pedigreed bully Bosco (Kiefer Sutherland) in a turf battle, which involves staging a fake fight with Carlos to prove his supremacy. Craving respect from his fellow canines, Marmaduke hosts a wild party at his house which causes so much destruction that he feels he

must run away from home. It all ends tidily when the humans launch an allout search for the wayward pooch, while Marmaduke becomes heroic as he rescues Mazie from her fall into the raging waters of the local aqueduct.

"Marmaduke," mostly balanced between comic pratfalls and touching emotions, is so predictably formulaic that hardly anyone older than eight years will be surprised by what transpires. Nevertheless, "Marmaduke" proves to be enjoyable family fun at a time that movies geared to the family seem to be in short supply. I certainly found it much more pleasurable than the two movies mentioned below.

Now, briefly, I will refer to the "other dog" movies out there. First, "Sex and the City 2" is not only intolerable and unbearable it's also an affront to good taste and moral decency. Of course, according to some of my female friends, my views reflect a retrograde insensitivity to important things like shopping for high fashion clothes and jewelry and acquiring more shoes than Imelda Marcos. I can't believe I sat through this dreadful movie more than a week ago. Only now can I bring myself to write more than one sentence about the horror.

Another movie going to the "dogs" that will also fall flat is "Killers," in which dashing Ashton Kutcher tries to leave behind his previous career as an international super spy in order to settle down with his hot wife Katherine Heigl. When a price is put on his head, Kutcher finds his suburban lifestyle turned on its head. "Killers" has no idea if it wants to be an action picture or a comedy. As a result, it fails at both.



When/Where: Starting Friday, June 11 at 7 PM, there will be a full closure of Hazel Avenue at the American River Bridge between Gold Country Boulevard and Curragh Downs Drive. Information about the closure is as follows:

- Hazel Avenue and bike lanes and trails will be re-opened to the public at 6 AM, Monday morning, June 14th.


Detour Routes: The public is advised to avoid this area during closure hours as there will
