# FTC Cracks Down on Con Artists Census Bureau Begins **Door-Knocking Operation** Targeting Jobless Americans



Scams Prey on Victims of the Recession With Bogus Job, Money-Making Schemes

As part of the law enforcement sweep announced today, dubbed "Operation Bottom Dollar," the FTC has filed seven cases against the operators of deceptive and illegal job and money-making scams and announced developments in four previously filed job scam cases. In addition, the sweep includes 43 criminal actions by the Department of Justice, many involving the

recently announced a new crackdown for hundreds of thousands of Postal Inspection Service, as well on con artists who are preying on Americans already wrestling as one additional civil action by the unemployed Americans with job- with the economic downturn. Postal Inspection Service and 18 actions by state attorneys general.

The FTC also announced partnerships with the online job placement service Monster.com, the search engine Bing, by Microsoft, and the centralized network of online communities Craigslist, to help job seekers recognize job scams so they can avoid being victimized. Monster, Careerbuilder, Bing and Craigslist will display FTC consumer education

material to people who are using the companies' Web sites to look for jobs.

"Federal and state law enforcement officials will not tolerate those who take advantage of consumers in times of economic misfortune," David C. Vladeck, Director of the FTC's Bureau of Consumer Protection said. "If you falsely advertise that you will connect people with jobs or with opportunities for them to make money working from home, we will shut you down. We will give your assets to the people you scammed, and, when it's appropriate, we'll refer you to criminal authorities for prosecution."

"Employment and business opportunity fraud causes terrible hardship to those who are suffering the most in these difficult economic times," said Assistant U.S. Attorney General Tony West. "The Justice Department is committed to prosecuting those who defraud through false promises of employment or financial success."

To help consumers avoid being conned by employment scams, the FTC has produced a new consumer education video in English and Spanish. Still shots from the Web sites of some of the operators charged in this law enforcement sweep, as well as video footage of FTC Consumer Protection Director Vladeck, and Monica Vaca, an Assistant Director in the FTC's Division of Marketing Practices, will also be available. Sacramento Region takers will be fanning out into Northern California and knocking on the doors of households that didn't mail back their 2010 forms.

The U.S. Census Bureau launches the Non-Response Follow-Up (NRFU) operations in May - where census takers will collect information from households that did not return their census forms. Thousands of local residents have been hired as census takers to complete this important task.

"The Non-Response Follow-Up operation plays a vital role in helping achieve an accurate 2010 Census count and determine the allocation of federal funds for community services," said Seattle Regional Director Ralph Lee. "We ask that you cooperate with census takers should they contact you. It's easy, important and safe. Information collected by census takers cannot be shared with any other government agency; they've taken a lifetime oath to not reveal any data."

In most cases, census workers will make initial visits during afternoons, early evenings and weekends. Workers will identify themselves with a census ID badge that contains a Department of Commerce watermark. The census taker may also be carrying a bag with a Census Bureau logo. Census workers will not ask for citizenship status, Social Security numbers, credit card or banking information.

If asked, he or she will provide supervisor contact information and/or the Local Census Office phone number for verification. If census workers are unable to reach a household member in-person, they will also attempt



contact by phone to conduct the interview with the household member.

The Census Bureau began monitoring mail response rates since March 17, 2010 to estimate the local NRFU workload. Recruitment and training for NRFU operations began in November 2009. An estimated 635,000 census takers will be deployed around the nation for this operations, with more than 19,000 in Northern California. The NRFU operations are scheduled to be completed by July 10, 2010. For information on NRFU operations, visit 2010census.gov.

Mandated by the U.S. Constitution, the census takes place every 10 years. Census data determine boundaries for state and local legislative and congressional districts. More than \$400 billion in federal funds are distributed annually based on census data to pay for local programs and services, such as schools, highways, vocational training, emergency services, hospitals and much more. # IRS Office to Hold Open House to Help **Small Businesses, Individuals Solve Tax Problems**

Sacramento Region-The Sacramento Internal Revenue Service Office will be among 200 Taxpayer Assistance Centers nationwide to host a special Open House on Saturday, May 15, 2010 from 9:00 a.m. to 2:00 p.m. IRS staff will be available on site or by telephone at 4330 Watt Avenue to help taxpayers work through their tax problems and walk out with solutions.

"Our goal is to resolve issues on the spot so small businesses and individuals can put any issues they have with the IRS behind them,"

IRS Commissioner Doug Shulman said. "If you have a problem filing or paying your taxes or resolving a tough tax issue, we encourage you to come in and work with us."

The IRS Sacramento office will be equipped to handle issues involving notices and payments, return preparation, audits and a variety of other issues. Sacramento residents who cannot pay tax balances due can discuss payment agreement options with IRS professionals and complete

the paperwork then and there. IRS staff will also assist with offers-in-compromise. Likewise, taxpayers struggling to complete certain IRS forms or schedules can work directly with IRS employees to get the job done.

At the March 27 Open House, 88 percent of the taxpayers who came in for help had their issues resolved the same day.

The May 15 Open House is the first of three events scheduled through the end of June. The next two are planned for Saturdays June 5 and June 26. Details regarding those events will be available soon.

The donators started arriving early at 8:30 and they were taken care of prior to the official starting time of 9am. In the first two bin were items with screens (TVs, monitors etc) and the other bin contained other E-waste items.

traffic, checking with the donators to meet State regulations, and then directing them to the unloading area. # Lungren: Affordable Care Act

This week I had the opportunity to introduce legislation that will provide relief to millions of small business owners who would otherwise face an enormous tax reporting burden under the recently enacted health care bill.

Section 9006 of the Patient Protection and Affordable Care Act (PPACA, PL 111-148) has not received much attention. It is comprised of a mere 170 words – a drop in the 2,300-page, 384,000word health care reform bucket. But this little provision was calculated to be a big "pay for," raising \$17 billion in tax revenue over ten years to help offset the cost of the PPACA. It will require business owners to provide a separate 1099 tax reporting form for every company with whom they do more than \$600 worth of business in a given year. This means that California's 3.6 million small business owners will face an onerous new tax reporting mandate for basic, everyday business expenses such as phone and internet service, shipping costs, office supplies

and utilities, just to name a few. What the drafters of Section 9006 have done, under the guise of health care reform, is essentially draft small businesses as a new enforcement arm of the IRS. Congress has seemingly determined that conscripting companies to snitch on one another will serve as an effective enforcement tool, much like it does in organized crime cases. This reveals a disturbingly jaundiced view of the business community as nothing but egregious tax evaders.

This provision is a two-punch combination against small business owners. Not only are they faced with an enormous new tax reporting burden, but Section 9006 will change the way companies select their vendors. Businesses will think twice before purchasing goods and services from smaller companies if they have to fill out an additional

1099 form for each individual vendor with whom they do business. It will be easier to rely on a single large supplier than to negotiate with a number of small companies.

This mandate could not come at a worse time for California businesses. It will prove to be a particular burden for small business owners, who already find themselves in a challenging economic environment. National Federation of Independent Businesses has estimated that the cost of tax compliance is twothirds higher for small companies as compared to large ones. Section 9006 is especially devastating for the Sacramento region, where nearly 90 percent of all businesses employ twenty or fewer employees. In a region where unemployment rates are among the highest in the nation, we cannot afford to needlessly encumber small business owners. It is for this reason that I introduced H.R. 5141, which will repeal Section 9006.

Small businesses are the economic engine of our nation, creating more than 65% of new job growth. Imposing yet another tax burden on them is bad medicine for all Americans.

# Delta Lawmakers Request Review of DWR Bond Expenditures

Sacramento-TheJointLegislative Audit Committee today (May 5th) unanimously approved an audit requested to determine whether the Department of Water Resources (DWR) has demonstrated an ability to manage the significant amount of bond funds entrusted to it by California's voters.

Senator Lois Wolk (D-Davis) and Assemblymembers Alyson Huber (D-El Dorado Hills) and Joan Buchanan (D-Alamo) made the request late last month, acting on a recent report from the state's bipartisan Legislative Analyst's Office (LAO) that raised concerns about whether the department is spending bond funds as the legislature and voters intended.

"Since 1996, California's voters nave approved seven resources our natural resources requires appropriate oversight to ensure

that bond dollars are being managed and spent as the voters intended," Huber said at the hearing. "The audit is intended to provide the Legislature and the Department with the tools to ensure appropriate and effective distribution of general obligation bonds."

The LAO report points to a Bureau of State Audits review of DWR's administration of Proposition 1E Flood Protection Corridor Program. The 2007 audit found several problems with the administration of the program, such as poor monitoring of grants, and overpayment for land acquisition.

"The LAO's report highlights the necessity for stronger oversight and accountability of general obligation bond funds bonds totaling nearly \$21 billion. within the Department of Water This significant investment in Resources," said Wolk. "We need to ensure that the Department of Water Resources has the tools and capacity to efficiently and effectively manage bond funds in a manner that is consistent with voter and legislative intent."

# May is Water Awareness Month

Sacramento – The Department of Water Resources (DWR) reminds the public that May is "Water Awareness Month," a time to appreciate and carefully use the water resources essential to California's special quality of life.

"Water is vital to California's people, animals, ecosystems and economy," noted DWR Director Mark Cowin. "As warm weather and vacation season arrive, the need is greater than ever to use water wisely and practice water conservation."

DWR, in partnership with the Association of California Water Agencies (ACWA), will continue to run the "Save Our Water" program. The program, which was created by Gov. Schwarzenegger's 2009 drought declaration, aims to educate Californians about easy ways to conserve water indoors and outdoors.

Sierra snowpack and winter

California in early 2010. As April ended, Sierra snowpack water content statewide topped 130 percent of average for that time of year. But the State still is recovering from three consecutive dry years. Some major reservoirs are lagging below average.

Reflecting these conditions, SWP deliveries for 2010 currently are estimated at 30 percent of the amount requested by the SWP contractors. If wet weather patterns continue, a slight adjustment to 35 or 40 percent in the final SWP allocation for 2010 could occur.

Water Awareness Month originated during California's 1987-1992 drought to help educate consumers on using water resources efficiently.

During the recent three dry years, many regions activated drought restrictions and intensified their water conservation efforts. As of April 2010,

rainfall increased in much of 67 local water agencies in California mandated water conservation while 56 other agencies urged voluntary conservation practices. Visit the Web site at www.saveourh2o.org

In Carmina Burana the large SCSO Chorus sang and played with all-out zest that this score requires, with its libretto drawn from medieval latin texts celebrating the cycle of life and praising wine, song, romance and the joys of springtime. The SCSO Chorus and Orchestra clearly brought to the Mondavi stage an accomplished, artistically exciting performance, and a visceral experience that even the best recordings cannot remotely provide. In the couple of dozen songs that follow "O Fortuna" we hear the voices of lovers, tavern types, gamblers and wanderers who live under the sway of Fortuna. The sounds and rhythms of their words, whether in medieval Latin, French or German, are important, and in the whole performance the words sung by the Chorus had crystal clarity.

Orff's Carmina Burana opens with the stunning and famous O Fortuna whose text is a medieval resigned acceptance of the Wheel of Fortune as the determiner of one's fate. This piece alone is so familiar to the general public, having been used in many movies and commercials that they may not even know that it comes from a much larger work of classical music.

The Sacramento Children's Chorus added a lightness, charm, and a youthful energy to the program visually and musically. Their impeccable diction and musicality reflected thoughtful preparation by their Director, Lynn Stevens.

Ji Young Yang's sterling soprano voice soared in the magnificent Mondavi Center, extolling the joys of youth and springtime. Her ravishing coloratura soprano voice sailed effortlessly up to high D in "Dulcissima", sang it pianissimo and cascaded down chromatically, enthralling the Mondavi audience com or call (916) 536-9065.

with her warm, rich sound. Tenor Chester Pidduck's vividly portrayed a beautiful swan whose days were numbered. Using his strong and versatile tenor voice, he created an outer-space timbre and

negotiated a taxing falsetto voice for

the funny, macabre song of a young

swan aghast and indignant at being

roasted and carried to a tavern table.

Michael Sokol projected a focused baritone voice and was riveting for his swaggering personality, notably in the Abbot's song.

Dancer Chloe Horne added a wonderful touch to the performance through her graceful movements on stage during the opening and closing movements. The elegant manner in which she presented each of the soloists added a natural warmth to the overall performance.

It was, however, Music Director Donald Kendrick's conducting that added the true magic that drew the large forces of the entire Carmina performance together. Conducting the entire 70 minute score from memory - something that is rarely done - Kendrick coaxed nuance from both the orchestra and chorus. His natural musicianship and his mastery of the Carmina score provided an electric experience for both the performers and audience alike.





# Gas Prices Climbing Higher

Sacramento - Average retail gasoline prices in Sacramento have risen 2.2 cents per gallon in the past week, averaging \$3.09/g yesterday. This compares with the national average that has increased 2.1 cents per gallon in the last week to \$2.93/g, according to gasoline price website SactoGasPrices.com.

Including the change in gas prices in Sacramento during the past week, prices yesterday were 67.4 cents per gallon higher than the same day one year ago and are 3.4 cents per gallon higher than a month ago. The national average has increased 6.8 cents per gallon during the last month and stands 72.1 cents per gallon higher than this day a year ago.

"Last week we saw a correction in oil and wholesale gasoline prices," said Patrick DeHaan, GasBuddy. com Senior Petroleum Analyst. "With wholesale gasoline prices down as much as 30 cents per gallon since last Monday, I expect retail gasoline prices to fall as gasoline stations continue to sell through their more expensive inventory and buy cheaper supply, passing on lower prices to motorists." DeHaan says that the correction in oil prices wasn't much of a surprise, noting that fundamentals continue to show growing supply. "If the sentiment that ruled last week continues to weigh on traders, we could see the average price for gasoline drop across much of the country, just in time for Memorial Day weekend," he adds.


