"Get Back on the Road Again" Disabled Veterans Win Battle



DCSS Offices will open on two Saturdays in August to help parents get driver license reinstated.

Sacramento - The Sacramento County Department of Child Support Services works with parents all year long to get their driver license restored. To raise awareness of this service, DCSS is joining forces with the State to highlight this program during Child Support Awareness Month in August. "Get Back on the Road Again" is a public awareness campaign designed to reach out to parents who have had their license suspended because they did not meet their full child support obligations. The program is available to parents with child support cases in all California counties.

"We want to assist the noncustodial parent who may be having a tough time financially but wants to do the right thing for his or her children," said Porter, Director of Sacramento Department Child Support Services.

Under a 1996 California law, non-custodial parents who do not pay their child support may have their driver license suspended until they bring their payments current. The law also impacts business and professional licenses issued by the State of California such as licenses held by doctors, lawyers, contractor's cosmetologists and others.

After a case review, DCSS will release a driver license when the non-custodial parent meets the following conditions: Makes a payment equal to one month of their child support obligation, Makes an additional payment of at least \$25 towards arrears, Provides his or her current employment status and if applicable provides information regarding his or her current financial situation. Evaluations outside of these criteria will also be reviewed on a case-by-case basis.

State Corporate Income Taxes Hurt Workers' Wages

\$1 Increase in State-Local Corporate Tax Rate Causes \$2.50 Drop in Wages Five Years Later

Sacramento – A new Tax Foundation report shows that the burden of corporate income taxes is likely borne by workers – not investors. This finding throws more cold water on the notion that higher corporate income taxes would provide greater

progressivity in the tax system. High corporate income taxes are often justified by the rhetoric that businesses – and their high-income investors – should "pay their fair share." In Tax Foundation Special Report No. 169, "The Corporate Income Tax and Workers' Wages: New Evidence from the 50 States," Senior Fellow Robert Carroll, Ph.D., finds that states with high corporate income taxes have likely depressed their workers' wages over the long term,

while states with low corporate taxes have boosted worker productivity and real wages.

"These findings are not only consistent with a growing body of research on international corporate income taxes and wages, but they get to the heart of a longstanding political argument on business taxation," Carroll said. "Raising corporate income taxes has been viewed as an effective way for governments to push the tax burden onto the people who can best afford it, but this assumes that capital income, which is earned disproportionately by those with higher incomes, is indeed bearing the burden of the tax. We now see, however, an increasing amount of evidence suggesting that this is not the case."

This new Tax Foundation study finds that for every \$1 rise in state and local corporate tax collections, real wages fall by \$2.50 five years later. The reverse is also true: Wages rise \$2.50 for every \$1 reduction in state and local corporate income taxes.

This finding - that the burden of corporate income taxes ultimately falls on labor supports previous research indicating that corporate taxes are not borne by capital because capital, in today's increasingly global economy, is mobile, but labor is not. The Tax Foundation is

By eliminating the GFE more opportunity for DVBE is created and there are lower costs for taxpayers, saving thousands of hours wasted in preparing bids and reducing the waste in paperwork According to recent Federal reports, "Small businesses are the lifeblood of the economy in the United States. Based on data from the U.S. Census Bureau, the Office of Advocacy at the U.S. Small Business Administration documented that small businesses accounted for over 92% of the net new jobs created between 1989 and 2003."

Other recommendations in the AlliancememosenttoDGSinearly June 2009 include simplifying the legislation on Commercial Useful Function and eliminating the need for DVBE to submit tax returns for recertification annually. We need to make the Public Contracting Code and the Military and Veterans Code look alike so that laws and regulations for small business and DVBE are basically the same.

"With furloughs and reduced number of employees, this will help us maintain efficiency and still serve our customers."

DMV Online Business Surges 20.4% During First Six Months of 2009

Sacramento – Online business surged 20.4 percent during the first six months of 2009, as the Department of Motor Vehicles recorded 4.7 million internet transactions through June 30, 2009, the DMV announced today, July 31st.

"Customers plan their trips carefully and are opting in many cases to forsake a trip to the DMV and instead do business with us online," said DMV Director George Valverde. "We are constantly striving to add new features and encourage customers to take advantage of some of our more popular options."

The most popular business option online vehicle

registration renewals – totaled 3,213,660 from Jan. 1 through June 30, 2009, a 15.1 percent increase over the same period a year ago. The month of June also saw 671,356 online vehicle renewals, a new singlemonth record for this category which capped four straight months of at least 500,000.

Online driver license renewals for the six-month period ending June 30 totaled 473,078, a 32 percent increase over the 358,203 logged during the same time a year ago. Change of Address filings soared 18.3 percent, from 349,170 in 2008 to 413,246 through June 30, 2009.

Online filings of Notice of

Release of Liability (NRL) jumped 45 percent during the first six months of the year compared to 2008. In addition, the month of June saw 91,114 NRL filings, the largest single-month increase since the DMV began tracking this category in 2007.

The DMV offers an array of services to customers 24 hours a day, 7 days a week through its Web site (www. dmv.ca.gov), including online appointments for written and drive tests; vehicle registration and driver license renewals, selection of personalized license plates, changes of address and payment of fees via secure debit transactions.

You Can Rent a Painting at Sacramento Fine Arts Center

Sacramento – Imagine being able to change the paintings in your home or office every few months, or whenever you feel like redecorating, without enormous expense. It's possible to do just that by renting original art from the Sacramento Fine Arts Center. Paintings can be rented on a monthly basis, or rented and purchased later. Located in Carmichael the center is a nonprofit corporation founded in 1985 to serve the community as a center of original art. This is a great way to try out a painting before buying it. Sometimes a painting that you loved in the gallery doesn't look quite the same in your own home. More than 192 local artists currently are active members of the art center, and many contribute to the rental gallery. The artwork reflects various styles ranging from impressionist and abstract, to realistic and surrealistic. The cost of renting a painting varies from \$10.00 to \$30.00 a month depending on the size of the piece. The center tries to keep

it as easy as possible for people to have real art in their homes.

Ifaclientdecidestobuyapainting after renting it, the first month's rent is applied to the purchase. Prices to purchase paintings range from \$100.00 for a small piece to more than \$2,500 for larger works, with the average price about \$600. The program is also good business for companies, displaying local artists at a reasonable cost. If a company redecorates or relocates, it's easier to rent than to buy, and some companies like to rotate their artwork. Also, a company may not be able to budget for original art, but can easily afford the low rental costs.

Paintings are hung on the walls of the rental gallery so they can be easily viewed by potential clients. The center also houses two additional galleries for their art groups to hold exhibits and a variety of other shows, both regional and international. Altogether the art center has over 6000 square feet of space with two exhibition galleries, meeting and instructional rental prices reasonable to make studios, library, gift shop and staff

offices. The Sacramento Fine Arts Center receives a commission from each sale, which is used to partially fund the organization. Volunteers and a small staff operate the center five days a week Tuesday through Saturday 11 am to 3 pm, admission is free.

The Sacramento Fine Arts Center is located at 5330-B Gibbons Drive, between Walnut and Garfield. Two member art groups are responsible for displaying most shows (Northern California Arts - CAL and Watercolor Artists of Sacramento Horizons – WASH) which change regularly. The Galleries are open on Second Saturdays until 8:30 pm and include refreshments and sometimes music for visitors. The rental gallery can be viewed also at that time. In addition, the center offers workshops with well known local artists for a small charge, and is open for artists to paint on Tuesday nights (Hang out and Do Art) that is free. 



Steps to Draining Your Pool Properly



By Lisa Park, Sacramento County

For those who plan to drain or remove water from your swimming pool or spa, Sacramento County Water Resources wants to provide tips on how to properly dispose of the water through GREEN practices. We recommend disposing the water via the sanitary sewer because it goes through a treatment plant before entering the local water ways. However, the water can be discharged to the storm drain, but only after it meets certain requirements. See below for additional requirements on how to properly discharge swimming pool and spa while protecting water your local water ways and helping the environment.

Sanitary Sewer

We recommend this method because the water discharged to the sanitary sewer system is conveyed to a treatment plant where it is designed to remove most chemicals found in pools and spas. When discharging water to the sanitary sewer, make sure the flow rate is slow enough that it does not cause the sewer to back up and overflow into your house, your neighbor's house or onto the street.

Your pool may have a permanent indirect connection to the sanitary sewer. If not, you can pump the water into an interior laundry sink or other plumbing fixture or to a sewer cleanout.

Storm Drains (Limited)

You may discharge pool/ spa water to the storm drain system only if the water is:

- Free of all chemicals (chlorine, bromine, etc.) in toxic amounts
- Free of debris, algae, or vegetation
- At a flow rate that does not cause damage to the storm drain system or cause erosion downstream
- Not heated

Executing an endplay is usually a relatively simple procedure. In most cases, the only real difficulty is to recognize early enough that the ingredients for a potential endplay are pre-

For example, take this deal where South got to six diamonds on the sequence shown and West doubled. It certainly wasn't hard for declarer to conclude, once dummy appeared, that

expectation of scoring two trump tricks. South therefore decided to credit West with both the king and queen of trumps. Proceeding on this assumption,

West's double was based on the

South set about the preliminary groundwork necessary to achieve a trump endplay against West if he had exactly the right distribution. He won the spade lead with the king, cashed the ace, then ruffed a spade.

Declarer next played the ace of clubs, ruffed a club in dummy and cashed the K-Q-A of hearts, discarding the ten of clubs on the heart ace. With everything running smoothly thus far, declarer ruffed dummy's last heart and then trumped the queen of clubs in dummy.

Having survived all these risky but necessary maneuvers, South was now in position for the coup de grace. He had won the first 10 tricks, the lead was in dummy, and making the slam had become an absolute certainty. He led the ten of diamonds, ducked it, and poor West found that his two sure trump tricks had dwindled to one.

All of which goes to show that it's very unwise to double a slam when the double warns declarer he's about to run into an unlucky distribution. Without the double, it's hardly likely that South would have played the hand in such a cavalier fashion.

Former heroin addict shares life, death

Dear Straight Talk: I am writing to "Desperate in Salinas" (JUL 15), the girl who was hiding her heroinaddicted boyfriend in her parent's basement. I, too, was deeply in love with a beautiful soul addicted to heroin, and I guarantee if you don't get help, he will take you into a pit of hell with him, you'll have a needle in your arm, too.

Zach was finally going to quit. We started planning a life together. I was saving money to join him in Utah, when my grandmother, a daily support-figure in my life, died suddenly of stroke. It mentally unraveled me and I left spontaneously to see Zach. He warned me he was shooting again and strung out. I didn't care. As soon as that needle hit my vein I was wrapped in indescribable comfort. Not only was I not sad anymore, I felt better than I'd ever dreamed possible. It was my first shot.

Days later, I was spare-changing to support my habit, basically lying through my teeth for drugs. It was the lowest I've ever sunk and I didn't even care. The worst was when I took advantage of the Iraq war saying I needed to get home because my brother was shipping out. I was so good at lying, Zach always sent me out to make the money. I never sold my body though, like many addicts, and for that I'm grateful.

Within two weeks I became sick if I didn't shoot up. I decided to quit. That night was like having the worst flu imaginable. My skin had nonstop "creepy crawls" and I took showers till sunrise, then hit the street telling whatever lies I needed for another \$10 shot.

Another two weeks. A needle broke off in Zach's arm. At emergency, the doctor sliced his arm open right in front of us, his full pointer finger digging inside for that needle. Later, I was so hungry (having eaten only dumpster-dived pizza the day prior), all I could think was, "Can't that dealer hurry, I need my shot so I won't be hungry." Then came a flash of clarity: "What am I doing? Choosing drugs over food?" I returned to California for help getting clean and told Zach to get off heroin if he wanted me.

A year later, homeless on the streets of New York, Zach overdosed and died unconscious in a hospital. I flew there before they took him off life-support. I've replayed our relationship endlessly, all the "could'as and should'as", but with addicts you have to listen to your head not your heart because addicts will choose their drug over you and all the love in the world. All you can do is help yourself. It only takes one shot of heroin to kill you. If this letter helps you, Zach's death was not in vain. — Rose Apodaca, 21, Auburn, CA

Dear Readers: Rose is part of the Straight Talk youth panel and I'm honored to share her letter. Heroin is known for attracting beautiful, sensitive souls — who in turn

attract people who enable them. Rehab clinics are facing an unprecedented epidemic of heroin addiction due to the current chic of snorting heroin and smoking heroin "tar" in the end of cigarettes — this combined with the brain's "learned" predisposition for opiates from using Vicodin, OxyContin, Codeine, Percoset, etc., and hell is one needle away.

Heroin users need immediate professional intervention and care. To family and friends: tough love is essential. Your local hospital can steer you to resources.

- sports, hobbies




