Hornblower will operate from the Tourboat Dock, just north of the Tower Bridge. The company will offer a one of kind venue for private events as well as a unique dining experience open to the public. "We are thrilled to be coming to Old Sacramento, and we're looking forward to partnering with the City of Sacramento to bring the fun of dining on the water to the area," said Hornblower CEO Terry MacRae. Hornblower is the largest passenger vessel company in the United States. It operates more than 50 dining, ferry and excursion boats in California, New York and New Jersey. In addition to offering classic and modern yachts for charter, the company holds two National Park Service concession contracts. It

"Weather pending, our kids are going to bring out their animals and have a mini petting zoo," said Lisa Gordon, community club leader for the Citrus Heights 4-H. "It will be a lot fun as long as it's not too hot. Heat isn't good for rabbits." Fireworks represent the 4-H's largest money-maker, raising funds for leadership conferences, camp scholarships and other activities. From its TNT stand adjacent to the Citrus Heights Raley's Supermarket (7847 Lichen Drive) the group will try to grab its piece of the pyrotechnic pie in an admittedly unsweetened economy. Non-profits and the fireworks industry agree that the recession and a governor who discouraged fireworks sales due to the high number of wildfires had a negative impact on profits in 2008. A bleak economy and a summer fire threat loom again,

but one thing working in favor of the community organizations this year is a friendly calendar.

"When the Fourth of July falls on a weekend, the non-profits normally see a spike in sales," said Cathy Castilone, Northern

to scoring goals and hoping to reach a financial one as well.

"The Fourth of July is a great holiday and I'm thrilled it falls on a weekend for our sweet 16th fireworks fundraiser," said Esteban Nava, president of the Carmichael Soccer Club. "We're concerned [over the economy], but I think people will still go out and celebrate. "Let's just hope there are no fires and that the governor won't go out and tell people not to buy fireworks this year," said Nava, noting that those factors last year slightly hurt its only fundraiser. Proceeds from the club's TNT Fireworks stand, again in the Crestview Shopping Center at Manzanita Avenue and Winding Way, will help keep fees low, buy equipment and maintain fields for roughly 850 children. Some of the kids will be handing out discount fliers at the Carmichael parade on the Fourth of July, hoping revelers will support their fundraiser and maybe spend a bit more with the final day promotion.

Local Business Makes Philanthropy a Priority Despite Rough Economy



Lawson Mechanical Contractor's \$25,000 Donation to Mercy Foundation Helps Provide Vital Equipment for Premature Babies at Mercy San Juan Medical Center

Sacramento - The Neonatal Intensive Care Unit at Mercy San Juan Medical Center has three new state-of-the-art incubators for its tiniest patients, thanks to the generosity of a local company. The incubators arrived in May and are now being used by Mercy San Juan's smallest or sickest babies. Lawson Mechanical Contractors donated \$25,000 raised at its 2008 golf tournament to Mercy Foundation for the purchase of the incubators to help give these premature babies a better chance for a healthier beginning. Lawson Mechanical has also committed to donating the proceeds from its 2009 tournament to Mercy as well.

Lawson Mechanical's donations come at a time when many companies are cutting back on their philanthropy due to the downturn in the economy. Executives at Lawson Mechanical, however, say giving back to the community is even more of a priority now, when the need is greatest. "In spite of the troubled economic times," says David Lawson, Operations Manager, "Lawson and our partners in the construction community remain committed to improving lives over the long-term." Executives at Lawson Mechanical began their annual golf tournament in 2007 to celebrate the company's 60th anniversary

and as a way to give back to the community. The money raised during the tournament is then donated to a local organization identified by a committee within the company. For three years running, that recipient has been Mercy Foundation, which is responsible for raising philanthropic support for the Sacramento area Mercy hospitals, including Mercy San Juan Medical Center. For David Lawson, Mercy holds a special place in his heart. "Both of my sons were born at Mercy San Juan," he explains. "With my oldest, my wife went into premature labor at 24 weeks. It was a stressful time for us, but I always knew we were receiving the best possible care."

In 2008, the company raised \$25,000 for Mercy San Juan's Neonatal Intensive Care Unit (NICU). That money was used for the purchase of high tech incubators, designed specifically for the hundreds of premature infants treated at Mercy San Juan every year. The incubators arrived at the hospital just a couple of weeks ago and are now in use. "These incubators provide the vital protection and controlled environment that is so crucial to the survival of our most premature and fragile babies," explains Dr. Robert Kahle, Mercy Regional Medical Director of

Women's and Children's Services. "I know that had my son been born when my wife went into premature labor, I would want him to have the best possible equipment to help him thrive during an incredibly fragile time of his life," says Lawson. In 2007, Lawson Mechanical earmarked their donation for the refurbishment of one of the Mercy San Juan's oncology rooms. The money raised at their 2009 golf tournament (to be held this October) will also benefit Mercy San Juan however the specific department has not been identified yet. David Lawson says the first year his company hosted their golf tournament they raised \$15,000 for Mercy. Last year that number rose to \$25,000. And this year, he is confident that number will rise again, despite the current state of our economy. "We are committed partnering with Mercy to Foundation to improve the lives of those in need in our community." Established in 1954, Mercy Foundation is responsible for

raising philanthropic support and community awareness for the works of the Sisters of Mercy in the areas of healthcare, education, affordable housing, and care for the poor and elderly in the greater Sacramento region. Mercy San Juan Medical Center is a 260-bed facility serves more than 150,000 people each year from north Sacramento County, south Placer County and beyond with a broad array of quality programs and services. Doctors are the cornerstone behind teams of healthcare professionals who have earned national recognition for Mercy San Juan's Trauma Center, Cardiac Services, Family Birth Center, Neonatal Intensive Care Unit and Bariatric Surgery program. 

Run, Sal, Run

My doctor has been hounding me, my son has been teasing me, and a colleague at school is always asking when I am going to start my fitness running program. Okay, a fitness program that I religiously followed 25 years ago will need to be altered 25 years later. I'm no longer that kid who could get in top physical condition overnight; I will need patience. I will need to mentally throw away what I did years ago and develop a new attitude. "If you're looking for immediate results you need to get that thought out of your head right now," states Rich Hanna, Race Director for Capitol Road Race Management, Sacramento's Premiere Race Management and Timing Company.

"You first need to make sure you get running shoes that are properly fitted for your foot," Rich said. During our conversation I mentioned that it is going to take time for me to get back in good physical condition and that I can't give up when the muscles become sore and I start feeling discouraged. Rich suggested finding a workout partner so that we can keep "pushing one another." For starters, one must develop a plan of attack

because as Rich told me, "it will take 2-3 months before it becomes a habit and you actually want to work out." So, everyone, follow along and you to can develop a nice routine to get back in shape. As my doctor told me, the first step is to s-t-r-e-t-c-h! Get those legs loosened up, lean against a wall, fence, car, and stretch out. Start by walking first, then slowly jog, and then walk again. Rich said "you'll do more walking then running" when you begin and you need for your body to slowly build up stamina. Even though it may be tempting to accelerate my workout, my goal is

to build up my cardiovascular rate and to be consistent in my routine. This means I need to workout 4 to 5 times a week; Rich suggested to for at least work out minutes 35 each time.

Rich said there are people he knows that have a "Family Workout Night" and they encourage one another to get in better physical condition, which in turn does help a person's mental condition as well. It's also a great way to set an example for younger kids if they see their parents staying healthy. "They're learning a lesson for life," said Rich.

Suzie B. has been a CASA to not just one or two children in foster care, but five! This hard-working member of our community has volunteered her time to ensure her CASA youth have been provided with all the services and resources they have needed, in addition to serving as an excellent role model.

What is CASA? CASA stands for Court Appointed Special Advocate. Sacramento CASA is a non-profit organization that recruits and trains community volunteers to advocate for children who are dependents of the Juvenile Court. These are children who were removed from their parents due to abuse, neglect, and/or abandonment. Currently, there are over 4,800 children in the foster care system

"Having one caring person in a child's life makes a difference," states Suzie, "If every child in foster care had a CASA, the outcomes would be much different." Suzie saw various social workers, lawyers, therapists, and other professionals come in and out of the lives of her foster youth while serving as a CASA. It was easy for her to see how quickly pertinent information could get lost.

> Suzie was the only one constant person in their lives many times. This allowed her to effectively advocate for the children's needs, while directing and guiding them on the right path. Her last CASA youth, for example, is a senior in high school and has been accepted to seven colleges. "I think she may have had a very different life

if I had not been there for her. She may have ended up on drugs or in jail. She could also have run off with her older sibling," states Suzie.

With a CASA, 95% of children do not languish in long term foster care. With a CASA, 90% of children do not reenter the child welfare system. "These kids need somebody," adds Suzie, "One of my CASA youth would say, 'You are my only friend."" With worsening economic times and a system that is already overburdened, the needs of foster children are oftentimes unheard.

The use of heat pump technology also helps reduce oxides of nitrogen (NOx) and the carbon footprint.

"Paul Menard Associates provides excellent leadership among business customers helping our community by being more energy efficient," said Bill Slaton, SMUD Board Vice President and Ward 7 Director. "Hopefully, more customers will follow Paul's lead by seeking greater energy efficiency than the commonly used Title 24-compliant equipment when designing new commercial buildings."

Spending more for fireworks will be pretty much inevitable as prices are higher on many items due primarily to increased material and transportation costs in China, where 95 percent of America's consumer fireworks are manufactured. To help ease the double-dose reality of thinner walletsandfattenedprices,thelocal fireworks industry is ready to deal.

"This year, more so than in years past, consumers are looking for the best quality and value for their entertainment dollar," said Castilone of TNT's Sacramento office. "Sixteen of our items are now under \$5, seven additional crowd pleasers are listed as 'buy one get one free' and our assortments deliver up to 35 percent more value for the dollar. With deals like these, we hope to help our non-profit organizations raise the critical dollars they need to support their programs while making sure that consumers have an enjoyable Fourth of July celebration."

From Castilone's lips to God's ears is what Love INC - short for Love in the Name of Christ -- is praying for. The group, which brings Orangevale's East Valley Church and other Christian churches together to help provide the needy with food, furniture, clothing and longer-term assistance, will have TNT stands at 3290 Arena Blvd. and at Broadway and 16th St. "There's a little concern [about the recession], but the scripture tells us not to worry - you don't change anything by worrying," said George Thacher, one of the more active volunteers for the non-profit. "If God believes we're supposed to generate revenues it doesn't matter what the economy is doing."

Though his faith is no doubt just as strong as Thacher's, Matthew Oliver, senior associate pastor at Family Christian Center in Orangevale, is taking matters a bit more in his own hands. For one thing, Oliver, the church's resident pyro expert, has gone a route seldom taken among non-profits by linking once-dual fundraisers involving competitive fireworks resellers. He's also added a second TNT stand to go along with the church preschool's Phantom booth now brought under one operation. And in another innovative ploy to grab customers, Oliver started a Web site - www. thefireworkssupercenter.com thatoffersonlinepre-paidordering, making pick up at the main location pyrotechnically painless.

Why all the heavy-duty marketing strategy? Oliver says it's about survival.

"Our fireworks fundraiser has to do well. It could mean the difference between Club Retro surviving or not," Oliver said, referring to the Christian rock club-slash-teen center providing tutoringandcounselingforstudents of several area schools. "Last year our fireworks booth wound up

being 70 percent of our budget." The main stand, dubbed the "TNT Megastore," is on the Family Christian Center's own property at 6521 Hazel Ave. Its new sister TNT site, the "TNT Supercenter," is located at 8121 Madison Ave. next to Carl's Jr. The Phantom stand is in the Dairy Queen parking lot at 9295 Greenback Lane.

Another local church hopes to spark more fireworks business with a picnic on what is traditionally the slowest day of sales, the first. Water slides and lunch will be provided starting at 11 a.m., an hour before Sunrise Community Church's stand in Fair Oaks opens for what promises to be a brisk week of sales, according to the fundraiser chairwoman.

"Weekends are always good, we won't have the fires and we're thinking that people will stay home for the holiday and shoot off fireworks in the neighborhood," said Tammi Schmorleitz of Citrus Heights.

The group's Phantom Fireworks stand made about a third less last year than the prior season, but the stars seem to be aligning for a better outcome this go-around, and that's putting a smile on the fundraiser chairwoman's face.

"It's our largest fundraiser of the year and we rely on proceeds to send kids to summer camp," Schmorleitz said. "We're definitely looking forward to a more successful fundraiser this year. Only time will tell."

Internet feeds kids porn diet

Dear Straight Talk: My friend, "Sheryl", caught her son viewing porn on his computer with some other boys. When she got upset, he told her that everybody watches it and to chill out. She moved his computer to the living room, but he is almost 18 and she's at a loss. What should she do? - Darlene, Laguna Niguel, CA

Charles, 23, Sacramento, CA: Get over it. I saw porn the first time at a friend's house around age 10. It was the first year most of us had Internet service. After that, trading floppy discs of porn images became a normal part of boy life. Today, the joke among ALL my guy friends is, "How many gigs of porn do you have?" In college, some kids had 200 hours of porn on their computers! Porn is a good thing, a healthier outlet than unsafe sex, prostitution, or rape.

Jessie, 17, Ashland, OR: I was 12 when I Googled something for school and a vivid pop-up appeared. I was so embarrassed I closed the screen and took a zero on the assignment. My girlfriends don't watch porn, but I'm not positive about my guy friends. I think high school is too young for porn, but at 18, it's legal, so your friend should ease up - or ask him not to watch it at home.

Liz, 17, Sacramento, CA: At age 12, I was given my 20-year-

old brother's computer which was loaded with porn. I was somewhat intrigued and took a look, but after that I had minimal exposure. Since puberty, I've looked occasionally and have watched porn with my boyfriend once or twice. Most people I know view porn and are comfortable with it, including older couples. It seems relatively harmless unless it becomes addictive or lowers respect for women.

Rachel, 18, Fair Oaks, CA: I've never known girls to watch porn together, but guys often do. I walked in on a 13-year-old boy and his friends watching porn. I was babysitting his younger sisters and wasn't much older than he. When kids mess around on computers they will see porn. My first time, it scared me to death! But in my midteens, I explored it and think it can be stimulating. Yet for those not mature enough, it can be dangerous as much of it is aggressive and degrades women.

Graham, 15, Fair Oaks, CA: Your friend is overreacting. Unless her son is obsessed with porn, there's nothing to worry about. It's totally common. According to Family Safe Media, 42.7 percent of Internet users watch porn, 72 percent of them male. Professor Steven Landsburg (University of Rochester) reports: "A 10 percent increase in [Inter] Net access yields about a 7.3 percent decrease

in reported rapes." Bottom line: porn doesn't hurt people and may actually help them.


Dear Darlene: The argument that pornography is harmless for a growing mind is ridiculous. Yet I hear it from young people over and over. (See archives on our website FEB/MAR/MAY 2007.)

Parents, it's your home, you make the rules. Just as you express disapproval and set rules around drugs, you must do the same for porn as soon as your child begins using a computer. Ninety percent of kids age 8 to 16 have viewed porn on the Internet - usually while doing homework. It is habitforming and many view it regularly. Don't let media have privacy with your child. Computers and TVs should ALWAYS be in welltrafficked locations and armed with porn-blockers.

Sheryl did right to move the computer. Better late than never. She should also install blockers and clearly state no-porn rules for the household. The good part is her rules will give her almost-adultage son a reason (something sorely lacking today), to want to move out upon graduating — which is precisely when a parent's "stupid rules" start making sense.



State's New Home Tax Credit Going Fast

Sacramento - (Business Wire) -- The Franchise Tax Board (FTB) announced today, June 22nd, that the \$100 million allocated by the state in new home tax credits will soon be gone.

As of June 17, 2009, FTB had received more than 9,800 applications claiming nearly \$95 million. Because some of these applications are duplicates, revisions, or invalid, FTB plans to accept 12,000 applications. This will ensure enough valid applications will be available to allocate the full \$100 million credit. However, FTB will only issue approved credit certificates until the \$100 million is exhausted.

When 11,000 applications are received, FTB will update its Tax

Credit for New Home Purchases web page at www.ftb.ca.gov each business day with the new totals. Once FTB receives 12,000 applications, the fax service will be disconnected.

This tax credit is available for qualified buyers who on or after March 1, 2009, and before March 1, 2010 purchase a qualified principal residence that has never been occupied. The buyer must reside in the new home for a minimum of two years immediately following the purchase date. To apply, an Application for New Home Credit must be completed by the buyer and seller within one week after the close of escrow and faxed by the escrow person to FTB at 916.845.9754. To expedite the processing of applications, qualified buyers are reminded to: submit only one application per new home purchase, only send in the application after escrow closes, and complete the application carefully and accurately. Applications received before escrow closes will be denied.

FTB will continue to report the certificates issued on a weekly basis until the full \$100 million has been allocated. FTB expects to complete processing all certificates in August. Each applicant will receive a notification indicating the amount of credit allocated or denied. *Source*:



Buying in Debt-free Dear Dave,

I have an opportunity to buy a landscaping supply business. The current owner said he made \$250,000 last year, and he's on track to make even more this year. There are three employees, and he's asking \$390,000 for everything. The building is included in the price, but the land would be either a lease or

purchase. Do you have any advice for taking advantage of a situation like this without going into debt? - John

Dear John,

I'm glad you're looking at this venture with an eye on staying debtfree. There would be a lot more small business success stories if all entrepreneurs thought this way! One of the things you could do

is work a deal where you take over management of the company and have an option to buy over time. You would pay the owner a percentage of the net profits, which would go toward your ownership. You'd take out enough to live on, but everything else would go toward your purchase of the company.

You said the guy is asking \$390,000, but how do you know it's really worth that much? He told you he "made" \$250,000 last year. Was that how much he carried home? Or was that what he grossed? How much is he paying those three employees? Do they have contracts, or could you let them go? I mean, he could be grossing \$250,000 and literally taking nothing home, or the expenses could be \$350,000 and the business wouldn't be worth anything. There's just a whole lot more you need to know before you do this deal.

As far as the building is concerned, I'd say no to the idea of owning a structure on someone else's land. I'm not paying him for his building unless the ground comes with it. You can rent the building and land from him after you become the business owner. I'd put the land and building in a separate deal, and lease them with an option to buy later – after I purchase the business. By doing this, you just lowered the purchase price of the business considerably because you

took the building out of the equation. Is the business paying him rent for the building and land now? If this guy isn't charging any rent against his calculation of net profit, then the figures aren't realistic. It's also not realistic if he's not paying himself anything to manage and run the business. The bottom line is this: be

smart, and do your research before you make a move on this one! - Dave

A Lot of College Dear Dave,

We have five kids under the age of five. We'd like for all of them to be able to go to college, but we're not sure how much it will cost. Our household income in about \$90,000 a year, and we have no debt except for our home. What's the best route to go with our college savings plan? - Laura

Dear Laura,

Whew! Boy, you guys have got a house full and your hands full! You've also got a nice income, and that's going to help a lot. Right now, the most you can put into an Educational Savings Account (ESA) is \$2,000 per year. If you did this annually for each kid, you have a little over \$100,000 per child when it comes time to send them off to college. Pretty sweet, isn't it? That will buy a good education at just about any state school.

For the first \$2,000, an ESA has more flexibility than a 529 plan. They're very similar in how they act, but with an ESA you're in total control of the investment. You can move it around, and put it into almost any mutual fund. If you use the ESA or a 529 for anything other than college you'll get hit with a 15 percent penalty, plus the tax rate, so start brainwashing the kids now; it's for college only! - Dave


