## Jesuit's Army Ranger

Benning, Teaching a baby "crawl, walk, and run" is a task most of us will tackle at some point in our lives. But for the son of a Citrus Heights couple, teaching the Army's best soldiers to "crawl, walk,and run" is a challenge most of us will never experience.

Army Spec. Alex R. Marsolais, son of Don and Barbara Marsolais of Garry Oak Drive, Citrus Heights, is a medical specialist helping Army Ranger instructors to "lead the way" for soldiers to complete one of the toughest military training schools anyone can volunteer to attend.

The instructors push the Ranger students to their physical and mental limits through sleep and food deprivation, continuous enemy attacks, and extreme physical demands, teaching them how to achieve mission success while encountering and overcoming seemingly insurmountable obstacles.

"My job requires me to be ready at all times for any medical emergency," said Marsolais, who graduated in 2003 from Jesuit High School, Carmichael, Calif. "I am also responsible for the health and well being of all Ranger students and cadre."

Ranger School is a spread 61-day course distinct three out over locations. The "Crawl" phase is located at Fort Ga., where Benning, students find out whether or not they have the physical and mental skills to complete combat missions and the remainder of Ranger School successfully. The "Walk" phase is held in the mountains near Dahlonega, Ga., and teaches and the students techniques for employing squads and platoons for continuous combat patrol operations in a mountainous environment. Finally, the "Run" phase is held in the swamps

Fla., and tests the students' ability to operate effectively under conditions of extreme mental and physical stress.

Training young men to become Rangers requires the instructors be the best of the best. They themselves must have several years of leadership experience, and be qualified as a Ranger, jumpmaster, pathfinder, assault climber, mountaineer, combat lifesaver, and scuba diver.

"Rangers have to think on their feet. They are constantly in the field with the students, located miles away from any definitive medicalcare," said Marsolais, who is assigned to the Eglin location. "Recognizing and treating any life threatening injury is crucial to keeping the students safe. We always have to be proficient in our skills because we don't get to use them everyday, but when we need them it is pretty important."

Soldiers, Airmen, Sailors, Marines volunteer to become part of this highly trained and rapidly deployable light infantry force. Their specialized skills allow them to engage in a variety of conventional special situations. This means that they must possess technical tactical proficiency, physical fitness, mental toughness, and a winning spirit of never quitting--qualities and attributes that set them apart from other military members.

"Army Rangers are an elite fighting force. The training that they receive here, helps build future leaders of tomorrow," he said. "They are physically and mentally fit and better prepared to take on the challenges of combat."

For nearly 70 years, since the first group of volunteers picked was activated in World War II, Rangers have led the way on over 50 military campaigns, including operations in Afghanistan and Iraq. Occasionally, their unique skills are called upon during their military careers.

"Working with Rangers has allowed the skills that I have served me well during my 15-month deployment to Iraq. I was able to treat all kinds of traumas from gun shot wounds to amputations from U.S. and Iraqi soldiers alike," said Marsolais, who has been in the military for three years.

At the end of the day, Marsolais and his fellow instructors can proud to know that the men they are molding into future Ranger leaders will be the best of the best to "lead the way."

## Protecting Water Quality and Benefiting Ancil Hoffman Park

Aerojet Corporation, the Carmichael Water District and Sacramento County are working together to address groundwater contamination issues in order to protect our drinking water sources and restore groundwater aquifers and this collaboration also will benefit Ancil Hoffman Park. Construction is underway

of a groundwater treatment facility, irrigation pump station, and associated underground piping. The site is adjacent to the golf course parking lot. Installation of this treatment facility and associated components is part of an

overall plan approved by the U.S. Environmental Protection Agency and the State Regional Quality Control Board to remove and treat contaminated groundwater in benefits to the environment,

eastern Sacramento County. While the construction activities create some temporary inconveniences to park and golf course users, there are multiple components of this project that will provide long-term

the community, and to Ancil Hoffman Park. These benefits include: protection of valuable groundwater resources; reuse of treated groundwater for irrigation of the Park; and needed irrigation upgrades. The Department of Regional Parks estimates the upgraded irrigation system could save as much as \$80,000 per year in utility costs.

The work may be noisy at times and efforts will be made to minimize inconvenience to park visitors. Controls also will be implemented to accommodate pedestrian and vehicular traffic and to ensure public safely. Upon completion of the work, affected landscaping, paving, and other surfaces will be restored.

## **North Korea Convicts** Local Journalist

TV reporters Laura Ling and Euna Lee during proceedings running from last Thursday to Monday, June 8th, sentencing them to the maximum twelve years in labor prison. They were found guilty of "grave crimes" against the nation, the country's staterun Korean Central News Agency said. The KCNA report gave no other details.

Laura Ling, 32, was born and raised in Carmichael and is a graduate of Del Campo High School.

The reporters were working for former Vice President Al Gore's Current TV, on a report about North Korean refugees —the trafficking of women and children — who had fled their homeland.

Their arrest was made on March 17 on the China-North Korean border. The trial was not open to the public or foreign

Rodham Clinton has called the charges "baseless." The U.S. is considering adding North Korea back to a list of state sponsors of terrorism, Secretary of State Hillary Rodham Clinton said in an interview broadcast Sunday.

Current TV's Web site indicates Laura Ling has also reported on drug wars in Mexico and native tribes in Brazil. Wikipedia, an online encyclopedia lists Current TV is an independent media company led by former U.S. Vice President Al Gore and businessman Joel Hyatt. The cable television network went on the air the morning of August 1, 2005. Current TV features "pods", or short programs, of which a portion are created by viewers and users.

The blog "The Western Confucian" takes another opinion of the situation

Korea's North's Central Court tried observers. Secretary of State Hillary of Euna Lee, Laura Ling, and Al Gore. It states "The two ladies have been found "guilty of a 'grave crime' against the nation and of illegally crossing into North Korea" — It is impossible not to sympathize with anyone sent to "reform through labor" in that monstrous gulag archipelago, but what were they and their boss Al Gore thinking? 



**Question:** I've heard that our community needs more foster parents. What do they do, and why they are needed?

Answer: At some point in our lives, we all need a little help. Foster parents fulfill this role by caring for children who have been removed from their homes because their families are unable to keep them safe. They provide a nurturing environment for children until they can safely reunite with their parents, be cared for by relatives, be adopted by loving families, or successfully transition to adulthood. In some cases, foster parents adopt the children they have fostered.

In return, foster parents receive reimbursement to cover the costs of providing food, shelter, clothing, and other basic needs. But make no mistake about it ...it takes a special heart to be a foster parent. Aid payments do not necessarily cover all of the expenses of caring for a foster child, especially "little extras" like summer camp, school photos or after-school sports. The greatest reward comes from knowing that you are making a

difference in the life of a child. The foster care system has been in place for decades. The culture of foster care, however, has changed enormously. In Sacramento and other counties using the Family to Family model, foster families are known as "resource families" because of how they help children find permanent homes and how they act as resources for the birth family. Today, foster parents/

resource families serve as mentors, role models and advocates, often forming lifelong connections to the children whom they foster.

Older foster youth are especially in need of this kind of attention. Nearly half of the 3800 children in foster care in Sacramento County outcomes. They are less likely to move from home to home and more likely to remain in the same neighborhoods and school districts.

are older than 10. Each year, about 300 of these youths turn 18 and are no longer eligible for aid, a process known as "aging out" of foster care. Most leave the system without the kind of resources and connections they need to live as healthy, self-supporting adults. Having a permanent, lifelong connection with a caring adult makes the difference.

Another culture change is the increasing emphasis on placing children with relatives or extended family members (neighbors, family friends, etc.) who act as foster parents. Children placed with relatives tend to have better

#### WHY GIRLS TALK...WHY BOYS DON'T

As a parent, do you feel you need a survival guide to connect with your teen? Now you have that guidance from Susan Morris Shaffer and Linda Perlman Gordon. They offer a nurturing voice for those years of confusion and crisis, and they let us know how different boys and girls can be in "Why Girls Talk" And What They're Really Saying and "Why Boys don't Talk" And Why It Matters.

According to Shaffer and Gordon, teenage girls often worry about how others view them, and as a result, they resist expressing their honest feelings for fear of not being accepted. They may continue to talk a lot, but often they express what they think they ought to say. So they offer suggestions to help develop a girl's sense of self. This allows girls to thrive despite the normal setbacks of teenage life like not being invited to a party, having less than stellar athletic skills, breaking up with boyfriends, or not doing well on exams.

So, they explain how to:

1) Identify effective strategies for interpreting necessary information from the drama of girl's daily lives.

2) Assist parents in developing skills to help their daughters to establish a strong sense of self while sustaining the parent-child bond.

3) Strike a balance between the stereotypes of the "mean girl" and the "nice girls" so daughters can

create a sense of authentic self. 4 Explore parents' boundaries to avoid over identification with, and investment in, social success and failures of girls.

In their companion book on boys, they introduce the importance of staying connected with boys. In their research, they found the range of acceptable outlets for boys to be much narrower. Society pressures mothers into pushing away their sons for fear that their children may become dependent and enmeshed. Becoming a man is understood as becoming autonomous, self-sufficient, and separate. This may be achieved at the expense of learning how to stay connected with others, be intimate, participate in family responsibilities, and create a community. So the authors include this advice for boys: 1) Encourage empathy in the home. 2) Help build closeness and sense of

family.

3) Interrupt the cycle of racism by discussing all aspects of tolerance.

discussing all aspects of tolerance.4) Read subtle boys' cues.5) Set firm, consistent limits to

encourage responsibility.

6) Participate in school and community activities to make sure your child's needs are met when you're not present.

These are just a few of the examples used in both books. Susan Shaffer is a parenting expert, and acclaimed gender equity specialist. Linda Gordon is a clinical social worker and trained mediator. You can check out their website at www.parentingroadmaps. com. It's up to you, and being a parent is no easy task. You need all





Dear Straight Talk: I've been trying to get work at a fast food place with no luck. I'm 16 and I've never had a job before and there are so many kids applying. How can I set myself apart? — Sonya

Dear Sonya: Here are tips from two general managers of two different popular fast-food chains that hire tons of teens. I was not able to use the names of the chains due to corporate liability jitters, but I am grateful for the no-nonsense advice these hiring managers shared. As you read their tips, notice how both managers pay close attention to how you present yourself, how enthusiastic you are, and whether you have passion for their food. The other key is to keep showing your face. The squeaky wheel gets the grease, so don't think you are being annoying by stopping back in over and over. It's what they want

Show up looking presentable!

· Don't make the application look like a 2-year-old filled it out. A lot of you obviously aren't reading the questions before filling in the answers.

· If this is your first job, don't leave your past employment blank. Most of you have done babysitting or yard work. Write it down! These are real jobs, too.

· Lots of kids hand me the application and say, "Here, thank you." and walk off. This will not get you hired. You have to act like you WANT this job. Get over your embarrassment and say, "Hi, my name is Sonya. I come here as often as I can and such-and-such is my favorite thing to order. I really want to work here!" Your enthusiasm is what I am hiring.

· What bugs me most is when you check back by phone about your application. I get 50 applications a week, so you need to show your face in here once a week and keep telling me, in-person, that you want this job.

#### And from the other manager:

· Don't give your application to the cashier! I have a 6-inch-deep pile of applications on my desk right now. Give it directly to me so I have a face associated with it, otherwise it's lost in space.

· Don't come in during lunch or dinner rush. Come in when it's slow so I have time to give you a 5-minute interview. Now you're even more on my radar.

· We're tolerant of body jewelry and tattoos, but if they are obtrusive and make people uncomfortable, don't wear them

· Are you smiling? Do you make eye-contact with me? Do you have a positive attitude and up-beat energy? If so, you are one of the people I want to surround myself with. Skills? Don't worry, I can teach you.

· What do I ask during the 5-minute interview? I ask, "Do you eat here?" If you are passionate about your favorite item, you will probably be passionate about working here. I also pay close attention when I tell you we wash our own dishes and clean our own toilets. What's the look on your face now?



#### **ROCK DOC**

Thomas Jefferson had so many serious interests and accomplishments, it's difficult to name even half of them. Besides helping to found a nation, he analyzed the gospels, started a university, promoted fine dining and bought half our continent from the French. He also squeezed in a few hours now and then to theorize about the origin of some peculiar bones dug out of the earth. (That bit of work made him a cousin to all of us geologists – or so I like to think.) But despite his brilliance in many fields, Jefferson got something important quite wrong, and we

perhaps can learn from the fact that so great a mind clearly stumbled. Up and down the eastern

seaboard of North America, some odd sets of bones had been discovered in the gravel bars and riverbanks of colonial America. Many of them appeared to come from an elephantlike creature with enormous, curved tusks. No one had ever seen such an animal in the flesh. Today, every schoolchild would call the remains woolly mammoths and mastodons, but such identifications weren't obvious if you were Joe Farmer in 1750 and you unearthed just a

bone or two from a creek bank. In 1796 Jefferson seriously studied a different set of fossil bones dug up in western Virginia. The beast was about 8-10 feet long, with a tank-like skull, thick and sturdy bones, and amazingly long claws on its paws. Jefferson first thought the animal was a great cat – a mega-lion of some sort. Later, when he read a scientific paper that came from Europe, Jefferson changed his mind and correctly identified his animal as being a type of sloth. The current scientific name of the beast, Megalonyx (great-claw) jeffersonii, honors Jefferson for his connection to the animal.

But what's much more important to me than the old bones is that Jefferson fully expected living mammoths and great sloths to show up in the world. North America was largely unexplored, after all, and it seemed quite plausible to him that the animals might soon turn up grazing west of the Mississippi. Jefferson even asked Lewis and Clark to keep an eye out for the beasts when the famous expedition headed toward the Pacific.

To put it simply, Jefferson rejected the idea of extinction. And that remained true until his own dying day, many decades later. Extinction simply seemed to Jefferson like the wild imagining of an evil nightmare. If certain animals had dropped off the face of the whole Earth, Jefferson reasoned, others might as well. Then the whole

of creation could come apart. Like many great thinkers of his age, Jefferson could not believe that a divinely ordered Creation would include extinction. It was much easier to imagine mammoths and sloths roaming the Great Plains.

But it wasn't long after Jefferson's day until almost everyone accepted the idea of extinction. In part that was because exploration of the hinterlands didn't yield living mammoths and sloths. And in part it was because more and more exotic animals – what we'd now call dinosaurs, pterosaurs, and ichthyosaurs - were being unearthed, and it was really quite clear to everyone they were not still alive (and thank goodness for that!). And there were more extinct Ice Age mammals discovered, too, ranging from saber tooth tigers a beaver as large as a modern black bear.

Two generations Jefferson, the general public started flocking to newly built natural history museums to see the fossils of ancient monsters on display. The bigger, the scarier, the better, and school children continue that strong current of interest in the subject today in our society, with kids often more able than I am to assign the formal scientific names to dinosaurs and Ice Age mammals alike.

One of the clearest lessons of geologic history is that species are temporary - our own most likely included. We may or may not like it, but extinction is as common as dirt.

The fact that a man as brilliant as Thomas Jefferson was quite wrong about something so fundamental as extinction should makeuslessermindsquitehumble. But soldier on we must, with our best judgments and a reasonably tincture of self-doubt to guide us.

#### NIGHT AT THE MUSEUM: BATTLE OF THE SMITHSONIAN (Rated PG)

A few years back, Ben Stiller made the museum world a whole lot more interesting to movie audiences when he discovered all the exhibits came alive during his night shift as a security guard. The wildly successful "Night at the Museum" was destined for a repeat, if only because commerce demanded it. How do you improve on what New York's Museum of Natural History has to offer? The answer is found in the sequel's lengthy title: "Night at the Museum: Battle of the Smithsonian." Indeed, it's all to be found in Washington,

D.C.'s megaplex of antiquities. This time around Ben Stiller's Larry Daley has become wealthy hawking his gadgets and inventions on TV. Still, he hasn't forgotten his museum roots, and on a visit to an evening event he learns from the officious Dr. McPhee (Ricky Gervais)thatallthebelovedexhibits are being crated and shipped for permanent storage in the bowls of the Smithsonian. This reminds me of the "Indiana Jones" movie where the artifacts are carted off to a subterranean federal archives warehouse, only to be forgotten for all time. Apparently, the exhibits at the Natural History Museum are familiar with this movie and wish to avoid the same fate.

#### **MAGICALLY FUN** "MUSEUM 2" **OFFERS DELIGHT TO YOUNG** AND OLD

Frankly, it's hard to see how the museum's Board of Directors would find interactive exhibits more appealing, since their own exhibits come to life at night. But then, museums usually keep daytime hours. Besides, you can't stop progress, and so everyone, from the miniature figurines of cowboy Jedediah (Owen Wilson) and Roman general Octavius (Steve Coogan) to the wax figures of the Neanderthals and Indian guide Sacajawea (Mizou Peck), get stuffed in wooden crates shipped to Washington. Unfortunately, the new arrival sat the Smithsonian awaken the denizens of the Smithsonian, including ruler Kahmunrah Egyptian (Hank Azaria), who's in a foul mood after centuries of slumber.

diminutive Jedediah The manages to put out a distress call to Larry, who just might figure out a game plan with the help of his computer savvy adolescent son. Rushing off to the Nation's Capital, Larry breeches the security system of the Smithsonian, only to find that the Egyptian ruler is busy making alliances with some of history's most heinous villains. The bad guys include Ivan the Terrible (Christopher Guest), who insists that he has a less fearsome name; a height-sensitive Napoleon (Alain Chabat); and a snarling Al Capone (Jon Bernthal).

Fortunately, the museum seems to lack wax figures of Hitler, Pol Pot, Stalin and Mao Tse-tung, lest there be absolute



carnage on a grand scale. As it is, Kahmunrah, fueled by an overweening ego, is obsessed with unleashing the dark underworld forces locked behind a portal secured by the golden tablet. "Night of the Museum 2" isn't real heavy on story, relying instead on creating enough mayhem that people, such as this reviewer, are easily distracted by the likes of a feisty Amelia Earhart (Amy Adams) and an Albert Einstein bobblehead. The irrepressible Amelia is the most amusing character, sparking Larry to rediscover some fun and adventure, and all the while jabbering away in vintage slang. Why does Amelia speak like Katherine Hepburn in a Howard Hawks movie, while the Egyptian ruler and Abe Lincoln utter the common jargon of today?

Not quite as pretty as Amelia Earhart, a vain General Custer (Bill Hader), often strokes his long, golden locks, while wallowing in low self-esteem for his military failure at Little Bighorn. The most amusing character is the pompous Egyptian pharaoh, who doesn't really appear that menacing, regardless of his futile efforts to insist that he's wearing a tunic, not a dress. "Night of the Museum 2" has great fun bringing to life some very iconic items, such as the classic V-J Day in Times Square photo of the American sailor kissing a young woman or Grant Wood's "American Gothic" painting (which, to my knowledge, still resides at the Art Institute of Chicago).

The slapstick comedy and the vibrancy of inanimate objects contribute to a youngster's enjoyment of this delightful comedy. Meanwhile, adults may find delight in the lively realization of historical figures and cultural artifacts. But most of all, great fun is had for all in the fact that "Night of the Museum 2," though far from brilliant, is nevertheless often very funny and enjoyable for the simple pleasures derived from an abundance of clever special effects.



## **Consider With Me the Life** Situation of Adam and Eve

Consider with me the life situation of Adam and Eve. You will find their story in the first book of the Bible, the book of Genesis, Chapters 2-3. Take it literally or symbolically but either way there is a message about living with constant temptation. You see, as the story is told, there is a lush garden in which Adam and Eve resides along with all the animals. In that "Garden of Eden" they have everything they need for life and happiness. In amongst all the flora and fauna, God the Creator, points out to Adam and Eve two trees. God says one is the tree of life and the other is the tree of the knowledge of good and evil. Now if you have heard this story you know what happened. Eve was tempted by the serpent and she ate some of the fruit from the second tree and shared it with Adam who also ate. They yielded to temptation and incurred eternal consequences.

I, being the son of missionaries, have heard this story since childhood. It was only this past year that I came to understand a new truth from that story. It is a truth that speaks deeply to me about living in a culture of constant temptation. You see, there is no time reference between the moment God showed them the two trees and gave them warning and the moment when Adam and Eve took that fateful bite. So this was their real life situation. They lived every day in between the two trees. The forbidden fruit was there waving in the gentle breeze day in and day out. It caught their eye; it beckoned them; even after the sun went down they fantasized about the tree.

How many days or years went by with Adam and Eve living in a state of constant temptation, living between the two trees? We can only speculate. The day came when they both succumbed to the temptation and the rest is history.

Here is my point. Before Adam and Eve's first sin they lived with constant temptation.

All those who adhere to religious faith and who seek to live spiritually and morally fit lives need to realize this Biblical reality. Metaphorically, we too live constantly between these two trees. There will always be some person, some material object, or some bit of information that bears the lure and enticement of the tree of the knowledge of good and evil. That tree never dies! Living in isolation won't help, neither will following the injunction of Jesus "if your eye causes you to stumble, pluck it out ...! (Matthew 5:29-30) You can run away from sexual temptation like Joseph ran from Potiphar's wife (Genesis 39:12) but another temptation waits just around the corner. 

If there's one thing I've learned over the years, it's that you can't make another adult behave. The only person you can control is the one you look at in mirror every morning. Now,

should a son or daughter want to help their parents, especially if one is in poor health, and the money's tight? Absolutely! But family relationships are strange animals. That kind of stuff is a real turn off, and it can get thrown back in your face in a hurry!

#### Set Aside Enough Money

How much money should I have in my business emergency fund? My annual sales are about \$100,000, and I currently have a couple of months of general and administrative expenses set aside.

You're getting there! I like the idea of a small business having about six months of expenses set aside. Having that kind of cushion provides a ton of options, and lots of peace. It also eliminates the need for borrowing money, because with that kind of cash sitting around, you basically become your own line of credit!

Having a personal emergency fund set aside is a little different than having one in place for your business. When it comes to personal finance, I usually recommend setting aside three to six months of expenses. But the basic idea is the same, regardless of whether you're talking about personal finance or the financial health of your small business. A fully-funded emergency fund can turn a disaster into nothing more than a minor inconvenience!

We knew that if anyone had to go to the bathroom while we were out, they had to use the bucket, because my Dad warned, "We're not going back until we're done fishing!"
