

# San Juan Schools Sweep NorCal Science **Olympiad, Advance to Nationals**

Carmichael - Months of preparation has paid of for Science Olympiad teams in San Juan Unified schools with Mira Loma High taking first place in the high school division and Arden Middle School taking first place for middle schools in last weekend's NorCal Science Olympiad. The event held on April 18 also ended with San Juan's Bella Vista High taking second place in the high school division and Churchill Middle School taking second in the middle school division. Barrett Middle school placed fifth for middle schools.

Both Mira Loma High School and Arden Middle School teams will advance to the National Science Olympiad set for May 14 – 17 in Augusta, Georgia. This will be Arden Middle School's seventh trip to the national competition and the sixth trip in the last seven years for Mira Loma.

"Mira Loma is very proud of this year's Olympiad team," said Mira Loma Team Coordinator and Co-Coach Dean Karagianes. "This is a very powerful team and has the potential to do extremely well at nationals. They have the support of the entire school as they head off to nationals."

The 2009 Mira Loma team beat last year's winning Mira Loma team score by 26 points for a total of 202 points at the Nor Cal Olympiad

while earning six gold medals, six silver medals, and one bronze medal in individual events. "Each time we raise the bar, these kids not only reach it, they rise above it," said Arden Coach Chris Watson.

Arden's 2009 team scored a total of 221 points with gold medals in 10 events, silver medals in four events, and bronze medals in three events. Science Olympiad is a national non-profit organization with the goal of increasing interest in science and science education. More than 5,000 teams nationwide compete for a chance to participate in the national event which tests student's problem solving skills, teamwork, and knowledge.



#### **Banks Versus Credit Unions** Dear Dave,

We're completely debt-free, and my husband and I have been very conservative with our investments our entire lives. Considering the current state of the economy, we were wondering if a credit union would be a safer place than a traditional bank for some of our savings. - Beverly

#### Dear Beverly,

With a traditional bank, you've got the Federal Deposit Insurance Corporation (FDIC) looking out for you. Late last year, Congress temporarily increased the basic FDIC insurance coverage limit from \$100,000 to \$250,000. This change is scheduled to remain in effect throughout 2009. The National Credit Union Administration (NCUA) is the FDIC of the credit union world, and they also increased their coverage limits in 2008.

The biggest thing you want to look at is the "hassle factor" if your institution goes broke and closes up shop. I haven't done business with big banks for years, primarily because of the awful customer service you get at most of them. I like local, community banks, and I believe whole-heartedly in credit unions. As a rule, these institutions practice excellent customer service. Plus, most of them didn't get mixed up the sub-prime debacle. Community banks and credit unions are both safe, and in most cases, they're both fabulous places to put your money! - Dave

#### Not Wanting to Cancel

#### Dear Dave,

My wife and I are a few months away from being completely debtfree, except for our house. Our combined income is about \$100,000 a year. We've been looking into long-term disability insurance. What is non-cancellable guaranteed long-term disability insurance, and how much should we get? - Tim

#### Dear Tim,

Ask yourself this question: If I become disabled, how much money will I need to live on? In most cases, the maximum you can get is around \$75,000. Since you guys have a pretax income of \$100,000, you'd be able to live on that, even a little bit less, if something happened to one of you.

Check out the tax situation. Historically, employer-furnished disability payments were taxable as replacement income, while payments on individual policies were considered insurance proceeds, and not taxable. This will make a big difference in how much available cash you will be getting.

I don't worry about short-term disabilities, because if you're debt-free and have an emergency fund, you can handle those. It's the things that could incapacitate you for years, or even the rest of your life that should concern you.

If you get into a bad health situation, non-cancelable, longterm disability is definitely the kind you want as long as the additional premium for such a feature isn't sky high. But if you can get this for a few more dollars a month, I'd go for it! - Dave







## Pregnancy, STDs: How savvy are today's girls?

#### by Lauren Forcella

Dear Straight Talk: My granddaughter "Tamara" is 16 and I suspect she is sexually active. Her mother travels for weeks at a time with her work and she and Tamara do not appear bonded. What I'd like to know is what girls this age are doing to protect themselves from pregnancy and transmitted disease. Once I have a snapshot from your teen panel, I can approach her in a way that doesn't alienate. — Pacific Grove, CA

Abi, 21, Pope Air Force Base, NC, (deployed): The average age is probably 15 for girls to start using birth control pills. The pill is the most commonly used product because there is a wide selection of hormone levels. As for condoms, most girls are oblivious to HIV and other STDs and "wrapping it before tapping it" usually goes out the window.

Laura, 22, Fair Oaks, CA: Both in high school and college, the pill is the default birth control. I knew one girl in high school, and now one in college, on Depo-Provera (the birth control shot), but that's the only exception. The common time to begin birth control is during high school, but age varies from girl to girl. For STDs, most girls use condoms. But girls on the pill often don't use condoms because they feel it's redundant, even though the pill doesn't protect them

from STDs. I have college friends that use neither condoms nor birth control. They know they're not being smart, but they have the mindset that nothing happened to them before so nothing's going to happen now.

Nicole, 19, Arcata, CA: About 80 percent of my friends are on the pill and most began taking it around 15 and 16.

Callie, 18, Redding, CA: Not counting condoms, of the girls I know using birth control, about 90 percent use the pill. The remaining 10 percent use things like the shot, patch, or NuvaRing, which also use hormones like the pill. The average age girls start using birth control is 16 to 17, although some begin as early as 14 to get their body used to the hormones.

Brie, 17, Ashland, OR: Most sexually active girls I know are on the pill and they obtain it from my high school student health center or Planned Parenthood. The pill is preferred because it's one of the most effective methods — but only if the pills are taken at the same time every day.

Rachel, 17, Fair Oaks, CA: For their first time having sex, every girl I know only used a condom. But once girls have boyfriends they usually just use the pill figuring they're in a relationship and their partner doesn't have STDs. However, none of my friends have been tested, with or

without their partners, so how they assume they are clean is beyond me. In my school sex-ed is coed and everyone laughs everything off awkwardly. I'm disappointed that most girls aren't open about their sex lives with even their mothers, but then, most parents aren't supportive.

Dear Pacific Grove: There's your snapshot. The panel's observations match 2006 Guttenmacher Institute statistics which show that sex is fairly rare at age 15 with only 13 percent of teens ever having intercourse. But by age 19, that figure jumps to 70 percent, with 17 being the age when most teens have first sex. Although the pill is definitely the most popular birth control for teens, with condoms second, the US leads the developing world in teen pregnancies and adolescent sex accounts for half the new STI cases each year. Every "Tamara" out there needs a motherfigure to talk to as nearly half her peer group is sexually active. Be understanding and non-judgmental, take small, patient steps as if charming a feral cat. At this stage, connection, not control, will give you the most influence. Good luck.



# Making Work Pay Credit is Increasing Payroll

Submitted by IRS Media Relations Sacramento - In 2009 and 2010, the Making Work Pay provision of the American Recovery and Reinvestment Act will provide a refundable tax credit of up to \$400 for working individuals and up to \$800 for married taxpayers filing joint returns.

This tax credit will be calculated at a rate of 6.2 percent of earned income and will phase out for taxpayers with modified adjusted gross income in excess of \$75,000, or \$150,000 for married couples filing jointly.

For people who receive a paycheck and are subject to withholding, the credit will typically be handled by their employers through automated withholding changes in early spring. These changes may result in an increase in take-home pay.

The amount of the credit will be computed on the employee's 2009 income tax return filed in 2010. Taxpayers who do not have taxes withheld by an employer during the year can also claim the credit on their 2009 tax return.

It is not necessary to submit a Form W-4 to get the automatic withholding change. However, an employee with multiple jobs or a married couple whose combined income places it in a higher tax bracket should consult the IRS withholding calculator and, if necessary, submit a revised Form W-4 to ensure enough tax is withheld. Publication 919 provides additional guidance for tax withholding including a special Making Work Pay worksheet.

## Annual Seminar for Faith Leaders on End-of-Life Care is Set for June 3

Seriously ill and dying individuals, and their families, often turn to faith communities for support during their illness. Yet faith leaders may feel unprepared to care for people coping with complex medical, ethical and interpersonal issues that surround a person's last days. The Center for Healthcare Decisions will host Partners in Caring, an engaging seminar to help faith leaders gain confidence in supporting people near life's end. The program will be held from 8:30 am – 4:30 pm on Wednesday, June 3 at the Sierra Health Foundation Conference Center in Sacramento.

Partners in Caring is intended for community clergy, rabbis and priests; staff and volunteer chaplains; parish nurses and health ministers. Presenting faculty include physicians, other health professionals and faith leaders who will discuss: Important concepts end of life, Legal issues around life-sustaining treatment and advance directives, Information about pain management, including myths and misconceptions, How to partner with the medical team to address issues around suffering, Ways to address the spiritual needs of patients and families, and How to facilitate communication and be present with the dying.

Attendees have given high marks for the quality, value and sensitivity of material presented. Past participant Pastor Debbie Naramore with The Rock of Roseville Church notes that the program included "amazingly dedicated, professional speakers. This was one of the best seminars I've ever attended."

"Partners in Caring grew out of interviews with area faith leaders who said that while they often are called upon to minister to families facing end-of-life issues, most haven't received training about these issues

Once a vibrant, energetic lady who devoted many years in helping make the Elk Grove Strauss Festival such a success, Boyd said he watched his wife "take a long march to the grave. I know this disease, I've been through it, and it is terrible!" Boyd, a caregiver for seven years, who took an early retirement to care for Diane, had much support from their seven children and their families, but he began to realize he was living in a dark cave. "I was depressed; I was trying to do everything. I was trying to make Diane as comfortable as possible." Even a trip to the dentist was a welcome respite for Boyd. He told me he was living in "Alzheimer's prison," but he never lost his sense of humor, and Diane provided many funny moments at the most unexpected times. For instance, Diane once broke into song at a pharmacy, entertaining an elderly woman. Boyd "let out a laugh and thanked the woman for listening" he told me.

# **Swine Flu Public Health Update**

Sacramento - In addition to the one sample from a student at St. Mel's school in Fair Oaks that was sent to the Centers for Disease Control on Saturday April 25 for additional testing, on Sunday, April 26, Sacramento County Public Health identified three additional children at St. Mel school in Fair Oaks who were ill during the week of April 20 through April 24. Samples from all three children will be tested at the Sacramento County Public Health Laboratory today. If any of these samples turn out to be an unsubtypable Influenza A virus, the sample will be sent to the State Public Health Lab and to CDC for identification. One child has recovered completely, the other two children still had symptoms yesterday. All illnesses have been mild.

At this time, the last onset of symptoms for an influenza-like illness in students of St. Mel school was Thursday, April 23. Therefore the earliest the school would reopen is Thursday, April 30. However, if we identify other onset of illness the opening may be postponed. Sacramento County Health Officer

Dr. Glennah Trochet says there are three things the public should do at this time: "We continue to recommend the same, prudent precautions to the public that we always recommend during the flu season: that everyone should wash they hands frequently, stay home from work or school if they feel ill, and cover their mouths with a tissue if they are coughing," Trochet said. 

ave you ever wondered if you were related to someone famous? Did you grow up hearing stories about a distant relative and wonder if they were true? Or are you curious about what part of the world your family really came from?

He was only six-years old when the family was split up, and had spent his life wondering what had happened to his sisters. Together, they later found his sisters and have all since met and grown very close.

## **Digging Up Information**

There's a wealth of data available online, but you need to know where to look. According to Szucs, records such as these are constantly updated with new information.

- Census records can tell you where your ancestors lived, where they were born, what their occupation was, names of family members and other clues to the family puzzle.
- Newspaper collections carry birth, marriage and death notices, all of which provide valuable family information. You may also find your ancestor's name mentioned in legal or social notices, articles or advertisements.




