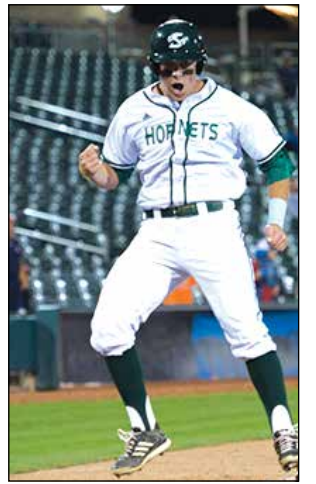

Sacramento Locals Prepare For Baseball's Biggest Stage

SACRAMENTO REGION, CA (MPG)

- Despite the San Francisco Giants and Oakland Athletics missing the playoffs this season, Sacramentans still have a lot to look forward to with the 2022 World Series beginning this Friday, October 28.

Three Sacramento-area locals will be participating in this year's Fall Classic, with two on the field and one in the dugout. Philadelphia Phillies first baseman Rhys Hoskins stands on one side representing the 916. On the other side stands utility player Mauricio Dubón and manager Dusty Baker for the Houston Astros.

Hoskins has played for the Phillies his entire career since being drafted in the fifth round of the 2014 Major League Baseball (MLB) Draft out of Sacramento State. Before becoming a Hornet, Hoskins played locally at Jesuit High School in Carmichael. This is Hoskins' first playoffs and World Series appearances as Philadelphia snapped an 11-year postseason drought this year.

Baker is back for more after reaching the World Series with Houston last year. After playing 19 years in the big leagues, Baker is in his 25th year as an MLB manager. He led the Giants to the World Series in 2002 and now the Astros to back-to-back appearances in 2021 and 2022.

Baker holds the record for most wins among managers who have yet to win a World Series. He went to Del Campo High School in Fair Oaks and still has a Sacramento residence

City Council Shopping for Military Grade Weapons

RANCHO CORDOVA, CA (MPG) - The Pentagon is holding a garage sale. The Rancho Cordova City Council plans to do a little bargain shopping.

Councilmembers voted unanimously in support of a resolution during the October 17th meeting, which would allow local police and deputies with the Sacramento County Sheriff's Department (SCSD) to deploy military-grade weaponry to "safeguard lives and ensure safety."

The resolution was placed on a consent calendar that contained several different items. All were approved with a unanimous vote with no city

council debate.

According to a Rancho Cordova city staff report, approval of the new policy will give local police and sheriff's deputies the ability to access and use "the most up-to-date equipment to safeguard the citizens of Rancho Cordova."

The resolution and city council vote that authorizes the use of military equipment for law enforcement stems from state legislation signed into law by Governor Newsom last year. AB 481 required law enforcement agencies to follow specified procedures prior to purchasing or using surplus federal military equipment. This new set of rules included approval from local governing

bodies, such as the Rancho Cordova City Council.

According to a Senate Floor Analysis of AB 481, the measure authorized the United States Department of Defense to transfer surplus guns and ammunition for use in law enforcement activities at no cost to the agency that acquires them. Furthermore, the measure required that law enforcement agencies create and adopt a "military equipment use policy."

Councilmembers were also provided with a 77-page inventory of military equipment that the SCSD has already acquired during the October 17th meeting. This includes 17 types of unmanned, remotely piloted, powered aerial or

ground vehicles.

The inventory list also includes armored personnel carriers, military-grade explosives, firearms of .50 caliber or greater (plus ammunition), flashbang, pyro, and expulsion grenades, and shoulder-fired 40mm launchers that can deliver chemical agents such as tear gas and smoke.

Although no type of weapon is currently listed in the SCSD inventory, a military equipment use policy revised and released in March of this year mentions the possible acquisition and use of "kinetic energy weapons and munitions." Definitions and types of kinetic energy weapons can vary widely, but most

was president and CEO of the Sacramento Chamber of Commerce.

Paula Villescaz, Democrat, www.paulavillescaz.com. Villescaz was unable to attend the Campaign Whistlestop event or participate in a later interview. She is a lifelong Sacramento resident, has served two terms as president of the San Juan School District Board of Trustees, and was an assistant secretary of California Health and Human Services Agency during the pandemic. She attended Cal Berkeley and now is a director of Legislative Advocacy for the County Welfare Directors Association.

STATE ASSEMBLY,
DISTRICT 7

Ken Cooley, incumbent, Democrat, www.kencooley.com. Ken Cooley has lived in Rancho Cordova for 40 years, advocated strongly for cityhood and was elected as an inaugural City Councilmember in 2002. He is a lawyer, a graduate of Cal Berkeley, and his early work was as an insurance industry advocate. He became active in the League of Cities in 2004. "There are 500 cities in this state," Cooley said, "but I was moved right through the ranks of leadership to the top level . . . My career is one of how I deploy myself; I chose

to do that in public service." He said this would be his last Whistlestop. "I don't expect to run again, but I feel my work is underway."

Josh Hoover, Republican, challenger, www.hooverforassembly.com. "We rank 50th in literacy in the nation in California," Hoover said. "Our public education system has a lot of improvement that can be made. "Other focuses include restoring accountability to the criminal justice system, and homelessness. Hoover feels the root causes of mental health and substance abuse should be addressed first, with housing a close second. "I feel very good about our chances to win this race, because of redistricting . . . There are 80 Assembly races this year and only two of them are labeled as toss-ups, meaning they could go either way; this is one of those two."

Hoover is chief of staff to California State Assemblyman Kevin Kiley, and he is an elected member of the Folsom Cordova Unified School District Board of Trustees. He holds a degree from UCLA and USC.

Brian Danzl, incumbent, www.danzl4parks.com. Danzl has been an athletic coach and is a

longtime community volunteer. "In the 12 years I've been on the Park District," Danzl said, "we went from having almost no money, through the County, to now we've got over 15 million dollars in reserves . . . we've built new parks; we continue to just grow and grow." Because of a disagreement the City and the Park District discontinued their standard 2x2 meetings, Danzl said. The Brown Act requires the District to agendize the meetings, and the City refuses to attend if a public agenda is required.

Jack Zwald, challenger, www.jackzwald.com. Jack Zwald is an education policy advisor for the California Department of Finance, a former member of the Sacramento County Public Health Advisory Board, and past president of the Kiwanis Club. "I guess our main goal would be to turn around the relationships of the Park District with its neighbors," Zwald said, "and make it positive so that we can start collaborating in areas of combined interest to provide better public services and safety for our community." Zwald pointed out the lack of required 2x2 meetings between the District and the City of Rancho Cordova. He disagreed that having healthy reserves is a good thing calling it, instead,

"hoarding," and suggested using the money for investments to speed up the completion of projects.

Inez Reyes, incumbent, www.reyes4rec.com. "It's been 16 years that I've been on the Park Board, and we have worked very hard on what we call, 'the transition.'" Prior to the City's incorporation, Reyes said, parks were being maintained, not built. The transition was challenging and a whole set of skills built up around the change.

"Mr. Matus said something about the Park District – it had disarray," Reyes said. "In the last 5 years we spent \$15.5 million on completing 96 projects . . . We have put together a beautiful, very precise and concise orientation for new candidates. Only Mr. Matus attended, the others didn't even attend."

Between 1998 and 2006, Reyes worked as workforce development employment training administrator for the County Office of Education. She is also a real estate broker.

Mark Matus, challenger, www.markmatus.org. Matus is an information technology specialist with the State of California, specializing in audiovisual productions, web design, and social media

marketing. "I was born in Rancho Cordova and lived in the area most of my life," Matus said. "Also, my father has had a business in Rancho Cordova since 1976." He and his family visit (Prospect Hill) Park every single day and are involved in sport organizations six days out of the week in some capacity. A basketball court has had a huge gap that ran all the way down the middle of the court and presented a danger. "I find it interesting now in an election year . . . our basketball blacktop is being fixed, literally the week the ballots go out . . . I will do my part to improve the conditions in our older and established parks, provide clean, safe parks and establish amenities and repair relationships with our sports leagues, every single day."

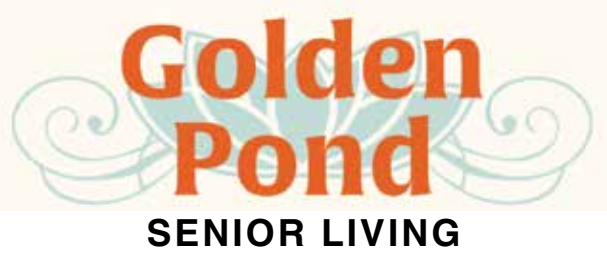
Terri Leimbach, incumbent. Leimbach is a member of the County Consolidated Redevelopment Agency Oversight Board. She was elected to CRPD in 2014 and re-elected in 2018. In addition, she has a Master's degree in management, and is a retired accountant from a recreation and park district; her experience is specifically in recreation and park districts. She serves on the Special District Advisory Board of LAFCo (Local

Agency Formation Commission). "The progress that we're making is the result of a great strong board and strong leadership of the district," Leimbach said. "We've had 10 years of clean audits from an independent CPA firm. We have 5 million in general reserve and 10 million in special reserves . . . Before that we had no reserves."

Daniel Langan, challenger, www.danielangan.com. Langan's decided to run for CRPD Board when their babysitter found used needles in a nearby park. The homeless population is a problem. I plan on working with the City Council to provide a permanent solution to our citizens," Langan said. He said the parks need better lighting, physical security and video surveillance. "I want to advocate for some splash pads or even a community pool."

Langan is a youth pastor at a local church, has coached Little League baseball for several years, and is assistant JV boys' basketball coach at Cordova High.

Shelly Blanchard, executive director of the Cordova Community Council delivered the introductions for each candidate. Each presented their cause and most participated in a brief interview in the days immediately following the event. ★

SACRAMENTO COUNTY, CA (MPG) - District Attorney Anne Marie Schubert warns the public that rainbow fentanyl pills are now in the Sacramento community. Law enforcement has recently made the first significant rainbow fentanyl fake M30 pill seizure in the Sacramento region.

These colorful fentanyl pills look exactly like Smarties candies, and they are designed to attract kids and teens.

With Halloween coming up, DA Schubert urges parents, guardians, educators and community leaders to talk to kids and teens about the fentanyl epidemic, how they're being targeted with rainbow pills and how to avoid

becoming a victim of fentanyl poisoning. Quick facts include: Fentanyl is deadly; just a few grains can kill; Fentanyl is everywhere: fake pills, powders, party drugs, now rainbow pills disguised as candy; 99% of Oxycodone M30 pills seized and tested in Sacramento County contain fentanyl; It's virtually

impossible to tell if a pill, or any form of a drug, is fake and contains fentanyl; If a drug didn't come from a pharmacy, assume it contains fentanyl.

Who Let the Dogs Out? We Did.

SACRAMENTO COUNTY, CA (MPG) - It was all fun and games for the dogs at Sacramento County's Bradshaw Animal Shelter last month.

The shelter was chosen to participate in three intensive, all-day training workshops with Dogs Playing for Life (DPFL), a 501c3 non-profit organization rooted in a dog's natural instinct to play. The sessions, which taught staff how to conduct successful large-scale playgroups to increase dogs' adoption prospects as well as provide efficient and effective socialization and exercise, took place from Sept. 28 - 30, 2022. Over three days and a series of playgroups, more than 100 dogs ran, wrestled and rolled around together.

The play model is part of an innovative approach to animal sheltering: one that aims to make a stay at the shelter more like a fun trip to summer camp and less like time behind bars. DPFL furthered staff's expertise of dog behavior by teaching them how to assess nuances of play styles and body language in order to create dog playgroups that bring out the best in animals while minimizing the risk of injury or

spread of infection.

"A big misconception is that it's too risky to let dogs play or that shelter dogs have to be carefully taught how to socialize," said Lauren Revier, Program and Research Administrator for DPFL. "It's natural for dogs to interact and play, and when playgroups are approached thoughtfully, most dogs can participate and enjoy them."

Dogs that have the most difficult time getting adopted stay in shelters the longest and are most at risk of developing behavioral issues due to prolonged shelter stress are generally those that aren't social with other dogs. Most adopters and rescue groups seek out dogs that play well with others since the majority of homes interested in fostering or adoption already have at least one

dog at home. These playgroups can help the less social dogs develop the dog-to-dog skills they need to adopt and succeed in their new homes.

Shelter staff plan to carry out what they learned from DPFL in ongoing future playgroups. In large municipal shelters like Bradshaw Animal Shelter, where the numbers often tip past 300 pets on site, it is a daily endeavor for shelter staff and volunteers to ensure every animal gets quality time outside of their kennels each day. Not only will the playgroups give dogs more time to run free, but they will enable staff and volunteers to spend individualized time with dogs that need it most, such as the ones that are extremely scared and shut down in the shelter environment. ★

contain the result of "destroys everything in its path."

Under its military equipment policy, the SCSD will be required to create and distribute a military equipment report every year for as long as the equipment remains in use. This report will also be posted on the SCSD website. In addition, the SCSD will be required to hold at least one public meeting every year to

respond to public questions regarding the funding, acquisition, or use of military equipment.

According to a city staff report, the City of Rancho Cordova has a law enforcement services contract with the SCSD. This agreement led to the formation of the Rancho Cordova Police Department. These two agencies provide municipal law enforcement services within the city. ★

CHP Gets Grant for Motorcycle Safety

SACRAMENTO, CA (MPG) - The California Highway Patrol (CHP) will implement a yearlong federal grant to help save lives and reduce the risk associated with riding a motorcycle.

The goal of the Get Educated and Ride Safe (GEARS) V grant is to decrease the number of motorcycle-involved crashes and victims through education and enforcement efforts across California through September 30, 2023.

From October 1, 2020, to September 30, 2021, there were 7,078 motorcycle-involved crashes resulting in 354 deaths and 6,400 injuries within CHP jurisdiction, an increase of 3 percent over the previous 12 months.

"Motorcycle riders are statistically more likely to be injured or killed when involved in a crash," said CHP Commissioner Amanda Ray. "In an effort to ensure every motorist reaches their destination safely, the CHP will continue to

use enforcement and non-enforcement strategies, including education and community engagement, to target the leading causes of traffic deaths."

During the grant period, the CHP will participate in traffic safety education efforts, such as

"May is Motorcycle Safety Awareness Month." These campaigns will promote the use of U.S. Department of Transportation-compliant helmets for all riders and raise driver awareness of sharing the road with motorcyclists. The CHP will also increase enforcement in areas with a high number of motorcycle-involved crashes, which resulted from speed, improper turns, and driving under the influence of alcohol and/or drugs.

Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

The mission of the CHP is to provide the highest level of Safety, Service, and Security. ★






Cordova Crashes Back to Earth with Loss to Johnson

ROSEMONT, CA (MPG) - The Cordova varsity football team faced a reality check on Saturday afternoon with a 60-15 loss to Johnson following its first victory of the season.

The Lancers (2-8, 1-3 Greater Sacramento League) and Warriors (7-3, 3-1 GSL) played at Rosemont High School on Saturday, October 22 as Johnson celebrated Homecoming weekend.

Cordova was set to play at Rosemont against the Wolverines on September 9, but the game was canceled due to the air quality and heat. The Lancers forfeited the

game, balancing out their record, as they earned a forfeit win from their matchup against El Camino on August 27.

The Warriors quadrupled the Lancers on the scoreboard, winning 60-15. Johnson was led by junior quarterback Marino Fragata who completed 22-of-26 passing attempts for 520 yards and eight touchdowns.

Senior Kevin Lewis returned to back under center for Cordova after starting a handful of games in the backfield at running back. Lewis tossed 4-of-11 passes for 108 yards and a score.

His one touchdown pass went to junior Jayden Rice who made

the catch in the back of the end zone, barely keeping one foot inbounds. The scoring play was set up by a 55-yard catch and run by the junior. Rice finished with three receptions for 105 yards and a touchdown.

Lewis was the game's leading rusher as he finished with 15 carries for 144 yards (9.6 yards per carry) and one touchdown. The do-it-all senior also led the Lancers in tackles with 11 total, one for a loss and eight on his own.

Cordova returns home this Friday for Senior Night against Florin. Kickoff for the last Lancers game of the season is set for 7:15 p.m.

California May Reallocate Shrinking Water Supply

which agricultural water agencies would curtail diversions to maintain river flows, but results have been scanty at best.

Without such agreements, the water board could implement mandatory reductions, but they would be viewed by farmers as an assault on their historic water rights and probably trigger massive legal battles.

The key principle in these conflicts is that water belongs to the public as a whole and must be put to “beneficial use,” as defined in a 1943 law that implemented a constitutional declaration passed by voters in 1928. The law commands authorities to prevent “waste or unreasonable use or unreasonable method of use of water...”

Environmentalists believe the constitution thus authorizes the state water board to curtail agricultural diversions for the protection of habitat, but the 1943 law also declares, “In the enactment of this code the Legislature does not intend thereby to effect any change in the law relating to water rights.”

That obvious legal dichotomy is the crux of the situation.

Whether, indeed, the state water board is gearing up for a showdown over water rights, some of which stretch back to the 19th century, is the subject of much speculation in water circles.

Early this year, water board chairman Joaquin Esquivel told a gathering of water officials, “We know we have to change the system. Water rights can be there as a tool to be able to manage supplies through not just a drought but when

there is water again. Our water rights system can be there to facilitate decisions on projects and help us make decisions, or they can be a hindrance.”

While the water rights issue percolates in Northern California, there’s a similar conflict underway in Southern California over how much water the state diverts from a severely threatened Colorado River.

California is legally entitled to 4.4 million acre-feet per year, with the vast majority of that going to the Imperial Irrigation District and other agricultural users, but the Colorado’s flow has dropped dramatically.

The federal government demands that California and other states that draw from the river, principally Nevada and Arizona, reduce diversions by 2-to-4 million acre-feet per year, and threatens to mandate cuts under the “beneficial use” doctrine if they cannot agree.

California has offered a 400,000 acre-foot reduction, only 9%, but that’s not enough to satisfy the other states and the outcome is very much in doubt. Meanwhile, the feds are offering Colorado water users \$400 for every acre-foot of water they don’t take.

Farmers’ water rights are clearly not as sacrosanct as they once seemed to be, and as drought persists the stage is being set for a monumental reckoning of some kind.

Sheriff’s Dept. Seeks Information on Delta Jane Doe Homicide from 2004

SACRAMENTO COUNTY, CA (MPG) - On Saturday, March 29, 2008, the Sacramento County Sheriff’s Office Communications Center received a call regarding the discovery of possible human remains in the area of Tyler Island and the Georgianna Slough, located in Sacramento County.

Patrol deputies arrived to the location and determined the remains appeared to be human and requested Sheriff’s Homicide Investigators respond to the scene. Over

the next 3 days, Homicide Investigators, Criminalist from the Sacramento County District Attorney’s Laboratory of Forensic Services and the Sacramento County Coroners Office processed the scene and exhumed the remains. The Coroner classified the case as a homicide and determined the victim was most likely killed in the fall of 2004.

Over the past 13 years, Sheriff’s Investigators and the Coroner’s Office have worked to identify the victim. The investigation included reviewing hundreds of Missing Persons reports, providing the media with photographs of clothing and jewelry found with the remains as well as a composite drawing of what the victim may have looked like. A facial reconstruction, using the victim’s skull, was also released to the media at the time but the victim remained unidentified.

In 2021, Investigators began a Genetic Genealogy Investigation. As a result of this investigation, the

victim has been identified as Shannon Vielguth (born 1969). Her identity has been confirmed with the DNA of a close family member. Vielguth used several last names, including Judkins, Hutchings and Joyce. Investigators learned Vielguth was transient during the 6 months prior to her murder, staying in Missouri, Oklahoma, Kentucky, Colorado, Nevada, and California. Based on law enforcement records, Vielguth was most likely in Reno Nev., and Sacramento in October of 2004 which coincides with the time she was most likely killed.

Veterans and Suicide

Veterans Day, November 11th, is an important day for every American and is intended to honor America’s veterans for their patriotism, love for their country, and willingness to serve and sacrifice for the common good. This day of remembrance celebrates the service of all U.S. military veterans. Communities across the country plan events to honor those who have served and are currently serving. As we celebrate and recognize these brave men and women, we should also consider the struggles that they go through with mental illness.

Suicide is a national problem in the U.S. and a major concern for active-duty service members and military veterans. Members of the military may experience a variety of difficult and traumatic events including combat, natural disasters, and physical assault. According to the 2022 National Veteran Suicide Prevention Annual Report, there were 6,146 Veteran suicide deaths in 2020. That is 31.7 deaths per 100,000. During that year, suicide was the second leading cause of death among Veterans under age 45. The suicide rate for Veterans was 57.3% greater than for non-Veteran U.S. adults.

Veterans can come home from service carrying a weight they did not go in with. Without the right help, that weight can seem like too much, leading some Veterans to consider, or carry out, suicide. Some of the warning signs that Veterans exhibit include feelings of hopelessness, acting agitated, struggling with anxiety, insomnia, outburst of

anger or rage, an increase in substance use or abuse, and isolating themselves from the people close to them. Other factors related to the higher risk of suicide among Veterans are related to undiagnosed or untreated conditions, such as PTSD or mood disorders, which can increase a person’s overall risk of suicide.

The VA offers a wide range of treatment programs for Veterans and their families. Also, “Vets for Warriors” is a peer support network with Veterans answering the phone for those in need. The number is 1-855-838-8255. Veterans may also use the Veterans Crisis Line Number where there is 24/7 crisis support. Dial 988, then press 1.

The Jason Foundation is another valuable resource for those struggling with suicidal ideation. Many times, a Veteran will exhibit clear warning signs prior to an attempt. By knowing the warning signs, and knowing how to help, you could save a life. SACRAMENTO, CA (MPG) - Rail passengers in Northern California and the Central Valley will start enjoying a more comfortable and modern ride after Caltrans accepted into its fleet the first of seven Siemens Mobility single-level intercity trainsets at the San Joaquin Regional Rail Commission facility in Stockton.

I started reading a book called "life is messy," and the author is Matthew Kelly. It began by saying "The human dilemma. Life is messy. This is the human dilemma. You're not doing it wrong. Life isn't a color-within-the-lines exercise. It's a wild and outrageous invitation full of uncertain outcomes. Sometimes it is beautifully rational, at other times it lacks all logic. What appears to be a step back today, may turn out to be the first marvelous step forward ten years from now."

"There is no plan you can devise that will solve the mess. There is nothing you can buy, learn, or accomplish that will eliminate the mess. Finding the love of your life and the perfect career won't either. There is nothing you can start doing or stop doing that will eradicate the mess. There's nothing you can tell yourself that will make the mess magically disappear, and you cannot think your way out of it. The mess is here to stay. It's unavoidable. It's just life."

I will be reading the book and see what else it may say, but I like the way it is written. Maybe you would like it too.

Spooky, Creepy and Tasty Too

Halloween straddles fall and winter...life and death. It's thought to have originated with the ancient Celtic festival of Samhain. People would light bonfires and wear costumes to ward off roaming ghosts. The Celts, who lived some 2,000 years ago in the area that is now Ireland, the United Kingdom, and Northern France celebrated the New Year on November 1. This day marked the end of summer and the harvest, and the beginning of the dark and cold winter, a time of year that was often associated with human death. Celts believed that on the night before the New Year, the boundary between the worlds of the living and the dead became blurred. That's why on October 31, they celebrated Samhain. They thought these roaming ghosts would cause trouble and damage crops. Since this was a culture entirely dependent upon the volatile natural world, prophecies were an important source of comfort and direction during the long, dark winter.

Then Halloween came to America, but extremely limited in colonial England because of the rigid Protestants. It was much more common in Maryland and the southern colonies. Today's tradition probably dates back to the early All Soul's Day parades in England. During the festivities, poor citizens would beg for food and families would give them pastries called "soul cakes" in return for their promise to pray for the family's dead relatives. The soul cake was encouraged by the church as a way to replace the ancient practice of leaving wine and food for roaming spirits. Merging different ethnic groups and Native American Indians gave America its own Halloween. The first ones were party-driven and public events to celebrate the harvest. Neighbors would share stories of the dead and tell fortunes. Colonial Halloween festivals added ghost stories and America began dressing in costumes and going house




to house asking for money for food. That's when "trick or treat" was born. Young women believed they could divine the name or appearance of their future husband by doing tricks with yarn, apple parings and mirrors. By the late 1800s, there was a move to mold Halloween into a holiday more about community and neighborly get-togethers than about ghosts, pranks and witchcraft.

- 5. Chew Sugarless Gum.** Chewing gum causes increased saliva flow which helps wash out food and naturally cleans teeth. But enjoy the fun and tasty treats. ★
