The Flu Has **Had Serious** Consequences in Sac County

SACRAMENTO COUNTY, CA (MPG) - The flu season is already in full swing in Sacramento County. With these flu cases increasing so early in the season, Sacramento County Public Health urges everyone to prioritize getting the flu shot now to protect you and your family from the deadly virus.

Since the beginning of this year's flu season, 12 flu cases have been admitted to the Intensive Care Unit (ICU) in Sacramento County and Public Health has received reports confirming influenza has claimed the life of a Sacramento County 66-year-old, as well as a 7-year-old who had multiple underlying medical conditions. This is the second pediatric death in California for the 2019/20 flu season.

Getting vaccinated is the best defense against the flu, but it takes a couple of weeks after vaccina tion for the body to build immunity. The strains of influenza that are circulating in Sacramento County this season are Influenza B, which is most prevalent among the cases (ICU and deaths, all ages) reported to Public Health, and Influenza A (not subtyped and subtype H1N1 and H3N2). The flu vaccine, which is readily available, covers the strains of the flu that have been detected in Sacramento County. The California Department of Public Health and the Centers for Disease Control and Prevention (CDC) recommend annual influenza vaccinations for everyone six months of age and older - including pregnant women - who do not have medical contraindication to receiving the vaccine. A person's decision to receive the flu vaccination or not affects the entire community - especially those who medically cannot have the flu vaccine. Those who have regular contact with people more vulnerable to the complications of flu - including babies, children with chronic health conditions such as asthma and diabetes, and adults 65 years and older - should get vaccinated so the flu virus isn't spread to them. "Everyone in the community, who can get vaccinated, should get vaccinated. Vaccination is the best protection against the flu, which is a preventable illness," Sacramento County Public Health Continued on page 8

Rancho Cordova Police Department Halts Unsafe and Illegal Marijuana Cultivation

RANCHO CORDOVA, CA (MPG) - The Rancho Cordova Police Department (RCPD) is taking a proactive approach to identify and halt illegal marijuana cultivation to prevent illegal activity and nuisances for residents and businesses in the City of Rancho Cordova.

According to the Rancho Cordova Municipal Code, up to six plants may be cultivated indoors in a private residence in the city. However, RCPD is seeing unsafe and illegal cultivation in residential and business areas that far exceeds this plant requirement.

RCPD recently added an officer focused on illegal marijuana cultivation investigations and enforcement to enhance its ability to investigate tips from the

Budget Update: Board Approves Ongoing Reductions to Provide Solutions

Folsom Cordova Unified School District

RANCHO CORDOVA, CA (MPG) - The Folsom Cordova Board of Education on Nov. 21 approved a package of budget reductions proposed to help alleviate the District's budget challenges. The measures were designed to avoid potential layoffs while minimizing impacts to classrooms and student learning.

The Board voted 3-2 to approve \$4.9 million in ongoing reductions, as well as another \$1.4 million in one-time dollars, through a series of measures reached collaboratively with the District's employee bargaining units. The reductions identified were the culmination of months of work with school site leadership, employee union leaders, and others to review and evaluate new ways to design programs and services while maintaining high-quality educational opportunities for students.

More reductions must be determined: The District will still need to identify an additional \$2.5 million in cuts by its next budget report to the Sacramento County Office of Education (SCOE) by March 2020.

Note: Potential staffing reductions adopted Nov. 21 are likely to be absorbed through attrition.

Some of the approved, ongoing reductions include:

Staffing reductions at the Education Services Center (\$250,000): The District began eliminating vacant administrator positions in 2018-19 and will continue to evaluate opportunities to restructure operations. The reductions approved include the elimination of one director and two classified positions.

Reduction of teacher prep periods at Mills and Mitchell middle schools (\$828,793): This move will standardize middle school schedules across the District and will result in a surplus of 5.7 teachers at Mitchell and 4.5 teachers at Mills, likely to be absorbed through attrition. The District is working with staff at both schools to design new school-day schedules that support and sustain exceptional educational offerings, such as International Baccalaureate.

Standardizing Kindergarten schedules (\$190,000): This measure will move all kindergarten to the "AM/PM" model currently used by six school sites and result in surplus of 1.9 physical education specialists, likely to be absorbed through attrition.

Redirection of Folsom Lake High School students to existing Alternative Education (\$407,000): Under this plan, students would be provided the opportunity to obtain credits through a hybrid model that includes a small learning environment in another location that best meets their needs. Students will also have the chance to enroll in electives and other courses at Folsom High School. The Independent Living Skills (ILS) program for 18-22-year-olds with special needs will remain at the Folsom Lake High campus for the 2020-21 school year while alternatives are explored. Three certificated, two classified employees, and one administrator will be impacted by the move, with the potential to absorb possible reductions through attrition.

Why do cuts need to be made? School districts across the state are experiencing fiscal challenges due to rising employee and operating costs that are outpacing revenues. The Board has held five public study sessions in the last year to explore ideas for solutions to Folsom Cordova's budget shortfall.

In the 2020-21 school year, the District projects an estimated \$3.5 million budget shortfall, and an additional \$5.5 million the following year. If long-term, ongoing cuts are not identified, SCOE may reject the District's budget, prompting deeper cuts.

Have any cuts been made previously? As part of the first phase of budget reductions this year, the District has taken several actions, including reducing travel and conference expenses, saving money through early retirements, eliminating vacant teaching positions that did not have class rosters (such as intervention teachers in Folsom), declining to backfill some clerical positions, and eliminating some administration positions by collapsing vacant positions.

What's next:

The District is working with its classified employee bargaining unit, CSEA, to evaluate an early retirement incentive that could reduce staffing across the District and avoid layoffs by not backfilling vacancies. The teachers union, Folsom Cordova Education Association, accepted a similar early retirement program last year to reduce teaching staff.

The District will continue to work with its school communities to identify and implement further reductions for the 2021-22 school year.







CHP Revamps Registration Violators Program

By Jaime Coffee, California Highway Patrol

SACRAMENTO, CA (MPG) - The California Highway Patrol (CHP) announced a new CHP Registration Enforcement and Guidance (CHP REG) program to reduce out-of-state registration violators. The CHP REG program replaces the Californians Help Eliminate All The Evasive Registration Scofflaws (CHEATERS) program.

Since the program's inception in 2004, the CHP has recovered approximately \$26 million in registration fees. In 2018, the CHP surpassed \$3.2 million in recovered fees from residents avoiding California registration.

"California loses millions of dollars in revenue every year from vehicles being unlawfully registered in other states or countries," CHP Commissioner Warren Stanley said. "This program relies on the public's input to support our investigators in returning funding to the state. Recovered registration fees are important to the California economy and are invested back into local communities."

The CHP REG program focuses on residents who register their vehicles out-of-state

while living or working in California and operate those vehicles on California's roadways. The primary goal of the program is to obtain voluntary registration compliance through education, but, when necessary, enforcement action is taken.

California vehicle registration through the Department of Motor Vehicles is required within 20 days of establishing residency and for all vehicles primarily operated in the state.

The CHP encourages members of the public to report vehicles driven on a regular basis on California roadways with out-of-state registration to the CHP REG program Web site at https://www.chp.ca.gov/Notify-CHP/CHP-REG-(Out-of-State-Registration-Violators).

When reporting a suspected violator, it is important to include: state of the plate, license plate number, date and time observed, where observed, make, model, vehicle color, and any additional identifying comments. In 2018, more than 24,000 tips were reported to the Web site, leading directly to cases investigated by CHP personnel and dedicated senior volunteers.

The mission of the CHP is to provide the highest level of Safety, Service, and Security. *



Public Notice Extent of Groundwater Contamination **Eastern Sacramento County**

Groundwater in a portion of eastern Sacramento County is contaminated. Contaminants include industrial solvents and chemical esulting from the manufacture and testing of rocket and missile systems and production of chemicals.

The map shows the approximate extent of contamination in the vicinity of the Aerojet Superfund Site where contaminant concentratio exceed regulatory standards established to ensure safe long-term consumption. There are currently two regulatory actions (Wester Groundwater Operable Unit and Perimeter Groundwater Operable Unit) that require Aerojet Rocketdyne to halt the spread of contamination, remediate the contamination, and restore the groundwater to beneficial use. Aerojet Rocketdyne has installed and is currently operating the treatment systems necessary to remediate and restore the off-site groundwater. Additional system modifications are anticipated to be completed in the next several years. Groundwater in portions of areas south of the Aerojet Superfund Site is also contaminated. Other regulatory actions are addressing these areas

Drinking water in this area is primarily provided by public water supply systems, which monitor water quality and shut down impacted wells of Drinking Water sight of the State Water Resources Control Board-Div



onstruction of new private and public water supply wells in Sacramento County requires a County permit. The Sacramento Count Environmental Management Department has developed a special review procedure for permit applications associated with wells propose to be constructed near sites with known groundwater contamination. HUNTSVILLE, AL (MPG) -Aerojet Rocketdyne is ready to begin producing large solid rocket motor carbon fiber cases in the in the Rocket City. Rocket City following installation and calibration of a key machine at its new Advanced Manufacturing Facility (AMF).

The state-of-the-art machine will be used to wind the carbon fibers that form the structural case of large solid rocket motors. It is capable of producing motor cases up to 72 inches in diameter and 22 feet long, which is large enough to support strategic missile programs.

"The successful transfer of this important capability from Sacramento, California, to Huntsville, Alabama, is part of our ongoing efforts to increase efficiencies and decrease product costs to our customers,"

said Eileen Drake, Aerojet Rocketdyne CEO and president. "Expanding support of missile programs at the Advanced Manufacturing Facility is a major component of our ongoing growth

The carbon fiber-winding machine will begin producing large solid rocket motor cases for missile defense target vehicles built by Aerojet Rocketdyne Coleman Aerospace starting in early 2020.

"This capability also positions our Advanced Manufacturing Facility and Huntsville Defense Headquarters to support new U.S. national security priorities, such as the Air Force's Ground Based Strategic Deterrent (GBSD) program," said Drake.

The 136,000-squarefoot AMF was designed to manufacture motor cases for a variety of missile, missile defense and hypersonic systems. Among the

existing production programs it supports are the Terminal High Altitude Area Defense and Standard Missile-3 interceptors.

Aerojet Rocketdyne, which has provided propulsion on every U.S. ICBM to date, was recently selected by Northrop Grumman to be an integral part of its nationwide GBSD team.

Public voting will also determine one Community Choice winner from the pool of national finalists, who will be eligible to win an additional \$10,000 in technology and classroom supplies.

Local teachers from each of the California State Finalist schools are available for interviews about the local issue they're working to solve and the importance of hands-on STEM learning.
