# **Board of Equalization to Hold Taxpayers' Bill of Rights** Hearing

#### SACRAMENTO, CA (MPG) -

The annual Taxpayers' Bill of Rights Hearing will be held by the California State Board of Equalization (BOE) on August 27, 2019. The hearing provides taxpayers, assessors, and other local agencies the opportunity to provide comment on any items discussed in the State Board of Equalization's 2017-18 Taxpayers' Rights Advocate's Annual Report for the purposes of correcting any problems described in the report. Taxpayers may also comment on BOEadministered programs or local property tax issues.

Individuals may also present their concerns regarding agency services or other issues related to the administration of its tax programs, including state and county property taxes, alcoholic beverage tax, and tax on insurers. With respect to the alcoholic beverage tax, individuals may present their ideas and recommendations regarding legislation which may further improve voluntary compliance and the relationship between taxpayers and government.

The Taxpayers' Bill of Rights Hearing is held in accordance with The Morgan Property Taxpayers' Bill of Rights and California Taxpayers' Bill of Rights provisions. The BOE has a Taxpayers' Rights Advocate to ensure taxpayers' rights are protected and to facilitate resolution of property tax problems. More information on the BOE's Taxpayers' Rights Advocate Office (TRA Office) and the Taxpayer's Bill of Rights Hearing is available at http://www.boe.ca.gov/tra/

Taxpayers are invited to share their experiences with problems encountered to bring it to the attention of the BOE and TRA Office for assistance with resolution.

The Board of Equalization is the only elected tax board in the country. Its five members include four equalization district members, and the State Controller. Under its constitutional mandate, the BOE oversees the assessment practices of the state's 58 county assessors, who are charged with establishing values for approximately 12.8 million assessments each year. In addition, the BOE assesses the property of regulated railroads and specific public utilities and assesses and collects the private railroad car tax. The BOE's monthly meetings offer taxpayers and other interested parties opportunities to participate in the formulation of rules and regulations adopted by the Board. 

is the major qualification. "Some staff come back year after year until they graduate from college," says the boss. "Many came through here first as campers, so they've seen how all students are different. Some are superathletic; some are fearful. You adjust teaching styles for each personality. But my staffers are big kids at heart. They keep things fun and exciting. They also supervise plenty of goof-off time on water slides and swings."

Overnight camps are an option on alternate weeks. "We go out for a sunset paddle," explains Dulgar. "Then we have a Spaghetti Factory dinner and toast s'mores on the barbecue. Campers and counsellors sleep in the open. After a pancake breakfast, we get back to more aquatic fun. By the end of the week, the kids are all pretty exhausted and so is the staff."





Changing from veterans to general information, I currently serve on the Sacramento-Yolo Mosquito and Vector Control District Board of Directors. I need to update everyone with information about the mosquitoes that carry the West Nile Virus and have become very active as of late. As District Manager Gary Goodman discussed, typically, our activity tends to decline once we are in August as the temperatures slowly get lower and the winds tend to pick up. But this year, what is usually normal could be an anomaly. There were seven positive test pools and five positive dead birds last week, which makes it the most active week this year.

Placer, San Joaquin and other surrounding districts in Northern California are starting to see more activity as well. Just remember the seven District D's of mosquito prevention: drain standing water, dawn and dusk are times to avoid being outdoors, dress in long sleeves and long pants when outside, defend using mosquito repellent, doors and windows need to be kept in good workbeen able to live again ing order, and district McGarvey, God bless, and

any mosquito problem you may be experiencing.

I remember when my wife and I purchased our first home in Rancho Cordova in March of 1967, there were many more open fields in our community. I remember the ground spraying for mosquitoes seemed to be very active. Today, the ground spraying is much more selective than it was in the past. When we lived on Silverwood Way in the White Rock area, Highway 50 was Folsom Boulevard, and its nickname was "blood alley." Especially on Sunday afternoon and evening, the traffic was tremendously active.

When the concrete for Highway 50 as we know it today was being poured, it was right behind our backyard. They made temporary water pools along the highway as it was being poured, and the pool right behind our backyard broke and flooded our backyard. It was also a perfect place for mosquitoes to breed. They took care of that error very quickly, but the mosquitoes took advantage of it while they could. Just remember to pay attention around your home, as empty places could fill with standing water and provide a place for mosquitoes.





PROJECT LOCATION: The Project site consists of approximately 530 acres located in the City of Rancho Cordova city limits. The Project site is bound by existing single-family residential uses to the north, vacant land to the east, vacant land to the south, and Rancho Cordova Parkway, single family residential, and vacant land on the west. The Project site is located on the east side of Rancho Cordova Parkway, across from the existing terminus of Chrysanthy Boulevard. The Project parcel is Sacramento County Assessor's Parcel Number (APN) 067-0040-008. The Project site is not included on the lists of sites enumerated under Section 65962.5 of the Government Code (Hazardous Waste and Substances Site List maintained by the Department of Toxic Substances Control).

PROJECT DESCRIPTION: The Project includes development of: 1,725 residential units, including 737 age restricted single-family units, 735 non-age restricted single-family units, and up to 253 multifamily units, 38 of which would be age-restricted multifamily units, with a club house for the age-restricted senior community, and other recreational opportunities, including parks and trails; dedication of 5.16 net acres for commercial use; and dedication of 8.43 net acres for multi-family residential uses in accordance with the City of Rancho Cordova's Affordable Housing Plan. The Project would also preserve approximately 199.5 acres as a nature preserve that would be deeded to a third-party conservation entity.

On-site infrastructure associated with the Project would include the construction of internal and external access roads and a network of bicycle and pedestrian trails. Primary access would be from Rancho Cordova Parkway. The Project would provide for future connections to an extension of Chrysanthy Boulevard east of the Project site.

The Project site is currently designated Planning Area in the City's General Plan. The Project would require a City of Rancho Cordova General Plan Amendment to the Land Use Element to change land uses on the Project site. Changes to the Land Use Element would include changing the entire Project site from Planning Area to Low Density Residential, Medium Density Residential, High Density Residential, Commercial, Parks/Open Space, and Natural Resources. 





# Where's The Baby? Look Before You Lock!



The California Office of Traffic Safety (OTS) is asking drivers to not leave children in hot cars and check the back seat before you get out of the car.

**SACRAMENTO REGION, CA (MPG)** - The summer heat is here and that means it is even hotter inside the car. The California Office of Traffic Safety (OTS) is asking drivers to not leave children in hot cars and check the back seat before you get out of the car.

Tragically, 52 children died last year after being left alone in a hot car, a 21% increase from 2017 and the highest number in more than 20 years. Since 1998, more than 800 children have died from vehicular heatstroke.

"Cars are well insulated and rise in temperature quickly," OTS Acting Director Randy Weissman said. "Too many senseless tragedies have taken place because parents or caregivers either forgot, thought it would be okay to leave a child in the car, or gave a child easy access to get inside."

The temperature inside of a car can rise nearly 20 degrees in only 10 minutes. Even when it is only 70 degrees outside, the car temperature can reach triple digits in half an hour. A children's body temperature can rise five times faster than an adult, leaving children prone to heatstroke quicker.

Common signs of heatstroke include red, hot and moist or dry skin, lack of sweat, dizziness, nausea, confusion, as well as being grouchy or acting strangely.

The OTS encourages parents and

caregivers to take extra precautions to make sure a child is not left or forgotten in the back seat:

Never leave a child alone in a car, even if you are running a quick errand, the child is sleeping or doesn't want to get out; Make it a habit to look in the back seat before you leave the car. Keep a stuffed animal, purse, phone or wallet next to the car seat as a reminder; Check in with a spouse, child care staff or caregiver when there is a change in schedules to verify the child was picked up or dropped off; Always lock your vehicle and keep the keys out of reach. Teach your child that a car is not a play area.

Heatstroke prevention also applies to pets, who face the same risks for heatstroke when left in a hot car. Keep your pets safe by leaving them at home unless you need them with you.

If you see a child or pet alone in a hot vehicle:

Make sure the child or pet is okay and responsive. If not, call 911; Try to find the parents or pet owner. Notify security or use a business or shopping center's PA system to alert the car owner.

The OTS administers funding for traffic safety programs statewide with the goal of reducing crashes that result in deaths, injuries, and economic losses. The OTS is a department under the California State Transportation Agency (CalSTA).
