Learning at White Rock Elementary

**RANCHO CORDOVA, CA (MPG)** - Bees, bats, birds, butterflies, and beetles have one thing in common, and a group of students at White Rock Elementary learned the connection between these mammals, insects, and birds. Each is an important pollinator.

"We use these main groups to help students remember many of the pollinators and become familiar with their various needs and also their various skills," wrote Shannon Hardwicke, Soil Born Farms Youth Education Manager.

Although there are other pollinators, including moths, she explained that this was a good start for students, especially in a limited time setting.

By the end of the lesson, students were able to identify the type of flower

over another. Some pollinators, like beetles, hide inside flowers. Others prefer purple flowers over red. Students sat in a circle on mats, listened, asked questions, and responded to a host of questions to help engage their critical thinking skills.

Students learned that butone pollinator might prefer terflies need flowers with

"large landing pads," so narrow petals would not necessarily be the best. Hummingbirds love red, cylindrical flowers and might be found near gladiola. Bats, on the other hand, are drawn to white or light blue flowers.

"What color are bees attracted to?"

Several responses were

given, including red flowers. Bees can't see red, but students knew hummingbirds preferred red flowers.

With all that was covered, students performed well, said Hardwicke. They were enthusiastic, raising their hands to share what they had learned. Besides listening and responding, they were Continued on page 3

SACRAMENTO, CA (MPG) - The Sacramento SPCA announced the receipt of \$25,000 to help senior cats and cats needing extended medical care at the Sacramento SPCA through a single gift made to establish The Joe Willie Initiatives. But Glickman had ever known. more important is the story behind this gift; a remarkable bond between a man and his special needs cat, Joe Willie, that inspired a movement.

Mark M. Glickman, a resident of Carmichael, was inspired by his cat, Joe Willie, who had significant assistance to encourage the medical needs when Mr. Glickman adopted him 29 years ago.

was on a noon-time walk in the San Francisco Financial District when I came upon a mobile adoption site", shared Mr. Glickman. "One of the kitties was a small Tuxedo cat. He had neurological damage in his back-side, and did not walk well. I expected that he would require ongoing attention for his condition, but adopted him anyway and named him Joe Willie."

Stiff legs were just the first of Joe Willie's challenges. He had serious gastro-intestinal issues and eventually lost his ability to walk. Later, he suffered other significant medical conditions. Throughout all of this, Joe Willie remained the sweetest, most loving cat that Mr.

Realizing that there were cats just like Joe Willie in need of care in Northern California shelters, in February, Mr. Glickman established The Joe Willie Initiatives, which will fund medical and placement adoption of senior cats and other cats with special needs.

by potential adopters. Now, with this generous gift designated for medical care for cats, we will be able to save even more lives."

Mr. Glickman's donation is the largest donation the organization has ever received for senior kitties and those with special needs. In addition to the Sacramento SPCA, Mr. Glickman honors the memory of Joe Willie through his support of other animal welfare organizations, including Marin Humane and Field Haven Feline Center.

"All of my cats have inspired me," said Mr. Glickman. "While I learned about cats from them, I learned about myself from Joe Willie. I want other people to adopt a cat and have that opportunity for an extraordinary connection."

The Sacramento SPCA reports an overall increase in cat adoptions since partnering with Mr. Glickman with more than 60 adopted through the program. And the goodwill is spreading – other Sacramento SPCA supporters have also been inspired to sponsor adult and senior cat adoptions.

Mr. Glickman issued the following statement:

"Historically, cats have not been treated with the same level of respect, understanding or attention as other animals. That has not been true of the Sacramento SPCA. For the last three years the organization has been at the forefront of this issue, seeking to change those perceptions. I am hopeful that my gift will allow them to continue their work, in new and innovative ways."

# Nan's Comfort **Critters Help Cops**

CARMICHAEL, CA (MPG) - All kids love soft toys. But a child whose life is in crisis really needs something to cuddle.

At accident or domestic crime scenes, terrified children often end up in police cars. Police officers - frequently parents themselves - know the value of a huggable teddy. "A soft toy gives traumatized children comfort," says Carmichael grandmother Nancy Fellers. "It also makes a police officer less frightening." From several Sheriff's deputies in her own family, Nancy (86) learned that cops bought emergency toys with their own money. She decided a stitch in time was called for.

For the past 20 years, the retired school teacher and travel agent has collected, cleaned and repaired thousands of what she calls "stuffies." Used or new, the comfort critters come her way from church friends, fellow Kiwanians and neighbors.

Nancy's mission has turned her Carmichael home into a virtual Pooh Corner, but she has the support of her 88-year-old husband, retired ARC professor Bill. "When we get used stuffies, we always wash them," explains Nancy.

"Many need to be re-stuffed – you'd be surprised what some manufacturers fill them with. If a toy gets a hole in it, a child could ingest some really awful stuff." After revitalizing each critter, she adds a new bow to each fluffy neck; she and husband Bill then deliver the individuallybagged stuffies to Sheriff's headquarters in Rancho Cordova. Here, big burly cops select bunnies, bears and monkeys to store in patrol cars for emergencies. "The officers are always glad to see me," says Nancy. "They know I come with gifts that make their job easier. To a frightened child, a cuddly critter helps children see officers as kind and caring. In these situations, a toy is a necessary part of police work. I don't see why deputies should have to pay for them."

Though she loves her vocation, the octogenarian hopes to eventually bag her last bunny and find a successor. "The work hardly costs anything and it takes little time," she says. "All you need is a washing machine, some basic sewing skills and a kind heart."

CARMICHAEL, CA (MPG) - Congressman Ami Bera's office rewarded teenage artists during a recent presentation at Sacramento Fine Arts Center, Carmichael.

Sponsored by the Congressional Institute, the contest annually seeks entries from across the nation. In 37 years, more than 650,000 high school students have participated.

Artists submit entries to their representative's office; a district judging panel then chooses the best. First place achievers win a trip to Washington DC to see their art displayed in a U.S. Capitol exhibition that hangs for one

year. Top 7th District prize was awarded for Madeleine Ng's portrait of her sister Jaslyn in a balletic leap on a New York City rooftop. Called "Little Dreamer Dancing on Top of the World," Ng's canvas reflects Jaslyn's ambition to study at Julliard School of Dancing. Madeleine (15) is in11th grade at Cosumnes Oaks High School, Elk Grove.

Second prize was claimed by Justina Ibarra (18) from Sheldon High School, Sacramento. Dr. Bera will display Justina's colorful "Bouquet at the Market" in his DC office. Elk Grove High School student Riley Bloodworth (17) won third place for her digital composition "Looking Within." This will hang in Bera's Sacramento headquarters for a year.

*Continued from page 1* also actively engaged with a matching game. Each student received a card, either a pollinator or a flower, and sought a match, keeping in mind the preference and Hardwicke, who explained needs of each pollinator.

Students also dissected a plant and examined the flower. This project, Hardwicke said, was a condensed version due to time constraints and location. Instead of microscopes, students received a magnifying glass. This lesson provides a base on which to build.

and activities, students also tended the garden which includes several crops corn, zucchini, tomatoes, strawberries, snap peas, and dill. Flowers are planted in order to attract pollinators. Students eagerly pulled weeds in order to prepare the beds for a new planting of watermelon seeds. Others harvested radishes, which they also washed and shared with the class.

The main purpose of this class, which built upon the prior week's class, was "connecting the unique pollinators to their functions with the flower," said that the lesson built upon the prior week's lesson about the critical role that pollinators play in the environment and to the food we consume.

The program at White Rock Elementary is growing and the current six classes will double to twelve next year, said Principal Peterson.

Soil Born Farms comes In addition to the talk out to work at the school weekly throughout the academic year. It also works with other schools as part of the Our Growing Together School Garden Initiative begun in South Sacramento. Hardwicke's team serves six school sites in two districts, three in Rancho Cordova.

"We work with all low income populations with the goal of improving connections to healthy food, science standards and environmental stewardship," she said. Gardens, she added, are sometimes the place where a student can shine and lead others and can be a place of safety.

"They learn firsthand, not in a book," said Mayor McGarvey about the Measure H funded program.

For home gardeners who want to attract pollinators, they might consider asking these students or provide a variety of flowers that bloom throughout the year. Hardwicke advises purchasing plants from Soil Born Farms, nurseries, or other locations that do not treat the plants with chemicals.

On May 19, Soil Born Farms will host its Day on the Farm event with classes, activities, plants, and much more.

"What I find really powerful is we're giving kids healthy habits," said Principal Peterson.



# Newsom Requests Preparation of | Legislation to Stop the Text Water Resilience Portfolio

**SACRAMENTO CA (MPG)** - As climate change continues to threaten the state's water infrastructure and reliability, Governor Gavin Newsom today signed an executive order directing his administration to think differently and act boldly by developing a comprehensive strategy to build a climateresilient water system.

The order seeks to broaden California's approach on water as the state faces a range of existing challenges, including unsafe drinking water, major flood risks that threaten public safety, severely depleted groundwater aquifers, agricultural communities coping with uncertain water supplies and native fish populations threatened with extinction.

"California's water challenges are daunting, from severely depleted groundwater basins to vulnerable infrastructure to unsafe drinking water in far too many communities. Climate change magnifies the risks," said Governor Newsom. "To meet these challenges, we need to harness the best in

science, engineering and innovation to prepare for what's ahead and ensure long-term water resilience and ecosystem health. We'll need an all-of-above approach to get there."

The order directs the secretaries of the California Natural Resources Agency, California Environmental Protection Agency and the California Department of Food and Agriculture to identify and assess a suite of complementary actions to ensure safe and resilient water supplies, flood protection and healthy waterways for the state's communities, economy and environment.

The order directs the state to think bigger and more strategically on water by directing the agencies to inventory and assess current water supplies and the health of waterways, future demands and challenges. The agencies will seek input over the coming weeks and months through listening sessions, information workshops and other public meetings to help inform the water resilience portfolio that will be recommended to the Governor. ### We've Heard **Enough From Robert Mueller**

The last thing the world needs is more of Robert Mueller's commentary, but Congress is determined to have him hold forth at a public hearing.

It's not as though we don't already have the special counsel's version of events. He mustered enormous investigate resources and took two years to write a 400-page report that is available to the public and presumably carefully written (although not necessarily carefully thought through).

That should be enough for Mueller to stand on, and enough for Congress to make a decision to impeach or not impeach, or otherwise dispose of the matter as it sees fit.

Instead, Mueller is going to be asked to expand on his already-expansive report that not only blew through Justice Department regulations, but inverted the long-standing burden of proof in the Anglo-American legal tradition.

As a prosecutor, Mueller's subjected to this new


Now, Congress wants Mueller to compound the offense by speaking publicly. It doesn't want facts from him. They are already in the report. It wants opinions and sound bites, especially any embarrassing to the president. Congress wants him to spend a couple of high-profile hours further "not exonerating" the president.

If Mueller had a proper understanding of his role, he would decline the congressional invitation. But the fact is that Mueller and Congress have a symbiotic relationship. For two years, Mueller was acting as, in effect, the lead counsel for an impeachment inquiry -bizarrely housed within the executive branch -- while Congress wants to use his moral authority as a crutch at a time when it is vulnerable to charges of partisan overreaching.

This, too, is not supposed to be how the system works. But we are long beyond anyone caring. For a swath of the political world and much of the media, all that matters is that Mueller "not exonerate" Trump, and the more, the better, in whatever format or forum.

On September 11, 2017, members of that family were out in the front yard, including a 4-year-old boy. Brown and another individual drove up to the family's residence. Brown then got out of the car, pulled out a semi-automatic handgun and shot four times at the residence. No one was struck by the gunfire. Brown got back into the car and drove away. Several family members were able to identify Brown as the shooter

#### **Defendant Convicted** for Multiple Robberies DATE: May 7, 2019 **CASE:**Theo Simmons

(Case #16FE008671) **PROSECUTOR:** Deputy District Attorney Scott Schweibish, Career Criminal Prosecution Unit

Theo Simmons was convicted by a jury of four counts of robbery. The jury also found true that Simmons personally used a firearm during two of the robberies.

On New Year's Eve 2015, Theo Simmons and a juvenile accomplice entered a Walgreens in Rancho Cordova armed with a firearm. Both defendants went to the pharmacy and jumped the counter looking for drugs. Simmons jammed the gun in the side of a victim

and forced her in the back where the drugs were kept. The juvenile grabbed the other victim and ordered her to provide him with drugs. They placed the pill bottles into a backpack and fled the store to a waiting getaway vehicle.

On February 29, 2016, Simmons and the juvenile robbed the same Walgreens. In this robbery, the pair took a pill bottle with a tracker on it, which was tracked back to an apartment complex. Officers did not locate the suspects, but they did find the getaway vehicle. Inside the vehicle, officers located clothing consistent with clothes worn by the suspects as well as a pellet gun. Simmons and the juvenile were later arrested in San Joaquin for committing a similar robbery. They were both linked to the Sacramento robberies through clothing and prints. Simmons pled guilty to the robbery in San Joaquin County.

Simmons faces a maximum sentence of 21 years, 4 months in prison. Sentencing is set for May 28, 2019, at 9:00 a.m. in Department 28 before the Honorable Richard Sueyoshi

#### **Defendants Convicted for** Murder of Teenage Brothers

DATE: May 7, 2019

CASE: Hieu Hoang & Richard Saterfield (Case #17FE008865)

**PROSECUTOR:** Deputy District Attorney Jeff Hightower, Homicide Unit

Hieu Hoang and Richard Saterfield were convicted by a jury of two counts of murder for the shooting deaths of 19-yearold Daniel Murti and 15-year-old Sergio Murti. The jury also found that both Hoang and Saterfield personally used a firearm in the course of the murders, and that both committed the special circumstance of multiple murders.

On May 11, 2017, Richard Saterfield initiated a confrontation with the victims. Saterfield obtained a gun from his vehicle and gave it to Hieu Hoang, who shot both victims. Sergio collapsed and died where he was shot. Daniel attempted to flee through a parking lot. Hoang and Saterfield got in their car and chased Daniel. Saterfield fired several additional shots at Daniel, who collapsed in the parking lot and died.

Both defendants face a maximum sentence of life in prison without parole. Sentencing is set for June 7, 2019, at 9:00 a.m. in Department 41 before the Honorable Helena Gweon.


