RANCHO CORDOVA, CA (MPG) -Four candidates are vying for three open seats on the Folsom Cordova Unified School District (FCUSD) Board of Education. On Monday, September 24, an informational candidate forum gave candidates an opportunity to share their opinions and priorities with district voters.

Jaya Badiga outlined her goals for the board as action, accountability, and transparency. Badiga believes the board should ensure a welcoming culture for students in district schools. She suggests introducing social emotional learning, which teaches students how to cope and function in a group so they develop increased empathy, which reduces bullying and

RANCHO CORDOVA, CA (MPG) - Rancho Cordova's Barrel District is comprised of six breweries, two distilleries, and the only meadery in the area. On Saturday, October 6, the Rancho Cordova Chamber of Commerce is hosting the Barrel District Experience, a fundraising event from noon to 6 p.m. that will allow ticketholders to not only sample each venue's product, but also to experience the culture and atmosphere of each unique location.

The Chamber of Commerce was looking for a new fundraising event, so Sheryl Smith, Rancho Cordova

Chamber of Commerce board member, initiated the idea of the Barrel District Experience. "I thought it would be awesome to do an inaugural event in the Barrel District, since it's such an asset to the City," said Smith. As the Chairwoman of the Barrel District Experience, she really wanted to showcase everything these businesses have to offer local connoisseurs-and anyone looking for a fun evening out. Smith said, "There is not another district like this in the United States, due to the combination of distilleries, breweries, and the meadery all together in one area of the city.'

Superheroes Descend Upon Sacramento DC Wonder Woman Run Series Brings Out the Hero in Everyone

- Sacramento was overrun by superheroes on Saturday, September 22 when the DC Wonder Woman Run Series hosted its inaugural event with a 5K and 10K run through Capitol Mall. Sacramento was the first city in the United States to participate in this race.

The event was produced by SON Events in conjunction with Warner Bros. and DC Entertainment. Sarah Ratzlaff, director of marketing for SON Events, said, "The race has a strong overall theme of women's

empowerment. Wonder Woman embodies strength, bravery, and power. The goal of the event is to show that there's a Wonder Woman in all of us. That's why we're using the hashtag #IAmWonderWoman."

The festival area was decorated with giant balloons and lined with an array of fluttering Wonder Woman flags. Area streets were blocked off by police cars, flashing their red and blue lights. Approximately 1,300 people participated in the 5K and 10K runs. The first-place finishers were Sandra Khounvichai with a time of 20:26 in the 5K and Stephen Harms with a time of 48:43 in the 10K.



The DC Wonder Woman Run Series is designed to empower the Superhero in everyone, so runners and walkers of all ability levels were encouraged to participate, regardless of their athletic abilities. Many participants had never run or walked in a 5K before this event. After completing the course, each participant was given a Wonder Woman medal. The festivities continued after the race, with a celebration featuring food trucks, a beer tent, face painting, official Wonder Woman merchandise, and a main stage with live musical entertainment.

Race participant Christie Pierce said he was persuaded to join the race just the evening before: "I decided to tag along. I said, 'Sure, I'll wear a

Mundy's kids, Isabella (10) and Jackson (8), and their friend Sophie Carr (10), all love Wonder Woman. They enjoyed the race and especially loved getting a shiny medal to commemorate their accomplishment of crossing the finish line.

The DC Wonder Woman Run Series will be hosted in Oakland, San Jose, San Diego, and Los Angeles this fall. The Los Angeles run, as the flagship run, will be the largest in the series with 7,000 - 8,000 participants expected. Experience would be enhanced by introducing the right foods to pair with the tastings. The Chamber of Commerce worked with each of the nine businesses to identify what types of food would best complement their craft brews and spirits. The participating food vendors are donating substantial "bites" to accompany the libations at each location.

In addition to craft brews, fine spirits, and fabulous food, the venues will also be offering activities and games that emphasize their distinct character. The Barrel District businesses will not be closed to the public during the event, but the Barrel District Experience will give ticketholders access to private parties held at each location. The work of local artists will also be on display, loaned to the Barrel District Experience by the Cordova Art Council.

The two distilleries in the Barrel District are Gold River Distillery and J.J. PFister Distilling Company. The six breweries are Thin Line Brewing Company, ol' Republic Brewery, Old Hangtown Beer Works, Fort Rock Brewing, Claimstake Brewing, and Burning Barrel Brewing Company.

The meadery is a major selling point of the event, because there are very few meaderies in California. Strad Meadery in the Barrel District is the only local venue where you can sample this unique honey wine, which ancient people called "Nectar of the Gods."

The businesses within the Barrel District are not within easy walking distance of each other, so that did present a safety issue when coordinating this event. The Chamber of Commerce wanted to ensure that ticketholders are able to travel safely between the nine locations. Rancho Cordova Chief of Police Chris Pittman shared that concern and worked with the Chamber to find workable solutions. The Chamber was originally planning to offer \$15

tickets for designated drivers, but that ticket price has been reduced to only \$5; designated drivers will have access to the food, games, and activities at all locations. The Chamber is partnering with Lyft, which is offering \$10 off of two rides within nine miles of the Barrel District. Some of the venues are also located near Light Rail stations.

Smith expressed gratitude to the event's social media strategists, beer enthusiasts Maggie Huss and Matt Van Donsel, who helped spread the word online. Smith also acknowledged the sponsors who help make the event possible: Rancho Cordova Travel and Tourism, California American Water, Smith Real Estate Services, Councilmember Garrett Gatewood, Graphics and More, and Grand Stand.

Tickets to the Barrel District Experience are limited and could sell out before the day of the event. Tickets are \$35 and can be purchased online at www. BarrelDistrict.com. ★



Sacramento CERT Needs You



Sacramento's California Emergency Response Team's (CERT's) graduation drill took place on Saturday, September 1 from 2 p.m. – 10 p.m. at the Northern California Regional Public Safety Academy in McClellan Park.

SACRAMENTO REGION, CA (MPG) - Sacramento's California Emergency Response Team's (CERT's) graduation drill took place on Saturday, September 1 from 2 p.m. – 10 p.m. at the Northern California Regional Public Safety Academy in McClellan Park. The community participated and explored their inner actors as volunteer victims with broken arms or legs or other injuries for the day's free event.

The drills tested the program's graduates on practical skills including sizing up a building to determine if it is safe to enter; search and rescue; transport; and triage and treatment. They assessed situations simulating burning buildings and locating victims in dense smoke and at night. Graduates radioed transport crews, practiced victim transport before another group assessed injuries, bandaged, and prepared victims for transport to a medical facility said Robert Ross, Chief, Operations, Sacramento CERT, CERT 22.

"Watching, you don't get to see as much," he said, adding that the role of victim teaches more to the community who wants to understand what happens during an emergency such as a fire.

Ross explained that most

people see only the end result. "It's a good way to see them in action and experience it without being in a collapsed building," he said.

The Basic CERT course, Level 3, is sanctioned by FEMA and was developed by Los Angeles Fire Department (LAFD) after the Mexico City and Kobe earthquakes. The course, Ross explained, is for everyday citizens with no previous training or particular skills who want to learn how to prepare for a disaster and is offered at no charge.

"Civilians will be on their own for the first 72 hours," said Ross, and will learn about disaster psychology and how to prepare bags with the necessities to assist in their immediate neighborhoods. Ross said that people don't often think about bringing items like pet toys when they need to evacuate. Trained civilians can put out small fires and even triage in their neighborhoods if the need arises, but they need to practice, and that's where the graduation drill comes in.

Graduates learn about fire behavior, which has been especially bad in California this summer, identification of hazardous materials, including those being transported, and terrorism. Upon graduation, CERT trained civilians can assist locally and can transfer their CERT training to other cities or states if they move. Since the Sacramento region is prone to flooding, this would also be covered in local training.

This level is required in order to continue with advanced courses to be certified as a Disaster Service Worker or a First Responder. Additionally, graduates may pursue training to join one of the special teams – Urban Search & Rescue, Animal Response, or Radio Communications.

"During a disaster cell phones won't work, satellite phones are few and far between," said Ross. "Ham operators during Hurricane Katrina passed messages. We can talk to Japan if we need to," he said.

One legally blind team member who used a motorized wheelchair ran the ham radio and was one of the best in Sacramento.

"There are no limitations on who can participate. There are many ways to be involved, with a job for everyone."

Defendant Sentenced for Murdering Jail Cellmate

DATE: September 14, 2018 CASE: Richard Russell Harden (Case #09F01356 **PROSECUTOR:** Deputy District Attorney Satnam Rattu, Homicide Unit

The Honorable Ernest Sawtelle sentenced Richard Russell Harden to 19 years to life in prison. On August 15, 2018, a jury convicted Harden of the second-degree murder of Evaristo Ramirez and assault with a deadly weapon.

On February 16, 2009, Richard Harden walked into the Home Depot on Folsom Blvd. and attacked an employee with a hammer. Harden was booked into jail and placed in a cell with Evaristo Ramirez. The next day, Ramirez was found unresponsive in the cell. An autopsy revealed that Ramirez was strangled to death and had multiple blunt force injuries to his head and torso.

Inmates Sentenced for 1st-Degree Murder

DATE: September 18, 2018

CASE: Lance Clemens & William Sylvester (Case #12F06425)

PROSECUTOR: Deputy District Attorney Scott Divine, Prison Crimes Unit

The Honorable Russell Hom sentenced inmates Lance Clemens and William Sylvester to life in prison without the possibility of parole. On August 14, 2018, a jury convicted Clemens and Sylvester of the firstdegree murder of Ronald Richardson with the special circumstance of lying in wait. The defendants were also convicted of inmate in possession of a weapon, and both defendants admitted to prior convictions.

On October 7, 2011, inmates Lance Clemens and William Sylvester attacked fellow inmate Ronald Richardson on an exercise yard at California State Prison, Sacramento. Clemens and Sylvester were armed with inmate manufactured knives and stabbed the victim 31 times. Nineteen of the stab wounds were to the victim's neck. The victim was pronounced dead minutes after the attack.

Clemens has three prior strike convictions for attempted robbery in 1993, assault with a deadly weapon in 1996 and assault with a deadly weapon in 2006. Sylvester has a prior 1997 strike conviction for first-degree murder.

Defendant Convicted for Charges Stemming from Sexual Assault

DATE: September 20, 2018 **CASE:** Harpreet Singh (Case #16FE018212) **PROSECUTOR:** Deputy District Attorney Matt Chisholm, Adult Sexual Assault Prosecution Unit Harpreet Singh was convicted by a jury of felony counts of assault with the intent to

commit a forcible sexual penetration, conspiracy to intimidate a witness, witness intimidation by force and



kidnapping for extortion. Singh also admitted to a 2011 strike conviction for rape of an unconscious person.

In 2016, Singh invited an acquaintance to his house and assaulted her in his bedroom. The victim reported the sexual assault the next morning and underwent a sexual assault evidentiary exam. The sex assault case was set for jury trial in October 2017. Approximately one week prior to the trial, Singh and his coconspirators kidnapped and threatened the victim not to testify in the trial. The victim was released without being harmed, but she continued to be threatened throughout the remainder of the week. When the victim reported the kidnap and intimidation to law enforcement, Singh

Singh faces a maximum sentence of 33 years to life in prison. Sentencing is set for November 9, 2018, at 10:30 a.m. in Department 41 before the Honorable Helena Gweon.

Defendant Convicted of Sexual Assault, False Imprisonment

DATE: September 25, 2018 CASE: Adbel Elbadry (Case #16F013497) **PROSECUTOR:** Deputy District Attorney Kevin Jones, Adult Sexual Assault Prosecution Unit

Adbel Elbadry was convicted by a jury of forcible sexual penetration by foreign object and felony false imprisonment.

On May 23, 2014, the victim was selling tamales at a Sacramento area flea market. Elbadry approached her and offered her money to clean his house. The victim agreed and followed Elbadry to his house. Once inside, Elbadry followed the victim into a bedroom, pushed her onto a bed and sexually assaulted her. The victim was able to ultimately get away, but she did not report the crime for a year. In 2015, the Sacramento Police Department was notified of the crime and began to investigate. When officers searched Elbadry's house, they found evidence linking him to the 2014 crime. The investigation also revealed that from 2003 to 2014, Elbadry was contacted by law enforcement six separate times after being accused of the same type of crime under similar circumstances. Elbadry had previously pled guilty to felony false imprisonment in 2003 and was sentenced to state prison.

Elbadry faces a maximum sentence of 8 years and 8 months in state prison. Sentencing is set for October 18, 2018, at 9:00 a.m. in Department 11 before the Honorable Trena Burger-Plavan.★









RANCHO CORDOVA, CA (MPG) -Wrapping up its non-league schedule with a third straight late defeat left the Cordova High School football team a bit baffled. The Lancers lost 26-23 to the Oakmont on Sept. 21 despite holding an 11-point lead with three minutes remaining.

After forcing a three-and-out Cordova struck again — and quickly. Five plays was all the Lancers needed to take the lead. Kenneth Brown snagged a 21-yard pass to get Cordova into Oakmont territory. Banks capped the drive with a leaping 26-yard touchdown catch on a fade route for a 13-8 advantage.

Hops for HOPE Fundraiser

CARMICHAEL, CA (MPG) - HOPE (Healthy Outcomes for Personal Enrichment) is a local nonprofit organization that offers affordable counseling services to the community. They rely on fees for services as well as community donations to keep costs low for their clients. HOPE is hosting their second annual Hops for HOPE fundraiser, which will be held at River City Brewing Company on October 4, 2018. The event is from 6:30 - 8:30 p.m. Tickets are \$40 per person and include appetizers and two drink tickets. River City Brewing Company (which is located in Milagro Center at 6241 Fair Oaks Boulevard in Carmichael) generously donates wine, beer, and staff for the event.

Community donations are especially important because HOPE's mission is to offer affordable sessions to those in need. Darlene Davis, executive director of HOPE, explained that there is a group of people who do not qualify for Medi-Cal but also do not have access to affordable counseling through traditional insurance. The goal of HOPE is to serve this segment of the community by offering counseling on a sliding scale depending on what the client is able to pay. Typically, \$40 per session is the lowest rate, but HOPE does occasionally offer sessions for \$20 to those in the

greatest need.

The experienced licensed therapists of HOPE not only work with clients to improve their well-being, but they also work in a supervisory capacity to train new therapists. To become a licensed therapist, it requires a master's degree and 3,000 hours of supervised therapy sessions. It is an extremely intensive process, and HOPE is proud to support the next generation of therapists who will serve the community.

One of the reasons HOPE is able to offer such affordable rates is because graduate students who are working toward becoming licensed therapists volunteer as trainees. As part of the training process, HOPE offers clients an eight-week counseling program known as the One-Way Mirror. During this program, trainees conduct counseling sessions in a room with a one-way mirror that allows supervising therapists and other trainees to watch the session in real time. The trainee wears an ear-piece so the supervising therapist can offer immediate feedback and suggestions. Davis explained that it is like having eight therapists at once. The cost is only \$25 per session, and clients sign up for this program knowing that they are getting the help they need while also giving the trainee valuable hands-on experience.

The supervising therapists at HOPE work hard to train people with integrity who are eager

to serve the community. Davis takes great pride in the work they do and in their dedicated trainees and associates. Davis said, "We all work in our communities, and it's so important to us that we're building healthier communities by building healthier families."

To better serve all those in need, HOPE offers many specialized forms of therapy such as Cognitive Behavioral Therapy (CBT), which helps people understand and address harmful thoughts and actions; Acceptance Commitment Therapy (ACT), which offers strategies to accept, destigmatize, and live with mental illness; Active Parenting of Teens (APT), which teaches parents how to talk to their teens and to watch for signs of high-risk behavior; and Eye Movement Desensitization and Reprocessing (EMDR), which addresses how the brain accesses and reacts to traumatic memories.

Donations to HOPE help pay for standard operating costs as well as to purchase needed equipment for specialized therapeutic techniques. Davis first began operating HOPE as a nonprofit in 2008. She said, "I just wanted to give back to the community and give back to the profession, and it's grown into what it is today."

Congressional Negotiation and Compromise Necessary, Says Bera

RANCHO CORDOVA, CA (MPG) -Congressman Ami Bera spoke at the Rancho Cordova Luncheon on September 21. "I'm an optimist, actually," Bera said. "I believe that the United States is a remarkable nation and the values that we are founded on are so remarkable." Though unemployment is down, he feels that most of the new jobs are either on the high or the low end. The middle class are being "hollowed out" and need to be grown. Bera said, "I feel like - 'Okay, let's roll up our sleeves, let's think about how we address some of these challenges."

"He seemed to want to reach both sides of the aisle," Smith said. "Some of the insights that he shared about how things work in D.C. were helpful."

Bera is a founding member of the bipartisan Problem Solvers Caucus in Congress, and he decried the dysfunction and the constant partisan bickering in the House. Under the Caucus's Break the Gridlock proposal, Bera and others in the Caucus have a plan to make the House more accessible to members.

"Right now, historically, 95% of the things that we debate on the floor are under a closed rule,"

Bera said. "What that means is I can't go to the floor and offer an amendment, because it's closed. Thirty years ago 90% were under open rules, in active debate. We want a functioning House, we need robust debate, and need to break the gridlock with pragmatic members . . . the ones that want to govern and recognize we've got to negotiate and compromise."

Small business owner Cari Zarou, owner of Pocket Deli in Rancho Cordova, said, "On a positive note, (Bera) sees great growth for the Sacramento region and what it will look like in 25 years. He says that proper planning will be the most important issue to ensure expansion."

Siri Pulipati, who is running for election to the Cordova Recreation and Park District Board, said about Bera's talk, "I like that Bera spoke from the heart. He touched on his humble upbringing and his vision for Sacramento, which involves getting more jobs to the area."

Bera, a democrat, won his first term in the House for California's 7th Congressional District in 2012, was re-elected in 2014 and 2016, and is running in 2018 against republican Andrew Grant. Bera's parents immigrated to the United States from India in the 1950s. Bera attended public schools through the 12th grade, attended UC Irvine for both his undergraduate and his medical degrees. His residency was in internal medicine and in his 20 year medical career he also served in various leadership and medical management roles. Bera lives in Elk Grove with his wife, also a physician, and they have one daughter.

Grant, who attended the event, said, "Even among business leaders at a Rancho Chamber of Commerce event, (Bera) refuses to acknowledge how tax reform, deregulation, and investor confidence has created the best job growth and wage increases in years."

Speaking of the years to come in his closing remarks, Bera said we need to, "Look to the future and what we can do that will still be effective five, 10, even 25 years from now, so that the next generation will benefit and move on from there."

the board's transparency and accountability, and creating a culture of inclusion within the schools. Hoover stated that "closing the achievement gap is the greatest need and challenge facing our district." Hoover is particularly concerned with the lack of parental involvement in some areas of Rancho Cordova, so he wants to focus on engaging those parents because increased parental involvement leads to increased student achievement.

As a board member, Hoover says he plans to be actively engaged in the process; he will do the research and come prepared. He will have the difficult conversations in order to find the best possible policies to meet the needs of the community. "All decisions will be based on what is best for students and parents...It's very important to listen to the needs of the community," said Hoover.

Dave Reid has more than 20 years of education policy experience. Since moving to California in 2006, he has served as general counsel at EdFund in Rancho Cordova, is the current president of Folsom Cordova PTA Council, and is a founding board member of Folsom Cordova Education Foundation.

Reid believes that not everyone needs or wants to go to college, so he supports bringing trades back into the high schools to give students other pathways to successful careers. He would also like to see the district partner with the business communities to provide students with internship and apprenticeship opportunities.

As the district continues to grow and more school sites are needed, Reid believes the district must be smarter about their building designs. He said singlestory construction is outdated and school sites quickly run out of space so they can't expand when necessary, while multilevel buildings would reduce the environmental impact and would allow for more growth.

Some of Reid's top priorities are to close the achievement gap, reduce class sizes, and better address students' mental health. If elected, Reid said, "I can't guarantee you that we'll always see eye to eye, but what I can guarantee you is that you will always have my ear, no matter what."

Incumbent Ed Short has served on the FCUSD board for 16 years. He is proud of how the board handled tough decisions during the economic downturn, doing the best they could with what they had available. When making decisions on the board, Short strives to always follow the board's mission statement and to ensure decisions align with existing goals and policies. He said it's important for the

board to involve all stakeholders in difficult decisions so that policies are fact based and fiscally responsible.

Some of Short's top priorities are to increase programs for English learners and improve special education programs. He acknowledged that growth in the area is a major challenge, and overcrowding is a serious issue, so the district needs to focus on expanding and maintaining facilities.

Short said, "I believe my qualifications, experience, and impeccable record of service qualifies me to continue serving
