RANCHO CORDOVA, CA (MPG) - The Cordova Recreation and Park District (CRPD) created a beautiful community park suited to host recreation, education and play. Last month, only a half-year after its opening, Heron Landing Community Park received an award. The California Association of Recreation and Park Districts (CARPD) granted CRPD the 2018 Award of Distinction for Outstanding New Facility.

CRPD's Heron Landing Community Park opened in mid-December. Its opening was

much anticipated by CRPD and community members, especially those who attended community meetings to voice their wants and needs and helped to shape and design critical elements of the park.

There are many reasons the park is being recognized as outstanding. A strong resource conservation aesthetic is built into its design and is reflected in the selection of the many drought-tolerant and low water-use plants on the grounds. The park's celebration of nature is made palpable in the shapes and colors selected for its play areas and spray park as well as in its bike path – which travels on to join other

trails and ultimately connects with the Folsom Canal and American River Trail. With multiple tennis courts, basketballs hoops, ballfields, walking trails, multi-use open turf fields and a splash park, the park promotes recreation to its fullest. The District also worked closely with the community to include site specific accessible elements so that a variety of experiences can be shared by people of all abilities.

The CARPD award is the second award the park has won since its opening. The Facility Design and Park Planning Award was presented to CRPD in February by the California Park & Recreation Society, District 2.

Academy participants will learn about the divisions at RCPD, laws of arrest, patrol procedures, investigations and other topics. Participants will also experience a tour of the main jail, a special presentation by air ops, and meet RCPD's K9s.

Twenty-five residents and business professionals graduated from the spring Citizen's Academy, including resident and business professional Ryan Yentes.

"I decided to participate in the Academy to further advance possibilities for a career in law enforcement. I figured getting my face out there and getting familiar with the departments, especially where I reside, would be the best benefit for me," Yentes said. "K9 was one of my favorite parts of the academy, in addition to air ops. I didn't know that they worked so close together."

#### Lieutenant Chad Lewis

Lieutenant Chad Lewis wanted to be a doctor, and

specifically an anesthesiologist, from day one. He studied at Fresno State as a pre-med major and made good grades. However, he was miserable between the school schedule and three part-time jobs, and realized he needed to make a change. He decided to come to Sacramento to take a few criminal justice classes; he got hooked, and never looked back.

# **County Budget Focuses** on Social, Health Services

SACRAMENTO COUNTY, CA (MPG) -The Sacramento County Board of Supervisors unanimously adopted the Recommended Budget for Fiscal Year 2018/19 on Tuesday, June 5.

The Budget maintains the capacity to provide services to County residents while implementing strategic initiatives that address the Board's priorities.

'Sacramento County's FY 2018/19 budget clearly acknowledges the pressing needs of the community with the additional investments in mental health, alcohol and drug programs and services to homeless individuals," said District 3 County Supervisor and Board Chair Susan Peters. "We've done exactly what we set out to do: make significant investments in public health and safety, while at the same time fully funding current staffing and program needs with a balanced budget."

More than 80 percent of the County's investment in new or enhanced programs is in the Health Services Department, with the focus on addressing critical needs in the Mental Health and Alcohol and Drug programs, including:

- \$5.9 million to implement the Drug Medi-Cal Waiver that will provide enhanced drug treatment services to the community.
- \$4 million to develop and implement a program that provides trauma-informed mental health services and support for foster youth, with a focus on placement stability for foster youth and their families.
- \$24.2 million to continue to implement the Boardapproved three-year MHSA (Mental Health Services Act) to expedite mental health services for

individuals with serious mental illness and/or cooccurring substance abuse disorders and are homeless or at risk of becoming homeless.

- \$4.7 million to provide contract and rate increases for mental health service providers to ensure provider stability and uninterrupted services for patients.
- The Budget will also continue funding for programs and services that were initiated over the last few years with Board approval, including:
- •Initiatives to address homelessness, such as Rapid Rehousing, the winter shelter program, improving family crisis response and shelters, preserving the Mather Community Campus, establishing a full-service rehousing shelter and implementing a flexible supportive rehousing program.
- •The Parkways and Unincorporated Communities Clean-up and Safety Initiative to reduce the incidence and mitigate the impact of illegal camping in the County's parkways and unincorporated communities.
- The intelligence-led policing model being implemented by the Sheriff's Department.
- The Healthy Partners Program that provides healthcare services to undocumented immigrants, increasing the enrollment cap from 3,000 to 4,000 and eliminating the upper age limit of 64 years.
- A strategic plan to reduce disproportionate African-American child deaths through community-based contracts and targeted

staffing in Child Protective Services, Public Health and Probation.

- Implementation of an Adult Supervision Model in Probation that will prioritize supervision and services for high-risk probationers in the first six months to a year of probation.
- Implementation of the Sheriff's ShotSpotter Initiative, that uses acoustic surveillance technology to identify and respond to illegal gunfire incidents in selected geographic areas in real time.
- Animal Care Initiatives focused on improving animal care, increased spay/ neuter services and increasing the Bradshaw Shelter's live release rate.
- Efforts to reduce fire danger and illegal camping, increase debris removal and enhance the visitor experience in the American River Parkway and the County's Regional Parks.

The numbers on the Recommended Budget will change between now and September, when the County receives new information including the impact of the State Budget and updated revenue totals. The Final Budget will come back to the Board of Supervisors in September for review and adoption.

# Sacramento County Ends Contract with ICE

#### Undocumented Detainees Will No Longer Be Held in County

SACRAMENTO COUNTY, CA (MPG) - The Sacramento County Board of Supervisors voted not to renew a multi-million dollar contract with the United States Immigration and Customs Enforcement last week.

The \$6.6 million a year deal with ICE had been in place for the past five years, placing detained illegal immigrants at the Rio Cosumnes Corrections Center as they awaited their hearings.

County Supervisors Don Nottoli, Patrick Kennedy and Phil Serna voted to end the multi-million dollar contract on Election Tuesday. "We're not housing these people, we are jailing these people," Serna

commented. "Our budgets must reflect our values. I do not value jailing immigrants, some of whom have not committed any criminal violations."

Supervisors Sue Frost and Susan Peters voted against ending the contract and those who were in favor of continuing the deal with ICE are worried about the negative effects that this decision may have on the Sacramento region and the state as well as the millions of dollars the county will lose out on.

"It's completely symbolic in nature. It doesn't solve any part of the problem at all," said Frost. "We'll have to look into our discretionary funds and into our other programs to see what we have to cut to figure out how

we're going to pay for that." ICE Spokesman Richard Rocha

issued a statement on the vote: "The Sacramento County

Board of Supervisors' decision to not renew a contract housing ICE detainees at the Rio Cosumnes Correctional Center will negatively impact local ICE operations. However, the impact will be greater for those who would have been detained at the facility. Now, instead of being housed close to family members or local attorneys, ICE may have to depend on its national system of detention bedspace to place those detainees in locations farther away from Sacramento, reducing the opportunities for in-person family visitation and attorney coordination."

for and was accepted into the Sacramento County Sheriff's Department Academy. He worked full-time at Foundation Health during the day and attended the Sheriff's Academy at night and on Saturdays. He graduated as the most outstanding recruit and was hired by the Department that same year with the goal to become a SWAT Officer.

Over his 25-year career, Lieutenant Lewis has worked in Patrol, Main Jail and Branch Jail, Problem Oriented Policing, the Communications Center, Special Operations, Air Operations and SWAT.

One of the most defining moments in Lieutenant Lewis' career was in 2000 when he applied for both air operations and SWAT, as the tests were being conducted around the same time. He was added to the waitlist for SWAT, and was selected to Air Operations as a Tactical Flight Officer and later a Crew Chief and training officer for air operations. He loved everything about the role and felt it was a natural fit for him.

Two years later, Lieutenant Lewis, who at the time was a Deputy, was called to the Lieutenant's office and asked if he wanted to go to pilot training. He immediately said yes to the five-year commitment. But the Lieutenant stopped him and said, "Hold on. You have a decision to make. The Tactical Commander wants you to come to SWAT."

"Every decision I had made up to that point in my career was with that goal in mind," said Lieutenant Lewis. "So I gave up my wings and joined SWAT."

Lieutenant Lewis served in SWAT for a total of 14 years in his career, as a Deputy Operator and Sniper, Sergeant Team Leader and Lieutenant Tactical Commander. Through the years, he participated in over 1,400 high-risk entries and spontaneous tactical events, often as the first person on the team through the door.

"I don't want bad things to happen in this world, but I know they will," said Lieutenant Lewis. "When they do, I want to be the first one there to fix the problem and make it better. This

is what drove me in SWAT and has continued to drive me today."

> Another memorable moment in his career was coming full circle back to Rancho Cordova as the Assistant Chief of Police for RCPD in July 2017.

> "It felt like going away to college and coming home again," Lieutenant Lewis said. "The Rancho Cordova Police Department is an inspiring place to work. We have an all-star team and the support of the community. In the last month, I can't think of a time I have been in the community and haven't been stopped by a resident to be told thank you."

> In his role, Lieutenant Lewis oversees the Patrol Division, Administration team and Youth Services Unit.

#### Lieutenant Jeff Schelldorf

Lieutenant Jeff Schelldorf grew up in Sacramento in a law enforcement family. His stepfather was a Deputy Sheriff and his mother was a Dispatcher with the Sacramento County Sheriff's Department.

At 21 years old, Lieutenant Schelldorf wanted to see what a career in law enforcement might look like for him, so he went to the Sacramento County Sheriff's Department's Reserve Academy and became a volunteer reserve officer for a few years.

In the meantime, Lieutenant Schelldorf enlisted in the U.S. Army Reserve and deployed overseas on active duty. When he returned in 1998, he applied for and was hired as a Records Officer with the Sacramento County Sheriff's Department.

In 1999, Lieutenant Schelldorf realized he wanted to become an officer, so he attended and graduated from the Sacramento County Sheriff's Department Academy. In 2000, he was hired with the Department.

"In the Academy, I realized that this was a family, not just a job, and a place I wanted to be the next 25 or more years," he said.

Over the next 13 years, he worked at the Main Jail, California Department of Justice Anti-Terrorism Information Center Task Force, contract City of Citrus Heights, Patrol, Detectives, Airport Division, IMPACT Division and

Communications Bureau.

In September 2013, Lieutenant Schelldorf joined RCPD as the Administrative Training Sergeant overseeing training programs for officers, special programs and planning for special events. In addition, he partnered with then-Chief and Assistant Chief of Police to start the Crime Suppression Unit, a highly proactive team funded by the City of Rancho Cordova's Community Enhancement Fund that focuses on enforcement in high crime areas in Rancho Cordova, and he oversaw the unit.

"Before coming to the Rancho Cordova Police Department, I had never worked in this area and didn't know what to expect," said Lieutenant Schelldorf. "I quickly realized how engaged the community was in their city and how supportive they were of the Rancho Cordova Police Department."

In 2015, Lieutenant Schelldorf was assigned to the IMPACT Division as the Gang Sergeant covering the area south of the American River, including Rancho Cordova. In 2016, he was promoted to Lieutenant and worked at the Rio Cosumnes Correctional Center as the Watch Commander.

In 2017, Lieutenant Schelldorf returned to RCPD as a Watch Commander for the Patrol Division Day Shift, managing and overseeing four sergeants and 18 officers for RCPD and the East Division.

### **Riley Reviews HEIST CAPER FUN IN "OCEAN'S 8"** HAS A GREAT GENDER TWIST

#### OCEAN'S 8 (Rated PG-13)

Heist capers, even the mediocre ones, are usually a lot of fun. Quality is not an issue for "Ocean's 8," which picks up, in a sense, from where the "Ocean's" trilogy left off. The hand of Steve Soderbergh is greatly on view.

Soderbergh, the prolific producer and director of many feature films and television programs, serves as the producer for this one, having relinquished the director's spot to Gary Ross ("The Hunger Games"), who is also credited as the co-writer with Olivia Milch.

To his credit, Ross keeps the Soderbergh spirit alive in much the same way as the original "Ocean's Eleven" (not the Rat Pack version) set about a meticulous recruiting effort by former inmate Danny Ocean (George Clooney).

Apparently, larceny and grand schemes run large in the Ocean family because this time the ringleader is Danny's sister Debbie Ocean (Sandra Bullock), who just spent 5 five years, 8 months and 12 days plotting her next big score upon release from a New

Jersey correctional facility. Reference is made to Danny

Ocean's passing (or is he really dead?) and Debbie visits his gravesite for inspiration to carry on family history. In any event, the criminal equation this time is completely distaff. Debbie sets about to recruit the capable women needed for the iob.

But first, fresh out of lockup, the penniless Debbie hits New York City, shoplifting at the fancy Bergdorf Goodman for beauty products and then conning her way into a free room at a ritzy hotel. The game is soon afoot to get a trusty crew.

The target of Debbie's meticulous plan is to steal the famous Toussaint diamond necklace worth a stunning \$150 million. It's the property of the legendary Cartier jewelry emporium on Fifth Avenue where it remains locked in an impenetrable vault.

This will not be a jewelry store version of a casino heist breaking into the vault. The diamond is scheduled to make an appearance at the annual elegant Met Gala held in the tight security confines of the Metropolitan Museum of Art's dinner party. Debbie first enlists the help

of old colleague Lou (Cate Blanchett), a brainy tough cookie with street smarts who despite her harsh exterior actually comes to act like the voice of reason to restrain Debbie's over-the-top instincts likely hardened from a stretch in prison.

Together, Debbie and Lou assemble an interesting crew to infiltrate the Met Gala and get close to the event's celebrity host, Daphne Kluger (Anne Hathaway), who will be dressed in a stunning gown cut low enough to allow plenty of room for the display of the diamond necklace.

Needing a fashion designer to work on dressing Daphne is Rose Weil (Helena Bonham Carter), whose floundering business needs a big cash infusion, and she proves game to join the crew to keep her enterprise afloat.

Mindy Kaling's Amita, a shady jeweler, has worked with Debbie before on low-level schemes. Expert fence Tammy (Sarah Paulson) has retired to motherhood and family duties in suburbia but can't let go completely of her past life with the stolen goods in her garage.

Constance (Awkwafina) is a young street hustler and deft pickpocket that Lou and Debbie meet in Queens. Rihanna's Nine Ball, a dreadlocked hacker, is a brilliant

key to decoding the museum's security to create the necessary vulnerabilities.

If you kept count, the crew described above totals seven participants. So where does the eight in "Ocean's 8" come into play? Could it be an unwitting accomplice in the grand scheme? That's one of the plot twists that turns into having its own twist that is not to be revealed here.

The plot operates on Debbie's pithy assessment of how a female crew works best. "A 'him' gets noticed. A "her" gets ignored. For once, we want to be ignored." This appears to have more to do with entering the ladies' room then being spotted among throngs of other beautiful women.

"Ocean's 8" is what a heist caper should be - fun and interesting to watch unfold with a plot that is convoluted but not so not puzzling that it could not be satisfactorily understood or explained without turning in to a pretzel on steroids.

The chemistry with the female cast is good and believable enough in service of advancing the heist to an enjoyable entertainment. As a fan of the first "Ocean's" film, "Ocean's 8" is a pleasurable diversion.  $\star$



#### **Defendant Sentenced to Prison** for Felony Animal Abuse

**DATE:** June 4, 2018

CASE: Lamar Robinson (Case # 17FE001189) **PROSECUTOR:** Deputy District Attorney Hilary Bagley-Franzoia, Animal Cruelty Unit

The Honorable Lawrence Brown sentenced Lamar Robinson to 4 years and 8 months in prison after Robinson pled to 8 counts of felony abuse.

On December 12, 2017, an apartment tenant was awakened to the screams of an animal. When the tenant went to her window, she witnessed Robinson repeatedly body slam a small dog against the ground, using a leash to increase the impact to the pavement. Robinson was also holding a second dog by its neck, and that dog appeared unconscious. The witness called 911 and Sheriff's Deputy Brian Fowell responded. Robinson was arrested after the deputy encountered him 'walking' two dogs with obvious injuries, including a broken leg.

Radiographs of both dogs revealed multiple rib fractures in different stages of healing. Surveillance footage captured part of Robinson's horrific crime.

The case was prosecuted by the recentlyformed Sacramento County District Attorney's Animal Cruelty Prosecution Unit, the Sacramento County Sheriff's Department and Sacramento County Animal Care and Regulation.

#### **Defendants Convicted for Murder**, **Attempted Murders**

**DATE:** June 6, 2018 CASE: Dashawn Tinsley & RV Watson Jr. (Case #16FE016082)

**PROSECUTOR:** Deputy District Attorney Satnam Rattu, Gangs & Hate Crimes Unit

Dashawn Tinsley and RV Watson Jr. were convicted by a jury for the first-degree murder of Andrew VanHunnik and three counts of premeditated attempted murder. The jury also found true that both defendants fired firearms causing great bodily injury or death to three separate victims.

On December 24, 2015, one victim drove to his mother's Citrus Heights home. As he exited his car, he was shot three times and suffered a broken left arm from one of the bullets.

#### On December 28, 2015, law enforce-

ment responded to a shooting in Citrus Heights and found a car riddled with bullets. Inside the car was Mr. VanHunnik, who was deceased from multiple gun shots. Two other victims who were also in the car survived. One victim escaped the car after being shot five times, and the second victim escaped without being shot. Detectives from the Citrus Heights Police Department were able to locate witnesses and physical evidence which established both Tinsley and Watson as the shooters in the murder and the earlier attempted murder

The allegation that Watson has, a prior 2012 strike conviction for first-degree burglary will be determined at his sentencing hearing.

#### **Court Finds Sexually Violent** Predator Will Stay in Hospital **DATE:** June 7, 2018


CASE: Steven Bradley (Case #83648) **PROSECUTOR:** Deputy District Attorney Denise Halstead, Mental Health Litigation Unit

The Honorable Allen Sumner found true a petition of civil commitment against Steven Bradley as a Sexually Violent Predator (SVP).

In 1987, Bradley was convicted of multiple counts of sexual assault, including oral copulation, rape, sodomy, assault and kidnapping after he took the victim from Sacramento to Redwood City while assaulting her at knife point. While released on his own recognizance and pending sentencing, Bradley came back to Sacramento and raped a woman with Cerebral Palsy. In that case, he tied the victim up and put a pillow over her face while he committed the acts. Bradley was sentenced to 53 years in state prison for the two cases. Upon his review for parole, he was referred to the Department of State Hospitals for consideration as an SVP. Two psychologists gave an opinion that Bradley had a mental diagnosis and because of this mental disorder he is likely to commit a sexually violent predatory offense if released to the community.

Deputy District Attorney Denise Halstead states, "The Court's finding that Bradley is a Sexually Violent Predator will keep this dangerous sex offender out of our community and protects the people of Sacramento."



### **IRS Warns Tax Pros of New Scam Posing as Professional Associations**

SACRAMENTO, CA (MPG) - The associations' websites rather than IRS and its state and industry Security Summit partners today warned tax practitioners to beware of phishing emails posing as state accounting and professional associations.

This week, the IRS received reports from tax professionals who received fake emails that were trying to trick them into disclosing their email usernames and passwords.

Cybercriminals specifically targeted tax professionals in Iowa, Illinois, New Jersey and North Carolina. The IRS also received reports about a Canadian accounting association.

The awkwardly worded phishing email states: "We kindly request that you follow this link HERE and sign in with your email to view this information from (name of accounting association) to all active members. This announcement has been updated for your kind information through our secure information sharing portal which is linked to your email server."

Tax practitioners nationwide should be on guard because cybercriminals can easily change their tactics, using other association names or making other adjustments in their scam attempts.

Tax practitioners who are members of professional associations should go directly to those

open any links or attachments. Tax practitioners who receive suspicious emails related to taxes or the IRS, or phishing attempts to gain access to practitioner databases, should forward those emails to phishing@irs.gov.

This scam serves as a reminder to all tax professionals that cybercriminals are targeting their offices in an attempt to steal client data.

To assist tax professionals with safeguards, the Security Summit partners urge practitioners to follow these minimal security steps:


- Learn to recognize phishing emails, especially those pretending to be from the IRS, e-Services, a tax software provider or cloud storage provider. Never open a link or any attachment from a suspicious email. Remember: The IRS never initiates initial contact with a tax pro via email.
- Create a data security plan using IRS Publication 4557. Safeguarding Taxpayer Data, and Small Business Information Security – The Fundamentals, by the National Institute of Standards and Technology.
- Review internal controls:
  - o Install anti-malware/antivirus security software on all devices (laptops, desktops, routers, tablets and

phones) and keep software set to automatically update.

- o Create passwords of at least eight characters; longer is better. Use different passwords for each account, use special and alphanumeric characters and phrases. Password protect wireless devices and consider a password manager program.
- o Encrypt all sensitive files/ emails and use strong password protections.
- o Back up sensitive data to a safe and secure external source not connected fulltime to a network.
- o Wipe clean or destroy old computer hard drives and printers that contain sensitive data.
- o Limit access to taxpayer data to individuals who need to know.
- o Check IRS e-Services account weekly for number of returns filed with EFIN.
- Report any data theft or data loss to the appropriate IRS Stakeholder Liaison.
- Stay connected to the IRS through subscriptions to e-News for Tax Professionals. Quick Alerts and Social Media.



# It's Swim Season – Make a Healthy Splash!

SACRAMENTO REGION, CA (MPG) - As the weather heats up in Sacramento County, residents will be heading to the water to cool off. Whether it's a public swimming pool, water park, or our lakes and rivers, you should be aware of healthy swimming behaviors.

Swimming is fun and has great healthful benefits from the physical activity, but that's why it's also important to keep it clean. The water we swim in is rarely germ free. Even when the concentration of pool chemicals is well maintained, or a lake or river looks clear, bacteria and microorganisms can still be present.

Protect your health with a few steps to keep germs out of the water and off you:

Keep it clean - stay out of the water if you feel ill; shower before you get in; have everyone get out to take bathroom breaks every hour; and don't swallow the water.

Anyone enjoying public lakes, rivers and waterways should:

Not drink recreational water or

use the water for cooking. Wash your hands or shower after swimming.

Not enter the water if you have cuts or open sores, as these are pathways for bacteria to enter your body.

Avoid algae blooms (brightly colored water) and trash in the water.

Pay attention and follow any warning signs and postings. Do not access a water body if posted warnings indicate it is not safe to do so.

Contact your healthcare provider if you have concerns regarding your health after swimming in recreational waters.

"Environmental Management Department inspects more than 2,200 public pools, spas and water parks in Sacramento County annually," said Marie Woodin, Sacramento County Environmental Management Department Interim Director. "Whether in a pool at an apart-

ment complex, fitness club,

hotel or water park, we can all safely cool off, exercise, and have fun with a few common sense practices and proper pool maintenance."

### **Golden State Water Files for Rate Decreases to Pass** Savings to Customers Resulting from Changes in Tax Law

RANCHO CORDOVA, CA (MPG) -Golden State Water Company (Golden State Water) recently filed to decrease water rates for all service areas to pass cost savings from the new lower federal corporate income tax requirement through to customers. If approved as submitted to the California Public Utilities Commission (CPUC), residential water rates in the Arden Cordova service area-Rancho Cordova, Gold River and Arden Manor communities-will decrease by 2.88 percent for metered customers and 2.86 percent for flat-rate customers on July 1, 2018.

The Tax Cuts and Jobs Act of 2017 lowered the nation's federal corporate income tax rate from 35 percent to 21 percent, effective January 1, 2018. As

directed by the CPUC, Golden State Water is tracking the impact of the new corporate tax rate and other changes in tax law, and will submit a separate filing to credit customers for any revenue surplus resulting from the reduced tax expense during the period from January 1 - June 30, 2018.

"Golden State Water is regulated by the State of California to ensure water bills reflect the full cost of providing water service and making capital investments that are critical to continue providing quality, reliable water service to customers," said Denise Kruger, Senior Vice President of Regulated Utilities for Golden State Water. "The new tax law reduces our costs, and we are eager to pass along

those savings to our customers." The new federal corporate income tax rate will also lower rates proposed in Golden State Water's General Rate Case filing for 2019-2021. Golden State Water is working with the CPUC to adjust the rate proposal and revenue requirement to reflect the lower tax requirement, which was signed into law after the rate case was filed in July 2017.

# Missed the Tax Deadline and Owe Tax? File by June 14 to Avoid Higher Late-Filing Penalty

SACRAMENTO REGION, CA (MPG) - Taxpayers who owe tax and file their federal income tax return more than 60 days after the deadline will usually face a higher late-filing penalty. For that reason, the Internal Revenue Service urges affected taxpayers to avoid the penalty increase by filing their return by Thursday, June 14.

Ordinarily, the late-filing penalty, also known as the failure-to-file penalty, is assessed when a taxpayer fails to file a tax return or request an extension by the due date. This penalty, which only applies if there is unpaid tax, is usually 5 percent for each month or part of a month that a tax return is late.

If a tax return is filed more than 60 days after the April due date -- or more than 60 days after the October due date if an extension was obtained -- the minimum penalty is either \$210 or 100 percent of the unpaid tax, whichever is less. This means that if the tax due is \$210 or less, the penalty is equal to the tax amount due. If the tax due is more than \$210, the penalty is at least \$210.

The late-filing penalty does not apply to the more than 135 million taxpayers who met this year's April 18 deadline to file their individual tax return. It also won't apply to the estimated 14 million taxpayers who asked the IRS for a six-month extension of time to file, as long as they file by Oct. 15, 2018. Though a tax return claiming a refund is also not subject to penalty, the IRS reminds taxpayers that, by law, they only have three years to file for the refund.

For those who did not file or request an extension, the IRS recommends filing by June 14 to avoid a penalty increase. The late-filing penalty will stop accruing once the taxpayer files. In addition, the IRS urges

taxpayers to pay what they owe to avoid additional late-payment penalty and interest charges. The late-payment penalty, also known as the failure-to-pay penalty, is usually 1/2 of 1 percent of the unpaid tax for each month or part of a month the payment is late. Interest, currently at the rate of 5 percent per year, compounded daily, also applies to any payment made after the original April 18 deadline.

After a return is filed, the IRS will figure the penalty and interest due and bill the taxpayer. Normally, the taxpayer will then have 21 days to pay any amount due.

Taxpayers can use their online account to view their amount owed, make payments and apply for an online payment agreement. Before accessing their online account, taxpayers must authenticate their identity through the Secure Accessprocess.

#### Penalty relief may be available

Taxpayers who have a history of filing and paying on time often qualify to have the late filing and payment penalties abated. A taxpayer usually qualifies for this relief if they haven't been assessed penalties for the past three years and meet other requirements. For more information, see the First-Time Penalty Abatement page on IRS.gov.

Even if a taxpayer does not qualify for this special relief, they may still be able to have penalties reduced or eliminated if their failure to file or pay on time was due to reasonable cause and not willful neglect. Be sure to read the penalty notice carefully and follow its instructions for requesting this relief.

#### Payment options

Many taxpayers delay filing because they are unable to pay what they owe. Often, these taxpayers qualify for one of the

payment options available from the IRS. These include:

• Installment Agreement – An installment agreement, or payment plan, allows a taxpayer to pay over time. Individuals who owe \$50,000 or less in combined tax, penalties and interest can request a payment plan using the IRS's **Online Payment Agreement** application. Those who have a balance under \$100,000 may also qualify for a short term agreement. The agreement can usually be set up in minutes and requesters receive immediate notification of approval. To reduce the chance of default and avoid having to write and mail a check each month, select the direct debit option for making these payments. For other ways to set up a payment plan, visit Payment Plans, Installment Agreements.

Offer in Compromise — Some struggling taxpayers may qualify to settle their tax bill for less than the amount they owe by submitting an offer in compromise. To help determine eligibility, use the Offer in Compromise Pre-Qualifier tool.

Special filing deadline rules apply to members of the military serving in combat zones, taxpayers living outside the U.S. and those living in declared disaster areas. For those who qualify, these special deadlines affect any penalty and interest calculations. Visit IRS.gov for details on these special filing rules.

#### Check withholding

Taxpayers who owe tax for 2017 can avoid having the same problem for 2018 by increasing the amount of tax withheld from their paychecks. For help determining the right amount to withhold, use the Withholding Calculator on IRS.gov \*
