RANCHO CORDOVA, CA (MPG)

- By a count of years since its incorporation in 2003, the City of Rancho Cordova is barely a teenager. But considering the caliber of economic and cultural growth taking place, it would not be too far off the mark to call this the city's "Golden Age."

> "We are growing at a relatively rapid pace," says Curt Haven, director of economic development and neighborhood services. California's **Adolescent Birth Rate Drops** to Another **Record Low**

STATE POINT MEDIA (MPG) - The California Department of Public Health (CDPH) announced that California's adolescent birth rate continues to decline. In 2015, there were 17.6 births per 1,000 females aged 15-19: a 10 percent decline from the 2014 rate of 19.6 and a 62 percent decline from the 2000 rate of 46.7.

"By empowering young people with the knowledge, tools and resources to make healthy choices, California is succeeding in reducing births among adolescents," said CDPH Director and State Public Health Officer Dr. Karen Smith.

The adolescent birth rate decreased across all racial and ethnic groups between 2000 and 2015. During this time, the adolescent birth rate dropped among Hispanics from 77.3 to 27.0, among African-Americans from 59.1 to 19.7, among Whites from 22.3 to 6.9, and among Asians from 15.0 to 2.9.

Despite declining birth rates, racial disparities persist in adolescent childbearing in California. African-American and Hispanic adolescents were three to four times as likely to give birth as White females. Additionally, the adolescent birth rate varies considerably across counties, from a low of 6.7 in Marin County to a high of 43.1 in Del Norte County.

California has a number of programs aimed at preventing adolescent pregnancy and improving pregnancy outcomes among young women. CDPH funds the Information and Education Program, the Personal Responsibility Education Program authorized through the Affordable Care Act of 2010, and the Adolescent Family Life Program for expectant and parenting adolescents. Also, the state provides no-cost family planning services to eligible men and women, including adolescents, through the Family PACT Program.

Sutter's Fort Presents "Hands on History: Catch Gold Fever"

SACRAMENTO, CA (MPG) California State Parks, Sutter's Fort State Historic Park (SHP) and Friends of Sutter's Fort are proud to present an interactive and fun "Hands on History: Catch Gold Fever" event on Saturday, January 20, 2018, from 10 a.m. to 5 p.m. Fort visitors will have the unique opportunity to step back in time and explore an era that changed California forever. The gold discovery at Coloma echoed around the world and triggered the largest migration in United States history. Thousands of immigrants gambled and came to early California to try to strike it rich. They left family behind, spent life savings, and borrowed money all in the pursuit of gold. Many miners bought one-way passage on ships bound for California, and abandoned ships clogged the port in San Francisco as miners and sailors took off for the hills. Miners stopped at Sutter's Fort before they headed for the hills in their quest for gold, and the Fort was often the first place to which they returned for supplies and entertainment. Sadly, the dream of riches was not often the reality and many left the hills with only disappointment in

their pockets. As an event highlight, Fort visitors are invited to spend the day enjoying hands-on activities such as gold panning, parlor and card games (and other games of chance) and "Pioneer dress-up Station" activities where families dress as pioneers (perfect for picture-taking). In addition, there will be a display of guns and weapons from the Gold Rush era and demonstrations of black powder weaponry in action including the crowd-favorite firing of Sutter's cannon. Sexual Misconduct 'Secret Settlements' Will Roil California, D.C. in 2018

No doubt there are many on Capitol Hill in Washington, DC, and in state capitals across the nation that are somehow hoping that the distraction of Christmas and New Year's Day will somehow change the channel on the intense scrutiny of sexual harassment (or worse) committed by politicians of both political parties.

That's not going to happen. In fact, I predict that the high profile that this issue has taken over the past few months is just a harbinger of things to come as the holidays come to a close.

We have seen members of the U.S. Senate and House resign, or announce retirements. We have seen state legislators do the same. Here in California we have seen resignations from Assemblymembers Matt Dababneh (D-Los Angeles) and Raul Bocanegra (D-Arleta) already. The resignation of the former has placed a lot of negative scrutiny on U.S. Rep. Brad Sherman (D-CA), for whom Dababneh served as district director. A third Assemblymember, Sebastian Ridley Thomas (D-Los Angeles), just this week announced his sudden resignation, citing health reasons - after his name had been whispered as someone else who might end up in the spotlight on this issue. California State Senator Tony Mendoza (D-Artesia) is considered by many to be politically a dead man walking as multiple credible accusers have made serious allegations about him and he has been suspended from all of his committee assignments as a formal investigation takes place. Another Senator, former Assembly Speaker Bob Hertzberg (D-Reseda), is also the subject of an investigation as well.

The reason the issue is a powder keg that has not really blown up yet is the secret-taxpayer funded settlements. In the U.S. Senate and House, it has been revealed that millions of dollars have been spent settling sexual harassment issues coming straight out of the offices of federal legislators. In some cases, these secret settlements have taken place using money from individual office budgets; in other cases, payments have been made from funds controlled by the institutions (so presumably, ultimately, leadership).

Similarly, in the California legislature we have learned that significant sums of taxpayer money have been spent on sexual harassment claims made against elected.

No one that I have spoken to regarding secret settlements - and I have spoken with many - thinks that this is okay. In fact, most get downright angry when they hear about it. For two reasons, mainly.

The first: if money is being paid out to someone who filed a claim there is a presumption that the claim was meritorious, and that the public has a right to know when one of their elected officials has been found to be conducting themselves inappropriately, or worse.

The second: these are public dollars and the public has the right to know where their dollars are being spent.

Adding to the considerable cost of these secret settlements themselves is now the fallout from resignations - i.e. special elections, and their significant cost to taxpayers.

It seems that there are two main groups of politicians who are interested in slow-walking or ideally never revealing the truth behind secret settlements.

Of course there are the sleazy politicians who know that if and when the news breaks that they had sexual harassment allegations so credible against them that victims had to be paid off - well, as we have seen, these have been extinction moments for most.

But then there are the enablers: those that have not actually committed and untoward or sleazy actions themselves, but they are covering up for those who have done so. That means those who are in a position to open the books - to provide transparency. Presumably this is leadership in Washington and in Sacramento - both elected leaders, as well as those legislators heading up key administrative committees with oversight over such matters.

Frankly, every federal and state legislator should be putting out a statement calling for transparency and for making the secret settlements public as well as stating on the record that they have not had any issues themselves. That would create significant peer pressure.

There are efforts both in the national and state capitols to shine the light on settlements. In D.C. a legislative effort is being spearheaded by Rep. Ron DeSantis (R-FL). In Sacramento, the Senate Republican Leader, Pat Bates (R-Laguna Niguel), has called for more transparency.

Legislators that are not affirmatively trying to open up the books, and shine the light on secret settlements, are in fact part of the problem.

The war drums on this issue are only getting louder and louder - and the new year will bring a new national drive for transparency and accountability.

This entire episode has emerged as a painful stain on our political system (and as an ugly cultural black eye, as stories continue to emerge across the country outside of politics).

But this is not without a considerable upside. Change needs to happen. It's not alright for people with power to engage in sexual misconduct - period. It's not appropriate, nor humorous, in any context.

Dawes. Intake starts at 5:00 p.m. each day, and is first come, first served.

Almost all days of the program have a host site assigned, but one week in February is still not covered. The HART Winter Shelter, which is a drug, alcohol, smoking and pet free shelter, can serve 30 people a night. Those who use the shelter are grateful for the hot meal and safe space to sleep. The hardest part of being homeless said one 60-year-old winter shelter guest is "just living." Other guests agreed. Some people lie in wait for the homeless when they collect their Social Security at a certain time each month. "We are game for the little young 'uns that prey upon us every minute on payday," said the guest. "I don't have my wallet, I don't have my SSI card, no ID, all like that, it's all been taken from me." The homeless have nowhere to legally lay their heads. A peace officer can roust them out of a location, because the police have to enforce the codes. "Well, where do you suggest that I go?"

the guest said he has asked the police. "You cannot go and lay your head down anywhere at all. Period. Nowhere. Cannot loiter in the parks, can't stay after dark. Cannot hang out in front of a house or business or alley or anywhere. Or river . . . You break the law by hiding anywhere."

Karen Edwards of Sun River Church, who helped initiate this winter shelter in 2014, said that because of a grant from the City of Rancho Cordova Community Enhancement Fund, some additional services will be offered this year. "We're going to be having some clothing vouchers, and bus passes," Edwards said. "We might have some food vouchers, too." The Department of Human Assistance will be coming once a week to suggest other options, as will Sacramento Self Help Housing.

Rancho Cordova HART expects to begin a volunteer mentoring program this season. "The mentoring program," said Pam Bradley, program director, "is about helping people to help themselves." HART will carry out training at 6:30 p.m.,

Thursday, January 11, at Sun River Church, 11223 Trinity Dr., Rancho Cordova. The training will review mentor duties, present guidelines, and answer questions for anyone who would like to volunteer.

Rancho Cordova HART is a 100% non-profit organization, which means they rely completely on donations to support their work, they have no paid staff, and donations are tax deductible. All work is done by volunteers. "Being a part of HART is a great opportunity to benefit other people," Pam Bradley said. Those without a home "truly are a part of our community, so we all need to work together."

The program still needs volunteers through February 24. Continued from page 1 helped spearhead the push for the ballot measure for independence.

"Because I was the CEO of the chamber, I just had a love and desire to see Rancho become a greater city than it already was," said Haven. "I knew it could come back if it had the distinction of being its own city with its own governing capacity."

Under his guidance, Rancho's Development Services Team, comprised of representatives from various city departments, as well as partnering agencies, manage a lot of "moving parts". Those involve the attraction of and service to new and existing businesses, whether that's a Blue Shield bringing in some 600 jobs, a craft brewery or a mom and pop eatery.

The approach, says Haven, is small town. He and or a member of his team will sit down with just about every prospective business owner interested in setting up shop in Rancho to help them navigate the process. The city's OpenCounter service and online tools help also provide a quick way for any prospective business owner to generate a list of the permitting and fee requirements expected in advance.

"There's a whole bunch of moving pieces involved in our approach to serving the economic growth of our city, but we keep it that way so it's nimble," said Haven. "Because we are a new city, we were able to set up processes for businesses that weren't siloed or heavily bureaucratic. We answer questions quickly. Even if someone just has an idea, they can come in and sit around a table with us and discuss their plans. Whether they are a large company or a small one, they all want certainty."

Recently, the city and chamber co-created a marketing program as a way to both keep commuters in the city after working hours and bring out the locals at night. The "Stay An Hour After Work" campaign touts Rancho's 16 "happy hour" hot spots, nearly two dozen fitness "centers," and its much-revered and expanding Barrel District, offering a full

delivering craft beers and specialty cocktails across a swath of Rancho's industrial section of

The Barrel District is home to Gold River Distillery, the first distillery to come in line since Prohibition. J.J. Pfister Distilling Company, Burning Barrel Brewing Company, as well as Strad Mead, which will serve wine distilled from honey, are also on their way into the district. It will be the first meadery in the region.

Combined, these businesses are feeding the reinvention of Rancho. It is not just a big place for corporations to spread out in or large developers to blueprint a new housing community. While those are both critical components of Rancho's growth and attraction, everyone knows when paychecks are spent in the same city where they are earned, economic prosperity and a destination status are solidified.

"About two years ago we had a discussion with the city council about Rancho's amenities and we talked about how to keep employees who don't live here in the city after 5 p.m.," said Haven. "We also talked about where our residents are going after work. So we collaborated with the chamber on that program as a way to build up night life and we see it working very well."

There are also existing businesses who are actually facing issues with aging, if you can believe that for a city on the cusp of 15. To address some of those issues, Haven's department launched the Commercial Façade Improvement Program in 2016, which makes minigrants of up to \$5,000 available to businesses to cover the costs for things such as new signage, exterior cleaning and painting, new awnings, lighting and landscaping.

Matching grants for up to \$70,000 are also available through the program, funded by the city's Community Enhancement Fund, supported through the half-cent sales tax measure approved by voters

range of eateries and breweries in 2014. The city also offers businesses support through its Revolving Loan and Business Incentive programs.

"Our job is also to retain businesses, so we want to do whatever we can to support small-scale infrastructure projects or beautification projects," Haven said. "It's important that we do what we can to help ensure their longevity and success."

New projects coming in line also include a 199-unit, upscale apartment project at Capital Village and the Sunridge Plaza project at Sunrise Boulevard and Douglas Road, which will feature, among others, 9Round Kickboxing, Bark Avenue, Chase Bank, Jimboy's Tacos and Soho Sushi.

While he can't share details, Haven confirmed San Gabriel-based Shun Fat is attempting to open an Asian supermarket inside the now vacant 114,431-square foot building on Sunrise Avenue, formerly home to Sam's Club.

Several upscale, single-family housing communities also are on the radar, but perhaps the most widely discussed one is the planned Rio Del Oro project, which calls for 12,000 new homes, six elementary schools, one middle school and the first high school to open in the city in five decades. It, too, will include several miles of commercial real

estate opportunities. Rancho took a disastrous hit economically with the closure of the aerospace sector in the 1990s. Its reputation as home to scrappy immigrant communities, low-income housing, shuttered buildings and growing blight was widespread. But years of advocacy for cityhood lead by Haven and fellow members of the incorporation team, followed by a laser-focused plan for reinvigoration upon its hardwon vote for cityhood, have put Rancho Cordova firmly back on

"I knew that I always wanted to work where I could offer a way to bring in change," said Haven. "So, for me, this is not just a job. It's a passion."

RCPD Creates Innovative Officer Training Program

RANCHO CORDOVA, CA (MPG)

- According to the National Highway Traffic Safety Administration, nearly 29 people in the United States die in alcohol-impaired vehicle crashes every day—in 2016, that was one person every 50 minutes. In addition, the 2015 Governors Highway Safety Association survey indicated 43% of deceased drivers tested positive for drugs in their system, while 37% tested positive for alcohol.

The Rancho Cordova Police Department (RCPD) is responsible for enforcing traffic safety laws throughout the Rancho Cordova community. Among other responsibilities, RCPD responds to traffic collisions and people driving under the influence (DUI) of substances, such as alcohol, prescription drugs, and illegal drugs. Each officer receives 16 hours of training in the Sheriff's Academy to prepare them to respond.

Motor Officers Marcus James and Brian Aubuchon were responding to these situations when they began to notice that their fellow officers might benefit from additional training.

"I train other officers in responding to DUIs and have received the Drug Recognition Expert certification," said Officer James. "There is additional knowledge that prepares me to respond to situations that I thought my colleagues in the field could benefit from also."

The Officers' observation led to them creating an in-house training program that teaches RCPD officers to investigate traffic collisions and respond to DUIs.

The program includes 40 hours of training in collision investigation and 80 hours of training in DUI and impaired

driving investigations. Officers review RCPD policies and procedures; learn case law, DMV process, report writing and more; and receive hands-on training.

"This extensive training program ensures RCPD officers can better serve the Rancho Cordova community," said Officer James. "The program is already making a difference. Our officers are better able to detect impaired drivers, respond to traffic collisions, and overall keep our roads safer."

RCPD wants to remind you to "drive sober or get pulled over" and that "DUI doesn't just mean booze." Here are some tips you can follow to be prepared:

- If you will be drinking, plan on not driving. Plan your safe ride home before you start the party. Designate a sober driver ahead of time.
- If you take prescription drugs, particularly those with a driving or operating machinery warning on the label, you might be impaired enough to get a DUI. Marijuana use can also be impairing, especially

in combination with alcohol or other drugs, and can result in a DUI.

A Merit-based Immigration System Would Help Americans – and Skilled Foreigners

Don't expect a bigger paycheck anytime soon. Fed Chair Janet Yellen recently admitted there might be far more "slack" in the labor market than she and her colleagues realized, meaning that employers can attract all the workers they need without raising wages.

This is a longstanding problem. Inflation-adjusted wages have climbed just 0.2 percent annually since 1973.

Several lawmakers on Capitol Hill plan to end this wage stagnation by transitioning to a merit-based immigration system. Limiting low-skilled immigration would make it easier for working-class Americans to find jobs and negotiate raises.

Each year, the US gives out more than 1 million "green cards," permanently allowing foreign-born individuals to live and work in the United States. Only 140,000 of those are for highly skilled immigrants.

The current immigration system reserves two-thirds of all green cards for foreigners who already have extended family in the country without accounting for immigrants' economic potential.

Because so many extended family members of immigrants possess few skills, they compete with the most vulnerable Americans for jobs.

This influx of workers has pushed many less-educated Americans out of the job market entirely. In the 1960s, 95 percent of male high-school dropouts were working or actively looking for jobs; today, only 80 percent participate in the labor

American workers also take a pay cut. Harvard economist George Borias found Americans lose \$402 billion annually in foregone wages as a result of competition from immigrant laborers.

Congress may soon consider a bill, the Reforming American Immigration for a Strong Economy (RAISE) Act, to relieve these Americans. The RAISE Act would cut the number of green cards by 50 percent by scrapping family-sponsored green cards, with notable exceptions. Recent immigrants would still be able to obtain green cards for their minor children and spouses but no longer be able to bring adult children and siblings.

People will receive points if they have high-paying U.S. job offers, fluent English language skills, and college degrees.

The RAISE Act would eliminate slack in the labor market, giving workers more leverage to demand raises.

Some special interest groups have expressed skepticism. They needn't be concerned.

American universities worry the RAISE Act would disadvantage foreign students. Actually, the RAISE Act would benefit them because currently, those students often struggle to obtain work visas once they earn

The new system would award extra points to graduates of U.S. universities, giving them a leg up on graduates from foreign institutions.

Some agricultural firms fear the RAISE Act would jeopardize their labor force. Those concerns are similarly misplaced.

The agricultural industry doesn't depend on green card holders. Out of more than 1 million green cards distributed in 2015, less than 4,200 went to immigrants in farming, fishing, or forestry jobs. The H-2A visa program, which lets firms bring in an unlimited number of guest workers for farm work, would remain untouched under the RAISE Act.

Our economy is changing. It's becoming tougher for lesseducated Americans to find decent-paying jobs. Reforming the legal immigration system would help these citizens while still attracting the best and brightest from around the world.

Dry December Produces Below-Average Snowpack

Still Too Early To Draw Conclusions from Season's First Snow Survey

SACRAMENTO, CA (MPG) supplies against disruptions."

- Department of Water Resources (DWR) manual snow survey, held January 3rd, east of Sacramento in the Sierra Nevada found little snowpack, which was predictable after a dry December throughout California. Measurements at Phillips Station revealed a snow water equivalent (SWE) of 0.4 inches, 3 percent of the average SWE of 11.3 inches in early January at Phillips as measured there since 1964. SWE is the depth of water that theoretically would result if the entire snowpack melted instantaneously.

"As we're only a third of the way through California's three wettest months, it's far too early to draw any conclusions about what kind of season we'll have this year," DWR Director Grant Davis said. "California's great weather variability means we can go straight from a dry year to a wet year and back again to dry. That's why California is focusing on adopting water conservation as a way of life, investing in above- and below- ground storage, and improving our infrastructure to protect our clean water

More telling than a survey at a single location, however, are DWR's electronic readings from 103 stations scattered throughout the Sierra Nevada. Measurements indicate the SWE of the northern Sierra snowpack is 2.3 inches, 21 percent of the multi-decade average for the date. The central and southern Sierra readings are 3.3 inches (29 percent of average) and 1.8 inches 20 percent of average) respectively. Statewide, the snowpack's SWE is 2.6 inches, or 24 percent of the Jan. 3 average.

"The survey is a disappointing start of the year, but it's far too early to draw conclusions about what kind of a wet season we'll have this year," said Frank Gehrke, chief of the California Cooperative Snow Surveys Program who conducted today's survey at Phillips. "There's plenty of time left in the traditional wet season to reverse the dry trend we've been experiencing."

California traditionally receives about half of its annual precipitation during December, January, and February, with the bulk of this precipitation coming from

atmospheric rivers (ARs). So far this winter, an atmospheric high-pressure zone spanning the western United States has persistently blocked ARs from reaching the state. If that zone were to move or break up, storms could deliver considerable rainfall and snow this

Davis noted that forecasting accuracy falls off dramatically after just a week or 10 days into the future. "Current technology and computer modeling can tell us what our weather might be weeks into the future, but we're essentially blind to what the weather will be beyond the two-week mark," he said. "That's why we are putting in so much effort to improving medium- and longrange modeling."

The Phillips snow course, near the intersection of Highway 50 and Sierraat-Tahoe Road, is one of hundreds that will be surveyed manually throughout the winter. Manual measurements augment the electronic readings from the snow pillows in the Sierra Nevada that provide a current snapshot of the water content in the snowpack.

Proposed Legislation Will Fuel the Opioid Epidemic in the U.S.

Commentary by George M. Karavetsos

The International Police Organization and regulators and law enforcement from around the world just conducted a major sweep of online pharmacies. Over the course of one week in mid-September, INTERPOL seized more than 25 million illicit and counterfeit medications, or \$51 million worth, and made 400 arrests worldwide. It also shut down more than 3,500 illegal online pharmacies, including some selling pain pills laced with fentanyl. Illegal trafficking and abuse of this powerful opioid is killing tens of thousands of teenagers and adults in the United States each year.

This operation demonstrates how easily consumers can purchase millions of dangerous and deadly drugs through illegal online pharmacies.

At a time when federal regulators and law enforcement have the nearly impossible daily task of detecting and intercepting hundreds of thousands of packages containing these dangerous counterfeit drugs, some members of Congress are proposing drug importation legislation that would allow Americans to purchase drugs from foreign, unregulated pharmacies.

Though it may seem wellintentioned, this proposed legislation ignores the realities of the public health crisis America faces today. If enacted, it will also inevitably

that will be lost.

Consumers access many of these pharmacies online. They believe that they are ordering drugs from reputable foreign pharmacies. But they aren't.

Consider the numerous entities that claim to be "Canadian" online pharmacies. Only a tiny percentage of these pharmacies actually are licensed in Canada.

In fact, ninety-six percent of online pharmacies operate illegally, selling drugs without a prescription or distributing counterfeits.

Many of these counterfeit medications fuel the U.S. opioid epidemic. Counterfeiters will turn a few thousand dollars into \$10 million by buying fentanyl powder -- often purchased from Chinese labs -- and a pill press online.

They'll then make a drug and pass it off to our teenagers and adults as legitimate versions of other non-fentanyl, pain pills. These unsuspecting victims will then take the drug, overdose, and die.

Should Congress' proposed importation legislation pass, there would be no regulatory mechanism to distinguish between legitimate and counterfeit imports. Consumers will have no idea if they are receiving a drug that is safe and effective or a counterfeit that could kill them.

One thing is certain: with a direct pipeline to American consumers, criminal organizations will tap into other, less

increase the number of lives regulated global drug markets to ramp up the size and scale of their illegal pharmacy

> Their goal? Pump as many drugs as they can into the United States.

> These drugs won't be coming from vetted sources. Illegal online pharmacies source their drugs from countries like China, which is the number one supplier of fentanyl to North America, according to the U.S. Drug Enforcement Administration.

There are other types of counterfeits being made over-

In 2014, for instance, Polish police arrested 14 suspects for manufacturing counterfeit Viagra and selling it online. In 2016, officials charged a Belgium man for creating falsified U.S. labels for drugs manufactured in India. And last spring, officials discovered a counterfeit cancer medication in Germany's supply chain.

The ban on foreign drug imports exists for good reason. Lifting it will make it harder for America to keep counterfeit and illicit drugs out and cost many Americans their lives.

Defendants Sentenced for Home Invasion Robbery, Kidnapping

DATE: December 22, 2017 CASE: Antione Cisco & Reynaldo Eknar

(Case #16FE012117)

PROSECUTOR: Deputy District Attorney Sam Alexander, Career Criminal Prosecution Unit

The Honorable Marjorie Koller sentenced Antione Cisco and Reynaldo Eknar to 179 years and 8 months to life in prison. On August 2, 2017, a jury convicted both defendants of three counts of first-degree robbery in concert, six counts of kidnapping for extortion, and three counts of kidnapping for robbery. The jury also found true the allegation that each defendant personally used a firearm on all counts.

On June 20, 2016, Antione Cisco and Reynaldo Eknar kicked down the front door of a home where a mother and her two sons lived. The defendants demanded money and property, beat the victims, and forced them to the ground at gunpoint while they searched for valuables. The defendants then forced the victims into a vehicle, drove them to a bank, and told one of the sons to withdraw \$8,000. The son followed orders out of fear for the safety of his brother and mother, who were being held in the car at gunpoint by the defendants.

The defendants then drove to another bank and told the son to withdraw another \$8,000. Instead, the son informed bank personnel of the situation and they called 911. Officers arrived and took the defendants into custody.

Eknar has prior convictions for illegal possession of a firearm and possession of marijuana

Defendant Convicted of Multiple Child Sexual Assault Charges

PROSECUTOR: Richard Lee Hranac Jr. (Case #16FE024088)

Richard Lee Hranac Jr. was convicted by a jury of four counts of lewd acts on a child under 14 years of age, five counts of oral copulation with a child 10 years of age or younger and two counts of sexual intercourse with a child 10 years of age or younger.

From 2007 to 2011, the victim's mother was constantly in and out of the hospital due to a medical condition. The victim was often left in the care of Hranac, who started sexually abusing the victim when she was 7 years old until just days before her 11th birthday. In January 2011, the victim was placed in the custody of a family member. She was initially afraid to report the abuse, but disclosed the abuse after her mother passed away in 2013.

Hranac faces a maximum sentence of 139 years to life in prison. Sentencing is set for February 16, 2018 at 10:00 a.m. in Department 12 before the Honorable Maryanne Gilliard.





Dear Dave,

My father-in-law started a business as an LLC few years ago. He named all his daughters owners, with him owning the majority share. The business failed, and now he is being sued by creditors. He told the family these creditors can't come after us and the other siblings, because he is the majority owner. Is this true, or should we get a lawyer?

- Caleb

Dear Caleb,

Your wife is probably not in danger, unless she signed paperwork making her liable for a loan or liable with a creditor. If she signed official, legal paperwork - like if she went down to the bank and signed on a loan - then she's liable. It's that simple. That would make her, or any of her siblings who did this, comakers on the loan.

Your wife, and any of her sisters, who signed on trade accounts taking supplies from a supplier and paying them

could also be liable. But they are not automatically liable simply because they were listed as minority owners in an LLC, or even a sub-S corporation. If it were a general partnership, there's a possibility they could be liable. That's one of the reasons I hate general partnerships. I hate partnerships in general,
