RANCHO CORDOVA, CA (MPG) -

While some cities struggle to find an identity, change old perceptions, or find ways to grow and attract new residents or businesses, Rancho Cordova is not one of them. This is a city on the

The City of Rancho Cordova rotates the office of mayor each year and in 2017 Mayor Donald Terry will complete his first term. On November 2, Terry presented the State of the City and talked about the many ways

that Rancho Cordova was On the Move in 2017.

"The first thing we're going to talk about is crime is on the move down," Terry said.

From 2011 to 2016, violent crime and property crimes combined decreased by 31½%, and it didn't happen by accident. The Crime Suppression Unit's proactive team of sergeant and four officers targets career criminals and major crimes. The CSU made arrests, contacted indiconfiscated illegal weapons, illicit drugs and contraband, and collaborated with RCPD detectives to investigate and solve major cases.

The neighborhood policing program, led by new Chief of Police Chris Pittman, teams up RCPD patrol officers with memneighborhoods. Neighborhoods are further on the move with asset-based community development. In the West La Loma and Lincoln Village neighborhoods City representatives met with local residents and asked them what was good about their neighborhood and built on that.

RANCHO CORDOVA, CA (MPG) - Three Rancho Cordova Police officers - Officers Ronald Sutter, Kimberly Boswell and Ken Gouveia - recently graduated from the Sacramento Regional Drivers Training Facility's Basic Police Motor School class. Each officer completed 80 hours of training in the class to teach them to safely ride a police motorcycle, which follows 80 hours of pre-training to prepare them for the class.

The Motor School class was created in 2004 with the goal to provide a regional motorcycle program for law enforcement agencies. Agencies from the Sacramento region and throughout California, and as far away as Vancouver, Canada, have sent officers to be trained at this school.

The primary premise is for officers to learn to control the motorcycle at slow, moderate and high speed on a variety of surfaces, which are typical conditions for a Motor Officer. The cone patterns utilized during instruction are designed to instill

riding techniques that the officers will use it's an art to learn how to ride a bike and throughout their careers to help them avoid collisions and keep them safe.

Officer Sutter, a 23-year veteran of the Sacramento County Sheriff's Department, has aspirations of working with the community as a Motor Officer. Officer Sutter feels

Guiding Veterans in Tough Times

FAIR OAKS, CA (MPG) - Ed Outland is not a veteran. As a young man, however, he planned to serve his country, as did his father, a career serviceman. But those hopes were dashed when he developed an illness that disqualified him for enlistment.

"I was drafted in 1969 and I wanted to be a pilot," says Outland, founder

and CEO of Family Heritage Group, LLC in Fair Oaks. "I found out I had a form of spina bifida and that was it. I didn't get to go."

Flash forward several decades (and careers) later and Outland, 71, heads up a company offering financial estate planning and related services for individuals and their family members. He's found a circuitous but important way to serve his country by providing pro-bono financial services

to aging, sick and injured veterans to ensure they receive, at minimum, access to a little known government entitlement benefit that a vast majority of his clients don't even know they qualify for.

Sure, Outland has to keep the lights on, so his core company, which currently carries a portfolio of roughly \$11 million, centers on financial and estate planning services for the elderly, helping them navigate the wildly complicated qualification process for Medi-Cal benefits, the state's Medicade program for low-income individuals, and guiding clients on the purchase of life insurance, annuities and other investment and retirement vehicles.

But Heritage Group has a niche market serving veterans with critical medical issues, ensuring they and or their spouses receive assistance through the Aid & Attendance program (A&A) offered through the US Dept. Of Veteran's Affairs (VA). The to present day, also qualify.

benefit, which can be combined with social security and Medi-Cal, can be used to pay for non-service related medical expenses, including long-term care fees and other expenses due to a catastrophic illness.

Outland does not charge for helping veterans get this benefit. For those veterans who may have assets exceeding qualifying levels, Outland works with them to redirect their assets in order to meet the requirements.

"Roughly 96 percent of the financial services and catastrophic illness planning we do with veterans is pro-bono work," says Outland. "We help them or, if need be, the spouse, apply for the A&A benefit so they can deal with medical expenses with dignity and not have to go broke doing it."

There are fewer and fewer financial advisors willing to dive into the tangled web of entitlement benefits, according to Outland, who has

been working with veterans for about 11 years. Over that period, he's established good relationships with the skilled nursing facility community, working with staff and ensuring residents are signed up for and receiving the full range of government entitlements needed to pay for their care and board.

"This work is not for the weak willed or faint of heart," says Outland. "Believe me, the VA doesn't like us

To qualify, a veteran must have served at least 90 days of active duty with one day during a time of war and a clean discharge from service between Dec. 7, 1941 and Dec. 31, 1946 for WWII; June 27, 1950 to Jan. 31, 1955 for the Korean Conflict, and between Aug. 5, 1964 to May 7, 1975 for the Vietnam War. Veterans with at least two years of active duty service during the Persian Gulf War from Sept. 2, 1990 up

While most of his VA pro-bono clients do not have much money saved, Outland works to help all who apply for the A&A benefit to qualify. The VA stipulates applicants can have only a maximum \$30,000 in assets if single, \$50,000 if married.

But for most, the A&A benefit represents the last option for financial aid to cover medical care costs. Few have wealth management portfolios to break apart and redirect.

"Many of our veterans come in the door with \$50 in their savings accounts," says Outland. "Getting these benefits is life-changing for them."

Part of Outland's work with others also involves dispelling myths, the biggest one being that if you have money you can't qualify for Medi-Cal. And that myth is widely prevalent among a good majority of WWII veterans and their family members who are struggling to balance paying for medical care without depleting their assets and robbing their children of an inheritance.

"The greatest generation of veterans is dying off," says Outland. "So our job is to make sure that the \$10 trillion that roughly comprises their total wealth is passed on to their families and not sucked up by the ever-increasing

costs of long-term medical care and expenses."

Outland said of the roughly 16 million veterans who served in WWII there are roughly 750,000 still living. He estimates there also are roughly 2.5 million WWII widows still living who are entitled to the benefit and can apply for it. They just need to know it's there.

"That's a lot of veterans and widows out there and most of them don't have a clue the benefit is there for them," Outland says.

Receiving the Aid & Assistance benefit has made it possible for veterans from all backgrounds to fill the gap between Medi-Cal coverage, Social Security and pension payments and costs of long-term care, among other things, which amounts to an average of close to \$7,000 a month in many places. As of January 2015, a veteran and spouse could qualify for as much as \$2,126 a month through the program. The A&A benefit for single veterans is currently set at \$1,794 a month, and for surviving spouses the benefit is \$1,156


"It truly can mean that someone can age with dignity in a good facility and pay for it without having to lose everything they've spent their lives saving up," Outland said.

Outland also has an hour-long, weekend radio program offering listeners financial and estate planning guidance, He's successfully parlaying a long, first career in radio advertising sales and station management into a passion helping people manage their money, preserve their family's wealth and plan for the future.

"I'm self-taught," said Outland. "I got tired of doing radio sales day in and day out. I have been doing this for 28 years now and I guess you could say it really is a second career."

Outland said when he "discovered" the Aid & Assistance benefit was available there were reportedly roughly 400 recipients in the Sacramento County region signed up for and receiving it. As of January of this year, he estimated his firm had successfully completed roughly 6,000 A&A cases for veterans.

"It was like the sky opened up," Outland said. "We've got to get the word out there that these benefits are



Continued from page 1 After a year of work between the City, the police department, and the residents, the neighborhood threw their own block party. "We ran out of food and there were over 400 people there," Terry said. "... And it's really being led by the residents themselves."

This year three residents of the West La Loma area and three from Lincoln Village attended the Community Leader Institute put on by the nonprofit, NeighborWorks America, for which Donald Terry works. "About 1,500 resident leaders from across the country come together and learn from each other about how to be leaders in their own community," Terry said. Those six people spent four days learning from others how to be neighborhood leaders. Next year, after carrying out their own neighborhood plans, the Rancho Cordovans will go back and pass on their knowledge to new people attending the conference.

With a population of 73,872 and a growth rate of 2.2%, Rancho Cordova's population is on the move. "There are many reasons we are growing faster than any other city in the county," Terry said. "They include having the best value of new homes, a central location in the county, free amenities year round with our Community Council, and career opportunities and access to great schools."

Terry's Moving with the Mayor initiative encouraged residents to exercise more, and provided an opportunity for the mayor to meet people and share what's new in the city. He and city council members went to different locations and schools and along with kids and others participated in yoga, skating, biking, walking, running, and working out. He continued the mayor's walks that were started by Ken Cooley a number of years ago.

The City also planted trees. "Our City met and exceeded its goals to plant a tree a day in Rancho Cordova to improve air quality, increase shade and overall beautifying our community," Terry said. "We planted 367 trees in 365 days."

Business and residential development is flourishing. Vice mayor Linda Budge, who will take over as mayor in 2018,

The use of Community Enhancement Funds supported by Measure H sales tax provided funding during the second year of the fund for more than 50 projects selected based on input from the community. Among them were 620 linear feet of sidewalk replaced as part of the 2017 ADA sidewalk improvement project; 1½ miles of new sidewalk, crosswalk and bike routes; 2017 street rehabilitation of 44 streets paved, 87 curbs upgraded, 79 drainage location upgrades, and 5,440 sq

ft of sidewalk repaired in three neighborhoods; and two new traffic signals at heavily traveled intersections in the City.

Terry presented much more. Larry Stafford, president of the Cordova Community Council said that there is a lot that people don't know about Rancho Cordova. "That's why I like events like this so we can publicize a little bit more and fill people in on all the really exciting things that are happening," Stafford said.

In closing, Terry played the City's new video on Rancho Cordova, the maker city, which stated in part: "We are the makers . . . we get things done . . . push the limits . . . or we just go with the flow. Rancho Cordova is the place to make your mark, enjoy the fruits of your labor. We have a lot to celebrate and as one of the most diverse cities in the nation, here in the city of makers we say, make your

Continued from page 1 nitpicking on traffic violations or what have you," said Sutter. "As a motor officer, you get to really see how those violations that people think are small can impact a motorcycle rider or the motoring public in cars. A small violation that might make a small car accident with a person could potentially kill a motorcycle rider."

Officer Boswell, a 13-year veteran of the Sacramento County Sheriff's Department, grew up with motorcycles and enjoys riding them. This and her respect for and work with the motor officers at the Rancho Cordova Police Department made her want to go to Motor School. In spite of the physically and mentally demanding training, Officer Boswell graduated and calls it her biggest accomplishment during her time

at the Sheriff's Department.

"It was the biggest decision I've ever made in my entire career," said Boswell. "It was the hardest decision because of the dangers. That's why there are very few officers who actually take the plunge to become a motor officer because of the dangers of this job. I wanted to represent the Rancho Cordova Police Department, Sacramento County Sheriff's Department, and especially the very few women that actually pass and become motor officers.'

Officer Gouveia, a 13-year veteran of the Sacramento County Sheriff's Department, always had an interest in doing motorcycle and traffic enforcement. He said motor school was the first step in the road to becoming a motor officer. Now that he's graduated, Officer Cordova

Gouveia looks forward to doing more in-house training to learn the ins and outs of enforcement.

"You have a whole new respect for motor officers," said Officer Gouveia. "Going into the school, they tell you it is going to be hard, and day one, you discover how hard it's going to truly be. It's probably the hardest thing I've done in law enforcement even with the academy."

Now that the officers have graduated, they will spend an additional 80 hours of time with a Certified Motorcycle Training Officer to train them on performing the duties of traffic enforcement. The Rancho Cordova Police Department congratulates Officers Sutter, Boswell and Gouveia for a job well done!



remember that all those pieces of metal and plastic, and all of their information, etc., are what men and women have put into them.

And another thing that happened in our city on Saturday, November 4th was an event titled "A Conversation about the Vietnam War." The event was co-sponsored by the City of Rancho Cordova and Rancho Cordova Library and hosted by Vice Mayor Linda Budge. The event was held at the Rancho Cordova Police Department in the Larry Canfield Room. In addition to the conversation on Vietnam, Vietnam Veteran lapel pins were given to Vietnam Warera veterans who were able to attend. I have been asked about the Vietnam Veteran lapel pins that we have been handing out to Vietnam Warera veterans for a couple of years. The lapel pins are given to those who served on active duty in the U.S. Armed Forces at any time during the period of November 1, 1955 to May 15, 1975, regardless of location.

According to the Vietnam War Commemoration staff, the records of the U.S. Department of Veterans Affairs show we are losing over 500 Vietnam veterans every day, so I am glad they have extended the time for telling them welcome home. That welcome home is well overdue. There are still approximately seven million Vietnam veterans alive out of the nine million who served during that time. Listening to the stories of the veterans

on November 4th makes me think of those histories that are not written, but are only in the memories of people. Everyone has a story, but unfortunately, those stories are not often told.

I met a woman who said she was a demonstrator back in the 60's who was against the war. She now knows that taking everything out on the veterans when they came home was the wrong thing to do. She wishes she had had a chance to say to the veterans that she knows now that she was wrong. Some of the veterans she knew then have passed on, and she never had a chance to say she was wrong and that she was sorry. I believe that today, there are probably quite a few demonstrators like her who would truly welcome them home

I talked to a Vietnam veteran who lives in Rancho Cordova today who couldn't accept the Vietnam Veteran lapel pin because of the things that were done and said to him when he came home during the Vietnam War after serving in the military. His memories are too bitter and it hurt too much to accept something from the government. I listened and then welcomed him home anyway. Even though he wouldn't accept the pin, he knew I was sincere when I thanked him for his service, and he accepted my personal welcome home to him.





California's Tax-and-**Spend Cycle Continues**

Commentary by Senator Ted Gaines

The California legislature has descended into policy madhouse where decisions defy every bit of fiscal and economic common sense and serve to put working class people in the poorhouse.

Case in point is this year's tax-heavy legislative session, where the ruling party took breaks from abusing President Trump only long enough to pass bills making California unlivable. In a state with the highest poverty level in the nation, legislators inexplicably set out to make absolutely everything more expensive.

California already has some of the highest gas taxes in the country, so what do the legislative Democrats do? They start by imposing a new gas and car registration tax, which added twelve cents to every gallon of

gasoline starting November 1, and increases vehicle registration fees by \$25-175 per car. And that twelve-cent tax will go up starting in 2021, adjusted for inflation, forever and ever.

This tax was sold as a way to repair our roads but we already have money for that and have simply not made the commitment to spend those funds where needed. California general fund spending increased by around \$25 billion over the past five years, but transportation spending stayed flat. Tell me why those funds could not have paid for roads?

Every year a billion dollars in truck weight fees are diverted away from transportation where they belong and into the general fund. California has the money! By putting this new tax on every mile regular people drive for work, for school, for family, the dominant party is simply charging you twice for road construction and repair. Would you rather see our road money spent where it belongs before paying new and higher taxes?

But even that was not enough. The big bamboozle came in the extension of the state's cap-andtrade scheme, which is alleged to fight "climate change" but really fights against prosperity in the working class. If you were angry over the 12-cent gas tax, how do you feel about the 73-cent increase on every gallon of gas due to cap-and-trade? And, the money raised by capand-trade will go to subsidize California's legendary money burning High Speed Rail, which most ordinary Californians will only ever see from their cheaper, faster, more convenient seats on Southwest Airlines.

Lastly, in a state where housing prices are eating up 50- or 60-percent of many people's income, the legislature saw it fit to make housing even more expensive with a host of new fees and mandates that will add hundreds of dollars in costs to many real estate transactions, but many tens of thousands in costs for some new construction.

These housing taxes are not without consequence. For every \$1,000 increase in the median price of a home, an additional 15,000 Californians are priced out of the market. The legislature is creating a permanent renter class by making housing and staple goods unaffordable, cutting off a traditional lifeline to a middle-class life for too many in our state.

California seems as though it has many problems - budget deficits, unfunded pensions, bad roads, high taxes – but it really has just one: Politicians. Until Sacramento's tax-and-spend pirates change their ways, it's higher taxes from here on out.



HIGH-OCTANE ACTION OF "THOR" GETS LIFT FROM SENSE OF HUMOR

THOR: RAGNAROK (Rated PG-13)

Fans of the Marvel Comics Universe are most likely to warmly and exuberantly welcome the return of Chris Hemsworth as the hammer-wielding Norse God of Thunder in his third run as the titular character in "Thor: Ragnarok."

Let's face it. While Hemsworth is greatly appealing as always in the role of Thor as the heroic guardian of the planet Asgard, the second chapter entitled "Thor: The Dark World" arguably had its share of shortcomings with a bland, generic blueprint.

"Thor: Ragnarok" does not fail to entertain beyond the usual tropes of a Marvel Comics superhero action film, and much of the credit goes not just to the good use of Hemsworth but to the vision realized by acclaimed New Zealand indie director Taika Waititi.

More than any previous installment in the "Thor" franchise, this third go-round turns loose Thor's sense of humor and ease with wisecracks to create an enjoyable ride through the sometimes thin gruel of action scenes that play more like a repetition of everything we've seen before.

Understanding what the word "Raganarok" means explains the basic mission of this chapter. In Norse mythology, it refers to the end of days in which the destruction of Thor's homeland and the end of Asgardian civilization is threatened by sinister forces.

"Ragnarok" opens with Thor trapped in what seems like the devil's lair on the other side of the universe without his all-powerful hammer. Captured by a fiery monster, his wit is part of his arsenal to break free of captivity to save his planet.

But first, Thor's primary objective to save Asgard is burdened by a slew of complications, beginning with the fact that his father Odin (Anthony Hopkins), currently imprisoned on Earth, is being impersonated by Thor's duplicitous brother Loki (Tom Hiddleston).

Given that Loki shifts his allegiances like a spinning weathervane in a windstorm, his character has always been more complex and interesting than the upright Thor who adheres to the moral code of an honest custodian of Asgard's security and the wellbeing of its people.

There's nothing like sibling rivalry and a sense of self-preservation that could motivate one's behavior. In this case, the return of the villainous Hela (Cate Blanchett), older sister to Thor and Loki, is a motivating factor in the new-found unity of the brothers.

Hela's power is unlike anything else in the Nine Realms. Armed with the ability to unleash unlimited weapons in astounding and deadly ways, Hela has returned to seek vengeance on those who cast her out of Asgard.

Needless to say, this monster that grows antlers when summoning her powers has no love for her father Odin or her two younger brothers. Known as the Goddess of Death and resembling a wicked witch, Hela intends to usher in a new era of cold brutality for Asgard. Meanwhile, before Thor can do

much about his homeland, he finds himself captured by bounty hunter Valkyrie (Tessa Thompson) and taken prisoner on the planet Sakaar where the eccentric ruler Grandmaster (Jeff Goldblum) runs gladiator contests for pure sadistic

At one point, Thor, whose long hair has been a significant feature of his superhuman façade, has his golden locks cut very short. But unlike Samson, this act does not cause him to lose his strength.

Still without his hammer, Thor is forced into a brutal competition with the brooding Hulk (Mark Ruffalo) who has somehow gone two years without returning to the human form of Bruce Banner.

Things start to gel for the superheroes when Loki figures out the clash with Hela is inevitable, the Incredible Hulk turns into the soulful Bruce Banner and the hard-drinking Valkyrie decides her supreme warrior skills are a nice match for teaming up with

The back end of "Thor: Ragnarok" is inevitably the most predictable and least interesting, unless of course the sight of Hela and her army of mercenary soldiers engaged in full combat with Thor and his crew is the most desirable aspect of this adventure.

"Thor: Ragnarok" is at its best when it embraces the comedic elements. Chris Hemsworth has terrific comic timing with his quips, and Jeff Goldblum does not disappoint with his whimsical portrait of an oddball tyrant who's actually funny.

My guess is that the fan base will look more so to the film's action sequences than its idiosyncratic tendencies to judge the merits of this latest "Thor" adven-

Green Light at the FERC Corral

Commentary by Robert L. Bradley Jr.

The Senate recently confirmed two new appointees to the Federal Energy Regulatory Commission, or FERC, ending a seven-month dormancy due to lack of a quorum. With three members, two Republicans and one Democrat, one pick from each party remains for a full five-member commission.

This delay, on top of a fossil-fuel animus by Obama's FERC, has created a \$13 billion backlog of regulatory approvals for 17 market-ready natural gas projects. With its other business, FERC's total project backlog represents \$50 billion. FERC should begin greenlighting projects immediately.

Under the authority of the Federal Power Act of 1935 and the Natural Gas Act of 1938 (NGA), the primary duty of

this agency is to "ensure just and reasonable rates, terms, and conditions" concerning interstate transmission of electricity and natural gas.

One can only wish. Sadly, FERC delays often impede otherwise readyto-go projects. Section 7(c) of the NGA, in fact, was designed to allow coal and oil interests to intervene in hearings to slow the spread of (consumer-preferred) natural gas. And now, energy obstructionists want to complicate the certification process to keep natural gas (and other fossil fuels) in the ground.

The new FERC has a lot of catching up to do. Approvals are entirely consistent with President Trump's America First energy policy. Many stalled projects are hosted by states that he won with his promises of economic revitalization.

FERC is off to a good start. In late

August, it approved the NEXUS, a natural gas pipeline between Ohio and Michigan. This \$2 billion project could bring 3,300 jobs to those two states as well as Pennsylvania. And just this month, FERC started fighting statelevel obstructionism in places (like New York) where authorities were withholding water quality permits to stymie new pipeline construction.

The next approval could be the Atlantic Coast Pipeline, which would run between West Virginia and North Carolina. It would create 10,000 jobs for those two states and Virginia.

FERC is also expected to greenlight the Mountain Valley Pipeline across West Virginia and Virginia, which would involve almost 9,000 jobs. These projects, and three others waitlisted during FERC's inactivity, could create more than 26,000 jobs in total.

should oppose all nominations."

Environmentalists' objections are rooted in fantasy -- and they impede safety. Pipelines are the safest way to transport fossil fuels, meaning they're less likely to damage crops than the alternatives. And based on average annual accident rates, pipelines are over three times safer for natural gas transport than rail.

With Commissioners Robert Powelson and Neil Chatterjee confirmed, FERC is free to greenlight projects that put consumers and economies first.

The sooner FERC starts greenlighting projects, the sooner consumers receive the economic benefits associated with natural gas.



Environmentalist of the Year Award Goes to Citizens' Climate Volunteer Jennifer Wood

- Jennifer Wood received the Environmentalist of the Year Award from the Environmental Council of Sacramento (ECOS) November 8th. Jennifer is a volunteer with the Sacramento Chapter of Citizens' Climate Lobby (CCL), and she was honored along with other champions of the environment at the annual awards ceremony.

Jennifer Wood founded the Sacramento Chapter of CCL in January of 2013 because of CCL's emphasis on citizen engagement and its focus on bipartisan national policy. She began as the volunteer Group Leader for the Sacramento Chapter and is now a volunteer Chapter Coordinator, focusing on groups in the Central Valley and Sierras. Jennifer stated: "CCL has an approach that can bridge the political divide and bring many voices into the conversation. We advocate for national climate policy that is equitable, effective, and efficient."

CCL, which has 84,000 members globally and chapters that cover every Congressional District in the U.S., trains volunteers in the skills of citizen engagement and helps members exercise their political voice. The Sacramento CCL chapter has grown to over 800 members and has developed relationships with Representatives Doris Matsui



and Ami Bera, demonstrating community support for common-sense national climate policy.

Members meet with local elected officials and community leaders and educate the public about national climate solutions. Last June, seven chapter members traveled to Washington, D.C. for CCL's annual conference, and joined 1,000 volunteers as they lobbied every member of Congress about the need for national climate action. "It was a life changing experience to participate in grassroots organizing." said Edith Thacher, Sacramento chapter co-lead,

"Imagine hundreds of volunteers walking the halls of Congress, meeting with each representative or their staff, expressing a unified message, and respectfully discussing the congressperson's perspective on climate action."

Commenting on the award, Jennifer said, "This award belongs to my Chapter's members as much as it does to me. There is no CCL without the volunteers and there is no political will for change unless citizens speak out and become active".

Defendant Sentenced for Murder of Disabled Man

DATE: October 30, 2017

CASE: Joshua Lowery (Case # 14F01574) **PROSECUTOR:** Deputy District Attorney William Satchell, Homicide Unit

The Honorable Steve White sentenced Joshua Lowery to 16 years to life in prison. On August 16, 2017, a jury convicted Lowery for the seconddegree murder of Christopher Sorgani. The jury also found true the allegation that Lowery personally used a deadly weapon.

On October 23, 2013, Christopher Sorgani took light-rail and a bus home from work. Mr. Sorgani was physically disabled and often walked the last stretch of his trip home for exercise. As Mr. Sorgani walked down Greenback Lane, Joshua Lowery approached him from behind and struck him in the head with a hammer multiple times, killing him. Mr. Sorgani and Lowery had no connection with each other and there was no apparent motive for the murder.

Defendant Convicted of Child Sexual Assault Charges

DATE: October 31, 2017

CASE: Peter Nicholas (Case #16FE016102) PROSECUTOR: Deputy District Attorney

TeriAnn Grimes, Special Assault & Child Abuse Unit Peter Nicholas pled no contest to two counts of sexual assault of a child 10 years old or under, and admitted to a 2003 prior strike for sexually assaulting a child under 14 years of age.

Nicholas was a friend of the victims' family and would often stay at their house on weekends. Nicholas would sexually assault the two girls who lived in the house whenever he had the opportunity. The assaults occurred over a seven-year period when the victims were between the ages of 3 and 12. Neither victim knew the other was also being assaulted. The oldest victim disclosed her abuse to her mother after receiving encouragement from her friend.

Nicholas faces a maximum sentence of 60 years to life in prison. Sentencing is set for November 17, 2017, at 1:30 p.m. in Department 24 before the Honorable Shelleyanne Chang.

Former High School Teacher Convicted for Sexual Relationships with Students

DATE: November 1, 2017

CASE: Byron Wallace (Case #15F06533)

PROSECUTOR: Deputy District Attorney Maria Wilson, Adult Sexual Assault Prosecution

Byron Wallace was convicted by a jury of four counts of committing sex acts with a person under the age of 18, communicating with a minor with the intent to commit a sex act, molesting a child under the age of 18, three counts of unlawful sex with a minor, and dissuading a witness.

Wallace was a popular math teacher at Inderkum High School. He also ran the Christians in Action club as well as the HOPE program. A high school freshman met Wallace when she was a student in his geometry class. She got to know Wallace throughout her high school years from math classes and as an active member of the Christians in Action club. During her senior year, Wallace and the victim began exchanging flirtatious text messages. Eventually, they began meeting before and after school and became physically intimate. Over the course of their relationship, the victim spent more than \$3,500 on Wallace – buying him expensive shoes, belts and watches. Another student met Wallace her senior year when she asked him for help in math. She also became active in the Christians in Action club. Wallace and the victim began exchanging flirtatious text messages. Soon after, their relationship became physically intimate. Wallace also sent nude photos of himself to both victims.

Wallace faces approximately 8 years and 4 months in prison. Sentencing is set for December 15, 2017, at 9:00 a.m. in Department 10 before the Honorable Laurel White.

Marijuana Robbery Ends in Murder

DATE: November 3, 2017

CASE: Shaquille Huston & Dayvon Stroupe (Case #14F07830)

PROSECUTOR: eputy District Attorney Caroline Park, Homicide Unit

Shaquille Huston and Dayvon Stroupe were convicted by a jury for the first-degree murder of Vincent Amaya with a special circumstance of committing the murder during the course of a robbery.

On November 17, 2014, the victim met Shaquille Huston, Dayvon Stroupe and two additional unidentified assailants at the Florin Meadows Apartments to sell them marijuana. Huston, Stroupe and the two unidentified individuals attempted to rob the victim of his marijuana. During the course of this robbery, one of the four robbers shot and killed the victim.

Huston and Stroupe face a maximum sentence of life in prison without the possibility of parole. Sentencing is set for December 1, 2017, at 9:00 a.m. for Stroupe and December 19, 2017, at 4:00 p.m. for Huston in Department 33 before the Honorable Michael Savage.



My wife stood in front of me both hands on her hips during me and then she lifted her right hand to scratch her head and discovered her glasses were on top of her head.


"Oh," she said as she spun around to leave, "here they are on the top of my head."

I have a medical condition, and I finally got an appointment with a specialist I'd like to see. The office requires credit card, debit card, or bank account information be kept on file. Having this kind of information out there with them makes me uncomfortable, but I really want to see this doctor. What should I do?

Dear Chelsey,

If you're uncomfortable with this practice having your financial information, then you should also be uncomfortable with any medical opinions they would render. If you don't feel they're trustworthy enough to professionally handle something like a debit card or bank account number, then they're not trustworthy enough to treat you — period.

I hope that wasn't unclear.

Lancers Defeat Wolverines to Win Share of SVC Crown

RANCHO CORDOVA, CA (MPG) - Members of the Cordova High School football team will need to send the Union Mine squad Christmas presents or gift cards next month.

That is because Cordova will hoist up a second consecutive – and final – Sierra Valley Conference title. The Lancers posted their first shutout of the season against Rosemont, which led to a 48-0 win at Lancer Stadium on Nov. 3rd.

As Cordova was en route to its win, Union Mine jumped out to an early start that led to beat El Dorado 23-20. That win gave Cordova (4-1 in the SVC, 7-3 overall) and El Dorado (4-1 and 7-3) a share of the conference title. Cordova and El Dorado, along with Liberty Ranch, were tri-SVC champions last

"We were sweating that game out for sure," said Cordova head coach Darren Nill, referring to the El Dorado-Union Mine game.

Now the Lancers begin the Sac-Joaquin Section Division III playoffs against a familiar non-league foe in Vista del Lago of Folsom. See elsewhere on this page for another story on Cordova's second consecutive playoff trip.

Five minutes left in the first quarter against Rosemont (2-3 in the SVC, 4-6), Cordova scored its first touchdown when quarterback Johnele Sanders scored on a 33-yard run. Along with Alvin Banks booting the extrapoint, the Lancers led 7-0.

The Lancers' defense played a role in the team's next two touchdowns, both in the second quarter. Cordova, face a Wolverines' team that runs the veer offense, forced a turnover at midfield that gave the ball back into the Lancers'

hands. That led to wide receiver Jordan Colvin hauling in a 38-yard pass with 10 minutes left in the quarter, concluded with Banks' extra-point boot to make it 14-0.

Banks, from his defensive back spot, set up the next score on an interception halfway through the quarter. Then he rambled 49 yards into the end zone that gave Cordova a comfortable 21-0 halftime lead.

"Alvin gets open when the rest of the team is performing," said Nill of Banks. "The defense played lights out."

Five minutes into the third quarter, Cordova's defense forced Rosemont to punt. That led to another offensive possession and score for the Lancers, as Sanders scored on a 47-yard run to make it 28-0, plus Banks' extra-point

Then three minutes left in the quarter, Cordova made it 35-0 when running back Elijah Jenkins crossed the end zone on a rushing touchdown. The Rosemont coaches asked for a running clock at that time.

Two different Lancer players scored the final two touchdowns, both in the fourth quarter. Tyreke Tate scored the first one on a 37-yard run, followed by Kijon Allen on a 20-yard run. The extra-point kick missed but the score became 48-0.

Toward the end of the third quarter going into the fourth, Nill and his assistant coaches got all of the Lancer players into the game.

"Every single person played," said Nill, who started rotating players after Rosemont asked for the running clock. "We knew we had to work extra hard to get everybody in the game, and we

Sanders completed 8-of-16 passes for 104 yards and a touchdown. On the ground, he rushed for 103 yards on five

"Johnele was just a nightmare running our game against Rosemont," Nill

Cordova running back Raymond Fite had 89 yards rushing on eight carries,

and had 122 all-purpose yards. Colvin had his one reception for 40 yards, and Banks, who had a combined 124 allpurpose yards, 3-38. Cordova had 422 overall yards; 318 rushing and 104

"When you have over 300 yards rushing, your offensive line is clicking," Nill

On defense, Fite and Jenkins, who plays linebacker, had 13 tackles each. Outside linebackers Yusef Pugh followed with eight tackles, outside linebacker Ryan McMoore and defensive back Jaylen Jones and Colvin, who plays strong safety, had four each.

This was the last SVC football game for Cordova. Next July, Cordova, for all sports, will be one of six schools as members of the inaugural Greater Sacramento League, which the section created and

approved through the section's board of managers for the 2018-22 league realignment cycle earlier this year.

Other schools joining Cordova in the new league, which is Division IV, are Florin, Johnson, Valley and West Campus, all of Sacramento, and Natomas. The SVC drops to D-V, and adds Bradshaw Christian, which is in the Sierra Delta League that is D-VI, with El Dorado, Galt, Liberty Ranch, Rosemont and Union Mine.

Cordova Football Opens **D-III Playoffs on Road**

RANCHO CORDOVA, CA (MPG) - This time, the Cordova High School football team will be traveling east.

Cordova won a share of the Sierra Valley Conference title with a 48-0 win over Rosemont in the conference finale at Lancer Stadium on Nov. 3rd. Conference foe Union Mine (3-2 in the SVC, 5-5) knocked off rival El Dorado 23-20 in their meeting, which led to Cordova and El Dorado finishing with identical 4-1 marks in the SVC, 7-3.

On Saturday, the Sac-Joaquin Section released its playoff brackets for all seven divisions. Cordova is the No. 12 seed in D-III, and will make the short eastbound trek on Highway 50 to play at No. 5 seed Vista del Lago of Folsom. The host Eagles took second place in the Capital Athletic League at 4-1, and 6-4 overall. Because of Veteran's Day being observed Friday and Saturday, the Cordova-Vista del Lago game will be played on Thursday at 7 p.m. The winner will play the No. 13 East Union of Manteca-No. 4 Patterson winner, as that quarterfinal game will be on Friday, Nov.

Last year, Cordova made a short trek southbound on Highway 99 to Sacramento City College to play Christian Brothers in the D-III opener. The Lancers battled, but the Falcons soared to a 30-20 victory.

In a non-league game on Sept. 15th at Vista del Lago, the Lancers and Eagles combined for 970 total offensive yards. Vista del Lago posted a 54-33 win.

On its way to winning the title, Cordova has given up 14.1 points per game in five SVC games. The Eagles' offense has averaged 34.2 points per game.

"We were a lot different team than we were then," said Cordova head coach Darren Nill. "The big change is our defense. We have different defensive tackles in there. Our linebackers are playing forward more, which is something we've been trying to get them to do (during the pre-season). I think it's going to be a different ball game from the defensive side."

Cannabis Sellers Must Register with the California Department of Tax and Fee Administration



Cannabis cultivators, processors, manufacturers, retailers, microbusinesses and distributors who make sales are required to obtain and maintain a seller's permit. The cultivation tax rates are \$9.25 per dry weight ounce of cannabis flowers, and \$2.75 per dry-weight ounce of cannabis leaves.

SACRAMENTO, CA (MPG) -Individuals planning to sell cannabis or cannabis products beginning January 1, 2018, must register with the California Department of Tax and Fee Administration (CDTFA) for a seller's permit. Cannabis cultivators, processors, manufacturers, retailers, microbusinesses and distributors who make sales are required to obtain and maintain a seller's permit as a prerequisite for applying for a license with the Bureau of Cannabis Control, the Department of Food and Agriculture, or the Department of Public Health. It is easy and convenient to register online with the CDTFA. Individuals who already have a seller's permit (including a permit previously issued by the Board of Equalization) do not

need to register for a new one. In addition, distributors of cannabis and cannabis products must also register with the CDTFA for a cannabis tax permit - which is separate from a seller's permit – in order to report and pay the two new cannabis taxes to the CDTFA starting in January 2018. Registration for the cannabis tax permit will be available on November 20, 2017.

Beginning January 1, 2018, two new cannabis taxes will be in

effect. A 15 percent excise tax is imposed on purchasers of cannabis and cannabis products. Retailers are required to collect the excise tax from the purchaser and pay it to the cannabis distributor. A tax on the cultivation of cannabis that enters the commercial market is imposed on cultivators, who are required to pay the cultivation tax to either a distributor or manufacturer depending upon the nature of the transaction. The cultivation tax rates are \$9.25 per dry weight ounce of cannabis flowers, and \$2.75 per dry-weight ounce of cannabis leaves.

Individuals who operate a cannabis business that does not make taxable sales will need to obtain a certification letter from the CDTFA indicating that their business does not require a seller's permit. The certification letter will be available through the CDTFA online registration system beginning November 20, 2017. Individuals may also sign up for CDTFA Cannabis ListServ notifications for the latest information on how to comply with the new laws related to cannabis businesses.

More information about the permits necessary to collect these new taxes is available in this special notice and in the Tax Guide for Cannabis Businesses.
