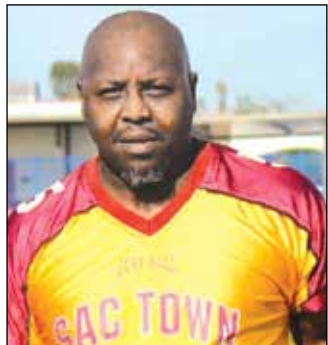

# A New City of Trees

*Rancho Cordova Receives Recognition for Tree Planting Program*

**RANCHO CORDOVA, CA (MPG)** - The Sacramento Tree Foundation awarded the City of Rancho Cordova its "Growing Greenprint" Tree Hero Award on Wednesday, May 31st for the City's efforts towards expanding its urban tree canopy. With support from elected officials, City staff and community volunteers, tremendous work has gone into planting more trees across Rancho Cordova on both public and private property.

Commitment to an improved tree canopy began in 2015, when the City outlined a tree plan and hired a contract arborist to assist with its development.

In May 2016, the City planted 100 trees in Lincoln Village as part of its first neighborhood planting event. More recently, the

City completed an inventory of its public trees and vacant planting sites to create a tree maintenance and planting plan. The City developed a goal to plant one tree a day or 365 trees during the fiscal year in neighborhoods and private property, churches, businesses, and parks.

"The City's tree program has been a great community effort with residents and businesses coming together to identify planting sites, as well as physically getting the trees in the ground," said Steve Harriman, the manager of the tree program for the City of Rancho Cordova.

In collaboration with the Sacramento Tree Foundation, the City of Rancho Cordova and community volunteers planted 35 trees in the

Cordova Meadows and Cordova Gardens neighborhoods, and 100 trees were planted on church properties. 100 additional trees will be planted on neighborhood, commercial, and church sites, and the remainder of the trees will be planted on City property by June 30, 2017.

The City is also working to improve its tree ordinances and is drafting its Urban Forest Management Plan to further support efforts to grow trees in Rancho Cordova and increase shade.

"The robust urban forest that we are building makes Rancho Cordova a cleaner, healthier and even more beautiful community. This program will be a lasting legacy for the City," Harriman said. ★

# City Council Appoints Gatewood as New Member

## City of Rancho Cordova Special Release

**RANCHO CORDOVA, CA (MPG)** - The Rancho Cordova City Council today appointed Garrett Gatewood to the City Council seat left vacant by the passing, on April 20, 2017, of longtime City Council Member Dan Skoglund.

Garrett Gatewood, a resident of Rancho Cordova for 12 years, is the owner of Business Computer Services of Sacramento. He has been an active member of the Rancho Cordova Chamber of Commerce for five years, and he has served on the Board of Directors of the Chamber for the past three years. He is also actively involved in two nonprofits, Sonders Solutions, which places veterans into jobs, and Region Technology, which works to

bring technology jobs to the greater Sacramento region. Mr. Gatewood was instrumental in the organization of a citywide cleanup in partnership with Volunteers in Neighborhood Services. He is a Little League and soccer coach, as well.

"It's never an easy task to fill the shoes of a colleague like Dan Skoglund, but it's encouraging to see the tremendous civic engagement that is represented by the 24 applications we received," said Mayor Donald Terry. "We had a number of very qualified candidates, but only one can be appointed. I am thrilled to welcome Garrett Gatewood to the Rancho Cordova City Council."

The City Council, within sixty (60) days from the date of the vacancy, is required to either fill the vacancy by appointment or call a special

election to fill the vacancy. At its May 15th meeting, the City Council voted to open an application process to appoint a new Council Member to complete the remainder of Council Member Skoglund's term, which ends in December 2018. An appointment is required by June 19, 2017.

Applications to fill the vacant City Council position were open from May 16 – May 30, 2017. Twenty-four residents applied and, later, three applications were withdrawn. Nineteen of the 21 applicants attended today's Council meeting, providing formal statements as to their willingness and ability to serve on the City Council. City Council Members also listened to many members of the public who provided public testimony.

After public deliberation by the City Council,

the candidates were narrowed to three and then to two. Council then voted to select Garrett Gatewood to fill the vacant City Council seat. Mr. Gatewood will be sworn in at the June 19, 2017 Council Meeting.

"It is an honor and a privilege to serve my City in this manner, and I know I have big shoes to fill," said Mr. Gatewood. "Rancho Cordova is the greatest city in which to live and work, and I only see great things in its future. I look forward to being a part of that future."

In order to be eligible to hold office as a member of the Rancho Cordova City Council, a person must be a registered voter and otherwise qualified to vote for that office at the time the application is submitted. During the term of office, a person must also continue to reside in the City. ★

# PaintCare: An Historic Milestone for a Unique Organization

**SACRAMENTO REGION, CA (MPG)** - When Congressman Jared Huffman began sponsoring a product stewardship law for architectural paint in California in May 2009, even he couldn't envision the level of success that was to come in a few short years after the state's paint stewardship program began in 2012.

"Congratulations to PaintCare on its five year anniversary and for recycling more than 10 million gallons of paint in California," said Rep. Huffman the Second District Representative. "To go from no California product stewardship presence to 10,000,000 gallons in California alone in so short a period of time is an incredible achievement. When I authored this legislation in the California Assembly, my main goal was to make leftover paint recycling more convenient for Californians, reduce the burden of disposal on local governments, and to protect the environment. I'm glad to see that PaintCare has reached these goals with flying colors within just five years. It's a testament to a lot of hard work on the part of many different people."

What has legislators so excited about PaintCare and Product Stewardship though, is not just the success PaintCare has had in collecting a combined 20,000,000 gallons of paint for recycling in those states and jurisdictions with paint stewardship laws (with California accounting for a little more than half and the seven other states and the District of Columbia accounting for the remainder) Ken Pereira, Waste Management Specialist for Sacramento County, highlights the cost savings to municipalities:

"Sacramento County's Department of Waste

Management and Recycling (DWMR) is committed to excellent environmental stewardship. Historically, DWMR has spent approximately \$150,000 annually in order to divert leftover or unwanted paint products from the landfill, and ensure that they are reused or recycled. Thanks to our successful relationship with the PaintCare organization, DWMR has reduced those annual costs to less than \$8,000 per year. These cost savings directly impact our rate payers and also allow DWMR to expand and improve the county's Household Hazardous Waste (HHW) Program."

PaintCare is the flagship organization under the growing header of Product Stewardship, an environmental strategy in

which product manufacturers have the primary responsibility to establish, fund, and manage programs that minimize the environmental impact of products across the entire product life cycle, including end-of-life management. Government agencies help set performance goals for the programs and ensure accountability and transparency. This means that PaintCare is a unique non-profit operator, at once a partnership between private business and public agencies, and yet its own independent body. California Product Stewardship Council Executive Director Heidi Sanborn on PaintCare's role in the evolution of the general public's understanding of product stewardship.

"PaintCare has demonstrated that a producer designed and operated system can provide a much more convenient collection system than the government can because they have more locations where people normally go to shop. It's called "take-back" because the retailers are taking back what they once sold making it convenient for their customers. We know if recycling is convenient and free at end of life and the public is informed how to use it and it has a sustainable funding source, the programs work very well. A great benefit of the paint stewardship program in California is that is has freed up millions of dollars of public money to be used on other hazardous waste collection."

PaintCare Executive Director, Marjaneh Zarrehparvar, has earned a reputation over the past five years as being an effective mitigator in the sometimes-tricky relationship between private business and public sector waste and environmental agencies. Kelly Moore CEO, Steve DeVoe, on PaintCare's leader:

"I have had the pleasure of working with Marjaneh now for a number of years both as a paint manufacturer and retailer, and I'll tell you, I think the secret to PaintCare's success is a lot simpler than it might seem. All too often with product stewardship, it seems that businesses, governments and nonprofits can start out as adversaries. But Marjaneh and her PaintCare team have collaborated effectively with everyone and created a program that has processed 20,000,000 gallons of unwanted, leftover paint. I think we are on the right track to process millions of gallons more. PaintCare is a great model of product stewardship and shows what can be done."

## Highway Patrol Offering Free "Start Smart" Classes

**SACRAMENTO REGION, CA (MPG)**

- The leading cause of death for Americans 15-20 years old is motor vehicle collisions. In an effort inform and to reduce motor vehicle collisions in California, California Highway Patrol (CHP) North Sacramento area will offer a free Start Smart class. According to the National Highway Traffic Safety Administration (NHTSA), mile for mile, teenagers are involved in three times as many fatal crashes as all other drivers.

Recent collisions involving teenagers in our area demonstrate the importance of these types of classes. The classes are used to promote traffic safety to both parents and teens. We encourage both parent/caregivers and teens to attend the class.

The CHP's Start Smart program is a driver safety education class which targets new and future licensed teenage drivers between the age of 15 -19 and their parents/guardians.

The Start Smart class will cover collision avoidance techniques, driver responsibility, collision trends, distracted driving laws, alcohol related driving laws and the provisional license

process. The program also offers an opportunity for new drivers and parents/guardians to ask CHP Officers clarifying questions. The class incorporates videos and classroom discussion.

North Sacramento CHP will be offering this free class on Tuesday, June 13th, and Tuesday, June 27th, from 6:30 p.m. to 8:30 p.m. The class will be held at the Sacramento Water and Sewer Treatment Plant at 5026 Don Julio Blvd, in the conference room. This building is located on the northeast corner of Elkhorn Blvd. and Don Julio Blvd.

Persons interested in signing up for the class will need to register for the class by emailing Officer Chad Hertzell at [chertzell@chp.ca.gov](mailto:chertzell@chp.ca.gov) or by sending a private message to our Facebook account at [Facebook.com/chp-northsac](https://www.facebook.com/chp-northsac). It is highly encouraged that at least one parent/guardian attend the class with their teen driver. # State-of-the-Art Sheet Metal Workers Training Facility Opens at Mather Field

**RANCHO CORDOVA, CA (MPG)** - A newly renovated sheet metal and HVAC training center opened at Mather Field on May 31, 2017, marking a growing demand for skilled personnel in the Sacramento region’s building trades and sheet metal industries. Over \$3 million in investments went into renovating the Northern California Valley Sheet Metal, Heating and Air Conditioning Training Center, which will provide free college-level training to more than 100 men and women on an annual basis. “This new facility is almost twice the size of the old training center and will allow for expansion of the program for years to come,” said Dennis Canevari, Assistant Business Manager for the Sheet Metal Workers’ Local Union No. 104. The state-of-the-art facility features an HVAC Service Lab, sheet metal fabrication area and lab and welding equipment, and offers a variety of specialized courses for prospective tradespeople. “We stand ready to supply the Sacramento area contractors with a skilled labor pool,” said Canevari. The apprenticeship program is the only State-certified program of its kind in the Sacramento area and will educate Union craftsmen in the sheet metal industry across 23 northern California valley counties *Source: City of Rancho Cordova* ★

# Senate Unanimously Approves Berryhill Bill to Help Fight Deadly Forest Fires

**SACRAMENTO, CA (MPG)** - A bill to help Tuolumne County with the emergency removal of dead trees cleared the Senate unanimously on Wednesday. “This bill will save lives,” said Sen. Tom Berryhill, R-Twain Harte, the bill’s author. “I look forward to working with members of the Assembly and the governor on this important issue.” If made into law, SB-265 would increase the amount of state aid to Tuolumne County from 75 percent of emergency removal costs to 90 percent. There are more than 102 million dead trees in California, many of which




**Sen. Tom Berryhill, R-Twain Harte** are in Tuolumne and the surrounding counties. Other counties are watching SB-265 and considering taking the actions necessary to qualify. Drought, bark beetle,

and other stresses have led to massive tree die-offs in California’s forests. The tree mortality crisis worsens wildfire risk across whole regions of the state and presents life safety risks from falling trees in many forested communities. On October 30th, 2015 Governor Brown declared a state of emergency due to the tree mortality crisis. Senator Berryhill represents Rancho Cordova and the counties of Amador, Calaveras, Inyo, Mariposa, Mono, Stanislaus, Tuolumne and parts of Fresno, Madera, Sacramento and Tulare. *Source: The Office of Senator Berryhill* ★

If you looked at the City’s website at the end of the day on May 30, 2017, there were 24 Rancho Cordovans the four Council Members had to choose from. # And Another Thing ...

## Update on Our City Council Meeting and New Council Member

Many people were glad that the budget was passed on June 5th, rather than waiting for two more weeks. We are in a good position to sell off special tax refund bonds and to achieve a lower interest rate and cash flow savings relative to prior bonds. That was just one of the decisions that was made out of the thousands we had to make for our 2017-2019 operating budget. Our staff came through again with flying colors after putting in innumerable hours. Thank all of you for making the City of Rancho Cordova shine again.

I will be very glad when we receive the finished video of our May 29, 2017 Memorial Day celebration. When we began recording the Veterans Day and Memorial Day celebrations, we have been able to share stories that would have been lost. The Rancho Cordova Historical Society started doing video interviews of the citizens of Rancho Cordova, and they captured parts of our records and accounts of Rancho Cordova history. By recording what is said and remembered, we now can save what is said by our keynote speakers at Veterans Day and Memorial Day. I think that these recordings could be used in libraries and in schools when the teacher is telling their students about what was done in WWII, or Korea, or Vietnam, or the Gulf

War. The people who were there can provide details and mental color and pictures that a textbook cannot touch.

Rancho Cordova changed from a population of 72,203 to 73,872 from last year to today. That is a 2.2% increase, and makes us the most rapidly growing city in Sacramento County. Homes for sale all over Rancho Cordova move very quickly when placed on the market. It will be interesting when we see the population increase next year, and our city’s population goes over 75,000.

And another thing that I mentioned in the past, but is worth repeating, there are a few people who still think of Rancho Cordova as two separate entities, north and south, new and old, north of Folsom Boulevard and south of Folsom Boulevard. They forget that Mather Air Force Base, and now Mather Field, has been south of Folsom Boulevard (and also south of Highway 50) for decades. All the businesses on Sunrise Boulevard south of Highway 50, like the auto dismantlers, have also been there for decades too. And they are all part of Rancho Cordova. There really isn’t a dividing line in Rancho Cordova, except in the minds of people who don’t know Rancho Cordova.

# Gibson Ranch Management to Stay Under Ose

**CARMICHAEL, CA (MPG)** - The County Board of Supervisors on Tuesday unanimously approved a management contract for former Congressman Doug Ose to continue overseeing Gibson Ranch, ending months of negotiations over the fate of the 325-acre nature preserve.

Ose said Tuesday he is very pleased with the board’s decision, which essentially gives his company, GRP 211, LLC (GRP) a year-to-year contract to manage the park. The agreement will stay in place for four years and carry an option for annual extensions of up to four additional one-year terms, with a 90-day notification to terminate.

The new agreement with Ose shifts a significant portion of operational costs to the county, a win for Ose, who

was granted a five-year renewable lease to manage the park in 2011, but announced plans earlier this year to pull out unless the county could renegotiate an agreement to offset what he said was amounting to out-of-pocket losses of roughly \$20,000 a month due to rising labor costs.

Under the terms of the agreement, the county will take over roughly \$110,500 in annual operating costs for Gibson Ranch, including an estimated \$53,000 for utilities, including sewer and water quality certification; between \$5,000 and \$7,000 to maintain and repair the wells on the property, and provide Ose with a \$50,000 annual contribution toward reimbursements for capital improvements and deferred maintenance.


An original request by Ose to raise additional revenue through a hike in the park’s entry fee

from \$5 to \$8 was not something the entire board would support. The hike was removed from Ose’s proposal and the entry fee will not be raised, Ose said.

County Supervisor Sue Frost, who was among those opposing the entry fee hike, called the agreement a “rare win for everyone involved.”

“The county gets to have a jewel of a park for a smaller price than everything comparable in the county, and the residents of the community get to continue enjoying the park for the same fee as they are used to paying,” Frost said. “I’m extremely pleased with how this worked out.”

The new agreement also calls for the county to install an automatic pay station in the park, which could net the county additional revenue of between \$7,000 and \$10,000 annually. ★

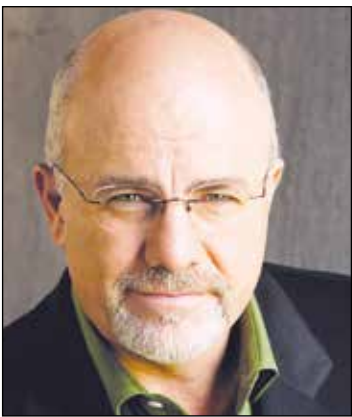

### You can't fix it for her

My younger sister recently received a tax bill from the IRS for \$30,000. I love her to death, but she's extremely irresponsible with money and in debt up to her eyeballs. I know how you feel about debt, and I've tried to teach her how to handle money, but considering her situation — should I take out a home equity loan of \$30,000 to help her?

Dear Toni,

Absolutely not! Does that mean

you don't love her and care about her? It does not. But you told me she won't behave with money. You don't give money to people who won't behave with the stuff. That kind of behavior doesn't help anyone, and it doesn't fix the problem. It's like giving a drunk a drink.

"Help" would be aiding this lady in changing her ways when it comes to finances. If you just give her a fish, it will stink and go bad. You have to teach her to fish. That attitude is not about being mean to her, it's just where she is in her life. She needs to be educated, not enabled. And it doesn't mean she's a bad person, either. It just means you can't endorse negative behavior or participate in her denial.

Keep trying to teach her, and pray for her. Make sure, too, that she's in contact with the IRS about a payment plan. I know she's your little sister, but you can't fix this one for her. Sometimes the best help you can give someone is to help them change their behavior. That way, they will hopefully learn how to carry their own weight.

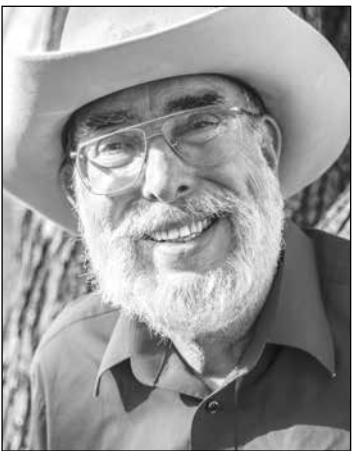

# Triple Your Taxes for the Fourth of July?

**SACRAMENTO REGION, CA (MPG) -** Are you ready for California to double your taxes? What about triple or quadruple them? A bill currently making its way through the state Legislature could push tax rates up beyond imagination, making us tax serfs to the state, and driving hundreds of thousands of jobs out of California.

Senate Bill 562 (SB 562), the “California Healthcare for All Act,” proposes to ban private insurance coverage and force every citizen in the state into the equivalent of the Medi-Cal system we provide for the poor and disabled, where state-provided healthcare would be the only option. The costs would be staggering.

A recent analysis by the California Senate Appropriations Committee estimated that implementing SB 562 would set back California taxpayers \$400 Billion. This year’s general fund spending – including roads, schools, universities, prisons and more

– is estimated around \$124 billion. In a highly-taxed state that just recovered from years of massive deficits and still teeters on the edge of fiscal ruin, where is this additional taxpayer money supposed to come from? Four hundred billion is more than \$10,000 a year from every man, woman and child in the state. Do most California families have that kind of money laying around?

That extraordinary cost is consistent with estimates from other states and is the major reason that single-payer schemes have been voted down or abandoned before implementation. New York state is currently proposing its own SB 562. In 2019, when New York’s plan would be active, the state expects to collect \$82 billion in taxes, but would need another \$91 billion to pay for its single-payer scheme. New York, as is the case with California, will more than double its overall revenue. See a trend?

And that \$91 billion number might be charitable. An analysis by healthcare expert Avik Roy concluded that New York’s plan could cost \$226 billion a year, nearly quadrupling the state’s current tax collections, just to pay for healthcare, not government’s other responsibilities. Roy estimates that the plan would jettison 175,000 jobs from the state, as “high-wage, high-value industries move to neighboring states” as a result. California, a much larger state, could shed hundreds of thousands of jobs under SB 562’s crushing fiscal mandate.

California’s plan also proposes to pay for all care for all residents, regardless of whether they are in the state

illegally, or whether they are here legally but just moved here to take advantage of the state’s “free” medical care. California, already the king of the tax dollar giveaway, would become the hot new destination for immigrants and indigents seeking care, driving the costs even higher.

And, even if the costs were not fantastically, impossibly high, SB 562 presents other problems for California healthcare. Our state suffers from a shortage of healthcare providers, particularly in rural and inner-city areas, a condition that would only be intensified by the provider rate caps in the bill.

Single-payer systems are also prone to deadly wait times since they ration care to reduce costs.

The United States is a medical innovator and California is the nation’s bioscience hub. That will disappear in the price-controlled, socialized system California legislators are trying to dump on the people. Price caps, a key component of single payer plans, spell doom to medical innovation.

Remaking the entire healthcare system is a terrible idea if the reform is going to make healthcare slower, less innovative, and wildly more expensive.

SB 562 is an ill-advised plan with unpayable costs that would make California taxpayers sick.

# CDPH Notifies Public of Salmonella Infections Linked to Contact with Live Poultry

**SACRAMENTO REGION, CA (MPG)** - The California Department of Public Health (CDPH) is warning people of the risks of Salmonella infection associated with contact with live poultry. The U.S. Centers for Disease Control and Prevention (CDC) reported that from January 2017 through May 25, 2017, 372 ill persons in 47 states have been infected with several Salmonella strains that have been linked to live poultry contact; 36% are children younger than 5 years old. Seventy-one ill persons have been hospitalized and no deaths have been reported. Infected persons include 21 California residents from 15 counties. Salmonella symptoms include diarrhea, fever, and abdominal

cramps, and usually begin 12 to 72 hours after a person has been infected. Most infected people recover within a week without treatment. However, some people may have severe illness that requires hospitalization. Young children, older adults, and people with weakened immune systems are at highest risk for more severe illness. Outbreaks linked to contact with live poultry have increased in recent years as more people keep backyard flocks. Live poultry, especially baby chicks and ducklings, may have Salmonella in their feces and on their bodies (feathers, feet, and beaks) even when they appear healthy and clean, which can get on the hands, shoes, and clothing

of people who handle or care for the birds. Salmonella can get on cages, coops, feed and water dishes, bedding, plants, and soil in the area where the birds live and roam. If you have contact with live poultry: Always wash hands with soap and water after handling live poultry, their eggs, or anything in the area where they live and roam; Prevent live chickens, ducks, and geese from coming into the house; Do not allow children younger than 5 years to handle or touch live poultry and eggs without supervision and subsequent handwashing; Do not snuggle or kiss the birds; Do not touch your mouth, or eat or drink while near live poultry. # Sacramento County DA Reports



**Defendant Convicted of First-Degree Murder**  
DATE: May 31, 2017  
CASE: Ismael Cassiano (Case #15F03537)  
PROSECUTOR: Deputy District Attorney Andrew Smith, Homicide Unit  
Ismael Cassiano was convicted by a jury for the first-degree murder of Antoine Davis. The jury also found true the allegation that Cassiano personally used a firearm. Ismael Cassiano was living at Antoine Davis' home. On June 9, 2015, Cassiano got into an argument with a female during a barbecue. Mr. Davis intervened and got into a fight with Cassiano, who was then told to leave the house. Cassiano returned to the house later that night to confront Mr. Davis, and to ask for an apology for the injuries he received during their earlier altercation. When Mr. Davis refused to apologize, Cassiano shot him once in the chest, killing him. Cassiano faces a maximum sentence of 50 years to life in prison. Sentencing is set for July 21, 2017, at 9:00 a.m. in Department 32 before the Honorable Emily Vasquez.

**Defendant Sentenced for Robberies**  
DATE: May 12, 2017  
CASE: Ira Johnson (Case #15F04234)  
PROSECUTOR: Deputy District Attorney Jeff Hightower, Homicide Unit  
Ira Johnson was convicted by a jury for the second-degree murder of Rogelio Gastelum, and two counts of attempted murder. The jury also found true allegations that Johnson personally discharged a firearm causing death or great bodily injury. On July 12, 2015, Ira Johnson and his friends attended a party in North Highlands. When asked to leave, the group started a fight. Johnson and another unidentified man pulled out guns and fired multiple shots into the crowd of partygoers, killing Rogelio Gastelum. Two other victims were shot, but survived their injuries. Johnson faces a maximum sentence of 59 years to life in prison. Sentencing is set for July 21, 2017, at 9:00 a.m. in Department 41 before the Honorable Helena Gweon.

**Defendant Convicted of Gross Vehicular Manslaughter, DUI Charges**  
DATE: June 2, 2017  
CASE: Antonio Reddick (Case #13F07409)  
PROSECUTOR: Deputy District Attorney Kelly Clark, Vehicular Homicide Unit  
Antonio Reddick was convicted by a jury of two counts of gross vehicular manslaughter while intoxicated, driving under the influence of alcohol or drugs with great bodily injury, and hit and run.

**Defendant Sentenced for Attempted Murder**  
DATE: June 2, 2017  
CASE: Austin Scott (Case #16FE006988)  
PROSECUTOR: Deputy District Attorney Kimberly Macy, Vehicular Homicide Unit  
The Honorable Patrick Marlette sentenced Austin Scott to 15 years and 4 months in prison. On March 6, 2017, a jury convicted Scott of assault upon a peace officer, evading a police officer, felony hit and run causing serious permanent injury, and two counts of vehicle theft. However, the jury was unable to reach a verdict on the charge of attempted murder.

On November 4, 2013, Antonio Reddick was driving with his passengers, Cherion Robinson and Gregory Hunt. Reddick was stopped at a light at the intersection of Madison and Date Avenue. All of a sudden, Reddick drove into a car that was stopped next to him, hitting the front area of the car. He then proceeded to run the red light, and continued to run another red light while speeding and driving recklessly. Driving at a speed of approximately 80 to 90 mph, Reddick ran another red light and crashed into a car driving through the intersection on a green light. The force of the collision sent Reddick's car across several lanes and into a tree, killing both of his passengers. Ms. Robinson was pronounced deceased at the scene from a blunt chest injury. Mr. Hunt died several days later as a result of the injuries he suffered in the collision. The driver of the car Reddick hit in the intersection suffered serious injuries. Reddick also suffered injuries and was transported to a hospital. Analysis of Reddick's blood showed a blood alcohol content of .09 percent along with presence of marijuana and methamphetamine. The jury also found that Reddick had suffered two prior strike convictions in 2008 for robbery and attempted robbery. Reddick faces a maximum sentence of 103 years to life in prison. Sentencing is set for September 1, 2017, at 9:00 a.m. in Department 10 before the Honorable Laurel White. ★

On April 7, 2016, Scott was in Reno and took methamphetamine. He went to his mother's house, took her truck without her permission and drove to Sacramento. For an unknown reason, Scott stopped in the center median of westbound Interstate 80 between Madison Avenue and Greenback Lane. CHP Officer Michael Ericson was on duty and went to do a welfare check on the vehicle. Officer Ericson pulled behind the truck and turned on his lights and siren. Scott then suddenly put the truck in reverse, hitting Officer Ericson's motorcycle and ejecting Ericson. Scott then pulled forward, driving around the overturned motorcycle and running over Ericson's body. Witnesses followed Scott, who drove into a construction zone near Northgate Boulevard. Scott got a flat tire and abandoned the truck. He got into a running pickup truck at the site and left the scene. A Woodland CHP officer spotted Scott and pursued him. At one point, Scott did a sudden brake check on the officer, causing the officer to swerve to avoid a crash. The pursuit continued to Fairfield where a spike strip deflated Scott's tire and he was taken into custody. A blood sample was obtained from Scott and showed the presence of methamphetamine. Scott was awaiting retrial on the attempted murder count and agreed to plea to attempted murder. Scott also waived his rights to appeal any aspect of his case and he received no credit for the time he had already served in custody. ★

## Rancho Cordovan Named Flag Football Hall of Famer

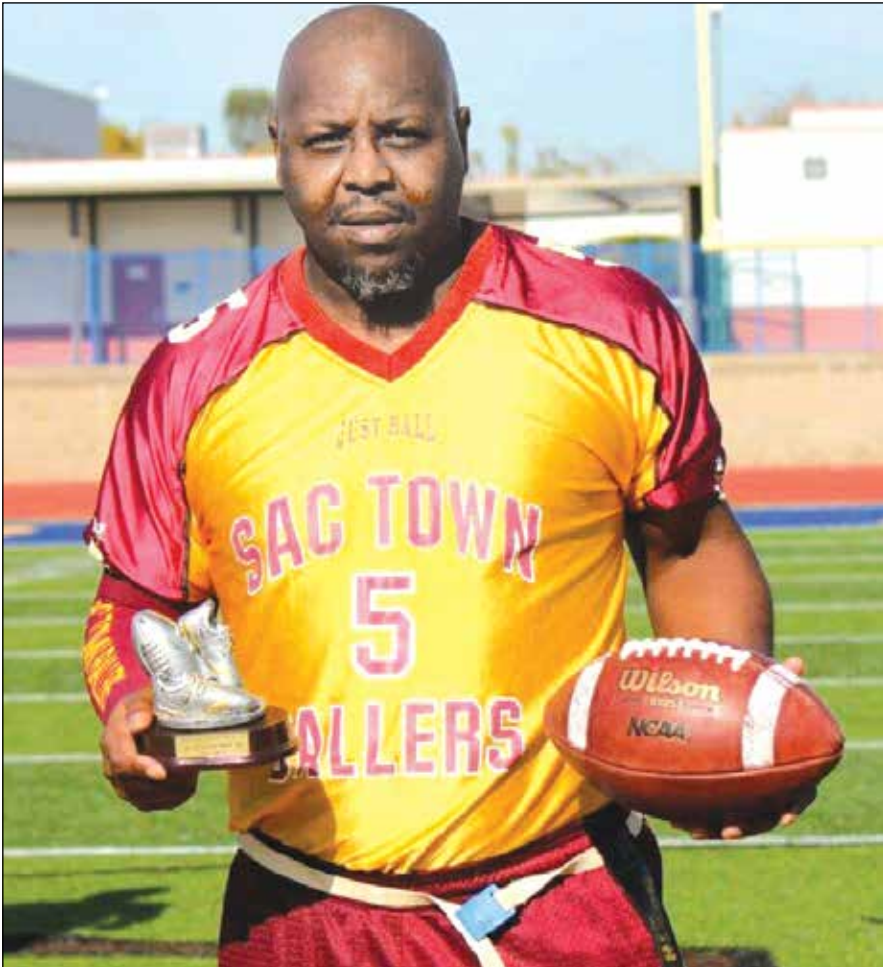
**RANCHO CORDOVA, CA (MPG)** - Willie Sloan first came to Rancho Cordova in the 1980s. Ever since then he has continued to be a presence in the sports circles of the City. After his mother read media accounts, the family purposefully moved to Rancho Cordova during the Cordova High football program's powerhouse days, specifically so Sloan could play here. Although it's been decades since Sloan played football at Cordova High School, he has remained an active and avid player, including making the switch from full contact to flag football. That dedication to the sport recently resulted in Sloan earning an inaugural place in the Central Valley Flag Football Hall of Fame. Sloan graciously gave the following in a recent interview.

**Q:** Please tell me about yourself. How did you come to Rancho Cordova, how are you still involved?

**A:** I came to the City of Rancho Cordova from New Jersey in 1982 via my father retiring from the Air Force. I also, still currently reside within the City of Rancho Cordova. I am involved in a few little things at the moment within the community of Cordova Villa, but I am always open and looking to be more involved within the community and/or City of Rancho Cordova. I am currently one of the organizers for what we call the "Villa Reunion." The Villa Reunion is a group of us from my old neighborhood who decided last year, that it would be nice for our community to organize, and try to bring the community together once on year (1st weekend in June) for a community reunion and barbeque picnic. This year, after a successful year last year, will be our second year.

**Q:** How did you become involved in sports here and what was the experience like for you?

**INTENT TO GRANT AN EASEMENT**  
**FOLSOM HIGH SCHOOL**

**WHEREAS**, California Education Code Section 17557 provides that the governing board of a school district, by a 2/3 vote, must state its intention to grant an easement.

**NOW THEREFORE, BE IT RESOLVED** by the Board of Education of the Folsom Cordova Unified School District:

1. That it is the intent of said Board, pursuant to Sections 17556, et. seq., of the Education Code of the State of California, to convey an easement to 2ASJ Company, LLC, a California Limited Liability Company for storm drainage.
2. That a public hearing will be held at 6:00 p.m. on Thursday, June 15, 2017, at the Education Services Center, 1965 Birkmont Drive, Rancho Cordova, California, on this question, and any and all persons interested may appear.
3. That pursuant to Education Code Section 17558, this Resolution shall be published once in *The Grapevine Independent*, a newspaper of general circulation, printed and published within the school district, not less than five (5) days before the date of said meeting.
4. That copies of this Resolution shall be posted in three (3) public places in said school district, not less than ten (10) days before the date of said hearing.

**THE FOREGOING RESOLUTION** was passed and adopted at the meeting of the Governing Board of the Folsom Cordova Unified School District on June 1, 2017.
