Back to the 80's Store Has Expansion in Its Future

RANCHO CORDOVA, CA (MPG) - 1980's memorabilia is so hot, just one year after opening its doors Rancho Cordova's Back to the 80s Store & More is preparing for the future with a fall relocation and expansion to accommodate a larger collection, as well as a new retro video game arcade for all ages during the day and a 21-and over nightclub.

"It's been an amazing year," says Christopher Knecht, 39, who opened the store in March of 2016 after a industry. His store's success mirrors what's going on across the memorabilia sector nationwide. While clothing, jewelry and housewares are losing some market share to online retailers who can offer fast shipping and steep discounts, brick and mortar memorabilia stores remain somewhat insulated. Sales for the store tripled in the first three months and have increased 30 percent in the last

SACRT Offers Free Transfers for Connect **Card Users**

SACRAMENTO, CA (MPG) - With a unanimous vote, the Sacramento Regional Transit District (SACRT) Board of Directors approved a pilot program to provide a free 90-minute transfer option to passengers who use a Connect Card, the region's new smart card fare payment system. The transfer option will be available to customers beginning on Thursday, June 15, 2017, marking the official launch date of the new Connect Card system.

RideSacRT, the agency's mobile fare app, has included 90-minute transfers since its rollout in January 2016. The new Connect Card is expected to be more widely used since the initial cards will be free, whereas the mobile app requires a smart phone. Transfers on the Connect Card will be good for unlimited boarding within a 90-minute period on both bus and light rail, just like the mobile fare app. The free transfers are expected to help generate additional ridership.

Connect Cards can be loaded with transit passes and stored value online, SACRT's Customer Service and Sales Center located at 1225 R Street, and at participating retail outlets. Customers who prefer to pay with cash will also be able to receive the benefits of the 90-minute transfer by simply loading cash onto their Connect Card at SACRT's Customer Service and Sales Center, and at select retail outlets, including Raley's/Bel Air markets in mid-June when the Connect Card officially launches.

The Board action comes on the heels of news that fare revenue has increased by 18% over the past nine months, despite a decline in ridership. The revenue increase is being attributed to SACRT's fare enforcement efforts, which has successfully reduced SACRT's fare evasion rate from more than 15% a year ago, to just 5% now. "SACRT staff has taken every measure to ensure that our trains and buses are cleaner and safer than ever before," said Henry Li, General Manager/CEO. "Fare enforcement efforts have reduced the number of non-fare paying passengers and increased the security presence throughout our system. It's a win for everyone"

Bus agencies throughout the Sacramento region are also adopting the Connect Card in order to provide seamless travel for passengers transferring from one bus line to another. The free 90-minute transfer will be available for six months, while the agency conducts an equity analysis.

The Connect Card and the RideSacRT mobile fare app will make it more convenient to ride by providing online sales, speeding up boarding times and removing the worry of having exact cash to pay fare.

Other ridership initiatives that SACRT is working on include improving service reliability; optimizing bus routes to make them reflect 21st century commuting patterns. Source: RT Media

Rancho Cordova: Fastest Growing **City in Sacramento County**

RANCHO CORDOVA, CA (MPG) - A recent report by the California Department of Finance listed the City of Rancho Cordova as the fastest growing city in Sacramento County last year. In 2016, Rancho Cordova's population grew by 2.2% from 72,203

City officials expect the population to continue to grow with families and professionals from diverse backgrounds moving to Rancho Cordova. Hundreds of new homes are being constructed, and with Rio Del Oro and other projects, the City has plans for the construction of thousands of homes for the future. The City of Rancho Cordova also estimates that 20 new schools will be constructed over the next two decades, which officials say is one reason parents, and future parents, are attracted to Rancho Cordova.

can't get online," said Knecht. "They can buy stuff on eBay or another site, but customers tell me all the time they love buying in person because they want to see what we have and have a personal experience of nostalgia, not just for themselves but also with their kids."

The store offers a vast collection of 1980s era collectables, including band posters from the likes of Duran Duran and The Bangles, walls of plush E.T. toys and others from the era, replicas of Pee Wee Herman's fuzzy blue chair, Star Wars memorabilia, vintage T-shirts, retro jewelry, sunglasses and other totally awesome accessories, as well as trading cards, toys, candy and drinks. On third Saturdays, the store features a parking lot party with celebrity guests, art, cover bands, food trucks and a costume contest.

Knecht has secured a lease for a 4,000 square foot space near the current location. He's planning for a fall grand re-opening and will be significantly expanding his memorabilia collection. But the new space will be more than just a store. Knecht is bringing in roughly 60 vintage arcade games, including Pac-Man, Ms. Pac-Man and old school Xbox with dual controls, and will be running the space as a family arcade and store during the day for all ages. There also will be TVs throughout the new store, blasting out retro music videos and classic cartoons, as well as a Slush Puppie machine.

"You gotta love the original Slush Puppy," Knecht said.

After 9 p.m., the store and arcade will shift to a 21-and-over music venue called "Club Retro" with a full bar and live bands dedicated to the era. Berlin, perhaps most famous for its break out hit "The Metro," is already signed on for a performance, and there are plans for monthly concerts with other heavy hitters, such as Tears for Fears and The B-52s, as well as weekly gigs featuring 80s tribute bands.

"I am reliving my own youth in this adventure," says Knecht, who explained he got his start in the shop when his father passed on a collectables business to him after inheriting an antique business from his father before him. "My grandfather really started all of this, and then my dad took it over. He would buy antiques and vintage stuff, but he also would buy us toys and things as kids, and when he did, he often bought two of them. That's how the collection started growing."

When Knecht took over the business from his father he knew he wanted to focus on the era of his own youth. The collection in the store is only a fraction of what he and his father amassed and the collection changes weekly. With sales as brisk as they are, Knecht said he's more than ready to move to larger digs.

"We have already been working with the city for permits and they have been just great to us," Knecht said, adding that the current location will remain open as construction and final touches are put on the new store and club, which he anticipates will happen in late fall.

"We hope to be up-and-running in the new location in November."

While sales have far exceeded his expectations, Knecht said the store is truly a labor of love. To be able to expand and take the business to a new level, he says, are simply icing on the cake.

"I didn't put any of this together to get rich," Knecht said. "I'm doing this to create an experience. If I can get someone to say to me that they were having a rough day but that coming into the store brought a smile to their face, that's what makes it all worthwhile for me."



It's Spare the Air Season

SACRAMENTO REGION, CA (MPG)

- The Sacramento region's 23rd Spare The Air season starts May 1. Each summer, the Spare The Air campaign educates the public about the health effects of air pollution and asks residents to drive less when a Spare The Air alert is issued due to poor air quality.

Residents in the Sacramento region are urged to pay attention to the daily Air Quality Index (AQI) by downloading the free Sacramento Region Air Quality app. It's available in iOS, Android and Windows app stores. Users get the daily air quality forecast, current air pollution readings for Sacramento, Placer, Yolo-Solano and El Dorado counties, as well as Spare The Air alerts and wildfire smoke advisories when issued.

The AQI keeps the public informed about how clean or

polluted the air is in their communities. The chart has six categories: Good (green), Moderate (yellow), Unhealthy for Sensitive Groups (orange), Unhealthy (red), Very Unhealthy (purple), and Hazardous (maroon).

Some people are more vulnerable to the health impacts of air pollution, including children, because their lungs are still developing; older adults and the elderly; pregnant women; and individuals with heart or lung disease, especially asthma. Even if you are healthy, air pollution can cause respiratory irritation or breathing difficulties during exercise or outdoor activities.

Follow these tips to help reduce air pollution and protect your health this summer:

 Reduce your driving – postpone at least one trip, especially on a Spare The Air day

- Garden green avoid using gas-powered lawn mowers, leaf blowers and other garden equipment
- Link your errands into one big trip to lower pollution by reducing cold starts of your car engine
- Work from home get employer permission in advance
 Bring your lunch to work
- Use an electric starter or chimney briquette starter instead of charcoal lighter fluid to start your barbecue
- Postpone outings on gas or diesel-powered boats, trail bikes or all-terrain vehicles because they are high pollution sources
- Take public transit, walk or bike for commute, errands and recreation

City of Rancho Cordova Seeking Applicants for Vacant City Council Seat

The City of Rancho Cordova is seeking applicants to fill a vacant City Council seat. Council Member Dan Skoglund, who had served on the City Council since 2004, passed away in April leaving a vacancy on the five-member City Council.

At the May 15th City Council meeting, Council Members voted to fill the seat through an application process which was launched as an online form on the City's website on May 16th. The City is accepting applications from Tuesday, May 16, 2017 through Tuesday, May 30, 2017 at 5 PM.

At the June 5th City Council meeting, applicants will be interviewed by the current City Council Members. The City Council will select and appoint one candidate at either the June 5th or June 19th City Council meeting. The City expects to swear in the new City Council Member on June 19th.

All applicants must be residents and registered voters within the city limits of Rancho Cordova. All applicants are required to disclose financial information and to file a Fair Political Practices Commission Statement of Economic Interest. The application form is located on the City's website at http://www.cityofranchocordova.org/departments/city-clerk/elections.

RANCHO CORDOVA, CA (MPG) - The City of Rancho Cordova spends millions of federal, state and local dollars on public works projects annually, but several

large-scale projects have converged this year, making 2017 one of the biggest funding years for capital improvements the City has had to date.

Multiple projects, totaling

over \$15 million, are already under construction. The City expects several more multimillion dollar projects that are currently in the design phase to begin construction within the year, accounting for a total of \$25 million in infrastructure improvements. The funding is designated primarily for street, sidewalk and traffic signal

One of the largest price tags belongs to the 2017 Street Rehabilitation Project that includes rehabilitating residential streets with new asphalt and making sidewalk and storm water upgrades in various neighborhoods. The \$4.2 million project, supported by the City's Community Enhancement Fund, will begin construction in May.

Other projects include repairing damaged or broken sidewalks in various locations to improve pedestrian walkability, and installing a new signal at the intersection of Justinian Drive and Sunrise Boulevard to improve access and traffic safety to and from the Anatolia neighborhood and nearby parks. Landscaping and beautification projects, such as murals, are also planned for heavily traveled roads, including Sunrise and Folsom Boulevards.

"The significant investment the City is making demonstrates our commitment to creating walkable, connected neighborhoods and safe routes, while also beautifying Rancho Cordova," said City Manager Cyrus Abhar. 

At our City Council meeting last night, the last item on the agenda was for us to discuss and then direct staff regarding options for filling our City Council vacancy. We gave Dan's family, friends and colleagues time to grieve and show the respect he deserved. We had to decide at the May 15th City Council meeting though, because Government Code Section 36512 sets out the options and steps for how vacancies on the City Council are filled.

It requires the Council, within sixty (60) days from the date of the vacancy, to either fill the vacancy by appointment, or call a special election to fill the vacancy. This means the Council must call the election or fill the seat vacated by Councilman Skoglund by June 19, 2017. We could either have an application process or call a special election. The Sacramento County Elections Office informed our City Clerk that the cost of holding a special election to fill the seat would range from \$355,770.00 to \$711,540.00. This is based on the number of registered voters in the City (35,577). The City would be responsible

for the cost. The cost of a special election, the lost time before the election (October 3, 2017), and then the swearing in of the newly elected Council member

on November 6, 2017, would mean that we would have to wait for six more months before our new Council Member would be seated. That made it easy to drop the special election. We chose the application process. After those who submit the applications are interviewed, the one who is chosen and sworn in at the June 19, 2017 City Council meeting will be filling the vacancy within the 60 days according to the law.

The application is available on the City's website at http:// www.cityofranchocordova.org/ departments/city-clerk/elections, and those who wish to

fill it out can do so online. The applications must be returned to the City Clerk no later than 5:00 PM on May 30, 2017. Our City Clerk will be available to help in the process because like they say, "the devil is in the details." I will be putting more information in my column as time goes by because it is easy to miss something. And after you are done, you think how could I have missed "that" whatever "that" is.

And another thing, Memorial Day is coming very quickly, and while it is going to be at the VA Medical Center at Mather as it usually is, it will be in another location on the parking lot because of the construction and expansion of the older Mather hospital. Cordova Creek Naturalization Project Recognized

SACRAMENTO COUNTY, CA (MPG) -

An important project to improve the nature of urban runoff in the Cordova Creek area has been overseen for the past two years by the Department of Water Resources and Department of Regional Parks. The Cordova Creek Naturalization Project is designed to restore the creek, develop recreational use, and offer a nature study area.

This unique concept has caught the eye of Sacramento Environmental Commission, which awarded the project an award for demonstrating "outstanding environmental stewardship" on April 17.

The Cordova Creek Naturalization Project gave the area a much-needed face-lift by

removing an existing trapezoidal-shaped concrete channel, and replacing it with a natural winding channel that complements the current land use. It also offers a functioning, living stream that improves the environment.

This wasn't an easy fix. Due to the size of the project, it was divided into two phases. The first phase began June 2015 with the second phase starting April 2016, and has transformed the creek into a natural riparian corridor. The new design includes reintroducing native trees, shrubs and groundcover along the stream banks, wetland areas and surrounding uplands. The Cordova Creek Naturalization Project augments 80 acres of recently restored riparian woodlands and native grasslands to the west, and the 50-acre Soil Born Farm and native plant

nursery to the east. This includes a walking trail with interpretive signs to provide the public access from the Dedo Way River Access to the American River Parkway.

The Project was developed by a partner group, including Sacramento County Departments of Water Resources & Regional Parks, Water Forum, Sacramento Area Flood Control Agency, City of Rancho Cordova, Soil Born Farms and California Native Plant Society.



Our son is 13, and he wants to give half the money he received for his birthday to the nursery at our church. They need new baby toys and things like that. Should we let him give that much, or should we tell him that maybe 25 percent is enough?

Dear Kyle,

I hope you're proud of this kid. He's a got a good heart, and it's probably a reflection of the way his mom and dad are raising him. I like

I would very gently, and without any commanding or control verbiage, use some examples from the Bible when talking to him. There are several things to be learned about money from Scripture, and the concepts of generosity and giving are in there. There's also a verse that says we need to take care of our own households first. Another one says in the house of the wise are stores of food and oil.

We need to do all of these things with money — in balance. Thoughtfully and prayerfully decide what your giving amount will be, so that you don't destroy your ability to save and do other important things. Talk to him about these concepts, then ask him to wait two or three days and think about his decision.

If he comes back and says he still wants to give half of it, I would encourage him to do so. But slow things down a little, and make sure this isn't a knee-jerk reaction. You need to be a wise giver, not an impulsive giver!

My husband and I are currently in Baby Step 2, and paying off all our debt except for our home. A friend recently told us to pay off everything except for the credit card debt. She says we can then settle for a far less amount and not have so much money going out the door. This feels a little unethical to me. What are your thoughts?

There's a good reason this idea feel unethical to you - it is unethical! Would a good friend, a smart friend, encourage you to do something as dishonorable as not pay a bill you're morally and legally obligated to pay? I don't think so.

If you're able to pay your bills, you pay your bills. It's as simple as that. Now, if you honestly can't pay the bill, and you have to settle upon a mutually agreed upon amount with the creditor or collector, then it's okay at that point to try and reach a settlement.

Otherwise, it's a simple question of ethics. Pay the bill!





The Problems with a Carbon Tax



Commentary by Merrill Matthews

While President Donald Trump wants to cut taxes, there are others who hope to raise them -- by taxing carbon.

The idea has long been supported by environmentalists and left-leaning groups, but

among some establishment ory says that corporations Republicans. The notion is that don't pay taxes, people do. by taxing carbon, the country would use less, reducing our to consumers in the form of impact on climate change.

However, there are a number of problems with the plan.

There is no viable alternative to carbon-based fuels. The goal of a carbon tax is to force people to embrace substitutes, but fossil fuels are one of the most inelastic products. There just aren't any viable and scalable alternatives.

If the price of gasoline were to rise significantly because of a carbon tax, some people would carpool or take public transportation, but the vast majority would just have to suck it up and pay the higher

Companies pass along taxes higher prices.

Because we would still have to use fossil fuels for the vast majority of our travel, transportation and power generation, a carbon tax would simply be priced into virtually every product and service.

Food must be harvested, processed and transported to grocery stores. Clothes and consumer goods must be manufactured and transported to retail outlets or to consumers' homes. Planes, trains and longhaul trucks cannot run on solar or wind power. Neither can our military.

While many power gener-The price of everything ating plants use renewable energy from wind and solar power, those renewables only that you voted to get rid of is make up about 7% of power generation—and that's after throwing hundreds of billions of taxpayer dollars at renewables for decades.

Thus a carbon tax would have little impact on carbon use and a big impact on what we pay for everything.

For example, Norway passed a carbon tax in 1991. They concluded, " the carbon tax effect on emissions was modest. ... This surprisingly small effect relates to the extensive tax exemptions and relatively inelastic demand in the sectors in which the tax is actually implemented."

The good news is that

the U.S. has been reducing energy-related carbon emissions without a carbon tax. U.S. Energy Information Administration announced last October that energy-related carbon emissions for the first six months of 2016 were down to their lowest level since 1991. That's in large part because fracking has made natural gas a cleaner and more affordable option than coal.

The country needs policies that help the U.S. become more competitive. Lowering the tax burden is the best way to achieve that goal.



Defendant Sentenced for 1997 Sexual Assault

DATE: May 1, 2017

CASE: Joseph Brian Cox (Case #15F00096) PROSECUTOR: Deputy District Attorney Matt Chisholm, Adult Sexual Assault Prosecution

The Honorable Marjorie Koller sentenced Joseph Brian Cox to 20 years in prison. On March 15, 2017, Cox pled guilty to three counts of forcible digital penetration and two counts of forcible rape.

On the morning of May 20, 1997, Joseph Brian Cox unlawfully entered the home of the then 14-year-old victim, her mother and her 11-yearold sister. Cox wore a mask and held the family at gunpoint. He proceeded to bind the hands and feet of the victim's mother and sister with rope and tape. He also bound the victim's hands before forcibly sexually assaulting her in her bedroom. After the assault, Cox smoked a cigarette in the victim's room. He then looted the house for cash and valuables before fleeing. The assailant could not be positively identified because he was masked during the crime. Initial DNA testing of items found at the scene did not yield significant results and the investigation stalled pending further leads.

The Sacramento County Sheriff's Cold Case Unit continued to work the case. As DNA technology advanced, items they submitted to the District Attorney's Crime Lab for testing resulted in a hit to Cox. The most significant DNA matches were found on the cigarette butt recovered from the victim's bedroom and a roll of tape recovered from the scene that was used to bind the victims.

Defendant Convicted for Murdering Wife

DATE: May 3, 2017

CASE: Justin Jesus (Case #15F07687) **PROSECUTOR:** Deputy District Attorney Shelly

Justin Jesus was convicted by a jury for the firstdegree murder of his wife, Elizabeth Masters. The jury found the allegation that Jesus used a knife in the commission of the murder to be true. Jesus was also convicted of felony domestic violence, including allegations that he inflicted great bodily injury and used a deadly weapon.

Jesus had a history of domestic violence, and in the course of their tumultuous relationship, Ms. Masters left their home to stay with her family in Folsom. Approximately one week later on December 20, 2015, Jesus showed up at Elizabeth's parents' home in Folsom. Elizabeth Masters and Jesus left the Folsom home around midnight. Several hours later, family members heard a commotion outside

and found Jesus in the backyard holding a knife. Soon after, the family discovered Elizabeth's body on the side of the house, buried under a pile of leaves. Elizabeth had been stabbed numerous times including severe lacerations to the neck. Jesus was apprehended by law enforcement a short distance away, and in possession of the murder weapon.

Jesus faces a maximum sentence of 26 years to life in prison. Sentencing is set for May 18, 2017, at 9:00 a.m. in Department 20 before the Honorable Michael

Defendant Pleads Guilty to Attempted Murder of His Children

DATE: May 5, 2017

CASE: Charles Ewers (Case #15F02083)

PROSECUTOR: Deputy District Attorney Quirina Orozco, Special Assault & Child Abuse Unit Charles Ewers pled guilty to two counts of attempted murder and admitted two enhancements for causing great bodily injury and use of a deadly

On April 4, 2015 at 9:24 p.m., Sacramento Sheriff Deputies responded to Ewers home after receiving a call from his estranged wife who was concerned about her childrens' whereabouts as Ewers had failed to return them at the agreed upon time. Deputies heard the sound of a running car motor from the garage. They forced entry into the garage where they found two children in the car, ages 8 and 10, with bloodied head and faces. There were yellow hoses connected from the exhaust pipe that led into a small opening through the rear passenger window. Deputies immediately removed the children from the vehicle while Charles Ewers remained in the car in the driver's seat with a replica airsoft gun on his seat before he was later removed.

Ewers admitted to deputies that he had given his children Ambien to make them drowsy and had planned to suffocate his children by carbon monoxide poisoning. When they failed to get drowsy, he used a mallet to strike them each repeatedly on their heads, causing them extensive injuries to their head and bodies. After physically assaulting them, he then forced the children into his running car where he told the children they were all "going to Heaven."

When questioned by law enforcement, Charles Ewers stated, "I am in control. I am not in a rage. I am in control and I am sad that it didn't work out. If I could try again, I would." He later explained that he had planned the act for several months and was looking for the "right time" to do it.

Ewers will be sentenced to 22 years to life in state prison. Sentencing is scheduled for June 6, 2017 at 8:30 a.m. in Department 63 by the Honorable Jaime Roman.



Jerry Brown's New Budget Includes Millions **To Defend Illegal Aliens From Deportation**


Last week, California Governor Jerry Brown unveiled his May revisions to the state budget proposal he rolled out in January. Buried deep among billions of dollars in proposed new spending are millions of dollars for the state to provide criminal defense for illegal immigrants in California who are facing deportation to their home country by our own federal government.

Apparently the governor is proposing to put taxpayer money where his mouth is, following up on his bold statement last January in his State of the State speech to the California legislature: "Let me be clear: We will defend everybody - every man, woman and child - who has come here for a better life and has contributed to the wellbeing of our state."

It is certainly controversial, to say the least, for a state government, within the United States, to start providing taxpayer dollars to fight efforts by the United States to deport people who have entered the country, or overstayed their visas, in violation of the law.

To find this controversial spending proposal, just in the summary document of the budget, you have to comb through to the Department of Social Services section, and then read all of the way through to page 38, in the Health and Human Services subsection - where you find under "Immigration Services" an increase of \$15 million to \$30 million "to further expand the availability of legal services for people seeking, "...deportation defense...".

President Donald Trump ran and was elected on a platform of cracking down on illegal immigration. Trump's Attorney General, former Senator Jeff Sessions (R-AL), has been carrying out the President's promises by focusing federal law enforcement resources

on cracking down on illegal immigration.

The Trump administration's focus on this issue, conversely, has been a rallying cry for the progressive Democrats that control the levers of political power in California. Legislation authored by State Senate President Pro Tem Kevin De León (D-Los Angeles) to make California a "sanctuary state" is rapidly advancing through the legislative process. In addition, the state legislature has produced stinging anti-Trump resolutions. Last week, it was announced that the California legislature extended a controversial contract for former Obama-era Attorney General Eric Holder and his law firm, at \$25,000 per month, focused on taking an aggressive posture against the Trump administration.

Sacramento Democrats are not the first to engage in this very aggressive funding of efforts to stymie federal immigration enforcement. Several large cities around California with Democratic mayors and city councils have already entered into this space.

Last December, Los Angeles Mayor Eric Garcetti announced the creation of the "L.A. Justice Fund" to include \$5 million in taxpayer funds, saying that the city would fight for and, "...

reach out to people who are American by every measure except the papers they hold...".

(Earlier this year, the Los Angeles City Council also unanimously passed a resolution calling on the President to be impeached.)

In February, San Francisco Mayor Ed Lee allowed the city's Public Defender's Office to use more than \$200,000 in savings from the city's budget to hire additional staff attorneys for the defense of illegal immigrants facing deportation.

Most recently, earlier this month, at the request of Sacramento Mayor Darrell Steinberg, the city council of California's capital voted unanimously to make \$300,000 of city funds available to assist a network of legal, education and non-profit groups help illegal immigrants facing deportation.

In yet another example of the high priority that Governor Brown places in "taking on" the policies of the federal government and President Trump, he has also proposed increasing the budget of California Attorney General Xavier Becerra to support a stream of lawsuits challenging executive orders of the President. The revision to the Attorney General's budget includes funding for 19 attornevs and 12 other staff members.

There is no doubt that Democrats in California are on the "tip of the spear" in taking on the policies and directives of the newly elected Republican president. Frankly, in and of itself, that is not so surprising.

But what is controversial to say the least is the fact that tens of millions of dollars are being spent, so far, by the State of California and some of the state's largest cities to wage public relations and legal battles against the federal government.

Reaching a national audience on May 10th from Sacramento, BBB, local victims and leaders of two security industry associations joined forces to alert consumers, along with ADT, a leading home security company, BBB Accredited Business and National Partner.

"Consumers should feel safe wherever they are," said Mary E. Power, president and CEO of the Council of Better Business Bureaus. "When a con takes advantage of people, literally at their front door, it poses a significant challenge. We appreciate the industry taking a lead on helping BBB address these deceptive sales tactics."

BBB was represented today at the Sacramento event by Lynn Conner, interim CEO of BBB serving Northeast California, who echoed Power's thoughts: "We hope our outreach will educate consumers on what to do when they encounter someone using deceptive sales tactics at their front door."

In 2016, over a half million consumers across North America used BBB resources to research information about home security

companies. But thousands also complained about dishonest and misleading sales pitches.

Speaking out today was victim Marie Marshall. The 86-yearold was deceived into switching her ADT service to another company which the salesman falsely claimed was affiliated with ADT. Marshall is now in a 60-month contract with that company, paying a higher monthly rate.

"By the time I realized I had signed with another company, it was too late," said Marshall. "I am very disappointed that I got duped into doing business with a company that practices deceptive sales."

BBB shared tips for consumers who are considering a home security system (bbb.org/homesecurity), and also released advice to potential employees who are being recruited to spend their summers knocking on doors (bbb.org/alarmsales).

"We urge those who are selling security systems to abide by the BBB Standards for Trust," said Conner. "Tell the truth, honor promises, and embody integrity."

Jay Hauhn, Executive Director and CEO, The Monitoring Association said "We are in the life-safety business where credibility is incredibly important. So, it pains me, greatly, to hear about how a few unscrupulous sales reps are giving a black eye to an entire industry that I dearly love. Cleaning up our industry is job one. We're making progress and getting our messages out. Some companies like ADT and Protection One are leading the way by fighting deceptive sales through legal action in a court of law and through PR opportunities in a court of public opinion."

Merlin Guilbeau, Executive Director and CEO, Electronic Security Association said "The ESA Code of Ethics and Standards of Conduct are our industry's stake in the ground. It says that you cannot be a member of our association if your company engages in deceptive, misleading, unlawful or unethical business practices. It is our expectation that ESA members will take this code seriously and continually make it part of their company's culture and way of doing business. It is also our expectation, that if there is a failure other ESA members and consumers will take the appropriate steps by following the process outlined in the code and file a complaint so that ESA may take appropriate action. Let's be clear... we are NOT 'knocking' doorknocking. Door-to-door selling is a very effective tool, practiced for decades in our industry. But it needs to be practiced the right way, with honesty and integrity."



RANCHO CORDOVA, CA (MPG) - The Agricultural Academy at Cordova High School, in its sixth year, focuses on career readiness within the agriculture industry. Learning about agriculture is not all that the students get from joining Future Farmers of America and being part of the Academy. "I don't think people understand how much of a bond you create with the people you're with," said sophomore Agnes Budge. "It's an amazing experience."

This year and last students have been raising animals to show and sell at the Sacramento County Fair. Four students are raising goats this year: Agnes Budge, 15, McKenzie Emery, 17, Tabitha Hoyt, 18, and Faith Lipanovich, 17. The goats are a special challenge, said the students, since they seem to have minds of their own and very definite opinions.

Agnes joined FFA and entered the Agricultural Academy as a freshman. Last year she raised and sold a meat rabbit.

McKenzie Emery is a senior, and hopes eventually to go into agricultural law. "Without agriculture we wouldn't be able to eat, and especially California agriculture, it's so, so important," McKenzie said.

Tabitha Hoyt is a senior, and not sure of her post-graduation activities, but plans to work while she considers the possibilities. "I love animals," Tabitha said. "I just like being around them, handling them."

Faith Lipanovich, 17, will attend Folsom Lake College in the fall and is aiming toward a degree in zoology. "I want to get a general degree with animals, so that I have the ability to work in any field involving animals," Faith said. She is also into roller derby.

Those who are raising rabbits this year are: Kimberly Griffin, 16, Nick Haro, 15, Kaitlyn Hoyt, 15, and Chris Nelson, 17.

The Agricultural Academy has two teachers. Bret Harnden, who started the program in 2011, is the lead. He grew up in Shingle Springs and earned his degree in animal science and education at Chico State University. Though the Academy started out with just 35 students its first year, now it serves 300. "We have enough students that we could have a third teacher at this point," Harnden said. "For the past couple of years we've had enough students where we're actually turning kids away.'

Teacher Jennifer Rossiter earned a biology degree from Sacramento State University and

recently attained a Master's degree in agriculture education. As a youngster she bred and sold swine on her parents' farm in Lincoln. Though the program includes considerable classroom work, it is about more than classroom learning. "(The students) learn responsibility, they learn time

management, they learn how to budget and take care of other animals," Rossiter said.

The opportunity to succeed in the program helps the students to see their own value. "That's kind of a validation," Harnden said. "They say, 'This is cool; I could be somebody, I can do something.""★
