

French Air Force's Elite "Patrouille de France" to Perform at Mather Airport April 15 event Honors 100th Anniversary of US Entering World War I



MATHER, CA (MPG) - America's oldest ally, France, is sending her world-renown aerial military jet demonstration team to Mather for one day only. The event is sponsored by the California Capital Airshow (CCA) and the City of Rancho Cordova for a single performance on April 15th.

This stop is part of a limited tour by the French Air Force to honor the 100th Anniversary of the United States entering into World War I. It also corresponds to the upcoming centennial celebrations honoring the opening of Mather Field, which would later become Mather Air Force Base.

Rancho Wins Place Among Best Green Career Cities

RANCHO CORDOVA, CA (MPG)

- The City of Rancho Cordova was recently awarded a top ranking as one of America's 2017 Best Cities for a Green Career by datacrunching company Good Call. Rancho Cordova ranked 35 out of 75, beating out neighboring cities of Folsom, Sacramento and Davis, among other national contenders.

The initial candidate pool consisted of 192 cities across the United States. Good Call looked hard at state capitals and tech-rich areas that people may want to consider when looking for a "green" job. Half of the top ten cities were state capitals, and only one of those had fewer than 300,000 recorded

"These cities tend to be places where workers with a focus on the environment can make more money and where cost of living is lower, so that larger paycheck will also go further," according to ranking company. "Analysts included the metric on amenities per capita to weed out less desirable cities that might pay well or have lots of job openings but with few restaurants or things

Small cities fared especially well in the rankings. "Those at the top also tended to be small cities; only four cities in the top 30 had more than 300,000 residents and none in the top 10 had fewer than 100,000," Good Call states on its website.

Jobs and salaries were also leading indicators for comparison. Utilizing positions posted online at indeed.com, Good Call drilled down for city specifics. "Available jobs were found

based on a search of Indeed.com. Analysts searched for jobs that included 'Environmental' in the title and included these words in the description: conservation, science, scientist, geology, geologist, hydrology, or solar. Salaries were averaged for various environmental positions and expressed as a comparison to the overall average in each area."

Rental Property Inspections: No Harm, No Foul?

RANCHO CORDOVA (MPG)- For several weeks, one Rancho Cordova resident has been busy fighting city hall in an effort to resolve Rancho Cordova Code Enforcement ordinances that he feels are infringing on his Four Amendment Rights.

Michael Zechlin is currently a very unhappy resident. Several weeks ago Zechlin found a notice posted on his front door that his home had been identified by Rancho Cordova Code Enforcement (RCCE) as a rental property and had been scheduled for an inspection by a Code Enforcement officer. Zechlin phoned RCCE, explaining his house was owner occupied by him and was not a rental property. RCCE apologized and that was supposed to be the end of it.

A few days later however, Zechlin discovered a new notice from RCCE taped to his door, again stating that his home was a rental property and was scheduled for an inspection. Zechlin again contacted RCCE to remind them he lived in the home and was the owner. RCCE acknowledged the error and reiterated that it was in error and no inspection would take place. For Zechlin, this was too little too

"I have the right to live without fear of unreasonable search of my home or by having my privacy infringed upon." Zechlin commented, by referencing legal precedents he has come across. He cited the Fourth Constitutional Amendment, which guarantees citizens protection from illegal search and seizure. Zechlin feels the city of Rancho Cordova has overreached legal precedent, stating his assertion that the city "has to have 'probable cause' to enter a

cade of correspondence among Zechlin, the city, Code Enforcement and Rancho Cordova City Councilmembers, venting his frustrations and fears about the handling of his case, along with questions about how and why it occurred in the first place. Zechlin has even addressed the Rancho Cordova City Council in person during one of the recent Council meetings. He remains unmoved.

"The city attempted a warrantless search of my home under threat and intimidation. Had I not made issue of it they most certainly would have pursued the matter," Zechlin said of the incident.

"I was in fear of the city forcing their way into my home, taking legal action against me or placing a lien on my property. The fact that I was sitting at my desk and I saw someone tag the notice to my door and run made it seem even worse."

Zechlin's email trail indicates that city staff have acknowledged the error and offered formal apologies, but he maintains the notices were equivalent to Rancho Cordova making the assumption that he was violating code.

City Council Member David Sander, who has been Zechlin's primary correspondent with the city, addressed this in writing, stating: "There was never a finding that you were violating a code. There was an assumption made that your property was a rental because publicly available data. We do not inspect single family non-rental prop-

erty," wrote Sander to Zechlin. According to Maria Kniestadt, the Communications and Legislative Affairs Manager for the city of Rancho Cordova, the data used by the city to identify rental properties is provided

What has followed is a cas- by the Sacramento County Assessor's Office and is readily available as public information. The county records are based on who is listed as the owner of record for individual properties throughout Sacramento County. Such information is recorded and kept for each state. Sacramento and the state of California are no exception.

He does have ideas on what the city of Rancho Cordova could do to rectify his situation and protect other residents from similar unfortunate circumstances. "There needs to be some sort of oversight for the actions that Code Enforcement takes. There are apparently no "checks and balances" to restrict their unfettered access to our homes or neighborhoods. They are enforcing codes that for the most part have no purpose other than to generate revenue for the city. Additionally, they are the authors of the codes they enforce. Yes, it is important that we have rental properties inspected, but perhaps we need to find another mechanism for identifying those places. For that matter, whatever took the place of simply talking to the home owner before making assumptions in error?"

The city, he asserts, should, " Place Code Enforcement under the review of a third party separate of local government to audit their practices, institute a "sunset law" with respect to local ordinances that requires those ordinances over 2 years old to be reviewed by the same organization and dumped if ineffective or unreasonable to property owners (case in point the requirement to have a permit to paint your house number on the curb in front of your home).

Another potential problem Zechlin sees is his belief that Rancho Cordova is using

inspections to "generate revenue." He cites the city budgets from 2014-2015, which indicate over \$400 million in fines and forfeitures were reported.

"We actually lose money on our code enforcement activities," wrote Rancho Cordova Councilmember David Sander in an email to Zechlin. "Like other forms of public safety (police, fire, building inspection, animal control, etc.) there is no way to recoup what we spend. Fees or fines are rarely assessed and rarely collected. When they are, it is usually a large scale slumlord issue (think of the Stagger Inn, the First Value Inn, Cordova Inn, a crummy apartment complex, etc.). So we aren't pursuing public safety and law enforcement as a means to make money."

According to Sander's emails, there is a differentiation with regard to the city's policies on rental home inspections based on legal definition. "Because this is not a criminal matter, there is no need for "probable cause" or even the finding of a code enforcement violation. This is a business inspection of a residential rental business, to ensure that laws are being followed that the city has a legal and moral responsibility to uphold. There is no 4th Amendment issue here as a result. Rental property owners virtually always have access rights."

Sander continues, "Rental housing is subject to rental inspection unless the renting occupant refuses it. It's up to the renter unless there is an obvious external sign of a life threatening situation (like a roof caving in) that requires an inside follow-up - but that is true for any property and almost never happens.

Notice of Intent to Adopt an Initial Study/Mitigated Negative Declaration for the Capital SouthEast Connector D2 Expressway Project

WHAT'S BEING PLANNED?

The Capital SouthEast Connector Joint Powers Authority (Connector JPA) proposes to reconstruct Grant Line Road to an access-controlled four lane expressway with a center earth median and an adjacent Class 1 bike/pedestrian trail on the west side of the alignment. The project site is located along Grant Line Road from approximately north of the White Rock Road/Grant Line Road intersection moving south to approximately the Grant Line Road/Jackson Highway intersection, located in the City of Rancho Cordova's southeastern boundary with Sacramento County. The Connector JPA is the California Environmental Quality Act (CEQA) lead agency.

The proposed project is approximately 7.4 miles long and is part of the JPA's larger 34-mile Capital SouthEast Corridor project extending from El Dorado County near Highway 50 to I-5 and SR 99 in Sacramento County. The D2 Expressway will improve traffic operations, implement a transportation network to accommodate approved growth, and provide efficient and safe mobility options for regional and local access. This Project will also include utility relocation of existing electrical utilities, and accommodations for others to develop electrical, gas, water and sewer facilities owned by SMUD, Sacramento County Water Agency, Sacramento Area Sewer District, and Aerojet as needed.

The Project meets the goals of the Connector JPA Programmatic Environmental Impact Report (PEIR), which was approved in 2012. The goals of the PEIR include enhance mobility, safety and accommodate travel demand, which have been compromised by increasing congestion. The Project is intended to link employment centers and residential areas in the corridor and contribute to the remedy for current and future deficiencies in transportation capacity, safety, and land use compatibility. The proposed Project is planned to be phased in order to meet traffic demands for the next 20 years.

Pursuant to Section 15072(f)(5) of the California Environmental Quality Act Guidelines, it has been determined that the project site is not identified on any of the lists enumerated under Section 65962.5 of the California Government Code pertaining to hazardous wastes.

Bera Warns of Impact on Flooding, Drought, and Clean Energy Economy in Sacramento County



Do this with her for several months, while you keep one on the account, too. After that, I want her to do it alone and show you her work. Her balance should match yours and the one at the bank.







For sports fans, the Golf Channel presents "Jack," a three-part event beginning on April 9th capturing the spectacular career of Jack Nicklaus, one of the all-time greats who won a record-setting 18 major championships.

The central figure is Manfred (Francois Arnaud), a psychic who communicates with spirits and surrounds himself with both human and supernatural allies. Dylan Bruce's Bobo runs the local pawn shop and Parisa Fitz-Henley's Fiji runs the town's wiccan shop.

Everybody has secrets in the town of Midnight, but they have to band together as reluctant allies to fight off deadly biker gangs and other outside pressures. The series is based on books by Charlaine Harris, the same author who inspired the "True Blood" series on HBO.

edy, there may be few more classic than "It's a Mad, Mad, Mad, Mad World," starring a wide range of talent from Spencer Tracy to Jonathan Winters, Phil Silvers to Ethel Merman, and Mickey Rooney to Milton Berle, just to name a few.

Intelligence Reports Reveal Russia's Secret War against America's Fracking Industry

Recent intelligence reports show Russia is interested in influencing more than just America's elections. Russian President Vladimir Putin and his cronies have taken aim at undermining the U.S. energy

Buried within the U.S. intelligence community's report on Russian activities in the presidential election is evidence the Kremlin is financing and choreographing anti-fracking propaganda in the United States. By targeting fracking, Putin hopes to increase oil and gas prices, destabilize the U.S. economy and threaten America's energy independence.

Fracking, or hydraulic fracturing, is a drilling technique in which water and sand are pumped through rock at high pressure to release deposits of oil and natural gas.

Thanks to new technologies which make the process more efficient and environmentally friendly, fracking supports 4.3 million jobs and generates half a trillion dollars in economic benefit to the United States annually. Natural gas prices have dropped in half, saving American families \$200 a year on

Fracking is the major reason why the country is on pace to become completely energy independent by 2020. America relies on fracking to produce more than 1.5 billion barrels of oil yearly -- over half of

Russia sees all this as a threat. The Russian government, relying heavily on energy exports for revenues, is concerned "about the impact of fracking and U.S. gas production on the global energy market. "Increased U.S. gas exports create "potential challenges" for the profitability of Russia's stateowned oil and gas monopoly.

In response to America's growing fracking industry, RT, Russia's government-funded international media outlet, aired air a slew of dubious attacks against fracking -- ramming 62 anti-fracking television stories down viewers' throats in seven months.

This isn't the first time Russia has been accused of anti-fracking

In 2014, intelligence information led then-NATO secretary general to conclude Moscow conspired with environmental groups to block fracking activities in Romania, Lithuania and Bulgaria.

A U.S. Senate report found the Sea Change Foundation funneled over \$43 million to environmental causes, financing anti-fracking organizations like the League of Conservation Voters and the Sierra Club. The foundation is heavily funded by a Bermuda-based shell corporation with direct ties to Putin and Russian oil interests.

continue even though science confirmed fracking poses no public health threat.

The EPA could "not find evidence that [fracking] led to widespread, systemic impacts on drinking water resources.'

The U.S. Geological Survey and the Groundwater Protection Council found fracking caused no groundwater contamination. A three-year study at the University of Cincinnati found fracking had no impact on local water supplies.

Fracking created millions of jobs, spurred the economy and created a path to energy independence -- without posing a risk to people or the environment.

It seems the only folks left attacking fracking are puppets of the anti-science, anti-American Russian propaganda machine. They hope lies about fracking can weaken the United States, dry up the supply of oil and gas, drive up energy costs and force European countries to pour money into Putin's coffers.

As the U.S. intelligence report proves, Russia is willing to go to great lengths to destroy America's fracking industry. But the United States should stand firm against this threat. The battle over fracking is one fight America can't afford to lose.



Small Business Workshop Offers Vital Resources

owners gathered to collect resources from county, state and federal officials about how to get help for everything from obtaining small business "micro" loans and tax help support, to the bidding process for county and federal contracts and how to get support for women- or minority owned companies, or those in underserved areas.

"I'm not retired yet, but when I do get there, I intend to launch my own company doing what I've always done," said Winter, who plans to start up a mobile automotive performance service. One of the key questions on his mind at the workshop was how to get clearance to operate outside his resident city of Citrus Heights. He got that, and much more. "I didn't realize how many resources there are out there for small companies," said Winter.

The Small Business Resource Workshop was presented by State Assemblyman Ken Cooley, who kicked-off the event with an energetic push for supporting small businesses, saying they play a key role in driving the economic engine of all communities. "Dollars get spent. You put money in the pockets of employees, who then spend that money in their community, and that's how communities grow," Cooley said.

Perhaps one of the most daunting and oft-misunderstood agencies governing laws pertaining to small businesses is the State Board of Equalization, the state's main governing agency over business tax reporting and licensing. To help demystify some of the issues was David Nelson, who told attendees that many entrepreneurs who set out on their own don't always reach out to his agency for available help, often leading to their unnecessary

failure.

"We don't want anyone going out of business because they didn't know about the resources available to them," Nelson said.

In addition to providing free, online sellers permit applications, Nelson explained that the board of equalization can guide small business owners through the process of correctly reporting sales, even if they don't have any, how to craft a solid business plan for potential funding or grant opportunities, and options for creating a financial roadmap for success.

"We are not in the business of justifying how much you do, but reporting what you do," said Nelson.

Joe McClure, district director of the Small Business Administration (SBA) office in Sacramento explained how his agency works to secure micro and small business loans for

start-ups of all sizes and focus, and then he cautioned borrowers about defaulting on an SBA loan. "If you don't pay it back, we will find you," McClure said.

For women and minority owned small business owners. and those from underserved communities, Deboarh Lowe Muramoto from California Capital Financial Development Corp. was on hand to discuss how her agency secured more than \$30 million contracts last year for small businesses. In addition, the center provided roughly 200,000 hours of counseling to existing and would-be business owners, and served more than 3,500 in its bilingual training programs, she said.

One of the most important things a small business owner can do, Muramoto told the crowd, is learn how to effectively represent themselves in their community.

"We also offer classes in advocacy," Muramoto said. "Advocating for yourself as a small business is critical."

Legislation to Ban Sale of Nitrous Oxide **Unanimously Passes First Committee**

Senator Jim Nielsen's Measure -SB 631 – Will Help Save Young Lives



Senator Jim Nielsen's (R-Tehama)

SACRAMENTO, CA (MPG) - After hearing heartbreaking stories of a mother's grief over the loss of her daughter and a young man who suffered spinal cord degeneration and was confined to a wheelchair, both due to nitrous oxide abuse, members of the Senate Public Safety Committee unanimously passed Senator Jim Nielsen's (R-Tehama) measure to prohibit smoke shops and head shops from selling these "whippits."

"There is no legitimate reason for smoke shops to sell nitrous oxide," said Senator Jim Nielsen. "Young people buy and inhale this gas to get 'high' because they mistakenly believe it is a 'safe' substance."

Mary Anne Rand, mother of Camille Rand who was killed in a fatal car accident by a driver who was believed to be high on nitrous oxide, said, "My daughter's life was cut short at the age of 26. I hope Senator Nielsen's bill becomes law to reduce the chance of any other parent suffering the loss of their child."

Nitrous oxide use is difficult to prove because it does not

stay in a user's bloodstream for long.

Ms. Rand added, "Because deaths and injuries are just 'believed to be attributable to' I am afraid the extent of the problem is underreported and not statistically available."

Specifically, Senate Bill 631, if passed and signed into law, would prohibit smoke and head shops from selling nitrous oxide.

According to the National Institute on Drug Abuse recreational use of nitrous oxide can lead to "death from lack of oxygen to the brain, altered perception and motor coordination, loss of sensation, limb spasms, blackouts caused by blood pressure changes, and depression of heart muscles functioning."

"My concern about whippits, and the damage they cause to the central nervous system, led me to reach out to Senator Nielsen and share my story. I view the abuse of this substance as a public health hazard," said Mr. Patrick O'Brien, father of a 20-year-old whose spinal cord degenerated and was confined to a wheelchair.

Senate Bill 631 passed the Senate Public Safety Committee unanimously. It will now move onto the Senate Committee on Business, Professions and Economic Development for its consideration.

The Power of the "Deep State" **Worse than Thought**

The power of the "deep state," the intelligence community's lock on the secrets of every citizen in the United States, information that used to be only in sensational magazines, is now public knowledge. The March 8, Wikileaks dump of over 9,000 emails, a dump reportedly far larger and worse than the Edward Snowden revelations in 2013. A dump disclosing potential spying of Americans by their own television sets, whether on or off, or by their automobiles. Sophisticated cyber technology "beyond what Snowden could have imagined," capable of spying leaving the footprint of other countries so our government remains undetected. The power to blackmail the powerful of either political party is in the hands of the "Deep State." And reportedly, the 9,000 documents are but 1% of what Wikileaks has received by whistle blowers within the National Security Agency (NSA).

No one is exempt, not even President Donald Trump. One warrant allowed the spying of Trump Tower during the latter part of the Trump campaign and a second the Trump server itself, the first reportedly authorized by the FISA Court—a largely secret court where intelligence organizations CIA, FBI and etc. request spying authority. Since 1979 only 12 requests were denied out of 38,169 made. The judges almost never turn down the intelligence community. The second, by the FBI authorized by someone higher, some have suggested President Barack Obama.

As serious as this is, it is not new. Some remember CIA spying on the U.S. Senate Intelligence Committee led by Democrat Committee Chairperson Dianne Feinstein just three years ago this month. In this scandal, the

it "had secretly searched Senate computer files related to an investigation of the agency's Bush-era harsh interrogation program." The Senate was investigating them and was about to release its incriminating findings. Their admission that they lied for several months when accused of having done this and their apology to the senators to whom they had spied, does not make such acceptable.

Nor did they disclose who directed them to spy on the Senate in the first place? This wasn't just any group of U.S., it was the Senate Intelligence Committee, charged with overseeing all spying sponsored by our government. In effect, the CIA was spying on its congressional boss.

But Wikileaks dumps and spying on a presidential candidate or the US Senate are extreme examples of the power of the "Deep State." What of their power to spy, and potentially blackmail our elected officials, or you?

We have known for years of the government's secret surveillance network, code named "Stellar Wind," that intercepts, deciphers, analyzes, and stores "vast swaths of the world's communications as they zap down from satellites and zip through the underground and undersea cables of international, foreign, and domestic networks... Flowing through its servers and routers and stored in near-bottomless databases." Stored are "all forms of communication, including the complete contents of private emails, cell phone calls, and Google searches, as well as all sorts of personal data trails—parking receipts, travel itineraries, bookstore purchases, and other digital "pocket litter" (James Bamford, "The NSA Is Building the Country's Biggest Spy Center. Watch What You Say," Wired, Mar. 15, 2012) Edward Snowden documentation revealed their "intercepting 200 million text messages every day worldwide through a program called Dishfire" (Lorenzo Franceschi-Bicchierai, "The 10 Biggest Revelations from Edward Snowden's Leaks," Mashable, Jun. 05, 2014).

So where is your sensitive information stored? Launched in 2004 under the George W. Bush Administration, but vastly expanded under Barack Obama, the National Security Agency

CIA acknowledged that Bluffdale, Utah facility houses all electronic information in the world. It is designed to hold a Yottabyte of information. A yottabyte is 1,000 zettabytes (the number 1 followed by 24 zeros -- 1,000,000,000,000,000,000,0 00,000). The philosophy is that the "more data, the more telephone calls, the more email, the more encrypted data that you have—the more patterns that you're likely to discover."

> The NSA Oak Ridge facility houses the super computer, installed in 2006, capable of finding patterns and printing them out in milliseconds in a process code named "Brute Force." The "goal was to advance computer speed a thousand fold, creating a machine that could execute a quadrillion operations a second, known as a Petaflop—the computer equivalent of breaking the land speed record." With upgrades the computer, called "jaguar for its speed, it clocked in at 1.75 petaflops, officially becoming the world's fastest computer in 2009," is housed in Building 5300. There "318 scientists, computer engineers, and other staff work in secret on the cryptanalytic applications of high-speed computing and other classified projects" (Cryptome, "NSA Decryption Multipurpose Research Facility," March 16, 2012).

> Resistance to this invasion of privacy was massive resulting in the termination of the Patriot Act whose authority was used to justify bulk collections. It was replaced in 2015 by the USA Freedom Act, which required telephone companies to collect the metadata instead and store it at their expense. The NSA may still access (and does) the information with approval of the secret FISA Court if the government maintains there is a reasonable suspicion that the phone data of a target is relevant to a terror investigation. Reportedly this is why Trump Tower was under surveillance the closing weeks of the Trump presidential campaign.

Gang Members Convicted for Fatally Stabbing Father; Defendant Sentenced for Multiple Child Molestation Charges, Rape Gang Member Sentenced for Possession of Firearm

DATE: March 16, 2017

CASE: Sebastian Flores Torres & Jose Guadalupe Salazar (Case #14F01794)

PROSECUTOR: Deputy District Attorney Shelly McGill, Gangs & Hate Crimes Unit

Sebastian Flores Torres and Jose Guadalupe Salazar were convicted by a jury of the second-degree murder of Shannon Gregg and two counts of assault with a deadly weapon. The jury also found true that the defendants committed the crimes for the benefit of a criminal street gang, the Howe Park Sureños.

On March 12, 2014, a juvenile gang member belonging to the same gang as defendants Sebastian Flores Torres and Jose Guadalupe Salazar got into a verbal altercation with a group of juveniles near the intersection of Bell and Alta Arden. The juvenile gang member fled the scene and told defendants Torres and Salazar about the altercation. That same juvenile along with two other minors and defendants Torres and Salazar drove back to the scene of the altercation and discovered the group of juveniles now standing in the front yard of a nearby home. As the five gang members began to approach the group, the homeowner, Shannon Gregg, came out of the house in an attempt to prevent a physical altercation. The gang members began assaulting the individuals in the front yard. Mr. Gregg and an adult friend attempted to help fend off the attack. Mr. Gregg, his adult friend, and one of the minors standing in the front yard were stabbed, in the course of the assault. Witnesses varied as to whether defendant Torres or defendant Salazar was the individual wielding the knife. Mr. Gregg, who was the father of one of the juveniles in his front yard, died from a stab wound to his heart. The

other two victims survived the stabbing. The defendants face a maximum sentence of 26 years and 8 months to life in prison. Sentencing is set for April 28, 2017, at 9:00 a.m. in Department 28 before the Honorable James McFetridge.

DATE: March 23, 2017 CASE: Steven Ramos (Case # 13F05434) PROSECUTOR: Deputy District Attorney Jeff Harry, Special Assault & Child Abuse Unit

The Honorable Michael Sweet sentenced

Steven Ramos to 46 years and 4 months in prison. On October 17, 2016, a jury convicted Ramos of 22 counts of child molestation charges, forcible rape, and attempted forcible

In the mid-90s, Ramos began molesting two girls when they were 5 and 6 years old. In 1997, the victims disclosed the sexual abuse to El Dorado County law enforcement and charges were filed against Ramos. Due to outside pressure, both victims recanted their disclosures to law enforcement nearly a year after initially disclosing. Charges were then dropped against

Ramos began abusing both victims again and continued to do so until the victims were 16 years old. In 2012, when the victims were then in their early 20s, they reported to law enforcement the years of continued sexual abuse at the hands of Ramos. Their motivation to report was to prevent Ramos from sexually assaulting other potential victims.

CASE: Thomas Salaam (Case #15F06107) **PROSECUTOR:** Deputy District Attorney Kristen Andersen, Career Criminal Prosecution

The Honorable Steve White sentenced Thomas Salaam to 15 years in prison. On August 5, 2016, a jury convicted Salaam of being a felon in possession of a firearm and found that the crime was committed for the benefit of a criminal street gang. The jury also found true that Salaam has a prior serious felony or strike conviction.

In September of 2015, Salaam was involved in a gang fight which was captured on video. Several days later, Salaam was in a car with another validated gang member when rival gang members shot at their car. On October 1, 2015, Salaam was a passenger in vehicle that was pulled over by officers. When officers conducted a parole search of the vehicle, they located a loaded firearm underneath a sweatshirt in the backseat of the car. The firearm had a 26 round drum magazine attached to it with an additional loaded magazine placed next to it.

Salaam has a prior 2014 strike conviction for robbery while armed with a firearm.
