## Rancho Cordova Honors Volunteers

*Tracey Harris Named Volunteer of the Year for Summertime Efforts*

**RANCHO CORDOVA, CA (MPG)**

- On March 10, at "Get Your Golden Ticket," the Community Volunteer Awards program, Tracey Harris was named the Rancho Cordovan of the Year. Harris received the honor for his untiring work for the community over a period of years, in many capacities, including helping Moose Lodge golf tournament to raise more than \$54,000 for the Cordova Food Locker.

"Tracey, so many people know you, so many people love you, and so many people are here tonight because they want to join us in thanking you for all you do for our community," said Ken Rudolph of Good Day Sacramento, Master of Ceremonies for the event.

Harris expressed his gratitude for the honor. "We couldn't do it without everybody that's here in the community," Harris said. He shared a memory of going with his friends to the Jerry Lewis Twin Cinema as a child to see Willy Wonka and the Chocolate Factory, which was the theme for the night.

The program started out with the Sunrise Elementary School Choir singing and acting out songs from that movie. Led by teacher and director Trevor Harding, the kids in costume created a fitting start for the 18th year of this annual event. After their rousing performance, Rudolph presented the eight awards for the various categories of volunteer work.

Jim Purvis received the Distinguished Community

Service award for his paralegal work with Senior Legal Hotline and Neil Orchard Senior Activities Center in Rancho Cordova. "I feel good when I help people help themselves, and give them information that they then use to have power to resolve their problems," Purvis said.


Kaiser pediatrician Catherine Vigran, who will retire next month, earned the Outstanding Service to Youth honor for her care for kids in many ways above and beyond her service as a doctor. "I'd like to let everyone know what

a pleasure it's been to work in this community and to see children grow up and go on to do what they're going to do to make their contribution," Vigran said.

Outstanding Teen Service Award went to 13-year-old Anthony Lacayo. An 8th grader, he racked up 150 hours of volunteer service last year. "You can count on him, and he volunteers with his whole heart," said Linda Burkholder in her nomination letter. "He stands out for his ever-willing spirit, his reliability and his passion for helping others."

The "We could not have done it without you" award went to David McFarland. As pastor of New Life Center on Zinfandel Drive, McFarland was afraid his preschool would not be able to continue during the recession in 2008. He built a children's train, and with that and the influx of students transferred from Cordova Neighborhood Church, the preschool continues on. Now the train

## AmeriCorps Alum Now Leads Program in Rancho Cordova

**RANCHO CORDOVA, CA (MPG)** - As Andrea Aguinaldo coordinates the region's AmeriCorps VISTA program from her office at United Way California Capital Region in Rancho Cordova, she remembers why she chose to serve as an AmeriCorps VISTA.

"After I graduated from college, I was hungry to be part of something bigger than myself," Aguinaldo said. "So I decided to join the AmeriCorps VISTA program, a national service project with a mission to eliminate poverty."

During National AmeriCorps Week, and Aguinaldo and her colleagues at United Way California Capital Region saluted the 40 AmeriCorps VISTA members who dedicate a year or a summer to serving the Sacramento region.

"These young people dedicate a summer or a year of their lives to bringing change to local communities across the nation," said Stephanie Bray, president and CEO, United Way California Capital Region. "Many are

assigned to projects far from where they grew up. They gain valuable experience through their service to communities in need. Here in Sacramento, many nonprofit organizations rely on these dedicated individuals.”

The AmeriCorps VISTA program in the Sacramento region, as well as the service of this region’s members, is valued at \$419,000. Members are serving locally at Communities and Health Professionals Together/UC Davis Pediatrics, Health Education Council, Lutheran Social Services, Opening Doors, PRO Youth and Families, Sacramento Loaves and Fishes, Sacramento Regional Coalition to End Homelessness, Sacramento Self Help Housing, United Way California Capital Region, Wellspring Women’s Center, WIND Youth Services, Women’s Empowerment and Woodland United Way.

During Aguinaldo’s two service terms, she served in a rural county in Northern California and in the greater Los Angeles area.

“My service years were defined by moments of persistence through situations that were beyond my comfort zone,” Aguinaldo said. “I learned how to work with people who did not always share my perspective, and I witnessed the harrowing and extensive realities of child poverty. For each difficulty I faced, I found that it was the community I served that ultimately uplifted me with its generous tenacity.”

“It’s more important than ever to make sure people know how incredibly valuable AmeriCorps VISTA members are to our community and the work of nonprofits in our region. Their service is vital to our community’s health,” Bray said.

VISTA was founded in 1965 as a national service program to fight poverty in America. In 1993, VISTA was incorporated into the AmeriCorps network of programs under the umbrella of the Corporation for National and Community Service. AmeriCorps VISTA taps the skills, talents and passion of more than 8,000 Americans annually to support community efforts to overcome poverty. Members make a year-long, full-time commitment to serve on a specific project at a nonprofit or public agency. They focus their efforts to build the organizational, administrative and financial capacity of organizations that fight illiteracy, improve health services, foster economic development and otherwise assist low-income communities.

United Way California Capital Region is leading the AmeriCorps VISTA program in the Sacramento region as part of its efforts to increase capacity at local nonprofits and schools for its Square One Project, United Way’s 20-year promise to significantly increase the number of local students who graduate from high school ready for success in college and beyond. United Way believes ending poverty starts in school and is working to ensure kids meet important milestones for success in college or career.

Now as Aguinaldo serves at United Way as the coordinator of the AmeriCorps VISTA program in the Sacramento region, she has the opportunity to encourage other members in their work.

“I don’t think the amount of service I do will ever equate to the meaning these communities brought into my life,” Aguinaldo said.

# Hacker Lab Continues to Test the Waters in Rancho Cordova

**RANCHO CORDOVA, CA (MPG)** - Sacramento area “startup incubator” Hacker Lab recently partnered with the city of Rancho Cordova to host a Town Hall Idea Fest in February, seeking input and feedback from the community about what the possibilities for Hacker Lab could look like both for the nonprofit itself, as well as potential members.

The Town Hall Idea Fest was the next step in Hacker Lab’s feasibility study as the organization weighs its options in deciding where to open its third location in the Sacramento area. Beginning with its first site in the city of Sacramento, the group most recently opened a facility in Rocklin, working closely with that city and Sierra College. The Rocklin Hacker lab is currently expanding to nearly quadruple the current size. Both locations have met with enthusiastic responses from sponsors, the cities and a booming membership, and it appears that Rancho Cordova is poised to follow suit.

The Idea Fest was held February 23 in Rancho Cordova at the American River Brewery. A crowd of over 100 people attended and brought a gaggle of ideas for what they felt the group could offer at a potential Rancho site, known as an Innovation Center.

Thus far, Hacker Lab is garnering a wide range of support from Rancho Cordova tech businesses, the city itself and citizens of all ages. Rancho Cordova Chamber of Commerce President and Chief Operations Office Diann Rogers is just one businessperson who sees the possibility of economic exponential growth for the city. Rogers is very supportive of Hacker Lab choosing Rancho Cordova for its next facility and has been since the beginning.

“The Rancho Cordova Chamber of Commerce strives to promote the prosperity of our members. The Hacker Lab would be an amazing addition to our business community,” said Rogers. “Their mission and that of the Chamber go hand-in-hand seeking to develop opportunities and foster creative ideas. Collaboration is a key part of our mission. Collaboration with Hacker Lab will be a win for all in Rancho Cordova.”

According to Ashley Downton,

Community Relations Specialist with the city of Rancho Cordova, Hacker Lab is currently considering some of the following relationships and offering for a new facility in Rancho Cordova:

- Partnering with Soil Born Farms in Rancho Cordova for events.
- Partnering with post-secondary schools in Rancho Cordova such as the Agee Fashion Institute.
- Partnering with the Sacramento Employment and Training Agency on workforce development initiatives.
- Partnering with the Cordova Community Council on events for artists in Rancho Cordova.
- Beginning the search for potential locations for an innovation center in the City of Rancho Cordova.

“The overall goal of a Hacker Lab in the City of Rancho Cordova will be to support and create a maker and

manufacturing community and brand Rancho Cordova as the region’s ‘Maker City,’” said Stidham.

While initial conversations between Hacker Lab and the city of Rancho Cordova have been quietly going on for some time, it is only recently that the news became known to the public. Representatives from Hacker Lab attended a City Council session late last fall, including their founding CEO Gina Lujan. Lujan is a Sacramento native and community innovation powerhouse.

Lujan’s credentials read exactly as the mover and shaker she is, having over 20 years as an Innovation Consultant and award-winner with the likes of Northrup Grumman, Toyota, Sacramento and Tuolumne and Sacramento Counties, Latina of Excellence in Information Sciences and Technology, Women’s Day, Women Who Mean Business and more. Lujan also excels at forging alliances with educational institutions and providing tech training and programs

to underserved or at-risk youth in local communities, providing students with opportunities to see how acquiring technical knowhow could change their lives for the better.

“I strategize, build momentum, & develop opportunities for my team to execute innovative projects for our region, & community.”

Of her vision and direction of her team’s efforts, Lujan has been quoted online as saying, “We focus on community building, hacker & maker space development, regional support, & corporate, academic, and government innovation through grassroots education and spaces.” She has also been quoted as describing herself as a “Visionary Orchestrator/Community Evangelist. I hack issues and support the wonderful world of creators.” In short, she gets things done.

Lujan’s outreach efforts began with an ad on Craigslist, but she and the nonprofit Hacker Lab have come a

long way since then. In November, she appeared at a TEDx gathering in Livermore, speaking on the success of the group in inspiring crafts persons, small businesses and individuals by supplying tools, training and support for startups in the Sacramento area.

Currently, Hacker Lab member benefits, according to the group’s website, are effective and wide-ranging. “Our goal is to provide you with all the resources you need to learn new skills, meet people and launch a new venture. This includes access to mentors, networking opportunities, and tons of more hands on tangible benefits.” To that end, Hacker Lab facilities currently include blazing fast Internet connections, unlimited specialty coffee, private conference and meetings rooms, web hosting, free job board postings, storage, a kitchen, laser printing and copying, 24-hour keycard access, manufacturing tools, equipment and space (a 3D printing lab, laser cutter, wood shop and tools, metal shop and tools and MIG, TIG and Oxy welding equipment) an Electronics Lab, Computer Lab and Textile Lab in their CoWorking and Maker Spaces.

Hacker Lab itself focuses on providing “Workspace,” education and a sense of community to all members. Dozens of classes in everything from working with bamboo to coding and more are provided for members. They describe themselves as “[A] Community for hackers, makers, entrepreneurs, startups, and small businesses. We’ve got tech classes, maker space, prototyping too. We’re striving to be your go-to resource for all things education and entrepreneurship. From coworking, to rapid prototyping, learning. Our goal is to provide you with all the resources you need to succeed. Learn new skills, meet people, access equipment, and launch a new venture. This includes access to mentors, networking opportunities, and tons of more hands on tangible benefits.”

The group has a clear statement of its philosophy and mission: “We believe that technology can change the world and the starting point is education. Hacker Lab aims to educate folks and spark innovation with community driven resources Collectively we can build a brighter future using lean methods in both education and business.” ★



## And Another Thing ...

*The Vast Majority of People in This Country Are Waiting For the Elected Officials in Washington D.C. to Get Back to Work*

Something that Mother Teresa said makes a lot more sense than the constant turmoil in congress. She said, "You can't shake hands with a clenched fist." I think that explains why our legislators can't/won't either. Congressmembers and Senators did compromise in the past, and when they did, they were able to provide what this country expects of them; transportation, local security, and protecting our country are a good part of that legislative package. The vast majority of people in this country are waiting for the elected officials in Washington D.C. to get back to work and let the rest of the world see that the United States can still provide leadership. On to other things.

The Sacramento Regional County Sanitation District had its public hearing regarding monthly sewer rate increases on March 8, 2017. This meeting was very important to the region because it shows the rate increases that were forced onto our region. On December 10, 2010, the Central Valley Regional Water Quality Control Board adopted an updated discharge permit for the Sacramento Regional Wastewater Treatment Plant. The permit required implementation of new treatment processes at an estimated capital cost of \$1.5 to \$2.1 billion. These included biological nutrient removal, filtration, and new disinfection processes. The project, collectively known as the "Echo Water Project", must be constructed and fully functional by 2023.

Initially, the cost to you and me was estimated to be \$65.00 a month when all was said and done. However, with the

research that was done and led by District Engineer Prabhakar Somavarapu, when the work is done, we will be paying \$39.00 instead of \$65.00. That will be the residential rate. We began paying \$20.00 a month in July 2010, then it increased by \$2 dollars for 2011, 2012, and 2013, and \$3 dollars for 2014, 2015, and 2016. So in 2016, the residential cost was \$35.00, up from \$20.00. Now it will increase by \$1 dollar for 2017, 2018, and 2019, then \$.50 in 2020 and 2021. That will be a total, at the end, of \$39.00 a month. If the 12 hours of testimony from you and your City Councilmembers in 2010 had really meant anything, it would be a different story, but the state had the final say. So I think when all is said and done, the service we will have will be better than anyone else in the state.

## SAFE Credit Union Donates \$5,000 to Local Salvation Army

providing food and comfort in evacuation centers around the region, including Chico, Grass Valley, Roseville, Oroville, and Anderson. They continue to assess needs and have units on standby to support other affected areas, if needed.

"We're so thankful for SAFE Credit Union's generous donation to our Emergency Disaster Services program," said Major Guy Hawk, Salvation Army Divisional Secretary for the Del Oro Division. "The funds will help a lot with the meal services we have provided for the evacuees of the Oroville Dam situation, and they may also be used to assist families as they transition back home. It goes without saying, but we can't do

this without local support from individuals and organizations like SAFE Credit Union."



## Collections and creditors question

Dear Dave,  
 We were very late on one of our credit card bills, and now it has been turned over to a collection agency. The collection company has offered us three or four different payment options. Does the original creditor accept the agreement, too, if we accept one of the collection agency's options?  
 - Anonymous

Dear Anonymous,  
 In most situations of this type, the collection agency owns the debt outright or they're directly

representing the original creditor. It's pretty much standard operating procedure when someone has defaulted on a loan.

My advice would be to accept the deal they've offered that makes the most sense for you and your current financial situation. It'll ding your credit report, and show a settlement on the defaulted credit card, but that's not the end of the world. There's already a mark against you for it being turned over to collections.

If you want to keep things like this from happening in the future, you need to get control of your finances. Stop playing with credit cards!



# How to Make America's Elites More Responsible

**Commentary**

Observing Hollywood's posturing posers deliver their goods at the Oscars, as they ooze self-righteousness and narcissism, triggers a pesky thought that no doubt trumps in the minds of normal people. That is, few of those luminaries strutting across the stage are affected by the events or ideas targeted by their ego-driven drivel. Thus, the question arises, what if they were? More than that, what if America's elites in the entertainment industry, political realm, media complexes, and academic institutions were forced to suffer the consequences of the views they hold, the policies they force on the rest of us? This tantalizing hypothetical is worth a thought experiment or two.

Let's start with Obamacare, which many pundits on the right predict will collapse, implode, or turn into a pumpkin at midnight. Whatever. But nothing

in Washington happens by itself; no policy ever self-destructs; it takes the political equivalent of a pile of plastic explosives to make something happen. Unless, of course, Obamacare suddenly (and inexplicably) were applied to members of Congress, Republicans and Democrats alike, their staffs, and everyone else on a government payroll. Then, before you could say "Affordable Healthcare," Barack Obama's signature legislation would vanish overnight. In short, forcing lawmakers to obey their own laws would do wonders to clarify minds and speed up lethargic congressional processes.

Next, academic La-La-Land is desperately in need of a kind of intellectual Drano. Try this proposal for starters: Every professor who has published a great deal should be required to relinquish authorship of at least half of his/her publications to those who have published nothing at all. These academic enthusiasts for income redistribution need to

understand how ripping off producers to benefit those who contribute nothing works in an endeavor they hold dear. Again, mental clarification is the goal.

What can be done with radical feminists? This is simple, actually. Require the most ardent ones to sojourn for a year in Saudi Arabia, not as pampered celebrities, but as ordinary women forced to endure daily humiliations of male dominance. Then have them return to America to recount their experiences about what a misogynist society is really like. Look forward to them explaining the charms of following Wahhabism to their fellow travelers, who remain convinced that a woman needs a man like a tick needs a trampoline.

Forcing radical environmentalists to face reality is even easier, in theory, at least. Every environmentalist who harangues the rest of us about the hideousness of fossil fuels should be forbidden to use any means of transportation powered by gasoline-related

products, along with any material good or service whose existence depends on oil. Let them ride buggies, tend to horses, and raise chickens. This simple step would collapse the global warming industry more quickly than you could pronounce the words, "anthropogenic climate change."

Of course, the point that inspires these speculations is one that should be taken very seriously, regardless how much fun it is to ridicule the antics of the country's ruling class, which continually sneers at ordinary Americans for being unenlightened slob.

The point is that there is a chasm separating our country's elites from regular citizens, a matter that has been addressed increasingly by thoughtful observers of American politics. Although developments in our country have not reached the crisis levels that destroyed Rome, for instance, or France under Louis XVI, clearly the existence of vast, interconnected swath of overseers—actors

and activists, professors and pundits, politicians and bureaucrats—who are insulated from reality and the consequences of what they say and do, spells doom for America.

Which means that any measures that force elites into the world of responsibility should be welcomed, regardless of preposterous screeches of protest such efforts would ignite. The normals among us fervently hope that such efforts succeed before it is too late, before our "land of the free" succumbs to the tyrannies (soft or hard) that inevitably ensue when irresponsible elites lose all interest in preserving the country that made them so important in the first place.

## Prison Inmate Convicted for 1st-Degree Murder of Cellmate; Defendant Convicted for Bank Robbery, Carjacking

**DATE:** February 27, 2017  
**CASE:** Joshua James Anderson (Case #14F02844)

**PROSECUTOR:** Deputy District Attorney Dina Cataldo, Prison Crimes Unit California State Prison (CSP) Sacramento inmate Joshua James Anderson was convicted by a jury for the first-degree murder of his cellmate, Thomas Parks.

On February 8, 2014, Joshua Anderson strangled Thomas Parks to death with a scrap of bedsheet in their shared locked cell. Sacramento County District Attorney investigators assigned to CSP Sacramento responded to the prison that night to interview Anderson. Anderson initially denied killing Mr. Parks, stating he had no reason to kill him because he only had three years left on his prison term. Anderson also claimed Mr. Parks committed suicide by self-inflicted ligature strangulation.

When investigators noticed a bruise and fresh scratch on Anderson's face, Anderson admitted to the murder. DNA taken from Mr. Parks' fingernail scrapings matched Anderson, and the wounds inflicted on Mr. Parks' face were found to be inconsistent with Anderson's suicide claim.

Anderson's criminal history includes assault with a deadly weapon, two burglary convictions and unlawful sex with a minor. At the time of the killing, Anderson was serving a sentence for possession of controlled substance and resisting a peace officer.

Anderson faces a maximum sentence of 31 years to life in prison. Sentencing is set for April 21, 2017, at 1:30 p.m. in Department 11 before the Honorable Trena Burger-Plavan.

**PROSECUTOR:** Deputy District Attorney Dinah Mielke, Felony Prosecution Carlos Aguirre was convicted by a jury

of carjacking and six counts of robbery. The jury also found true the allegation that Aguirre personally used a firearm on all seven counts.

On January 22, 2010, Carlos Aguirre was armed with a gun and wearing a ski mask when he followed the assistant bank manager into her work at the Bank of America on Folsom Boulevard. Aguirre grabbed her from behind with his arm around her neck, and put the gun to her head. He ordered her and other individuals in the bank to the ground. He then ordered two tellers to give him the money. Both women complied, giving him between \$30,000 and \$50,000. Customers in the bank each testified that they were afraid they were going to die that day.

Aguirre grabbed his backpack with the money and ran towards the doors with keys he had grabbed from the assistant bank manager. Realizing he had taken her work keys and not her car keys, he went back and demanded car keys from her while still displaying his gun. She complied and Aguirre ran out of the front and to her car. When Aguirre reached her car, he lost the ski mask off the top of his head.

The mask was submitted to the District Attorney's Crime Lab for DNA analysis. A DNA sample was obtained from the mask, uploaded into the DNA database and matched to Aguirre's DNA. Cell phone records put Aguirre's phone in the area of the bank 11 minutes before the robbery took place, and at approximately the same time the day before.

Aguirre has a prior 1997 strike conviction for assault with a firearm with the allegation that he used the firearm during the commission of a felony or attempted felony.

Aguirre faces a maximum sentence of 60 years in prison. Sentencing is set for March 24, 2017, at 1:30 p.m. in Department 40 before the Honorable Raoul Thorbourne. ★

# 'Beauty and the Beast' New, Unimproved

Spoiler alert: Beast mauls Belle to death in Walt Disney's live-action remake of its iconic 1991 animated musical, "Beauty and the Beast." Then at her funeral Belle turns into a flesh-eating zombie and terrorizes her once-quiet, provincial town. Tale as old as time no more!

Exciting as that sounds, it's just a fantasy for those not looking for another family version of the well-worn fairy tale. The latest spin has little spin; it's pretty much the same as the old one: An enchantress posing as an ugly, old witch in need is snubbed by a young prince, yada yada yada. She gets her revenge on the boorish, womanizing jerk by casting a spell, blah blah blah. The heartless royal is transformed into a big, hairy beast, and his servants into household items for all eternity unless true love is found. Enter the beautiful outcast Belle, her persistent and unwanted suitor Gaston, and yada yada yada.

The new, still-zombie-less version starring Emma Watson does at least have a slightly different plot from the 26-year-old Disney treasure. The Mouse House pushes the envelope ever so slightly from the original French fairy tale published in 1740 as well as mainstream animated features. The new "Beauty and the Beast" (opening March 17) is the first family film from Disney to feature an openly gay character, complete with

what director Bill Condon calls "an exclusively gay moment," and throws in multiple mixed-race relationships at the end. Another modernization is Belle is much more than a stereotypical bookworm. Like her dad, she's an inventor. A mid-1700s mechanical engineer of sorts, Belle is far too complex for her village of illiterate simpletons. No wonder she yearns for more than this provincial life.

Belle isn't the only one wanting more. Never mind that Disney, a company once synonymous with innovation, admits to running out of ideas with every live-action adaptation of one of its classic animated films. Many have been box office gold. But if you're going to humanize classic cartoons, be purposeful at least. Other than three new songs and a few groundbreaking nuances, there's little that makes the new "B&B" required

viewing. Watkins is so flat as Belle, the animated 1991 personification is more lifelike in comparison. Human co-stars include Luke Evans as the one-dimensional Gaston. Josh Gad does one heckuva impersonation of Jack Black – if Jack Black was playing sidekick LeFou as a gay man. Bringing life to his CG-rendered character, Dan Stevens shines best as the beastly prince. The all-star voice cast led by Ewan McGregor, Ian McKellen and Emma Thompson adds nothing to what was already accomplished by their 1991 predecessors. Been there, heard that.

Let's hope for better with the next live-action adaptations of animated Disney classics. New takes on "Snow White," "Mulan" and "Aladdin" are among those in the works. Can at least one of those have zombies? Please? 2 of 5 Stars ★

## Key Affordable Housing Measure Clears Second Hurdle in Senate

SACRAMENTO, CA (MPG) - On March 15th, the approval of SB 2 (Atkins) by the Senate Governance and Finance Committee signified an important step to beginning to address California's devastating housing shortage. The Senate Transportation and Housing committee approved the measure last month. The Senate Transportation and Housing committee approved the measure last month.

"SB 2 is an important measure to begin to right the ship in California after years of failing to invest in affordable homes. This measure will provide thousands of new affordable rental homes in California while protecting general funds and

boosting our economy," said California Housing Consortium Executive Director Ray Pearl. "We are experiencing a massive housing shortage in California and it is time for a commitment to policies that can affect real change. California's families, children, seniors, veterans and vulnerable residents deserve nothing less than access to safe and affordable homes."

California has seen a 69 percent overall decline in state and federal investment in production and preservation of affordable housing since the Great Recession in 2008. A new California Department of Housing and Community Development statewide housing assessment finds that California families are facing a harder time finding a place to live than at any point in our history

and homeownership rates in California are at their lowest since the 1940s.

SB 2 (Atkins) would enable thousands of affordable rental homes to be built through a \$75 fee on real estate transaction documents, capped at \$225 per transaction. Sales of homes and commercial properties would be exempted.

CHC is also calling on lawmakers to approve AB 71 (Chiu), which would end a costly vacation home tax subsidy to provide affordable apartments and homes while protecting the mortgage interest deduction crucial for families to afford their first home. These common-sense measures do not dip into the General Fund and would generate additional federal, local and private investment. ★

# Annual Roseville Gem Show Rolls On for 2017

**SACRAMENTO REGION, CA (MPG)** - Roseville Rock Rollers 55th Annual Gem, Jewelry, Fossil, and Mineral Show will take place at the Placer County Fairgrounds in Roseville March 25-26. Hosted by the Roseville Rock Rollers, also known as the Roseville Gem and Mineral Society, this year's show features gemstones, jewelry, fossils and minerals and has something for the whole family.

The group was established in 1960 as a group of local "rockhounds," according to show chair James Hutchings. That group, deeply interested in the science and art of the earth's natural beauty in rocks and minerals, first met in homes and then as their numbers grew, expanded to the use of a local school room.

This year's show has dozens of exhibits for attendees, such as jewelry, metal, wire and glass beading arts, fossils, crystals and minerals, but that's not all. So that attendees aren't rushed, the show also provides a cafeteria. "A very fine hot lunch is available at our own kitchen in Johnson Hall," states Hutchings. The group has put together a menu of very reasonably priced food and beverages will also be available at the show's cafeteria, featuring burgers, Philly steak cheesesteaks, chicken salad, baked potatoes, pies, cakes and more.

In addition to exhibits, classes and demonstrations, show goes

can pan for gold, purchase equipment, buy raffle tickets, have rocks, gems and mineral identified by experts or make purchases at a silent auction.

Wishing to share the art and science of the mineral world, in the tradition of gem and mineral shows around the world, the Roseville Rock Rollers established their own gem and

mineral show around 1962. The society grew, the show grew, and the show and the Society moved to the Placer County Fairgrounds where it continues today.

"As the Roseville Gem and Mineral Society has expanded to just under 300 members, the show expanded to support the costs associated with its programs, such as the Rookie Rock Rollers, juniors program, the Annual Scholarship program to Geology Students at Sacramento State Geology Department, and our year round Lapidary shop on the fairgrounds," said Hutchings. "The lapidary shop on the Fair Grounds is the heart and soul of our Society, where we teach lapidary arts, jewelry fabrication, conduct mineral identification and mini tail gate rock sales."

Hutchings developed his love for "rockhounding" at an early age. "Personally, I as most young people, was fascinated with rocks minerals and crystals. My parents encouraged me

with my first Golden Book of Rocks and Minerals, a book still in current print, and my first rock pick."

At the age of 38, he became seriously interested in rockhounding and gold mining, attending a mineral identification course at Sierra College, next pursuing an in depth understanding the chemistry and physics that form "these miracles in the earth." He has put that knowledge to good use today providing what he refers to as a "mini lab" during the show to test rocks, minerals, and gems to provide guest an idea of materials they have in their possession.

While the Rock Rollers must generate funds to keep their programs operating, the primary purpose of any Gem and Mineral Show is to promote the Art and Science of the mineral world, according to Hutchings.

Like many of the group members, an early exposure to rockhounding and lapidary arts

often provides a genesis of interest that often blossoms later in life, Hutchings said. "We really work hard, to attract the parents who want to expose their children to the natural world and foster that spark."

There are presentations and activities for youngsters on identifying and handling specimens of all kinds. Students and Scouts can reinforce their California Rock Cycle curriculum and merit badge information. Scouts can have their mineral finds evaluated for rock type or mineral and validated for their required collection.

Other interesting stops are featured at this year's show. The Education Station is the place for the "learners," said Hutchings, "and we are all learners. There [are] demonstrators showing

Hutchings suggests visitors come early and plan on spending the day at the show. "We take over the entire fairgrounds with exhibits, demonstrators, and vendors."

Not to be missed are real treasures the group will have on display. "Folks tend to walk by the display cases," he says. "These simple, well lighted boxes contain the best of the best of personal collections of minerals in variety or by theme. The displays are, 'literally' miniature museums showcasing specimens in the possession of individuals who have spent a lifetime collecting the best of the best of their favorite species of rock or mineral," said Hutchings.

"We are looking for the general public who are looking for gem stones, set and unset, hand-

you the actual arts of lapidary, faceting, wire wrapping, and other jewelry arts." The Fossils for Fun booth encourages fossil hunters to view and purchase or bid on fossils from vendors. NorCal Bats brings a live bat to show how fascinating these mammals (often found in caves along with gems, stones and crystals) are. This year "Rocklin Bach to Rock" students will perform on stage to provide entertainment for the public.

## Game Plots

*Nintendo Needs to Switch Tactics*

The Nintendo Switch, released on March 3rd, is filled with Nintendo's usual brand of innovation. The removable screen and reconfigurable controllers (with built in motion control) combine to make a flexible console to fit a flexible lifestyle. It can accommodate on-the-go play, local multiplayer, motion gaming, and traditional on-the-couch games right out of the box. And despite its innovations, perfectly tailored to fit the daily routines of modern gamers, it will be a failure.

Nintendo seems to be trying to replicate its success of years past without really understanding why it attained such success in the first place. The Nintendo Wii and Nintendo DS didn't soar to the top of all-time sales charts purely because of their innovation; they succeeded because their innovations appealed to brand new markets that had never been exposed to gaming before. The DS's touchscreen and foldable design made it easy to carry and intuitive to use, while the Wii's focus on motion controls demystified the complex control schemes of other systems and made gaming immersive and approachable. There was a reason why seeing senior citizens own these consoles was not uncommon.

But Nintendo lost their edge this generation. Though the

3DS has been a moderate success (although nothing near the levels of the original DS), the Wii U has been a colossal failure. It failed to recapture that same non-gamer market, and next to the juggernauts of the Playstation 4 and Xbox One, its sales among traditional gamers floundered.

The Nintendo Switch is entering the market under similar circumstances. It has nowhere near the graphical power of its competitors, a meager 32GB hard drive that fails to accommodate our age of digital, rather than physical, game sales, and weak lineup of games (*The Legend of Zelda: Breath of the Wild* is the highly-anticipated exception). With Microsoft posed to announce a new console this year, and Sony likely to follow suit, the gap will grow even wider.

Maybe the Switch could attain more success if it released under the Wii's circumstances. In 2006, the libraries of the Wii's competitors lacked innovation; their graphics were good, but they didn't feel altogether "new." Revolutionary titles like *Wii Sports* felt like a breath of fresh air when we sorely needed one. But nowadays, innovation on traditional consoles, the Playstation 4 and Xbox One, is thriving. We're in the midst of a golden age of new ideas and inventiveness, and in this environment, the Nintendo



The feeling of you cannot win and/or you cannot understand has been pioneered by writers like H.P. Lovecraft and Neil Gaiman in creating some of the most frightening and unsettling stories of the century; games have failed to inspire the same emotions in a similar way.

Switch's features simply don't feel necessary.

Of course, I hope that Nintendo can prove me wrong. A successful Switch could be a welcome off-the-wall competitor to modern consoles, and inject a little more of Nintendo's signature levity in the usually serious and somber artistic tone of the game market. But given the circumstances, Nintendo has set itself up for seemingly inevitable failure. There's no need to worry about the company itself; the 3DS's sales and its recent forays into mobile are enough to keep Nintendo afloat. But if it wants to remain relevant in the home console market, and prevent Sony and Microsoft from running a two-person race, Nintendo needs to switch up its tactics.

Finishing off a four-day road trip with a match at Reedley College, the Falcons managed to shake off the fatigue and a slow start as they rallied to defeat the Tigers, 8-1, on Saturday afternoon. With two of the doubles matches decided by tie-breaker sets, the Falcons took a 3-0 lead after doubles. The lone loss in singles occurred when Abriana Rowe was forced to retire with the flu. With the win, the Falcons improve their season record to 7-0. They will face American River on Thursday at ARC in a showdown of the Big 8 Conference leaders.

### Men's Tennis

The FLC men's tennis team used their superior depth to defeat a tough Reedley College squad on Saturday, 6-3, on the strength of their third through sixth players. With Reedley winning at number one doubles, then taking the top two singles matches, the Falcons relied on Alex Bychkoviak, Josh Harder, Max Hennessy, and Praj Ta to secure the victory. Reedley entered the match with a 4-1 record, having won three consecutive matches.

The Falcons improved their season record to 8-2 and will now set their sights on the Big 8 playoffs, beginning on March 21.

### Women's Softball

The Falcons entered Saturday's doubleheader at Diablo Valley with a 1-4 conference record and in need of a win, but were swept by the Vikings 6-2 and 8-0. The first game saw the Vikings score early, then hang on as the Falcons' bats came to life. Mac Robertson drove in two runs with her sixth inning double as the Falcons tried to rally, but that was as close as the visitors would get.

In game two, the Falcon bats remained mostly silent as they managed just three hits. Meanwhile, the Vikings tallied runs in innings two through five to break the game open. The FLC softball team lost a game to American River College on Tuesday afternoon that was there for the taking. A questionable non-call by the field umpire and a near-miss of a fine defensive play in right field led to three Beaver runs in the first inning that proved to be the difference. Lefty starter Lauren Orris settled in after that and kept the Beavers' bats in check, but

the Falcons weren't hitting, either. Brie Maddux' RBI single in the first inning scored McKenna Rickles from second with the Falcons' only run of the game. "We missed a great opportunity to pick up an important win in the Big 8 Conference," noted first-year head coach Jenna Alexander. "Hopefully we can move forward and get two on Saturday." The Falcons travel to Santa Rosa for a doubleheader on Saturday.

### Men's Baseball

After opening their Big 8 schedule with three losses to Sac City last week, the Falcons looked to get untracked against Sierra College yesterday in Rocklin. The Wolverines, however, were just as desperate for a win after losing three to Santa Rosa. Sierra jumped out to a 2-0 lead in the first inning, but FLC freshman Carson McCusker erased that with his seventh home run of the season, a three-run blast that put the Falcons on top 3-2. That lead didn't last long as Sierra tallied four in the third and added another in the fourth to go up 7-3. The Falcons closed the gap in the fifth with two runs on Greg Vaughn's RBI double and McCusker's sacrifice fly. A Jack Rotteveel solo home run in the sixth

- his second of the season - pulled the Falcons within one, but that was as close as they would get. Sierra added a run in the seventh for the final 8-6 score.

With four RBI in the game, McCusker is now fourth in the state in that category and second in home runs.

The season-long struggles of the FLC pitching staff continued on Tuesday afternoon as the Falcons fell to Santa Rosa, 12-9 in 10 innings at Falcon Field. Once again, FLC's potent lineup kept the Falcons in the game as they rallied to score four runs in the bottom of the ninth to send the game into extra innings. After falling behind 6-0 in the fourth, Josh Winkler crushed

a three-run home run into the scoreboard in left field to cut the deficit in half. The Falcons made it 6-5 in the sixth on a run-scoring double play and a solo home run by catcher Mason Allen, his second of the season. The Bear Cubs responded with three more late-inning runs to go up 9-5, but the Falcon offense came to the rescue again in the ninth. Four consecutive hits to start the inning made it 9-7, then a walk and a hit batter made it 9-8 with the bases loaded and still none out. After a foul pop-up for the first out, Mason Allen's single tied the game. One out later and with the bases still loaded, Grant Heisinger roped a liner to the gap in right-center that looked like the game-winner, but the Bear Cub centerfielder made a great read on it and caught it for the third out. In the tenth, the Bear Cubs loaded the bases on a hit and two walks (one intentional) before getting a couple of two-out hits that drove in the final three runs of the game.






