# Virtual Public School Gives Back at Sacramento Food Bank

#### SACRAMENTO, CA (MPG)

California Connections Academy @ Ripon is a tuition free, virtual public school serving students in an eight county region including Sacramento County. While students are widely dispersed and complete course work online, they do get together regularly for field trips.

Amber Manko, School Counselor from Modesto said that she and other counselors and advisory teachers decided a good way to get students engaged in community service would be to schedule a service project. After researching, they agreed that the Sacramento Food Bank sounded like a good choice. "I've been pretty impressed with the

organization and how it's run," Manko said. "I'm really just excited to be able to offer the opportunity for kids."

At the food bank Maria Zefo, food resource manager, showed the group around the facility on Bell Avenue in Sacramento. The food bank took over the building from Senior Gleaners around two years ago. "At that time, we were feeding about 50,000 people," Zefo said. "Now we're at 135,000." Zefo took the group through several of the warehouses (there are five) to the one where the group would work. She filled them in on Sacramento Food Bank facts along the way.

The organization serves Sacramento County via 220 other agencies who come to them for food and resources: churches, soup kitchens, food pantries, senior programs and more. The food bank itself does not dispense Continued on page 4

# **Region Now Conserving Water** at 25 Percent

SACRAMENTO REGION, CA (MPG)

- Sacramento-area residents reduced water use by 25 percent in 2016 compared to 2013 even without a state mandate to conserve, according to an analysis of water use figures submitted to the State Water Resources Control Board (State Water Board) and the Regional Water Authority (RWA), which represents nearly two dozen water providers in the Sacramento region.

"The savings last year demonstrate that residents are continuing many of the waterwise behaviors adopted during the drought," said RWA Water Efficiency Program Manager Amy Talbot. "The conservation ethic did not go away with the mandates."

The State Water Board in May 2016 adopted a new Emergency Regulation that allowed water utilities to set their conservation standard based upon local water supply conditions and the utility's ability to pass a "stress test" (to meet customer demand in the next three years if drought continued). Local water providers certified that they have adequate supplies to meet customer needs. "However, this was not a signal to stop using water wisely," Talbot said. "Instead, it recognized that local water providers have planned and invested in building reliable supplies for decades."

The 25 percent savings in 2016 comes on top of significant water use reductions over the past decade. Overall, the region's water demands have decreased 9 percent from 2000-13, while population increased 17 percent. The region uses the same amount of water today as it did in 2000 while serving 400,000 more people. And, during the drought, the Sacramento region achieved some of the highest water use reductions in the state.

"Although the Sacramento region is no longer in a drought, we're encouraging everyone to continue using water wisely," Talbot said. "Droughts are a part of life in California and remind us that water is precious. Wasting water is foolish, especially when there are so many easy ways to conserve."

RWA and local water providers are asking residents to turn off sprinkler systems until spring, especially in light of the recent drenching by winter storms. In addition, now's a great time to consider how to save water indoors by, for example, replacing older fixtures with high-efficiency WaterSenselabeled ones. These include toilets, showerheads, faucets, aerators and weather-based sprinkler timers.

#### RCPD Partners with CA Department of Alcoholic Beverage Control to Reduce Underage Drinking when adolescents stand outside of liquor

RANCHO CORDOVA, CA (MPG) - Nearly 20% of American adolescents ages 12-20 reported alcohol consumption in 2015, according to the National Survey on Drug Use and Health. The Rancho Cordova Police Department (RCPD) and the California Department of Alcoholic Beverage Control (ABC) are working to reduce that number in our community.

RCPD will work with ABC until the end of August in a coordinated effort to help reduce underage drinking and reduce youth access to alcohol through education and enforcement. RCPD and ABC will conduct several operations in the

City of Rancho Cordova and its neighboring areas in Sacramento County that focus on businesses and individuals that provide alcohol to adolescents under the age of 21.

"I look forward to working with the California Department of Alcoholic Beverage Control to reduce underage drinking and its repercussions in our community," said Rancho Cordova Police Chief Chris Pittman.

The operations, conducted by RCPD Problem Oriented Policing (P.O.P.) officers and ABC agents, consist of "shoulder taps" using minor decoys, or situations

stores or markets and ask adults to buy alcohol for them, as well as inspections of local businesses that hold ABC licenses. This project is part of ABC's Minor Decoy/Shoulder Tap Grant Project, funded by the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

#### **GSW Collaborating with Schools** to Test for Lead in Drinking Water

SACRAMENTO REGION, CA (MPG) -Golden State Water Company has announced it will work closely with schools in each of its service areas to test the drinking water inside school facilities for compliance with state and federal lead standards. This work is in accordance with the State Water Resources Control Board Division of Drinking Water's recently-announced initiative encouraging California schools to work with their local water providers to sample for the presence of lead in the drinking water that is served to students and staff.

"Drinking water safety is of paramount importance to families across California," said Denise Kruger, Senior Vice President of Regulated Utilities for Golden StateWater Company. "Golden State Water's dedicated team of water quality professionals regularly treats, tests and monitors the water we deliver for more than 230 elements, including lead; however, the most-common cause of lead exposure in the drinking water at schools is often prolonged contact with a building's lead-based pipes and plumbing fixtures. This collaboration with the more than 500 schools we serve provides Golden State Water the opportunity to test

the drinking water inside the facilities and communicate the sampling results to the schools."

Any school served by Golden State Water is eligible to have its drinking water tested for lead at no charge through the program. All requests must be submitted by a school official.

# **Arts Important to Community Economics, Ulich Says**

RANCHO CORDOVA, CA (MPG) - When Jody Ulich came to the City of Sacramento as the new director of Convention and Cultural Services, one of the first people she heard from was Rancho Cordova's now mayor-elect Linda Budge. "Actually, I think that on my first day, as I'm just trying to figure out how to get

downtown," Ulich said,

"Linda was my first phone

call." Budge had attended the United States Conference of Mayors in Dallas in June of 2014 and learned how the state of Texas had developed arts districts and how valuable they were in economic development. Later in the fall, Budge read that Ulich, who was just starting her new responsibilities in Sacramento, had come from Fort Worth. "So I knew she was bringing the skills that I had been so in awe of in the Dallas-Fort Worth area," Budge said. "I was her first speaking engagement. I got her three weeks after she came to town, and she has come to talk to the (Rancho Cordova) leadership classes for three years now."

On January 20 at the Rancho Cordova January luncheon, one of the focuses of Ulich's message was that big cities don't have the only claim on the arts. Arts organizations are just as important in smaller communities. "It's really important in all reality that we go completely and totally regional," Ulich

Rebecca Garrison, chair of the Metropolitan Arts Commission, attended the luncheon. Her colleagues, Garrison said, understand the local arts community

extends well beyond downtown and midtown. "Some of the most significant arts initiatives are happening in places like Rancho Cordova, Elk Grove, and Folsom," Garrison said. "I think we are starting to see that jurisdictional boundaries fade away when artists get together to collaborate and strengthen their own community."

Whether nonprofit or not, arts organizations are businesses, Ulich said. They employ people, and those people are likely to live and shop locally. "These organizations themselves are economic drivers in your community, they serve your community," Ulich said. "They make your community different, they help to identify your community . . . Then the second thing it does, is it tells employers that arts and culture are important to your community and this makes it a

great place to live." Asked about the renovation of the Sacramento Community Center, Ulich said, "We finally have funding for this, so I will tell you we are moving forward with that." The Community Center includes the Convention Center, the Community Center Theater, and Memorial Auditorium. The first year will focus on infrastructure at Memorial Auditorium, such as sound system and rigging upgrades. Then the Community Center Theater will be moved to Memorial Auditorium for a year and the theater will be redone. "It's going to be ADA accessible, upgrades of all the theatrical systems, new seating . . . expanded lobby space," Ulich said. "... I would say that within three years both of those projects

should be done." Ulich stressed the importance of government support for the arts and the continued funding in Washington D.C. for the National Endowment for the Arts. "If, as you are growing your arts program, you want to apply for a grant from the California Arts Council, the answer is, that money comes from the NEA," Ulich said. ". . . The NEA is very, very

important." She said the NEA also funds the military healing arts network, providing veterans with arts programs such as music, yoga, and painting.

As director, Ulich oversees a staff of 245 and a budget of about 18 million dollars. Her realm includes Sacramento Community Center Theater, Convention Center, Memorial Auditorium, Sacramento History Museum, Metropolitan Arts Commission, Crocker Art Museum, Historic City Cemetery, Old Sacramento Historic District, Fairytale Town, and the Sacramento Zoo. Before coming to Sacramento in 2014, Ulich was director of the Fort Worth, Texas, arts council for seven years. She spent ten years as cultural services director in Tempe, Arizona.

#### Allergy Alert Cashew Allergen in Dry Roasted Almonds 19, 2017, to three customers, one of whom

U.S. FDA Special Report

**SACRAMENTO REGION, CA (MPG)** - Specialty Commodities, Inc. (SCI), a subsidiary of Archer Daniels Midland Company (NYSE: ADM), is recalling a specific lot of dry roasted almonds because they may contain undeclared cashews. People who have an allergy or severe sensitivity to cashews run the risk of a serious or life-threatening allergic reaction if they consume these products.

The recall was initiated after it was discovered that the cashew-containing product was distributed in packaging that did not reveal the presence of cashews. The recalled dry roasted almonds were distributed between December 22, 2016, and January


redistributed them for sale in either bulk bins or clam shells to retail outlets in California, including Safeway and Nugget Markets.

Subsequent investigation indicates the problem was caused by a temporary process irregularity that occurred at the third-party contract manufacturer that processed and packaged the almonds for SCI. Then, an inventory processing irregularity resulted in the almonds being forwarded to the impacted customers.

individual state, it makes sense that a candidate might win the popular vote across the entire United States, but not win the Electoral College. Four candidates in the past did not receive a plurality in terms of popular votes but were elected by the Electoral College. Only one candidate, John Quincy Adams, lost the popular vote by 44,804 and was chosen by the House of Representatives after a tie in the

Electoral College. The presidential candidates who lost by popular vote were John Quincy Adams who lost by 44,804 popular votes to Andrew Jackson in 1824; Rutherford B. Hayes lost by 264,292 popular votes to Samuel J. Tilden in 1876; Benjamin Harrison lost by 95,713 popular votes to Grover Cleveland in 1888; and George W. Bush lost by 543,816 popular votes to Al Gore in 2000; and I don't have the exact numbers, but I believe President Elect Trump lost by about 3,000,000 popular votes. All five of these candidates didn't win by popular vote as was shown, but they did win the

The result of the November 8, 2016 election has brought out many demonstrators who are expressing their constitutional right to show their unhappiness with the election results, but there is no constitutional right to injure anyone, or to use the demonstration to steal or destroy anyone else's property. Historically, the 1876 election was one of the most disputed elections in American history. There were 20 con-

1877. The history of that compromise is a story in itself, and I do not have room in this column to give that too. However, history is very interesting if you are willing to take the time to do some research on your own.

And another thing that is a piece of history, Eugene Cernan was the commander of Apollo 17 in December 1972. He was the last to re-enter the lunar module, and the last to walk on the surface of the moon. He died last Monday at the age of 82, and the words he spoke on his final goodbye to the moon are not as famous as Neil Armstrong's were, but they say so much. "...America's challenge of today has forged man's destiny of tomorrow. And, as we leave the Moon at Taurus -Littrow, we leave as we came and, God willing, as we shall return, with peace and hope for all mankind. Godspeed the crew of Apollo 17." In 1999, he was quoted again, "Here I am at the turn of the millennium and I'm still the last man to have walked on the moon, somewhat disappointing. It says more about what we have not done than about what we have done." We have all made a true mark in history, and it didn't have to be on the moon. Each and every citizen of the City of Rancho Cordova, all 72,203 of us, are continuing to learn from the past and are making great progress toward the future every day. Don't forget how each person brings hope to others by just trying to help a little. That's what we do here in Rancho Cordova.

# Virtual Public School Gives Back at Sacramento Food Bank

food from their facility, but they do send their trucks out to nearly 20 sites to dispense food. "We just completed hunger assessment for this county, what areas are not being served, where there is need and no agency, where we can go and pull up a truck and hand you some food," Zefo said.

The Sacramento Food Bank serves over 135,000 people a month via family services programs and food distribution. In 2015 donors provided 16,342,858 pounds of food and 175,124 clothing items. Nearly 8,000 volunteers gave close to 90,000 hours of service. Only 7 cents on the dollar goes to operating costs, so 93% of the food bank budget goes directly to programs. The national average, per Zefo, is only 80% directly going to programs.

The California Connections Academy group's job was to sort food, and they attacked the huge bins with gusto during their three hours of service. School Site Administrator Amy Hunt, along with her 10-year-old son Brady, worked alongside the others. "Brady and I got to the bottom of our barrel, and we moved on to another one," Hunt said. "I think we were the slowest of everyone there. When we got to the bottom, everyone else had moved on to another one."

Those volunteers who turned up for the event were happy they were able to help. "We're already going to start looking for an opportunity in the Bay Area, another area that our families hopefully can attend," Hunt said.

Though Manko was disappointed in the number of those turning out for this event, she hopes for a better response in the future. "I work with high school students and often they want to know how they can get involved in their community," Manko said. "So it would be nice if our school can build on this and offer more opportunities throughout the year . . . It's important."





# Trump Saves U.S. from the Trans Pacific Partnership

For readers who do not understand the international trade deals of the last 25 years, notably NAFTA, GATT and TPP, you will never fully grasp what President Donald J. Trump has just done for the Constitution and against the proponents of globalism. In his first day in office, pulling the United States out of the Trans Pacific Partnership, he has done more to return us to constitutional integrity and to international free market economics

than the last four presidents combined. Space permits our confining ourselves to the threat averted to the Constitution

International trade deals have historically been a mix of oxymoron's: Republicans for and Democrats against, with the actual trade deals finalized and implemented by Democrat presidents Bill Clinton and Barack Obama. Unions, considered left, and Tea Party folks, considered right, have been consistent opponents, as have constitutionalists. land for the United States and 11 other countries in the Asia-Pacific region—without the input of a single member of Congress. This in violation of Article I, Section I of the U.S. Constitution that mandates that all legislative powers reside in the House and Senate and in no other body. The admission that the TPP will influence foreign policy is interesting as only the U.S. Senate may influence foreign policy as per Article II, Section II. Giving a "more central part of foreign policy" to an international agency would have virtually voided the Constitution in this area.

The Post identified "60 senators (who) have asked for the final agreement to address currency manipulation." Senators Elizabeth Warren and Ron Wyden, both Democrats, have been especially vocal about the Obama "Administration's refusal to make draft text available." Wikileaks published the chapter on

Police Officers Lawfully Acted in Self-Defense in Shooting of Dazion Flenaugh Woman Sentenced for Stealing Wallets, ID Theft Woman Convicted for Double Murder of Elderly Couple

**DATE:** January 13, 2017

The District Attorney's Office has determined that three Sacramento Police officers lawfully shot Dazion Flenaugh after he rushed at them in a threatening manner while holding two knives.

On April 8, 2016, Sacramento Police officers contacted Flenaugh in the South Sacramento area after receiving a report that Flenaugh had been acting suspicious in the neighborhood. Flenaugh ran from the officers and committed multiple crimes while seeking to avoid apprehension. After jumping over fences and escaping through backyards, Flenaugh stole a large pick axe from one yard and used it to smash another residence's front door window. He also broke the back door glass. Flenaugh then went to an occupied home, which he forcibly entered after threatening to harm the resident with the pick axe and knife he was holding. She retreated from her home and contacted a neighbor for help. After discarding the pick axe and now holding two knives, Flenaugh confronted and threatened the neighbor, then fled.

When officers finally caught up with Flenaugh, he refused to comply with repeated commands to drop the knives and get on the ground. Instead, he rushed directly at one of the officers with the two large kitchen knives still in his hands. Two other officers were also standing nearby. Fearing for their own safety and the safety of each other, the three officers discharged their weapons at Flenaugh. Flenaugh died as a result of his gunshot wounds.

Multiple witnesses reported Flenaugh acting in a manner consistent with being under the influence of a controlled substance. Laboratory testing confirmed the presence of amphetamine and methamphetamine in Flenaugh's blood.

The District Attorney's Office investigates all officer-involved shootings that result in death or bodily injury. By law, officers are allowed to use deadly force when they reasonably believe they are faced with imminent danger.

Based on a thorough review of the evidence, Flenaugh posed an imminent threat of death or serious bodily injury to the three officers, and they were justified in shooting Flenaugh to defend themselves and each other.

Our review only addresses whether the officers involved committed any violation of criminal law. We do not address issues of civil liability, police tactics, or department policies or procedures.

factual and legal findings is available to the public.

The Honorable Michael Bowman sentenced Jasmine Moore-Grant to 21 years county jail prison, of which she was ordered to serve 13 years in custody and 8 years on mandatory supervision. Moore-Grant previously pled to one felony count of second-degree burglary, 24 felony counts of identity theft, and admitted to two prison priors.

In July and August of 2015, Moore-Grant entered office buildings during business hours and stole wallets from employees who were away from their desks. She then repeatedly used and attempted to use more than a dozen victims' credit cards to make purchases at local stores. She completed over 90 fraudulent transactions causing more than \$7,000 in loss.

Moore-Grant has a prior criminal history of multiple theft and identity theft offenses.

Shauna Burton was convicted by a jury of two counts of first-degree murder for beating Melvin Bain and Jean Bain to death. The jury also found true weapons and multiple murder special circumstance allegations. Burton was also convicted of robbing a store clerk.

On November 3, 2013, Shauna Burton went to a CVS Pharmacy on Zinfandel Drive, where she threatened a clerk with a gun and then robbed the store. Shortly afterwards, Burton went to Melvin and Jean Bain's residence. Burton had previously assisted in caring for 78-year-old Jean Bain. While at the Bains' residence, Burton demanded prescription pills and money. When Melvin Bain refused, Burton stabbed Melvin Bain in the face and beat the elderly couple to death with a large Maglite flashlight.

Burton faces a maximum sentence of life without the possibility of parole. Sentencing is set for February 24, 2017 at 9:30 a.m. in Department 13 before the Honorable Matthew Gary.

The Low-Level Laser Therapy (LLLT) alone, per Sehr can be highly effective in treating, diabetic ulcers, venous stasis and arterial ulcers, and many other types of non-healing wounds.

The hospice care that Sehr's company provides is a growing service, based on industry best practices, but also on her own experiences as a nurse. Most hospice patients they see are given six months or less to live, but that isn't an outcome set in stone. "We don't give up," she says. "We're not God, but people do 'graduate'

Revenue Service has said that it successfully started accepting and processing 2016 federal individual income tax returns on schedule. More than 153 million returns are expected to be filed

People have until Tuesday, April 18, 2017 to file their 2016 returns and pay any taxes due. The deadline is later this year due to several factors. The usual April 15 deadline falls on Saturday this year, which would normally give taxpayers until at least the following Monday. However, Emancipation Day, a D.C. holiday, is observed on Monday, April 17, giving taxpayers nationwide an additional day to file. By law, D.C. holidays impact tax deadlines for everyone in the same way federal holidays do. Taxpayers requesting an extension will have until Monday, Oct. 16, 2017 to file.

"Following months of hard work, we successfully opened our processing systems today to start this year's tax season," said IRS Commissioner John Koskinen. "Getting to this point is a year-round effort for the IRS and the nation's tax community. The dedicated employees of the IRS look forward to serving taxpayers this filing season, and I want to thank all of the tax and payroll community for their hard work that makes tax time smoother for the nation."

The IRS expects more than 70 percent of taxpayers to get tax refunds this year. Last year, 111 million refunds were issued, with an average refund of \$2,860.

#### Refund Delays

A law change now requires the IRS to hold refunds on tax returns claiming the Earned Income Tax Credit (EITC) or Additional Child Tax Credit (ACTC) until Feb. 15. Under this change required by the Protecting Americans from Tax Hikes (PATH) Act, the IRS must hold the entire refund — even the portion not associated with the EITC and ACTC. Even though the IRS will begin releasing EITC and ACTC refunds on Feb. 15, many early filers will still not have actual access to their refunds until the week of Feb. 27. The additional delay is due to several factors, including weekends, the Presidents Day holiday and the time banks often need to process direct deposits.

This law change gives the IRS more time to detect and prevent fraud. Beyond the EITC and ACTC refunds and the additional security safeguards, the IRS anticipates issuing more than nine out of 10 refunds in less than

21 days. However, it's possible tax-filing or payment obligations a particular return may require additional review and take longer. Taxpayers are reminded that state tax agencies have their own refund processing timeframes that vary, and some states may make additional reviews to ensure their refunds are being issued properly. Even so, taxpayers should file as usual, and tax return preparers should submit returns as they normally do.

#### Use e-File and Free File

The IRS expects more than 80 percent of returns to be filed electronically. Choosing e-file and direct deposit remains the fastest and safest way to file an accurate income tax return and receive a refund.

The IRS Free File program, available at IRS.gov, gives eligible taxpayers a dozen options for brand-name products. Free File is a partnership with commercial partners offering free brand-name software to about 100 million individuals and families with incomes of \$64,000 or less. Seventy percent of the nation's taxpayers are eligible for IRS Free File. People who earned more than \$64,000 may use Free File Fillable Forms, the electronic version of IRS paper forms.

#### **Protecting Taxpayers** from Identity Theft-Related Refund Fraud

The IRS continues to work with state tax authorities and the tax industry to address tax-related identity theft and refund fraud. As part of the Security Summit effort, stronger protections for taxpayers and the nation's tax system are in effect for the 2017 tax fil-

The new measures attack taxrelated identity theft from multiple sides. Many changes will be invisible to taxpayers but will help the IRS, states and the tax industry provide new protections. New security requirements will better protect tax software accounts and personal information.

#### Renew ITIN to Avoid Refund Delays

Many Individual Taxpaver Identification Numbers (ITINs) expired on Jan. 1, 2017. This includes any ITIN not used on a tax return at least once in the past three years. Also now expired is any ITIN with middle digits of either 78 or 79 (Example: 9NN-78-NNNN or 9NN-79-NNNN). Affected taxpayers should act soon to avoid refund delays and possible loss of eligibility for some key tax benefits until the ITIN is renewed. An ITIN is used by anyone who has

under U.S. tax law but is not eligible for a Social Security number.

It can take up to 11 weeks to process a complete and accurate ITIN renewal application. For that reason, the IRS urges anyone with an expired ITIN needing to file a return this tax season to submit their ITIN renewal application soon.

#### New AGI requirement for e-file

All taxpayers should keep a copy of their tax return. Beginning in 2017, taxpayers using a tax filing software product for the first time may need their Adjusted Gross Income (AGI) amount from their prioryear tax return to verify their identity. Taxpayers can learn more about how to verify their identity and electronically sign tax returns at Validating Your Electronically Filed Tax Return.

#### Free Tax Help

Low- and moderate-income taxpayers can get help filing their tax return for free. More than 90,000 volunteers around the country can help people correctly complete their return.

To get this filing help, taxpayers can visit one of the more than 12,000 community-based tax help sites that participate in the Volunteer Income Tax Assistance and Tax Counseling for the Elderly programs. To find the nearest site, use the VITA/ TCE Site Locator on IRS.gov or the IRS2Go mobile app.

#### Filing Assistance

The IRS reminds taxpayers that a trusted tax professional can provide helpful information about the tax laws. A number of tips about selecting a preparer and information about national tax professional groups are available on IRS.gov.

The IRS urges all taxpayers to make sure they have all their year-end statements in hand before filing. This includes Forms W-2 from employers and Forms 1099 from banks and other payers. Doing so will help avoid refund delays and the need to file an amended return.

#### Online tools

Many tax issues can now be resolved online or by phone from the convenience of a home or office. The IRS urges taxpayers to take advantage of the many tools and other resources available on IRS.gov. IRS phone lines will be busy again this year, so in order to save time, people should first visit the IRS website for tax assistance.

# How to Build Better Drugs Faster

Breast cancer surgeon Dr. Laura Esserman sings to her patients as they go under anesthesia. She tackles any song request, whether it's a top 40 hit or a Broadway ballad. This same patient-centric attitude drove Dr. Esserman to participate in adaptive clinical trials, a game-changing way to test new medications.

It's past time that other researchers think beyond traditional clinical trials. Adaptive trials can make drug testing both more efficient and accurate. If regulators were to encourage greater use of adaptive trials and facilitate sharing of electronic health record data, researchers could deliver better drugs to patients, faster.

In a traditional clinical trial, researchers plan out every element of the trial -- from the number of participants to the type of data to be collected -- before they begin testing. They stick to this rigid master plan until the trial is complete.

But in an adaptive trial, researchers pre-plan certain modifications that they can make part-way through the trial, based on the results they've uncovered

Think of it in terms of mapping a run. A runner might look at a map and realize that at one point, the road will fork. Instead of deciding whether to go left or right before he ever begins jogging, he might choose to postpone the choice until actually reaches the fork. Perhaps he'd like to observe which path is muddier or which path has less traffic -and he'll only know when he gets

Similarly, researchers administering adaptive clinical trials can modify their tests as they make observations. Like the runner, they have to pre-plan what choices they'll make and when. But the more flexible trial formula enables them to alter the trial in response to real-world results.

Dr. Esserman's trial, for example, personalized testing by splitting breast cancer patients into different groups depending on various measurements of their health. She tested a combination of therapies on these patients -and only continued testing those that were found initially effective. By not having to run a dud treatment through the course of a standard clinical trial, the adaptive design reduced the cost, time, and number of patients needed for the

The FDA currently permits adaptive trials in limited instances. Letting researchers use this model more often would improve the drug development

Another way to improve the process is to enable doctors,

insurers, and drug companies to share data on patients' health outcomes after they take new FDA-approved medicines. By analyzing this data, they could uncover patterns that can't be detected even in the largest clini-

For instance, a clinical trial for a diabetes drug might include 1,000 participants, 10 of whom are Native American. Perhaps 60 percent of all patients respond well to the drug, but all 10 Native Americans get their blood sugar under control thanks to the medicine. It's impossible to tell from such a small sample size whether the medicine really is vastly more effective for Native Americans, or whether those 10 patients just got

Changing regulations to permit greater sharing of such data would help researchers unveil rare side effects, complications, or "miracle" results that crop up.

Adaptive trials and increased data sharing would deliver better medicines to patients faster and with greater safety. That's something to sing about.

There are numerous reasons for this; procrastination, avoidance, denial, lack of awareness. lack of time, or hoping things will either fix themselves or go away. Regardless of why you don't address them, unresolved problems grow quickly and even multiply.

No matter how many times a person is burned by growing problems, many still don't change their approach. If you want things to change, you have to change them. Remember, doing the same thing over and over and expecting a different result is one definition of insanity.

Bigger problems generate more stress than smaller ones. Constant stress creates its own secondary problems. Judgment is impaired. Patience is diminished. All types of physical problems can follow as

address your problems. It makes so much more sense to handle them while they are still small and more easily rectified. As you have already learned, putting them off doesn't work. So you need to develop a more effective strategy.

Begin by differentiating problems from symptoms. Problems lead to symptoms which themselves cause additional secondary problems if the original problems are ignored. Not only do ignored problems grow in size, they also grow in number.

Treating only symptoms leaves problems untouched. For example, if a lost nail causes the horseshoe to shift, the horse would start limping. So, if you erroneously identify the limp as the problem, you would then allow the horse to rest. Unless and until you accurately recognize the problem as a missing nail, you won't be able to formulate a solution. For maximum effectiveness, the root problem must be rectified.

Once you identify the root problem, the exact cause must to Live Without Limits," the be determined and corrected. Otherwise, the problem will keep recurring. Since, the missing nail is the real problem, it should be replaced. But why did it fall out in the first place? Was it the wrong size, the wrong shape, the wrong type, worn out, or defective? Unless it was worn or defective,

unless a different type is used. Your goal is to correct the root

cause of a problem while it is still small and has not yet generated secondary problems. The sooner you identify and fix a problem, the

Problems that initially appear overwhelming should be broken down into smaller, manageable pieces. Each component can then be tackled individually. This approach enables you to expeditiously handle unwieldy issues.

Correcting problems as they arise prevents a problem backlog. Rather than being constantly bogged down by problems, you have the energy and freedom to stay on your desired course. You will be able to quickly identify and fix problems as they arise. Your stress level will drop while enthusiasm rises. No longer will you feel as if you are on a treadmill which is going a little faster than you can keep up.

# Cordova Boys Soccer Beats El Dorado


