RANCHO CORDOVA, CA (MPG) - Mayor David Sander's State of the City address on November 10 was opened by three stirring songs by the Cordova High School Choir, directed by Kathryn Campbell. Larry Stafford, President of the Cordova Community Council, followed the choir with a quote from John Ed Pearce that said, in part, "... Home is where love resides, memories are created, friends always belong, and laughter never ends. Home is not a place, home is a feeling."

In his introduction of Sander at City Hall, Ross Johnson, State of the City chairperson, said that Sander has "received the gavel" three times since our city was founded. Johnson said, "Each time he has taken the opportunity to guide our city toward important goals."

Sander began by congratulating and pledging support to those who were voted in through this month's election. "This was in my experience the most polarizing election I've seen," Sander said. "Regardless of whether you're happy or scared, remember the words of our pledge, which I'll say in short. 'One nation, under God, indivisible, with liberty and justice for all'."

Since the year is 2016, at the beginning of the year Sander listed 16 things that were likely to happen. Number 16 was that "We will fail." "If we don't fail at something, we're not trying hard enough," Sander said in explanation. "If you don't take a little risk, you're not really making any gains."

But the year was full of accomplishments,

not the least being some of the uses of Measure H funds. This includes Cordova High football equipment upgrades that provide specially developed helmets to prevent and monitor brain injuries and concussions.

As an enhancement to public safety, the City has been able to add four new police officers they call the Crime Suppression Unit, which focuses on heading off crime before it happens. Through this unit, this year there have been 108 felony arrests,

City's Credit Rating Has Increased

RANCHO CORDOVA, CA (MPG) - Standard & Poor Global Ratings (S&P), an American financial services company, has raised the City of Rancho Cordova's credit rating from A+ to AA-. This upgraded rating is based on S&P's view of the improved economy, and the City's track record of positive financial performance - and the expectation that it will continue.



Standard & Poor's upgraded rating reflects that the City has a strong economy, strong management with good financial policies and practices, and strong budgetary performance, with surpluses in the general fund in recent fiscal years. The outlook on all ratings of the City is stable. S&P also noted that the City's model of providing many if its General Fund services through long-term contracts adds certainty to the City's budgetary flexibility. In addition, the City's strong liquidity and low overall debt obligations further contributed to the enhanced credit rating.

"We are pleased with S&P's vote of confidence and this improved credit rating," said Kim Juran, Chief Financial Officer for the City of Rancho Cordova. "We will continue to work towards positioning the City for future credit rating increases."

Todd Harms Sworn in as New Fire Chief

SACRAMENTO COUNTY, CA (MPG) - The Sacramento Metropolitan Fire District Board of Directors will conduct a swearing-in ceremony at its regular meeting tonight for new Fire Chief Todd Harms. Following a national search, Harms was selected by the Board of Directors in August as the District's sixth Fire Chief. He replaces Mark Wells, who, after 29 years of service in public safety and two years as Fire Chief, is retiring.

"I am truly honored to have this opportunity to lead Metro Fire," said Harms. "I look forward to continually finding way to improve our service delivery, showing the communities we serve that Metro Fire is here every day of the year to solve their problems."

Harms has 35 years of public safety service and most recently spent nine years as an Executive Staff member for the Phoenix Fire Department. He served as Assistant Chief of Operations, Assistant Chief of Personnel and the Training Division, with oversight of the Training Academy, Command Training Center, Special Operations, Emergency Medical Services, Technical Services, dispatch and the Regional 9-1-1 services.

Harms began his fire service career in 1981 as a Firefighter Paramedic in Peotone, Illinois. In 1987, he became a member of the Phoenix Fire Department. While there, he progressed through the ranks as a Firefighter, Paramedic, Engineer, Captain, Battalion

Chief, Deputy Chief of Special Operations and Shift Commander. He also has been an Urban Search and Rescue team member, with deployments to Hurricanes Katrina and Rita. Harms holds a Bachelor's degree in Fire Service Management and is a past adjunct instructor at Phoenix College in the Fire Science Program.

"My career in the fire service was more rewarding than I ever expected," said retiring Fire Chief Mark Wells. "I have been honored to serve this community for the last 29 years with the men and women of Metro Fire."

Chief Wells started his fire service career with the Citrus Heights Fire District in 1987,

and progressed through the ranks of Firefighter, Captain, Battalion Chief, Assistant Chief, Deputy Chief of Administration, becoming Fire Chief in 2014.

Key accomplishments during Wells' tenure as Fire Chief include the successful negotiation of a new labor contract, the reopening of three closed fire companies, the implementation of a Joint Arson/Bomb Task Force with Sacramento County Sheriff, the development of a Residential Care Facility Inspection program, equipping all Metro Fire medic units with video laryngoscopes, power gurney systems and automatic chest compression devices, and the donation of two surplus medic units and one fire engine to local community colleges. ★

68 people with felony warrants found and served, 30 misdemeanor warrants and 661 probationers contacted. "We want to spend our money and invest our officers' time with the most proactive and effective means," Sanders said. Development has continued. At Sunridge Plaza, Sunrise and Douglas, the 40,000 sq. ft. Raley's is underway, along with a number of other stores such as an AM PM store, Jimboy's Tacos, Great Clips, a dentist, a dry cleaner, and a pizza place. The biggest development coming up in Rancho Cordova is Rio del Oro, 3,828 acres bordered by White Rock, Sunrise,

and Douglas Road, an area larger than that of downtown Sacramento. There will be jobs, houses, parks, and a large wetland preserve. The ground breaking should occur in 2018. Three new businesses bring distinctive products with a flair. Bases Loaded is the largest baseball store in the region, and has made Rancho Cordova a nexus point for baseball. The Free Form Factory is a high tech manufacturer of individual watercraft such as jet skis. "Their mode of manufacturing is unique, and they have been lauded all over the country," Sander said. Viva Supermarket, where the old Raley's used to be on Folsom Boulevard, "fills a niche that we

don't find now otherwise in our community, and activates that center," Sander said. Sander brought out much more of the development and programs of the past year through video presentations and news clips. "The state of our city, the state of our home town is strong, really strong," Sander said, "and that is the take-home message for tonight." Sander earned a PhD in molecular and cellular biology from Tulane University and is a principal consultant with Sander & Associates, specializing in medical, biomedical, or biological communication needs. ★

Officer Spotlight: Tyrie McIntyre

RANCHO CORDOVA, CA (MPG)

- Deputy Tyrie McIntyre has a personal stake in Rancho Cordova. It is where he grew up and attended school from elementary through Cordova High. “I know a lot of people here,” McIntyre said. “It makes me feel good, because Rancho Cordova is a unique place. There’s no place like Rancho Cordova. It’s a family.”

A deputy in the Sheriff’s Department was a mentor to McIntyre when he was a kid, and McIntyre was often around other officers, as well. “I got to see what it was they did,” McIntyre said, “and not just to see them in a law enforcement capacity, but also on a personal level.” When he later joined the Sacramento Sheriff’s Department, he worked with some of those officers, although some are now phasing out and retiring.

McIntyre has a passion for working with young people and feels that it’s important for kids to have a positive experience with law enforcement. “When I’m on patrol and I come across a young man that may be struggling, I can share some of the experience that maybe I had, and kind of give perspective.” Parents help, he said, when they talk positively to their children about the police. “When you see an officer, you tell (kids), ‘You see that guy right there? He’s there to help you. If you’re in trouble, if ever you’re in need, that guy right there is risking his life to come help you.’” Contrarily, parents can put the opposite thought in a child’s mind by negative comments that McIntyre sometimes hears, such as, “See that policeman? He’s going to get you!”

Some of the best moments on the job come from helping children, McIntyre said. Some of the worst, though, come from seeing children he knows are not in a good home situation, and knowing that he can’t fix

it. “It bothers me, it just weighs on me,” McIntyre said. “That’s probably the toughest thing that I deal with personally.”

Balancing time between work and family is always a challenge in this line of work, and McIntyre’s favorite pastime is spending time with his wife and three children. “It takes a special person to become an officer, because you’re going to see things that are going to impact you at home,” McIntyre said. “You just have to be able to deal with that in whatever constructive way you can.”

With a Bachelor’s Degree in Criminal Justice, and over 12 years experience with the Sacramento County Sheriff’s Department, including his three years with the Rancho Cordova Police Department, McIntyre loves his work. “It’s just good to have people that you know you have a common goal with,

and you’re willing to work to get to that goal . . . Chief Goold, he makes it a good place to work. He’s brought in good people, and he continues to bring in good people.”

Chief of Police Michael Goold said that McIntyre has a vested interest in the safety and security of all who call Rancho Cordova home. “Every day he comes to work with a smile on his face and a determination to make a positive change. He is a shift leader and counted on patrol veteran.”

With the current climate surrounding law enforcement, McIntyre said, “Some people just don’t understand what we do . . . I don’t have a problem, when someone stops me and asks me why, what do I feel about a certain situation. I love to share that with them because oftentimes they walk away with information that they may not have had prior to our contact.” ★



And Another Thing ...

I Will Try to Follow My Own Advice, and Send Postcards and Christmas Cards to the People I Haven't Communicated With for a While

Everyone is aware of the presidential race results and that Candidate Trump is now President-elect Trump. A few local elections are almost complete, and I say almost complete because there are still 250,000 ballots that are still being counted. One of those for example is the Congressional District 7 race between Congressman Ami Bera and candidate Sheriff Scott Jones. As of this writing, there are about 2,100 votes between them. Final certified results are due to the Secretary of State for presidential electors on December 6, 2016, and all other state contests on December 9, 2016. The Secretary of State will certify the statewide results by December 16, 2016. That seems to be a long time to be sure of the results, but at least it will not last two years like the presidential race did. You might send a letter of thanks to the people you may know who spent so much time working on the different races. A thank you never hurts, and from me to all the volunteers who spent so much time on so many races, Thank You! The most important message from me to all of you is thank you for hiring me for four more years for the City of Rancho Cordova's City Council. I won't let you down. Come to think of it, when was the last time you wrote a letter to someone? Now I don't mean sending an email to someone, or "talking" to a few thousand people through "Facebook". I am talking about really writing a letter to just one

person with a pen and a piece of paper, signing it, and sending it in good old snail mail. What brought those thoughts to my mind was something of a dilemma one of our grandsons was in the other day. He had just read a story and his assignment was to write about the story. He could talk about the story, and what the story was about, and even about the characters in the story, but he hates to write.

My wife is a retired teacher, so our grandson has an immediate resource of information about writing and how to write, but he wants to get finished with his homework and go play. What kid doesn't! But when you are in the fourth grade or fifth grade, you are given assignments that will prepare you for middle school, high school, and college. Many people today can only think of using their computer, iPad, or other machines because they will "always be there". And they will always be there of course, except when the power is out so the computer is out and your phone and everything else is out, and the only thing left to complete your homework and another assignment that is due the next day is by being able to pick up a pen or pencil and write (or print) it by hand. That is hard to do if you very seldom write by hand.

I wrote many letters to my family and my fiancé when I was in the Air Force. Then I wrote again to my children when they joined the military (the Air Force by chance) too. I know receiving letters in the mail when you were away from home was very important because it gave you a connection to home. Even though today's generation can accept an email without any problem, some of us still get that warm feeling when you receive a

handwritten letter, postcard, or Christmas card, and you can see that someone took the time to write to you. Postcards used to be more important than they are today. Unless there are postcards that I don't know about, the only Rancho Cordova postcards you can pick up and send "back home" are the ones here at City Hall. There may still be some Rancho Cordova postcards in our hotels and their gift shops, but I will have to look and see if there are any left.

Communicating with the people who are, or who used to be important to you, may still be important, especially if you haven't talked to them for a long time. Making a phone call or writing a letter isn't too hard, but it is easy to let them slip on by because you now feel guilty for not making that phone call or writing that letter. The longer you wait, the harder it is to contact them, and the guiltier you may feel.

It is the holiday season now, with Thanksgiving and Christmas just around the corner. One of those Rancho Cordova postcards I spoke about shows our Christmas tree after it is lit and is easy to send to the people who will really appreciate receiving it. I will try to follow my own advice, and send postcards and Christmas cards to the people I haven't communicated with for a while. Maybe some of that guilty feeling will be removed. Max Lucado said, "Forgiveness is unlocking the door to get someone free and realizing you were the prisoner." Forgiving ourselves isn't always the easiest thing to do.

“Seabee” Veterans Changed Lives in Vietnam

Rancho Cordova Recognizes Veterans of the U.S. Naval Construction Forces

MATHER, CA (MPG) - Veterans of the U.S. Naval Construction Forces, best known as Seabees, were recognized at Rancho Cordova’s 11th annual Veterans Day Ceremony. The event was held at Sacramento VA Medical Center, Memorial Plaza in Mather.

The event provided musical performances by the Rancho Cordova River City Concert Band, as well as speeches from Congressman Ami Bera, Senator Jim Nielsen, Assemblyman Ken Cooley, Mayor David Sander. A flyover was conducted by the Vultures Row Aviation Team.

One of the honorees was David Cooper, who

enlisted in the Seabees in his 20s after graduating with an engineering degree from UCLA.

In 1969, David was deployed to a Marine Firebase in Vietnam where he operated heavy machinery, surveyed construction, and participated in combat. On Christmas Eve, he and a group of Seabees visited a Vietnamese village to participate in a church service. During the service, a group of children came down the aisle in white robes singing “Silent Night” in Vietnamese. A child jumped into his lap, and David began to cry, realizing that the locals were just people like him. David decided to join the Navy’s “Civic Action” team, which supports underdeveloped villages and are considered “Navy Goodwill Ambassadors.”

For four months, Cooper helped build a new marketplace and school building, as well as install a sewer and drainage system. He also protected the village when it was attacked, earning him a Vietnam Armed Forces Honor Medal for his heroism. When he left the village to return home in 1970, the villagers held a huge party and presented him with carved elephants as a gift – a gift he cherishes to this day.

The City of Rancho

Cordova is a vibrant community that values its veterans, having been the site of an active air force base. Many who served decided to establish roots in Rancho Cordova, and an estimated 5,000 veterans continue to call it home to this day. On this year’s Veterans Day, the City recognized the Seabees for their unique role as skilled fighters, builders, and goodwill ambassadors. The Seabees have a history of building bases, bulldozing and paving thousands of miles of roadway and airstrips, and accomplishing myriad other construction projects in a wide variety of military theaters dating back to World War II. “We build. We fight.” is their motto. The Seabees have continued to serve to this day and now include 7,000 active personnel and 6,927 reserve personnel.

Sacramento Sailor Continues 74 Years of Seabee Tradition

GULFPORT, MISS. - “We Build, We Fight” has been the motto of the U. S. Navy’s Construction Force, known as the “Seabees”, for the past 74 years. Today, Sacramento, California native and a 2009 Sacramento New Technology High School graduate Seaman Faith Devisscher-Knudtson builds and fights with the Navy on the Gulf Coast and around the world as a member of the Navy serving at Naval Construction Battalion Center, Gulfport.

Gulfport is the command headquarters that oversees all naval construction forces based in the eastern half of the U.S. Land for the Naval Construction Battalion Center at Gulfport was acquired in April 1942, the same year the “Seabee” name was adopted for members of the Construction Battalions, a clever play on the CB initials.

Devisscher-Knudtson is responsible for base safety and security.

“I like to spread positivity,” said Devisscher-Knudtson. “I like the being in the job gives me the opportunity to spread positivity in stressful situations.”

“Seabees are some the hardest working Sailors in the Navy,” said Captain Cheryl M. Hansen, NCBC commanding officer. “They are tough, bold, and ready, and they get the job done. They build and fight in some of the harshest and most hostile environments in the world.”

For the past 74 years Seabees have served in all American conflicts. They have also supported humanitarian efforts, using their construction skills to help communities around the world following earthquakes, hurricanes and other natural disasters.

“I like being on this base because we get to work hand in hand with law enforcement,” said Devisscher-Knudtson.

Seabees around the world will take part in a year-long celebration in 2017 to commemorate the group’s 75-year anniversary. The theme of the celebration is “Built on History, Constructing the Future.”

Today, Seabees continue their innovative traditions ensuring they always meet fast-paced challenges, according to Hansen.

Working with the Seabees and serving in the U.S. Navy has allowed Devisscher-Knudtson to continue learning about the legacy she wants to leave to future sailors.

“The Navy has taught me how to get out of my comfort zone,” said Devisscher-Knudtson. “People had doubts about my ability to do my job so I’m using that as motivation to be better.”

Funding for Winter Sanctuary Approved

SACRAMENTO REGION, CA (MPG) - On November 1, the Sacramento County Board of Supervisors approved an agreement for \$360,000 with Sacramento Steps Forward (SSF) for the administration of the Winter Sanctuary Program. The Winter Sanctuary Program provides nighttime shelter with local faith-based organizations, including transportation and two meals, for Sacramento County's homeless population from November 21 through April 30, 2017. "This is the fifth year of funding this program in order to provide 100 additional beds for Sacramento's homeless each night during the winter," said Chair of the Board Roberta MacGlashan. "We are pleased and grateful to the 19 congregations that have agreed to host and look forward to

other organizations filling in the remaining open nights."

As part of the agreement, SSF will provide monthly reports of the number of persons sheltered per night, including the breakdown of men, women and families served and their geographic origination. The data will be utilized to determine potential areas of focus for future funding opportunities.

Sacramento Steps Forward coordinates the shelter, transportation to and from the shelter sites, and meals with, as well as outreach and referral efforts for ongoing supportive services.

Currently, congregations have been lined up to provide services for every night except 52. Sac Steps Forward and its subcontractor, First Step Communities (FSC), are working to recruit congregations

to fill out the list, including those that can accommodate pets, and two congregations to serve as intake sites for persons who are unable to travel to the main intake site of Loaves and Fishes.

In recruiting these additional intake sites, SSF and FSC are utilizing data to determine where the highest populations of homeless exist outside of the immediate geography of Loaves and Fishes.

The County is also providing \$75,000 to Volunteers of America (VOA) for the period of November 21 through March 31, 2017 for the administration of the Winter Shelter Program for homeless families. Offered since 2011, this program has provided shelter to 876 adults and children since its inception.

New Statewide Plan Aims to Dramatically Reduce New HIV Infections

SACRAMENTO COUNTY, CA (MPG) - California has released a new surveillance, prevention and care plan designed to dramatically reduce new HIV infections in the state, with the goal of eventually getting that number to zero. The "Getting to Zero" plan is a blueprint for state and local health departments and community organizations working to achieve a more coordinated statewide response to HIV.

"Thanks to better treatment and prevention options, new testing technology and better access to health care, California has reached a point where we can begin to envision the possibility of zero new HIV infections," said California Department of Public Health Director State Public Health Officer Dr. Karen Smith. "In a state as large as ours, it will take an incredible

amount of coordination, innovation and work to make this vision a reality. This report lays the foundation for achieving our goals."

The "Getting to Zero" plan was developed by the California Department of Public Health (CDPH) in coordination with local health officials, other state departments, medical and non-medical providers, and HIV community organizations and planning bodies. The report set four goals to be achieved by 2021. The four goals are to reduce new HIV infections, increase access to care, reduce disparities in underserved communities and achieve a more coordinated statewide response to the HIV epidemic.

To achieve those goals, the report outlines 15 strategies and 12 key objectives that will be

monitored on an annual basis by CDPH's Office of AIDS. Some of the strategies include improving HIV testing and HIV pre-exposure prophylaxis (PrEP) utilization, enhancing availability of HIV care and increasing community collaboration and involvement.

"This comprehensive plan reinforces the state's ongoing commitment to address the HIV epidemic," said Dr. Karen Mark, Chief of the Office of AIDS at CDPH. "This commitment includes supporting people living with HIV, reducing the rate of new infections, and recognizing that not all communities have been equally impacted by this epidemic, and making those most at risk a high priority."

Saved from the Zone

There's a lot written about getting into "the zone" these days, but little about how to get out of the zone. This is an interesting story about a very successful and famous artist who spends most of his time in the zone and it inspired me to write about how to get out of one.

There's a bronze sculptor in Eastern Oregon named David Manuel. My husband has been his official videographer for more than 20 years and we've gotten to know the whole family as David has become world renowned for his bronzes.

On this visit, we were there to video an historic event, which I'll tell you about later.

I've had the honor of being able to watch David work on his masterpieces over the years. While my husband would be out and about filming something for the Manuel's marketing program, David would let me watch him whenever I wanted to. During this visit, he was working on the front leg of a horse (knee area). (Do horses have knees?)(Don't have time to Google.) Where was I? Oh, yeah, David told me he's such a perfectionist that he could work on one piece into forever. He said that Lee, his wife, has to take pieces away so he can move on to another project.

That's a lesson we can learn. Since we don't have Lee to say, "Enough already!" we really need a timer to jerk us out of one of those zones (that we love to be in by the way). We SHEs (Sidetracked Home Executives) are just like artists when it comes to hyper-focusing. We get into that glorious zone and time flies while we're in there, and before we know it, we've turned five (of the 55, dull, stained, bathroom, shower tiles), into shiny squares that look brand new and it only took two hours! A timer can save you from the zone when you need to be.

13 years ago, David and Lee bought the land and building (as seen in the photograph) known as Hot Lake Hotel (also known as Hot Lake Resort) in eastern Oregon. It was their dream to restore the building to its original glory and create an historical place for David's gallery and incredible, interpretive museum, while making a peaceful and artist-inspiring

place for him to work his magic with clay. Sounds exciting, doesn't it? But wait! If you could have been there with us, and seen the horrible condition of the buildings and property, you would have said, "NO, don't let them do this!"

The hotel and resort was originally built in 1864. It's located in Union County, Oregon. The hotel received its namesake from the thermal spring lakes on the property, and operated as a luxury resort and sanatorium (hospital) during the turn of the century, advertising the medicinal attributes of the mineral water and drawing visitors worldwide. It was also the first known commercial building in the world to utilize geothermal energy as the primary heat source.

After a fire burned down over half of the hotel in 1934, the remaining building was used for various purposes, including a retirement home, asylum, and a nurse's training school during World War II. After that, operations were intermittent under various owners before the building's abandonment in 1991. The hotel is on the National Register of Historic Places.

Hot Lake touts the most mineral dense hot water on earth. It used to be known as the Mayo Clinic of the West and saw its heyday in the early 1900s with people coming from all over the country to bathe in the healing waters and stay in the luxurious hotel. But before that, Hot Lake was the gathering place of American Indians who would come together in peace to soak and heal.

When the Manuel's bought the property, the hulking building was uninhabitable. We were there with them and a crew of architectural engineers who conducted a thorough inspection, with our cameras rolling. The 60,000 square foot building with about 350 windows had only four windows intact! Owls and pigeons flew freely and had nests built in many rooms and when we went under the building, the cameras caught eyes I just know were rattle snake eyes. The structure of the building was sound, which at the time seemed like the only good news.

Today, after 13 years of extreme, hard labor, Hot Lake has been transformed. But the Manuels are selling the property and we were there to film the

continuation of the history of Hot Lake. For three days we were surrounded by media, legislators, and wealthy businessmen and women who were brought together for the breaking news.

Hot Lake is going to be a restorative retreat center for our combat veterans (remember the healing waters), while it houses a training facility for practitioners of holistic, natural medicine and there's more. Hot Lake is going to raise 5 million pounds of fish a year to help feed the region and beyond. (That's another story!)

Can you imagine the feat Lee Manuel accomplished bringing these three entities together? The combination couldn't be more divine! Together they'll create a place to heal our combat veterans, using natural medicine and healing mineral waters and raise fish to feed millions.

At one point, after the press had gone, and everyone had left the building, I sat alone in the Manuel's immense gallery, displaying some of the most beautiful art I've ever seen, and I remembered that just a few hours before, hundreds of people were milling around in the gallery, excited about this historic event, and it struck me, that the only reason anyone had been part of this occasion, goes back to David's genius. Underneath the glitz of all the lights, cameras, microphones, and dignitaries in fancy clothes, there sits a quiet man, alone in his studio, happily working his genius from morning to night. I thought back about the three days we were there, and every time I'd peek into David's studio, he was still working on that horse's knee! Without that focus, Hot Lake would probably still remain abandoned.

You are a creative and when you get into your "heavenly" zone, whether you're cleaning bathroom tiles, playing with your children, or creating a masterpiece, enjoy your zone time, but have ways out because you do live in the world too.

Turnovers Leads to Lancers Losing Tough Playoff Opener

SACRAMENTO, CA (MPG) - Throughout the season, the Cordova High School football team has found ways to score a touchdown or field goal, once inside an opponents' red zone.

That led to the Lancers producing a 7-3 overall record. That included a 4-1 mark to win a share of the Sierra Valley Conference title with Liberty Ranch and El Dorado, and Cordova's first league title in 25 years.

The scoring continued for Cordova against Christian Brothers in the first round of a Sac-Joaquin Section Division III playoff game at Hughes Stadium on the Sacramento City College campus. But turnovers, both inside the Falcons' red zone, were the downfall for the Lancers.

That led to Cordova, the No. 14th seed, being clipped by the Falcons 30-20 on Nov. 11th. This was the Lancers' first playoff appearance since 2006. Christian Brothers, the No.3 seed, is 3-0 against the Lancers in playoff meetings between the two schools.

"We had a total of four turnovers," said Cordova head coach Darren Nill. "It's pretty hard to win a playoff game when you have four turnovers."

The Lancers led 14-12 entering the fourth quarter. The Falcons soared to the lead, courtesy of a Lancer fumble, on an 18-yard pass. Along with the 2-point conversion, Christian Brothers led 20-14 just one minute into the final quarter.

Then the Falcons bumped their lead to 22-14 on a safety in the Lancers' end zone. Christian

Brothers added its final touchdown of the game on another pass, this time of 32 yards. Another 2-point conversion gave the Falcons a 30-14 advantage with six minutes remaining in the contest.

"This was a hard-hitting, fun type of game," Nill said. "It wasn't chippy; both teams were helping each other up (after plays). Just out there, having a good time playing football. That was really fun to watch."

But the Lancers never gave up. On its next offensive drive, Cordova trimmed the lead to 30-20 when quarterback Xavier Johnson scored on a 14-yard run. Toward the end of the quarter, the Lancers had the

ball again, but an interception led to Falcon possession and victory.

Cordova recorded its first touchdown of the game with a minute left in the opening quarter. Johnson completed a 29-yard pass to wide receiver Alvin Banks for a 6-0 lead.

"We really took it to them," Nill said. "Through three quarters, we were the best team out there."

Christian Brothers tied the game at 6-6 on another TD pass from quarterback Tyler Vander Waal, who threw four in the game. The score remained that way at half-time. Then in the third quarter, the Lancers took a 14-6 lead when running back Deante McCullough scored on a 70-yard run. Johnson

ran in the 2-point conversion.

Lancer defensive end Kelechi Njoku, a junior who also doubles as one of the team's running backs, led the squad in tackles with 12. Linebacker Yusef Pugh followed with eight tackles, defensive back Bryan Estrada seven and linebacker Jason Johnson and middle linebacker Kenneth Haney had six each.

Cordova wasn't the only SVC champion eliminated in the first round of the playoffs. Liberty Ranch was within reach of Placer, 14-7 in the first quarter but fell 42-21, in a D-IV contest in Auburn. In another D-IV playoff opener, El Dorado led 20-10, but fell to Los Banos, 23-20. ★

Of the 39 players on the roster, Nill loses 19 seniors to graduation next spring. Some of those players are running back Deante McCullough, who rushed 145 times for 1,339 yards and 16 touchdowns, and middle linebacker Kenneth Haney, who led the Lancers in tackles with 91. Linebacker Michael Gonzalez was another factor on the Lancers' defense, with 53 tackles.

The next two years should put Cordova in the driver's seat toward battling for the SVC title. With 20 players projected to return in 2017, six are sophomores and 14 are juniors.

"You can never rule out Liberty Ranch and El Dorado," said Nill of the Hawks and Cougars. "You never know what's going to happen in the SVC. Nobody thought Cordova was going

to be around, and look what happened."

Leading the list for the Lancers is sophomore quarterback Xavier Johnson, who completed 123-of-221 passes for 1,862 yards and 19 touchdowns. Johnson also had a quarterback rating of 93.4 percent.

Other key players expected to return are running back defensive end Kelechi Njoku, who scored seven touchdowns and second on the team in tackles with 74. Wide receivers Calvin Augusta, a junior who had 852 yards in receptions and eight touchdowns, and sophomore Alvin Banks, who had 594 yards and seven touchdowns.

Junior linebacker Yusef Pugh registered 67 tackles, and defensive back Terrill Johnson – one of four Lancer players on this year's team who has the last name Johnson – had 58 tackles. ★

In fifth and final set (to 15 points), the two teams traded the lead a few times before the Beavers went on a run that put the match away, 15-6. Despite the loss, it was an exciting night at Falcon Gym and proof that Falcons can play with anyone in the Big 8. Falcon freshman Kylie Haverson again lit up the stat sheet with her 23 kills and 16 digs. Middle hitter

Emma Flewell had a big night as well with her 17 kills, while setter Samantha Hegseth provided 30 assists and added 14 digs. The Falcons finish off the regular on Wednesday night when they host Diablo Valley at Falcon Gym at 6:30 pm. They'll then await the pairings for next week's CCCAA state playoffs, which begin next Tuesday November 22.

The Falcon men closed out the season with a home match against Delta College on Friday

night, and for a big chunk of the match it appeared the Falcons would finish the season with a victory. Freshman Miguel Medina added to his team-leading scoring total (7) when he netted a goal midway through the first half. But the Mustangs were just as determined to get a win as they tied the score ten minutes into the second half. With time winding down, both teams were desperately looking for the winning goal and it was Delta who found it in the 88th minute,

securing the 2-1 victory. The Falcons finish at 6-10-4 overall (their most wins in any season) and 3-7 in Big 8 Conference play.

Women's Soccer

The Falcons closed out their regular season with a 7-0 win over host Sacramento City on Thursday night, then learned late Friday (after American River tied with Big 8 leader Santa Rosa) that they were the Big 8 co-champions with Diablo Valley College. Five different players scored for the Falcons, led by sophomores Leily Ghods

and Paty Navarro with two apiece. Also scoring were freshmen Jackie Kittredge, Keionna Claypoole, and Paige Verneuille. With the win, the Falcons closed out the Big 8 schedule with a 10-3-3 record. With Santa Rosa unable to earn a victory on Friday night, FLC and Diablo Valley found themselves tied atop the final Big 8 standings. DVC finished at 9-1-6 (33 points; 3 for each win, 1 for each tie) while the Falcons also finished with 33 points, thus the earning the co-championship. The Falcons will now set their sights on the state playoffs, which begin this Saturday November 19. The pairings will be determined at Tuesday's Norcal seeding meeting, but Falcon head coach Donny Ribaudo expects to be a #2 or 3 seed, meaning at least two home playoff matches – and possibly three – as long as the team keeps winning in the single-elimination tournament.
