# Planting a Future

Leadership Class Plants 27 Trees at Hagan Park

RANCHO CORDOVA. CA (MPG) - ()n Saturday. May 14th, nine members of this year's Leadership Rancho Cordova Class X planted four species of trees in the dog park at Hagan Community Park, located at 2197 Chase Drive. Also lending a hand were Sarah Saetern and Rachel Pittman from the Sacramento Tree Foundation (STF) and three friends and family of Leadership Class members.

Planting procedure for each of the trees included removing the tree from a 15-gallon container, loosening its roots and soil, placing the tree in the hole that was dug by park personnel using an auger, backfilling the soil in the hole, staking with two heavy-duty stakes and ties, and finally creating a berm and placing mulch around the tree base to conserve water and soil moisture.

"The 4-hour planting went without mishap except for when the auger hit a water main; but fortunately the machine operator is a park irrigation staff member and he was able to quickly take care of the problem," said Horacio Oropeza, Park Services Supervisor and a member of this year's Leadership Class.

The planted trees, all donated by STF, include 10 Red Oak, 10 Sawleaf Zelkova, two Willow Oak, and five Valley Oak. Saetern, STF Community Forester, selected the species of trees and where they should be planted. She gave "special thanks for the chance to work with Leadership Class members and the park district staff. There was great team work and we got a lot done with a small group of volunteers. These trees will provide many benefits to the community as well as make it an enjoyable place for dogs to mingle."

The sizable planting was the start of Class X's dog park revitalization that will also include adding play equipment for dog visitors and benches for their owners. The project will be completed during the coming months and will be officially opened at a ribbon cutting during Doggie Day in the Park on September 17th.

To complete the project, Leadership Class members have participated in several fund raising projects and are asking for donations from companies, businesses, and the public. ## Cooley Stresses "Doing Good"

RANCHO CORDOVA, CA (MPG) - Although State Assemblyman Ken Cooley is in his first term at the Sacramento Capitol, he is not inexperienced. Cooley worked straight out of Berkeley for a senior member of the assembly. "He was Rules chairman, I was his top guy," Cooley said.

Cooley later worked for a state senator drafting legislation, and this was while he was also on the Rancho Cordova City Council. Having worked with Cooley on the city council for years, council member and past mayor Robert McGarvey said, "He's probably one of the most experienced elected officials there in the Capitol right now."

Therefore when Ken Cooley began his term he was able to step right into the


When Cooley spoke at the May 20th Rancho Cordova Luncheon, rather than focusing on legislation he spoke about three concepts. Persistence in doing good was the first thing. "Good doers, that's what the community needs, people who just see the need and step out to do good things," Cooley said. Since Rancho Cordova is a military town, Cooley thought everyone would also relate to the second subject – deployment. "So much of our life, I would say, is deployment of self," Cooley said. "What am I going to do this day, this week, this month? What are the priorities? What is the place where I can make a difference?'

Third is tyranny of the urgent. You start the day, Cooley said, with an idea of what you need to accomplish, and it doesn't take long for life to intervene. "There are fires to be put out," Cooley said. "Somebody calls you up with an urgent personal need. And suddenly there goes the day." With these three things as a base, Cooley talked about matters on which he has deployed himself during his term.

Cooley went on with a statement from John Stuart Mill who wrote a book on representative government in 1861. "The proper office of

# It's a Small World After All

RANCHO CORDOVA, CA (MPG) - Thousands of people took a trip around the world May 14. But they never left Rancho Cordova.

Rancho Cordova's international festival – iFest – returned to Village Green Park with a visual carnival of color, new wine tasting and chalk art activities, and attracting record crowds.

Visitors grabbed selfies scaling the Great Wall of China or Eiffel Tower with the help of green screen technology. Others hitched a ride on a pedicab, checked out local art, learned about animals from around the world, had their arm tattooed with henna or took a swing at a Mexican piñata. An estimated 4,000 people visited iFest 2016.

Children searched for treasure during the Go for the Gold Scavenger Hunt and scrambled through a Brazilian Rain Forest climbing adventure while food trucks served up everything from Filipino lumpia to Mexican tacos.

But the shining jewel of the event was the jam-packed amphitheater, which was full from beginning to end as host Andy Gee directed the traffic on stage during a virtual world tour. Hula dancers, lively Indian Bollywood beats, Middle Eastern belly dancers and Ukrainian Bandura musicians were just a sampling of what was in store on stage.

"iFest is about cultural understanding and appreciating our differences, as well as celebrating our common values," said Shelly Blanchard, executive director of the Cordova Community Council, producer of the event. "Everybody learns something new at iFest."







### Rancho Cordova Honors Merchant Mariners at Mather VA

RANCHO CORDOVA, CA (MPG) - "In Peace and War Remembering our Veterans and Honoring the United States Merchant Mariners" will be the theme at Rancho Cordova's 10th annual Memorial Day Ceremony. The event will be held on Monday, May 30 at Sacramento VA Medical Center Memorial Plaza, 10535 Hospital Way, Mather.

Pre-program entertainment will begin at 9:30 a.m. and will feature the Rancho Cordova River City Concert Band followed by the com-

memoration program at 10 a.m.
During World War II, it is estimated 243,000 men served in the Merchant Marine. Mariners died at a rate of 1 in 26, which was the highest rate of casualties of any service. Yet few veterans organizations accepted them, they received no veterans benefits, and they were not con-

sidered veterans
It wasn't until the late 1980s when Merchant Mariners who served in World War II were classified veterans by the U.S. Government. Those who served after and who serve now still aren't considered veterans. Rancho Cordova wants to change this by honoring Merchant Mariners to celebrate their accomplishments and help them mourn and honor the dead

### **FCUSD High Schools See Increase in Graduation Rates**

RANCHO CORDOVA, CA (MPG8) - All three comprehensive high schools in the Folsom Cordova Unified School District saw gains last year in the number of students earning a diploma – and even fewer students dropping out.

As the economy has improved, and the state has made more funding available to public schools, Folsom Cordova has invested in a variety of additional academic and emotional supports for at-risk students – including intervention teachers, mental health counselors, and new tools for teachers to better support student growth throughout the school year.

Among Folsom Cordova students who started high school in 2011-12, 92.7 percent graduated with their class in 2015, an increase of 0.9 percentage points from the year before, according to data released by the California Department of Education this week. Since 2010, the District's graduation rate has risen 2.4 percentage points.

Additionally, fewer students are dropping out of school. The dropout rate declined 1.1 percentage points, or 16 fewer students – from 4.3 percent in 2014 to 3.2 percent in 2015. The District's dropout rate has dropped 1.7 percentage points

The dropout rate does not have

graduation rate because some students are still pursuing a high school degree or its equivalent after

English learners and socioeconomically disadvantaged students saw even bigger gains in the past year. The graduation rate for English learners rose 4.1 percentage points – to 82.2 percent -in 2015, while the dropout rate for this group fell 3.5 percentage points. The graduation rate for socioeconomically disadvantaged students rose 2.9 percentage points, and the dropout rate fell 1.7 points.

Here are additional highlights from the District's three comprehensive high schools:

Cordova High School, with 344 graduates in 2015, continued to see big improvements in its graduation and dropout rates in the last year. Its graduation rate rose to 95.3 in 2015 - 3 percentage points over the previous year and 5 percentage points since 2010. The dropout rate, in the meantime, fell 1.8 percentage points in 2015, to 3.0 percent – or 11 students – 8 fewer students than the previous year.

English learners at Cordova High saw enormous gains in the graduation rate, with 88.3 percent of students earning diplomas improving 10.7 percentage points over the previous year. The rate of English learner students dropping a precise correlation with the out also fell sharply, from 13.4

percent to 8.3 percent.

Cordova High graduates from socioeconomically disadvantaged backgrounds also increased, by 4.3 percentage points to 94.8 percent in 2015. The rate of dropouts in this category of students also fell, by 2.9 percentage points.

The graduation rate at Folsom High, which had 466 graduates in 2015, has continued to grow in recent years, to 98.3 percent. That's 0.9 percentage points since 2010. In 2015, all but one English learner (11), and all but one socioeconomically disadvantaged student (88), graduated.

Vista del Lago High School has the highest graduation rate in the District, at 98.8 percent. In other words, only four students out of the 335 seniors at Vista del Lago High School did not graduate in 2015, and the school did not report any dropouts. (The dropout rate does not have a precise correlation with the graduation rate because some students are still pursuing a high school degree or its equivalent after four years.)

While only half of English learner students at Vista graduated in 2015 (the state did not provide an exact number, to protect student privacy where there are 10 or fewer students), 100 percent of socioeconomically disadvantaged students (40) at Vista graduated that year.





### Honoring Pearl Harbor Survivors



a representative assembly is to watch and control the government, to throw the light of publicity on its acts, to compel a full exposition and justification of all of them, which any one considers questionable," Cooley

Oversight, Cooley feels, has been greatly diminished in the legislature over the past 20 years. He accepted the position of chair of the Rules committee even though it meant he could not chair a policy committee. "When it comes to oversight functions, take off your party hat . . . I point out to (those who have taken an oath of office) that oversight is a chance for us to start to learn as members to function together and not fight over partisan issues." Cooley has now put together a guide on oversight. "In collaboration with staff, for the first time in probably 40 or 50 years, the California State Assembly has a Legislative Oversight Handbook," Cooley said. "I feel like this is an example of being personally persistent in doing good."

Paul Andersen, a safety professional who came to the luncheon specifically to hear Cooley speak, said that we need people who are responsible and ethical themselves to be on the ethics committee. "I really appreciate that Ken is of the people, for the people, and regardless of his party, I will always support him and follow his lead." Andersen said

Cooley is the chair of the subcommittee on foster care. He has introduced legislation dealing with the issues of human trafficking, child abuse generally, and child sexual abuse. Lots of kids end up in trafficking out of the foster care system, he said. "I feel part of my responsibility as a member," Cooley said, "since I'm pretty experienced in legislative work and advocacy, is to be an advocate for people who don't have an advocate."

"That is one of our main goals for next year," Hughes said. "For us to be successful we need to build from the ground up."



Leading Cordova in hitting this season was Logan Appino, shown here during a recent home game, with a .488 batting average.





## **America Marches Blindly Toward Single-Payer**

Hillary Clinton just dipped her toe a little bit further into the waters of single-payer health care, prodded by her competitor for the Democratic presidential nomination, Bernie Sanders.

She recently called for allowing more people to join Medicare - the government-run healthcare program for seniors - by allowing those "55 or 50 and up" to buy into it. Sanders can no doubt take credit for pulling her further left – his proposal to expand Medicare to all Americans has evinced cheers from his partisans.

But the record of other single-payer systems should silence those cheers. Single-payer would destroy health care quality and rob patients blind in the process.

Sanders has been agitating for single-payer for decades. The supposed price tag of his latest proposal for "Medicare-for-All?" About \$14 trillion over 10 years, he's claimed.

But according to studies from the Urban Institute and the Tax Policy Center, the real cost would be about \$33 trillion. Even after accounting for the revenue that Sanders's plethora of new taxes would take in, the government would still need \$16 trillion.

Nevertheless, Sanders's focus on single-payer has attracted

#### **Berryhill Response to** Legislature's **Attack on Gun Owners' Rights**

SACRAMENTO, CA (MPG) - Senator Tom Berryhill (R-Twain Harte) issued the following statement in response to the Legislature agreeing to a package of bills that further restrict the rights of California's law-abiding gun owners:

"If this body were really interested in making it harder for criminals to use firearms it would give law enforcement the tools it needs to track the criminals down, put them in jail and keep them there. Let's put some teeth into the laws we have before further restricting the rights of the rest of us.

"In some instances Governor Brown has already vetoed a similar policy idea. SB 1407 for example is almost identical to 2014's SB 808. His veto message says it all:

'I appreciate the author's concerns about gun violence, but I can't see how adding a serial number to a homemade gun would

significantly advance public safety.' "What the Senate passed today is an attack on the Constitutional Rights of law-abiding gun owners. It will do little or nothing to

attention. A recent survey found that 63 percent of people had a positive reaction to the term "Medicare for all." Meanwhile, thousands of doctors recently signed on to a plan similar to Sanders's.

Some states could even greenlight single-payer in the coming months. This November, Colorado voters will decide whether to create a state-level single-payer system. The initiative would cost \$38 billion annually and require billions in new taxes.

Coloradans should take note of another state that tried to implement a single-payer system and failed -Sanders's home state of Vermont.

The state's attempt at singlepayer in 2014 was projected to cost \$4.3 billion - almost equivalent to the state's entire \$4.9 billion budget. To fund the program, Vermont would have needed an extra \$2 billion in revenue plus new taxes on businesses and residents. Officials abandoned the idea because it would have collapsed the state's economy.

The recent history of singlepayer systems sponsored by the federal government isn't much more encouraging.

Take the Veterans Health Administration, which continues to subject beneficiaries to lengthy waits for care. In March, the Government Accountability Office tracked the experience of 180 newly-enrolled vets and found that 60 waited as many as 71 days to see a primary care doctor. Sixty more never even managed to get an appointment.

Patients haven't fared much better under single-payer systems

Horror stories from Britain's National Health Service emerge almost daily. Recently, a

government investigation found that hospitals are discharging elderly patients without ensuring that they're fit to go home.

This spring, thousands of junior doctors went on strike. Patients had no choice but to wait for the walkout to end, as hospitals postponed more than 112,000 appointments and 12,700 operations in response.

Canada, my native land, has similar issues. Canadians must wait an average of 18.3 weeks to see a specialist after getting a referral. That wait time is 97 percent longer than it was in 1993.

Almost 900,000 Canadians are waiting for treatment.

The promise of single-payer high-quality, universally accessible, free - is nothing like the reality of such a system. Taxpayers pay dearly for the promise of such care.

This fall, voters must not allow themselves to fall prev to the siren song of single-payer.
