# **Shaved Heads Support** Cancer Research



RANCHO CORDOVA, CA (MPG) - On March 14th, a stand was set up in front of Rancho Cordova City Hall, and 15 volunteers took turns getting their heads shaved as a token of solidarity with six local children who have suffered from cancer. The volunteers ranged in age from 5- to 60-years-old.

Emily Marler, 16 and now cancer free, is one of those six and was there to support the cause. She is a two-time survivor, the first a rare type of liver cancer she developed at age 12. She was treated with aggressive chemotherapy, and after a year and a half of being cancer free, developed acute myeloid leukemia. Emily received a bone marrow transplant and was in complete isolation

"It may not have been a great thing to go through," Emily said, "but I'm glad that I went through it because if I didn't, I wouldn't be who I am today, and I'm proud of who I am today."

Other honorees are Timothy B., 6, in remission; Dalton W., 5, in treatment; Thomas R., 8, no evidence of disease; Karyn Pearl S., 5, cancer free; and Kitauna G., 17, in treatment.

St. Baldrick's Foundation began fundraising for childhood cancer in 1999, and Rancho Cordova joined in for the first time in 2015, taking in around \$14,000. Contributions reached \$9,000 on the day of this year's event, and more will be applied to the total as it comes in through the end of March.

# Community Celebrates New Performing Arts Theater

\$22 Million State-of-the-Art Facility Long-Awaited by Rancho Cordova Students and Community

RANCHO CORDOVA, CA (MPG) - Students, families, alumni and community leaders on Thursday, March 17th, celebrated the grand opening of Cordova High School's \$22 million state-of-the-art Performing Arts Theater, a long-anticipated resource that will benefit not only generations of student performers, but will serve as a sought-after gathering place for the Rancho Cordova community.

The 35,000-square-foot facility features a 464-seat theater and modern rehearsal and classroom space for Cordova High's band, choir, and drama programs. Dressing rooms, an orchestra pit and full audio, visual and lighting amenities will provide students, teachers, and community members with the professional tools they need to put on high quality productions. The project, which broke ground in May 2014, was financed through bond proceeds previously approved by Rancho Cordova voters.

Thursday's grand opening celebration will

# **Project 680 Collects Hoodies and Polos for Homeless Students**

RANCHO CORDOVA, CA (MPG) - Homeless students in the Folsom Cordova Unified School District need supplies. Right now the call is out for new uniform polo shirts for elementary school children in black, navy, and white. New hoodies, especially in children's small and medium sizes, and youth/adult medium and large may be in uniform or other colors. The items or donations can be dropped off at Rancho Cordova City Hall by March 31st.

"Walmart has a little section within the kids' clothing area," said Melody Granger-Mayer of Cordova Community Council. "They actually have a couple of little racks specifically all grouped together that have the standard polo shirts that the schools use. You can get them other places, but they definitely are the cheapest that we've been able to buy."

In 2008, members of the community became aware, through the FCUSD District Liaison for Homeless Services, that there were 680 homeless students in the District. Project 680 took its name from that number, and set out to provide for needs that many of these students have no way of fulfilling. The informal drive in 2008 intended to collect 680 pairs of socks and ended up with 3,144 pairs. Since then there

have been other drives to supply clothing, hygiene items and other necessities for the homeless students in the District.

"I love that our district goes the extra mile," said Joe Rich, committee chair of Project 680. "California requires that we provide our homeless students with a full and equal opportunity to succeed in District schools... Succeeding sometimes means more than just enrollment.

"Sometimes our parents need help navigating the system and finding the help that is available in our community. So I'm happy to participate in any event where we can stand up with these employees and show these students (and their parents) that this is a caring community."

The plight of homeless children affects more than most people would expect, with the current count within FCUSD at 783 according to the last count available. The challenge is the same throughout Sacramento

County school districts. In 2011, according to the Project 680 website, there were 7,254 homeless children and youths, a jump of more than 50 percent since 2005.

As the Project 680 website states, "homeless" is defined as "an individual who lacks a fixed, regular, and adequate residence." The students that the school district serves in Folsom and Rancho Cordova are living in unstable places like motels, in homes without a parent or legal guardian, in homes without power or water, in RVs in parking lots, in cars, in tents, on the streets, and more.

Because Project 680 does not have official nonprofit status, Cordova Community Council provides fiscal oversight for the group. "The Cordova Community Council accepts donations on their behalf," said Granger-Mayer. "The money that's collected can then be used to purchase additional items or whatever it is that is needed (for the homeless students)."

The final drop-off and celebration for the drive will be 5 to 9 p.m., Thursday, March 31st, at Rancho Cordova City Hall. Refreshments will be served.

Project 680 is managed by a volunteer board of community members that consists of Joe Rich, Melody Granger-Mayer, Lorianne Ulm, Sheryl Longsworth, and Ryan Lundquist. ★



alarming. "More children are lost to cancer in the U.S. than any other disease, more than all other childhood diseases combined," said Shelly Blanchard, executive director of Cordova Community Council. "Before they turn 20, one in 285 children in the U.S. will have cancer, and worldwide a child is diagnosed with cancer every three minutes."

The first four to mount the shaving block were Rancho Cordova Vice Mayor Donald Terry and his 5-year-old son Keaton; Zak Ford, vice president of the Folsom Cordova School Board; and Anil Kondakrindi, a Rancho Cordova software engineer and vice president of the Sacramento Telangana

Association. Good humor and jokes at the "shavees" expense accompanied innovative shaving techniques by Breanna Stahl, Megan Thrasher, and Laura Curtes, who undertook the procedure for Terry, Keaton, and Kondakrindi respectively. Jessicah Ford carried out an imaginative process on her brother, Zak Ford. All the hairdressers are from Aveda Salon in Roseville.

Terry gave special thanks to event organizers Ashley Downton, communications specialist, and Lorianne Ulm, community engagement analyst. "Last year I sprung this on Ashley and Lorianne," Terry said, "who out of the goodness of their hearts put this event together in about

ten days... It's a great testament to our community and to our city that we hosted an event like this.'

Zak Ford joined with Terry to support this Rancho Cordova event. "This is really a minor thing to do for the greater cause," Ford said. "This is something that's absolutely heartbreaking and needs to be resolved."



On March 16th, also a home game, the Lancers led 5-3 going into the top of the seventh inning.


But the visiting Diamondbacks rallied in their last at-bat with six runs. By the end of the game, Union Mine outhit the Lancers Prior to the D'backs scor-

There are some USC Trojans who will be haunted every time they step to the free throw line by visions of their missed shots late in a loss in the 2016 NCAA Tournament. There will be a Northern Iowa star who will remember (probably above all of the great moments in his career) his two unwise, hurried shots in the final minute, while some of his teammates will clearly recall panicky turnovers that helped blow a 12-point lead in the closing 45 seconds of regulation that gave Texas A&M the chance to steal the game.

A couple of Stephen F. Austin Lumberjacks will be kicking themselves for not blocking out on a rebound that gave Wisconsin the opening to tip in a missed shot at the buzzer for the win.

The entire No.-2 seed Michigan State team, picked by many to reach the Final Four and possibly go all the way, will forever shake their collective heads when thinking about their performance against No.-15 seed Middle Tennessee State in a first-round defeat. When Denzel Valentine (a Player of the Year candidate) and fellow Spartans seniors Matt Costello, Bryn Forbes and Colby Wollenman --- a legendary group that won 109 games together --performed the traditional kissing of the mid-court MSU logo after a decisive win over Ohio State on Senior Night, little did they know that their fond memories of their final season would be tarnished by such an abrupt ending.

Closer to home, it was instant bad karma for the Cal Bears when an assistant coach was

Way back when you were promptly fired after a long-run- the cut, but five (Cal, Colorado, ning investigation into sexual harassment violations (there's a regrettable mistake) came to light on the verge of a potential deep run in the tournament. A No.-4 seed in the South bracket (Cal's highest-ever seeding), it all went wrong in a hurry. Point guard and leading scorer Tyrone Wallace broke his hand in practice and sharpshooter Jabari Bird suffered severe back spasms before the game, and neither played in a first-round loss to No.-13 Hawaii, 77-66. That may have been called an upset, but, under the circumstances, it was no surprise.

Potential NBA draftee Jaylen Brown got into early foul trouble and was limited and ineffective, and fellow freshman star Ivan Rabb had little help against the Rainbow Warriors, who won their first-ever NCAA Tournament game. (It appears that duo are likely to be high NBA picks, though they might be betterserved by returning to Cal for a second season. Brown has the powerful body, but is inconsistent and needs work on shooting, while Rabb is more refined in his skills, but needs work on the body).

In what could have been a remarkable dream season for coach Cuonzo Martin's 23-11 Bears, --- don't forget they crushed Oregon at home by 20 and lost on the road at Virginia in overtime (two teams in the Sweet 16) --- it all fell apart quickly on the doorstep of grand success and crumbled into an unimaginable nightmarish finish.

But in a sense, this is a tournament of losers. Out of all of the 68 entrants, just one will conclude its season with a victory and a championship, while the 67 others will forever have thoughts about the "what ifs" and the mistakes made along the way that led to their demise.

As a group, the Pac-12 will not have much to cherish regarding its showing in this year's tournament, thus far. A record seven teams from the conference made

Arizona, Oregon State, USC) lost in the first round. After an opening win over Fresno State, Utah was trounced by Gonzaga of the West Coast Conference, 82-59. All six losses were to lower seeds. With wins over Holy Cross and St. Joseph's, Oregon, the top seed in the West bracket, was to meet defending-national champion Duke Thursday.

Surprises were not exclusive to the Pac-12, however. Lowerseeded teams won 12 of the 32 first-round matchups and three lower seeds won in the second round. All four top seeds in the West bracket played in Anaheim --- Oregon, Duke, Texas A&M and Oklahoma --- reached the Sweet 16. Two double-digit seeds survived to advance and face each other in the Midwest Regional, Gonzaga (11) and Syracuse (10).

That all makes you wonder, again, how St. Mary's College of the WCC might have fared had it been chosen to participate. The Gaels lost a close game at Cal and defeated Gonzaga twice during the regular season, but lost to the Zags in the WCC tournament title game and missed out on the automatic berth.

Playing, instead, in the Not Invited Tournament (NIT), also known as the National Invitational Tournament, coach Randy Bennett's Gaels (29-5) held on to edge New Mexico State, 58-56, and beat the Georgia Bulldogs, 77-65, in games at McKeon Pavilion in Moraga, to reach the quarter-finals. They were to play at Valparaiso (Ind.) Tuesday night for a chance to go to Madison Square Garden for the secondary Final Four.

When it is all said and done, even if St. Mary's was to win the door prize at The Hop, the Gaels will all remember and perhaps shed a tear or two over losing that last go-round against Gonzaga and missing out on their ticket to The Dance.


