Meet the Winter Wildlife Vernal Pool Critter Educational Walks Begin

RANCHO CORDOVA, C (MPG) - At this very moment, a feeding frenzy is happening beneath the surface of Sacramento's vernal pools. These rare seasonal wetlands host a dazzling array of tiny creatures that survive for only a few weeks and live only in vernal pools. With El Niño upon us, hopes are set on seeing heavy rains and lots of water in the Mather Field Vernal Pools.

Grapevine

During the wet phase, the vernal pools host dozens of species of aquatic invertebrates. Half of them have not even been named! Bigger critters that eat them come to the pools to dine: frogs, snakes, birds, and more. Don't miss your chance to experience the wet and wild phase of the Mather Field Vernal Pools!


The educational tours begin at the Splash Education Center, where you'll meet minuscule creatures up-close using magnifying glasses and microscopes. You'll tour Critterville for a close look at some of the amphibians and reptiles that begin their lives in vernal pools. Then you'll venture out to the vernal pool prairie to see how the animals live in the wild.

Vernal pool tours are free! All ages are welcome. Bring sunscreen and wear a jacket/windbreaker, long pants, and closed-toed shoes. Waterproof boots are good, but not essential. Reserve your spot early—space is limited and reservations are required.

Tours will be held Sunday, March 6th from 10 a.m. to 12 p.m., and Sunday, March 13th from 1 p.m. to 3 p.m. To make a reservation (required), visit www.sacs-plash.org or call (916) 364-2437. The Splash Education Center is located at 4426 Excelsior Road, Mather, Calif., 95655. Children must be accompanied by an adult.

Free Dental Day Success

Over \$14,000 Worth of Work Was Provided to the Underprivileged Kids Through SDDS

RANCHO CORDOVA, CA (MPG) - Imagine a whole office of dental professionals working all day without compensation, just because they want to help kids. That is what happened on recently at the Smile Kingdom.

Smile Kingdom Dental owner and operator Jose Juarez, D.D.S., his practice manager Danielle Mendoza, dental assistants Aida Camper and Robyn Alongi, and office volunteer Erin Castleberry, worked an entire day to give qualified kids the chance to overcome their dental problems. The Sacramento District Dental Society (SDDS) program also sent a dentist, Dr. Penumetcha, and her assistant to help with the higher volume this year.

Last year at Juarez's office just six patients came to receive treatment on the special day set aside. Others were scheduled but did not show. This year, 17 patients I love to give kids a smile day, it brings me back to my dental assistant roots and being in the community helping the dentists help the kids.

were treated and there was only one no-show, perhaps indicating that the process is becoming more clear to parents of the children who are screened and recommended for the program. Work done included 17 exams, cleanings, and fluoride treatments, 100 x-rays, 16 fillings, one root canal, three crowns, and seven extractions—totaling a dollar value of \$14,026.

The dental treatment performed

at no cost for patients at the Smile Kingdom Dental office is the culmination of a long process that begins each year with the schools. Under the SDDS program, schools in a five county region—Sacramento, Placer, Yolo, Amador, and El Dorado may opt to have dental screenings performed for the children by volunteer dentists associated with the dental society's charity dental program. The dentists do screenings at the various schools in the fall.

According to Erin Castleberry, students are given a score of one, two, or three. "One means they look good, two means they probably should see a dentist, and three means [the dentist] visually can see urgent needs," Castleberry said. The school follows up on those rated with a three to see if they have dental insurance. If they do not have insurance, those children are referred to the SDDS Smiles for

New Luxury Apartments Coming to Rancho Cordova

RANCHO CORDOVA, CA (MPG) - Rancho Cordova will welcome a new luxury apartment complex to the community. Bridgeway Square Apartments will have 199 units, a clubhouse, an outdoor pool area, and parking at the southeast corner of Bridgeway Drive and Data/Disk Drive.

The project was approved by the Rancho Cordova City Council on Tuesday, Feb. 16th as a result of its focus on providing an appealing home to millennials and more than 50,000 business professionals in the surrounding area.

"Bridgeway Square Apartments will be the first of its kind in high-end apartment living in the City of Rancho Cordova," said Rancho Cordova Mayor David Sander. "Business professionals are looking for a home within walking distance to work, restaurants, and shopping, and Rancho Cordova can now provide that. We look forward to seeing this development come to fruition in our growing City."

The project is located next to the Capital Village shopping center that includes amenities such as Panera Bread, Lowe's, Anytime Fitness, and more. The adjacent park will hold free

events throughout the year such as iFest International Festival, Moonlight Movies, and Summer Concerts Series.

The project applicant, The Spanos Corporation, will now submit applications for building permits and improvement plans to construct the new housing complex. A timeline has not yet been

established pending submittal.

"Rancho Cordova is a great location for us to develop a luxury apartment project given its broad employment base and high growth rate," said Alexandros Economou, executive vice president. "Bridgeway Square Apartments is envisioned to be top of the market along the US-50 corridor

and will provide another housing option for the 50,000 plus employees, especially millennials, currently commuting into Rancho Cordova every day for work."

Born in rural Minnesota, she met her future husband while in high school and they wed in 1960. She followed him in his 23 year





Kids program.

Castleberry, who worked previously for SDDS, now works as an administrative specialist for the Sacramento Metropolitan Fire District. "I worked with the program for 10 years, so it's kind of my baby," Castleberry said. "[The kids] come in scared. A lot of times they come in with a lot of problems, and oral health in kids is so important. It really affects their whole overall health in their whole body, so it's really important to get them off on a

good start."

Alongi works now for the California Dental Association Foundation, and was back just to help out. "I love to give kids a smile day," Alongi said. "It brings me back to my dental assistant roots and being in the community helping the dentists help the kids." She worked in x-ray and sterilization.

A limited number of dental offices participate, which Castleberry estimates at 25 to 40 offices in the entire five county region. "From what I know," said Practice Manager

Danielle Mendoza, "we are the only ones in Rancho Cordova participating with this charity."

If the child needs work from a specialist, something that can't be done on that day at that office such as orthodontics or another specialty, the parents are instructed to call SDDS and the dental society has a list of specialists who will complete the treatment at no cost.

For more information about the dental program, please contact your school and ask if they participate in the SDDS annual dental screening.

The American Legion's National Commander Dale Barnett spoke about the history of our country when he wrote about the book "The Bonus Army."

"American History is punctuated by moments and history that become prisms through which larger events are better understood-the Boston Tea Party, Nat Turner's Rebellion, the Alamo, John Brown's Raid. The march of the Bonus Army belongs in such company. The first veterans who marched to Washington D.C., to petition for their benefits that they believe they deserved, were soldiers from WWI, and they

chased away by soldiers under federal orders. But its significance has been obscured by time, even to its direct beneficiaries-the millions of later veterans whose bonus would be the GI Bill and the benefits that have followed to the present day.'

A retired Air Force master sergeant Lionel Leblanc said he "wanted to honor not just his fellow veterans, but those men and women fighting today. 'They've been shortchanged,' LeBlanc said. 'We allow refugees to slip into the country to receive benefits while veterans sleep under bridges.'

Mather Veterans Village will be a shining example of what the citizens in the City of Rancho Cordova can do, and are doing for our veterans. I spoke in the past about the defense cuts that are placing us and our country into a very dangerous position in the world today. There are now less than 1 percent of our populations serving in the armed forces of the United States of America. And only 16 percent of the elected officials in Washington D.C. have any military background. Perhaps that's why they really don't understand why the veterans of today need more support from Washington than they receive. Cutting our National Defense

marched in 1932. They were is being done when the world is not at peace. This coming election in November will be of great importance for our country and the world.







Sacramento State President Toughens up on Goals

RANCHO CORDOVA, CA (MPG) - For a man who said that originally he "just wanted to be a cowboy," Dr. Robert S. Nelsen has done pretty well in higher education. In his address at the Rancho Cordova February luncheon on Feb. 19th, Nelsen provided a look at his background, his improvements and his plans for the future at California State University, Sacramento, also known as Sacramento State, where he began as the eighth permanent president on July 1st, 2015.

Nelsen and his wife made the choice for him to come to Sacramento State in large part because, of all the universities west of the Mississippi, California State University is what most people would call the seventh most "diverse."

"I'm trying to get away from the word 'diverse,' because that's about separation," Nelsen said. "We're the seventh most inclusive. ...What we've done is we've made education affordable here." The Sacramento State tuition, at \$5,412 per academic year is among the 10 percent lowest in the United States.

Nelsen talked about what he is doing at Sacramento State. He talked about helping to bring two large corporations into the Sacramento area that will eventually provide nearly 5,000 jobs between them, by providing the curriculum and the brain power that will supply the skilled work those companies will need to have done.

He talked about helping students avoid the costs and wasted time of a year of remedial work because they did not take the classes they needed before coming to university. He talked about his five-year goal to raise the four-year graduation rate from 8 to 25 percent, and the six-year graduation rate from 46 to 60 percent.

He advised those who attend a community college before transferring to Sacramento State to get the full Associates Degree. He said he was not proud that of those who transfer without the degree 76 percent graduate within four years after the transfer. "I'm disgusted by it," Nelsen said. "Because they probably took four years to get there, and now we're saying another four years? That's an eight year graduation rate. If a student has completed their Associates Degree and has the full degree, 85 percent of them graduate in two years, because there is no losing of classes."

Nelsen grew up on a ranch in Montana, earned

a bachelor's and master's degree in political science from Brigham Young University, and his doctorate from the University of Chicago's Committee on Social Thought, where his fields of study were modern literature, modern philosophy, and modern political theory.

After teaching English at the University of Illinois, Chicago, Nelsen spent 18 years at the University of Texas, Dallas, where he founded and was director of the creative writing program, and served as professor of literary and aesthetic studies, and as vice provost.

After a stint in 2008-2009 at Texas A&M University he moved back to the University of Texas as President of the UT Pan American, where he helped create a new University in South Texas. "I did that because my students down there were impoverished," Nelsen said. "So, when we found a loophole in the constitution that allowed us to be able to create a new university and get into the Texas permanent university fund-14.98 billion dollars in West Texas

oil money-I said: 'I'm going to work myself out of a job, but I'm going to do it for my kids.³ And I did it. And today there are 348 million dollars in new buildings coming up there and a new medical school."

When Nelsen concluded his address, he said he had to do something. He proceeded to approach the audience, and shouted at the top of his voice, "Sac State number one! Stingers up!" holding his pinky finger up in the classic sign of the of the Hornets' stinger.

"He is student driven and student focused, which is tremendous," said Robert Dugan, director of governmental and civic affairs at Sacramento State. "He's got everything focused on how we help students be successful and be ready to walk out with a degree and contribute to society. That is his driving focus, which drives all of our activities."

Natural Gas Becomes a Real Mess

The Porter Ranch Disaster May Erase the Industry's Undeserved Reputation as a Clean Energy Source

Until late last year, Laura Gideon's family lived in Porter Ranch on the outskirts of Los Angeles. "We didn't ever want to leave," Gideon told the Associated Press. It's "a nice gated community."

What uprooted them from one of LA's wealthiest pockets? They became climate refugees when the nearby Aliso Canyon natural gas storage well sprang a nasty leak.

Clouds of gas have billowed from the faulty well, which lacked a subsurface shutoff valve, for three and a half months. After inhaling nonstop plumes of methane, benzene, and other toxic chemicals, local residents began to suffer nausea, vomiting, headaches, and nosebleeds. The disaster has also smacked local businesses hard and eroded real estate values.

Erin Brockovich, the activist and legal researcher made famous by an Academy-award winning film depicting her against-all-odds victory against another California utility, lives only 30 miles away. Now working with a law firm to help the locals file claims, she calls the Aliso Canyon leak a "BP oil spill, just on land" — because of its magnitude, duration, and climate impact.

And that's why this incident imperils more than the people who live there and the bottom line of Southern California Gas Co., the local utility that ran the well.

Just as the Gulf Coast disaster invigorated opposition to offshore oil drilling, the Porter Ranch debacle may sap the natural gas industry's popularity. Above all, it's exposing the fuel's persistent reputation as "clean" and climatefriendly as a complete lie.

Environmentalists, backed by ample research, have struggled to debunk that narrative for years.

Although burning natural gas releases less carbon dioxide than coal or diesel, extracting and distributing it releases methane into the atmosphere. And so do storage accidents like this one.

And methane is between 86 and 105 times as powerful as CO₂ at disrupting the climate over a 20-year period. The now common practice of hydraulic fracturing, or fracking, to obtain natural gas also pollutes waterways and squanders water — a big problem for parched California.

Environmental Defense Fund is tracking the climate damage wrought by the broken well, which is located in a vacant oil field about a mile and a half underground. The group calculates that the roughly 100,000 metric tons of natural gas that escaped is the equivalent of burning nearly 900 million gallons of gasoline.

This big climate footprint is particularly troubling because thanks to record production levels, natural gas will soon become the nation's top power source, eclipsing coal. Natural gas supplies have grown so fast that U.S. prices are crashing due to oversupply. The industry wants to fix this imbalance through exports.

Shipping the stuff overseas requires condensing natural gas

into liquid form at very high heat, using expensive infrastructure. More production will trigger more pollution and potential leaks.

Exporting liquefied natural gas, or LNG, also depends on persuading foreigners to buy it. But where are the customers?

Selling to Europe means competing with Russian producers. And the Russians stand ready to block this competition by slashing their own prices. At the same time, liquefied natural gas prices in Asia have fallen. Experts say they could plunge further as supplies outweigh demand.

In other words, the natural gas business has turned into a moneylosing venture at the same time that the fossil fuel's real costs to people and the planet are becoming clearer.

Capping the failed well won't stop all the physical, emotional, and financial distress experienced by Laura Gideon and thousands of other Southern Californians. As she told the AP: "We're in mourning now."

The natural gas industry probably is too. It's a fracking mess.




