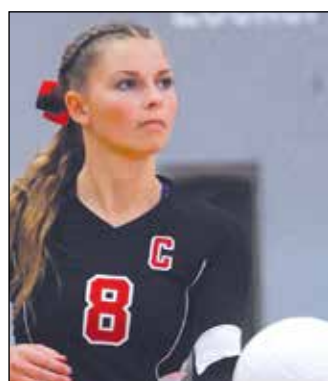

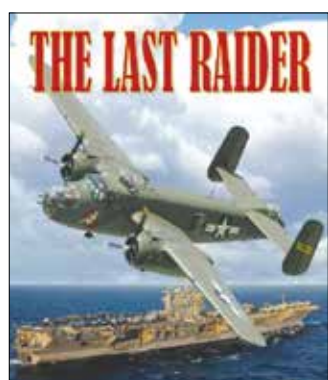

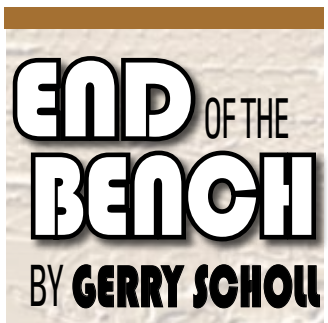

Rebuilding Homes and Bringing Joy

Volunteers Help Revamp Community Member's Home

RANCHO CORDOVA, CA (MPG) - A group of volunteers was hard at work recently helping spruce up Jim Hopkins' home. Hopkins, who inherited his Rancho Cordova house from his parents, hasn't been able to keep up the place due to medical issues.

"It was a rough looking home and not something you'd want to see when someone comes off the freeway and enters Rancho Cordova," said Hopkins.

Hopkins' Cordova Meadows home was identified as a place that could use support from Rebuilding Together Sacramento. He was one of seven homeowners selected to receive home improvements free of charge on their Fall Rebuild Day.

Volunteers worked on his home from morning until afternoon. They gutted and trimmed the yard, removed chain link fencing, built a new fence, painted rooms, and removed old carpeting. Republic Services even provided dumpsters and performed a special pick up service for the renovation at no cost.

"I had given up, and what they've done for me has given me a new life," said Hopkins. "I've got something to look forward to. I wasn't happy, and I was stuck. I had no recourse. I had no resources."

Rebuilding Together Sacramento plans to continue working with Hopkins on additional repairs, including an updated electrical system in his master bedroom and bathroom.

"They have given me a new existence. Now I'm happy as a clam!" said Hopkins.

Rebuilding Together Sacramento has partnered with the City of Rancho Cordova over the last two years to work on projects throughout the community. The organization has supported local homeowners to nonprofits like Soil Born Farms, and made lasting changes.

"Rebuilding Together Sacramento is a great partner with the City in helping us renew some of our older neighborhoods," said Vice Mayor David Sander. "It's very important for us to be sure that these long-term citizens who built our community are able to stay here as long as they can."

Rebuilding Together Sacramento plans to

- The Rancho Cordova City Council unanimously appointed Cyrus Abhar as the new Rancho Cordova City Manager on Monday, Nov. 2nd.

Abhar has served as Interim City Manager for the past four months following a vacancy in the position. Beforehand he served as the City's Public Works Director and Chief Building Official. An employee since incorporation on July 1st, 2003, Abhar welcomes the opportunity to continue to grow Rancho Cordova into a fresh and thriving community.

"Thank you to the Rancho Cordova City Council for entrusting me with the great responsibility of the City Manager," said Abhar. "I am deeply grateful to our remarkable

staff. We have an amazing team of dedicated professionals who work very hard every day to make Rancho Cordova a great place to live and this City a great place to work for."

In this role, Abhar will serve as the organization's chief executive officer, and will become one of only three people to be appointed City Manager since Rancho Cordova became a City.

Abhar is a proud graduate of the first Leadership Rancho Cordova class, a program sponsored by the City and Rancho

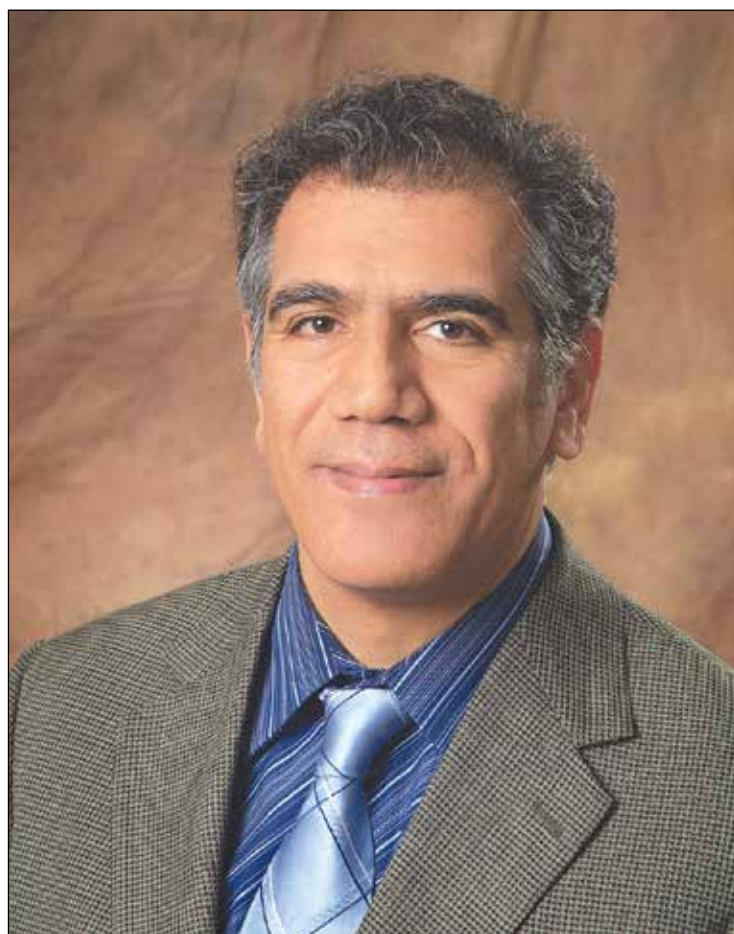
Cordova Chamber of Commerce to develop community leaders.



Governor Brown Signs Landmark Medical Marijuana Legislation

SACRAMENTO REGION, CA (MPG) - Assemblyman Ken Cooley (D-Rancho Cordova) announced that Governor Brown signed AB 266, AB 243, and SB 643, the historic package of bills that will finally regulate the medical marijuana industry after nearly twenty years of legal gray areas. The package of bills establish a balance between California’s communities’ ability to preserve influence over medical marijuana distribution within their borders and the rights secured by Proposition 215 (1996) for California’s citizens to access medical marijuana. Establishing health, public, and environmental safety rules affecting distribution and cultivation, these bills will improve the current status quo and will not alter patients’ existing rights of access to, or cultivation of, medical marijuana provided by Proposition 215.

“For almost twenty years, medical marijuana has had no standards at the state or local levels to ensure the safety of patients or the communities where this distribution takes place,” said Cooley. “Finally, California is addressing this issue in a way that carefully balances patient’s rights and the community’s needs. I am grateful to have the input and support of both Citrus Heights and Rancho Cordova throughout this process.”

AB 266 (Bonta, Cooley, Jones-Sawyer, Lackey, and Wood) creates a Bureau of Medical Marijuana within the Department of Consumer Affairs, a central head agency with accountability that will create licenses for all types of industry actors, from cultivators to dispensaries. In addition, AB 266 ensures both a state and local license must be in place for a medical marijuana business to operate, which creates both statewide standards and accountability while also respecting local control for those communities who do not wish to allow medicinal marijuana businesses. Additionally, the bill provides for a task force to help advise the Bureau regarding issues of patient access and affordability, a key component of Proposition 215’s original intent.

AB 243 (Wood) creates critical environmental standards for medical marijuana cultivation—something never before achieved on a statewide level. This bill ensures that violations of environmental standards will be dealt with swiftly and monies from those penalties used to remediate environmental damage.



“Finally, California is addressing this issue in a way that carefully balances patient’s rights and the community’s needs. I am grateful to have the input and support of both Citrus Heights and Rancho Cordova throughout this process,” said Ken Cooley.

Finally, SB 643 (McGuire) creates licensing standards for cultivation, requires background checks for all licensees, and provides for the establishment of a “track and trace” program to ensure that any contaminated medicinal marijuana can be traced back to its source.

“AB 266 proves that, for the first time, Californians can work collaboratively to develop and produce comprehensive medical cannabis regulation,” said Chief David Bejarano, president, California Police Chiefs Association. “This piece of legislation is an example of bipartisan collaboration, compromise, and growth. I am thrilled that this measure received the support of Governor Brown. We look forward to working with all stakeholders to ensure the successful implementation of this significant piece of legislation.”

“The Governor’s signature on this trio of bills represents a major victory for California cities,” said League Executive Director Chris McKenzie. “The Medical Marijuana Regulation and Safety Act establishes a different regulatory model for medical marijuana than what exists for the regulation of alcohol in this state through the dual licensing requirement that is paramount to ensure that local jurisdictions have

local control over the cultivation and distribution of medical marijuana within their communities.”

In 1996, Proposition 215, or the Compassionate Use Act (CUA), decriminalized the use of marijuana for medical purposes as it provided for patient access to medical marijuana and prevented doctors from being penalized for making medical marijuana recommendations. In 2003, the Legislature’s enactment of SB 420, the Medical Marijuana Program Act (MMPA), clarified some specifics of implementing the CUA, including issuance of identification cards for qualified patients and allowing patients and their primary caregivers to collectively or cooperatively cultivate medical marijuana. However, neither Proposition 215 nor the MMPA made any attempt to establish broader distribution standards or lay out how it would be implemented in California’s communities.

Assemblyman Ken Cooley represents the 8th Assembly District, which includes the communities of Arden-Arcade, Carmichael, Citrus Heights, Rancho Cordova, Rancho Murieta, Rosemont, Wilton, and other portions of unincorporated Sacramento County.

Examples would be a woman who helps to establish a domestic violence shelter, a woman who starts a mentoring program for at-risk girls, or a woman who lobbies her company to provide on-site child care. This program will give the club and the entire organization the opportunity to say thank you and encourage others to explore ways to assist women. Past recipients include the Executive Director of A Community for Peace



and Executive Director of the Sacramento Valley Chapter of the Susan G. Komen Foundation. An individual may nominate themselves or someone may nominate them. The application deadline is November 15th, 2015. Applicants need not reside within Rancho Cordova or Gold River city limits. However, applicants can submit an application to only one club. From the Mayor’s Corner Valley and Butte Fire Update



“The man who moves a mountain begins by carrying away small stones,” according to Confucius. What I have been hearing (and thinking) over the last few years is that what the citizens of our country want is for someone to follow Confucius’s suggestion and try not to move the mountain of hardheaded members in one fell swoop. That, as “they” say, ain’t gonna happen. The vast majority of the people of the United States are tired of waiting for the members of our Legislature in Washington D.C. to stop demanding everything they want and complete the job they were hired to do! Like everyone else, I am waiting to see if the new Speaker of the House Paul D. Ryan, will not try to move that mountain, but instead move one small hardheaded stone at a time. In other words, compromise when necessary. No one at the local city level expects to get everything they want. The members of Congress shouldn’t expect or demand everything either. The first serious storm of this winter season came through Rancho Cordova (and the rest of Northern California) during the first part of this week. With the rain that began Sunday night and into early Monday morning, the rain gauge in our backyard showed about 1/2 an inch of rain. The clouds outside were pretty grey, and I hoped they would provide more rain here and snow in the

mountains before they went east. Now, that is something you definitely can’t compromise about, but we can always hope. On Tuesday, some of us went to meet with other members of the National League of Cities at the Congress of Cities and Exposition in Nashville, Tennessee. The information that is exchanged at meetings such as these has been very helpful as we learn how other cities are coping with similar problems as we have here in cities like Rancho Cordova. The time spent will be worthwhile as we learn what is being done in other states in the US. Getting a return on an investment, and we are talking about time, helps us focus on new ways of helping (e.g.) older neighborhoods that have similar difficulties. Learning how to make things better is what it is all about. And that is whether it is your home or your city. On Monday night at our City Council Meeting, we made a very important decision for our City. The Council voted unanimously, and made Cyrus Abhar our permanent City Manager. The decision was important because Cyrus has been with us for over 10 years and knows better than many what makes the staff work very well, and even more what the people of Rancho Cordova expect of their city.

CALIFORNIA (MPG) - The U.S. Environmental Protection Agency (EPA) and its federal, state, and local partners continue the assessment and clean-up of household hazardous wastes in the aftermath of the Valley Fire in Lake County, CA and the Butte Fire in Calaveras County, CA. EPA mobilized to the two fire-impacted areas first to clear properties near public schools in Lake County, then more broadly in fire impacted communities under mission assignments from the Federal Emergency Management Agency (FEMA). As of the end of October, the number of properties cleared are as follows:

- Butte Fire: 610 parcels have been cleared as of October 24th, 2015 (approximately 90%)
- Valley Fire: 632 properties have been cleared as of October 27th, 2015 (approximately 61%)

Accomplished and Ongoing Response Activities
EPA has three household hazardous waste task forces and one survey team in Lake County to assess residential properties destroyed by the fire. Each task force conducts air and radiological monitoring, and, once completed, begins household hazardous waste characterization and removal. To date, 981 properties have

been identified for household hazardous waste assessment and removal. This number is determined by the County as those properties where Right-of-Entry has been granted by the homeowner. In Calaveras County, EPA has three teams assessing residential properties following a similar process, and three teams from the California Department of Toxic Substances Control (DTSC) are also working in the area. The cleaned-up properties listed above are for all six teams working in Calaveras County. 678 properties have been identified to date.

Response Background Information
The Governor of California, Edmund G. Brown Jr., issued Executive Orders (B-33-15 and B-35-115) in response to the wildfires in Lake, Trinity, and Calaveras counties to initiate clean-up of burnt debris and ash. The Department of

Resources Recycling and Recovery (CalRecycle) has been assigned to manage the removal and proper disposal of the solid waste and debris left over from the fires. On September 28th, 2015, EPA On-Scene Coordinators (OSCs) from the Pacific Southwest Regional Office in San Francisco, using Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) authority, began clearing properties of household waste in a buffer zone around public schools and performing air and radiation monitoring. On October 3rd, 2015, EPA received two Mission Assignments from FEMA for debris management and to collect, stage, and dispose of household hazardous waste. For these tasks, EPA manages the categorization, removal, and appropriate disposal of household hazardous waste and orphaned containers at

properties with destroyed residential structures within the Valley Fire boundary in Lake County and the Butte Fire in Calaveras County. Teams first sample the air for possible volatile or radiation contaminants, then assess the property for household hazardous waste (propane tanks, aerosol cans, pressurized cylinders such as oxygen tanks and SCUBA tanks that can pose an explosive hazard, and other containers that could have wastes that survived the fires). Items are collected and brought to the staging area, sorted, and properly disposed. Larger items such as drums and household propane tanks are also removed from the properties before CalRecycle removes the remaining debris. Properties are then sampled to ensure that contaminants have been removed and are suitable for rebuilding. Source: Rusty Harris-Bishop, Environmental Protection Agency ★

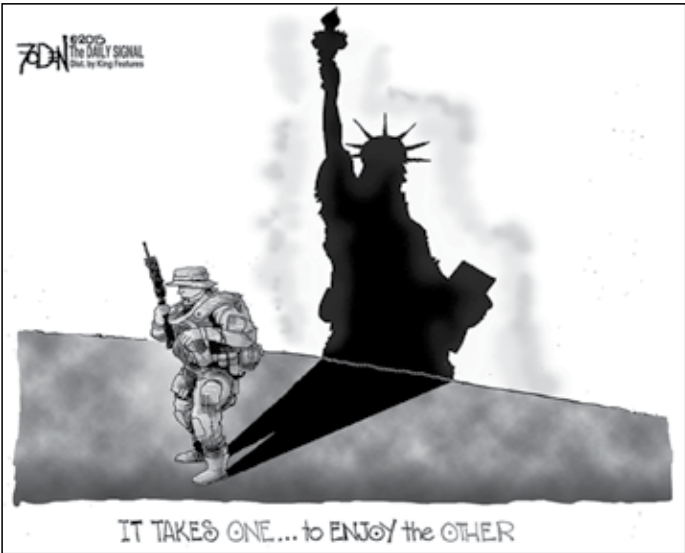

Hillary: It's the Sexism, Stupid

It was inevitable that Bernie Sanders would be accused of sexism sooner or later.

His day came at the signature Jefferson-Jackson dinner in Iowa. Hillary Clinton hit the Vermont senator for saying in the first Democratic debate that “all the shouting in the world” wouldn’t keep guns out of the wrong hands. According to Clinton, Sanders had directed a notoriously sexist insult at her -- although not one of the 15 million people watching at the time had noticed it.

“I haven’t been shouting,” Clinton intoned, “but sometimes when a woman speaks out, some people think it’s shouting.” What Clinton’s plaint lacked in plausibility, it made up for in bad faith.

Shouting has not typically been considered a loaded term. Sanders

didn’t say “screeching.” He didn’t say “nagging.” In fact, he had been saying that shouting is ineffectual in the gun debate long before he was entangled in an argument about gun control with Hillary Clinton.

Nonetheless, Sanders felt compelled on the CNN show “State of the Union” to tout his record on women’s issues and say, “I think what the secretary is doing there is taking words and misapplying them.” But there he goes again -- suggesting that women aren’t capable of correctly applying words.

Sanders should get used to it. If he remains a threat to Clinton in the early states, he’ll be deemed a cross between Archie Bunker and Andrew Dice Clay. Already, the left-wing publication Salon ran a headline urging on the sisterhood: “Let’s storm the Sanders’ he-man women-haters club.”

If Hillary is willing to use this tack against Sanders, a down-the-line supporter of the feminist policy agenda, just wait until she gets into a race with Donald Trump, Ted Cruz or any other Republican. No microaggression will be too “micro” to try to use to win a news cycle.

Hillary has already broadcast that she’s going to wield her gender as an all-purpose argument for her candidacy. At the Democratic debate, she said she’s an outsider -- because

she’s a woman. She said she wouldn’t simply be the third term of Barack Obama -- because she’s a woman. Hillary clearly doesn’t want anyone to be mistaken about her gender.

Hillary will need to do all she can to motivate women voters to make up for what may well be a historic poor showing among men. In the latest Wall Street Journal/NBC poll, her favorable rating among white men was an abysmal 26 percent.

Republican pollster Kellyanne Conway says there are three positive attributes that voters tend to attribute to women candidates: They are warm and understanding; they are new and fresh; they are honest. Hillary, a partisan warrior who’s been on the national stage for decades, usually trailed by an ethical cloud, is an imperfect vessel for all of those qualities. Which is why she’ll use her gender as a means of attack as much as a selling point.

In Iowa, she defended playing the “gender card,” saying if that’s what it’s called when you stand up for women’s rights, then “deal me in.” Actually, she’ll be doing the dealing, and it will be from the bottom of the deck.

Why Cats Won't Use Litter Box

sion to a litter's texture. And of course, diligent litter box cleaning makes every one in the household -- humans and cats -- much happier.

As I said in the previous article, owners whose cats are avoiding the box have to experiment a bit to find a solution. Using boxes with lids, or boxes without lids; replacing heavily soiled carpet and backing and treating with a "keep away" spray; increasing the number of litter boxes available; and observing the cats' behavior for potential conflict or health issues.

Sacramento County DA Reports

Recent cases of interest

CASE: Mohammad Khan
PROSECUTOR: Deputy District Attorney Caroline Park, Homicide Unit

The Honorable Kevin McCormick sentenced 35-year-old Mohammad Khan to 35 years to life in prison after he pled guilty to second-degree murder and admitted to a use of a firearm allegation.

On June 28, 2014, Khan met Kelsey Snyder and her friends at the Dive Bar. The friends described the interaction between the two that night as tense, and the two had a verbal argument.

After Khan went back to Ms. Snyder's apartment with her, her friends were unable to get a hold of her. A friend ultimately found Ms. Snyder shot to death in her bed with multiple gunshot wounds. Khan fled to Mexico during a vehicle pursuit, but ended up turning himself in to authorities. Khan was found to have had a 9 mm registered to him.

CASE: Allen Dee Taylor
PROSECUTOR: Deputy District Attorney Tate Davis, Domestic Violence Unit

The Honorable Patrick Marlette sentenced 41-year-old Allen Dee Taylor to 23 years, 8 months in prison. On August 24, 2015, a jury convicted Taylor of felony false imprisonment with use of a screw driver, assault with a deadly weapon, criminal threats, and child endangerment.

On August 11, 2014, deputies responded to a 911 hang up call at Taylor's residence. Officers immediately noticed Taylor appeared to be under the influence of a controlled substance.

When the victim attempted to leave the house with her children, Taylor took hold of her and pressed a screwdriver into her side, threatening her if she tried to leave. After Taylor refused commands to drop the screwdriver, officers drew their weapons. Taylor responded by corralling the victim's crying children behind him. When more officers arrived at the scene, they were able to gain control of Taylor and arrest him.

Taylor's criminal record goes back more than 20 years, including a 1996 strike conviction for burglary. Other convictions include domestic violence, DUI, felony drug possession and possession for sale, and forgery.

CASE: Alex Bruno
PROSECUTOR: Deputy District Attorney Morgan Gire, Gangs & Hate Crimes Unit

The Honorable Marjorie Koller sentenced Alex Bruno to 61 years to life in prison. On June 26, 2015, a jury convicted Bruno of two counts of attempted murder, each with enhancements for causing great bodily injury and discharging a firearm causing great bodily injury.

In September 2012, Nick Stevenson was at a family birthday party at their south Sacramento home. Alex Bruno disliked the Stevenson family and went to the house to get his girlfriend, who was at the party. As Bruno and his girlfriend pulled away from the house in their car, Bruno fired shots through the rear window. Mr. Stevenson was struck in the abdomen, critically injuring him. A 16-year-old friend of the family was struck in the back and seriously injured as he turned to run away from the gunfire.

The car Bruno was driving was recovered a week later. The District Attorney's Laboratory of Forensic Services matched broken glass found inside the door frame of the car to the glass left at the scene. Witnesses were initially reluctant to identify the shooter, but ultimately came forward to identify Bruno, who remained at large for several months before his arrest.

CASE: Aaron Lee Ramzy
PROSECUTOR: Deputy District Attorney Valerie Brown, Homicide Unit

Twenty-four-year-old Aaron Lee Ramzy was convicted by jury of first-degree murder. The jury also found true a personal use of a deadly weapon allegation.

The victim, 23-year-old Zachary Kane, shared an apartment with three other young adults, one of whom was Ramzy's sister. The roommates agreed to let Ramzy stay with them when he became homeless. On February 23, 2015, Ramzy stabbed the victim more than 18 times as the victim sat in a chair watching movies with friends.

Prior to the murder, Ramzy exchanged text messages with his ex-girlfriend stating his intent to kill the victim. The victim's three roommates testified that there had been no altercations or disagreements between the two leading up to the murder.

Ramzy face a sentence of 26 years to life in prison. Sentencing is set for December 17, 2015, at 1:30 p.m. in Department 29 before the Honorable Timothy Frawley. ★

Saluting the Last Raider

I met Spencer R. Anderson at the recent 10th Anniversary of the California Capital Airshow at Mather Air Force Base. Mr. Anderson, a Vietnam veteran who obtained the rank of Staff Sergeant E-5, enlisted in the US Air Force after he completed his duty as a Civil Air Cadet in Salt Lake City, Utah, and served his country from 1962-1970. Mr. Anderson has also written a book titled, “The Last Raider.” A work of fiction with a sprinkling of real-life combat scenarios, it is a good read for those intrigued by rescue missions and dramatic life situations.

As a communications specialist serving under Marine General Lewis Walt at Da Nang Air Base, Vietnam, it was Mr. Anderson’s duty to monitor telephone land line communications and make sure no one, including General Walt, mentioned any classified

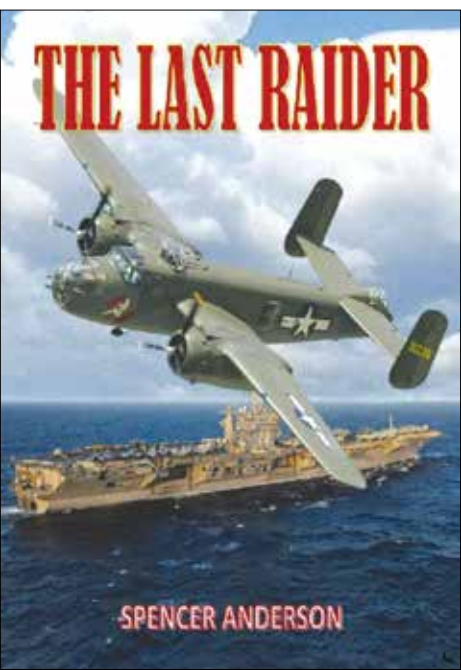
information, or happened to express their political opinion of the Vietnam War while using the telephone.

Vietnam was a controversial war, to say the least. The United States was in a turbulent period in its history and our government was not going to make reparations and rebuild Vietnam while putting a drain on our own economy. “Peace with Honor” was how then-President Richard M. Nixon described the Paris Peace Accord in January, 1973. Upon his honorable discharge, Staff Sergeant Anderson was advised not to wear his uniform when landing in the United States, “as you will be spit on and have garbage thrown at you.”

But Mr. Anderson was “proud to represent [his] country” and he wore his uniform upon landing in San Francisco. “I was not going to hide as people called me names,” he said.

Mr. Anderson had witnessed his buddy die in Vietnam and could not understand how his fellow citizens could treat servicemen and women with such hatred.

Presently, Mr. Anderson and



his wife, Carole, follow the air show circuit around the United States enjoying the shows and selling “The Last Raider.” He is also an honorary Colonel with the Commemorative Air Force, Airbase Arizona, an organization dedicated to honor the military airmen and flyers and to preserve and maintain classic wartime airplanes, such as the B-17 and B-25 aircraft.

Local Schools Performing Above State Average in New Assessments

First-Year Results Represent New Starting Point in Measuring Student Achievement

RANCHO CORDOVA, CA (MPG) - Results of new computer-based tests taken by students last spring by the California Department of Education (CDE) indicate that, overall, Folsom Cordova Unified School District (FCUSD) schools are performing above statewide averages. The Smarter Balanced tests—part of the new California Assessment of Student Performance and Progress—are aligned with the state’s new, more rigorous content standards, which provide a better measure of how prepared students are to succeed in college and the workforce.

FCUSD’s baseline results show that 55% of students met or exceeded standards for English-language arts and 47% of students met or exceeded standards for math. Statewide, 44% of students achieved the same measure in English-language arts and 34% met or exceeded the mathematics standards. Additionally, FCUSD results are the highest among large unified districts in Sacramento County and the third-highest among unified districts in the four-county region.

“We carry high expectations for each student’s achievement and success, and these results are one of many measures we will continue to use to help all learners reach their goals,” said Superintendent Deborah Bettencourt. “The skills measured in these assessments are a more

accurate indicator of whether our students are gaining the critical thinking and problem-solving skills necessary to succeed in a rapidly evolving world.”

More than 11,700 FCUSD students in grades 3-8 and 11 were tested last spring in the first year of the new assessments. The two-part tests consisted of an adaptive test—in which questions got harder or easier depending on how many correct answers students provided—and a performance task that required students to demonstrate more depth of knowledge and application to real-world problems.

These tests represent a new starting point for measuring student achievement, providing a new baseline for measuring students’ growth in future years. These test results cannot be compared to any standardized tests from previous years because they are too fundamentally different and measure a wider range of skills than previous pencil-paper tests.

While overall results show FCUSD schools are exceeding state averages, scores for disadvantaged groups, such as English learners and low-income children, indicate a significant achievement gap—mirroring a challenge in school districts across the state.

“We know we have much room for improvement to ensure all of our students succeed,” Bettencourt said. “Folsom Cordova is

investing numerous resources into instructional initiatives and new intervention staff focused on improving educational outcomes for our most vulnerable students. We now have a better measure of where we are starting, and I’m confident we will see growth in future years.”

Later this month, families of students who took the assessments will receive individual score reports by mail. The District has not yet received these reports from the state, and FCUSD has within 20 days to deliver them to households after they arrive. The reports provide detailed, customized academic performance information for individual students. For a preview of what the reports look like and answers to common questions, please visit www.fcusd.org/testing.

Once the reports arrive, FCUSD encourages families to speak with their child’s teacher to learn more about what the scores mean, and how they will be used to support their success. These scores are just one measure of student progress and will be only one of many tools teachers and families can use to help students improve throughout the year.

Late Rally Falls Short for Lancer Football

RANCHO CORDOVA, CA (MPG) - Leading 22-7 in the second quarter of last Friday's Sierra Valley Conference home game, the Cordova High School football team appeared to be headed to a victory over Union Mine. But the visiting Diamondbacks rallied toward the end of the quarter that carried over into the second half. The result was a Union Mine 35-28 win over the Lancers (1-3 in the SVC, 4-5), who suffered a blow in their bid to earn an at-large Sac-Joaquin Section playoff berth. Teams have two or more wins in league, plus wins in most of their non-league games for consideration. The D'backs cut the Lancers' lead to 22-14 with less than two seconds left in the second quarter. "They spread us out, going to an empty backfield," said Cordova head coach Darren Nill on the D'backs setting up the touch-down toward the end of the quarter. "I had two guys who had clean shots at (D'back Brody Pearman who scored on a quarterback sneak). That was a little bit of a crushing blow. We (Nill and his assistant coaches) spent most of halftime trying to pick our guys back up." Union Mine (3-1 in the SVC, 6-3) took the lead for good in the fourth quarter thanks to a blocked punt that led to a touchdown. But the Lancers had one more chance to score. Cordova marched down the field to the D'backs' 1-yard line on first-and-goal with 47 seconds left in the game. But one run stopped short of the goal line and three incompletes passes, including one on fourth down, ended the Lancers' drive and chance to come-from-behind. "It was a tough, crushing blow," Nill said. Lancer quarterback Unique Perez had a big night in the air. He completed 25-of-37 passes for 442 yards and two touchdowns. Cordova wide receiver Devin Baldwin had 15 receptions for 337 yards and two touchdowns. "He's got great hands," said Nill of

Baldwin. "He practices one-hand catches, awkward catches, catches across his body. And it really pays off. The kid just goes up and catches the ball." Cordova running backs Kenneth Haney and Seth Trujillo scored a touchdown each. Trujillo had eight carries for 61 yards and Haley 6-21. They were part of an offense that had 554 total yards; 442 in the air and 112 on the ground. On defense, the Lancers were led by defensive backs Jason Johnson with 11 tackles and Terrill Johnson with 10. Defensive back Aaron Giles followed with eight and linebackers Chance Manzanares and Haney had seven each. Giles and Johnson recovered a fumble each. In the frosh/soph contest, Cordova also lost a close one to Union Mine, 27-26. Lancers are 2-2 in the SVC and 7-2 for the season. Nill and his coaching staff turns to conference finale. Also at home tonight, Friday, Cordova will close out its regular season, hosting Rosemont (2-2 in the SVC, 5-4). The Lancers will also hold Senior Night to honor the players in their final year of playing prep football. "We're going to finish this out for the seniors," Nill said. ★

Turning Back the Hands of Time

Maybe if our extra sleepy-time dreams would come true...and when we awakened all was right with the world. If we really had that hour to live over again, what would we do different? What if we had whatever amount of time we might desire to do all over again? Whether or not we are living with any regrets, that would be a pretty cool option to have. If we could go back to the past from the present, knowing what lies ahead back in the future, what might we want to change in the past to alter the future? But, we couldn't be sure of what we might have in our present --- our future while in our past --- if we do decide to change things while we are back in the past. But, if our present is not so bright, we might be willing to take our chances of changing the past if given the opportunity. (There's a movie plot in there somewhere. Perhaps Marty McFly or Calvin can help us sort it all out). It's "a lock" bet that the San Francisco Forty Niners would elect to go back in time and alter a few things that went down in their recent history. Set the Wayback Machine to February 3, 2013. It's the Harbowl --- Super Bowl XLVII in New Orleans, pitting 49ers then-coach Jim Harbaugh against his brother John, coach of the Baltimore Ravens. Quite a game, but the 49ers trailed late, 34-29. They advanced to a first-down-and-goal at the Ravens' 7-yard line in the closing

moments with a great shot at stealing the victory. A 2-yard run and a pair of incompletes preceded a last-ditch pass from QB Colin Kaepernick that sailed about a foot beyond the outstretched hands of WR Michael Crabtree in the end zone. Forty Niners all-time leading rusher Frank Gore never touched the ball during that final set of downs, even though he had just reeled off a 33-yard run to finish with 110 yards on the day. An intentional safety by the Ravens and an unsuccessful, final-chance kick return by the 49ers' Ted Ginn ended the game at 34-31, Baltimore. Look at the 49ers now. Where would they be if they had done a couple of different things back then? Now, Harbaugh's gone; most of the other coaches are gone; Gore's gone; Ginn's gone; Crabtree's gone; Kaepernick (who went 4-2 in six playoff games and was one play away from winning a Super Bowl) is gone to the bench and backup QB Blaine Gabbert (5-22 as a starter in the NFL) will start at home Sunday against the Atlanta Falcons; TE Vernon Davis is gone, traded to Denver; a whole host of other guys are gone by way of free agency, retirement, injury; winning is gone, gone, gone, solid gone. What if? There are a few people around the NBA who wish they had June 25, 2009, to do over again. That's the day that point guard Stephen Curry, the reigning league MVP, was selected seventh in the draft lottery by the now World Champion Golden State Warriors. All Stars Blake Griffin and James Harden (neither a champion as yet) were chosen ahead of Curry --- acceptable; the others among the top six --- not so much. Chosen No. 2 by the Memphis Grizzlies was 7' 3" center Hashem Thabeet, last seen playing for Grand Rapids in the D League after averaging about ten

minutes per game in the NBA. Curry and the W's beat the Grizz in the playoffs last year and just the other night torched Memphis by 50 points with Curry going for 30 in just 28 minutes. The other three players selected ahead of Curry, unbelievably, were all point guards. Your Sacramento Kings picked Tyreke Evans at No. 4. A fan favorite for a while, Evans, now with New Orleans, has had a respectable career but is out for weeks with a knee injury. The Minnesota Timberwolves had two picks just ahead of Golden State and used them both on point guards --- Ricky Rubio, still hanging on though shooting under 37% for his career, and Jonny Flynn, out of the league after 163 games for three teams over three seasons. What if any of them had taken Curry, the baby-faced assassin and new face of the league, who has the Warriors off to a high-flying start with four straight blowout wins (average margin of 25 points) while averaging 37.0 ppg? If only they could've seen it all coming. Throughout sports everybody wishes they had enough gigawatts to power their own flux capacitor and ride a DeLorean back and forth through time to ensure success. Just for one more example, take the Portland Trailblazers --- in 2007 they drafted injury-prone Greg Oden No. 1-overall ahead of Kevin Durant, and back in 1984 after Houston took Hall of Famer Hakeem Olajuwon at No. 1, they took oft-injured Sam Bowie No. 2 ahead of Michael Jordan, the greatest player of all time to date. There are infinite examples. Everybody in sports (including Lucas Duda and the New York Mets, who threw away the deciding game of the World Series to the Kansas City Royals) would love it if mulligans were not exclusive to golf. But since we can't do it over, take that extra nap and dream on... ★

SEC WEST SHOWDOWN

Undefeated LSU heads to Tuscaloosa to battle one-loss Alabama

LSU AT ALABAMA

The stakes are once again enormous in the latest edition of what has become the most important game in the SEC in most seasons. Alabama and LSU are considered by most to be the top two teams in the league and among the top five or six teams in the nation. Alabama, however, does not control its own destiny in the SEC West due to an early season loss to Ole Miss. The Tide could win out yet not play in the league title game and be left waiting to see how the College Football Playoff committee treats a team that didn't even win its own division. LSU has no such worries — at this point. The Tigers, who have yet to play Ole Miss, will win the West if they win their remaining four games. This game, on paper, seems to favor Alabama due to its ability to stop the run. The Crimson Tide haven't faced a back as formidable as Leonard Fournette, but they do rank first in the SEC and third nationally in run defense, allowing only 83.4 yards per game and 2.6 yards per attempt. Fournette leads the nation in rushing but has faced only one team (Florida) that has a run defense ranked in the top 60. If Fournette is held in check (let's say under 125 yards), Brandon Harris will have to prove that he can move this offense through the air in the biggest game of the season. *Alabama 24–17*

TCU AT OKLAHOMA STATE

Oklahoma State has navigated the first two-thirds of its schedule without a loss, but not many consider the Cowboys to be a legitimate threat in the Big 12. Well, the Pokes will have several opportunities to prove their doubters wrong, beginning with this week's visit from TCU. The Horned Frogs, also 8–0, are much more respected by the pollsters even though their schedule has been comparable to Oklahoma State's. The reason? They went 12–1 last year and began the 2015 season in everyone's top five. TCU also boasts the nation's most dynamic quarterback in senior Trevone Boykin and perhaps the best wide receiver in college football in Josh Doctson. These two figure to present some problems for an Oklahoma State defense that gave up 480 passing yards and 53 points in a win over Texas Tech last week. *TCU 44–37*

FLORIDA STATE AT CLEMSON

Perhaps no team has been as consistently strong in 2015 as the Clemson Tigers. The offense, as expected, has been solid with sophomore quarterback Deshaun Watson leading the way. The rebuilt defense, however, is the reason this team is being mentioned as a favorite to reach the College Football Playoff. The Tigers have allowed only 18 touchdowns in eight

games, and only one team has scored more than 24 points against them. Florida State bounced back from its loss at Georgia Tech with an impressive showing against Syracuse while playing without starting quarterback Everett Golson (concussion) and star tailback Dalvin Cook (ankle). Both should be available this week, but there is no guarantee that Golson will start. Backup Sean Maguire, who threw for 348 yards with three touchdowns and no interceptions against Syracuse, is now being considered as a legitimate option going forward. The guess here, however, is the more mobile Golson will get the nod due to Florida State's issues on the offensive line against Clemson's stout pass rush. *Clemson 31–24*

DUKE AT NORTH CAROLINA

This game would be far more hyped had Duke not lost at home to Miami in that crazy finish on Saturday night. But it's still the biggest game of the year (so far) in the ACC Coastal Division. North Carolina, which is undefeated in the league and already has a win over one-loss Pitt, can take complete command of the division race with a win. A Duke win will create a three-way tie at the top between the Devils, Tar Heels and Panthers. North Carolina is playing the best of any team in the division and is a play or two away from being undefeated overall. This team has a veteran quarterback (Marquise Williams), an underrated running

back (Elijah Hood) and one of the most improved defenses in the nation. This won't be as one-sided as last year, when UNC rolled Duke 45–20 in Durham, but the Tar Heels are the better team. *North Carolina 30–17*

PENN STATE AT NORTHWESTERN

This has been a strange season for Northwestern. The Wildcats opened the year with a dominant victory over Pac-12 power Stanford, and they also have a win at Duke and a 27–0 victory over Minnesota. But they lost to Michigan and Iowa by a combined score of 78–10. Pat Fitzgerald's team has clearly proven that it is capable of playing solid football, but they were also alarmingly uncompetitive against the two best Big Ten teams they have played. That makes Penn State an interesting opponent. The Nittany Lions appear to be improved this season, but they have nothing close to a quality win. The offense, however, appears to have hit its stride, with back-to-back 30-point games for the first time in the James Franklin era. Christian Hackenberg is averaging a healthy 9.9 yards per attempt in his last three games and hasn't thrown an interception since Week 3. *Penn State 24–21*

PRIME TIME PLAYERS

Clemson quarterback **Deshaun Watson** enjoyed the most productive day of his sophomore season, throwing for 383 yards with five touchdowns and no interceptions and adding 54 yards and one score on the ground as the Tigers fought off NC State for a 56–41 win in Raleigh. ... For the fourth time this season, New Mexico State running back **Larry Rose** rushed for at least 180 yards. For the first time, however, it came in a win. Rose, one of the nation's most underrated backs, ran for 212 yards and four TDs to help the Aggies beat Idaho 55–48 in overtime for their first win of the 2015 season. ... **James Washington** caught only four passes in Oklahoma State's 70–53 win at Texas Tech. Not impressed? Well, he averaged 50.0 yards on his four receptions and scored two touchdowns. ... With **Dalvin Cook** sidelined with an

injury, true freshman **Jacques Patrick** stepped in and rushed for 162 yards and three scores as Florida State topped Syracuse 45–21. ... Notre Dame quarterback **DeShone Kizer** accounted for all but 25 yards of the Fighting Irish's total offense in a 24–20 win at Temple, throwing for 299 yards and rushing for 143. He had three total TDs, including the game-winning 17-yard TD pass to **Will Fuller** with 2:09

remaining. ... Ole Miss quarterback **Chad Kelly** threw for 381 yards and two touchdowns (on a season-high 51 passing attempts) to lead the Rebels to a 27–19 win at Auburn. ... One week after getting a curious DNP-coach's decision in a loss at Ole Miss, **Kyler Murray** earned his first start of the season and combined for 379 yards of offense and two touchdowns in Texas A&M's 35–28 win over South Carolina.

STOCK REPORT

A North Carolina has seized control of the ACC Coastal Division with a 4–0 start highlighted by last Thursday's win at Pittsburgh. Under the watch of new defensive coordinator Gene Chizik, the Tar Heels are allowing 358.0 yards per game, down from an ACC-worst 497.8 last season.

V Any confidence Charlie Strong rebuilt at Texas in recent weeks evaporated with a listless performance in a 24–0 loss to Iowa State. The Cyclones fired their offensive coordinator and changed QBs last week, but Texas was the inept team on offense with 127 total yards and seven first downs before their final possession in garbage time.

A Purdue snapped a nine-game Big Ten losing streak with a 55–45 win over Nebraska in West Lafayette. The win, however, might not be enough to keep Darrell Hazell off the hot seat. The fourth-year head coach is 6–26 overall (2–18 in Big Ten games), and three of those six wins have come against FCS competition.

V Georgia's disastrous October concluded with a 27–3 loss to rival Florida in a game that eliminated the Bulldogs from the SEC East race. Faton Bauta completed only 15-of-33 attempts and was intercepted four times in his first career start at quarterback. Georgia went 1–3 in October, with the lone win over Missouri.

- 114 Colorado ran 114 offensive plays in its 35–31 loss to UCLA, one snap short of setting the FBS record. UCLA, on the other hand, ran only 59 plays.
- 15 Cincinnati's Gunner Kiel completed all 15 of his passes for 319 yards with five touchdowns in a 52–7 win over UCF.
- 19-11 With a 56–41 win at NC State on Saturday, Clemson improved to 19–11 in ACC road games under coach Dabo Swinney. Virginia Tech's Frank Beamer, who will retire at the end of the 2015 season, leads all active coaches with 33 ACC road wins.
- 20 Georgia Tech dropped to 1–5 in the ACC with a loss to Virginia on Saturday, ensuring that the Yellow Jackets' streak of 20 straight non-losing seasons in the ACC will come to an end.

COACHING CAROUSEL

Normally, the college football coaching carousel doesn't get cranked up until after the season concludes. This year, however, hasn't been normal — far from it. In the past week, three more FBS jobs opened up, bringing the total to 10. And we still have one month remaining in the regular season. Here's an update on which schools will be looking for new leadership and our ranking of the quality of the jobs.

1. **USC** — **Steve Sarkisian** was fired in mid-October one day after the school announced it had forced him to take an indefinite leave of absence to deal with alleged alcohol addiction.
2. **Miami (Fla.)** — **Al Golden** was fired last month after his team suffered the worst loss in school history, a 58–0 defeat at home to Clemson. He was 32–25 overall and 17–18 in the ACC during his four-plus seasons.
3. **Virginia Tech** — **Frank Beamer**, who built his alma mater into a national power, announced on Monday that he would retire at the end of the season. He currently has a 234–120–2 overall record, including a 123–52 mark in league games.
4. **South Carolina** — Legendary coach **Steve Spurrier** stepped aside after six games this season due to his team's lack of competitiveness. He went 44–40 in the SEC in his eight-plus seasons at South Carolina.
5. **Maryland** — **Randy Edsall** was let go in the middle of his fifth season with a record of 22–34. The Terps were 0–12 against ranked opponents during his tenure.
6. **Illinois** — This job opened up before the season began when **Tim Beckman** was dismissed in August amid allegations that he mistreated players. Bill Cubit has served as the interim head coach.
7. **Minnesota** — **Jerry Kill** stepped down last week due to health concerns. The highly respected veteran coach had a 29–29 record in his four-plus years with the Golden Gophers.
8. **UCF** — The Knights went a combined 22–2 in league games from 2012–14 under **George O'Leary**, but things got very ugly very quickly. He stepped aside in late October after his team dropped to 0–8.
9. **North Texas** — **Dan McCarney's** program failed to sustain the momentum gained by a breakthrough nine-win season in 2013. McCarney was fired last month after the Mean Green lost to Portland State 66–7 at home.
10. **Hawaii** — **Norm Chow** was fired on Sunday after the Rainbow Warriors dropped to 2–7 with a 58–7 loss to Air Force. Chow is 10–36 in his three-plus seasons at the school.
