CRPD Makes Effort to Conserve Water in Parks

RANCHO CORDOVA, CA (MPG) - In California, the ideal amount of water needed for landscaped areas equals one acre-inch of water per week. One acre-inch of water is equivalent to 27,155 gallons applied onto an acre of land.

During last year's drought conditions, Cordova Recreation and Park District (CRPD) reduced the amount of water used within the parks and on the ball fields by 15% to 20%. That translated to using 4,100 to 5,500 gallons less water per acre per week.

This year, the Park Services staff is implementing a strategy of inspecting, testing, and retrofitting the irrigation systems within the park and streetscape areas for water use efficiency and effectiveness. The retrofitting strategy includes replacing older nozzles in existing irrigation heads with more water-efficient nozzles, replacing wornout solenoid valves, replacing drip irrigation lines with low-flow sprinkler heads, and adjusting irrigation heads to target green spaces and not hard surface areas like sidewalks and asphalt areas.

Through most of spring, CRPD will be watching the weather reports and reducing water usage for irrigation by 20%. For player safety, the ball fields will receive more irrigation, but there will still be a 20% reduction of water being used on the fields. CRPD is currently experimenting with other conservation practices that will hopefully be useful in their water conservation efforts. Those practices include aerating the lawn panels more frequently, fertilizing with a polymer coated fertilizer, applying more organic matter to the soil structure, and using plant growth regulators. The spray parks and the splash park will remain open throughout the summer. The water used at those facilities is cycled through intricate filtration and treatment systems and reused on a continuous basis. Enjoy a Sunset Equestrian Ride at Deer Creek Hills Preserve

SACRAMENTO REGION, CA (MPG) - The Sacramento Valley Conservancy (SVC) invites you to saddle up for a guided equestrian ride at sunset at Deer Creek Hills on Saturday, April 11th from 4:00 p.m. to 8:00 p.m.

Riders and horses alike will explore more than 4,400 acres of the preserve's open space in the late afternoon light. Views of the sun setting from the eastern Sacramento County foothills will be enjoyed by those attending.

This outing is suitable for only intermediate and advanced riders and is not suggested for novice riders. All public outings are led by docents and travel through a working cattle ranch.

Approximate ride time is 2.5 hours, and you will ride through open country over a variety of terrain, including water crossings and climbing and descending hills. Horses should be accustomed to riding in groups and in open fields. Most groups are from 10 to 20 people in size and travel at a walk.

Deep shadows and rich colors will embrace those traveling the blue oak woodland hills. The sun is scheduled to set at 7:39 p.m. and participants will be arriving back to truck and trailer in complete darkness, so don't forget to pack a headlamp or flashlight!

Taking in the evening's stillness in Sacramento's largest open space preserve is a very unique experience.

To attend the Guided Sunset Equestrian Ride, you must be over 16 years old and provide your own horse. The cost to attend is \$20 per person; please register online at www.sacramentovalleyconservancy.org/calendar. asp.

Directions to Deer Creek Hills Preserve from Sacramento: Take Hwy 50 to the Bradshaw exit, turn right (South) onto Bradshaw, turn left (East) onto Jackson Road (Hwy 16), continue East past Sloughhouse, and turn left (North) onto Latrobe Road. After you pass Scott Road, travel 1/8 of a mile to a severe right turn onto Stone House Road; do not make this turn, but travel straight onto a dirt road. The dirt road is Latrobe Road. Travel approximately one mile to Eagle Camp Corral where participants will gather and start the outing. When crossing Crevis Creek, it is highly recommended that you cross at the extreme left side of the road since this is the shallowest section of the creek.

The Sacramento Valley Conservancy (SVC) is celebrating over 24 years of protecting open space and accreditation by the Land Trust Alliance Accreditation Commission. The SVC is a private, non-profit land trust founded in 1990 on two basic principles: that open lands are necessary for quality of life and that we must save land today so future generations may enjoy its benefits tomorrow. Home Prices and Values on Steady Climb

RANCHO CORDOVA, CA (MPG) - There will likely never be the home market boom we once had. But prices and values are finally on a steady climb again, which should mean steadier, longer-term industry and economic growth, including in Rancho Cordova.

In Rancho Cordova, the February median home price was \$224,500 dollars, up \$8,500 from a year ago. Zillow. com describes the market temperature as "neutral."

Sacramento Association of Realtors President Ron Greenwood said the city has more properties to clean up to reduce the criminal element, but they are making progress. "They're attracting commerce in there with stores," said Greenwood. "I think they're good."

In February, 36 homes were sold, compared to 35 in January and 26 a year ago. But as the market recovers, it also means affordability is dropping again. Zillow.com says buyers must now make at least \$78,000 a year to be able to afford the statewide median price. And more than two-thirds of households make less than \$70,000. In Rancho Cordova, income needs to be at least \$51,000.

But Greenwood says prices are going up much more modestly than in the boom years. He also is not expecting looming interest rate increases to scare off a significant number of buyers. "We had gas prices go down, which gave them more disposable income," he said. "And the job market seems to be improving gradually. All that bodes well."

Although homebuilding is picking up again, Greenwood admits inventory continues to lag. "We would like to see somewhere between four and six months' supply," he said. "In reality, we're more like half that. The problem is the good properties that are priced right are going quickly. If we look at the selling time, it's been reduced almost in half. It used to be 60 to 90 days to close a house, now it's closer to 30 to 60 days."

A double-digit decline in home foreclosure activity is reported in California by Realty Trac: 11% in February compared to last year. The number of distressed homes is the lowest in eight and a half years.

With values showing a consistent increase, the percentage of "underwater" homeowners in the Sacramento area is dropping. It was nearly 15 % in the last quarter of 2014, according to Zillow.com, compared to 20% the previous year. That's resulting in more consumer confidence.

Greenwood said, "Some people were just saying they just don't want to venture and buy something that's going to be worth a lot less that what they paid for. I think everyone realizes the market is going up. And if they're going to get into it, do it now, and enjoy the lower interest rates and lower prices."

A more stable market is always a good barometer of overall economic health. "It's a slow, gradual turn," Greenwood said, "and it's driven by the right forces. It's driven by need and also knowing that the job market's healthy. It's not external and being driven by greed. That's what hurt us the last time."

Permit Simplicity Comes to Rancho Cordova City Will Launch One-Day Permit Program

RANCHO CORDOVA, CA (MPG) -The cities of Rancho Cordova and Elk Grove will be the first agencies in California to launch a pilot program designed to streamline the permitting process for tenant improvement projects to one day. The program is based upon a successful working model from the City of Phoenix.

Working with the Region Builders, an association whose mission is advancing regional economic growth, the cities of Rancho Cordova and Elk Grove are moving forward with the plans to launch the Permit Simplicity program on July 1st, 2015. Permit Simplicity allows businesses to obtain a permit for improvements to an existing building in one day. Under this program, plans prepared by a designated, pre-qualified professional architect or engineer will be reviewed by the City staff at the permit counter and a permit will be issued the next day.

"We are leading the charge for regional adoption of this program because we value growing the economy. Our goal is to get businesses up, operating, and profitable as quickly as possible, because time is money," said Pat Hume, the Vice Mayor of Elk Grove and vocal advocate for the program. "Elk Grove is ready to compete for jobs in the 21st century marketplace."

The Permit Simplicity program is optional and there is no additional processing cost associated with it. For now, the program is limited to tenant improvements for retail, office, and warehouse buildings and no food establishments or change in use applications will be considered as part of this process.

"The City is always looking for ways to streamline our processes and support a 'Fresh Take' on business," said Rancho Cordova Mayor Robert J. McGarvey. "The Permit Simplicity program is a new and

effective tool to help streamline business location and expansion in Rancho Cordova."

Architects and engineers who wish to utilize the Permit Simplicity program will need to obtain all other permits required by other agencies prior to final submittal to the cities. Other agency approvals typically include Fire, School Districts, and Utilities. The program may be expanded to other types of permits after the initial trial period.

"Permit Simplicity will set Rancho Cordova and Elk Grove apart from every other jurisdiction in California. The sell point of being able to obtain a permit in one day will be a powerful marketing tool to position our region as a place for businesses to locate and grow," said Joshua Wood, Executive Director of Region Builders.







For more than 25 years, I have had the honor of assisting a number of nonprofits in their fundraising efforts. I have come to understand that the art of fund raising is about more than finding money; whether a fundraiser is seeking funds on a small or large scale, it always comes down to how prepared you are and how focused your fundraising plan is. I have developed my own guidelines for success in raising money that have served me well over these many years.

More than once I have been given the opportunity to guide students on how to earn money for their organizations, and I always require them to create a plan. Determining how to approach fundraising is not a "fly by night" operation. There are some basic guidelines that

Lessons in Fundraising

must be followed, whether you want to raise \$500 or \$50,000. My lessons are just guidelines designed to help those who find themselves spearheading a fundraising initiative and don't know how to begin.

Lesson #1: What is the reason for your fundraising and what is your clear-cut mission? In other words, who is the benefactor? State this mission clearly. Organizations that are in need of support often list many areas where that money is needed and they lose their focus; the message then becomes muddled and confusing. If you want to build a new ball field, then that is what you say. Stick to simple, direct messaging so that everyone can understand your purpose.

Lesson #2: Set a financial goal, but be realistic about the scope of your efforts. Stating that your goal is to make \$10,000 may not be realistic in light of the type of fundraising event you are undertaking or the number of people you have available to go out and promote the fundraiser. Review your event without rose-colored glasses (keeping in mind expenses that will offset the potential profit you hope to make), set an attainable goal, and focus on making that

amount. If you exceed your goal, then so much the better for your organization! In fact, it is good for morale as well. Volunteers like to see their efforts paying off, so reaching for the stars and not coming close to the goal can be deflating to those involved and may result in people looking for other causes to support.

Lesson #3: Who makes up your committee? Who are the "sales people" that are out front and visible, and who is on the clean-up crew? Here is a crucial lesson in fundraising: If your brother-in-law wants to help but is not quite polished enough to be a spokesman, maybe he's better suited to doing something behind the scenes. The needs of the fundraising effort must trump the egos of the committee volunteers. Match talent and skills as necessary.

These are just three steps (out of 15) in a plan that I have developed that has proven successful for many years. If you find yourself chairing a fundraising event, I encourage you to review these proven steps-it will make your task easier and improve the likelihood that you'll reach or exceed your fundraising goal... everybody wins!

FBI Arrests Ten, Thousands of Counterfeit and Pirated Disks Seized

SACRAMENTO REGION, CA (MPG) - Multiple search warrants and a local probation search were executed on Friday March 13th, 2015, in San Jose, CA. Approximately 75,000 counterfeit music compact discs, 60,000 pirated movie digital video discs, and materials and equipment to duplicate, produce, and distribute more than 10,000 additional discs were among the items seized during the searches.

Nine subjects were detained and subsequently arrested as a result of the warrant activity and searches on March 13th: Victor Flores Fuentes (38), Edgar Hipatl Rodriguez (25), Angel Gomez (34), Ramiro Mendes

(34), Efrain Lozada Rosas (33), Antonio Morales (31), Enrique Aguilar (25), Eric Ivanez (21), and Jesus Cuevas Lopez (24). The individuals were arrested for allegedly trafficking in counterfeit labels, criminal copyright infringement, and conspiracy (18 USC 2318, 2319, and 371). The 10th subject, Cornelio Rojas (50), was arrested in Atwater, CA, on Monday, March 16th for the same alleged crimes.

According to court documents, the men allegedly conspired to duplicate and reproduce copyrighted music CDs and counterfeit movie DVDs. The counterfeit materials were then distributed to resellers in California cities including Atwater, Modesto, Stockton, and Sacramento. The counterfeit materials included movie titles that were in theatrical release and not yet available for legitimate sale on DVD.

The arrests and seizures were a product of an investigation conducted by the Sacramento Intellectual Property Rights Task Force comprised of the Federal Bureau of Investigation and Sacramento County Sheriff's Department and assisted by the San Jose REACT Task Force, TRACE Task Force, and the California Highway Patrol.

son, they might want to consider adopting football's promotional model. As pathetic as it may be, it attracts a lot of attention.

Football shows no shame whatsoever. For as long as any of us could likely recall, the NFL has preyed on most men's basic instincts and desires to sell its products. Take, for example, that classic Oakland Raiders billboard ad that appears each season that everybody has seen from the freeway —- the advertising brain trusts' version of the Killer B's: a frosty Coors; a Raiders emblem; a Raiderette cheerleader — Beer, Ball and Babes. That'll catch your eye every time.

The promoters of the NCAA Men's Basketball Tournament have obviously caught on. (Although, all of this commercial silliness is based on a long-standing, time-proven, winning formula: The majority of sports-lovin' men also love women).

It was impossible not to notice the not-very subliminal tactics used on the broadcasts of some of the tournament games. You must have seen this one a couple of times —- during a break in the game as the station led into its commercials, along came a rapid sequence something like this: a player drives to the basket for a lay-up; a blink-of-the-eye, vague glimpse of a young woman; a three-pointer swishes through the net; a vicious blocked shot; a little-bit-longer peek at the young lady spinning; a sweet move to the hoop; a great pass for a fast break conversion; another moreextended look of a side-view of the sweetheart arching her back (undoubtedly excited about the action on the court); a ferocious slam dunk; off to the commercials.

They've got us right where they want us. No wonder that on television, especially in ads and sitcoms, that men are portrayed as such idiots. We're not all already underway, and the start of the Major League Baseball season is just days away.

Following bits and pieces of the San Francisco Giants, the Oakland Athletics and MLB in general through the course of the painfully-long spring training activities, its seems as though there is a perceived shroud of doom and gloom hovering over the Bay Area franchises.

It does look as though powerhitting will be an issue for the Giants after losing Pablo Sandoval and Michael Morse from the lineup. They do have aging starters in the pitching rotation. They are relying on bounce-back seasons from a star starter (Matt Cain), a differencemaking outfielder (Angel Pagan) and a still-developing, slugging first baseman (Brandon Belt) who are coming off injury-riddled seasons. They have a young second baseman (Joe Panik) hoping to avoid a sophomore slump.

The A's shipped out a bunch of All Stars and top-flight pitchers. They made nine trades involving 27 players. They are projected to field a whole new infield alignment and a lineup featuring five new faces.

A panel of USA Today "experts" all chose the L. A. Dodgers to win the NL West for the third straight year over the Giants, and only two of them tabbed the Giants as a wild card team. Only Buster Posey and Madison Bumgarner have been given any love at all by the fantasy baseball gurus. No one picked the A's to even reach the playoffs this year and they were listed 15th in the MLB power rankings (the Giants were sixth). Only newlyacquired second baseman Ben Zobrist and pitcher Sonny Gray cracked the top-seven at their position by the fantasy crowd.

What the Giants do have is the last World Series MVP

As usual, the doubters far outnumber the faithful. Few thought the Giants could do it in 2010, 2012 or 2014. People always seem surprised when the A's band of un-renown is successful.

The A's had the best record and the Giants had the worst through Monday of the relatively meaningless Cactus League exhibition schedule. You never quite know just what to make of any of that until the real games begin. Maybe the young A's are playing their tails off to make a big impression. Maybe the seasoned Giants are going through the motions, just easing into regular-season form and waiting to hoist their third World Series banner at AT&T Park to kick it into gear.

But starting out, few seem confident that these teams will be big winners. They are not considered the favorites, once again, but clear underdogs. They've got 'em right where they want 'em. \star

If you made more than \$60,000, you still have a free option in Free File Fillable Forms. This is the electronic version of IRS paper forms. It's pretty basic, so this program is best for people comfortable doing their own taxes.

Free File's software programs will help you find the tax benefits you are due, help pick the right tax forms, and do the math for you. This year, Free File also helps you complete information on your return that is related to the Affordable Care Act. When it comes to the health care law, almost everyone will need to do something new when filing a tax return this year. For each month in 2014, you and everyone on your return will need to do one of the following:

Gather your tax-related documents

Collect the tax materials needed to do your taxes. Here's what you'll need:

- A copy of last year's tax return
- Valid Social Security numbers for yourself, spouse and children
- All income statements, i.e. W-2 forms, from all employers
- Interest and dividend statements, i.e. 1099 forms
- Form 1099-G showing any state refunds
- Unemployment compensation amount
- Form 1095-A, Health Insurance Marketplace

Reporting health care coverage

If you and everyone on your tax return had health care coverage for all of 2014, simply check the "full year coverage" box when completing your return in the Free File software. For most people, that's it!

Claiming a Coverage Exemption

If you did not have health care coverage for all or part of 2014, you may qualify for a coverage exemption. Free File will help you complete Form 8965 and file it with your tax return.

Making a shared responsibility payment

If you or your dependents had neither health care coverage nor an exemption, you may need to make a payment with your tax return. Free File will help you calculate your payment and report it on your tax return.

About the Premium Tax Credit

If you or anyone on your return purchased insurance coverage from the Marketplace, you may be eligible for the premium tax credit. As the tax filing deadline fast approaches, the IRS recommends taxpayers take advantage of the numerous online tools for fast, easy service. Please visit www.IRS.gov for the following information, tools, and services:

Get a tax transcript. You may need a tax transcript for a variety of reasons, including if you apply for a loan or student financial aid; for information needed for state or local tax filing purposes: or even for medical, housing, or utility social services.

Try IRS Direct Pay. If you owe taxes, pay with IRS Direct Pay. It's a safe, easy, and free way to pay from your checking or savings account.

Apply for an IRS payment plan. If you can't pay all your taxes at once, apply for an IRS Online Payment Agreement. A direct debit payment plan is a great way to pay. It has a lower set-up fee, you won't miss a payment, and you won't get an IRS reminder to send a check each month.

Check on your refund. The "Where's My Refund?" tool is a fast and easy way to check on your tax refund. Use the IRS2Go mobile app to access the tool, or Assistant tool for help on how

www.IRS.gov.

Use IRS Free File. If you need to file your tax return, you can e-file for free by using IRS Free File. If you earned \$60,000 or less, you can prepare and e-file your taxes using free brand name tax software. If you made more, you can use Free File Fillable Forms. This option is the electronic version of IRS paper forms. You can also use Free File to file for an extension.

Get answers to tax questions. The Interactive Tax Assistant covers many common tax topics. Type in your question or search terms and it can lead you step-by-step to the answer. The IRS Tax Map gives you a list of tax law subjects to select. It integrates tax topics, forms, instructions, and publications into one research tool.

Get health care tax information. IRS.gov has information about the Affordable Care Act at www.IRS.gov/aca. You can visit this site for details on how the health care law affects your taxes. For example, the pages provide information about Reporting health insurance coverage, claiming an exemption from the coverage requirement, making an individual shared responsibility payment, claiming the premium tax credit, and reconciling advance payments of the premium tax credit. You can also use the Interactive Tax

situation.

Check out a charity. You must donate to a qualified charity if you want to deduct the donation on your tax return. Use the IRS Select Check tool to see if a charity is qualified.

Get forms and publications. View, download, and print federal tax forms and publications anytime.

Calculate your tax withholding. If you get a larger refund or owe more taxes than you expect when you file your tax return, you may need to change your tax withholding. You can complete and give your employer a new Form W-4, Employee's Withholding Allowance Certificate. Use the IRS Withholding Calculator tool to help you fill out a new form.

Some taxpayers are currently visiting a TAC as a result of having received a letter 5071C from the IRS to verify their identities. Taxpayers are encouraged to go through the identity verification process by accessing www. idverify.irs.gov. The website will ask a series of questions that only the legitimate taxpayer can answer. Because of the high call volume on the toll-free numbers, the IRS-sponsored website is the safest, fastest option for taxpayers with web access.
