



teen crashes found substantial evidence that distracted driving is a much more serious problem than previously known, according to the AAA Foundation for Traffic Safety. Video analysis finds that distraction was a factor in nearly six out of 10 moderate-tosevere teen crashes. This is four times as many crashes as official estimates based on police records.

Researchers at the University of Iowa analyzed the six seconds leading up to a crash in nearly 1,700 videos of teen drivers taken from in-vehicle recording devices. The results showed that distraction was a factor in 58% of all crashes studied including 89% of road-departure crashes and 76% of rear-end crashes. National Highway Traffic Safety Administration (NHTSA) previously estimated that distraction is a factor in only 14% of all teen crashes.

Among the key findings in the study were

"Parents can play a vital role in preventing their teens from engaging in distracted driving and learning to be a safe driver," said Cynthia Harris, AAA Northern

## **Consider Carefully Before Adopting Easter Pets**

SACRAMENTO COUNTY, CA (MPG) - Easter is associated with spring, renewal, and new life. Well-meaning parents or family friends may gift baby chicks and bunnies to children in honor of that tradition.

Yet so often after Easter, chicks and bunnies given as Easter gifts are surrendered to animal shelters because they become unwanted as they grow and need increased maintenance.

Rabbits and chickens are excellent pets for those who are familiar with the maintenance necessary for healthy, happy pets.

"Rabbits and chickens can live 10 years or longer, so those who adopt the animals should be prepared for that commitment," said Dave Dickinson, Director of Sacramento County's Department of Animal Care and Regulation.

"Before adopting any animal, people should ask themselves, 'Can I provide specialized diet and housing needs? Can I provide care during travel and vacations? Will this animal be a good match for my family in three to five years?""

Before adopting chicks and bunnies, consider whether or not your property is zoned to keep chickens, whether you can provide proper habitats (roosting quarters for chickens and hutches for rabbits), whether you are able to spay or neuter your new pet, and whether you can provide proper exercise space indoors and out.

Alternatives for live animals as Easter gifts can include chocolate rabbits or stuffed rabbit and chick toys. Pet owners

Keep Easter baskets away from pets, as chocolate and tiny toys can be dangerous or fatal.

The Easter Lily is a toxic plant to pets; it can cause kidney failure when ingested, so keep the plant away from animals.

With the warmer spring weather, dogs and cats will be spending more time outside; make sure your animal is spayed or neutered to prevent unwanted litters, and keep license and vaccinations up to date.

## **Rancho Cordova PATH Changes Name** to HART, Applies for CDGB Grant

RANCHO CORDOVA, CA (MPG) -The first order of business at the March Rancho Cordova PATH (People Assisting the Homeless) meeting was to change their name. Though independent, the group is aligned with similar Elk Grove and Citrus Heights groups. Elk Grove PATH, in securing their nonprofit status, ran into a copyright issue with the name, which was already taken by an independent PATH group in Los Angeles. As the simplest solution, all three Sacramento-area groups agreed to change their name to Homeless Assistance Resource Team, or HART.

"I love that because that's what we're doing," said Karen Edwards, one of the coordinators of the Rancho Cordova group. "We are a resource, and we're a team, so from here on out we will not be referred to as PATH any more, we will be the Rancho Cordova chapter of HART."

The meeting was attended by a core group of people who are moving forward to help those in the area who lack housing. Ken Bennett, community outreach coordinator of Sacramento Self Help Housing (SSHH), was there to add his support. Rancho Cordova HART is operating under the umbrella of SSHH until achieving its own nonprofit status.

The report on the 2014/2015 Interfaith Rotating Winter Shelter revealed that the Rancho Cordova faith community provided four weeks of shelter during the past winter season and did intake on 40 individuals, serving an average of 11-12 each night. Staff from SSHH came each Tuesday evening to do housing counseling and up to 10 individuals, including five veterans, were able to get into transitional housing.

Given vacations and all of the activities that occur during the

Christmas season, it will be efficacious to reconsider the start date for the next winter shelter, Edwards said. "We're going to have to ... start earlier in the year and work on that intake site, which was the biggest real problem that we encountered," said Edwards, who is in charge of Women's Ministry at Sun River Church.

The winter shelter brings people into view, where they can become aware of options. "Some of those people were able to get into permanent housing already," Bennett said, "and they're people we wouldn't have necessarily brought in or found."

The next step toward independence after the winter shelter is to provide a transitional house, said Edwards. When a person or family is without a place to stay, resources are not accessible to them.

"They can't really get the services they need unless they're living somewhere," Bennett said. "You can't make doctor's appointments, you can't get a job, you can't do lots of things if you don't have a place to live."

In order to achieve this, Rancho Cordova HART has applied for the Community Development Block Grant to help provide a transitional house. In order to be awarded that grant, certain things must be accomplished. "We're applying with hope," Bennett said. "We're not applying with matching funds. We're not applying with funds in hand. In the normal course of things we would be denied automatically. Now, however, there is possibility because we told them we're going to be applying for Measure H funds to make up the difference of what they don't give us. So they might give it to us in a contingency if we get approved for the Measure H funds."

Representatives of HART will attend Measure H Town Hall meetings to put forward their cause and will submit a grant application.

The next meeting of Rancho Cordova HART is on April 16th at Sun River Church. Every interested person from the area is invited to attend.

"Hopefully we will get a good sampling from the greater community too, not just the faith community," Edwards said. "Obviously we can anchor it, but it's a collective. We're the Rancho Cordova Homeless Assistance Resource Team."



## **Local American Legion Post Honors** Lenard Yates, Tuskegee Airman

RANCHO CORDOVA, CA (MPG) -Members of Lenard Yates Post #709 of the American Legion, along with family and friends of Lenard Yates, gathered on March 24th at the United Methodist Church in Rancho Cordova to honor the post's namesake: Lenard LeBaron Yates.

Yates was one of the original Tuskegee Airmen who volunteered to become America's first black military airmen. He entered Tuskegee Institute just out of high school and joined the Army Air Corps ROTC. In 1944, he earned his pilot's license and was appointed Cadet Sergeant in the Tuskegee Institute Unit. He enlisted in the Army Air Corps in 1945 and served for 30 years with a primary specialty of USAF Supply Specialist.

Yates was a member of the George S. "Spanky" Roberts Chapter, Sacramento, of the Tuskegee Airmen, Inc., and a longtime Rancho Cordova resident. He died in 2013 at the age of 87.



As a young man, Lenard LeBaron Yates attended Tuskegee Institute and became one of the Tuskegee Airmen, America's first black military aviators. Yates had a 30year career in the U.S. Air Force, and Rancho Cordova was the family's home base for much of

The American Legion post named after Yates was chartered on May 28th, 2014. Michael Hughes of Rancho Cordova was at that time District Commander for the American Legion in Sacramento and Yolo counties. Hughes obtained permission from the Yates family to name the new Rancho Cordova post after Yates because of his military history and career as a Chief Master Sergeant in the Air Force.

Hughes knew Yates for 16

years, and they often went fishing together. "He was one of the greatest men that I've ever known," Hughes said.

"He was very humble," Hughes said. "Nobody even knew that he was a Tuskegee Airman until [the movie] Red Tail came out. ... He was very honest, he believed in God, and he practiced what he preached."

Family and friends who gathered at the American Legion meeting to honor Yates spoke out about his dedication to God, country, and family. "He had the best character," said Yates' daughter, Valerie Yates Talley, of Rancho Cordova. "He always spoke the truth, and he just loved people."

After retiring from the U.S. Air Force, Yates worked for Northrop Aircraft Corporation and then for McDonnell Douglas Services, Inc., where he "coordinated all phases of training" for Royal Saudi Air Force personnel. He and his family lived in Saudi Arabia for 11 years. Saudi Arabia follows Islamic law, which is strictly enforced.

When Talley would come to Saudi Arabia, she said Yates would have her bring her Bible. "I would say, 'Well, Dad, I could get in trouble.' And he'd go, 'No, put your Bible in your luggage on the bottom and then you cover the top of it with your underwear. The Arab men would shut your suitcase right away when they would see that.' And

I'd go, 'But, Dad!' And he'd go, 'No, you have to go on faith."

Talley said that living in Saudi Arabia taught her important lessons and gave her a different view of life than those who have only seen the United States. "He did a very good job in having me understand the people and their cultures," Talley said, "and how you respect the other cultures and remember that you are not in America; they are letting you come and live in their country so you must respect that."

Talley remembers going out on the Red Sea with her father and seeing the "blue holes." She said that the sea was very shallow, and they could wade out for a long distance with the water only up to their knees, until they came to one of the "enormous blue holes" that go down hundreds of feet, imparting a dark blue color to the water. People would fish at the holes.

"You'd sit there and you'd peek over into this blue hole, but you couldn't see anything, it was so dark, the blue," Talley said. "But very scary. He loved anything about fishing; he just loved the water."

The American Legion is a patriotic veteran's organization that was incorporated by Congress in 1919, a group of "veterans helping veterans," Hughes said. Hughes estimates that there are 30 districts and approximately 980 posts in California.





**FCEA Denounces Management Stalling** 

Declares Contract Impasse and Asks Agency to Intervene

"This declaration brings us one step closer to a strike, something our teachers don't want. They would prefer to devote all their energies to helping our students excel. Management's refusal to make good faith efforts to end this dispute is negatively impacting our classrooms and our students," said Itkoff.

The FCEA is pressing the district to use Proposition 30 tax dollars for their intended purpose: to support classroom instruction. Among other things, the district's failure to offer competitive salaries and health benefits is forcing an exodus of highly qualified teachers to other better-paying nearby districts. Low salaries and substandard benefits are also making it difficult for the district to attract highly qualified new teachers to replace them.

Twice in the last 16 years, in 2007 and 1998, PERB certified an impasse in the district, and the dispute moved to fact-finding, the last step before management can impose its last, best offer, and teachers gain the power to call a strike in response. The law also allows teachers to strike in response to illegal management bargaining behavior, a so-called "Unfair Labor Practice Strike."



**RANCHO CORDOVA, CA (MPG)** - The long-planned Rancho Cordova Parkway Interchange project received the green light for construction at a March 16th City Council meeting despite mostly opposition from residents, many of whom were from Gold River and concerned about noise and pollution.

The City Council voted unanimously to approve a new interchange between Sunrise Boulevard and Hazel Avenue, which will also include a new four-lane arterial street called Rancho Cordova Parkway connecting the interchange to White Rock Road. City officials say the project is necessary to ease traffic and improve emergency response times in the community, as well as improving trade and commerce.

"(This) allows for the anticipated future growth of our city," said Economic Director Curt Haven. "Residents, businesses, and trade will leave our city if there is not an alternative route to Highway 50."

Residents from Gold River challenged the city, saying the south-only interchange would bring more noise and pollution to their neighborhood. Sacramento County Supervisor Roberta MacGlashan suggested that the project be relocated to Hazel Avenue where the county plans to make upgrades, partly due to two development projects that have been approved for construction on land owned by Aerojet Rocketdyne. Many Gold River residents echoed MacGlashan's proposal, some imploring the council to build the interchange elsewhere.

According to one planning official, an interchange at Hazel Avenue would create problems for Aerojet, including loss of jobs, and was therefore eliminated as a possible location. An attorney for Aerojet said that the company approves of the interchange but did not comment on the Hazel Avenue alternative.

Some residents said that the project is needed to alleviate traffic on Highway 50 and Sunrise Boulevard, stating that the often mentioned pollution cannot be contained to one part of town.

"We live in a bowl here... I don't think it matters much where you put the traffic, the pollution is going to spread," said Derald Langwell. "It seems we have two choices: either get the interchange built and get some of that traffic moving or just have more traffic sitting there idling on Sunrise Boulevard."

Developer fees will be used to primarily fund the \$100 million project, which would serve approximately 30,000 homes to the east over the next 50 years, including the Suncreek development approved by the city last year.

## I CARE in Action: Making a Difference for Homeless Veterans

**SACRAMENTO REGION, CA (MPG)** - Every day, VA healthcare workers on the front lines help some of the most vulnerable American citizens—homeless veterans. Dr. Michael Yanuck, MD, PhD, of Sacramento H-PACT, is part of a team of health care workers who treat homeless patients. He recently wrote in to the I CARE in Action website to share some of his observations about how VA makes a difference.

Dr. Yanuck recounted the story of one homeless veteran that he and his team assisted in their mobile clinic. He said, "A concerned homeless veteran (with no medical issues) ran out and pleaded for us to help a fellow veteran who was 'wasting away.' The ill veteran told us that he couldn't swallow and over the past three months had lost nearly 50 pounds. Upon hospitalizing the patient, it was found that he had not one but two forms of cancer (throat and lung). He is now receiving assistance in feeding and re-conditioning, and working with specialists in

G) cancer and palliative care." Another homeless veteran

was on the brink of committing suicide when he first came. Dr. Yanuck recalled, "A few weeks before he'd [the veteran] been assaulted and beaten so severely that there were fractures to his facial bones that could not be set. After assisting to admit the veteran to the hospital, we found that he had liver cancer. We assisted in placing him in a nursing home close to family, where he could spend his final days near his son, as were his wishes. The team's efforts at helping with housing and his medical care were met with overflowing expressions of gratitude from the veteran....When next he came to the clinic, he was carrying a dream catcher he'd bought at the gift kiosk. 'It's just perfect to fill an empty space on the wall,' he said. A large image of an eagle filled the center of the dream catcher. 'It's big so I can see it,' he said, alluding to the facial fractures which had irreversibly affected his eyesight and blurred

his vision. Then, he smiled. 'The world is too beautiful to just give up on it,' he said."

Dr. Yanuck said that he and his team have seen VA's homeless program make a difference. He said, "On a daily basis these veterans (who have sacrificed so much) leave me and the members of my team humbled with their expressions of appreciation for even the smallest acts of assistance."

He and his team embody the values of I CARE: Integrity, Commitment, Advocacy, Respect, and Excellence. He went on to say, "There are few patient interactions more rewarding than making a difference in the lives of homeless veterans. They continue to inspire, even as many of them face the greatest of challenges-rising to their mortality and terminal disease. The VA is making a difference in caring for homeless veterans. Over the past months it has been a privilege to play a small part in assisting in their care."

## **Building Activity Strongest in Last Decade**

**RANCHO CORDOVA, CA (MPG)** - As one of our worst recessions in history slowly recedes, developers and residents have gotten a lot busier with construction projects. The number of building permits recently issued in Rancho Cordova is the highest in about a decade.

So far, 1,625 building permits have been issued this fiscal year in Rancho Cordova, with three of the busiest months still left this fiscal year. That number includes 1,081 residential permits.

Permit Services Supervisor Joe Cuffe says most of the growth spurt is in the south part of the city, including the Sunridge/Douglas development area, where the majority of homes are being built.

"It seems like the people who are building the homes are a lot more confident in the ability to sell them," said Cuffe. "And with that, the commercial developers are coming in to supply the new homeowners. We're always cautiously optimistic and hope for the best."

According to Cuffe, they're going through "quite a good spurt" right now with lots of restaurants and other retail establishments opening. "We keep hearing that's going to continue for a while." he said.

And with new commercial development comes new jobs. "Rancho Cordova has a large sector of data centers and more internet-based business [and] insurance companies," he said. "They tend to hire quite a few people and that's great for us." ★



## **Gems Rock the Region**

#### SACRAMENTO REGION, CA (MPG) -

The Roseville Rock Rollers Gem and Mineral Society hosted their 53rd annual Gem and Mineral Show over the weekend, taking over the Placer County Fairgrounds with 65 vendors, lapidary demonstrators, and educational presentations for rock hounds of all ages. With over 3,000 visitors in attendance, it's becoming one of the largest gem and mineral shows on the west coast, according to show chairman James Hutchings.

But don't call it a gem fair. "It's not a 'fair,'" says Hutchings. "A gem 'fair' is a commercial thing; it has nothing to do with rocks and minerals." Enthusiasts and vendors from all over the west coast brought their collections of rough and polished gemstones, mineral specimens, fossils, meteorites, and jewelry collected from all over the world to be put on display or put up for sale. Collectors were also able to bring in rocks for expert identification. "We've got mineral identification, so people can come and bring their rocks, their gemstones, we'll put them through the testing here and determine whether they have something really interesting, sort of like Antique Roadshow, and give them an idea of what they have," explained Hutchings.


The Roseville Rock Rollers started out in 1960 with a handful of rock hound enthusiasts who banded together over a shared love of earth sciences and an affinity for collecting. The group now includes over 280 adult and youth members who enjoy lapidary and jewelry-making classes, specimen collecting field trips, and monthly meetings with their membership. The yearly show not only covers the group's annual operating costs but also gives members the opportunity to

display their prized personal collections. "We put out about 50 display cases of the most exquisite collections in the possession of individuals who have spent their lifetime collecting the best of the best," says Hutchings. "They keep them at home and once a year they bring these minimuseums to our show to show people what they collect."

The show was a family-friendly event, with special attention to educational opportunities for young rock hounds at the Kid's Junction, which featured jewelry arts and crafts and a fossil exhibit courtesy of Sierra College. Junior Rock Roller member Cannon Hansen of Roseville, age 9, brought a selection of his already extensive rock collection to be identified but couldn't quite put a finger on where his love for rocks and minerals comes from. "I've been collecting for years," he said. "I don't know, they're just cool things. I like fossils too, they're my favorite." Cannon's father, Erick Hansen, who is also a Roseville Rock Roller member, brought his son to the show to cultivate his enthusiasm. "Cannon has always shown an interest in rocks; every time we go on a walk outside he's always looking on the ground trying to pick up rocks. He's kind of fascinated

with that and it's a good way for us to teach him science," said the elder Hansen.

Hutchings hopes that such hands-on experiences with rocks, minerals, and geology will help to expand young minds. "Hopefully they're going to understand that the rocks in their back yard, the rocks along their driveway, are not the [same as the] rest of the

rocks in the world," he said. "The rocks of the world are absolutely exquisite productions of Mother Nature. There are things you never knew existed,

and that's the most common comment we get by people who have never been to a show: 'I had no idea that these things existed.""  $\star$





## Lancers Baseball Knocks Off Diamondbacks







### Got 'em Right Where They Want 'em

Are you ready for some....BASEBALL!!

This is when the smokin'-hot country singer comes prancing in singing some lame song about.....wait a minute, that's FOOTBALL. If the power brokers in baseball are looking to boost their lagging national television ratings this season, they might want to consider adopting football's promotional model. As pathetic as it may be, it attracts a lot of attention.

Football shows no shame whatsoever. For as long as any of us could likely recall, the NFL has preyed on most men's basic instincts and desires to sell its products. Take, for example, that classic Oakland Raiders billboard ad that appears each season that everybody has seen from the freeway —the advertising brain trusts' version of the Killer B's: a frosty Coors; a Raiders emblem; a Raiderette cheerleader —-Beer, Ball and Babes. That'll catch your eye every time. The promoters of the NCAA

Men's Basketball Tournament have obviously caught on. (Although, all of this commercial silliness is based on a long-standing, timeproven, winning formula: The majority of sports-lovin' men also love women).

It was impossible not to notice the not-very subliminal tactics used on the broadcasts of some of the tournament games. You must have seen this one a couple of times —- during a break in the game as the station led into its commercials, along came a rapid sequence something like this: a player drives to the basket for a layup; a blink-of-the-eye, vague glimpse of a young woman; a three-pointer swishes through the net; a vicious blocked shot; a little-bit-longer peek at the young lady spinning; a sweet move to the hoop; a great pass for a fast break conversion; another more-extended look of a side-view of the sweetheart arching her back (undoubtedly excited about the action on the court); a ferocious slam dunk; off to the commercials.

They've got us right where they want us. No wonder that on television, especially in ads and sitcoms, that men are portrayed as such idiots. We're not all easily-manipulated fools. Or, are we? (Admittedly, there has been an undeniable, irresistible craving lately to go out and get one of those new Carl's Jr.'s burgers). But, enough of that...for baseball is around the corner. The precious Little Leaguers, intent high schoolers and rambunctious recreational softballers are already underway, and the start of the Major League Baseball season is just days away.

Following bits and pieces of the San Francisco Giants, the Oakland Athletics and MLB in general through the course of the painfully-long spring training activities, its seems as though there is a perceived shroud of doom and gloom hovering over the Bay Area franchises.

It does look as though powerhitting will be an issue for the Giants after losing Pablo Sandoval and Michael Morse from the lineup. They do have aging starters in the pitching rotation. They are relying on bounce-back seasons from a star starter (Matt Cain), a difference-making outfielder (Angel Pagan) and a still-developing, slugging first baseman (Brandon Belt) who are coming off injury-riddled seasons. They have a young second baseman (Joe Panik) hoping to avoid a sophomore slump.

The A's shipped out a bunch of All Stars and top-flight pitchers. They made nine trades involving 27 players. They are projected to field a whole new infield alignment and a lineup featuring five new faces.

A panel of USA Today "experts" all chose the L. A. Dodgers to win the NL West for the third straight year over the Giants, and only two of them tabbed the Giants as a wild card team. Only Buster Posey and Madison Bumgarner have been given any love at all by the fantasy baseball gurus. No one picked the A's to even reach the playoffs this year and they were listed 15th in the MLB power rankings (the Giants were sixth). Only newlyacquired second baseman Ben Zobrist and pitcher Sonny Gray cracked the top-seven at their position by the fantasy crowd.

What the Giants do have is the last World Series MVP and Sportsman of the Year in Bumgarner, a former Rookie of the Year, batting champion and MVP in Posey, a future Hall of Fame manager in Bruce Bochy, the Comeback Player of the Year (Casey McGehee) replacing Sandoval at third base, and a returning "Core Four" of relievers (Affeldt, Lopez, Romo, Casilla) in the bullpen as they have been through the Giants' run of three World Series titles in five seasons. Among the four veteran starters behind Bumgarner, they have the winningest active pitcher in Tim Hudson (214), while the group has combined for three Cy Young Awards, three no-hitters and 549 combined victories. They have a wealth of playoff experience throughout the roster. They have a general manager who has paved the way for a long stretch of success.

Who knows what the A's have? But that's how they roll. With their usual annual roster turnover, you never know what to expect. But the masterful general manager Billy Beane has proven capable of bringing it all together — leading what looks like a makeshift roster that includes several unproven players that find a way to prove themselves in Oakland — steering the team into the postseason three years in a row.

As usual, the doubters far outnumber the faithful. Few thought the Giants could do it in 2010, 2012 or 2014. People always seem surprised when the A's band of un-renown is successful.

The A's had the best record and the Giants had the worst through Monday of the relatively meaningless Cactus League exhibition schedule. You never quite know just what to make of any of that until the real games begin. Maybe the young A's are playing their tails off to make a big impression. Maybe the seasoned Giants are going through the motions, just easing into regular-season form and waiting to hoist their third World Series banner at AT&T Park to kick it into gear.

But starting out, few seem confident that these teams will be big winners. They are not considered the favorites, once again, but clear underdogs. They've got 'em right where they want 'em.★

Two days after rallying past LSU in improbable fashion, NC State knocked off No. 1 seed Villanova to advance to the Sweet 16. The Wolfpack led by seven with 1:30 remaining but saw the lead dwindle to one in the final seconds before holding on for the thrilling win.

In four NCAA games, Winslow has averaged 14.0 points, 9.5 rebounds, 3.3 assists and better than one block and one steal per game.

Honorable Mention: Bryce Alford, UCLA; Robert Brown, UAB; Tyus Jones, Duke; Jahlil Okafor, Duke; Domantas Sabonis, Gonzaga; Kyle Wiltjer, Gonzaga Best Game: Duke 66, Gonzaga 52. That 14-point final margin didn't do the game justice, even if it was the most lopsided game in this year's Elite Eight. This was a four-point game with four minutes to go before the Blue Devils flexed their muscles and pulled away for the double-digit win.

Also, the Spartans need to continue to hit their free throws on a consistent basis — something they did not do during the regurlar season.

**Will lose to Duke on Saturday if...** Duke overwhelms Michigan State. Feel free to argue that the Spartans were under-seeded as a No. 7, but Michigan State was 19–10 a month ago. This is a team that plays well as a group, but from a talent standpoint, the Spartans will have trouble matching up with Duke's Big 3.

Duke coach Mike Krzyzewski has his team in the Final Four for the first time since 2010, when the Blue Devils beat Butler to win the national title.
