

Hookah Lounge Moratorium Extended One More Year

RANCHO CORDOVA, CA (MPG) - Citing health concerns and potential impacts on the community, the Rancho Cordova City Council voted unanimously at a March 2nd meeting to extend a 10-month moratorium on the establishment and operation of hookah bars and private smokers' lounges within city limits.

Unlike a moratorium passed in August banning sales of alcohol

near strip clubs, the hookah moratorium had no residents speak out during public comment and was adopted without any controversy. According to City Attorney Adam Lindgren, last year the city did an update of ordinances related to smoking and encountered issues relating to hookah bars and smokers' lounges.

"We became curious and received some level of impact that hookah lounges may have on the community at large," Lindgren said in a phone interview.

Lindgren said that the moratorium will help city staff better examine options for safeguarding some of Rancho Cordova's younger or more vulnerable residents.

"The police department and the city attorney's department have received anecdotal information that minors are getting some access to these types of facilities," Lindgren said. "We want to look closely at whether or not additional regulations other cities

have adopted would protect the where the places where their community."

Some of the issues that Lindgren said the city is looking into are health effects associated with the use of hookah pipes and e-cigarettes, a battery-powered cigarette that produces nicotine vapor instead of tobacco smoke. Another related concern is where the city might allow such establishments to operate if the moratorium is lifted.

"We want to look at what are the best places for these businesses,



impact on the community would be most appropriate," Lindgren said. "We haven't decided exactly where those areas should be; we might well conclude that we need to treat them as we have other what we call 'specially regulated uses'."

Specially regulated use areas are necessary for the same reasons as prohibiting beer sales in strip clubs and minors from going inside smoke shops, according to Lindgren.

"We do in many cases have zones where businesses that have the potential to have particular impacts on minors are more distanced from those populations," Lindgren said.

City officials will continue to examine any potential impacts on the community from smoking lounges throughout the year and possibly make recommendations regarding zoning areas next year once the study is completed. \star

Local Youth Earn \$10,000 in Grants for Community Projects

RANCHO CORDOVA, CA (MPG) Grants Advisory Board for Youth (GABY) granted \$10,000 to local youth-led projects during the 13th Annual GABY Convening at Rancho Cordova City Hall on Saturday, February 28th. A program of the Sacramento Region Community Foundation since 2002, GABY supports youth in developing their knowledge of philanthropy, skills for serving their community, and resources for implementing youth-led projects.

"I am inspired by these young people wanting to make change in the community," said Jordana Steinberg, daughter of former California Senate President pro tempore Darrell Steinberg. Jordana Steinberg addressed the students to discuss her struggles growing up with mental illness. "No matter how hard the task may seem, you can do whatever you choose to do and whatever you want to do if you set your mind to it."

Darrell Steinberg told the group that they wield positive power in our community and commended them for "[using] your energy, your intellect, and your beliefs ... to help your community and help other people."

Sacramento City Councilmember Rick Jennings II was also a guest speaker at the Convening. "These are the future leaders. They are current leaders

right now in their schools, and they are the future leaders [of] our city. I think they are going to take the message away that we are servants committed to serving and filling in the gaps wherever we can," said Jennings.

GABY is guided by a board of 23 youth between the ages of 13 and 18, and this year the board listened to 20 youthled projects as diverse as "Healthy Mind - Healthy Body" from Language Academy of Sacramento; "Growing Food, Love, and Advocacy" from People Reaching Out; "Budding Landscape Architects" from Grant Union High School; and "4-H On The Wild Side Program" from Sacramento County 4-H Youth Development Program. At the end of the Convening, all presented projects received grants for an overall total of \$10,000.

Parkway Interchange project is one step closer to coming to fruition to relieve traffic congestion, improve emergency access, and accommodate future planned developments in Rancho Cordova.

The project was identified by Sacramento County in the 1980s as a solution to ease traffic congestion along the heavily traveled Sunrise Boulevard. The City of Rancho Cordova began championing the project following incorporation in 2003.

The proposed project includes construction of a new south-only interchange and auxiliary lanes along Highway 50 between Sunrise Boulevard and Hazel Avenue. The project also includes construction of Rancho Cordova Parkway, a

RANCHO CORDOVA, CA (MPG) - The new four-lane street that would connect the interchange to White Rock Road.

> Traffic congestion is one of the primary reasons for the Parkway Interchange project. Since incorporation, the City's population has grown to over 67,000 residents and 47,000 business professionals.

> "Traffic congestion has become a problem on Highway 50 and major roads such as Sunrise Boulevard," said City Public Works Director Cyrus Abhar. "The Parkway Interchange will ensure that our infrastructure can accommodate the City's growth so we can continue to provide a good level of service to our citizens."

The project will also improve emergency access in the City for the police department, fire department, and other emergency responders.

Beginning in 2015, planned developments are expected to gear up, bringing new homes and commercial space to Rancho Cordova. The Parkway Interchange will provide additional highway access to these new developments.

The Rancho Cordova City Council is holding a public hearing for the Rancho Cordova Parkway Interchange project on Monday, March 16th at 5:30 p.m. at City Hall, 2729 Prospect Park Drive.



Local Father Turns Bedtime Stories for His Children into Fantasy Novel

RANCHO CORDOVA, CA (MPG) -Local Rancho Cordova dad, Jason D. Batt, has taken his children's bedtime stories and crafted them into an adventure-filled fantasy novel. The book, Keaghan in the Tales of Dreamside, tells the story of a young boy that discovers a world full of strange creatures inside his own home. Keaghan must journey through Dreamside, a strange world of twisting hallways with a labyrinth just beyond the walls of every home. Keaghan will discover that he is the Boy at the End and the only one capable of saving the world of Dream from the invading Cra-gin and their horde of ravaging Tomsi.

Batt describes the creation of Keaghan in the Tales of Dreamside: "We've long had a tradition of nightly bedtime stories. We quickly gave up reading from storybooks and instead, I'd come up with different stories each night with my children as the heroes. The stories became serialized, ending each evening in a cliffhanger. Finally, after a few years, my family encouraged me to write the stories down. I originally wrote it as a simple three-chapter book. Then I started receiving requests for the rest of the story. What were just a few pages turned into an entire novel.

Batt is a former English teacher and has a passion for teaching children the love of reading. He says, "My son isn't as avid of a reader as the rest of the family. He often struggles to find books that would interest him at his reading level. So, my desire was to take some of the elements that are found in older fantasy works and put them in a book that was at his reading level. It is an intense book. It's meant to be! I kept looking for something that would grab my son's attention from cover to cover and finally decided I'd have to write it myself."

Keaghan in the Tales of Dreamside was written for children between third and sixth grades, but Batt says he's had many adults e-mail saying that they "absolutely loved reading it themselves." Kirkus Reviews described the book as "...a phenomenally imaginative series, with a strong, relatable child protagonist, collected in this handsome, beautifully illustrated edition. It can also be appealingly dark, with eerie fairy-tale motifs...overall, an original, entertaining YA fantasy."

The book is now available in audio format from www. Audible.com, iTunes, and www. Amazon.com. The audio version is narrated by Mike Pyrc. Pyrc is a well-known Michigan sports announcer who works as a video editor and voiceover artist

for Dow Chemical. Batt was very impressed with Pyrc's work. Batt said, "He had sent over the first few chapters and I started listening to them in my car. My boys and I found ourselves sitting in our driveway waiting to see what happened next, completely enthralled with Mike's storytelling. And I wrote the book! Mike completely captured the spirit of the book and brought the characters to life in a way that was beyond my greatest expectations. Several auditions came in through ACX but none compared to Mike's work!"

The book is also available in print and as an eBook from Amazon.com, Barnes and Noble, Apple iBooks, Kobo, and Smashwords.

"After a month or two, my hair will be back to normal. It is a minor thing, considering it will provide awareness and financial resources for curing this horrible disease."

From all reports, Juergen Peters was a bright, sweet young man. He was born in Kassel, Germany shortly after Word War 2, the fabled city where the Brothers Grimm had lived and collected their many tales. Kassel was no magic kingdom post-war, however, as it had been utterly destroyed.

So together, Peters and Kassel, entered the world: The child born and the city remade. And both, it seemed, even with their new shine, suffered from great bombed-out craters. Juergen Peters was often troubled, depressed, and felt like he had a massive hole in his heart.

After an intense dispute at work one day he turned unusually dark, even for him. He walked off his job and climbed to the top of the city of Kassel's water tower-more than ten stories high-with every intention of jumping to his death. As authorities rushed to the scene, a crowd of onlookers gathered to witness the event.

At some point Juergen, thankfully, was convinced by a negotiator to change course. He carefully began climbing down the narrow iron ladder to the ground. The crowd, deprived of a sensational conclusion, did not take its disappointment lying down. Someone yelled out to the boy, "Jump, you coward, jump!"

This led to a kind of mob scene. As Peters descended the tower more and more spectators



began to jeer and deride him. He destructive. hesitated, looked down at the crowd, and then climbed back up. When he reached the top again, he moved out on the ledge and flung himself off. He was only nineteen years old.

If Juergen Peters had made it safely to the ground that day, I don't know if he would have received the mental health intervention he so badly needed. But I do know this: The cause of death may have read "suicide," but those in the crowd could have been detained as accomplices to the crime.

This is a tragic, dramatic story, but a necessary one. It was the great Flannery O'Connor who concluded that to get people's attention you have "to make your vision apparent by shockto the hard of hearing you shout, and for the almost blind you draw large and startling figures." We need to be shocked and startled, because our verbiage is as deadly today as it was below that water tower in Kassel, Germany.

We are destroying one another with our words as hateful, spiteful rhetoric spills out in all corners of society. Road rage. Bullying at school. Toxic hate speech. Political opponents locked in verbal assault. Hordes of tanked-up adults coming to blows at a Little League game. Online "comments" that are nothing but anonymous, poisonous vitriol lobbed like grenades into a crowd. The level of hostility and lack of civility in our country is nothing but

Ancient wisdom recognizes and identifies the root of this problem: "A tiny spark can set a great forest on fire. And the tongue is a flame of fire," the

Jewish sage wrote. Going further he said, "By our speech we can ruin the world, turn harmony to chaos, throw mud on a reputation, send the whole world up in smoke and go up in smoke with it, smoke right from the pit of hell."

All of us have this potentialto strike out with hellish words that act like kindling for a raging fire. We strike at our spouse and children. At the other drivers on the highway. At perfect strangers. At those already suffering from measureless internal torment. At our rivals we find so easy to demonize.

The children's rhyme we all learned before kindergarten is wrong: "Sticks and stones may break my bones, but words will never hurt me." That's a boldface lie. Words hurt. Words can lodge so deep in the memory that decades of living cannot erase the words or the pain they generate. Words can crush, destroy, and yes, even kill. But they are not just killing others. We are burning our whole world to the ground. May God give us the grace to keep our mouths shut.



A Recipe for Disaster: the Rancho Cordova Interchange Project

I love a well-made dinner. My mom-in-law is the best cook when it comes to the all-American pot roast, broiled potatoes, vegetables simmering atop the pot roast that has been carefully seared, then placed in the oven to marinate. Wait three hours, then out comes a meal worth waiting for. It smells so divine, you can get full just inhaling the aroma. A little horse radish and other garnishments to enhance the meat and potatoes, drown the meat in country gravy, and it's a meal fit for a king. After that indulgence, then comes the best part--dessert. Succulent apple pie delicately sprinkled with a crumb-top crust, apples with just the right dose of cinnamon, sugar, and butter to satisfy the most yearning soul hungry for the finer things in life.

What if my mom-in-law tried something different? What if she had all of us at the table first eat an apple apiece. Then each of us swallowed 5 tablespoons of sugar. Then she brought us all a halfcup of flour to choke down. Add to that a spoonful of cinnamon and salt. Oh, don't forget the four tablespoons of butter. We'd all be at the table greener than the apples we just ate. "A recipe for disaster" you'd say. "No one in their right mind would do something like that." A good meal, and its dessert, takes planning, years of fine tuning, and finally perfection is attained when just the right complement of ingredients are verified with proof by a round of applause by the dinner guests for the cook.

The City of Rancho Cordova is tentatively poised to approve the proposed Rancho Cordova Interchange Project at its March 16 meeting at City Hall. You may not be aware that the City and its

well-meaning project staff have been busy in the city hall kitchen preparing a recipe not unlike the apple pie that's revered as a properly baked confection, but instead is a recipe for disaster. It's not well thought out and the end product is no less than a literal gag-meal for the guests, those who will endure the project for as long as they live in Gold River. The massive 6-lane interchange structure will be located in Gold River's Eureka Village between Sunrise and Hazel in a small 7-acre parcel, as close as 50 feet to existing homes. Serving as the main traffic drain for a projected 53,000 homes, it is estimated that at least 100,000 cars will use the interchange daily. Can you imagine standing 50 feet away from such an interchange and breathing the toxic car emissions 24 hours a day? How about your children or grandchildren? How about the kids that run their hearts out playing soccer or recreating at the nearby Prospect Hill Park? You wouldn't even think of subjecting your family to such a hazard, but that's exactly what the City is proposing, and they are not batting an eye when they tell you it's a good project.

Dozens of studies have been conducted (many of them in California) by major universities that raise a red flag when it comes to children and toxic air emissions. Rates of childhood diseases increase significantly even at distances as far away as 1,000 feet from a freeway or interchange. In fact, one study documents that a mother who lives within 1,000 feet of a freeway while pregnant doubles a child's odds of having autism. Scientists in Los Angeles have for the first time directly linked freeway vehicle emissions with brain damage due to airborne

toxins from cars. Other studies document lung disorders in children that live near interchanges, especially those with stop-and-go (resulting in higher levels of emissions) vehicle approaches.

What does the City say to all of this? Nothing. Did they bother to even conduct a Toxic Air Contaminant study in the environmental impact report prepared for approval of the project? No. Did they attempt to characterize the risk to residents that might be living within a stone's throw of the interchange? No. Was there any sort of modeling exercise completed to at least warn residents of Gold River that their health will be impaired if they live within a 1,000 feet of the project? No. Yet the Rancho Cordova City Council is quietly and comfortably poised to approve the project, health risks and all. Next agenda item please?

Every Gold River resident needs to make known to the City their opposition to this project being located in Gold River. There are alternatives--for example locating the project at Hazel Avenue--that will accomplish the same goal for the City but not result in serious health maladies for our community and its residents. Call Mayor Robert McGarvey at (916) 851-8700 and let him know that putting an interchange 50 feet from homes is a terrible idea. Make your opinion known. Attend the City Council meeting. Water Districts May Step Up **Drought Conservation Efforts**

RANCHO CORDOVA, CA (MPG) - Water customers in Citrus Heights and Rancho Cordova should expect to continue conservation efforts this summer, with a fourth straight year of below-normal precipitation.

Suppliers will continue implementing emergency regulations issued by the State Water Resources Control Board last year. Those regulations currently prohibit using water to wash down hard surfaces like driveways, watering of outdoor landscapes that cause excessive runoff, and using hoses that don't have shutoff nozzles. Also, only recirculated water can be used for fountains or other decorative features.

And this year the Board is also proposing that all urban water suppliers that do not already have a limit on outdoor watering restrict it to no more than two days per week-including no watering during, and 48 hours following, measurable precipitation.

Rex Meurer is a conservation specialist for the Citrus Heights Water District, which serves about two-thirds of residents. He said education is still preferable to penalizing. But he said around 220 warnings were issued last year, mostly for broken sprinkler heads and automatic sprinkling systems running too long. However, only 12 residents received actual citations in the

mail that feature \$25 fines, and steady stream of water-wast-Meurer said the fines have not actually been imposed.

The district currently does not restrict residential watering to certain days. "We've found over time that if you go to even-odd days, based upon your house number, people tend to use more water," said District General Manager Bob Churchill.

On its website, the District tells customers that violating state regulations makes you a "careless water hog" and "irresponsible and selfish." But Meurer said residents have done a good job with keeping the city's conservation rate close to the state goal of 20%, although it dropped about three points in January to around 16%. "Our customers have been really good and responsive to our requests," he said. "We are very pleased with that trend and it's continuing."

In Rancho Cordova, where there has also been no watering restrictions, the conservation rate dropped from about 11% in December to -0.7% in January.

The Golden State Water Company also handles about two-thirds of total customers. Manager Paul Schubert said their supply is more secure than some areas. "It's not contract water, it's actually a property right," he said. "But because we are a part of the region, we're asking our customers to conserve just like everybody else."

Both districts have fielded a

ing complaints and take calls 24 hours a day. And volume is expected to pick up a lot more as the weather warms up. But Schubert says Golden State Water has not issued any citations.

Meanwhile, recreation will not be impacted. But the administrator for the Cordova Recreation and Park District, James Rodems, said users may find the landscape to be less green. "We're not at that point yet where we're saying we need to actually start taking turf out," he said. "But, depending on how this season goes, it could be something that we take a look at next year."

Rodems also said the district's five spray parks will remain open since they use recycled water.

In Citrus Heights, Sunrise Parks and Recreation District Administrator Dave Mitchell said they also plan to continue to reduce watering in non-essential areas. "People can live with lawns that aren't perfectly green all year long," he said, "as opposed to closing a swimming pool."

Data does indicate that only mandatory conservation can inspire water users to save on a more consistent basis. A recent Field Poll shows that mandatory rationing is now supported by more than one-third of voters. But a majority of voters still want a voluntary approach. \star



Brown fat activity is boosted fifteen-fold at 65 degrees F during exercise, when exposed skin meets the cold air. 4) BECOME AN INFLAM-MATION FIGHTER. Chronic, low-grade inflammation is a major contributor to a host of issues including type 2 diabetes. Inflammation can be measured by C-reactive protein levels (CRP), easily checked in your annual blood test, and is crucial to interpreting your risk of Diabetes, and cardiac arrest. I will get to the last four strategies in my next column, but keep in mind that, within each chapter of "The Diabetes Reset," Dr. King provides evidence to support the strategy and advice on adopting it into a daily routine. It also busts the myths that keep Americans from changing their habits, and outlines a clear twelve-week implementation plan with a tool to track your progress. Dr. King M.D. is research Director and Chief Scientific Officer at the Joslin Diabetes Center. He is one of the most sought-after speakers on diabetes and diabetes-related issues. Dr. King explains why preventive care is important for everyone regardless of current health or family history-including the surprising role of dental care and hygiene in Diabetes prevention. 

"The generous donation of these books will allow children to practice reading at home and give them the joy of having their own book," said Angela Griffin







The Winds of Change Really Blow

The window was wide open in 2012 and 2013, and the team was loaded with great stars and young talent. Now it feels as though the window has been slammed shut, stones have been thrown from every angle shattering the glass, and the gusty winds of change are howling through the building.

These are not going to be your uncle's (nor Jed York's uncle's) San Francisco Forty Niners anymore. One season removed from their best stretch of success in several years, these also will not be coach Jim Harbaugh's Forty Niners anymore, either.

Along with Harbaugh, who has ventured off to coach at his college alma mater, the University of Michigan, and almost all of his coaching staff, many other familiar 49ers faces that were a part of championship-challenging roster are gone, or soon will be.

A sudden flurry of activity early in the week seemed to set in motion an extensive reshaping of the team going forward. Based on the "where there is smoke, there is fire" theory, by week's end The Faithful will be wondering "Who are those guys?"

Frank Gore, whose 10-year run with the 49ers finds him standing atop the all-time team rushing list with 11,073 yards, was expected to sign with the Philadelphia Eagles Tuesday. Seven-time Pro Bowl linebacker Patrick Willis and star defensive end Justin Smith were expected to announce retirements. Wide receiver Michael

Crabtree and offensive tackle Mike Iupati were expected to sign elsewhere. There are even rumbling trade rumors around quarterback Colin Kaepernick.

Meanwhile, the 49ers have signed Australian rugby superstar Jarryd Hayne, veteran DT Darnell Dockett, troubled and not too "classy" wide receiver Jerome Simpson, and speedy wide receiver Torrey Smith, who teamed with 49ers holdover WR Anguan Boldin while with the Baltimore Ravens to help defeat the 49ers in the Super Bowl following the 2012 season.

As is customary in the NFL, following that great playoff run by San Francisco that fell just short, 34-31, against the Ravens, the 49ers' roster was pilfered by teams around the league over the last two years, and heading into next season there may be as few as six players remaining on the team from the starting lineups of that Super Bowl.

When Harbaugh joined the 49ers he took over a team that had not reached the playoffs in eight seasons, following the glory years of 1981-2002 when the 49ers had been a playoffs mainstay, winning five Super Bowls. He posted a 44-19-1 overall record, 5-3 in the playoffs. He led the team to the playoffs three consecutive years losing to the New York Giants, 20-17 in overtime, in 2011, to Baltimore the next year, and to the Seattle Seahawks in the NFC Championship on the final play in 2013, 23-17. That's when the window began to slide shut and the team, amidst season-long turmoil, slipped to 8-8 last year.

Now that Harbaugh and York's front office have not-somutually agreed to part ways, the 49ers will start next season in their new stadium in a new city (Levi's Stadium in Santa Clara that opened last year with very mixed results), with a new coach (Jim Tomsula, in his first year as an NFL head coach), a new staff and a bunch of new players looking to begin a new era of success.

Not surprisingly, the organization has been under heavy

criticism as a result of so many changes. Fans will certainly remain skeptical through their "mourning period" until there are positive performances on the field. Fans get attached to their guys and are loyal to their favorites, and there will be an adjustment period while getting used to the new guys

and choosing new favorites. The same can be said for the San Francisco Giants, who let lovable World Series hero Pablo Sandoval and power-hitting outfielder/first baseman Michael Morse get away during the offseason, replacing them with OF Nori Aoki (from WS opponent Kansas City) and third baseman Casey McGehee (from the Miami Marlins). McGehee was the NL Comeback Player of the Year in 2014, posting regular-season, across-the-board numbers very comparable to Sandoval, except home runs (4 to 16). His best season was 2010 for Milwaukee, hitting .285 with 23 homers and 104 RBI. Giants fans could warm to those kinds of numbers very quickly.

Sandoval didn't do himself any favors since moving on to Boston when he recently went public expressing his hard feelings about leaving the Giants, where he was a part of all three World Series titles and was named MVP of

the 2012 championship series.

Pablo complained about the relationship with Giants general manger Brian Sabean over contract talks, felt he was "disrespected" by the Giants and that the "only guys he'll miss" will be manager Bruce Bochy and Hunter Pence.

But Pablo, what about all of those celebratory dog piles on the infields, all the high-fives in the dugouts, the champagne showers in the clubhouses, the parades and all the rest?

Clearly, these are unfortunate, misguided comments from Pablo, who, hopefully, might eventually lessen the sting with additional statements later, because they only dim the shine from his long career with San Francisco. They will, however, make the transition a bit easier for both Giants fans and McGehee as they establish a new relationship.

Will these million-dollar ballplayers ever realize that it just doesn't sit well with fans to hear complaints about money, working conditions or being "disrespected?"

Time will probably heal any wounds. When the winds blow through it clears the air, setting the stage for a fresh new story. \star

1. KENTUCKY IS GOING FOR PERFECTION

College basketball hasn't had a story like this since — when, exactly? Kevin Durant vs. Greg Oden in the first year of one-and-done in 2007? The Christian Laettner era at Duke? This is the No. 1 story in college basketball as Kentucky tries to match Indiana's 1975-76 undefeated national championship team. Only five teams since have entered their league tournament undefeated, and only 1991 UNLV could claim to be as divisive. No fan base is more invested than Kentucky's, and John Calipari may be the only coach to match Mike Krzyzewski as a love-him-or-hate-him figure in the sport. One way or another, Kentucky will make history in this Tournament — either by becoming the first team to go 40–0 or being on the wrong end of a monumental upset.

2. THERE'S DRAMA IN THE PLAYER OF THE YEAR RACE

Maybe it's for the best that the race for the Wooden or Naismith awards doesn't get the same hype as the Heisman Trophy. A year after the Player of the Year award was a season-long coronation for Creighton's Doug McDermott, the sport has a legitimate two-player race between Duke's Jahlil Okafor and Wisconsin's Frank Kaminsky. Both play center for national championship contenders, but they don't fit the same profile. Okafor, who does his best work around the basket, has been a contender for the No. 1 overall draft pick since he was in high school. Kaminsky, who is more of a threat from the perimeter, was a virtual unknown two years ago. This will be the most heated Player of the Year race since Duke's J.J. Redick and Gonzaga's Adam Morrison shared the award in 2005-06.

3. A FINAL FOUR DROUGHT COULD END OUT WEST

The two best coaches who have never reached the Final Four both reside out West, and both may have their best chance to reach the final weekend of the NCAA Tournament. Gonzaga's Mark Few has a 30-win team that may be better than his Bulldogs team that was a No. 1 seed in 2013 or the team with Adam Morrison in 2006. Meanwhile, Sean Miller's Arizona team recently wrapped up another Pac-12 championship and will enter the postseason with one of the best rosters in the nation. Miller has been to the Elite Eight three times in his career, once with Xavier and twice with Arizona.

4. MANY MORE WINS ON THE HORIZON FOR COACH K

Earlier this season, Duke's Mike Krzyzewski became the first Division I coach to reach the 1,000-win mark, and he has a team that should be able to build upon that total in the NCAA Tournament. He has Okafor anchoring the center spot, but his backcourt of freshman Tyus Jones and senior Quinn Cook may be the most clutch duo in the country. Depth and defense remain an issue for the Blue Devils, so there's hope for the Duke haters who enjoyed the Devils' recent Round of 64 losses to Mercer (2014) and Lehigh (2012).

North Carolina coach Roy Williams has an athletic department embroiled in an ongoing academic scandal that seems to get worse every passing week. SMU coach Larry Brown was without his star recruit (point guard Emmanuel Mudiay) who is playing overseas and had to deal with eligibility issues with other key players. Kansas' most highly touted freshman and pro prospect (Cliff Alexander) might not play again this season while the NCAA investigates possible contact between his family and an agent. Why don't we all get back to basketball for a bit.

5. VIRGINIA IS A NATIONAL POWER

Virginia hasn't been this good since Ralph Sampson played for the Cavaliers, but what's most remarkable is that the Cavs aren't doing it with a ton of stars or flash. Virginia has won back-to-back ACC regular-season titles and enters conference tournament season with just two losses. Coach Tony Bennett has done this without a five-star prospect or a McDonald's All-American and without his top player, Justin Anderson, for the final eight games of the regular season. The style isn't for everyone — Virginia ranks 349th of 351 team in terms of tempo — but it is effective.

6. NO ONE IS TALKING ABOUT VILLANOVA

Villanova has lost only two games yet is flying under the national radar — a bit puzzling for a program that has won a national championship, been to a Final Four in recent years and has a star coach on the bench. The reason? Maybe it's because the Big East doesn't get much exposure from ESPN since most of its games are on FOX Sports 1. Or possibly because Villanova lost last season as a No. 2 seed in the Round of 32. Whatever the reason, don't hold it against this year's Villanova team. The Wildcats are in the top 20 in both offensive and defensive efficiency, a trademark of teams that go on to win the national title.

7. OFF-COURT ISSUES CLOUD BIG-NAME COACHES

This has not been a good year for Hall of Fame coaches. Duke's Mike Krzyzewski dismissed a player (Rasheed Sulaimon) who was later revealed to be facing sexual assault allegations. Syracuse banned itself from the post-

9. POWER TEAMS WILL BE AT HOME

Hope you didn't expect to tune in to watch Syracuse, UConn, Memphis and Florida in this field. They're home. Sorry. UCLA and Texas enter their respective conference tournaments on the bubble and could be headed for the NIT.

10. BIG NAMES WILL BE BACK

In the place of those powerhouses, you should be able to welcome back Larry Brown, who hasn't been to the NCAA Tournament since 1988. Brown's SMU team was snubbed last season, and now the Mustangs are closing in on their first appearance since 1993. Other powers due to be back after missing out in recent years: Purdue (2012), Maryland (2010), Utah (2009) and Arkansas (2008).

PRIME TIME PLAYERS

Devin Williams tied a career high with 22 points and added 13 rebounds to lead West Virginia — playing without star guard Juwan Staten (injured) — to an 81–72 win over Oklahoma State. ... Forward **Daniel Ochefu** (21 points, nine rebounds) was one of five Villanova players in double figures in the Wildcats' dominating 105–68 win over St. John's. ... With Selection Sunday looming, Xavier avoided a bad loss by beating Creighton 74–73 in Omaha. **Matt Stainbrook** led the way with 26 points and nine rebounds. ... **Craig Bradshaw** scored 25 points and

Taylor Barnette hit a go-ahead 3-points and with 3.2 seconds remaining to lift Belmont to an 88–87 upset over Murray State in the OVC Tournament championship game. ... Montrezl Harrell scored 20 points and grabbed 12 boards to help Louisville knock off ACC regular-season champ Virginia, 59–57. ... Freshman point guard **Tyus Jones** scored 24 points (12-of-12 from the foul line) and added seven assists and three steals as Duke completed the season sweep over North Carolina with an 84–77 win in Chapel Hill. ... Aaron White continued his strong play for lowa with a 25-point, eight-rebound performance in the Hawkeyes' 69–52 win over Northwestern. White is averaging 22.8 points in his last five games. ... **D.J. Newbill** scored 31 points, none more important than the 3-pointer he drained at the buzzer to give Penn State a 79-76 win at Minnesota. ... Demarcus Daniels scored 22 points off the bench to lead North Florida to a 63–57 win over USC Upstate in the Atlantic Sun championship game. The Ospreys are headed to the NCAA Tournament for the first time.

Aubrey Dawkins, Michigan

After scoring a total of seven points in consecutive games against Ohio State and Maryland in late February, Dawkins opened March with a bang, averaging 26.0 points last week as Michigan split a pair of games

with Northwestern (loss) and Rutgers (win). Seldom-used earlier in the year, the freshman swingman has been pressed into duty due to injury and is emerging as one of Michigan's top offensive options.


