RANCHO CORDOVA, CA (MPG) - Local football fans recently celebrated with a flashy Superbowl show but despaired at the loss of Cordova High Varsity Coach Vance Mueller who resigned from his duties citing personal issues.

Applications to find a replacement for Mueller were accepted up through Friday, January 30th and Cordova High Principal Dan Anklam told the Grapevine Independent that finding a coach on par with Mueller would be a challenging task.

"I was just sick when he gave me the letter," said Anklam. "It was just such bad news."

The change in leadership extends beyond one person, however. At Cordova High, the Varsity Coach builds an entire program from top to bottom,

choosing his Junior Varsity Coaches and directing the style and goals of football throughout the school.

Mueller's departure means that the current Junior Varsity Coaches could be replaced by the new coach.

Anklam was particularly supportive of Mueller's approach to the students, saying, "Vance had such a great relationship with the



Ribbon-Cutting Event for the Watt Avenue at U.S. Hwy. 50 Interchange Project

The Sacramento County Board of Supervisors, Sacramento County Department of Transportation (SACDOT), Caltrans, and the Sacramento Regional Transit District hosted a ribbon-cutting event to celebrate construction completion of the Watt Avenue at U.S. Highway 50 Interchange Improvement Project. This project made significant modifications to the interchange to reduce congestion, install dedicated transit facilities, and improve access and safety for bicyclists and pedestrians. O. C. Jones & Sons General Engineering Contractors was awarded the construction contract for the project (\$22.5 million) in September 2012.

The ribbon-cutting event was held on Friday, January 16th at the Watt/Manlove Light Rail Station Park & Ride Lot. Speakers at the event were Congressman Ami Bera; Assemblyman Ken Cooley; Assemblyman Kevin McCarty; Board of Supervisors members Serna, Kennedy, Peters, and Nottoli; Caltrans

SACRAMENTO COUNTY, CA (MPG) - Deputy District 3 Director of Maintenance Andrew Brandt; Regional Transit General Manager/CEO Mike Wiley; SACOG Chief Executive Officer Mike McKeever; and SACDOT Director Mike Penrose.

According to Mike Penrose, SACDOT Director, "Prior to completion of this project, the interchange had an outdated design for movement of vehicles and—as with most interchanges-it was difficult for bicyclists and pedestrians to get from one end of the facility to the other. Today, with completion of the project, we are excited about the benefits it will bring to all modes of travel including improved safety and reduced delay for motorists and unique transit, bicycle, and pedestrian features [that] set it apart from any other interchange in California. We believe this project will prove to be a model for other jurisdictions when faced with the difficult challenge of moving all modes of transportation through an interchange." Major improvements at

the interchange include the following:

- Widening the existing Watt Avenue overcrossing at Hwy. 50 to add two additional through lanes and two auxiliary lanes over the freeway; adding high-occupancy vehicles lanes to the freeway on-ramps; and widening and realigning freeway off-ramps to terminate at Watt Avenue at two signalized intersections.
- Construction of a new dedicated transit lane on Watt Avenue from north of the interchange to the existing Watt/Manlove Light Rail Station.
- Construction of a continuous bicycle and pedestrian pathway separated from vehicular traffic along the east side of Watt Avenue between La Riviera Drive and Manlove Road, with grade-separated undercrossings at the freeway ramps.

Public Health Officials: 'Get Vaccinated Against Measles'

SACRAMENTO REGION, CA (MPG) - As a measles outbreak that is believed to have started in California's Disneyland spreads to 14 states, Placer County officials recently urged people to get vaccinated.

"We have been fortunate so far that none of the results have been positive," said Dr. Robert Oldham, Placer County's public health officer. "But it is quite possible that we will see a positive case in the not too distant future and we have to prepare for that possibility."

The officials' comments come in the wake of two suspected cases of the measles within Sacramento and Placer Counties, both of which were confirmed as negative by officials on January 30th.

The California Department of Public Health (CDPH) reported that 79 measles cases were confirmed in California from January 1st-28th. Of the confirmed cases, 52 have been linked to an initial exposure in December at Disneyland or Disney California Adventure Park in Anaheim.

"This is a highly contagious disease that knows no political boundaries," said Oldham. "We

live in an area where people live in Placer County but work in Sacramento County, or live in Sacramento but shop and dine or work in Placer County. So, this is a regional issue that we are working together closely on to educate the public about the risks and the best prevention, which is vaccination."

Olivia Kasirye, Dr. Sacramento County's public health officer, also urged the public to get vaccinated if they have not done so already.

"One dose of the Measles Mumps Rubella vaccine, or MMR for short, provides up to 95 percent protection," said Kasirye. "Most children routinely get a first dose of the vaccine at 12 months of age or later. The second dose is usually administered when children start kindergarten, but can be given as soon as a month after the first dose and that boosts resistance to nearly 100 percent."

Dr. Oldham emphasized that Placer County has one of the lowest vaccination rates in the country, noting that many residents are concerned about whether vaccines are safe.

"Interestingly, the vaccination

rates often track against income levels." Oldham said. "The lack of vaccinations is not typically due to a lack of access to medical care – in fact, the higher income families are the ones opting not to vaccinate." A significant percentage of parents still question if there is a link between vaccinations and autism even though that claim has been debunked and all scientific evidence shows there is no link, he said.

Measles is a highly infectious, airborne disease that typically begins with fever, cough, runny nose, and red eyes, and, within a few days a red rash appears, usually first on the face and then spreading downward to the rest of the body.

The disease can be fatal or lead to serious neurological disabilities in some cases.

Residents with symptoms who believe they may have been exposed to the measles should contact their health care providers. Except in emergencies, it is best to contact health care providers by phone initially so other patients are not potentially exposed to the measles.

In the coming week the nation will gather at Gobbler's Knob, Pennsylvania for a uniquely American observance. The event is Groundhog Day, of course, as with bated breath we watch Punxsutawney Phil materialize from his cozy burrow. If he sees his shadow, as the legend goes, there will be six more weeks of winter weather. If he emerges shadowless, then it is the harbinger of an early spring.

Given how winters goes, I imagine there will be many more days of cold weather regardless of what Phil experiences on Monday morning. Besides, since 1886 old Phil and his successors have only been correct half the time. That's about as good as human meteorologists, though, so they all get to keep their jobs I guess, shadows or not.

For me Groundhog Day makes me think, not of plump rodents and top-hat-wearing old men, but of Bill Murray. It was more than twenty years ago that he starred in the now classic comedy film, "Groundhog Day." He plays weatherman Phil Connors, given the assignment of covering the Gobbler's Knob festivities. He hates it, and he is hateful; an arrogant, pompous, and spiteful man.

Somehow he gets caught in a time warp and must relive Groundhog Day over and over again. At first, he indulges in all types of fun and debauchery, but eventually he just wants all



the repetition to end. He grows so desperate that he attempts to off himself, even kidnapping Punxsutawney Phil in the process, thinking this will stop the agonizing time loop.

Internet nerds, who apparently have more time on their hands than the average person, have watched this movie thousands of times, and painfully parsing all the events and dialogue have calculated that weatherman Phil Connors stays trapped on Groundhog Day for almost forty years. Why? What is the point?

The point seems to be personal transformation. The comic gods decide that Connors must remain where he is until he is a changed man. There is no going forward until that work is done. He has to learn a few lessons, about himself and about life, and only then can he get off the merry-go-round that is the last four decades of his life.

Forty years seems to be the magic number, for that is exactly the amount of time spent by the Children of Israel in the wilderness. You may know the story: Moses is commissioned by God to save his people from Pharaoh's slavery. Plagues commence. Miracles ensue. Deliverance arrives (this would make a great movie, by the way).

But the former slaves don't know how to live as a free people. They complain, revolt, start worshipping inanimate objects, commit mutiny against Moses, and foolishly long for the false security of their chains over the

constant vigilance of their freedom. They are as trapped as when they were building pyramids in Egypt. And they remain as such, trapped for forty years.

It was a massive, repetitive Groundhog Day, unbroken until the "stiff-necked," stubborn, and contrary generation had been replaced by those who were ready to be free. The Scriptures say, "These things happened as a warning and example to us." It's not a simple retelling of history; it's an opportunity for us to learn. And the quicker we learn our lessons, the quicker we can be liberated.

If we review the trajectory of our lives we are likely to find a few common denominators in all we have experienced. That's because there's probably one or two major lessons that God is trying to teach us, a couple of persistent chains he is attempting to break. God allows life to repeat itself, over and over, until we do the hard, inner work of the soul.

Wandering the desert is a necessity and repeating difficult lessons is required, as there are some things that can only be learned in the hard places. But how long we replay and relive the same day is more or less up to us. There comes a time to get it, and to get on with it.

Among the cable networks, AMC has had great success with original series in recent years. The recently concluded run of "Breaking Bad" ranks right up there in popularity with "Mad Men." Both shows put AMC on the map for serious television.

Speaking of the Emmy-award winning series "Mad Men," the final seven episodes begin on Sunday, April 5th. There's still time for binge viewing of all the previous seasons. I lost track of the number of seasons, but two months should afford enough time to gain an appreciation for the pending fates of the main characters

Meanwhile, Vince Gilligan and Peter Gould, the creators of "Breaking Bad," are launching the new drama series "Better Call Saul," which is both a prequel and origin story to their award-winning series set in Albuquerque, New Mexico at a time six years before Bryan Cranston's drug dealer Walter White came in to the picture.

Before Bob Odenkirk's Saul Goodman became the notorious top criminal lawyer in Albuquerque, he was just a bottom-feeding attorney taking public defender cases only because he was struggling to make ends meet. "Better Call Saul" takes us back to when Saul was going by his real name, Jimmy McGill.

When we first glimpse Jimmy/ Saul's legal skills, he's in a courtroom trying vainly to portray three knucklehead teenage

defendants in a vandalism and trespass case as merely unwise and foolishly reckless youth engaged in harmless indiscrete pranks. The prosecutor's videotape evidence demonstrated otherwise.

Always on the prowl for a big payday case, Jimmy may believe he's the underdog fighting the good fight, but his moral compass, such as it is, and his ambition are often at war with each other. Hence, his unfortunate encounter with two skateboarding brothers leads to more bad decisions.

Just like Jimmy McGill walks a fine line between serving justice and doing just the opposite, critics have been requested to not reveal storyline details in advance so as not to ruin the fan's experience of the full impact of plots as they unfold throughout the season.

Speaking to the recent gathering of the nation's TV critics, Peter Gould proclaimed, in the spirit of full disclosure, that Walter White would not appear in Season One, noting that "we don't want to mislead people into expecting something that's not going to happen."

As a result, "Better Call Saul," standing on its own, brings new characters and situations to the fore, though some familiar faces appear in a different light. For instance, Mike Ehrmantraut (Jonathan Banks), before he was Saul's fixer, is currently a parking lot attendant who is amusingly discourteous and combative.

In a manner of fashion, Jimmy is looking after his older brother Chuck (Michael McKean), a name partner in one of New Mexico's most prestigious law firms, who is on leave due to an unfortunate illness. Though a

new character, Chuck lends an air of familiarity to Jimmy's ultimate transformation.

Full of bravado, Jimmy has an explosive scene when he storms uninvited into the boardroom of Chuck's law firm, bellowing accusations at the smug Howard Hamlin (Patrick Fabian), whose good looks, charm and success are a source of great annoyance to a lawyer trapped on the lower rung.

When his efforts to enlist as a client the local County treasurer facing a serious embezzlement indictment fizzle, Jimmy concocts a bizarre scene to use the skateboarding brothers in a staged accident that would result in a tidy settlement. Instead, the scam ends up in a series of unfortunate unintended consequences.

At one point of negotiation with a potential client with dubious intentions, Jimmy avers that he's "an attorney, not a criminal." The point seems to be arguable, given the circumstances of his questionable behavior during the first two episodes that will debut on back-to-back nights.

"Better Call Saul," which was originally conceived to be a comedy series, in deference to Bob Odenkirk's comedic talent, has morphed into a drama series that will explore Jimmy's fairly messy descent to the dark side as he moves toward becoming devoid of ethics as the sleazy defense lawyer Saul Goodman.

The more dramatic tone of "Better Call Saul" nevertheless does not blunt the black humor that Odenkirk so capably delivers when he unleashes his pointed tirades at colleagues, clients and even the officious clerk at the courthouse pay station.

Much like "Breaking Bad," the prequel "Better Call Saul" commands the viewer's attention to details and the nuances of the storyline. Patience may be required to track the shady lawyer's transformation into the man who puts the "criminal" into "criminal attorney." If anyone can make it work, it will be Odenkirk's Saul Goodman.



Delta Water Plan Refined to Reduce Local Impacts

SACRAMENTO REGION, CA (MPG) - The Brown administration and its federal partners has announced several significant changes to the water conveyance portion of the proposed Bay Delta Conservation Plan, including elimination of the need to build three pumping plants along the Sacramento River near Hood.

The changes represent an effort to respond to the concerns of Delta landowners and others. Subject to further refinement, they will be incorporated into the draft plan and Environmental Impact Report/ Environmental Impact Statement and will be recirculated for additional public comment in 2015. The proposed changes would eliminate three pumping plants on

the east bank of the Sacramento River between Hood and Walnut Grove; minimize activity on Staten Island, an important sandhill crane habitat, by removing tunnel launch facilities, large reusable

tunnel material storage areas, a necessary to also build pumping barge landing site, and high-voltage power lines; increase use of property owned by the California Department of Water Resources (DWR); eliminate the need for additional permanent power lines to the intake locations in the north Delta, including near Stone Lakes National Wildlife Refuge; eliminate impacts on Italian Slough (near Clifton Court Forebay) by removing an underground siphon; reduce power requirements; allow water to flow from the Sacramento River entirely by gravity at certain river stages; and reduce tunnel operation and maintenance costs.

The modified plan would eliminate the need to build three separate two-story pumping plants along a five-mile stretch between Clarksburg and Courtland. Plans to build three intakes screened for fish protection along that stretch of river would not change, but DWR has determined that it is not

plants adjacent to each intake in order to move the water from the river into tunnels. Instead, water could be moved from the river into tunnels by a single new pumping plant constructed 40 miles away at the end of the tunnels on DWR property near Clifton Court Forebay.

The roughly 87-acre footprint of each intake would not change, but three 46,000-square-foot buildings would not be needed to house pumping plants. No permanent transmission lines, substations, or surge shafts would be needed either. Facilities at the intakes would include fish screens in the river, sedimentation basins, drying lagoons, access roads, and control gate structures.

Elimination of the three pumping plants would help preserve the view on State Route 160 between Hood and Walnut Grove, a state scenic highway. It would also the river.

Throughout the eight-year development of the Bay Delta Conservation Plan, DWR has sought to minimize potential disruption and dislocation of Delta residents. In 2013, DWR made significant changes to the proposed water conveyance facilities that reduced by 50 percent the total permanent footprint of the project.

The most recent changes to the proposed conveyance system, along with many other changes to other aspects of the plan, will be available for formal public review and comment in 2015.

The Bay Delta Conservation Plan aims to both stabilize water deliveries from the Sacramento-San Joaquin Delta and contribute to the recovery of 56 species of plants, fish, and wildlife over the 50-year life of the plan. Water from the Delta

reduce construction traffic along reaches approximately 25 million Californians and three million acres of irrigated farmland.

> The plan aims to both reverse the ecological decline of the region and modernize a water system that now depends on hundreds of miles of earthen levees vulnerable to earthquake, flood, and rising sea levels. One of the conservation measures in the plan involves building new points of diversion in the north Delta in order to minimize the use of the existing south Delta diversion. The existing diversion, constructed 45 years ago, sits on a dead-end channel that cannot be effectively screened for fish. New diversions could be screened with modern technology and would allow for more natural east-west flow through the Delta to San Francisco Bay.

The Bay Delta Conservation Plan has been developed through eight years of analysis and hundreds of public meetings. It is a

habitat conservation plan under the U.S. Endangered Species Act and a natural community conservation plan under California law. It describes conservation measures that would be undertaken by the California Department of Water Resources, operator of the State Water Project, and the U.S. Bureau of Reclamation, operator of the Central Valley Project. The plan would provide a stable regulatory environment for operation of the water projects, which in recent years have been forced to curtail Delta pumping under rules to protect certain threatened and endangered fish species.




