Governor Brown Signs Compact With Jackson Rancheria **Band of Miwuk Indians**

SACRAMENTO REGION, CA (MPG) - Governor Edmund G. Brown Jr. announced that he has signed a tribal-state gaming compact between the State of California and the Jackson Rancheria band of Miwuk Indians.

The terms of the new compact are consistent with provisions of more recent compacts related to licensing, compliance enforcement, and mitigation of off-reservation gaming impacts but have been updated to reflect, among other things, the evolving nature of financial markets, as well as the professionalism of the Tribe's regulators and their constructive relationship with state gaming regulators.

The compact reflects a continued commitment by the Tribe to revenue sharing with non-gaming and limited gaming tribes so that the economic benefits of gaming reach tribal governments that have not chosen to operate a tribal casino. The terms also provide a framework for the sharing of gaming revenue with Amador County and other local jurisdictions for infrastructure improvements and fire, law enforcement, public transit, education, tourism, and other services and provide incentives for investments in renewable energy projects, non-gaming related economic development projects, and health care facilities that provide a mutual benefit to the Tribe and the local community. The compact continues to assure the protection of the health and safety of the casino patrons, guests, and employees and affirms the role of a tribal-state association of gaming regulators to provide a framework within which tribal and state gaming regulators can exchange information and collaborate to ensure that the gaming public has continued confidence in the integrity of casino operations. The compact supersedes the 1999 compact between the Tribe and the State of California. A copy of the compact can be found at www.gov.ca.gov/docs/Jackson Compact.pdf.

for the Smiles for Kids event," explained Raquel Juarez, who owns the practice along with her husband. "All these volunteers come out and they give free dental work to underserved communities and families. It's really nice to actually give back and see the kids smiling and happy. And the families are very appreciative."

Samantha Lindsay of Sacramento, who brought her daughter in for a cleaning and a checkup, was very impressed with the quality of care and attention her daughter received. "We were welcomed right away," she said. "Her anxiety went right out the door. She didn't hear

any drilling, she didn't hear any screaming, she didn't hear any arguing with other children. It was calm, it was really calm."

Ka Mauriona Parker (11) was also initially apprehensive about her dental appointment but was put to ease by volunteers' gentle bedside manners and by Smile Kingdom Dental's child-centric decor, which includes fantasythemed murals and TV monitors playing cartoons on the ceiling during procedures. "I liked it, it was comfortable," she explained. "I was nervous when we got here because they said they were going to pull out my tooth. But they didn't. I feel better."

Such confidence is exactly what volunteer Dr. Kasi Franck hoped to impart to her patients.

"Oftentimes the kids are in a lot of pain and parents don't really realize it. So being able to then take care of that pain for them makes a world of difference," she said. "Another goal of mine is to make them have a good experience, where they're not afraid of the dentist. There are a lot of kids who come in with a lot of anxiety because they're in pain and they're afraid that it's going to hurt. So we do a lot of education and prevention to help them become healthy patients who will go to the dentist when they're older and not be afraid of the dentist."



Before I get into the Paul Harvey "Rest of the Story" and "put my two cents in," I want you to know that I appreciate the response from a reader who disagreed with my balancing the budget column on January 30th. I have met many people who comment about this column and their comments include both agreeing and disagreeing. It's nice to know that what I write is thought provoking enough that they are willing to let me know what they think. So whether I meet them at church or at the store or if they write a letter to the editor, I'm glad that people know I'm always ready to learn something new.

Now for the "Rest of the Story": as far as "put my two cents in," it is from an English idiom in which someone expresses their opinion. Most people in the U.S. don't mind expressing their opinions about everything-from someone

else's hat to the way the govern- at City Hall, I have placed three ment uses our tax dollars (or, in their opinion, misuses the taxes they collect). Another money idiom we use is "a penny for your thoughts." Today, that usually means we are simply asking someone else to share what they are thinking about someone or something.

Thinking about money as simply money and not an idiom; I was reading that President Obama's budget outlay for the coming 2016 fiscal year is \$3.99 trillion. I decided to look up what President Johnson's budget was 50 years ago. The answer is that in the 1966 fiscal year, the budget outlay was \$698 billion. Before you leave each other in the morning, connect with eyeto-eye contact and tell him you love him. Never leave the house without acknowledging your husband or saying, "I love you."


6. Music

John Savely bought his daughter, Debbie, a Bible for her seventh birthday. Before she graduated from high school, her father had died. That Bible became a revered keepsake, but she lost it in 1974, while attending Tennessee's Volunteer State Community College.

Yet, last year, that Bible made its way back into Debbie's possession. A college officer from Volunteer State found the Bible in a box of debris from a 2006 tornado that almost destroyed the college's campus. The winds that splintered buildings uncovered the lost Scriptures.

With Debbie Savely's name inscribed within, that college officer went to work trying to find her; and by way of relentless pursuit and the marvel of the internet, John Savely's gift was returned to his daughter forty years after it was lost. She and her nearly ninetyyear-old mother were jubilant beyond measure.

What makes this story so remarkable is not that a Bible was salvaged. If the book had been a copy of "Green Eggs and Ham," it would hardy have been any less miraculous. Besides, I doubt that Debbie needed a Bible. She, like all of us, had access to millions of Bibles to read, still the best-selling book in the world.

What made this particular copy of the Bible special was its source. It had been given to her by her



father. Her attachment to it was as sentimental as it was spiritual. So it wasn't as if she had recovered the original stone tablets of Sinai or the Dead Sea Scrolls. She had something more important: She had a link to one who truly loved her.

What if we learned to approach our own Bibles with the same heartfelt sentiment? What if we concerned ourselves less with the "miraculous" nature of how the Bible arrived in our hands, and focused more on the link the book is to One who truly loves us? What if we stopped deifying the Bible (worshipping "God the Father, the Son, and the Holy Bible" as it were), and embraced it as a pointer aiming us in a more Jesus-like direction?

How do we do this? By being Christians, not Biblicists, A Biblicist is one who reads the Bible, "flat;" that is, every word is given the same weight and significance, because "God said it, I believe it, and that settles it." So, "He that curseth his father or mother shall surely be put to death," is given the same credibility as, "Love thy neighbor as thyself" (A drastic but accurate example).

Yet, Christians might be better served to see the Scriptures with a bit more texture. Our faith and practice would be healthier if our interpretive lens was Jesus Christ. He, as the living Word and Source, is the peak of revelation. So, we look to him as we read, using his words to hold ourselves to his way,

and, dare I say it, to hold the Bible accountable as well. Refusing to do this, schizophrenically puts the Bible and Jesus at odds with each other

Maybe this is what Kurt Eichenwald was trying to get at in his recent Newsweek diatribe, "The Bible: So Misunderstood It's a Sin." He railed against biblical abuses, ignorance that impedes science, the foolishness of uniting church with state, and the suffering inflicted on this world by those who misapply the Bible. My response was, "Amen! Preach it, brother!"

He couldn't hear my agreement, though, because his words were so thunderously angry; as were the vitriolic words of his critics. And while I believe Eichenwald was largely telling the truth, nothing will change about this state of affairs until Bible-reading, Bibleloving, Bible-believing people stop treating the Bible like it is God. It's not, no more than that stormtorn Tennessee testament was Deb Savely's father.

I love the Bible, but not because every passage can be reconciled with Christianity. I love it because it helps me stay connected to the Source, to Jesus. After all, he is the foundation of my faith, and even as the Good Book says, there is no other.

Lana and Andy Wachowski, the filmmaker siblings behind the "Matrix" trilogy and "Cloud Atlas," have an affinity for inviting audiences into uncharted territory and fantastic new worlds, the basic stuff of science-fiction.

At times their magic touch for fantasy adventure works, particularly with the first "Matrix," and then there is the complete bore that was "Cloud Atlas." With their latest effort in "Jupiter Ascending," the Wachowskis may have hit upon the middle ground.

The trouble with "Jupiter Ascending" is not that the lovely Mila Kunis is the central figure in a space odyssey which requires her character to bridge the gap between the working class of the Midwest and the royalty of the intergalactic universe.

A Russian immigrant toiling in menial jobs with her extended family, Jupiter Jones (Kunis) dreams of better things, but the cold reality is that she's cleaning other people's toilets and suffers an endless run of bad breaks.

FORMULA RISES WITHIN "JUPITER ASCENDING"

Along comes the hunky Caine Wise (Channing Tatum), who looks fully human except for his Spock-like pointy ears. He's a bounty hunter from outer space assigned to track down Jupiter because her genetic signature marks her as next in line for a royal title in the House of Abrasax.

Granted, it's a real leap of faith to think that the ordinary Jupiter Jones has royal blood, but that news is far more disturbing to the three primary heirs of the Abrasax dynasty following the death of the royal matriarch.

At this point, the problem for "Jupiter Ascending" is the somewhat convoluted story of the squabbling within the royal empire, where three siblings vie for total control of their dominion in a manner reminiscent of Shakespearean drama, which inevitably recalls visions of "King Lear."

On a distant planet, it is the death of the queen that triggers a battle for succession, which is complicated by the sudden presence of Jupiter, who has the same genetic makeup of the late monarch, a fact which would elevate the Chicago maid to queen of the universe.

Palace intrigue ensues. The oldest of the royal siblings is the treacherous Balem (Eddie Redmayne), a person so tightly wound that he speaks in an oddly controlled, ominous whisper until those moments when he bursts into uncontrolled rage.

Balem is a mercenary whose only interest, as the current head of Abrasax Industries, is to savor the expansion of wealth and power by looting the Earth of all its precious resources, including the harvesting of humans.

The sister Kalique (Tuppence Middleton), an ethereal beauty,

prefers to advise and befriend the newfound member of the royal family, but she is no less devious than the rest of the clan as she is reluctant to reveal her hand.

Titus (Douglas Booth), the youngest brother, gives the impression of a charming and spoiled playboy with an admittedly cavalier relationship to the truth, but his devotion to his hedonistic pursuits belies a fierce ambition every bit as calculating as Balem's.

To be sure, Jupiter, though faithfully assisted by Caine, is a mere innocent in this pit of venomous snakes. The amusing scene is when Jupiter is put through the bureaucratic maze of validating her royal position by obtaining the necessary paperwork.

Never before has dealing with red tape looked as inept, complicated and inefficient as here. Jupiter's shuffling back and forth to obscure government agencies is akin to the nightmare of having to deal with the DMV, IRS, Social Security Administration and Department of Homeland Security all at the same time.

Just in case you were wondering, aerial battle scenes are plentiful and exciting, with a generous helping of explosions. With Jupiter in his arms, Caine zips through the Chicago skies on his jet-propelled boots, and while this happening the aliens destroy most of the skyscraper landscape.

The action moves at the quick pace that may prove satisfying for most fans of the genre. Even the reliable Sean Bean gets into the act as toughguy bounty hunter Stringer who's been exiled to a ramshackle Midwestern farm in the middle of nowhere.

With the Warchowski pedigree firmly in place and the attention generated by an original work steeped in the genre elements of science-fiction, "Jupiter Ascending" may very well rise to the top, and not without good reason considering there's just enough action excitement to keep the convoluted business interesting.

For the second time in as many weeks Californians got the news that Sacramento politicians are proposing yet another big tax hike. The truth is that new taxes would never be required were it not for Sacramento's mismanagement of existing tax dollars.

Last week, it was the proposal to deal with the very real problem of "revenue volatility" in California's tax structure with the very unreal "solution" of a \$10 billion tax on services.

But the latest proposal comes from new Senate leader Toni Atkins who proposes a brand new tax on drivers to pay for highway and road repairs in California. This new "fee" would take \$1.8 billion dollars out of the pockets of hard working California citizens over the next five years.

Now, most Californians would wholeheartedly agree that our roads are in terrible shape. Years of neglect have resulted in a

nature of this new "fee" has yet to be determined, Senator Atkins' comments in proposing the new revenue source can only be described as foolish and insulting. Here is what she said: "California cannot have a strong middle class or a thriving economy if our roadways are congested and people and goods cannot move efficiently."

Really? A left-wing politician now claims that this new tax is needed to protect the middle class? She is simply blind to the truth that the progressive policies of heavy taxation and over regulation are crushing the middle class in California. As is so common now in California, statements from politicians such as Atkins reveal a profound disconnect between their pampered lives and the lives of ordinary citizens.

So, instead of slamming Californians with another tax hike, what is a better way to meet the funding needs for our crumbling highway system? Glad you asked.

First, let's demand that gas tax revenues pay for roads, not bike lanes, environmental mitigation programs and mass transit. The latter programs are all well and good, but gas taxes should go for roads. (For purposes of full

and, while we're at it, "prevailing wage" laws which also add to the cost of construction unnecessarily.

Third, let's direct valuable transportation dollars to those systems that actually work. This would mean abandoning the doomed-tofail High Speed Rail Project that is sucking up tax dollars in a way that voters never approved.

Fourth, we can agree that gas tax revenue has fallen a bit short of expectations because cars are now more fuel efficient. But if that is the case, why does the state still subsidize electric vehicles? Shouldn't we abandon those subsidies and direct those dollars to filling potholes?

Instead of reflexively demanding higher taxes, our elected officials should do what other states seem to do without controversy - prioritize spending. Now there's a novel concept.

The RCCYF Collaborative also met with their U.S. representatives and senators during Capitol Hill Day, which took place on Wednesday, February 4th during the CADCA Forum. 





What is Constitutional in the **State of the Union Address?**

In listening to the President's State of the Union Address one might think that he actually has the power to do what he requests. On domestic issues two old requests from last year's State of the Union Address were renewed: a request for raising the minimum wage and, instead of just making the college opportunity available to all middle class Americans, he went further proposing free community college for all. Other requests included advocacy for "a free and open Internet," which, given a recent executive order means control of it, expanded child care tax credits, improved job training, expanded paid leave, and a new tax benefit for twoincome families. All this to be funded by increased taxes on the rich. He threatened a veto to any legislation that altered Obamacare or undermined his recently decreed executive amnesty. He was decidedly unclear on his request for criminal justice reform, certainly a reference to the riots in Ferguson, Mo. More federal involvement always means more federal control

He defended his positions on Cuba and Iran and threatened presidential vetoes if Congress legislated differently. Constitutionalist had to have cheered when he seemed to lecture, the mostly Republican Congress, on what he called, "rash decisions, reacting to the headlines instead of using our heads; when the first response to a challenge is to send in our military-then we risk getting drawn into unnecessary conflicts, and neglect the broader strategy we need for a safer, more prosperous world." He called it, "a smarter kind of American leadership" and seemed aimed at the so-called military industrial complex of which President Dwight D. Eisenhower warned. He saw rewriting the Authorization of Use of Military Force, which authorized the air campaigns in Iraq and Syria, as a priority but left few specifics

on what that meant. He still refuses to use the term Radical Islamist Terrorists in describing the Islamists involved in the mass killing in Nigeria, Iraq, Syria and France even though while he spoke they were threatening to topple Yemen who has stood with us in opposition to al-Qaida.

The list went on and on as it does for every president Republican or Democrat, but what was different from last year is that he threatened the use of the veto rather than the threat of his bypassing Congress with the use of the "pen" through executive orders. The term executive order is not found in the Constitution and initially was nothing more than inter-departmental communications between the President and his executive branch with him requesting some action on their part. Constitutionally they have no law-making function.

Unfortunately most, if not all, of these things are not in Article II of the Constitution nor have they been added by way of amendment as outlined in Article V of that document, thus they are unconstitutional. It is very probable that, even with the approval of Congress, they would be outside the Constitution but that is a topic for another time. Presidents, in their thirst for power and / or proclaimed expediency, have empowered themselves to the point of "kingship" with their worshipful, unchallenging, party followers (whether Democrat or Republican) quite willing to look the other way as government grows beyond its ability to be constitutional or efficient. At any time he could remind the people of his real constitutional powers but he will not as that would drastically reduce his power that is beginning to look limitless.

We must return to the Constitutional powers of the President as identified in Article II. As we list these powers attempt to match the State of the Union requests wherein he suggests that he might have a role. Under the Constitution the president has

but eleven powers. Let us identify them: 1) "Commander in chief of the army and navy of the United States" including the militia when called into actual service of the United States; 2) supervise departments (cabinet), each presumably established by the Congress (George Washington had but four); 3) grant reprieves and pardons; 4) make treaties with the help of the Senate; 5) with Senate help appoint positions established by law such as ambassadors, ministers and judges; 6) fill vacancies "during recess of the Senate;" 7) make recommendations to Congress on the state of the union; 8) convene both houses on special occasions and handle disputes with respect to convening; 9) receive ambassadors and other public ministers; 10) make certain that "laws be faithfully executed;" and, 11) "commission all the officers of the United States."

Simply stated the president has two supervisory powers over existing organizations and two shared powers with the Senate, otherwise he pardons, recommends, appoints and entertains. That is it! Notice the absence of power to make any rules and regulations on us. This is the job of Congress alone.

All measures listed in the 2015 State of the Union Address are but suggestions to Congress, which alone, as per Article I, Section I, has all law-making functions—the president has none. That said, he is within his constitutional bounds with his threat of the veto, which is likely to be used liberally.

IRS Offers Free E-Filing for Tax Returns

SACRAMENTO REGION, CA (MPG) - The Internal Revenue Service (IRS) and the Free File Alliance announced the launch of Free File, which makes brand-name tax software products and electronic filing available to most taxpayers in California for free.

Free File software can help taxpayers with tax preparation, including the health care law that will affect almost everyone. California taxpayers can use Free File software immediately

Free File is available only at www.IRS.gov/FreeFile, thanks to a partnership between the IRS and the Free File Alliance, a consortium of 14 leading tax software companies.

"About 70% of all federal tax returns come in below the \$60,000 income level," said IRS Spokesman David Tucker II. "Millions can use it to file a federal income tax return for free."

Nationally, more than 3.2 million people used Free File last year with nearly 270,000 coming from California. Since 2003, more than 43 million people have used Free File, saving \$1.3 billion based on a conservative \$30 fee estimate.

"You don't have to be an expert on taxes or the new health care law. Free File software can help walk you through the rules and help you get it right," said John A. Koskinen, IRS Commissioner. "For 12 years, this partnership between the IRS and the Free File Alliance had helped taxpayers save both money and time. The real winner in this partnership has been the nation's taxpayers."

Taxpayers who earned \$60,000 or less last year are eligible to choose from among 14 software products. For those who earned

more, they are still eligible for Free File Fillable Forms, the electronic version of IRS paper forms. This more basic Free File option is best for people comfortable preparing their own tax return

Free File offers easy-to-use products that ask questions and supply answers. The software will find the right forms, find the right tax credits and deductions and even do the math.

Free File also can help taxpayers with the new health care requirements. Almost everyone will need to do something new when filing a tax return this year. For each month in 2014, you and everyone on your return must either report health care coverage, claim an exemption from coverage, or make a shared responsibility payment with your tax return. Most people will simply have to check a box to report health care coverage for the entire year.

Free File will be available through October 2015. Taxpayers who cannot meet the April 15 tax deadline can also use Free File to file a six-month extension.

Here are some common taxrelated documents you will need to complete your tax return: a copy of last year's tax return; valid Social Security numbers for yourself, your spouse and children; all income statements, i.e. W-2 forms from all employers: interest/dividend statements, i.e. 1099 Forms; Form 1099-G showing any state refunds; unemployment compensation amount, if any; Form 1095-A if you purchased coverage from a Health Insurance Marketplace; and proof of health care insurance coverage for you and everyone on your return. Remember, you must also have documentation of any credit or deduction you are claiming.



In the first half, El Dorado jumped out to a 16-12 lead, thanks largely to second and third chance shots resulting from offensive rebounds. Both teams exchanged leads in the second quarter with Cordova taking the halftime lead.



1. KENTUCKY KEEPS FINDING WAYS TO WIN

Winning conference road games is tough, and we're sure Kentucky's not going to get enough credit for answering the call each game in an otherwise mediocre SEC. The Wildcats' 68-61 win at Florida is a perfect example of why Kentucky remains undefeated. Andrew Harrison was a non-factor (no field goals, three turnovers), and the Wildcats shot 3-of-14 from 3-point range. Still, Kentucky won because it was 21-of-22 from the free throw line while Florida went 7-of-14. Karl-Anthony Towns played his best game of the season with 19 points and eight rebounds, and Aaron Harrison rebounded from a one-point game against Georgia to score 23 against the Gators. We've known this for a while, but taking out Kentucky is going to take an outstanding effort from a darn good team.

2. DUKE LOOKS SCARY GOOD

Time to stop worrying about what's wrong with Duke and try to figure out how anyone is going to slow down the Blue Devils. On Jan. 28, Notre Dame beat Duke 77-73 in South Bend for the Blue Devils' third loss of the season. Duke hasn't been defeated since. The rematch against the top-10 Irish was a thorough 90-60 beatdown. Notre Dame took a 6-0 lead, and from there, Duke went on a 43-7 run during the first half. This came with Jahlil Okafor playing only eight minutes in the first half due to foul trouble. Meanwhile, Justise Winslow continued his hot streak, flourishing in transition for 19 points. Guard Matt Jones obliterated his career high with 17 points (3-of-5 from 3) off the bench. And when Okafor was in the game he simply went 9-of-11 from the field for 20 points with 10 rebounds in 23 minutes. Ouite the statement for Duke.

3. CAVS NEEDS TO ADJUST WITHOUT JUSTIN ANDERSON

On the court Saturday, Virginia played yet another stifling game against a quality opponent. The Cavaliers defeated Louisville 52-47, holding the Cardinals to 13 points in the first half and 0.85 points per possession overall. The rub, though, is pending hand surgery for Justin Anderson, arguably the team's most important player. The injury may sideline him for 4-6 weeks — through the first week of March or into the first weekend of the NCAA Tournament. The Cavs face only three KenPom top 100 teams (North Carolina, Pittsburgh, Syracuse) before the finale against Louisville, but Anderson's absence will be a key speed bump for a team that's had trouble closing out games in recent weeks.

4. OKLAHOMA STATE MAKES A MAJOR STATEMENT

Oklahoma State is quietly picking up quality wins in the toughest league in the nation. On Saturday, the Cowboys defeated Kansas 67-62, giving the Pokes a key win for their NCAA Tournament résumé. O-State is now 6-5 in the Big 12 after winning three of its last four games. Kansas did not have a great game, turning the ball over 18 times, but the key for Oklahoma State has been the emergence of secondary scorers. For most of the season, the Pokes could count on only Le'Bryan Nash and Phil Forte to produce. That's changed. Four Cowboys scored in double figures against KU. Point guard Anthony Hickey is averaging 12 points over the last four games.

5. ANOTHER RED FLAG FOR ARIZONA?

On first glance, Arizona's 81-78 loss to Arizona State shouldn't be a major warning sign. The season is long, and this was a road game against a capable rival. The Sun Devils got hot from 3 (7-of-15) and were able to pull off the upset. But this is also the third loss of the season for Arizona against a team that won't be in the NCAA Tournament. The other two were to UNLV and Oregon State, both on the road. Arizona may still be a title contender, but these losses may cost the Wildcats a No. 1 seed.

last five Big 12 games. Victories in bunches don't come often in this league, so Baylor's hot streak must be noted. Baylor went on a 21-0 run in the first half and took advantage of West Virginia's struggles in the halfcourt. Against the Baylor zone, West Virginia shot 6-of-23 from 3-point range. Meanwhile, Rico Gathers was a beast as always on the glass with 16 rebounds to go along with his 17 points.

8. TIME TO START SELLING WEST VIRGINIA?

The other side of Baylor's rout in Morgantown: Maybe West Virginia is a team to start looking at a little more critically. The Mountaineers' elite pressure defense helped turn around the team this season, but West Virginia doesn't do much of anything else very well. Now, the Mountaineers' other deficiencies are starting to catch up to them. Their last three Big 12 losses - to Texas, Oklahoma and Baylor - have been routs. West Virginia has only two top-50 RPI wins, and one of those is over Wofford.

9. SHORTHANDED ILLINOIS IS MAKING A MOVE

On Jan. 24, Illinois was 13–8 overall and 3–5 in the Big Ten, thanks in part to an injury to guard Rayvonte Rice, the team's leading scorer. Rice and fellow guard Aaron Cosby are still sidelined, each serving a suspension. That hasn't been a problem for Illinois, which won its third consecutive game with a 59-54 road win over Michigan State on Saturday afternoon. Malcolm Hill, who scored 19 points against the Spartans, has become Illinois' best player as the Illini have quietly become an NCAA bubble team. Even before the win over Michigan State, Illinois had a 2-3 record against top-20 RPI teams, with wins over Baylor and Maryland.

win over short-handed VCU. Posley scored 15 points for the Bonnies. ... Bobby Portis scored 18 points and grabbed 11 rebounds to lead Arkansas to a 61-41 win over Mississippi State. ... The Owls, who went 9-22 (4-14 AAC) a year ago, are back in the discussion for an NCAA Tournament bid after posting a 61-60 comeback win at Memphis. The final shot, a Josh Brown jumper off a bounce pass from Will Cummings, deserves attention, especially since Dunphy elected not to take a timeout. But the real story is that Temple is back to defending at a high level after a three-year slump. According to KenPom, the Owls rank eighth in the nation in defensive efficiency and 13th in defensive effective field goal rate - both the best numbers for Temple since the 2009-10 season.

Jordan Mickey, LSU

His team has been a bit of a disappointment, but Mickey has been terrific of late for the Tigers. The sophomore forward scored 24 points and grabbed 12 rebounds in LSU's 71-60 win over Alabama. In his last three

games, Mickey is averaging 24.0 points and 14.6 rebounds while shooting 60.5 percent from the field. For the season, the Dallas native is averaging 17.0 points and 11.0 boards.


