SACRAMENTO REGION, CA (MPG)

- Walking in someone's shoes is not always an easy thing to do, especially if you're a man marching in women's high heels. That's exactly what 620 men did last spring to raise awareness of domestic violence and sexual assault at WEAVE's 2014 Walk a Mile in Her Shoes event. Through sponsorships, they raised over \$237,000 to fund many programs the organization provides to victims of abuse.

WEAVE's 2015 fundraising event, scheduled for Sunday, May 3rd, 2015, is slated to top last year's efforts; their goal is to have 1,000 men participate. This

will not only bring additional money to the group, but it will break a world record. The organization is accepting registration forms now.

Walk a Mile in Her Shoes is an international event in which men embrace the opportunity to raise awareness about the serious causes and effects of sexualized violence, which has reached epidemic proportions in every city in our nation. Between 2001 and 2012, 6,488 troops were killed in Afghanistan and Iraq, and 11,766 women were murdered by current or former partners that's nearly double the amount of casualties of war.

Domestic violence is not a singular incident. Statistics

Bonney Field to Welcome More Soccer Fans

SACRAMENTO REGION (MPG) - The Cal Expo Board of Directors unanimously approved a proposal from Ovations Fanfare, in conjunction with Sacramento Republic FC, to expand seating at Bonney Field from the current 8,000 seats to between approximately 10,500 to 11,500 seats for the 2015 season. Final

seating capacity will depend on further evaluation from the bleacher manufacturer. Expansion includes



new seats along with the reconfigwuration of some existing

Given 2014's sold-out attendance and the team's USL Pro National Championship victory at Bonney Field, both Ovations and Sacramento Republic FC have been exploring the possibility of adding more temporary seats to the facility to satisfy demand. Sacramento Republic FC reports that more than 7,200 season tickets have already been sold for the 2015 season.

"Our partnership with Ovations and Sacramento Republic FC further demonstrates the vitality of Cal Expo as a prominent community asset and keeps with our efforts to further enhance the State fairgrounds," said Cal Expo CEO Rick Pickering.

The additional seats will require the use of more land area. Consequently, additional square footage will be added to the north end of the existing 4.86 acres, for a total leased acreage of 5.397. In exchange for this additional land area, Ovations' annual guaranteed minimum rent to Cal Expo will increase

Bikes Recycled for Kids in Need

Sheriff's Toy Project Refurbishes Wheels

- There is more going on than transferring trash at the County North Area Recovery Station (NARS) on Roseville Road. For Sacramento County Sheriff's Toy Project, unused bikes are being separated out of trash

piles and collected weekly to be refurbished and distributed to families and children in need. Upon seeing the nearly 40

bikes a week that used to end up crushed for scrap metal recycling at the North Area Recovery Station, Operations Manager Alan MacIsaac decided something had to change. He created the NARS Re-cycle Project to refurbish the bikes instead of trashing them. The bikes are collected and restored by the Sacramento County Sheriff's Toy Project, which serves Sacramento families and children while creating a positive connection with law

enforcement. "Reusing is the best form of recycling, and keeping the bikes

out of the landfills is the best form of reuse. Helping families who cannot afford bikes for their kids is a win-win opportunity for all of us," said MacIsaac.

Children's bikes are most common, but the NARS Re-cycle Project accepts all nonmotorized bicycles, tricycles and wheelchairs, in all conditions. Toy Project volunteers refurbish and bring them back to useable condition. If a bicycle can't be brought back into useable condition the parts are used to make a bike—no part goes to waste.



Rancho Cordova **Residents Arrested for Selling Date-Rape Drug**

RANCHO CORDOVA, CA (MPG) -Detectives from Roseville's Vice and Narcotics Enforcement Team (VNET) are investigating regional sales of a synthetic narcotic drug similar to GHB, better known as the "date-rape drug." GHB and its

analogs (meaning chemically similar concoctions that produce the same effects) are often implicated in sexual assaults, DUIs and overdose cases. VNET detectives had long heard rumors about a house in Rancho Cordova being a major source of GHB in Roseville and the rest of the Sacramento metropolitan area.

On December 9th, Roseville officers served a search warrant at that home in Rancho Cordova. The house had a fortified security door and was protected with numerous surveillance cameras. Inside the house, officers found a large quantity of a GHB substitute drug disguised as, and sold as, massage oil. They also found



more than \$20,000 in cash, firearms, methamphetamine packaged for sale, and other evidence of illegal drug trafficking. Detectives later seized more large quantities of the drug at another related location.

Violence, approximately 40% of women experience some form of partner violence in a lifetime. Young women 18-24 years of age were significantly more likely (11%) to be victims of physical intimate violence in the past year. A report made by the California Student Survey (CSS) showed a prevalence of teen dating violence. At least one incident was reported by 5.2% of 9th grade girls and 8.2% of 11th grade girls. Additionally, among students with steady boyfriends, the rates of dating violence increased to 8.8% in the 9th grade and 12.8% in the 11th grade. These figures are disturbing, and they warrant educational intervention. The hope is that early education of these young men about these issues will help them change their ways

and prevent them from becom-

ing adult abusers. Although domestic violence and sexual assault can happen to any woman in any relationship and circumstance, there are specific groups that should be noted. In a survey conducted by the American Psychological Association, it was discovered that over 40% of women with disabilities were more likely to experience severe partner violence than those without disabilities. Many of these victims are in wheelchairs or suffer from conditions that prohibit them from running or defending themselves, making them the most vulnerable. Another group of women who suffer at the hands of their male domestic partners are female veterans. It has been found that women who served in the military may experience higher rates of interpersonal violence, sexual trauma, and related health challenges than those who have not served. The leading cause of murder among pregnant women is intimate partner violence. Victims of sex traf-

ficking are perhaps the largest

We don't have to be victims of domestic violence and intimidation, sexual assault, stalking, or human trafficking to feel the effects of it all. There's a financial element to this growing crime segment. Nationally, women lose eight million days of paid work every year because of the abuse perpetrated against them by current or former male

partners. This loss is equivalent to over 32,000 full time jobs. When a woman is treated for intimate partner violence, the cost of initial care is approximately \$948. Domestic violence is the third leading cause of homelessness among families in the United States. Between 1995 and 2005, the cost of domestic violence against women in the nation was \$5.8 billion. Today, that number has advanced with more than a 30% increase in domestic violence, and unfortu-

nately the numbers are rising. In 1978, WEAVE opened as a grassroots private organization to serve survivors and families of domestic violence in Sacramento County. Their services were used by countless victims who until then had nowhere to turn. Most thought abuse was just a way of life. The members of WEAVE tion has grown into a nationally recognized agency. Their critical services include a 24-hour support and information line; a confidential, emergency safe house; walk-in triage services including a lethality assessment and therapeutic counseling services; legal advocacy; youth and community prevention education programs; and more.

WEAVE encountered an increased need to house families surviving violence while they worked to make new lives for themselves. In 2009, they built a 12,000-square-foot safe home featuring 18 family suites with onsite support services and a charter school complete with a Nature Explore classroom. To further serve survivors, WEAVE initiated construction of Next Step Housing Village, a long term housing option for families graduating from the safe house programs. In 2013, WEAVE received a \$1 million grant from the Emergency Housing Assistance Program to purchase and renovate eight apartments to use as emergency shelter options for victims with unique barriers such as service animals. 2013 also saw the launch of Low Bono, a low-cost legal assistance program.

For the past 15 years, WEAVE's Suited for Success program has provided professional clothing and career development to hundreds of women in Sacramento County who have experienced violence. The program grew from the need to assist victims of violence in attaining economic independence. Lack of financial freedom is a common factor that binds abused women to their abusers. Many of WEAVE's clients leave all their belongings behind when they flee their threatening situation; they often arrive with only the clothes on their backs.



Required Pet Licenses Help Bring "Lost" Pets Home Rancho Cordova Animal Services is Source of Assistance & Advice

pet can be one of the most lovable gifts under the Christmas tree. It can be a faithful companion, a fun playmate, a source of joy – but a pet is also a longtime commitment with specific requirements and needs. Rancho Cordova's Animal Services Division is dedicated to promoting responsible pet ownership within the community and is ready to provide assistance and advice when needed.

Required by law for both cats and dogs, pet licensing and rabies vaccinations are inexpensive ways to ensure the safety and well-being of a pet. All cats and dogs in the City of Rancho Cordova must be licensed by four months of age. To get a license, the animal must have a current rabies certificate.

Pets can't speak for themselves but their license tags help

> "Almost on a daily basis, we return two to three lost animals to their owners, using licenses and microchips for identification," said Kerry Simpson, Rancho Cordova's Neighborhood Services Manager. "When we are able to return the animals, we save the owner the fee that is charged by the SPCA."

> Annual license fees for altered pets are \$15 per year. Pet owners who are 65 and older pay \$7.50 per year per altered pet. The cost for an unaltered pet is \$150 per year. The City's Animal Services staff can help you locate a local low-cost spay/neuter program if you want to get your pet altered. In fact, there is a free neutering program for pit bulls and pit bull mixes whose owners' zip code is

95670 or 95827.

License forms are available online at http://www. cityofranchocordova.org/Index. aspx?page=96#licensing; at the Rancho Cordova Neighborhood Services Center, 2880 Gold Tailings Court; or at the Sacramento SPCA, 6201 Florin-Perkins Road, Sacramento.

Other services and assistance provided by the Rancho Cordova Animal Services Division are investigating cruelty, neglect, and dog biting cases; caring for sick, injured, abandoned and unwanted animals; microchipping; and pet adoptions.

American River Trout Hatchery Reopens After Summer Evacuation

GOLD RIVER, CA (MPG) - The American River Trout Hatchery operated by the California Department of Fish and Wildlife (CDFW) recently reopened after warm water temperatures forced the closure of the facility in early

Colder winter temperatures and recent rain are allowing hatchery staff to begin filling the raceways with cooler river water and start producing rainbow trout for planting in northern California lakes in the summer of 2015.

"The drought forced us to think quickly and make the best fish," said Dr. Bill Cox, CDFW Fishery Program Manager. "Because of the rain and colder weather, we can start producing trout right away."

In June, CDFW moved all rainbow trout out of the American River Hatchery to avoid losses of young fish due to rising water temperatures. Both Nimbus and American River hatcheries' water supply comes from Lake Natoma, upstream of the hatcheries. Drought conditions resulted in reduced water supplies stored in Folsom Lake and warm summer temperatures

Foster Youth Receive Holiday Gifts and Stockings

SACRAMENTO REGION, CA (MPG) - More than 100 local residents donated 130 stockings and 192 gifts through United Way's Women in Philanthropy so that 194 local foster youth would have their holiday wishes fulfilled. Sixty-four foster youth in Sacramento County's Child Protective Services received the holiday gifts they requested, and the community filled stockings for 130 foster youth with United Way's financial stability initiative's \$en\$e-Ability project partners: Amador-Tuolumne Community Resources, Child Abuse Prevention Council of Sacramento, Koinonia Family Services, and New Morning Youth and Family Services.

Dozens of volunteers with United Way's Women in Philanthropy came together on December 3rd to wrap gifts

and stuff stockings with Target gift cards, hats, blankets, first aid kits, yearly planners, socks, snacks, and personal notes.

"This community really stepped up to ensure that kids in the foster care system don't feel forgotten during what is supposed to be the most wonderful time of the year," said Ruth Miller, co-chair of United Way's Women in Philanthropy. 
The Forgotten War, better known as the Korean War (or as many politicians liked to say, the "Korean conflict"), may be a cold page in the history books but not for Art Haarmeyer,

training at Sheppard AFB, Wichita Falls, TX, before moving on to Houston, TX, and finally to Mather Air Force Base, Sacramento, CA, for four months of Norden Bombing and Shoran (short-range navigation) Training.

Listening to Art describe his relationship with his commander, Colonel Delwin D. Bentley, or his description of the meticulous work that had to be done before embarksufferers continue to have terrifying flashbacks. I asked Art what event he recalls that is most traumatic to him, and he described in gruesome detail a moment on one of his last bombing missions with Colonel Bentley.

So, how does Art survive day-to-day with these terrible flashbacks? He writes books, he gives speeches, and he talks with others dealing with PTSD. Art said, "I share my story to

Korean War veteran and author of "Into the Land of Darkness." The Korean War started on June 25th, 1950, as North Korea invaded South Korea and engulfed the entire region until a ceasefire was declared on July 27th, 1953.

Art Haarmeyer graduated with an MBA degree from the University of Chicago; six months after that the United States entered the Korean War, and Art enlisted as a basic trainee in the United States Air Force. I have gotten to know Art Haarmeyer, now in his 80s. He is a man proud of sharp mentally as he was in his days as a graduate student and as a bombardier/navigaing on another bombing "run," gave me the feeling that I was actually with Art on these missions! Colonel Bentley was a "pilot who had a great feel for the aircraft," Art said. "He would bank that plane and set us up on our target like no other pilot I ever saw," Art continued. I asked Art what it like was to be a bombardier/navigator and dropping tons of bombs, including napalm, on people he did not even know. Art's answer: "I was just doing my job."

It was doing this job that led into Art developing post-trauhis service in Korea and is as matic stress disorder (PTSD), a condition that affects many war veterans, but which also may develop in people who tor on the Douglas B-26 light have experienced a traumatic

help others." He mentioned he liked talking with me because we are "our own therapy." I understand Art perfectly, as I also have PTSD-we do have our own two-man therapy sessions and we do realize we will never again be the same emotionally; nevertheless, we are still productive individuals to ourselves, family, and community.

My time in talking with Art and researching the Korean War has enlightened me to the fact there is no such thing as a "forgotten war." I recommend that you read Art's book and learn about an important part of our nation's military history from the perspective of someone who experienced it personally.

California Community College Districts Show Overwhelming Interest in **Developing Four-Year Degree Programs**

SACRAMENTO REGION, CA (MPG)

- On November 19th, the California Community Colleges announced that 36 districts, half of all districts in the system, submitted letters of intent to the state Chancellor's Office indicating their desire to host a baccalaureate degree program, signaling strong support for legislation signed by the governor this fall authorizing the system to award bachelor's degrees as part of a limited pilot program.

"The districts' strong interest in building baccalaureate degree programs is heartening," said California Community Colleges Chancellor Brice W. Harris. "They are pioneering a new mission for the California Community Colleges and opening up pathways for Californians who may not have had the chance to earn a four-year degree. I look forward to working with the districts to create world-class programs that graduate highly trained and marketable students.'

The legislation, known as Senate Bill (SB) 850 and authored by Sen. Marty Block (D-San Diego), allows up to 15 districts to establish a pilot baccalaureate degree program at one of their colleges in a field of study not offered by the California State University (CSU) or University of California (UC). Lowerdivision coursework would cost \$46 and upper-division coursework would cost \$84 under the new program, with an estimated total cost of about \$10,000 to obtain a bachelor's degree.

"SB 850 is a game changer for California students," Block said. "Students now have another door that can lead to a quality, affordable four-year degree. It tells employers that California is doing all it can to ensure that our state is open for business and will stay open to employers looking for highly trained employees."

The 36 districts seek to build baccalaureate degree programs in a wide variety of diverse vocational fields, ranging from airframe manufacturing technology, biomanufacturing, respiratory therapy, dental hygiene, engineering technology, and public safety administration. Many of the proposed programs are in fields where graduates with associate degrees can already expect to earn \$60,000 a few years after graduation, making them very cost-effective.

At its meeting on November 18th, Chancellor's Office staff presented a proposed process to the board. Any district wishing to host a program must submit an application to the Chancellor's Office by December 19th, 2014. Districts that did not turn in an initial interest form may still submit an application.

Applications will be reviewed by a team comprised of Chancellor's Office staff, a member of the business and workforce community, representatives from CSU and UC, and community college administrators, faculty, and staff from districts that did not apply to host a program.

Considerations for selecting a district include geographic distribution of the pilot programs, diversity of pilot programs, ability of the district to establish a rigorous program in their proposed field, and that the proposed program will meet an unaddressed local or statewide workforce need.

The team will then make its selections and forward its recommendations to the chancellor, who will decide which applications are submitted to the board of governors for ultimate

consideration and approval, in consultation with representatives of the CSU and UC. The board is scheduled to make its decision on January 21st, 2015.

Under the law, the four-year degree programs must be up and running by at least the 2017-2018 academic year; however, districts may start their programs by the fall 2015 semester. Districts must also seek approval from the Accrediting Commission for Community and Junior Colleges to start a program.

The legislation sunsets after the 2022-2023 school year, after which the Legislature and governor may renew it pending two Legislative Analyst's Office reviews of the pilot program, one in 2018 and another in 2022.

The law was enacted to assist the state in meeting the need for individuals in highdemand technical disciplines that are increasingly requiring baccalaureate degrees and to increase college participation rates and improve workforce training opportunities for local residents who are unable to relocate because of family or work commitments.

Further impetus for the measure comes from studies that show California needs to produce one million more baccalaureate degree earners by 2025 to remain economically competitive in the coming decades.

Community colleges are an efficient and economical way to help meet those needs due to their numerous locations throughout the state and modest tuition. Twenty-one other states also allow community colleges to offer baccalaureate degrees.



Recent cases of interest





Deputy District Attorney Aaron Miller, Career Criminal Prosecution Unit District Attorney Jan Scully announced that Gregory Aaron Gadlin was convicted by jury of 16 counts of second-degree robbery, being a felon in possession of a firearm and being a felon in possession of ammunition. The jury also found true three personal gun use allegations.

From May 2013 through July 2013, Gadlin entered primarily convenience stores and gas stations, displayed a handgun and robbed employees for money and personal belongings. During one robbery, Gadlin fired one round at a clerk, but missed. Three days later during another robbery, he again fired a round at a store clerk. This time, the clerk was struck in his torso and left hand. A bulletin went out to law enforcement with a description of Gadlin' vehicle. He was arrested after an alert on-duty security officer with the Sacramento County Sheriff's Department located Gadlin's car in the parking lot of the Department of Human Assistance.

Gadlin had been previously convicted of three prior strike offenses. At the time of these robberies, he was on parole for another robbery in which he personally used a firearm.

Gadlin faces a maximum potential sentence of more than 600 years to life in prison under California's Three Strikes law. Sentencing is set for February 18, 2015 at 9:00 a.m. in Department 40 before the Honorable Raoul Thorbourne.

CASE: Luis Enrique Monroy Bracamontes (12/8/14)

Both the Placer County and Sacramento County District Attorney Offices have reviewed the penalty determination for defendant Luis Enrique Monroy Bracamontes, consistent with the internal policies of each office. Input from the victims' families was solicited, received, and considered during the

Both offices independently concluded that the death penalty is the appropriate penalty in this instance. Prior to making that determination, both offices sought input from the defense team.

Mr. Barbour and Mr. Dawson on behalf of defendant Bracamontes responded in writing to that request. They have asked for a future opportunity to submit a package of materials to us for reconsideration of that decision. Collectively, we agree to that procedure.

Covanta Energy, LLC

District Attorney Jan Scully, along with the district attorneys of Butte County, Fresno County, Glenn County, Kern County, Stanislaus County, Tulare County and Tuolumne County, announced today the settlement of a civil environmental enforcement action against three California subsidiaries of New Jersey-based Covanta Energy LLC.

Biomass energy plants burn forest, agricultural and urban wood fuels in order to generate electricity and produce ash waste streams that are either sent to landfills or used for other purposes such as building roads or use in agriculture.

The civil enforcement action filed in Sacramento County concerned metal content in the biomass ash, asserting that the sampling and analysis practices of biomass ash at the three Covanta biomass facilities were not rigorous enough.

Under the final judgment, the three Covanta facilities must pay a total of \$536,211, which is comprised of \$258,306 in civil penalties, \$40,000 in contributions to special environmental projects and \$ 237,905 in reimbursement of investigation costs. The Covanta facilities have adopted and implemented enhanced policies and procedures designed to more appropriately sample and test their biomass ash. The facilities will be bound under the terms of a permanent injunction prohibiting any future violations of law and requiring adherence to the new sampling and testing program.

"Today's settlement is a significant step toward ensuring biomass energy plants operate in full compliance with California's environmental laws," said District Attorney Jan Scully. "I commend the California Department of Toxic Substances Control and all of the district attorney offices involved in this investigation as well as Covanta for its cooperation to protect the health and safety of our citizens.'

IRS Tips for Year-End Gifts to Charity

SACRAMENTO REGION, CA (MPG)

- The IRS is reminding individuals and businesses considering making year-end gifts to charity to keep in mind certain tax law changes made in recent years.

"With the holiday season upon us, many taxpayers use this time of year to give gifts, monetary and otherwise, to their favorite charities," said IRS spokesman David Tucker. "There are important things to keep in mind such as making sure the charity is eligible for tax-deductible donations."

Clothing and household items, including furniture, furnishings, electronics, appliances, and linens, generally must be in good used condition or better to be tax-deductible. A clothing or household item for which a taxpayer claims a deduction of more than \$500 does not have to meet this standard if a qualified appraisal is included with the return.

Donors must get a written acknowledgement for all gifts worth \$250 or more that includes, among other things, a description of the items contributed. Donations of money require a bank or written statement from the charity in order to be deductible, regardless of amount. The record must show the name of the charity and the date and amount of the contribution. Such donations include

those made in cash or by check, electronic funds transfer, credit card, and payroll deduction. For payroll deductions, the taxpayer should retain a pay stub, a Form W-2 wage statement, or other employer document showing the total amount withheld for charity, along with the pledge card showing the name of the

The IRS offers the following additional reminders to help taxpayers plan their holiday and year-end gifts to charity:

Check that the charity is eligible. Only donations to eligible organizations are tax-deductible. Select Check, a searchable online tool available on IRS. gov, lists most organizations that are eligible to receive deductible contributions. Churches, synagogues, temples, mosques, and government agencies are eligible to receive deductible donations, even if they are not listed in the tool's database.

Contributions are deductible in the year made. Thus, donations charged to a credit card before the end of 2014 count for 2014, even if the credit card bill isn't paid until 2015. Also, checks count for 2014 as long as they are mailed in 2014.

For individuals, only taxpayers who itemize their deductions on Form 1040 Schedule A can claim charitable deductions. It

is not available to individuals who choose the standard deduction (including Form 1040A or 1040EZ). A tax saving will be realized only if total itemized deductions exceed the standard

deduction. For donations of property, get from the charity, if possible, a receipt that includes the name of the charity, date of the contribution, and a reasonably-detailed description of the donated property. If a donation is left at a charity's unattended drop site, keep a written record of the donation that includes this information, as well as the fair market value of the property at the time of the donation and the method used to determine that value

The deduction for a car, boat, or airplane donated to charity is usually limited to the gross proceeds from its sale. This rule applies if the claimed value is more than \$500. Form 1098-C or a similar statement must be provided to the donor by the organization and attached to the donor's tax return.

If the amount of a taxpayer's deduction for all noncash contributions is more than \$500, a properly-completed Form 8283 must be submitted with the tax

Plants are not as dumb as they look.

At least to me, plants have never seemed like the brightest bulb in the box. They stand around, looking green, hoping for a sunny day but not able to walk, talk or turn on the TV. However, due to a recent university press release, I've got to rethink my attitudes about vegetation.

Two scientists at the University of Missouri, Heidi Appel and Rex Cocroft, studied a plant called Arabidopsis. That's a common experimental plant, used by researchers because it's fast growing and a great deal is known about it. Arabidopsis is a flowering plant that you can think of as a cousin to mustard and cabbage.

The researchers let caterpillars feed on a group of Arabidopsis plants. Using special devices, they recorded the sounds or vibrations made by the insects chewing on the

Next Appel and Cocroft and their team took two new sets of plants and separated them. To one set, they played back recordings of the sounds and vibrations the insects had made as they fed on the Arabidopsis leaves. To the second set of plants, they played back a silent tape-in other words, this second set of plants was the "control" in their experiment.

Then the team let caterpillars feed on both sets of plants. Results showed that the Arabidopsis that had been exposed to the sounds of the insects feeding on leaves had more mustard oils in their

leaves than did the control group. Mustard oils are chemicals many insects don't like and will avoid.

"What is remarkable is that the plants exposed to different vibrations, including those made by a gentle wind or different insect sounds... did not increase their chemical defenses," Cocroft said in a press release. "This indicates that the plants are able to distinguish feeding vibrations from other common sources of environmental vibration."

Plants really are not dim bulbs.

"Plants have many ways to detect insect attack," Cocroft said in the press release. "But [insect] feeding vibrations are likely the fastest way for distant parts of the plant to perceive the attack and begin to increase their defenses."

Next steps for the researchers include learning more about exactly how vibrations are sensed by the plants and what parts of the complex sounds may be the most important. The results of this type of work are not just academic. A long way down the road, such research may be able to improve crop plants, giving them a natural way to boost their own defenses against insect pests.

"Caterpillars react to this chemical defense by crawling away, so using vibrations to enhance plant defenses could be useful to agriculture," Appel said. "This research opens the window of plant behavior a little wider, showing that plants have many of the same responses to outside influences that animals do, even though the responses look different."

I've got a new respect for plants — and the researchers who are learning surprising things about them.

Pick it Up: Half-Life 2 Turns Ten

One of Maya Angelou's best quotes is "People will forget what you said. People will forget what you did. But people will never forget how you made them feel." I forgot what most characters said in during the time I spent with Half-Life 2. I forgot much of what I did. But I haven't forgotten the way it made me feel. Half-Life 2 arrived ten years ago as of November 16th, but I got on the train late, playing it only recently out of ignorant curiosity rather than to experience what many call the only perfect game. I've played games that have given me stronger emotions (some have even have made me cry), and I've played games with more profound messages, but Half-Life 2 conveys a full range of emotions over the course of its campaign, more so than anything else I've ever played.

I remember being completely underwhelmed by the first Half-Life, released in 1998. I came in expecting the first example of advanced storytelling in gaming, but instead found a series of outdated graphics and mechanics. So, going into Half-Life 2, I wasn't expecting

that would be the entertainment high-point of my life, was in the first few minutes. I'd just gotten off of a train, entering for the first time the station in the gritty, post-apocalyptic City 17.

As I made my way through the station, filled with faces of oppressed citizens, I came across a gas-masked soldier standing lazily by a trash bin. A soda can rested on the rim of the bin. He knocked it to the floor.

"Pick it up."

I did the rational thing, and picked up the can. And then I threw it right in his face. My disobedience was met with a brutal beating from the business end of his electrified billy club.It's one of the simplest moments in gaming, but one of the most powerful. There have been numerous analyses written, all valid, about this one moment and what it means, but for me, all it did was get me angry. Most games (shooters especially) are, at their core, power fantasies where you're the mightiest, most important person around. This one, dehumanizing act, from this one, bored soldier left me feeling betrayed as a gamer. I had

expected power, and was met with degradation. In most games, I shoot the enemy because the game tells me they deserve to be shot. Half-Life 2 was the first game where I was motivated personally to fight the enemy, where I wanted to shoot them beyond the reason "the game told me so." I had a vendetta to settle with this soldier, and with all of his gasmasked kind.

This moment represents Half-Life 2 as a whole. Valve, the developer, uses that initial kernel of rage to keep the player emotionally invested in the saga that turns you from everyman into the One Free Man, a messiah to the game's downtrodden humanity. Unlike other games, it does so not by instilling a physical change in power-level or appearance in the protagonist, but by manipulating players' emotions so that they feel themselves grow into their saviour role.

Angelou almost assuredly never played Half-Life 2, but she would've remembered how it made her feel.

Available at greatcall.com or 800-918-8543, the Touch3 sells for \$170 with a \$20 introductory discount, plus a one-time activation fee of \$35, and no-contract is required. Monthly service plans that include unlimited 5Star and Urgent Care service start at \$25. And their data plans start at \$2.50 per month for 20MB.

Tablet Computer

If you're considering a tablet, a top senior-friendly option is AARP's new RealPad, which costs \$189 at aarprealpad.org, walmart.com/realpad or Walmart

Produced in partnership with Intel, the RealPad is an Android tablet with a 7.85-inch touchscreen. It provides a clutter-free simplified home page with large text icons to frequently used functions like email, social networks, weather, news, games, camera and pictures, Google, the Web, apps and more.

It also has a 2-megapixel front camera and 5-megapixel rear camera, and comes with 24/7 phone support, a bunch of tutorial videos, and a "Real QuickFix" tool that connects users to

keyboard, and offers a variety technology support agents over the Internet who can access the tablet and fix problems.

Desktop Computer

If you think your grandmother would like a desktop computer, the Telikin (telikin.com, 800-717-7640), which has been around for three years now, is an excellent choice.

Ready to go right out of the box, this all-in-one touch-screen computer displays a big button menu on the screen at all times, providing simple access to most functions like the Internet, email, games, video chat, photo sharing, news and weather, and more.

Available in two sizes – the 18.6-inch "Telikin Touch" that costs \$699, and the 22-inch "Telikin Elite II" for \$1,079 these computers come with built-in speakers, a Web camera, microphone, wired keyboard and mouse. They also offer a "tech buddy" feature so you can access your grandma's Telikin computer remotely from your computer to help her when she needs it.

Back to the Caps: Frustrated



15 of its 28 years in Gold River, but not even a single point as the Las Vegas Neon

and battle-weary, the franchise changed hands in 1999 and the new ownership gave the town killjoys a victory two years later by moving to temporary stadia on the grounds of Sunrise Mall and Westfield Galleria at Roseville. The dozen seasons played on shopping center parking lots were hindered off the court by a string of ownership changes, several sullied in legal troubles (e.g., a Ponzi scheme) and financial woes (e.g., a bankruptcy) that would prove more destructive than the NIMBYs (not in my backyard) of Gold River. No wonder the end result was game, set, match for the Capitals in Sacramento Valley.

So why dig up this old horse now? Well, because last month marked a footnote in the Sacramento Capitals' rollercoaster history (more on that in a moment). Another reason is that after talking to friends who I used to see at Capitals matches, it's clear that many in Gold River don't know whatever became of the team. If you're among them, I bear the saddest news of all. After supposedly coming up

nent home for the Caps in the Sacramento market, new owner Deepal Wannakuwatte held a press conference in February to announce the franchise's move to Las Vegas and a name change. Unfortunately for tennis fans of Sin City, it was lights out for the Neon before the opening serve. Just one month after the big announcement, WTT revoked and disbanded the club. Seems the league frowns on owners whose assets are frozen by the feds on charges of bilking investors and lenders out of tens of millions of dollars. Who knew a surgical gloves company could be so contaminated? On November 13th, a

U.S. federal judge sentenced Wannakuwatte to 20 years in prison for what prosecutors say was perhaps the largest Ponzi case ever in the Sacramento region. Facing the music while wearing shades of prisoner orange and shame, the last in a line of Capitals owners was called a liar and an evil person by the judge and a sociopath and a serial thief by one of the victims. For what it's worth, the 64-year-old expressed remorse, saying he shamed his family and his Sri Lankan roots. He's up for parole in 2031.

As for court action of a different kind, the final match of the franchise was a road loss to the Texas Wild on July 24th, 2013. The Caps finished last in the same Western Conference it represented in the WTT Championship only one season earlier. That, too, was a loss, albeit to a Washington Kastles team that has now won four King Trophies in a row, a feat accomplished only once before—by the Capitals. Sacramento's streak came while they played at the Racquet Club, and two of those trophies were won on local soil. Clearly, the years at Gold River Racquet Club were the Capitals'

golden era. And because of that, I think a lot of us would like to see some sort of historical marker to honor the team. A plaque next to Court #2 at the Racquet Club seems appropriate, if not 13 years overdue. Up until this year, there was the excuse that the Sacramento Capitals were still alive and kicking away from Gold River. Now that the team is gone forever, it's time for the club to give fans like the driver of that green Kia Soul a physical place to pay their respects. The winningest team in Sacramento pro sports history deserves that, and not doing so is a Capital offense. ★

Season's Greetings, Fellas! And to All a Good Night!

Michael Malone, walking around with a blank look on his face, while you are out and about doing some late holiday shopping, take a moment to give the poor guy a hug.

Or, maybe you could give him a thoughtful, lovely parting gift; just be sure it is not something you picked up at the Kings' Team Store.

Malone already has received more than he would've asked for from the Kings --- a pink slip, the short end of a stick, the old heaveho. Malone must be feeling kind of down and under-appreciated if that's the thanks he gets for making the Kings watchable this season (at least until DeMarcus Cousins got sick).

Following eight consecutive dreadful losing seasons, the Kings were off to one of their better starts this year. After losing big to Golden State in the opener, Sacramento won five games in a row, lost three to probable playoff teams on the road, then won four of five to stand at 9-5 --- more winning than Kings fans have been used to seeing. But since, the team has gone just 2-8 through Sunday leading up to Malone's firing. Seven losses have come without the team's star center, Cousins (23.5 ppg, 12.6 rpg), in the lineup.

As reported by The Sacramento Bee, Kings general manager Pete D'Alessandro (who was hired two weeks after owner Vivek Ranadive hired coach Malone) said, "It wasn't about wins and losses. I didn't really care about what our record was. It's about who we want to be, what we want our identity to be as a team."

That seems odd. In professional sports isn't it ALL about wins and losses (and making the big bucks). Shouldn't the desired identity be that of a winning franchise? The Kings brass is intent on manufacturing an up-and-down, fast-paced games might be more appealing to

Of the fourteen coaches during the Kings' Sacramento era only Rick Adelman (1998-2006) had a winning record (395-229). Due to proverbial philosophical differences, Malone wasn't given much of a chance to turn things around. He went 28-54 last season, 39-67 overall, through a time of ongoing roster reconstruction.

Malone seemed to be doing rather well with what he had to work with --- a team whose star is one of the best low-post players in the league. It's questionable whether or not the Kings are built for run-and-gun just yet. They are a strong rebounding team that shoots free throws well and has improved defensively under Malone, but also one that does not shoot a good percentage from three-point range and is turnover prone. Former point guard Isaiah Thomas, The Husltin' Husky, was an exciting, freewheeling sort to whom defense was an occasional afterthought, but the Kings allowed him to depart. It's all pretzel logic at this stage.

The Kings have a new point guard in Darren Collison, a secondyear player in Ben McLemore and a rookie in Nik Stauskas who are all still developing into their roles. The three have played a total of 24 regular-season games together --a small sample-size. Good luck to the new coach, be it interim coach Tyrone Corbin, Chris Mullin, Vinny Del Negro, George Karl, Alvin Gentry, Mark Jackson or Red Auerbach (?).

At least in a couple of weeks, if all indications are on point, Malone will be able to seek out 49ers head coach Jim Harbaugh for some consolation. If, and likely when, Harbaugh is given his walking papers, the two ex-coaches will have something in common --- sent

If you happen to bump into for- style of play that might be more unceremoniously on their way mer Sacramento Kings head coach appealing to the fans. Winning despite measurable successes that had been uncommon in their teams recent pasts.

> Harbaugh, despite taking the 49ers to three straight NFC Championship games and a Super Bowl, and a record of 43-18-1, will, apparently, be exiting the scene due to another case of "philosophical differences" with the bosses. Maybe this too is "not about wins and losses (in the NFL?!!)."

But the guys upstairs will be able to use this 7-7, injury-riddled season, a stagnant offense --- that has featured a duct-tape line, a quarterback under constant siege and a halfhearted, half-fast corps of receivers --- and another disappointing loss to the rival Seattle Seahawks (17-7, Sunday, eliminating the 49ers from the playoffs) as a backdrop for Harbaugh's dismissal, if it happens as predicted.

Harbaugh, for sure, will not be alone on the list of fired NFL coaches at season's end. There are always a few downtrodden losers that get the axe. After all, in the pro's it's all about...uh...wins and

Harbaugh and Malone could join together and host a party for all of those guys to lift their spirits a bit. And they could invite some college football guys, too --- guys that also received early holiday gifts like Bo Pelini of Nebraska, Will Muschamp of Florida, Brady Hoke of Michigan, Tony Levine of Houston and all the others. They could check in on the Oakland Raiders' ex-coach Dennis Allen to see if he might need some cheer-

It might be a great idea to organize an annual holiday event to celebrate all of the guys that have had their coaching hearts ripped out during the year and make a grand evening of it.




