

After spending a day on the Leoni Meadows property collecting field data and interacting with natural resource professionals, students weighed in on which of many possible fuel reduction activities were most in line with the purpose of the grant program. During the challenge, teams of students also completed field training, followed by a field test, to assess their technical forestry knowledge and data collecting skills.





There are moments in life when we think to ourselves that our timing is perfect. Strolling along the Sacramento State University campus early one morning heading to my office, I noticed fog had blanketed the area. It also seemed the fog was acting as a sound barrier and campus was eerily quiet. As I approached my destination, I realized that my timing was perfect. A short distance from me, a bright light was about to shine for all to seethe raising of our nation's flag. The fog, miraculously, did not blanket this area!

Each school day, members of the Air Force or Army ROTC program practice the proper way to raise the flag under the guidance of a superior officer. Second Lieutenant Mark Ishizu, United States Air Force, is the admissions officer for the Air Force ROTC, Detachment 88, on the Sacramento State campus. Lieutenant Ishizu said, "there are many people who do not know about the history of our flag, and here, we also teach about the respect the flag deserves."

I began to think more about the flag; how much do we really know about the flag of the United States of America?

On June 14, 1777, in order to establish an official flag for the new nation, the Continental Congress passed the first Flag Act. The U.S. flag is the fourth oldest national flag in the world


(Denmark was first in 1219). The blue field on the U.S. flag is called the "union." There are 50 stars on the flag that represent our 50 United States; there are 13 horizontal stripes, seven red alternating with 6 white. The stripes represent the original 13 colonies, and the colors of the flag are symbolic as well: red symbolizes hardiness and valor, white symbolizes purity and innocence, and blue represents vigilance, perseverance and justice. The actual name of the American flag is the Stars and Stripes.

Now I ask you, did Betsy Ross sew the first U.S. flag? There is much debate by historians about this. We probably will never know. We do, however, have a good idea about who originated its design. Credit for that achievement goes to Francis Hopkinson, a New Jersey representative to the Continental Congress and signer of the Declaration of Independence.

It was not until 1923, however, that a Flag Code was officially adopted. Although it is not an enforceable law, the code is the guide to flag protocol. The Flag Code answers questions regarding the flag, like how does a person properly destroy a flag? The Flag Code states: "always dispose of a worn flag properly, preferably by burning it." To learn more about the Flag Code, you can go to www.americanflags.org.

The flag of the United States has at times been an emotional lightning rod when used by protesters to draw attention to their cause. The U.S. Supreme Court ruled in 1989 in Johnson vs. Texas that flag burning "constitutes a form of symbolic speech that is protected by the First Amendment." Many Americans prefer to focus on our flag in more stirring and patriotic ways. We take pride in flying our flags; we take pride in watching as the flag takes center stage in our hometown parade.

We see images of our flag everywhere-in neighborhoods, public places, sporting events, and on t-shirts. Powerful images that contain our flag include photos of the three firemen in New York raising the flag at Ground Zero in 2001 and the1980 United States Men's Olympic Ice Hockey team standing on the victors' platform as the flag was raised to the playing of our national anthem! The most iconic image of our flag, I believe, is its raising on Mount Sirabachi on Iwo Jima by U.S. Marines in World War II. Our flag is a Grand Old Flag!

Lately, I've been thinking about my friend, Charles, and missing him. He was a husband, father, English teacher, social worker, canoeist, bluegrass player, therapist, connoisseur of green-apple moonshine, and a good friend.

He spent the last decade of his life as the Director of Student Services in my hometown school district, on the front lines of advocacy for some of the most vulnerable children in the community. It was a role he relished almost as much as playing Gordon Lightfoot and John Prine songs on his guitar.

Charles died a few years ago, succumbing to leukemia. Friends of his gathered on a scraggly piece of land along the Tallapoosa River in North Georgia for his memorial service. I am certain that we gathered exactly where Charles wanted us. He loved that piece of land and the river that runs through it. He used it as a retreat for his body and soul. It was his sanctuary.

I use the word "sanctuary" intentionally, for Charles wouldn't enter a church. You see, there was always a rebel's spirit behind Charles' jolly smile, and he had lost a good deal of faith in politics, education, matrimony - in the human race in general. He seemed to have lost

the most faith in religion.

He and I would often speak of religion. At such times I could always count on him to sum up his faith by quoting Emily Dickinson: "Some keep the Sabbath going to church; I keep it staying at home; With a bobolink for a chorister, and an orchard for a dome...God preaches - a noted clergyman and the sermon is never long; So instead of getting to heaven at last, I'm going all along!"

Yet, for all the lost confidence, Charles never lost his hope for living in a better world. This was, after all, his calling. He wanted life to be better, more just, peaceful, and whole. While often disappointed, he kept wishing - and working - for nothing less than the Kingdom of God (though he disagreed with my terminology).

The "Kingdom of God," can invoke images of a faraway heaven where we will live in the sweet by-and-by. I don't think that is accurate, because heaven is just not that far away. Jesus taught that while there is an eternal element to Christianity, having faith is not so much about moving up and out when we die; it is about embracing and fostering the presence of God in this current world.

Imagine (to quote another of Charles' favorite musicians) a world with "nothing to kill for." Imagine all people "living life in peace." Imagine a world where the "lion will live with the lamb, where swords are beaten

into plowshares, and justice rolls down like the waters." But do more than imagine such a future - do more than simply wish for it - work for it. Implement it. Practice it. Live it.

I believe, with all my heart, that one day all of creation will be remade. I believe the universe will be divinely washed clean of all that has gone wrong, and the world will be set right. But I do not believe such faith gives me permission to be a spectator waiting for utopia. Such faith compels me to act, as Charles did, living as God would have this world to be.

So it never troubled me that Charles didn't go to the "House of God" on Sundays. Rather, it encouraged me that he went to do the work of God every day. I was never bothered by his claims to have no faith. Rather, I was challenged by how he actually practiced his faith. So what if he wanted the church to be "better?" He was making the world better.

Let this be a challenge to us all - especially those of us who enthusiastically gather each Sunday or Sabbath: Not all of God's work is done within the four walls of the church house. In fact, the lion's share of it is done outside. And that's good, because that is where it is needed the most.





Christian Church in Roseville and traveled to the East Lawn Cemetery in Sacramento for the family's private burial service.

"All of us in the first responder industry, from the police to fire, we all consider each other brothers and sisters," said Sacramento Metro Fire Department Captain Brad Reynolds. "It's vitally important that we all share in this and show our support for their family members. As sad as an event as this is to bring us all together, it's very heartfelt to see this all happen."

Patrick Fintel of Sacramento County was present for the entire half-hour long procession to honor the sacrifice made by Deputy Oliver and his family. "I came to show respect to the fallen officers and their family and to let them know that we're all thinking about them,"

said Fintel. "It is very important to come out and support our community and law enforcement."

Donna Martinez of Placer County had a more personal inspiration. Her husband is a Sacramento County Sheriff officer. "The community support, I think it's fabulous," she said. "Oftentimes you don't realize how big your community is or how much they care about your officers until something like this happens, which is unfortunate. But it is a truly good thing to see these people out here today."

Deputy Danny Oliver, a 15-year veteran of the of the Sacramento County Sheriff's Department, was killed in the line of duty on October 24th while investigating a suspicious vehicle on the 2000 block of Arden Way. He is survived by his wife and two daughters.

SACRAMENTO, CA (MPG) -One thing was certain for the Cordova High School boys soccer team going into its Sierra Valley Conference finale at Rosemont on Oct. 29th-advancing into the Sac-Joaquin Section Division III playoffs. But the question remained: Would the Lancer booters win their final regular season game against their rivals? That question, too, was answered in the final 40 minutes of the game that led to a 3-0 win.

Cordova (5-3-2 in the SVC, 14-5-2 overall) scored all of its goals in the second half after a scoreless first half. Anthony Acosta scored two of those goals for the Lancers, while Miguel Medina scored the other. Acosta and Alex Casal recorded an assist each.

There is nothing quite like a championship parade to make fans feel all warm and fuzzy inside, even when the celebration goes down in the cold and rain on a crowded workday afternoon.

The San Francisco Giants' family, friends and fans in The City's streets, throughout Northern California and around the country were really feeling the good vibes Friday during the third World Series title party in the last five years. Yes! Yes! Yes! Everybody around Major League Baseball wants what Giants Nation is having.

When the Giants closed out The Series in Game 7 last Wednesday, 3-2, behind the heroics of skyrocketing superstar Madison Bumgarner —- suddenly Jimmy Fallon's favorite player (he might even try on those MAD BUM underwear) --- The Nation was overwhelmed with unbridled joy. This determined group of beloved Giants players, underappreciated on the grand national stage, had defied the prognosticators once again to win it all.

The excitement, exhilaration, exclamations and exultations carried on for days, right through to the heart of San Francisco at City Hall. The throng on hand there, representing the sentiments of TheNation as a whole, rejoiced in the accomplishments of this third band of baseball brothers, that persistently claimed that the members of this unit consistently gave their greatest efforts for the good of the whole, their teammates and fans. It was all about The Team, The Team, The Team!

But as the party dispersed late in the afternoon and some people escaped to their chauffeur-driven limousines, Lincoln Town Cars, Bentleys, Escalades or such, while many others hit the streets to find their own cars, a cable car, a bus, a cab or BART, there was, undoubtedly, at least one common thread in the Giants conversations:

"What's going to happen with Pablo?"

Giants third baseman Pablo Sandoval, The Panda, became a free agent at the conclusion of the World Series. Recognizing that is a reminder to all fans that in the stark realities of professional sports it is too often about The Money, The Money, The Money!

The Panda, of course, has been a cuddly fan-favorite since coming up through the Giants' ranks and arriving on the MLB scene in 2008. He has been a .294 hitter since in his Giants career. This regular season he posted not bankbreaking numbers of 16 homers, a .279 average and 73 RBI. He has never matched his figures of his first full season in 2009 of 25 homers, a .330 average with 90 RBI

But The Panda has shown that he is "money" in October. In the last two championship drives, Sandoval has rung the register for the Giants. He was the World Series MVP in 2012, when he smashed three homers in one game, a la Reggie Jackson. This time he could've been part of a three-headed MVP, along with Bumgarner and Hunter Pence, hitting .429.

Over ten postseason series in his career, 39 games, Sandoval has hit .344 with a .389 on-base percentage, with 13 doubles, six home runs and 20 RBI. In 12 World Series games he has hit .426. Chaching! And, big No. 48, who also plaved a Gold Glove-caliber third base this season, is only 28 years old and figures to be —- weight issues permitting — entering the prime of his career.

The Panda will surely have many suitors during his open-market tour and it will be interesting to see just how much value that good ol' Giants-family feelin' carries in Pablo's heart. Several well-heeled franchises will likely be more than willing to open wide their pocketbooks to lure Sandoval to

greener pastures. No! No! No! Here at the End of the Bench we

always hate debating the money issues in pro sports --- particularly the actual specifics --- because the millions upon millions could always be spent on more deserving issues than a bunch of ballplayers (another story for another time). But, for now, the question is who is to know just how the dollarsdynamic will affect the Giants' roster going forward?

The team has several other matters to contend with beyond third base. The Giants have age, injuries and inconsistencies to deal with on the pitching staff. Other than Pence, they have health and performance issues in the outfield and the bench is not particularly strong. How this team won it all with the current collection of players was a giant surprise to many.

The roster will require in-depth examination on the part of the highly-successful front office if the team is to meet the expectations (another series win in a year, maybe two) of the fans and there will be explanations needed if Sandoval slips away.

The greater question, however, is will The Panda be greeted with cheers or boos if he returns to San Francisco as a Dodger, a Yankee or Red Sox? And what would happen to all of those Panda hats?

You could use yours to wash your car or line the bird cage. You could use it for a foot-mat on the mud porch. You could get fifty cents for it at your garage sale or use it for fire-starter at your next tailgate party. You could make a sweater out of it for your Chihuahua or make a bed for your cat. You could use it to clean up all of your Giants memorabilia or to dust off those Giants World Series DVDs you just ordered. Or, you can wear it and cry while sitting alone in the dark watching Giants games next season.

### The league's top two teams battle at Spartan Stadium in East Lansing

#### OHIO STATE AT MICHIGAN STATE

The last two unbeaten Big Ten teams meet Saturday night in East Lansing. The winner will all but wrap up the East Division title and remain alive for a spot in the College Football Playoff. Ohio State has a more difficult path to the Playoff because of its relatively low ranking (No. 16 in the initial CFB top 25) and a bad loss on its résumé (at home to Virginia Tech), but a win at Michigan State likely would vault the Buckeyes into the top 10. Michigan State, with a No. 8 ranking and consistently strong play throughout the season, is in much better shape. The Spartans have a "good"

loss (at Oregon in Week 2) but only have one quality win, in early October over Nebraska at home. It's not only important for Michigan State to win this game, but the Spartans need to look good doing so in order to impress committee members who might be questioning the strength of their schedule. #### NOTRE DAME AT ARIZONA STATE

Arizona State is quietly emerging as one of the top programs on the West Coast. The Sun Devils, the defending Pac-12 South champs, are 15-2 in the their last 17 league games dating back to the final month of the 2012 season. Todd Graham has taken his share of criticism over the years - some of it deserved — but the guy is clearly one of the top coaches in the country. Though his teams in recent years have been known for their prowess on offense, Graham has a background on defense, and his 2014 team - after a slow start - has done a terrific job on Stanford, Washington and Utah - to an average of 12 points and 273 yards. Replicating that type of performance against Notre Dame will be difficult. The Irish's schedule to date hasn't been overly taxing - Stan-but ND is averaging 35.4 points and 458.6 yards per game. #### **HEISMAN WATCH**

#### ALABAMA AT LSU

This matchup is always appointment viewing, but LSU's recent rise the Tigers have won three straight after an 0–2 start in the SEC — has made this game far more dangerous for Alabama. LSU has leaned on its running attack of late, averaging 254 rushing yards in wins over Florida, Kentucky and Ole Miss. During this three-game stretch, the Tigers have completed wins over Oklahoma State and Texas Tech, Boykin completed only 12-of-30 passes for 166 yards and one touchdown against WVU. He will need a big performance on a national stage to make a push in the Heisman race. TCU by 6

#### **BAYLOR AT OKLAHOMA**

This was supposed to be the Game of the Year in the Big 12, not the Kansas State-TCU showdown in Forth Worth. Baylor is still very much alive in the league race, with a 4-1 record and a win over TCU, but Oklahoma played its way out of title contention by losing to both TCU and Kansas State. The Sooners have been a disappointment on defense, most notably against the pass. They rank ninth in the league in passing yards allowed (265.8 ypg), due in large part to a three-game stretch in which they gave up 1,028 yards to West Virginia, TCU and Texas earlier this season. That's not a good sign with Baylor coming to town. The Bears can gash opponents with both the run and the pass, but they seem to enjoy the forward pass a bit more. The issue for Baylor will be on the line of scrimmage, where a once-stout offensive line is down two starters. If the Bears can protect Bryce Petty, they have a very good opportunity to record their firstever win in Norman. *Baylor by 3* 

#### PRIME TIME PLAYERS

In his first start of the season, Tennessee sophomore Joshua Dobbs threw for 301 yards and two touchdowns and added 166 rushing yards and three scores on the ground to lead the Volunteers to a thrilling 45–42 overtime win at South Carolina. ... Everett

Golson became the first player in Notre Dame history to pass for three TDs and rush for three TDs in a single game, during an uneven 49-39 win over Navy. Golson completed 18-of-25 passes for 315 yards, three scoring strikes and one pick through the air, while scrambling for 33 yards and three TDs. .. Pittsburgh's **James Conner** left it all on the

field during a disappointing 51-48 doubleovertime home loss to Duke. The 6'2", 250pound sophomore had 38 carries for 263 yards and three TDs. ... Baylor's Corey Cole**man** made the most of his three receptions, with 167 receiving yards (55.7 ypc) and TDs of 72 and 49 yards during a 60–14 blowout of Kansas. ... Vanderbilt quarterback **Johnny** 

McCrary tied a school record by throwing five touchdown passes in the Commodores' 42-28 win over Old Dominion. ... The latest in a long line of star USC quarterbacks, Cody Kessler connected on 21-of-32 passes for 400 yards, five TDs and zero INTs during a 44–17 road win in the fog and rain at Washington State.

1. Marcus Mariota, QB, Oregon Mariota recorded a win over Stanford for the first time in his three years as the Ducks' starter. He threw for 258 yards, ran for 85 and accounted for four touchdowns.

2. Dak Prescott, QB, Mississippi State Prescott has been a little loose with the ball (five INTs in his last three games), but the Bulldogs keep winning. He threw for 331 yards and one touchdown in MSU's 17-10 win over Arkansas.

3. Amari Cooper, WR, Alabama The Crimson Tide had a bye last week. In eight games, Cooper has 71 catches for 1,132 yards and nine touchdowns.

4. Trevone Boykin, QB, TCU His stats weren't gaudy (166 yards passing, 49 rushing), but Boykin led his team to a 31-30 comeback win at West Virginia.

5. Duke Johnson, RB, Miami Johnson rushed for 177 yards and two scores in the Hurricanes' 47-20 win over North Carolina. He's averaging 7.2 yards per carry against ACC opponents.

#### **STOCK REPORT**

Florida State showed its championship mettle by recovering from a 21-0 deficit in the first half to rally past Louisville 42–31 on Thursday night. True freshman Dalvin Cook, who rushed for 110 yards and two TDs, was the best player on the field in the decisive second half.

Penn State recorded only 219 yards of offense in a 20–19 loss at home to Maryland. The Nittany Lions had 373 yards vs. Rutgers in their Big Ten opener but have not cracked the 275-yard mark in league play since. They are averaging 3.1 yards per play over their last four games.

Florida stunned the college football world with a dominating 38-20 win over rival Georgia in Jacksonville. Led by Kelvin Taylor and Matt Jones, the Gators rushed for 418 yards (on a 7.0-yard average) en route to the most improbable win of the Will Muschamp era.

Is the magic gone at Stanford? The Cardinal dropped to 5–4 overall and 3-3 in the Pac-12 with a 45-16 loss at Oregon. After playing in a BCS bowl in each of the last four seasons, Stanford must now win one of its final three games simply to reach bowl-eligibility.
