**SACRAMENTO (MPG)** - Senator Ted Gaines (R-Roseville) issued the following statement regarding the news that Tesla Motors will build their "gigafactory" in Nevada.

"I'm devastated for the 6,500 families who won't have the chance at these jobs unless they move to Nevada. Tesla is a California-born company that the state has invested heavily in, and we want it to succeed. It makes complete sense for it to expand right here, close to its headquarters, yet they are headed out of state.

"It's a clear indictment of our business climate that Nevada is pulling this huge investment away from its natural home. I'm not sure there could be a stronger signal to legislators about how hard they have made it to operate here.

"But while I'm disappointed for California today, I'm going to be single-minded in my mission to turn our state back into a jobs-creating, economic powerhouse, and I challenge my colleagues to join me in a bi-partisan effort to ensure that we are the number-one destination for the next gigafactory."

# **Proposed Community Master Plan Revealed**

RANCHO CORDOVA, CA (MPG) -

After months of meetings filled with collaboration and deliberation, members of the Rancho Cordova City Council and the Cordova Park and Recreation District revealed a mostly finished master plan proposal for the community at a special August 21 work session.

Focusing largely on community facilities and sports tournament complexes, the plan proposes a park impact fee of \$8,784 per single family home to help offset the cost of lighted sports fields, additional restrooms and other community gathering facilities.

Meeting the needs of youth sports programs and tournaments with the proposed design is a concern for Mac Cameron of District 5 Little League. With an expected growth of more than 100,000 people by the year 2035, outgrowing other cities such as Roseville and Folsom, Cameron is not convinced that teams or their families will be adequately served by the placemakers, or public spaces that encourage

and meaningful interaction. He would like to see facilities that are superior to those in surrounding communities for his players and more fields centrally located instead of being scattered around town for families with more than one child playing Little League during the season.

"We need more facilities; with growth we want additional Little Leagues," Cameron said. "I don't think the placemakers are large enough to put a baseball complex. If you have multiple ages and levels playing, parents don't want to travel field to field."

Council member David Sander would like to have the boundary lines assessed more thoroughly for space and accommodation requirements for the influx of new residents expected to arrive over the next two decades.

"We're building a new community of 100,000 people, why wouldn't we build the best?" Sander said.

Sander was also bothered by the city's service ratio – that is, number of amenities to serve the population - compared to other nearby communities. The the Cordova Recreation and Park District states that the ideal service level for Rancho Cordova is five acres of neighborhood parks and community parks per 1,000 residents. Currently the service level is 37,000 houses on a ratio of 2.92 acres per 1,000 people.

"The reality is we don't have the facilities our neighbors have," Sander said. "Our current service ratio compared to other jurisdictions is astonishingly low – this shows us the gap we have."

The concept of the master plan and funding ideas for it are expected to be presented for approval next month to the District Board of Directors. Though there were various opinions about the master plan, most like Park Planning Manager Linda Taylor, agreed that improved communication among public agencies was responsible for what progress had been made and would only continue to help reach their goals.

"The more we work together the more trust that we can build," Taylor said. "I have every confidence in the world that we'll get







There are many communities, counties, and states who were hit pretty hard financially when the first BRAC (Base Realignment and Closure) went into effect in the 1980s. BRAC rounds of today were initially aimed at 2013 and 2015, but both of those were stopped by Congress. The next BRAC is scheduled for 2017, but even that should depend on whether we can or whether we will cut our military even more than we already have.

Originally, Secretary of Defense Chuck Hagel asked for the next BRAC to be in 2013 and 2015, but as I said that has now changed to 2017. It is unfortunate that both Congress and the Pentagon are looking at the \$\$\$ instead of learning about weakness from the past. Figures from the Senate Armed Services Committee show that the 1995 BRAC round cost \$6.6 billion while saving \$6.4 billion! And the 2005 BRAC cost \$34 billion with an estimated savings of \$13.7 billion over 20

### **BRAC** (Base Realignment and Closure)

years! Some of the Senators, like Senator McCaskill, said they could not support a process that is questionable about being in the best interest of American taxpayers or of our national security. I believe that seeing what is happening in the world today questions the wisdom of weakening our national defense even more than they already have.

"The United States is a Paper Tiger." That expression became well known by western countries because it was a slogan used by Mao Zedong's Chinese communist government when describing its opponents especially the Unites States of America. A Paper Tiger was a threat on the outside but could be easily dismissed because it could not (or would not) withstand a challenge or the "wind or rain" of international or military pressure. In the early years of the Cold War, Mao once called Russia a Paper Tiger because of "appeasement" to the United States. According to Wikipedia, Soviet Premier Nikita Khrushchev reportedly said, "The Paper Tiger has nuclear teeth." I guess you could say the Soviets didn't like it back then, any more than the United States likes it today.

President John Fitzgerald Kennedy, when talking about tempting our adversaries, expressed that concern in his inaugural address: "We dare not tempt them with weakness. For only when our arms are sufficient beyond doubt can we be certain beyond doubt that they will never be used." Today, we are seeing the Russia of the past beginning to show its aggressive arm again and there are also the terrorists who destroyed the twin towers in New York and aggressors like ISIS (Islamic State of Iraq and Syria). The United Nations has accused them of "mass atrocities" and war crimes. They have been designated by the United Nations and individual countries as a terrorist group.

We all will be watching to see what will transpire around the world and I hope that before another BRAC is planned and/ or put into effect, the Pentagon, the Department of Defense, and Congress will look out for our national security instead of waiting until we are hit with a "surprise" like a ton of bricks. ★



# Raley's Supermarket Settles **Civil Environmental Case**

Special Report District Attorney's Office

SACRAMENTO REGION, CA (MPG)

- District Attorney Jan Scully joins 25 other California district attorneys in announcing that West Sacramento-based Raley's supermarket was ordered to pay \$1,599,000 in civil penalties, costs and supplemental environmental projects, as part of the settlement of a civil enforcement prosecution, which includes a final judgment and permanent injunction. Raley's cooperated with the prosecution team throughout the investigation into their unlawful practices.

The judgment is the culmination of a civil enforcement lawsuit filed in San Joaquin County to stop the supermarket chain from unlawfully transporting and disposing of retail hazardous waste. The lawsuit claimed that more than 130 Raley's supermarket stores improperly stored, handled, and disposed of hazardous waste and pharmaceutical waste products into company trash bins. Instead of being sent to authorized disposal sites, hazardous

rials were being unlawfully transported to area landfills. Additionally, the lawsuit alleges that Raley's failed to take suf-

ficient steps to preserve the confidentiality of their pharmacy customers' information.

As a result of the prosecution, California Raley's supermarkets modified existing policies and have adopted new policies and procedures designed to eliminate the disposal of retail hazardous waste products and pharmaceutical waste into store trash compactors for eventual disposal into local landfills not equipped to handle such wastes.

wastes and contaminated mate- Hazardous waste produced by California Raley's supermarkets through damage, spills, and returns is now being collected by state-registered haulers, taken to proper disposal facilities, and properly documented and accounted for.

In addition, the settlement requires Raley's to dispose of or destroy all confidential customer medical information in a manner that preserves the confidentiality of the records.

In addition to devoting resources to California environmental compliance with regard to hazardous waste identification, classification, storage, transportation, and disposal, Raley's has agreed to purchase five mobile freshwater purification systems to provide safe drinking water to local communities in California in times of emergency or other pressing need. The mobile freshwater purification systems will be located in Placer, El Dorado, Sonoma, Sacramento and Contra Costa counties, but will be available for use by other counties within the state.

# Yesteryear Rests Peacefully in Fair Oaks Cemetery

FAIR OAKS, CA (MPG) - Picturesque Fair Oaks cemetery was founded on October 21, 1902 on a halfacre of land. Ornate headstones commemorating patriarchs lie in close proximity to simple, unnamed grave markers. The list of interments is unique; the first official resident of the grounds was Sarah Vail, a Folsom native who died in a fire and was buried in 1903. There are two other women who were buried in 1898, but Miss Vail is the first authenticated burial at Fair Oaks Cemetery.

Other gravesites include a dozen Civil War veterans from both the Union and Confederate Armies who now share a common ground. Another notable resident is Myrna Opsahl, a 42 year old mother of four who died in 1975 during an early morning bank robbery in Carmichael. She was shot by the infamous Symbionese Liberation Army. (The radical group also kidnapped and brainwashed heiress Patty Hearst during their reign of terror.) Alongside these graves are the plots of early 20th century people who are memorialized with small stone markers listing only last name and year of death. One in particular is a tiny headstone cradled amongst the roots of a large oak tree bearing the inscription: Bishop Baby - 1907. One hundred and seven years later, this little monument still brings on a melancholic sense.

Fair Oaks Cemetery manager of 17 years, Ray Young, takes great pride in the many years of service the cemetery has provided to the community. "We are one of the oldest cemeteries in the region." His staff includes

office manager Terri Perrin, clerk Theresa Day, and lead groundskeeper Guillermo Barron; they help Young maintain the tradition of honoring loved ones in a placid and serene setting. The cemetery facilities now cover 12 acres and over 100 years of local

Fair Oaks The Way it Was (1976) recounts: "In the early 1890s, a man, a representative of

the Howard & Wilson Publishing Co., which was seeking land for a colony, rode up a trail along the American River and was greatly impressed with the beauty of the land, especially a stand of mossdraped oaks along the north shore of the river. He had found his site. It was known as 'Sunset Colony' and was later named Fair Oaks because it looked like Fair Oaks, Virginia." The publishing


company purchased 9,000 acres and helped settle the area known today as Fair Oaks, California.

Pioneers from the Midwest and East with names such as Slocum, Straith, and McClatchy were families that helped establish Fair Oaks and the surrounding expanse. The Fair Oaks Bridge and the arrival of the railroad spurred growth, and Fair Oaks became known as the crown of the Sacramento Valley in the heart of California. A local publication of the period, The Tattler quipped: "Now that we have two M.D.s, the people have concluded that we need a cemetery." Two and one half acres at Olive Street and New York Avenue were purchased for the sum of \$250.00 from S.E. Keifer for use as a cemetery. Bylaws were drawn up and lots were apportioned to the stockholders. Fair Oaks Cemetery Association President C. H. Slocum allocated the remaining plots for future



A strong can-do attitude is a accomplishments. potent force in your quest for accomplishment. If you have any doubt, consider the alternative, a can't-do attitude? Anyone harboring a can't-do attitude is guaranteed of their results; nothing will work.

### **IRS Phone Scam Calls Continue**

issued a consumer alert providing taxpayers with additional tips to protect themselves from telephone scam artists calling and pretending to be with the IRS.

These callers may demand money or may say you have a refund due and try to trick you into sharing private information. These con artists can sound convincing when they call. They may know a lot about you, and they usually alter the caller ID to make it look like the IRS is calling. They use fake names and bogus IRS identification badge numbers. If you don't answer, they often leave an "urgent" callback request.

"These telephone scams are being seen in every part of the country, and we urge people not to be deceived by these threatening phone calls," IRS Commissioner John Koskinen said. "We have formal processes in place for people with tax issues. The IRS respects taxpayer rights, and these angry, shake-down calls are not how we do business."

The IRS reminds people that they

The Internal Revenue Service can know pretty easily when a supposed IRS caller is a fake. Here are five things the scammers often do but the IRS will not do. Any one of these five things is a tell-tale sign of a scam. The IRS will never:

- 1. Call you about taxes you owe without first mailing you an official
- 2. Demand that you pay taxes without giving you the opportunity to question or appeal the amount they say you owe.
- 3. Require you to use a specific payment method for your taxes, such as a prepaid debit card.
- 4. Ask for credit or debit card numbers over the phone.
- 5. Threaten to bring in local police or other law-enforcement groups to have you arrested for not paying.

If you get a phone call from someone claiming to be from the IRS and asking for money, here's what you should do:

If you know you owe taxes or think you might owe, call the IRS at 1.800.829.1040. The IRS workers can help you with a payment issue.

If you know you don't owe taxes or have no reason to believe that you do, report the incident to the Treasury Inspector General for Tax Administration (TIGTA) at 1.800.366.4484 or at www.tigta.

If you've been targeted by this scam, also contact the Federal Trade Commission and use their "FTC Complaint Assistant" at FTC.gov. Please add "IRS Telephone Scam" to the comments of your complaint.

Remember, too, the IRS does not use email, text messages or any social media to discuss your personal tax issue. For more information on reporting tax scams, go to www.irs.gov and type "scam" in the search box.

young men of color are valued and that they have an opportunity to pursue their boldest dreams in a space where they know we are our brother's keeper," said Rev. Ross.

The DZ is tailored to the ways that teens like to socialize and spend their free time. The DZ has all the high tech computer equipment and entertainment systems that are commonly enjoyed by young people. There is an internet café with free internet access and Wi-Fi.

For recreation and friendly competition, youth can play air hockey, pool, or play video games. Teens can lounge and watch movies on a drop screen movie projector with surround sound. There is also a customized spoken word poetry and karaoke stage for youth who want to express their creativity in these ways.



# **Patriots in Season Opener**

RANCHO CORDOVA, CA (MPG) - A mixture of passing and rushing scores on offense, tossed with a dash of defense, gave the Cordova High School football team a 14-7 season opening win over Pioneer at Lancers Stadium on Aug. 29th.

The Lancers rushed the ball 35 times and passed 30 times against the Patriots' defense. "We played a very balanced game," said Cordova head coach Vance Mueller. In the second quarter, Cordova (1-0) scored its first touchdown of the game when lineman Terion Guichard scored on a 1-yard burst up the middle.

"We use him in our goal-line package as an extra blocker," said Muller of the senior lineman. "We (Lancer coaches) told for all of his hard work he's going to get to carry the ball sometimes. We handed him off. and he just bulled everybody over for the score."

The first Lancer touchdown of the season was also Guichard's first score of his high school football career. "He was super excited," said Mueller of Guichard's first touchdown of the game and career.

In the third quarter, Lancer junior quarterback Unique Perez tossed a 60-yard pass to Devin Baldwin. The extra-point missed for the Lancers, but expanded their lead to 14-0.

"We just ran a quick fade route against (Pioneer's) coverage," said Mueller of the Lancers' scoring drive. "It was just a nice throw. It was a perfect throw and a good route, and he (Perez) was able to get into the end zone."

Four times in the game, Pioneer had the ball inside Cordova's territory, and went for it each time on fourth down. But

### **MARCUS MEETS MICHIGAN STATE**

Oregon's explosive offense must solve the retooled Michigan State defense

#### MICHIGAN STATE AT OREGON

Michigan State has emerged as the team to beat in the Big Ten, but the Spartans will need to defeat Oregon - or at least look really good in a close loss - to be considered a serious threat to make the College Football Playoff. Oregon, however, might be able to afford a loss, even at home, and still remain in the national title hunt. The Ducks simply have more good teams on their schedule, and thus, more opportunities for quality wins to impress the selection committee. Even with some questions at wide receiver, Oregon still boasts a breathtaking collection of skill-position players, but the Ducks will need to prove they have the physicality at the line of scrimmage to handle Michigan State. Oregon's issues with Stanford — which plays a similar style to MSU — the past two seasons are well-documented, but it

USC beat Stanford 20-17 in Los Angeles last season, snapping a four-game losing streak to the Cardinal. The Trojans have not won in Palo Alto since 2008. The question, as the season progresses, is whether the Trojans have the depth to handle the week-to-week grind of the Pac-12. #### **VIRGINIA TECH AT OHIO STATE**

The first game with redshirt freshman J.T. Barrett wasn't a work of art, but the Buckeyes survived with a 34-17 win over Navy. Barrett completed 12-of-15 passes for 226 yards with two touchdowns and one interception and added 50 yards rushCharlie Strong wasn't the head coach at Texas last season, but he is well aware of what happened on the Longhorns' visit to BYU in early September. Brandon Doughty, the Hilltoppers' senior QB, led the way with 569 yards and six touchdowns (with no interceptions) against a Bowling Green team that led the MAC in total defense in 2013. ... Keevan Lucas enjoyed a huge 2014 debut, catching

13 passes for 233 yards (more than half of his total last season) and three touchdowns to help Tulsa survive in Week 1 with a 38-31 win in double overtime over Tulane.
