Attendees will experience the rocking music of headliner Vanishing Affair, The Soft White Sixties, The Rudy Parris Band (as seen on The Voice), Once An Empire, Alex Vincent Band, and The Driftwood Sinn.

The Play it Forward benefit concert is for the 21 and older crowd and features no host drinks and food from Sacramento food trucks courtesy of SactoMoFo.

Tickets are available at www. PlayItForwardBenefit.com. General admission tickets are \$25. VIP tickets are \$60 and include food, drinks, and a private seating area. Parking is free.

The event is presented by Leadership Rancho Cordova Class 8, a program to prepare Rancho Cordova leaders to make a difference in the community. Proceeds benefit the purchase of musical instruments at Cordova High School, Mitchell Middle School, and Mills Middle School in Rancho Cordova.

"Many students who live in Rancho Cordova are being turned away from music programs because there aren't enough instruments" said Michael Luca Leadership Rancho Cordova representative. "We want to support these children and make their dreams of music come true."

several other vintage World War II airplanes. It will be FIFI's first visit to Sacramento in many years. The airplanes will be on display at Mather Jet Center, 10510 Superfortress Drive in Sacramento from Thursday, June 5th through Sunday, June 8th. Visitors will be able to tour the bomber cockpit and also purchase rides in all of the visiting aircraft.

The Boeing B-29 Superfortress, first flown in 1942, began active service in 1944 and is best known as the aircraft whose missions over Japan helped bring about the end of World War II. It was designed as a replacement for the older B-17s and B-24s, with longer range and greater bomb loads. The B-29 was also used in the Korean War in the early 1950s and was a staple of the U.S. Air

Force until the late 1950s.

FIFI, celebrating her 40th year of flight with the Commemorative Air Force (CAF) in 2014, will visit local airports in Arizona, California and the Northwest United States this summer as the feature aircraft in the CAF AirPower History Tour. The tour brings aircraft, pilots and crews from over 60 CAF units located throughout the country together to create an ever changing assortment of touring military aircraft. These aircraft are powerful history lessons bringing the sights, smells and sounds of World War II aviation to audiences across the United States.

The cost for admission is \$10 for adults

and \$5 for children ages 10 through 17. Children under 10 are free. All of the airplanes will be on static display when they are not flying. B-29 cockpit tours are included in the admission price and rides are available in all of the airplanes. Ride prices range from \$75 to \$1795. Ride reservations may be made at www.AirPowerTour.org where additional information about the tour stop can also be found.

The Commemorative Air Force honors the men and women who built, maintained and flew in these airplanes during World War II. The organization believes that is best

accomplished by maintaining the airplanes in flying condition and taking the airplanes to the people, allowing them to experience the sight and sound of the aircraft in flight.

CAF's B-29 Superfortress, FIFI

FIFI was acquired by the CAF in the early 1970s when a group of CAF members found her at the U.S. Navy Proving Ground at China Lake, California where she was being used as a missile target. The airplane was rescued and restored and flew for over thirty years until 2006 when the chief pilot made the decision to ground her pending a complete power plant re-fit. What followed was an extensive four year restoration that included replacing all four engines with new custom built hybrid engines. FIFI returned to the sky in 2010 and since that time has traveled coast to coast, attracting large crowds at every tour stop. Learn more about FIFI and her tour schedule at www.AirPowerTour.org.

P-51 Mustang

The P-51 is one of the most revered fighters in WWII and possibly the greatest airplane ever designed. It entered service in Europe in the spring of 1944

as a primary long-range escort fighter. It held 1,880 rounds of .50 (fifty) caliber in six guns, a flying range of 1,650 miles with external drop tanks, and a top speed of 440 mph at 30,000 feet. Mustangs were a deadly opponent in battle and destroyed 4,950 enemy aircraft in the air, more than any other US fighter in WWII. P-51s were flown in the pacific theater by the end of 1944 and escorted B-29s on long range missions to Japan. More than 13,500 P-51s were built and flown in the U.S. Air Force into the mid 1950s.

flying vintage historical aircraft for more than half a century, the Commemorative Air Force ranks as one of the largest private air forces in the world. The CAF is dedicated to Honoring American Military Aviation through flight, exhibition and remembrance. A non-profit educational association, the CAF has more than 10,000 members and a fleet of over 150 airplanes distributed throughout the country to 67 units located in 27 states for care and operation. Actually Uncle Sam isn't the only one who wants you to do something for your country or your community – there is your church and school and park and many other places where people are needed. And working for them, you would be giving back to your country in some way. But the "catch", I believe, is that there is a need to start a "draft" again. And for anyone who is old enough to remember the old draft, please read (as Paul Harvey said) the rest of the story because I am talking about a different or new kind of a draft.

The draft I am envisioning would include being drafted into service to your country. However, there would be choices in how you would give back to your country. You could choose to join the military for two years if that would be your choice but you could also work for your community, your church, or school, or you could volunteer for many other things in which dedicated people are needed. And this new draft would include both MEN and WOMEN.

Uncle Sam Wants You! The reason I have been mulling this idea over in my mind for years is that the old-style draft did two positive things for each person who was drafted. They

HAD to learn about themselves and they were forced to give time and service to their country. They HAD to work with people they wouldn't otherwise work with because they didn't have a choice. They HAD to get up every workday and go to work (no choice). They HAD to learn how to do a job (or many jobs); then they had to do it (no choice); and they HAD to do things they didn't want to do, like pick up pieces of trash, for

instance (no choice). This new draft, as I said earlier, would include both MEN and WOMEN and they would be drafted for two years. During that time they would have to work for the community or the hospital or other places on a designated list – or the military, if that was their choice. The military today is composed of all volunteers. The last time the draft was instituted, it lasted from 1940 to 1973. Since then, everyone in any branch of the service is part of the all-volunteer military force. The Selective Service System (draft's official name) would remain in existence but its mission would be changed to not only include both men and women but to also fill jobs other than just the military. The age to be drafted in the past was from 18 to 25 years old. Whether that would remain in place or not would have to be decided on.

Also, who wouldn't be eligible for the draft would be different. In the past for instance, if you had flat feet you didn't qualify for the military. In the new draft program except for the military, flat feet wouldn't disqualify a person from doing something else – people would be eligible to work and help their country in another way. One thing that wouldn't change is that those who were drafted would be paid by the U.S. government for those two years.

Financially this idea is 180% away from what the Federal government wants to do today. We don't have the money we are told, so we have to cut the budget of everything. Spending money to create jobs, puts the energy and creativity that American citizens still have back to work; plus a new draft system would help improve what people think of themselves. I think this new draft idea would be much better than continuing down the negative and destructive path some of our leaders are trying to force us down today. I guess this is a lot to chew on – but think about it. \star From Vice Mayor Bob McGarvey, God bless, and see

Mileage Tax Would Put Big Brother in Your Back Seat (and Within Arm's Reach of Your Wallet)

California is known as the world capital of the car culture. The automobile played a central role in creating the California Dream, giving people the freedom to travel, to live where they choose and to experience the exhilaration of the open road.

Now, if Senator Mark DeSaulnier gets his way, you'll have to pay a new tax for every mile you drive. His Senate Bill 1077 would begin with a "pilot program" in one unfortunate yet-to-be-determined city where motorists would pay taxes based on the miles driven. Eventually, the Democrat from Concord hopes to impose his mileage tax on all of us.

Just as many Americans are

expressing concerns about government surveillance programs that intrude on their privacy (think red light cameras and the NSA), the mileage tax would give state transportation bureaucrats access to data on where you go.

Sen. DeSaulnier contends that the state needs the data to calculate your taxes but will keep the information safe. However, in the last year California state agencies, including the departments of Public Health and Social Services, were responsible for data breaches that compromised the personal information of thousands of Californians.

Also, while SB 1077 is obviously a tax increase, DeSaulnier and his tax-raising buddies are trying to say it is a "fee" and not a tax. They know if they get away with calling it a "fee" they can pass it with a simple majority vote and increase it anytime they wish, all without needing to comply with Proposition 13's requirement that higher state taxes receive a two-thirds vote of the Legislature.

This mileage tax will fall especially hard on those who live in suburbs or exurbs and have to commute long distances to work and it will discourage people from taking vacations. Instead of feeling free to explore, Californians will have to take a government meter with them, dinging them with more taxes every mile they travel.

State policies have become

increasingly hostile to drivers over the years and the mileage tax would just make things worse. California has the highest gas taxes in the nation and gas prices are second only to Hawaii which, given its location in the middle of the ocean, makes fuel transportation expenses unavoidably high. California, sitting on huge oil reserves, can't claim that excuse.

And even with ridiculously high taxes on gas that are supposed to be dedicated to roads, a Reason Foundation study ranks our state 47th out of 50 (with 50 being worst) for worst roads in the nation. This is because Sacramento politicians have continually raided gas tax funds to spend on unrelated pet projects.

Free and fast movement of goods and people facilitates economic growth. High taxes and congested roads only harm our economy and frustrate hard working citizens who simply want to get where they need to go. Sacramento must stop its bait and switch tactics with the gas tax and make better use of the considerable funds already provided. DeSaulnier's proposal is just another tax increase and it takes us in the wrong direction. ★







RANCHO CORDOVA, CA (MPG) -Four months ago, the Cordova High School baseball team prepared for the season thinking it could win the Capital Athletic League-and the Lancers were the only ones who seemed to believe they could accomplish that feat.

Some of seniors on this year's team who played a major role were Nigel Robinson, who batted .367, Dominic Gentry, .295 and Tylor Myers, .259. Jerome Brown led the team in stolen bases with 27

On the mound, Zachary Tapia led the Lancers' pitching staff with a 5-2 record. Myers followed

with an ERA of 1.97.

Seven of this year's 15 players are expected to return in 2015 that include sophomore infielder/ pitcher Jarrett Harris and freshman catcher/infielder Logan Appino. Harris finished this season with a .362 batting average, and Appino was close behind at .328.

"Those are two good guys to build your team around," Anderson said.

In addition to winning the CAL title and earning the top playoff seed, Anderson won his 900th career win, in a CAL game at Antelope, on April 4 in which Cordova posted a 10-2 win over the Titans. That win puts him in second place as the

all-time winning coaches among California high school varsity baseball coaches. Anderson, 81, just finished his 42nd season as the Lancers' head coach.

Next season. Cordova returns to the Sierra Valley Conference, which is now Division IV. When the Lancers' athletic programs were in the SVC from 1996 to 2010. it was D-IL

Cordova will join Rosemont, which leaves the Metro Conference, in the SVC, along with El Dorado, Union Mine, Galt and Liberty Ranch, Galt's second high school.

"It will be interesting going into that new league," Anderson said. "I'm looking forward to it." ★

Interfaith Council Awards Honors at Power of One Banquet

RANCHO CORDOVA, CA (MPG) -The Interfaith Council of Greater Sacramento paid tribute to four honorees at this year's Power of One 2014 banquet on May 15. The Sacramento Cordova Stake of The Church of Jesus Christ of Latter-day Saints provided the venue. More than 200 people attended representing a variety of religions, traditions and organizations.

Recipients of this year's awards given to members of the Interfaith Council for outstanding service in the community included Mary Wesley, Pastor Rick Cole, Dr. Ephraim Williams, and Beth White.

Wesley has been a humanitarian and a doer all her life, involved in many functions in the interfaith arena, and has been president of Jericho Foundation for several years.

"The Interfaith Council brings to the table the issues that affect our community and our greater human needs," Wesley said. "Our concerns overlap and our voices mingle."

Rick Cole of Capital Christian Center took over the pulpit from his father, Pastor Glen Cole, who founded the Sacramento area's first megachurch 34 years ago. Rick Cole sees two important ingredients in the work and purpose of the Interfaith Council.

"One is to break down barriers of misunderstanding among faith groups so that we can appreciate one another and celebrate the work each is doing in our community," Cole said. "The other is to encourage collaboration in our efforts to meet the needs of the underserved in our community."

Williams, pastor of St. Paul Missionary Baptist Church, said that having multiple groups assisting in projects builds positive relationships.

"There are several urgencies within the Sacramento area," Williams said. "(One is to) give one-on-one guidance and assistance to help our young people in the areas of education, citizenship,

and how to become a responsible adult. (Another is) to help guide people to become aware of God and establish a relationship with Him."

White is now pastoral associate at Our Lady of Assumption Parish of the Catholic Church in Carmichael, after 12 years as associate director of Catholic Charities of Sacramento.

"I consider her in the same league as Mother Teresa," said the Rev. Michael Kiernan of the Roman Catholic Diocese of Sacramento, "living the gospel here in Sacramento, serving the downtown poor, refugees, immigrants and others in her Catholic Charities work."

The Interfaith Council also presented a "Giving Back to the Community" award of \$2,500 to Women's Empowerment of Sacramento, represented by Kate Towson.

The evening began with music by the Camerata Chamber Choir of Sacramento, directed by Mary Wesley, and the Folsom Lake Youth Choir.

Youth of the LDS church, attired in black and white, served dinner and attended tables throughout the evening.

Brandon Singer, 17, who attends Del Campo High School, was one of the many Mormon youth who received training the night before and helped out that evening. Someone asked Singer if he didn't have a problem spending his Wednesday and Thursday nights doing this.

"No, in our church we're very prone to giving service," Singer told the person. "It was great to be able to see all these different religions meet under one roof. With all the publicity you hear about all these different religions not liking each other – being able to see everybody communicate with one another in one building was great. I was just grateful for the organization that puts this on."

The Interfaith Council of Greater Sacramento was incorporated in 1911 as the Federation of Churches. Jon Fish, a member of the LDS church, is president of the council, and served as master of ceremonies for this event.

"I had 'in person' compliments; I have had phone calls today, and two dozen e-mails all commenting on the quality of it all," said Fish. "Each time they say it was so 'beautiful' and 'elegant' and 'well managed.' Everyone was pleased with the young people serving. 


