## Legal Drama Sparks Arena Debates

*McGinness to Moderate Third Debate As Arena Issue Intensifies* 

**SACRAMENTO REGION, CA (MPG)** - The consequences of a June vote on Sacramento's arena funding will be the topic for Arena Debate 3, the third town hall discussion between John Hyde and R.E. Graswich. The debate takes place onTuesday, February 11, at Belle Cooledge Library, 5600 South Land Park Boulevard, 7 - 8 p.m. Doors open at 6:30 p.m.

"The events unfolding around the arena petition are unprecedented," said Hyde, "and despite media attention, there's still a lot of misinformation circulating. It's critical that the community understands what's really at stake in this election."

Hyde is a former spokesperson for STOP (Sacramento Taxpayers Opposed to Pork), the group seeking to place the sports subsidy question before voters.

Graswich, former Special Assistant to Mayor Kevin Johnson and author of the new book on the Sacramento Kings, "Vagrant Kings," takes the opposite side, arguing against a public vote and citing the City Clerk's rejection of STOP's petition due to "major" legal flaws.

"The vote is a sham designed to kill the arena and run the Kings out of town," Graswich said. "Even if you don't like the Kings, you'd better know the consequences of sending the team and their \$1 billion investment down the river to San Jose or a more welcoming city."

Former Sacramento County Sheriff John McGinness will moderate Arena Debate 3, which is sponsored by Inside Publications. Former City Council members Lauren Hammond and Rob Fong

SACRAMENTO, CA (MPG) - As California experiences one of the driest winters on record, the California Natural Resources Agency, the California Environmental Protection Agency, and the California Department of Food and Agriculture released the final California Water Action Plan, laying out goals and vision for the next five years. The plan will guide state efforts to enhance water supply reliability, restore damaged and destroyed ecosystems, and improve the resilience of our infrastructure.

At the direction of Gov.

Edmund G. Brown Jr., a collaborative effort of state agencies, and nearly 100 substantive public and stakeholder comments formed a plan to set direction for a host of near- and long-term actions on water issues for the state.

"It is a tall order. But it is what we must do to get through this drought and prepare for the next," said Gov. Brown in his 2014 State of the State address.

The Governor's proposed 2014-15 budget lays a solid fiscal foundation for implementing near-term actions for the plan, recommending \$618.7 million in funding for water efficiency projects, wetland and watershed restoration, groundwater programs, conservation, flood control, and integrated water management.

"As we work on emergency actions to manage through one of the driest winters on record, we are also taking proactive, longterm steps to prepare California for future droughts and flood," said Secretary for Natural Resources John Laird. "Each decade brings improvements, but also significantly highlights what we can do better. The California *Continued on Page 12*







RANCHO CORDOVA, CA (MPG) - February art projects at the Sacramento Children's Museum (SCM) in Rancho Cordova will feature making valentine cards, masks, and puppets. February will also be Pop-Up Science Month and will include Science Sundays.


But the big news is that Story Factory that features a theater and stage will be installed in the Museum. For those who aren't familiar with the "The Rime of the Ancient Mariner," "water, water every where" is part of the poem which was written in 1797-1798 by Samuel Taylor Coleridge. In the poem, the mariner's ship is becalmed and while there is ocean water, there is no water to drink.

We aren't quite that desperate, but the water shortage in California is forcing decision makers to look at new avenues of "what can we do." The biggest change that the drought has forced them to do hasn't been considered nor thought of for decades. There will be no water being sent to Southern California from Northern California. And this time, we aren't looking at the water wars of the past in which voting power or money power was the decision maker. When there is no water to send, neither votes nor money will create more H2O.

Building more dams and finding other ways to save and store the water when it does rain is up for legislative review again. Saving the water we have will need both State and Federal legislation and they need to get some things done that will help us when the winter is as dry as this one is. The weather this weekend is predicted to include rain. I hope the weather forecasters are right because every rain drop in the valley and every

snow flake in the mountains are more precious than gold. And having legislators do nothing except argue is not acceptable!

I have family members who live in Indiana and like at least of two thirds of the United States, they are either receiving extra rain or are freezing because of the storms coming down from the Arctic. The only thing for sure with the weather is change. And the change isn't what is expected or predicted. I have a weather rock that has a 50-50 chance of being right half of the time. For example if it is wet, it's raining; if it is swinging, the wind is blowing; if it casts a shadow, the sun is shining; if it is coated with ice (like the water fountain in front of our house was last December), it's

below 32 degrees; if it can't be seen, it is either night time or it's foggy; if it's under water, there is a flood; and if it's missing, there was a tornado. Those are only a few examples of how accurate the weather rock is or can be, but it is also fun.

Many people saw Punxsutawney Phil, the famous groundhog weather prognosticator, see his shadow on Groundhog Day and foretell of six more weeks of winter. 



Cordova jumped out to a 19-16 lead after the first quarter. But Antelope made a run in the second quarter to tie the game at 29-29 at halftime. Roberson had the hot hand for the Lancers, scoring 34 points. Coles followed with 13 and Hendrix 12. Chris Johnson followed in scoring with nine, Brewer four and Bolden three. "He (Roberson) played an outstanding defensive game," said Johnson of Roberson, a guard. "He played a strong game."

Johnson feels when more than one Lancer scores in double figures, the end result will be a victory. "Anytime we get three or more people in double figures we're playing real well," Johnson said.

Cordova was almost perfect at the free throw line; the Lancers made 16-of-19 shots from the charity stripe. They also pulled down 42 rebounds. Crawford, a fifth-year senior who flirted with transferring in the offseason, averaged 23.5 points and 6.5 rebounds in the two wins. The Wildcats, under first-year coach Chris Collins, have won three straight Big Ten road games for the first time since the 1959-60 season.

# Ask the Editors McDermott continues to shine

Who was the Player of the Month in college basketball in January?

Mitch Light: 1 didn't overthink this one; it's Doug McDermott from Creighton. The frontrunner for National Player of the Year honors, Mc-Dermott was sensational during January, averaging 26.1 points and 6.1 rebounds while shooting over 50 percent from the field. He started the New Year with a 30-point, 10-rebound performance in a win at Seton Hall and capped it off with a seasonhigh 39 points — including the game-winning three with 2.5 seconds remaining — in a 63–60 victory over St. John's.

David Fox: Even though Doug McDermott is a virtual certainty for National Player of the Year, my top player of January is one of the few players in the Big East who can match McDermott's scoring prowess. Bryce Cotton of Providence has been one of the most underrated players in the country, but the Friars are on the precipice of their first NCAA bid in a decade thanks to Cotton's play of late. Cotton averaged 21.7 points and 6.3 rebounds in a month that saw Providence beat Georgetown, Creighton and Butler. Even more, Cotton has been a workhorse, averaging 41.1



Creighton's Doug McDermott was terrific in the month of January and heads into the

stretch drive as the favorite to be named National Player of the Year.

Surprising Texas improved to 6–2 in the Big 12 with a convincing win over Kansas on Saturday. The Longhorns have defeated Iowa State, Kansas State, Baylor and KU in the last four games. Not bad for a team picked to finish anywhere from eighth to 10th in the Big 12 in the preseason. K-State has slipped to the middle of the pack after a hot start in the league (4–1), but this team is tough to beat in Manhattan.

#### MICHIGAN AT IOWA

lowa can play its way back into the Big Ten race if it takes care of business this week at home against Ohio State on Tuesday and Michigan on Saturday. Michigan lost for the first time in Big Ten action on Sunday at Indiana, but the Wolverines — with a road win at Michigan State in their back pocket — still have to be considered the team to beat.

#### BAYLOR AT OKLAHOMA

Baylor stopped a five-game losing streak with a surprising — and potentially season-saving — win at Oklahoma State last Saturday. This team has enough talent to work its way back into the NCAA Tournament picture. Oklahoma's roster isn't as impressive as Baylor's, but the Sooners have the advantage on the bench — Lon Kruger is one of the game's elite coaches.

#### NORTH CAROLINA AT NOTRE DAME

The Tar Heels have recovered from a disastrous start in ACC play and once again appear to be a team capable of winning some games in the NCAA Tournament. Notre Dame has struggled to remain relevant in the ACC without Jerian Grant, who was lost for the season due to academics. Mike Brey's team is very tough to beat at home — the Irish knocked off Duke in South Bend on Jan. 4 — but Carolina has the decided edge in talent.

#### CINCINNATI AT SMU

It's gone largely unnoticed, but Cincinnati is off to a 10–0 start in the new American Athletic Conference. The Bearcats, who already have wins at Memphis and Louisville, will be tested on Saturday at suddenly relevant SMU. The Mustangs, under the guidance of Larry Brown, improved to 6–3 in the American with a resounding win over Memphis last weekend. SMU is closing in on its first NCAA Tournament appearance since 1993.

#### PROVIDENCE AT XAVIER

Providence and Xavier are among a pack of teams fighting for third place — behind Creighton and Villanova — in the new-look Big East. Both teams feature star power, with Bryce Cotton leading the way for Providence and Semaj Christon continuing to shine at Xavier.

#### OREGON AT ARIZONA STATE

This is a key game between two middle-of-thepack Pac-12 teams who figure to be fighting for at-large bids to the NCAA Tournament. Arizona State rebounded from a slow start in league play and is now 5–4 with a three-game homestand looming. Oregon stopped the bleeding with a win over USC at home on Saturday, but the Ducks have not played well since the end of December.

#### MISSOURI AT OLE MISS

Two of the nation's most feared 3-point shooters will be on display in Oxford this weekend when Marshall Henderson and the Rebels host Jabari Brown and Mizzou. Henderson's overall shooting percentage is down from last season, but he's been more accurate from 3-point range despite attempting more shots per game. Brown, the SEC's leading scorer (20.4 ppg), is shooting 47.7 percent from beyond the arc.

but the Cougars are getting great production from Haws. A junior guard from Alpine, Utah, Haws averaged 35.5 points while shooting 59.5 percent from the field to lead BYU to wins over Pacific and Saint Mary's last week. He is averaging 24.6 points.

#### YOGI FERRELL, INDIANA

With Indiana desperate for a quality win, Ferrell delivered in the clutch, scoring 27 points to lead the Hoosiers' offense and helping slow down Michigan's Nik Stauskas on the defensive end of the floor. Ferrell hit 8-of-10 from the floor, including 7-of-8 from 3-point range, in Indiana's most important win of the season.

#### TREVOR COONEY, SYRACUSE

Cooney drilled a school-record nine 3-pointers and scored a career-high 33 points to help No. 1 Syracuse to a tougher-than-expected 61–55 win over Notre Dame just two days after the Orange's epic overtime win over Duke. Cooney, a sophomore guard, is shooting 43.6 percent from 3-point range and averaging 14.1 points.

**Braden Gall:** Few players had as good of a start to the 2014 calendar year as Cincinnati's Sean Kilpatrick. First of all, the Bearcats went 9–0 in conference play during January, highlighted by wins at Memphis and Louisville. Kilpatrick scored 18 in the road win over the Tigers and 28 in the road win over the Cardinals. On the month, the Cincy sharpshooter averaged 20.1 points and 4.8 rebounds and shot 86 percent from the foul line. In addition, he had just nine turnovers in the final seven games of the month.

# Bigger surprise: Texas (6–2 in the Big 12) or Virginia (8–1 in the ACC)?

Light: Anyone who watched Virginia in the month of December has to be stunned that the Cavs are off to such a fast start in the ACC. In a four-

day stretch in early December, Virginia scored 38 points in a loss at home to Wisconsin and lost at Green Bay. Then after closer-than-expected wins over Northern Iowa and Norfolk State, Virginia was blasted by 35 points at Tennessee. Since that debacle in Knoxville, the Cavs are 8-1, with the only loss coming by three points at Duke. The emergence of sophomore guard Malcolm Brogdon as a consistent scorer has been a huge key. Since failing to score in 21 minutes in the loss at Tennessee, Brogdon has averaged 15.2 points, with a low of 11 against Florida State and a high of 18 against Virginia Tech. Virginia is done with Duke and North Carolina, and only has to play Syracuse once - at home. Don't be shocked if this team stays in the ACC title hunt until early March.

Fox: Texas is perhaps the biggest surprise of any team since conference play began. With a new athletic director and diminishing results in recent years, Rick Barnes appeared to be on his last leg with the Longhorns. Entering the season, the Horns did not have the look of a team ready to compete in a deep Big 12. The roster had been shed of most of its highprofile recruits - and it's worth mentioning those prospects didn't really pan out anyway. In reality, though, Texas shed itself of malcontents and egos. The Longhorns have become a legit team in the Big 12 and a threat to advance in the NCAA Tournament thanks to the out-ofnowhere emergence of Jonathan Holmes, the arrival of freshman point guard Isaiah Taylor and development of Cameron Ridley.

# Dignity Health Gives \$846,014 in Grants to Help Thousands in Need

by contributions from Dignity Health's member hospitals. In the Greater Sacramento region, Dignity Health hospitals that contribute to the grants program are Mercy General Hospital, Methodist Hospital, Mercy San Juan Medical Center, Mercy Hospital of Folsom, Woodland Healthcare and Sierra Nevada Memorial Hospital.

Grant funding is awarded according to specific criteria and restricted to the specific programs proposed.

To foster collaboration this year, Dignity Health's hospitals in the Sacramento region asked nonprofit

organizations to submit partnership proposals that provide a continuum of care for specific target populations.

#### Grant awards went to the following organizations:

- 1. El Hogar Community Services, Inc., Elica Health Centers and Asian Community Center will focus on providing needed services and care to underinsured and uninsured individuals with behavioral health challenges in hospital emergency departments by providing mental health, substance abuse, transportation, navigation and support services, and primary health care.
- 2. Pacific Trauma Specialist of Folsom and Partners in Care of El Dorado County will provide a broad spectrum of additional support for those patients discharged from the hospital but still having to manage the complexities of their terminal illness at home.
- 3. Health and Life Organization, Inc., Hmong Women's Heritage Association, Capitol

Health Network, Southeast Asian Assitance Center and La Familia Counseling Center will work together to improve culturally specific health access for underserved Hmong, Mien, Vietnamese and Latino populations.

- 4. Health for All, Volunteers in Victim Assistance, Health and Life Organization, Inc., United lu-Mien Community, Inc. and Crime Victim Assistance Foundation (iCAN) will in partnership provide victims of violence and their families with medical, dental, mental and social services that can help them cope with the devastating after effects of trauma, with a focus on prevention and education.
- 5. Sierra Foothills AIDS Foundation and Cares Community Health aims to increase access to dental care for people living with HIV/ AIDS in Sacramento, El Dorado and Placer counties.
- 6. Loaves & Fishes/Genesis Mental Health, Downtown Sacramento Foundation, Community Link and Transitional Living and Community Support, Inc. will link Sacramento's disabled and long-term homeless to medical and behavioral health services, creating a homeless health care access portal for the chronic homeless.
- Grant awards were also made to the following organizations and partnerships in Yolo County:
- 1. Suicide Prevention and Crisis Services in Yolo County and Yolo Community Care Continuum will work together to identify individuals calling

a 24-hour crisis phone line who are in need of immediate stabilization, residential care and other support services.

2. Citizens Who Care for the Elderly and Rural Innovations in Social Economics (RISE) will provide no cost support services to older adults and families coping with the challenges of various stages of dementia, ranging from early memory loss to advanced dementia.

Grant Awards were made to the following organizations and partnerships in Nevada County:

- 1. Domestic Violence and Sexual Assault Coalition and the Friendship Club will work collaboratively on a program that focuses on the integration of behavioral health and primary care to vulnerable populations.
- 2. Western Sierra Medical Clinic (WSMC), FREED Center for Independent Living and Community Recovery Resources will work together on initiatives that provide access to primary care and preventative services for vulnerable populations.

Since the program's inception in 1990, Dignity Health hospitals have made grant awards for nearly 3,000 projects, totaling almost \$47 million. Grant recipients are required to complete a detailed grant proposal outlining the purpose and scope of the project to be funded, as well as the population to be served, the project's outcomes, plans for its long-term operation and measurement of success. Projects must be in the area of health care and related social services. \*

# Final State Water Action Plan Released: Outlines California's Near- and Long-Term Water Priorities

Water Action Plan gives us clear focus and vision for the next five years."

Final revisions to the draft plan, released in October, include an expanded section on drought response and a new effort focused on better management of Sierra Nevada headwaters that helps water storage and quality, and ecosystems. Public comment on the draft plan made it clear that California must better understand the economic and ecological harm of sustained dry weather. The Governor's proposed budget would provide \$472.5 million in Proposition 84 funds to the Department of Water Resources (DWR) for integrated regional water management. The bond funds would leverage local and federal investment in projects that reduce demand, build supply, and offer additional benefits such as wildlife habitat and flood management. The budget also placed immediate emphasis on water and energy use efficiency and wetlands and coastal watershed restoration to further support the resiliency of water supply and ecosystems during this dry weather period.

The governor's budget also would allow DWR to better monitor the groundwater resources that

provide more than one-third of California's supplies in dry years, and supports the development of a state backstop for sustainable groundwater management practices by the State Water Resources Control Board, should local efforts to do so not materialize.

"Together, the Governor's proposed budget and this finalized plan provide the State with practical solutions to the state's most critical problems; the proposals on groundwater are a good example," said Cal/EPA Secretary Matt Rodriquez. "Data collection and monitoring are crucial to sustainable management of our unseen but incredibly important aquifers."

All of the near-and long-term actions in the plan center on sustaining supplies of water for people, the environment, industry and agriculture. This year's severe dry conditions highlight the stakes. Drought threatens to force the fallowing of hundreds of thousands of acres of farmland, throw thousands of people out of work, and potentially raise supermarket food prices.

"Our severe dry conditions are alarming for California's agricultural industry," said California Department of Food and Agriculture Secretary Karen Ross. "In the near term, we must do all we can to keep our fields productive. In the long term, we have a once-in-a-generation opportunity to make the investments that will allow us to stay productive in the face of a changing climate."

Key actions identified in the Plan include:

- Make conservation a California way of life.
- Increase regional self-reliance and integrated water management across all levels of government.
- Achieve the co-equal goals for the Delta.
- Protect and restore important ecosystems.
- Manage and prepare for dry periods.
- Expand water storage capacity and improve groundwater management.
- Provide safe water for all communities.
- Increase flood protection.
- Increase operational and regulatory efficiency.
- Identify sustainable and integrated financing opportunities. ★


