**CITRUS HEIGHTS, CA (MPG)** - It is good to be back! Following two years of low attendance and modified programs, all voiced their appreciation to be back at the Sylvan Cemetery on May 30, 2022, to honor those who had given all they had for others to be alive and free.

The Harmony Express men’s choral group was back with its many patriotic songs throughout the service.

Hosted by American Legion Post 637, member and Master of Ceremony Paul Reyes welcomed all veterans and guests. County Supervisor Sue Frost, a Citrus Heights native, returned to this venue to honor those veterans who gave their lives for their country. She acknowledged and thanked Regent Deborah Bartlett of the John A. Sutter Chapter of the Daughters of the American Revolution for their work.

Later in the morning Bartlett

gave a history of DAR and its purpose which includes “promoting patriotism, preserving American history and securing American’s future through better education for children.” She described Memorial Day as the “most poignant federal holiday.” All veterans who had served during the Vietnam War period, whether in Vietnam or at home between November 1, 1955 and May 15, 1975 were honored with a special

## Council to Review Security Measures for School Shootings

**CITRUS HEIGHTS, CA (MPG)** - After the recent school shooting in Uvalde, Texas – and far too many of such tragic events at other schools in recent years – school safety is a top concern for many citizens. At the May 26 Citrus Heights City Council meeting, Councilmember Bret Daniels said, “We saw what happened in Texas,” and asked the Council to support the formation of a committee that “examines the safety and security of schools in the Citrus Heights area and makes any recommendations for enhancements.”

While Councilmember Daniels said he doesn’t have any specific safety concerns about local schools, he made it clear that ensuring the safety of Citrus Heights students must be a priority: “I just want to see if we can make things even better in Citrus Heights.”

The security of the schools is the responsibility of the San Juan Unified School District, so Councilmember Daniels wants the Council to work together with the District to review existing security measures. “It’s a good opportunity to come forward and see if we can find a way to do things better for our kids in Citrus Heights.” He said the committee might find that no changes are needed, or it “might also just open some eyes about something we could do better.”

Councilmember Daniels asked that the Council move quickly on this idea over the summer so that any recommendations could be implemented before the next school year.

Councilmember Steve Miller said, “You can’t be too prepared. ... They’re our kids and we need to protect them.”

With overwhelming support from the Council, this issue will be presented as an action item on an upcoming agenda. ★

## County’s Response to Homelessness

**SACRAMENTO COUNTY, CA (MPG)** - Sacramento County is actively engaged in multiple strategies to provide services that unhoused residents need to transition into safe, stable housing.

In Fiscal Year 2021/2022 alone, we have invested nearly \$50 million in homeless specific programs, services, shelter, re-housing and data infrastructure to serve our community, with funding from the American Rescue Plan Act (ARPA), the Mental Health Services Act (MHSA) and the County’s General Fund, among others.

**Notable projects this year include:**

Safe Stay community developments - providing on-site services, security and re-housing to move people from unsheltered homelessness into housing and other supportive services while providing much needed respite to the neighborhoods through a reduction in trash, tents, violence and blight.

Encampment Service teams: Comprised of Outreach navigators, re-housing staff and clinical staff to

provide behavioral health assessments and referrals for those living in encampments.

Additional investment of the construction of Marisol Village – an affordable housing project slated to add an additional 116 units to the final project.

Invested three years of funding to greatly expand Coordinated Access (CAS), a powerful collaboration designed to ensure that homeless persons and persons at risk of

homelessness are matched, as quickly as possible, with the services that will most effectively end their homelessness. This funding provides for increased coverage at 211, and new field-based staff to assist households into crisis support services and rehousing.

Landlord Engagement and Re-Housing Supports: conducting outreach and educational events to recruit landlords and expand the availability of

rental units; investment in incentives such as sign-on bonuses, move-in assistance, vacancy loss payments, etc. to support landlord retention; and increasing flexible rental subsidies to improve the efficacy of voucher and homeless housing subsidy programs.

Funding 60 beds through December 2024 to support the Parkway Navigation team, prioritizing those exiting the portion of

## California Water Boards News Release

**SACRAMENTO, CA (MPG)** - In response to Governor Gavin Newsom’s March 28 Executive Order the State Water Resources Control Board adopted an emergency water conservation regulation that will ensure more aggressive conservation by local water agencies across the state.

The new regulation bans irrigating turf at commercial, industrial, and institutional properties, such as grass in front of or next to large industrial or commercial buildings. The ban does not include watering turf that is used for recreation or other community purposes, water used at residences or water to maintain trees. The regulation also requires all urban water suppliers to implement conservation actions under Level 2 of their Water Shortage Contingency Plans.

In March 2022, the state’s urban retail water suppliers reported average water use statewide that was nearly 19% greater than in March 2020, lowering the state’s cumulative water savings since July 2021 to 3.7%. On May 23, 2022, Governor Newsom convened leaders from the state’s largest urban water suppliers imploring them to take more aggressive action to combat drought.

“The severity of this drought requires all Californians to save water in every possible way,” said Joaquin Esquivel, chair of the State Water Board. “The regulation compels water systems and local authorities to implement a range of additional critical conservation measures as we enter the hot and dry summer months.”

Level 2 water shortage contingency plans are meant to address up to a 20% shortage of water supplies. In addition to implementing Level 2 actions, the regulation requires urban water suppliers to fast-track supply and demand assessments to plan for potential

extended dry conditions.

Level 2 actions often include things such as: Limiting outdoor irrigation to certain days or hours; Increasing patrolling to identify water waste; Enforcing water-use prohibitions; Increasing communication about the importance of water conservation.

Some water suppliers already have imposed strong new restrictions on customers’ water use in accordance with their drought management plans. However, about half of the state’s 436 water suppliers (both urban water retailers and wholesalers) have not yet activated Level 2, and 36 have not submitted drought plans. The emergency regulation will require suppliers without drought plans to take certain conservation actions, such as conducting outreach to customers about conservation, restricting outdoor irrigation to two days a week and enforcing against wasteful water practices.

The approved regulation will be submitted to the Office of Administrative Law (OAL) for approval, which typically occurs within 10 calendar days. The ban on non-functional turf becomes effective upon OAL approval and the Level 2 requirements for urban water suppliers are proposed to take effect on June 10, 2022.

The regulation will give suppliers new options to reduce water waste if they choose to use them. A violation of the non-functional turf irrigation provision, for example, would be an infraction and subject to a fine of up to \$500.

# 1 Man Killed, Another Wounded in Apartment Shootout

**CITRUS HEIGHTS, CA (MPG)** - A Citrus Heights man is dead and another is seriously wounded following a shootout in the late hours of May 23 at an apartment complex in Citrus Heights.

According to the Citrus Heights Police Department, several 911 calls were made around 10:55 p.m. on Monday, May 23, reporting fired gunshots in the 6000 block of Birdcage Street at Farmgate Way, west of Sunrise Boulevard and south of Greenback Lane.

A 20-year-old man suffering from multiple gunshot

wounds was found in the walkway of the apartment complex when officers arrived on the scene, according to a CHPD news release. The wounded man, whose name has not been released, was rushed by ambulance to a local medical facility in critical condition.

A second 20-year-old man was found dead at the scene with multiple gunshot wounds inside a nearby apartment, according to the CHPD. On May 25, the Sacramento County Coroner’s Office identified the name of the man who died in the shootout as Jacob Steven Lopez of

Citrus Heights.

Investigators believe the shooting wasn’t random and that the two men who were shot likely knew each other. According to the CHPD, preliminary information revealed both men appeared to be shooting at one another. The 6000 block of Birdcage Street was closed for several hours overnight as investigators evaluated the crime scene.

# 3 People Injured In Citrus Heights Stabbing

**CITRUS HEIGHTS, CA (MPG)** - Three people were injured in the early hours of May 15 after a stabbing in Citrus Heights, according to the Citrus Heights Police Department.

CHPD received 911 calls around 4:30 a.m. on Sunday, May 15, regarding a stabbing that occurred near businesses in the 6100 block of Auburn Boulevard in Citrus Heights near Greenback Boulevard and Greenback Lane. Two teenagers, a 16-year-old and a 17-year-old, along with one adult received treatment at a local hospital after each were stabbed multiple times.

Police suspect that the stabbing occurred

following a verbal dispute between two groups of people. The suspect, who is at large, is described as a Caucasian or Hispanic male, around 6-foot tall, skinny, with short hair and facial hair. The suspect may have been joined by a Caucasian woman wearing glasses.

Two days later on Tuesday, May 17, CHPD published a security camera image on social media of the man they presume could be the person who committed the stabbing. # Mountain Mike’s Vandalized, Again

**CITRUS HEIGHTS, CA (MPG)** - A local Mountain Mike’s restaurant in Citrus Heights was vandalized for the second time in four months on May 8 and the store’s owners fear it may be a hate crime.

Dave Brar has been the owner of Mountain Mike’s off Sunrise Boulevard and Antelope Road for 22 years. Brar believes the recent attacks on his restaurant may be racially motivated as he and his family are of Punjabi descent.

On Sunday, May 8, shortly after 4:11 a.m. a

man in a hoodie is seen on security camera footage arriving at the restaurant and singling it out as the only store in the shopping center that he attacked. According to Brar, 31 windows and three doors were vandalized. Nothing was stolen from the restaurant.

This was the second time in four months that the Mountain Mike’s location had been attacked. On Jan. 10, two men are seen on security camera footage pulling up to the restaurant in a white pickup truck and smashing six windows. Brar has other local businesses that have also been vandalized recently. The incidents

have left customers feeling unsafe when arriving at and departing from the restaurant, leading to Brar’s business suffering.

According to the Citrus Heights Police Department, the attack does appear to be targeted, although there is not any evidence at this time indicating that the vandalism is a hate crime. Investigators are searching for the suspects and anyone with information is encouraged to contact the CHPD at (916) 727-5524. # California Expands Infant Formula Options for WIC Families

**SACRAMENTO, CA (MPG)** - To further support California families while supplies of infant formula remain limited, the California Department of Public Health (CDPH) is adding a new flexibility by expanding purchasing options for the WIC (Women, Infants and Children) program. Effective immediately, families with WIC benefits have eight additional formulas, and a total of 13 options, they can purchase for their infants.

WIC families can find the latest updates at MyFamily.WIC.ca.gov or the California WIC App and should contact their local WIC office with questions on how these options work for infants. General information on the infant formula shortage is available at [cdph.ca.gov/formula](http://cdph.ca.gov/formula).

“We are quickly doing what we can to provide our WIC families with as many infant formula options as possible during this challenging time,” said CDPH Director and State Public Health Officer Dr. Tomás J.

Aragón. “In the coming days we will also add more formulas to this list.”

The state’s action temporarily expands the existing (WIC) authorized product list to include additional infant formula options. These newer options will be removed once infant formulas are widely available again.

**Safety Information for Families in Need of Formula**

Many California families are feeling the effects of the formula shortage. Safe formula preparation is vital to ensure infant safety.

Non-WIC parents and caregivers who face a

shortage should call their health care providers first to help them navigate infant formula options when supplies are scarce.

Parents and caregivers are advised to NOT dilute formula or use homemade recipes for substitution as this can seriously harm a baby’s health.

Babies usually tolerate alternative formula products except in the case of special therapeutic formula, and that’s why it’s important to consult with your healthcare provider first to get help or to discuss alternatives.

Vietnam War lapel pin and a certificate. Surviving spouses of Vietnam veterans who had died also received a pin.  
Post 637 Commander Sylvia Thweatt shared the fascinating history of Arlington Cemetery in Washington DC and the land it was built on, beginning in 1857 until today.  
Jim Monteton Sylvan Cemetery Board Trustee and member of American Legion Post 637 took us from the first colonist’s delivery of the Declaration of Independence to King George back home, through all the wars in American history and how, despite great loss of life, our fighting men and women have gotten stronger and stronger with more resolve to keep America free. Nearly 400 million members of our military have given their lives for us. Many that do return home safe become police officers and firefighters. Americans are tough and use their strength not only for themselves but to answer the call when needed in other countries. There are over 1,400 veterans from the Civil War to Vietnam buried at Sylvan. Many are husbands and wives, both veterans.

Two local veterans had interesting

stories. Thomas Gresham had served from 1966 to 1967 as an Entertainment NCO on the USS Bennington. He escorted entertainers including Bob Hope, Nancy Sinatra, Hank Snow and Oral Roberts to Vietnam entertainment venues.  
Air Force veteran Michael Coughlan, served throughout the East Coast from 1957 the 1961. He read a poem which he had written for Memorial Day 2014. He felt privileged to read it at the beginning of the service voicing his deep-felt appreciation and honor for those who had given their lives so he could live free. Here are several sentences from that poem titled “I Never.”  
“I never had to say goodbye and go away to fight a war. I never felt that terror as my friends were dying beside me. I never saw death’s face staring at my soul nor felt the ecstasy of victory as I waved our flag atop a bloodied hill. The ones that were there did that for me and forever are gone. No, let us never forget and let us never stop thanking them from our heart’s deepest depths that are even beyond our soul. ★

# New Fitness Center You Can ‘Bank’ On

**CITRUS HEIGHTS, CA (MPG)** - A former Bank of America branch in the Grand Oaks Shopping center in Citrus Heights is the new home of the Camp Transformation Center (the Camp) opening soon at 7965 Auburn Boulevard in Citrus Heights.

Its franchisee-owner, Andre Benavidez, said the new specialty gym will open to new members in late June.

“We’re just waiting on our final occupancy permit from the city,” Benavidez said. He will then schedule a public grand opening celebration and ribbon cutting event with the Citrus Heights Chamber of Commerce.

Benavidez, who is a successful Roseville commercial and residential real estate investor and developer, watched his own health suffer and his weight increase with each new project he took on.

Emerging from the pandemic, Benavidez vowed to make some health and dietary changes. He took on The Camp’s weight loss challenge program. In six weeks, he dropped over 30 pounds. Not soon after, he applied for a Camp franchise for himself in Citrus Heights and started scouting for a gym location.

The new 5,000 square foot Citrus Heights Camp Transformation Center will be the second Sacramento franchise location for the Southern California fitness chain. Renovation work began last summer.

Current tenants in the 28,928 square foot Grand Oaks Shopping Plaza, built in 1958 on 3.3 acres along Auburn Boulevard in Citrus Heights, include Grand Oaks Bingo, Charlie’s Café, World Appliances, Dollar General, Mary’s Thrift Store and

Yummy Tummy, a Greek-American family restaurant which opened in January.

The historic plaza also once served as the temporary home of the Citrus Heights City Hall in 2015, before the new city hall was built.

Inside, the interior was gutted, and a cushioned athletic floor has been installed. Colorful new motivational murals were painted and both gym equipment and free weight stations have been put into place ready for members to use. Both the original bank vault and door remain.

The new Citrus Heights Camp Transformational Center does not offer its members personal lockers or shower facilities. “Our members will come here to work out,” Benavidez said. Founded in 2010, The Camp has nearly 150 locations in more than a dozen states.

Marketing materials describe the company’s signature challenge, a combined six-week motivational weight loss and fitness starting point for its members as “a transformative moment in the lives of those who join, and

a launching pad for long-term membership.”

In the 20-week “Challenge,” participants agree to participate in 42 workout sessions in six weeks, setting their own fitness and weight loss goals as they follow a meal plan.

“The challenge encourages members both to be accountable, and show up for their workouts,” Benavidez said.

Once the member has achieved a desired goal, they can move on to another challenge. Success is measured as progress towards a reduced body mass index (BMI).

Benavidez said he will hire between 5-6 employees for core staff and will then add part-time certified trainers as membership grows. Candidates should “enjoy being a part of a team, and who have the interpersonal skills to work closely with individual members to achieve their fitness and weight loss goals.”

“We want our members to know they have a committed team working beside them,” he said.

Multiple membership

pricing tier options will be available, he said. Membership allows participants to take either morning or evening classes with no limits.

“We don’t want to cap the number of classes a customer can take. The more motivated a member is to achieve their fitness goals, the more classes they may want to enroll in.”

Opening cost of \$107 founding Camp membership allows the member to participate in its 21-day challenge.

Benavidez said he looks forward to becoming “fully involved and engaged in the greater Citrus Heights community which the new Camp will serve.” He’s also hopeful the upcoming Camp Transformation Center will also contribute to the success of city’s broader revitalization goals for Auburn Boulevard.

# Citrus Heights Teen Killed in Carmichael Shooting

**CARMICHAEL, CA (MPG)** - A Citrus Heights teenager was found dead following a shooting at a large apartment complex party in the 4400 block of Manzanita Avenue in Carmichael on May 28.

According to the Sacramento County Sheriff’s Office, 911 calls began incoming at 1:15 a.m. in the early hours of Saturday morning, May 28. The victim was identified as 17-year-old Mesa Verde High School 11th grader Antonio Rocha by the school’s Principal Jennifer Petersen.

Sac County Sheriff’s deputies arrived on scene at The Continental Apartments complex and found Rocha suffering from a gunshot wound. He was later pronounced dead at the scene by Sac Metro Fire and there is currently

no suspect as the investigation is still ongoing according to the sheriff’s office.

This is not the first time a minor has been shot and killed at a complex on the 4400 block of Manzanita Avenue. In 2018, a 16-year-old was shot and killed by a 13-year-old on the same block according to the sheriff’s office.

A GoFundMe page has been set up by Rocha’s godfather to help support the family with funeral service costs. The fundraiser has currently raised over \$23,000. According to the page, Rocha was a two-sport athlete who played football and wrestling.

the Parkway between Interstate 5 and Highway 160. The Salvation Army will provide 24/7 staffing, food, laundry, case management and re-housing supports, with an annual goal of rehousing 180 people who previously lived on the Parkway.

Mental Health Services Act (MHSA) Housing Program adding 60 units that provide a continuum of interventions including homelessness prevention, flexible housing funds, rapid rehousing, and permanent supportive housing for persons experiencing both homelessness and mental health issues. These units are on top of a recent \$27.3 million in No Place Like Home (NPLH) funding to build/renovate 137 additional dedicated apartments. Another \$9.5 million in NPLH funding is currently under State review to build an additional 37 dedicated apartments.

Additionally, working with our partners in all our cities is crucial to address the issue. Sacramento County and the City of Sacramento in particular must remain focused on addressing issues together, taking into account our responsibility to constituents, stakeholders and our homeless neighbors.

The County and City of Sacramento have collaborated for the past several years to identify and pursue opportunities to partner on projects that will serve the homeless population in the most efficient and effective way possible. While there are many good ideas to address the immediate and long-term needs around homelessness, not every project is feasible.

For example, the City and County were recently exploring a large site to potentially purchase and renovate as shelter with on-site wrap around services for

people experiencing homelessness. After careful consideration, the County decided not to pursue the project for multiple reasons, including the cost of the real estate, the limitations imposed by the property owner that would interfere with provision of critical services and the relatively small number of people who would be served for such a large investment. The County has multiple sheltering projects under consideration for a similar or lesser amount of funding that will serve greater numbers of people over the long term and result in permanent exits from homelessness.

Critical to our success is the ability to partner with the City of Sacramento – and the other six cities in our jurisdiction – but also weighing the benefits and drawbacks of every dollar spent with the end goal of reaching every person experiencing homelessness. The County is ready to support projects and programs that are aligned with evidence-based approaches to addressing homelessness.

Sacramento is facing an unprecedented crisis of homelessness in our community. This crisis cannot be pinpointed to one specific cause, rather a myriad of complicated issues including a housing affordability gap, the impacts of COVID-19 and the overwhelming need for mental health and drug and alcohol rehabilitation services.

The Point-in-Time count results will likely show a significant increase in unhoused residents in Sacramento County. Now more than ever, the County and cities can work side by side to address this crisis. Together we are stronger, more effective and more capable of success.

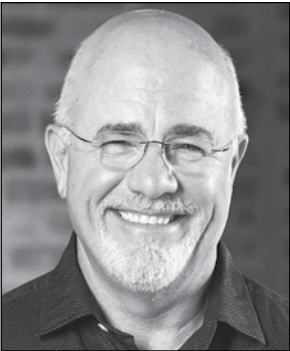


Above: Dad in Hollywood when he worked for MGM. Below: Later years but still going strong. Photos courtesy Mary Jane Popp

# Congress Is Going After the Alleged Price Gougers — Again

As Yogi Berra, baseball’s preeminent wit and philosopher, would say, “It’s déjà vu all over again.” Fifteen years ago, I wrote in this space about an attempt by Congress to impose additional taxes on oil companies at a time of high gasoline prices.

Last Thursday, the U.S. House of Representatives did it again. It passed “The Consumer Fuel Price Gouging Prevention Act” by a vote of 217-207. Four Democrats and every Republican voted against the bill. The bill would empower the federal government – specifically, the Federal Trade Commission – to fine oil companies if they increase prices in an “excessive” or “exploitative” way (without, in typical congressional vagueness, bothering to define what constitutes “excessive” or “exploitative”).

It is sad that members of Congress who voted for this bill are raging against oil companies when what is really causing the problem is the inexorable economic law of supply and demand. Gasoline prices are uncomfortably high now, not because oil companies are headed by unusually greedy individuals, but because supply is not keeping up with demand.

Consider, if you will, another big market in the U.S. economy – the housing market. The media are full of reports of soaring prices for houses in various parts of the country, often explaining that the price explosion is because supply is not keeping up with demand. What would you think of a federal law imposing a tax on homeowners who take advantage of current market conditions to sell their house for what would have been considered a ridiculously high price just a year ago? You would rebel in righteous indignation, I hope. After all, it is your house, your property, and you should be free to sell it at whatever price you can get in the marketplace. Are homeowners who are receiving top dollar for their houses behaving “exploitatively?” Of course not. That is just the way the real estate market is right now. How is that different from what is happening in the oil market? It isn’t different at all; it’s simply the law of supply and demand at work. The only difference is that some members of Congress believe they can get away with taxing oil companies, whom they routinely demonize, while they know that if they tried to tax homeowners on windfall profits derived from the sale of their homes, they would be voted out of office.

One tactic that the anti-price gouging crowd in Congress is employing against

oil companies is to accuse them of deliberately keeping production low and supplies tight. Rep. Katie Porter (D-CA), one of the co-sponsors of the fuel price gouging bill, asserted, “Big Oil is threatening our entire economy by keeping supply low and jacking up prices at the pump.” Similarly, Rep. Frank Pallone (D-NJ), the chair of the House Energy and Commerce Committee, said, “The problem is Big Oil is keeping supply artificially low so prices and profits stay high.”

In the first place, nobody has the right to dictate to a business how much they should produce (well, not in a free-market system based on property rights; under socialism, government does in fact issue such commands). But what makes blaming oil companies for cramped supplies so offensive here is that the Biden administration is in the forefront of efforts to curtail the production of oil.

I wrote twice last year (here and here) about specific anti-oil production policies that the Biden administration has adopted, and those policies haven’t changed a bit. In fact, just a few days before Reps. Porter and Pallone tried to blame oil companies for tight oil supplies, the administration canceled oil leases in the Gulf of Mexico and Cook Inlet. Existing leases are being held in regulatory purgatory by bureaucrats refusing to approve a green light for actual production. A few days ago, Senator Joe Manchin (D-WV) commented that 16 months after the Biden administration announced a pause on granting new oil exploration leases, “we still have no new leases,” and, “it has become crystal clear that the ‘pause’ is in fact a ban.”

With President Biden accompanying his aggressive anti-fossil fuel policies with equally aggressive rhetoric about sharply reducing, if not ending, Americans’ consumption of fossil fuels within the next decade or so, one can understand why oil companies might be hesitant to spend billions to ramp up production. Why should they risk huge losses if that production is going to be shut down not too long from now? Without commenting on if or how fast the U.S. economy should shift from fossil fuels to various “green” modes of energy, the present question is whether the current government policy of impeding the production of oil is hurting us more than it is helping. What do you think?

# CAL FIRE Awards Nearly \$118 Million in Wildfire Prevention Grants

## CAL FIRE News Release

**SACRAMENTO, CA (MPG)** - As part of California’s strategy to prepare properties and communities against the devastating impacts of wildfires, CAL FIRE announced it will direct nearly \$118 million in funding for 144 local wildfire prevention projects across the state.

“Drought conditions have once again taken hold of California and are already contributing to another year of early fire activity,” said Joe Tyler, CAL FIRE Director and Fire Chief. “This funding is a critical part of our overall wildfire strategy.”

CAL FIRE’s Wildfire Prevention Grants enable local organizations like fire safe councils, to implement activities that address the hazards of wildfire and reduce wildfire risk to communities. Funded activities include hazardous fuel reduction, wildfire prevention planning, and wildfire prevention education. These projects all meet the goals and objectives of California’s Wildfire and Forest Resilience Action Plan, as well as the Strategic Fire Plan for California.

In Los Angeles County, the San Gabriel Valley Council of Governments is one of many organizations receiving funding towards wildfire prevention efforts. Their project will work towards developing a Regional Wildfire Protection Plan that will help to protect over 31 cities and communities, 22 of which are identified as “Communities at Risk”. In Lake County, a grant has been awarded to the Robinson Rancheria Band of Pomo Indians for a hazardous fuels reduction project in the wildland-urban interface that will

incorporate professional training as well as a community outreach and education campaign to increase awareness of defensible space and fuels management. In El Dorado County, a grant has been awarded to the El Dorado Fire Safe Council for a project that will assist residents with hazardous tree removal to slow the spread of the bark beetle infestation. The project will also assist with removing stressed and injured trees damaged by the Caldor Fire.

“These 144 local wildfire prevention projects, along with the 105 projects we just funded in September 2021, will significantly increase California communities’ preparedness towards wildfires,” said Chief Daniel Berlant, CAL FIRE Deputy Director of Community Wildfire Preparedness and Mitigation.

The Wildfire Prevention Grants Program is funded as part of the State’s Wildfire and Forest Resilience Strategy, in part with Cap-and-Trade auction proceeds administered by the California Climate Investments (CCI) Greenhouse Gas Reduction Fund. CCI is a statewide program that puts billions of Cap-and-Trade dollars to work reducing greenhouse gas emissions, strengthening the economy, and improving public health and the environment - particularly in disadvantaged communities. These grants are part of the Governor’s unprecedented \$1.5 billion investment in wildfire resilience. The Governor’s Wildfire Resilience initiative has launched 588 projects to date, in addition to projects to be funded by these grants. ★

# We Can Make School Shootings Mostly Vanish

In no school massacre was an officer of the law on the scene in time to stop the first killing. But one person always is – a teacher or school staff member. If but one faculty or staff in the room, or close by, had a concealed weapon to defend their students and themselves and did so, school massacres would mostly vanish for the same reason the Uvalde, Texas Police Department stood down. Reportedly, they were afraid. This is the most reasonable solution to potential school massacres.

How do I know with certainty that this is the most reasonable solution. Because the teacher is likely to be in the room when a shooter arrives and also his first victim. Thus he /she has two motives that ensures his/her action: self-preservation and the preservation of the students he knows and is responsible for. No policemen has a greater motivation to action than this teacher.

Years ago a gunman entered a classroom in a high school immediately adjacent to the college where I was teaching and opened with a 12 gauge shot gun on two classmates that for years had bullied him. The first was wounded severely but survived, the second he missed. Both schools, the high school and the college next door, went into immediate lockdown.

In my college classroom, as in most, there was but one door, which opened outwardly and could be locked only from the outside. Everyone inside, including me the professor, has been set up by his own government and school board to be a victim. If this were the assailants first classroom no one could possibly get to the door in time to lock it from the outside.

For years my only defense was to ask students sitting on the door side of the room, upon hearing gunfire from outside the room, to lineup next to the wall, remove the fire extinguisher from

the wall next to the door that opens outwardly, and spray or hit the intruder as he enters. Those behind him then were to overwhelm the intruder after the distraction, but this is all that we could do and it likely would not be enough. Since my students were adults this could work with a lot of luck. Again, if we were a killer’s first classroom such is, in fact, a “free kill zone.”

In a college that refused to be a gun free zone a teacher or other adult with a concealed weapons permit, need only pull out a weapon from pocket or purse and fire a couple of rounds at a very surprised – then very dead potential killer saving several minutes (in the case of Robb Elementary School in Uvalde Texas, over an hour) of indiscriminate slaughter. Instead, 19 children and 2 adults were killed while up to 19 law enforcement agents declined to enter.

But in a grade school fewer adults are in the room to save all. Still, if but one armed concealed weapons permit holder, had been in the classrooms or close by, a custodian, a secretary, a parent assisting the teacher, he/she could have saved up to 21 lives. This is the reason shooters prefer grade schools – no real resistance.

Why not have employee permit holders do so on school grounds as well, allowing them to be an asset of protection wherever they are? They are on the scene, care for their students, are a trusted profession in society, and, most importantly, are themselves threatened. It would cost the school little or nothing. Chances are every school has several concealed weapons permit holders among its faculty and staff already. Again, why not let those who wish to protect their students do so?

This is not to suggest that every teacher must participate – only those who wish to. Hundreds of regular permit holding citizens in my previous county in California, already carried concealed weapons permits, as did I, everywhere except in gun free zones (others call “free kill zones”). Such is the same in most counties throughout the nation. Law enforcement normally see permit holders as an asset, the ultimate backup should they need extra help, and also because cops know they can’t be everywhere at the same time, as some Uvalde, Texas residents learned the hard way. Why

not let them be an asset of protection wherever they are; on school grounds as well? Some, like myself, would gladly participate in protecting those whom they serve.

Permit holders are among our finest citizens. Obtaining a concealed weapons permit requires a thorough investigation, a near perfect record from law enforcement, sometimes a stated need to carry, and some training. Normally they are older more mature folks and, in the case of teachers, society already trusts their young people to them several hours a day. They are already on the scene where a policeman could not possibly be. What a deterrent to a would-be killer if he knew schools are not so vulnerable.

Why not tell him so with a sign at every approach to the campus and every office door, in large print? “ATTENTION Please Be Aware that the Staff at (your school name) May Be Armed And Will Use Whatever Force is Necessary to Protect Our Students” (X22 Reports, EP. 2784B, May 26, 2022, 23:00). School shootings would mostly vanish.

Gun free zones clearly do not work as most massacres in the United States happen in them and law breakers do not care about the law. Anticipating no resistance, rather than deter, they entice killers giving them access to large groups of unprotected and innocent victims – usually children.

Most gunmen ceased their killing rampage only when confronted with another gun. Next time have that person be a teacher or staff member with a concealed weapon, and a vested interest in his and the safety of those around him, whose immediate action would allow so many more students to live. Only a few need to be armed. Assailants do not know who is, thus behave as though everyone is. Like the Uvalde police, they “don’t go in because they do not want to be shot.”

# DWR Offers Grants to Protect Communities, Support Fish Populations and Restore Streams

## DWR News Release

**SACRAMENTO, CA (MPG)** - The Department of Water Resources (DWR) on Wednesday, June 1, released the final Guidelines and Proposal Solicitation Package for the Riverine Stewardship Program, which provides funding to plan and implement projects that will reduce flooding, improve water quality, and restore streams, creeks, and rivers to enhance the environment for fish, wildlife, and people.

As communities and wildlife alike face challenges posed by climate extremes and California’s ongoing drought conditions, the program will award up to \$15 million in competitive grants to implement projects that help reduce flood risk, increase water supply, and enhance and restore fish populations and habitat. The funding will be delivered through the Riverine Stewardship Program and its two subprograms the Urban Streams Restoration Program (USRP) and the San Joaquin Fish Population Enhancement Program.

All three programs will help support watersheds, local wildlife, and aquatic habitat. Eligible projects include habitat restoration, bank stabilization, water

temperature improvements and habitat enhancements to increase water supply reliability to help fish adapt to climate change.

“Climate change is driving multiple threats to California including the severe drought conditions that challenge our communities and fish populations alike,” said DWR Director Karla Nemeth. “This funding supports a local and state partnership to make our communities and their streams more drought resilient for people and fish.”

Both the Riverine Stewardship Program and San Joaquin Fish Population Enhancement Program are funded by Proposition 13, while the Urban Streams Restoration Program is funded by Proposition 68, 84, and state budget general funds.

During the 2019 solicitation, DWR awarded \$54.4 million in competitive grants to 20 projects that improve habitat and spawning conditions for fish species, reduce flood risk to property and local communities, and more. The Urban Streams Restoration Program, which has funded projects for 35 years, recently celebrated ribbon cutting ceremonies for previously completed restoration projects located in Santa Barbara, Berkeley,

and Santa Rosa.

Applications will be accepted starting June 1, 2022, and funding is available for Tribes, local public agencies, and certified non-profits as specified in the program guidelines and proposal solicitation package. Other applicant types such as community groups will be considered on a case-by-case basis. For-profit corporations, non-public entities, and individual landowners are not eligible. The released guidelines will also address future funding that may become available to DWR through the 20222023 Budget Act to address drought resilience and aquatic habitat improvements.


The Urban Streams Restoration Program also provides funding and technical assistance for public engagement, outreach, and underrepresented community support. DWR encourages community participation in project design and implementation to promote educational opportunities to community members of all ages and increase understanding of the project’s benefits.

# California Saw 3.8% Increase in Used Car Purchases During COVID-19

**SAN DIEGO, CA (MPG)** - Inflation has been the dominant story in the U.S. economy for most of the last year. Year-over-year increases in the Consumer Price Index have reached their highest levels in 40 years, with consumers paying more for expenses from food to housing to energy. And one of the categories that has consistently seen the highest price increases in this inflationary period is vehicles, both new and used.

While the early months of the COVID-19 pandemic saw lower demand for vehicles as people avoided travel and commuting, the vehicle market has rebounded strongly since the second half of 2020. COVID-related concerns and transitions to remote or hybrid work have put a dent in public transit ridership, and instead, more former transit users have opted to buy cars. Low interest rates, strong government stimulus, and a rebounding economy have given many households the wherewithal to make vehicle purchases.

A lingering challenge, however, has been supply. COVID-19 outbreaks over the last two years have disrupted global supply chains, and carmakers have been particularly hard hit. Obtaining parts like semiconductor chips has been more challenging, and backlogs at ports worldwide have made it harder to ship new vehicles. In total, manufacturers produced approximately 1.7 million fewer vehicles in 2021 than 2019, and with a limited number of new vehicles hitting the market, used models are selling at a significant premium.

According to data from the U.S. Bureau of Economic Analysis, per capita annual spending on used cars jumped 10.9% between 2019 and 2020, from \$460 to \$510. This increase was the second highest single-year increase in nearly 25 years. The new vehicle market is historically prone to larger swings but spending on new vehicles only increased by about 2.1% from 2019 to 2020, from \$870 to \$889.

Car shoppers in some locations have felt the effects of these price increases more than others. Typically, residents of the central U.S. tend to spend the most on both new and used vehicles annually. Residents in these locations are typically more car-dependent because their rural geography puts more distance between people and communities. While residents of less car-oriented locations can spend less or put off vehicle purchases more easily, their car-dependent peers spend more, and now are carrying the extra burden of rising prices.

The data used in this analysis is from the U.S. Bureau of Economic Analysis's Personal Consumption Expenditures. To determine the states with the biggest increase in used vehicle purchases during COVID-19, researchers at CoPilot calculated the percentage change in total used car spending between 2019 and 2020. In the event of a tie, the state with the greater total change in used car spending over the same period was ranked higher.

The analysis found that used car spending in California increased by 3.8% during the pandemic, a total change of \$439.8M. Here is a summary of the data for California:

• within 24 hours of receiving this order sell to, or store with, a licensed gun dealer or turn in to a law enforcement agency any guns or other firearms within his or her immediate possession or control.

• within 48 hours of receiving this order file with the court a receipt that proves guns have been turned in, sold, or stored. (Proof of Firearms Turned In, Sold, or Stored (form DV-800/JV-252) may be used for the receipt)

• bring a copy of the receipt or Proof of Firearms Turned In, Sold, or Stored (form DV-800/JV-252) to the hearing listed in item 3.

9. The protected person(s) have the right to record communications made by the restrained person that violate the court's orders.

13. Transmittal order. The data in this order must be transmitted within one business day to law enforcement personnel. This order must be entered into the California Restraining and Protective Order System (CARPOS) through the California Law Enforcement Telecommunications System (CLETS).

b. The court or its designee will transmit a copy of the order to a local law enforcement agency authorized by the Department of Justice to enter orders into CARPOS through CLETS.

14. Service of temporary order

b. The restrained person was not present at the time the order was made. This order must be served.

15. Service of this notice of hearing must be at least five days before the hearing.

Warnings to the Restrained Person

If you do not obey these orders, you can be arrested and charged with a crime. You may have to go to jail or prison, pay a fine of up to \$1,000, or both. Taking or hiding a child in violation of this order is subject to state and federal criminal penalties.

You cannot have guns, firearms, or ammunition. If the box in item 5a is checked, the court issued a temporary restraining order, which means you cannot own, have, possess, buy or try to buy, receive or try to receive, or otherwise get guns, other firearms, or ammunition while the order is in effect. If you do, you can go to jail and pay a \$1,000 fine. You must sell to, or store with, a licensed gun dealer or turn in to a law enforcement agency any guns or other firearms that you have or control. The judge will ask you for proof that you did so. If you do not obey this order, you can be charged with a crime. Federal law says you cannot have guns or ammunition while the order is in effect.

Service of order by mail. If the judge makes a restraining order at the hearing that has the same

orders as in this form, you will get a copy of that order by mail at your last known address, which is written in item 2. If this address is not correct, or to find out if the orders were made permanent, contact the court.

Instruction for Law Enforcement Applicable only if the box in item 5a is checked.

Enforcing the restraining order. This order is effective when made. It is enforceable in all 50 states, the District of Columbia, all tribal lands, and all U.S. territories, commonwealths, and possessions and shall be enforced as if it were an order of that jurisdiction by any law enforcement agency that has received the order, is shown a copy of the order, or has verified its existence on the California Law Enforcement Telecommunications System (CLETS). If proof of service on the restrained person has not been received and the restrained person was not present at the court hearing, the law enforcement agency shall advise the restrained person of the terms of the order and then shall enforce it.

Conflicting orders Priorities for Enforcement.

If more than one restraining order has been issued protecting the protected person from the restrained person, the orders must be enforced in the following order (see Pen. Code, § 136.2 and Fam. Code, §§ 6383(h)(2), 6405(b)):

1. EPO: If one of the orders is an Emergency Protective Order (form EPO-001) and it is more restrictive than other restraining or protective orders, it has precedence in enforcement over all other orders.

2. No-Contact Order: If there is no EPO, a no-contact order that is included in a restraining or protective order has precedence in enforcement over any other restraining or protective order.

3. Criminal Order: If none of the orders includes a no-contact order, a domestic violence protective order issued in a criminal case takes precedence in enforcement over any conflicting civil court order. Any nonconflicting terms of the civil restraining order remain in effect and enforceable.

4. Family, Juvenile, or Civil Order: If more than one family, juvenile, or other civil restraining or protective order has been issued, the one that was issued last must be enforced.

Certificate of Compliance with VAWA for Temporary Orders

This temporary protective order meets all full faith and credit requirements of the Violence Against Women Act, 18 U.S.C. § 2265 (1994) (VAWA) upon notice of the restrained person.

This court has jurisdiction over the parties and the subject matter; the restrained person has been or will be afforded notice and a timely opportunity to be heard as provided by the laws of this jurisdiction. This order is valid and entitled to enforcement in all jurisdictions throughout the 50 United States, the District of Columbia, all tribal lands, and all U.S. territories, commonwealths, and possessions and shall be enforced as if it were an order of that jurisdiction.

# Capitol Democrats Again Reject Lower Gas Prices

## Assembly Republicans News Release

**SACRAMENTO, CA (MPG)** - On May 25, 2022, Assembly Republicans gathered in front of a local gas station ahead of a pivotal vote to suspend the gas tax. For the third time this year, Democrats struck down any efforts to lower gas prices as they continue to escalate. Ahead of Memorial Day weekend travel, Republicans wanted to put forward a bipartisan solution that would have passed on savings to consumers at the pump, though Democrats continued to play party politics and were not in favor of hearing this legislation on the floor.

Assembly Republican Leader James Gallagher (R-Yuba City) was joined by colleagues Assemblyman Kevin Kiley (R-Rocklin), Assemblywoman Laurie Davies (R-Laguna Niguel), Assemblyman Steven Choi (R-Irvine), and Assemblyman Thurston Smith (R-Apple Valley) in front of a Sacramento gas station to discuss bipartisan proposal AB 2547 ahead of a vote on the Assembly floor that took place this morning. This legislation would have suspended the gas tax for one year and require that all revenue generated by the tax be passed on directly to the consumer.

Assembly Members of the Republican Caucus released the following statements:

"This morning we are here to talk about the gas prices and much-needed relief California families need. As Republicans, we have been pushing for a gas tax suspension since the beginning, when we introduced a bill in January and pushed for a vote and brought a vote to the floor... we need to provide this relief. People have waited far too long... we are now on day 77 of the Governor promising to provide gas tax relief. The good news is, there's been a bipartisan measure that's been introduced, AB 2457, which has both Democrats and Republicans who have signed on. We are going to bring it to the floor and vote on it now. We are not

going to wait any longer." -Assembly Republican Leader James Gallagher

"Yesterday, Joe Biden celebrated high gas prices as we make our 'incredible transition'. Apparently, it's more incredible here in California than anywhere else as our gas prices climb to astronomical levels... our caucus is fighting to reverse the tide. We are fighting to make sure people can stay and build a career, raise a family, and retire. We are ready to meet our colleagues on the other side of the aisle when they are ready to work on real solutions. That starts today, this morning, when we will give them another chance to vote on suspending the gas tax." -Assemblyman Kevin Kiley

"When Republicans first proposed suspending the gas tax on January 12, gas prices were just \$4.58 on average in California according to AAA...if you tally up how much Californians would have saved since then if we had enacted the gas tax suspension, that number comes to about \$2,400 dollars per person. If you are looking at a family, that number nearly doubles. That's a far cry from the small checks the Governor has been proposing to send. Californians deserve better. In some parts of the state, gas is nearly \$8 a gallon. That is unacceptable and unsustainable for our communities... enough is enough." -Assemblywoman Laurie Davies

"Legislative Democrats continue to delay while Californians struggle to pay. Why hide behind process, deadlines, and blame, when we can take action today by using a small portion of the Governor's nearly 100 billion dollars of budget surplus to temporarily suspend the gas tax and lower gas prices by over 50 cents immediately? How many more gas price records does California have to break before Legislative Democrats take action? How much longer can we ask hardworking families to choose between filling up their gas tank or buying groceries? I emphatically urge the Legislature to suspend the gas tax and give these families a 50 cent break now. Today is the time to pass AB 2457." -Assemblyman Steven Choi, Ph.D. ★

# National Study of Pregnant Women Finds Increase in Chemical Exposure

**SACRAMENTO, CA (MPG)** - A national 12-year study that enrolled a highly diverse group of pregnant women, including women in the Sacramento region, found rising exposure to chemicals from plastics and pesticides that may be harmful to development.

“This is the first time we’ve been able to measure the amounts of chemicals in such a large and diverse group of pregnant women – not just identify chemicals,” said Tracey J. Woodruff, senior author of the paper. Woodruff is a professor and director of the UC San Francisco Program on Reproductive Health and the Environment and co-director of the UCSF EARTH Center.

The results of the study, which included co-authors from UC Davis Health, were published May 10, 2022, in *Environmental Science & Technology*.

Prenatal exposure to industrial chemicals can come from air, food, water, plastics, and other industrial and consumer products. Although these chemicals could be harmful to pregnancy and child development, few of these chemicals are routinely monitored in people.

**All Participants had Chemical Exposure**

To determine exposure, researchers measured 103 chemicals, mostly from pesticides, plastics, and “replacement chemicals,” new forms of chemicals that were banned or phased out, like bisphenol A (BPA) and phthalates. Certain phthalates have been identified as neurotoxic chemicals that can harm child brain development and increase children’s risks for learning, attention, and behavioral disorders.

All participants had chemical exposure, and several compounds were detected in all 171 participants. More than 80% of the chemicals were found in at least one of the women in the study, and more than a third of the chemicals were found in a majority of the participants. The study also found that some of these chemicals were present in higher amounts than seen in earlier studies.

The multi-institutional study included 171 women from California, Georgia, Illinois, New Hampshire, New York, and Puerto Rico who are part of the National Institutes of Health Environmental influences on Child Health Outcomes program. About one-third (34%) were white, 40% were Latina, 20% were Black, and the remaining 6% were from other or multiple groups.

**Latinas had Higher Levels of Exposure**

The study found higher exposures for non-white women, those with lower educational attainment, or who were single or had been exposed to tobacco. Latinas had especially high levels of parabens, which are used as preservatives, as well as phthalates and bisphenols, which are used in plastics.

“While pesticides and replacement chemicals were prevalent in all women, we were

surprised to find that Latinas had substantially higher levels of parabens, phthalates and bisphenols,” said Jessie Buckley, associate professor of environmental health and engineering, as well as of epidemiology, at Johns Hopkins Bloomberg School of Public Health and first author of the study.

“This could be the result of higher exposures to products with chemicals, such as processed foods or personal care products,” Buckley said. “Our findings make clear that the number and scope of chemicals in pregnant women are increasing during a very vulnerable time of development for both the pregnant person and the fetus.”

Many of the chemicals the women had been exposed to were replacement chemicals, which may turn out to be just as harmful as the ones they replaced. The study also found many women had been exposed to neonicotinoids, a widely used insecticide that is toxic to bees.

“Exposure to chemicals in the environment is inevitable because they are used widely. We know some of the chemicals cause harm, but for some of the ones being measured for the first time, all we can say with certainty is that exposure to these compounds is occurring.

More work needs to be done to determine potential risks,” explained Deborah Bennett, a co-author of the study. Bennett is a professor of environmental health in the UC Davis School of Medicine Department of Public Health Sciences. She helped identify which chemicals to track.

“Exposures are generally low, so pregnant moms should continue to live their lives and not be too concerned,” Bennett said. According to Bennett, there are steps people can take to help limit chemical exposures.

“Cook at home using fresh or frozen ingredients – rather than processed or packaged foods – when possible,” Bennett said. She also recommends avoiding pesticides and controlling household pests without chemicals. “People can also learn which personal care products have fewer harmful chemicals by checking with organizations such as the Environmental Working Group.”

Many of the children in this study will be followed as part of the Environmental influences on NIH Child Health Outcomes (ECHO) program study.

Bennett is leading a separate study funded by the Environmental Protection Agency that is looking at children’s exposure to chemicals in household dust. Bennett and her team will track more than 80 chemicals in dust collected from participating homes, including many plasticizers, flame retardants and environmental phenols. ★
