

**CITRUS HEIGHTS, CA (MPG)** - General site work in advance of construction of a new 36,152-square-foot sports club, owned by an Irvine-based corporation which operates the LA Fitness chain of health clubs, in the site of the former Jo-Anne Fabrics in Sunrise Village Shopping Center at 5425 Sunrise Boulevard in Citrus

Sunrise Village Plaza, tells the public that renovation there will begin soon.

Earlier this year, Jo-Anne Fabrics moved to a new building which was completed in the first phase of a \$15-20 million remodel and expansion project for the center which is owned by the San Francisco-based Merlone-Geier investment company. An adjacent tenant, retailer Tuesday Morning also moved from the Sunrise Village Plaza to a new grocery store.

Current retail grocery competition in the area includes Trader Joe's which is located across the street from the Sunrise Village Shopping Center in the Quail Point Shopping Center on Madison Avenue and a Sprouts located at the corner of Sunrise Boulevard and Greenback Lane. A Safeway grocery store is located at the corner of Dewey Drive and Madison in Fair Oaks.

# Sac County Artists Eligible for \$10,000 in Grants

**SACRAMENTO COUNTY, CA (MPG)** - The City of Sacramento's Office of Arts and Culture is now accepting applications for its \$450,000 "Seeding Creativity" individual artists grant program.

The grant program will support 45 individual artists located within Sacramento County with \$10,000 grants to create and/or present new work in the county during the grant period.

The Seeding Creativity grant program is funded through an award to the Office of Arts and Culture from the National Endowment for the Arts' federal American Rescue Plan dollars. Funds may be used to provide fees/stipends for artists to support services for specific project work.

In addition to grant funds, artists will receive one year of support programming to assist them in career building skills such as building entrepreneurial expertise, leveraging resources, deepening collaborations, developing portfolios and work samples, and crafting work statements. All grantees are obligated to produce a project by the end of the grant period within one of four chosen pathways: Creation, performance/presentation, social impact and research. Emerging and mid-career artists with a three-year work history in visual, craft, media, design, performing and/or literary arts are encouraged to apply. Applications close at 11:59 p.m. on June 20, 2022. A free virtual application workshop to review program goals, guidelines and help individuals apply will be held at 4:30 p.m. on May 18. Register on the City's website. The Office of Arts and Culture also provides one-on-one peer mentors to support artists in application preparation. Applications for grants will be reviewed and scored by a diverse panel comprised of artists from throughout the country as well as community members. Find more details on eligibility criteria, project pathways and grant program on the Office of Arts + Culture's website.

# Council Changes Meeting Time, Opposes Gambling Initiative

**CITRUS HEIGHTS, CA (MPG)** - At the June 9 meeting, the Citrus Heights City Council considered amendments to the Safety Element of the City's General Plan to include the updated 2021 Sacramento County Local Hazard Mitigation Plan (LHMP). Maintaining an updated LHMP is required to remain eligible for Federal **Emergency Management** Agency (FEMA) funding in the case of emergencies or disasters.

The Sacramento County LHMP was updated last year, with input from Citrus Heights and the other cities within the County. The City Council adopted the 2021 LHMP in February 2022, and now the General Plan must be amended to include the updated language in the new LHMP.

Five major goals are outlined in the 2021 plan

update: Protect people, property, public health, the economy, and the environment by minimizing risk due to natural hazards, including the impacts of climate change. Protect critical infrastructure and services from hazards and prevent or minimize loss and facilitate quick recovery when needed. Enhance public outreach and preparedness and find effective strategies to reach underserved and vulnerable communities. Increase community capabilities and coordinate inter-agency cooperation to prepare for, respond to, and recover from disaster events. Conform to federal and state mitigation initiatives.

The amendments to the General Plan were unanimously approved.

Council then considered whether to change the time of their meetings. The current schedule – the second and fourth Thursday of each month at 7:00 PM – has been in effect since 2005, when the City chose that day and time so the meetings could be broadcast live on Sacramento Metro Cable 14, the local public affairs channel.

At the recent Strategic Planning Retreat, the Council discussed starting the meetings earlier in the evening to increase public participation. A review of other council meetings in the region showed that most cities start their meetings at 6:00 PM or 6:30 PM, and staff confirmed that Metro Cable 14 would be able to broadcast the live meetings at either of those times.

City Manager Ashely Feeney explained that an earlier start time would allow people to come straight to the meetings after finishing work at around 5:00 PM, since it's believed that people are less likely to attend the meetings when they go home first and have to come back out for a later meeting. Feeney also said that an earlier start time would allow the Council's special meetings or study sessions, which are generally held ahead of the regular meetings, to be included as part of the regular meetings.

Councilmember Jeannie Bruins said that the earlier start time would make it more convenient and easier for people to attend the Council meetings.

Vice Mayor Tim Schaefer said, "I think it's great. I think it's time."

Councilmember Bret Daniels said, "I think it serves a very good purpose" and the change "allows staff to get home earlier too." He preferred changing to a 6:00 PM start time, stating that a 6:30 PM start wouldn't be enough of a change to make a difference.

# Don't Cry over Spills, Laugh!

Apple Fix Pros Services Computers the Manufacturer Won't

**CITRUS HEIGHTS, CA (MPG)** - If you suddenly find yourself with a broken MacBook Pro, MacBook Air, Mac Pro, iMac or Mac Mini, with a cracked display screen, or damaged by a liquid spill, don't panic.

Call on Apple Fix Pros (AFP) in Citrus Heights at 6831 Greenback Lane, certified Apple technicians, and they'll do their best to help you get your trusty Mac "back on track."

"The most common Mac computer problems we see are either broken display screens or liquid damages from unexpected spills. Some 10 to 20 damaged Mac laptops, computers or monitors come through our doors each day needing attention," said Ahmed Suliman, AFP owner, founder, and its overall technical repair lead.

AFP claims a 99.9 percent repair success rate for anything liquid damage related. Positive reviews from its customers on Yelp describe AFP as a "go-to source" for customers who suffer an accidental spillage on their Mac.

"We also offer exceptionally fast turnaround on repairs," he said proudly. "We're unique in that we sell, and we use all original equipment manufacturer (OEM) Apple parts."

Suliman, a Roseville resident, opened AFP in Citrus Heights four years ago. With a trace of humor in his voice, he described his own relaxed, personal business philosophy.

"Apple was always a

sales company, and not a repair company," he said. "We fix what Apple won't."

Against a wall filled with signage that teases about the special role of computer service technicians often play when customers often need them the most, he described his company's business success over the past four years and his upcoming plans for market expansion.

"At AFP, we specialize in repairing liquid damaged MacBook logic boards, keyboards, touchpads, and all other parts which may be affected when a machine gets wet," Suliman said. The average price typically to repair such damage can range around \$450.00, depending upon the specific repair work involved, he said.

Technicians perform extensive cleaning of liquid damaged parts, and corrosion removal, and then replace defective components as needed. Component level logic board repair includes a sixmonth warranty for the MacBook, MacBook Pro, MacBook Air, and the Intel iMac, he said. In general, most repairs are completed within 24-48 hours.

Suliman stepped away from Double Dex, a well-established Sacramento Apple service and repair company where he worked for three years as a lead service and repair technician to go out on his own. "Our clients are our busi-

ness," he said. "We offer friendly, quality service."

The company specializes in the repair and upgrade of Apple computers made from 2010 to 2017, noting newer Macs, made after 2017 are no longer upgradable.

AFP offers its customers a "no repair, no pay" repair service across a wide range of current Apple computer models. It doesn't fix iPhones, iPads or Apple Watches.

Suliman employs five technicians, all of whom are Apple Certified Technicians, Microsoft, and CompTIA A+ certified specialists. AFP is open six days a week to serve its walk-in customers.

AFP also pays top dollar for used or broken MacBooks, iMacs which are 2013 or newer which are often a primary source for Apple original equipment manufacturer (OEM) parts.

"If you or your company has an Apple device you no longer need, just bring it in for a fair offer or give us a call," he said. AFP also offers refurbished computers for sale.

"We also carry over 800 different parts for Macs," Suliman said. "Parts include display and LCD assemblies, top cases (keyboards/track pads), batteries, chargers/adaptors just to name a few," said Suliman.

Suliman describes his business as "highly organic." Off-site storage is used to house his growing parts inventory, and he recycles computer components which are too damaged to either salvage or resell.

Sale of Apple original (OEM) parts to local business and wholesalers who also specialize in Apple product repair throughout the United States is also an important part of AFP's overall business.

While AFP is a recognized commercial seller on both eBay and Amazon, it will shift this summer to its own e-Commerce sales and marketing platform, Suliman said. Doing so will eliminate the selling fees it has to pay and will better the business to manage its operating costs, he said.

Suliman hopes to open a second business location in Roseville sometime later this year but hasn't finalized a lease just yet. AFP will also soon launch a revamped website at www. applefixpros, where more information on specific repair services, sales, and repair appointment booking will be found.

physical grocery store which offers free same-day delivery and pickup in select locations for its Prime members.

Whole Foods Market has announced plans to expand across the country with 43 stores across 19 states and Washington, D.C. California will be home to 11 of the new locations, including three in San Francisco and two in Los Angeles, according to the grocer's website. The city of Citrus Heights isn't listed in those expansion plans.

Last month, the Starbucks located in the Quail Point Shopping Plaza across the street on Madison Avenue in Fair Oaks, moved to its new Citrus Heights in Sunrise Village.

A new Firehouse Subs is scheduled to be adjacent to the new Starbucks. Sections of the parking lot at Sunrise Village Shopping Center were recently repaved and new electric vehicle charging stations have recently been added.

In construction plans originally submitted to the city of Citrus Heights, the closed former Lyon's restaurant in the Sunrise Village Shopping center is scheduled for demolition. The space of the former 5,274-square foot restaurant is listed on the project brochure as being available for further development.

The general contractor who will build the new 50,000-square-foot sports club hasn't posted signage at the construction site.

Level 5 Builders, Inc. of Folsom, which built the new Jo-Annes store, isn't the general contractor in this new phase of the project, said its president, Kevin Meyer.

Renovation plans were approved by the Citrus Heights City Council in February 2020. The project developer, Merlone-Geier, will complete the project in scheduled phases. The project will take several years to complete and also includes new landscaping and upgraded signage.

Calls to Merlone-Geier for project information, identification of the general contractor involved in building the new sports club and the contractor handling the demolition of the former Lyon's restaurant were not returned as of press time.

# Placer Native Among 5 Marines Killed in Aircraft Crash

**GLAMIS, CA (MPG)** - Five United States Marines tragically died in an aircraft crash Wednesday, June 8, in Glamis, California, during what was supposed to be a routine training session.

One of the five victims was identified as Capt. John J. Sax, 33, of Placer, California. The other four victims were: Cpl. Nathan E. Carlson, 21, of Winnebago, Illinois, a Tiltrotor Crew Chief. Capt. Nicholas P. Losapio, 31, of Rockingham, New Hampshire, an MV-22B Pilot. Cpl. Seth D. Rasmuson, 21, of Johnson, Wyoming, a Tiltrotor Crew Chief. Lance Cpl. Evan A. Strickland, 19, of Valencia, New Mexico, a Tiltrotor Crew Chief.

John Sax graduated from Granite Bay High School and went on to become a MV-22B Pilot for the Marines. John Sax is the son of West Sacramento native and five-time MLB All-Star, Steve Sax.

"It is with complete devastation that I announce that my precious son, Johnny was one of the five US Marines that perished on Wednesday, June 8, in the Osprey Military crash near San Diego," Steve Sax said in a statement published Saturday by CBSLA-TV. "For those of you that knew Johnny, you saw his huge smile, bright light, his love for his family, the Marines, the joy of flying airplanes and defending our country! He was my hero and the best man I know, there was no better person to defend our country.'

Steve Sax said when

his son John was a boy, he dreamed of being a pilot and would get distracted by planes flying overhead during his Little League baseball games.

"There was never any doubt from a young age that Johnny would be a pilot and his passion was to fly!" Steve Sax said in a statement. "This loss will change my life forever and is a loss to not only the Marines but this world!"

"It is with heavy hearts that we mourn the loss of five Marines from the Purple Fox family" said Lt. Col. John C. Miller, Commanding Officer of VMM-364, in a news release. "This is an extremely difficult time for VMM-364 and it is hard to express the impact that this loss has had on our squadron and its families.

"Our primary mission now is taking care of the family members of our fallen Marines and we respectfully request privacy for their families as they navigate this difficult time. We appreciate all the prayers and support from the strong extended Purple Fox family and want them to know that more information will be forthcoming on how to help."

The five Marines were based at Marine Corps Air Station Camp Pendleton, CA, and were flying on a MV-22B Osprey aircraft at the time of the crash. All five were assigned to the Marine Medium Tiltrotor (VMM) Squadron 364, Marine Aircraft Group (MAG) 39, 3rd Marine Aircraft Wing (MAW), according to a news release from the Marines.

At the time of the mishap according to the Marines, the MV-22B Osprey and crew were conducting routine flight training and that the cause of the crash is under investigation. The crash occurred in Imperial County which is about 115 miles east of San Diego and about 50 miles from Yuma, Arizona.

John Sax served in the Marines for five years and eight months. He was awarded with the National Defense Service Medal, Global War on Terrorism Service Medal and Letter of Appreciation. John Sax is survived by his 20-monthold daughter and his wife Amber, who is pregnant with their second child.

# **Scandalizing The Little Ones**

In the New Testament, Jesus Christ says:

"But he that shall scandalize one of these little ones that believe in me, it was better for him that a millstone should be hanged about his neck, and that he should be drowned in the depth of the sea."

This quote from our Savior seems appropriate to our present-day cultural crisis, as we observe the outrageous and unjustified controversy cooked up by the "woke" Left over Florida's new parental rights bill which prohibits the indoctrination of small schoolchildren in transgenderism and sexual deviancy. Governor DeSantis' effort to protect young kids as young as five from having the public schools corrupt their young minds with such dangerous cultural Marxist ideologies should be applauded, not condemned.

Undoubtedly, the Left's current campaign to convince 5-year-old boys that they are girls and vice versa, that they should undergo "gender reassignment" surgery, or that young teenagers should receive so-called "puberty blockers" (which are actually just a form of chemical castration) would, in a saner day in this nation be classified as child abuse and child endangerment and prosecuted in the courts.

Of course, the entire purpose of the Left's drive to target America's children is because the final arrival of their cultural Marxist "utopia" cannot be attained without capturing the vouth. Every communist leader from Lenin to Mao has emphasized the need to capture a nation's youth and its educational institutions in order to guarantee the passing of the "old order" and the inauguration of a new amoral, godless state in which only government is worshipped. The introduction of "sex education" into America's schools in the 1960s and the subsequent expansion of such "education" far beyond discussion of the human reproductive system to discussion of explicit sexual practices and behavior and now to transgenderism has its roots in communist revolutionary movements of the early 20th century. In 1919, Lukacs became Deputy Commissar for Culture in the shortlived Bolshevik regime in Hungary headed by Bela Kun. He was quoted as asking the question: "Who will save us from Western Civilization?" According to an article in the American Thinker:

"He immediately set plans in motion to de-Christianize Hungary. Reasoning that if Christian sexual ethics could be undermined among children, then both the hated patriarchal family and Church would be dealt a crippling blow. Lukacs launched a radical sex education program in the schools. Sex lectures were organized, and literature handed out which graphically instructed youth in free love (promiscuity) and sexual intercourse while simultaneously encouraging them to deride and reject Christian moral ethics, monogamy, and parental and church authority. All of this was accompanied by a reign of cultural terror perpetrated against parents, priests, and dissenters."

Lukacs was, of course, a follower of the cultural Marxist philosophy of Antonio Gramsci, the Italian communist who helped found the so-called "Frankfurt School." Gramsci is the revolutionary who coined the term "long march through the institutions" to describe his strategy of sabotaging the religious, moral, and cultural foundations of Western Christian societies before launching the attack on capitalism. As a result of Lukacs' atheistic and nihilistic propaganda program for Hungary's public schools, much of that nation's youth descended into delinquency, becoming bullies, thieves, sex predators, murderers, and sociopaths. Today's "woke" revolutionaries are merely heirs to the old Gramsci-Lukacs Bolsheviks who saw – in the words of author and

past presidential candidate Patrick Buchanan - Christianity as the "heat shield of capitalism," which must be annihilated before the so-called "class struggle" could come to full fruition. What better way to achieve this objective than banning religious education from the schools and introducing sex education, unmoored from any religious or moral traditions instead. Of course, it is questionable whether the old cultural Marxists would go even as far as their modern contemporaries who outright deny science and argue that gender is not biologically determined, and that people should determine their own sexual identity.

Comprehensive Sex Education (CSE) is the Far Left's latest scheme to scandalize our children and destroy their innocence, while challenging their parents' authority and values. 

# **Council Changes Meeting Time, Opposes Gambling Initiative**

Miller didn't support an earlier start time, stating that he believes people might like the chance to get home, eat some dinner, and change clothes before coming to a meeting. "I don't know that necessarily making a change is beneficial." And he pointed out that holding the study sessions within the regular meetings wouldn't get anyone home any faster: "I don't know that there's a benefit there; the meetings are just longer.'

The Council voted 4-1 to change their meeting time to 6:00 PM, with Councilmember Miller dissenting. The change will begin with the July 14 meeting, after outreach is conducted to inform the public of the change.

The Council also considered whether to pass a resolution opposing the California Sports Wagering Regulation and Unlawful Enforcement Act Initiative, which will appear on the November 2022 ballot in California.

City Manager Feeney explained that the initiative would amend the California constitution to allow tribal casinos to offer roulette, dice games, and sports wagering, as well as sports wagering at approved horse-racing facilities—with the claim that allowing sports wagering at these highly regulated and experienced gaming operations would protect public safety. But the initiative would also amend the Business and Professions Code to authorize any person or entity to bring civil suits for violations of gaming laws, stating that this change is needed because the current enforcement of gambling laws is inadequate.

Feeney said that Stones Gambling Hall of Citrus Heights brought the issue to City staff due to concerns about how the initiative could impact their business. After reviewing

the initiative, Feeney said it could open the possibility for "frivolous lawsuits for one of our businesses."

Councilmember Miller asked for clarification about how this initiative would differ from existing law, and how it would expose the local business to lawsuits.

City Attorney Ryan Jones explained that lawsuits relating to gaming violations are filed by the Attorney General. But he said this initiative "would give private law firms the ability to file lawsuits as if they're the Attorney General." Jones said the shift would allow private law firms to act as if they are a governmental agency.

Vice Mayor Schafer said, "It seems pretty outrageous to grant private firms the ability to seek damages against an existing business for what, in my opinion, seems like normal business practices."

Councilmember Daniels agreed that the Council should oppose the initiative.

Carmen Shultz with Stones Gambling Hall spoke during Public Comment, stating, "It's a great concern to us; it's a great concern to the industry. It's really a smoke and mirrors initiative." He said that the real reason behind the initiative is for tribal casinos to gain the ability "to bring lawsuits against the industry." He stated that the tribal casino leaders view card rooms as illegal gambling, even though the Attorney General has approved the rules and regulations governing his establishment and others like it. If the initiative passed, he's concerned that even if the Attorney General declines to pursue a lawsuit, private firms could file on behalf of the tribal casinos, putting jobs and businesses at risk.

The Council voted unanimously to oppose the initiative.

an illegal gambling establishment operating at this location for the past couple of months. The operation was found to be in violation of several state and local laws including possession of a slot machine device and IMPACT Detectives maintaining a place for gambling.

During the service of the search warrant, two subjects were located inside and arrested for outstanding felony warrants and possession of an illegal firearm. Multiple electronic gambling devices were seized from the location along with illegal drugs.

Citrus Heights worked this case in partnership with the State of California's Department of Justice Bureau of Gambling Control.

Further investigation into the subject(s) who operated this location is forthcoming.

Toni: My husband, David, has been laid-off because of what is happening to the economy and rising gas prices. He is 68 and has never enrolled in Medicare. I am

turning 65 this September and we both are covered under his employer's health plan which is ending June 30th.

We have been told that he will get a penalty because he is over 65 and never enrolled in Part B. I really hope NOT! I will have to enroll in COBRA until I turn 65 in September. Please explain what our Medicare enrollment options are since we are different ages and have different enrollment situations.

Thanks, Paula from Charlotte, NC

Great Question, Paula:

There are 2 different rules regarding enrolling in Medicare Parts A and B in your household and I will keep how to enroll in Medicare for both you and David SIMPLE!

1. David needs to apply for a SEP (Special Enrollment Period) by downloading the form CMS-L564 (Request for Employment Information) from socialsecurity.gov or email info@tonisays.com and we will email you a form.

Have David's HR department sign off on the Request for Employment Information (CMS-L564) form and attach it to CMS- 40B (application for Medicare Part B). File both forms with your local Social Security office when applying for Medicare Parts A and B. Advise the Social Security representative that David is losing his company benefits and need his Medicare Parts A and B to begin July 1st.

This is an ALERT to the public because local Social Security offices which were closed due to the Pandemic and recently reopened. The wait is extremely long at the local offices. The public should call their local Social Security office direct for help filing forms to apply for Medicare Part B. Most Social Security direct 800# can be located by Googling online for that specific office's 800#. Generally, the wait while holding is less than calling the main Social Security 800#.

2. Paula, your way to enroll in Medicare is simple and quite different from David's because you are turning 65 in September. Go online to www.socialsecurity.gov/ benefits/medicare at least 90 days prior to turning 65 and apply online for a September 1st effective date.

Below is a checklist for those enrolling in Medicare the easy way:

- . Original Medicare Part A covers: in-patient hospital stay, skilled nursing/rehab stay, blood transfusions, home health and hospice.
- 2. Original Medicare Part B covers: primary care or specialist, whether in the office or performing surgery, outpatient surgery, durable medical equipment, x-rays, CAT scans, MRIs, chemotherapy, etc.
- 3. Original Medicare/Medicare Advantage: discuss with your healthcare facilities and medical professionals which Medicare plans they accept such as Original/Traditional Medicare with a Medicare Supplement or a Medicare Part C (Medicare Advantage plan such as HMO, PPO or PFFS). Research Medicare Advantage plan's hospital/provider online directory to be sure your physicians and hospitals are in that specific plan's network. Call to verify they are currently in network.
- 4. Research Medicare Prescription Drug plans every year to see if your standalone Prescription Drug or Medicare Advantage Plan with prescription's formulary covers all your brand name or generic prescription drugs.
- 5. Consider a Long-Term Care (LTC) option such as standalone LTC policies, hybrid annuities or life insurance with LTC riders, VA aid and attendant benefits or applying for financial help from your specific states Medicaid for LTC.

Remember, always make copies of every document given to the Social Security office or received from the Social Security office.


To say I miss you would be putting it mildly. Thank you for all you taught me with love. I will always love you Dad! ★
