CITRUS HEIGHTS, CA (MPG) -2017 the homeless in Citrus Heights have been offered the opportunity to enjoy a brief respite from their living situation each winter. For nine weeks, or 63 nights, eight churches in four cities are coming together on a rotating schedule to provide respite each night for 16 to 21 homeless men and women at their location. There

are four weeks remaining this year. Before being transported to the host church each evening, guests arrive at the intake venue, Messiah Lutheran at 5:00 p.m. HART volunteers conduct nightly registration and screening of new guests and sign-in for continuing guests. Bicycles and other gear are stored in a locked container at the registration site. Guests relax with a cup of coffee or cocoa

and a snack while Gabby Yost, the home less navigator works with those who would like to take advantage of the many resources available to help them

navigate the homeless life, including housing information, bus passes and vouchers to obtain a driver's license or photo ID card. The hope is they will eventually work to get back into the community with a job and a place to live. In the words of Deacon Mark Holt at Holy Family Catholic Church, the ultimate goal of this program is to "meet the homeless where they are, to give them a hand up, (rather than a hand out) and help them become self-sufficient citizens of

Citrus Heights." Holt was involved in the formation of the winter

At 6 p.m. a van owned and run by 'The Way Ministries' along with private drivers then transport guests to the host church for the night. Upon arrival guests receive a hot homemade meal prepared by volunteers, a safe warm place to sleep with a cot and sleeping bag, clean clothing and other personal items. After the meal,

SACRAMENTO REGION, CA (MPG) - It's January... and with January comes the planning of the year's Baseball and Softball season! Are you a baseball or softball fan? Some of the best games you will ever see, will be those played in Little League. Do you miss your glory days of playing ball? Or maybe, you loved the game, but you weren't one of those people blessed with the gift of being athletic. Well then, umpiring might be just the thing

Umpiring is a great way to make some money as well. Depending on the league, and sometimes the level, umpires will often make between \$25 and \$75 per game. Umpires create their own schedules so you work as much or as little as you want. On weekends, there are often 6 games in a day. That can easily be a \$600 weekend in pay, or more.

Becoming an umpire is easier than you might think. Knowledge of the game is not required, but it does help. All you need to do is sign up for umpire clinics that are offered by local little leagues and softball leagues. The clinics are generally free and teach you from the basics to recent rule changes. They teach you what

equipment is legal, and why other equipment is not legal.

There are free webinars and videos on https://www.littleleague.org/university/umpires/. If you live in the Sacramento area, USA softball is offering an umpire school on January 29th and 30th, in Roseville. Simply go to www.usasoftballsacramento. or or go onto Facebook at Facebook. com/usasoftballsacramento to register for the umpire school. You can also call Chuck Brabec at (916)834-8074 or email UIC@usasoftballsacramento.org

If you miss this one, don't fret. There will be other clinics in your area soon. Simply call Little Leagues or softball leagues in your area and ask to speak to their Umpire in Chief. You can also contact your District office and inquire about umpiring with them. In case you don't know what District you are in: Rocklin & Auburn is Dist. 11; Dixon and Woodland is Dist. 64; Carmichael is Dist. 5; South Sacramento is Dist. 7; Gridley is Dist. 2; and West Sacramento is Dist. 6.

Don't worry about if you are new at umpiring, they won't just throw you to the wolves. They train you and move you up as you gain confidence and experience. As you learn the profession of umpiring, like anything, it's all what you make of it. You can be one of those umpires that enjoy what they are doing and have fun being part of the game.

You can become one of those umpires that spots a shy or nervous kid and encourages them to get that hit or make that catch and know that you played a part in giving that child some self-confidence and pride. Most sports fans are officials from the stands or from their living rooms. Why not do it for real? It's a great way to stay active and have fun.

If baseball and softball is not your game, then consider officials training in whatever sport you like! In the last few years, there has been a real shortage and need for game officials in youth sports. It's really up to you where you take it. You may start out refereeing basketball for parks and rec, or umpiring for softball minors, but you may take it to officiating for schools, or for semi-pro or pro teams.

Regardless of the sport(s) you choose, working two days a week doesn't sound bad either. Officiating youth sports is a great way to give back to your favorite sport, your city and your kids! Put the knowledge you already have to use, and maybe learn some more about the game(s) you love.

SACRAMENTO REGION. CA (MPG) - When someone calls 9-1-1, the expectation is that an ambulance shows up quickly, you are assessed, stabilized if necessary, and taken to the nearest emergency department to be seen by a doctor within minutes. However, when someone calls 9-1-1 for a non-life-threatening event, they often times are not seen quickly at the hospital. Sometimes for several hours.

This is because a hospital emergency department operates under what is called a "triage" system and not a "first-come, first-served" systemlike a doctor's office. The more significant the medical event is, the faster the patient is seen. This is because things like choking, heart attacks, and head injuries require immediate attention to give the patient the best chance of survival.

to remind the community about when it is appropriate to call 9-1-1 and when an individual is better served contacting their primary care physician or driving themselves to an urgent care clinic to be seen by a doctor.

Always call 9-1-1 for a life-threatening emergency. If someone is having difficulty breathing, choking, head injury, loss of consciousness, chest pains, significant bleeding, internal injury, falls from a high distance, or any other injury or illness that is immediately life threatening 9-1-1 is appropriate.

It is recommended that you contact your physician for issues such as general pain, prescription refills, COVID testing, or an illness or injury that is not an immediate threat to health or life. If you need to be seen immediately, urgent care clinics can handle most non-life threatening issues such as prescriptions, routing testing, cold and flu like symptoms, and more!

many guests retreat to their cot and sleeping bag for some quiet time in their own space. Men and women are housed separately and there is security throughout the evening. At 6:00 a.m. guests are awakened and given a bag breakfast with a simple meal and a fan favorite: socks! At 7 a.m. they are returned to Messiah to retrieve their stored belongings and be on their way until 5:00 that night when they may return again.

On the Wednesday of week 4 at the Divine Savior Catholic Church the Orangevale Rotary had spent hours creating a meal to remember for their guests who were treated like royalty from the personalized placemats to the meals for which many came back for seconds. The food bank provided the food for a meal of shredded pork, simmered for four hours, mashed potatoes and well-cooked onions and string beans, which meant even those with few or no teeth could have a healthy meal of meat, protein and a starch. All applauded the homemade brownies by John!

Jay Kays a guest who is following that path to self-sufficiency has been homeless for 2 ½ years. This is his third year at the shelter program. He is proud that after relapsing the HART program is helping him with his rehabilitation. Working with the navigator, he says, he is anxious to work his way back into the workforce when the economy turns around, and he is looking forward

to better days. Meanwhile he visits the food closet on his bike and shares what he gets with others when he can. He has a place to stay in the park and cleans up the areas after others who are not as respectful of their surroundings. Because of COVID, many of the closed restaurants outside their entrances are becoming overcome with trash. He says despite the lack of adequate trash cans, he and his buddies do what they can to keep those areas in shopping strips clean. The police know them and appreciate their work.

A fairly new resource since 2020 is the portable showers provided by Mercy Holistic Ministry. They have provided their service at different sites in Sacramento County. Pastor Berhanu Kumalo founder of the program, has seen how something we take for granted like a simple shower can restore one's dignity. "When a person takes a shower (after not having one for so long), he feels human again." Each guest receives a towel for their shower and clean underwear and clothing to take with them. Socks are a popular item and are always needed. Every Tuesday for the next four weeks they will be at Messiah Lutheran from 1:30 to 6 p.m. and every Wednesday they are at the host church from 5:30 p.m.

Social Security Matters

Is My Analysis of my Wife's Social Security Correct?

Dear Rusty: I am 63 and my wife is exactly 4 ½ years younger than me to the day. I plan to file for Social Security when I turn 70. My earnings history is considerably higher than my wife's. I talked with a person at the local Social Security office, and she suggested that my wife file at 62 based on her own record then convert to her spousal benefit when I file at age 70. However, from what I can tell, if she files before her FRA of 67, not only will she get less based on her own record, but she will also receive less for her spousal benefit, as well as her survivor benefit if I die before her (which is statistically likely). Is my analysis correct? Signed: Planning Ahead

Dear Planning: Your analysis is correct regarding your wife's spousal benefit while you are both living, but incorrect regarding her survivor benefit if you die first. Here's

If your wife takes her personal Social Security (SS) retirement benefit at age 62, she'll get 70% of what she would get if she waited until her FRA of 67 to claim. That amount is permanent (except for COLA), and it is what her

to when she takes her spouse benefit (when you claim). In the scenario you mention, in addition to your wife's own benefit being reduced by 30% for claiming at 62, since she will not yet have reached her FRA of 67 when she takes her spouse benefit from you her "spousal boost" will be reduced as well. So, claiming at 62 not only reduces her personal benefit it also means she'll get less than 50% of your FRA benefit amount when you claim (FRA amounts are used to compute spouse benefits, regardless of the age benefits are claimed). All of which means her spousal benefit will be considerably less.

That isn't necessarily an unacceptable strategy unless she is working, in which case she'll be subject to an earnings limit which will either reduce how much Social Security will pay her while she's working or, if her earnings are high enough, eliminate her eligibility for any benefit until she stops working. The earnings limit changes yearly but for 2022 it will be \$19,560 and if that is exceeded, they will take away benefits equal to \$1 for every \$2 she is over the limit. There is no longer an earnings for information purposes limit when your wife reaches her FRA so your wife's plans for working should be factored into her decision on when to

In any case, you should look at your overall benefit opportunity as a couple to see when your wife should claim, and life expectancy should always be factored into your thinking. If your wife expects to live a long life (and does), waiting until her FRA to

"spousal boost" will be added claim her own SS will maximize her monthly benefit (including her spouse benefit) for the rest of her life. If her life expectancy is less optimistic, claiming earlier has much merit. Just for reference, a woman your wife's age, statistically, will live to an average age of 87.

> Regardless of when your wife claims her own benefit or her spousal benefit while you are both living, her benefit as your widow will not be affected. What affects her survivor benefit is her age when she claims it. If she has reached her full retirement age when she claims her widow's benefit, she'll get 100% of the benefit you were receiving when you died instead of the smaller benefit she was previously getting. If she hasn't yet reached her FRA when she claims her widow's benefit, then it will be actuarially reduced by a fraction of a percent for each month earlier than her FRA she claims it. Be aware too that even if your wife hasn't reached her FRA when you die, she can choose to delay claiming her survivor benefit until it reaches maximum at her FRA.

Sacramento County Cannot Afford Another Lockdown

Through the generosity of the Citrus Heights Messenger, this column serves to provide an update about matters affecting the community of Citrus Heights.

With the rise in COVID cases across the world as a result of the omicron variant, local jurisdictions are struggling with how to properly react. Some areas like Sonoma County have now issued "shelter in place" orders, which means residents can only go to places for essential reasons, such as the grocery store or doctor's office. I strongly believe Sacramento County should not go down this path, and should do everything possible to avoid further shutdowns like the previous failed attempts.

The current rise of COVID is somewhat misleading, as the only thing the media wants to currently report on is the number of COVID cases. And while the omicron variant is extremely contagious,

symptoms are less severe than other variants. The whole reason that the shutdowns happened originally were because deaths were on the rise and hospitals were being overrun, and in Sacramento County neither of these two things are happening. Thankfully, COVID related deaths have remained low, and our hospitals are not in danger of

exceeding capacity. Shutdowns do not come free, and should be avoided due to the devastating impacts they have on society. The Wellbeing Trust, a non profit working to de-stigmatize mental health issues, released a study that found 75,000 deaths during the recent national shutdowns were "deaths of despair" - which includes suicides and overdoses. And in California, nearly one in three restaurants permanently closed as a result of the most recent shutdown.

Nowhere are these negative shutdown impacts more evident than how they have impacted children. The United Nations Children's Fund released a report that showed the current generation of students will lose \$17 trillion

studies have shown that in lifetime earnings as a result of the learning losses suffered during the global shutdowns. The United States Department of Education also released a report that showed the pandemic has negatively affected academic growth, has deepened the impact of disparities in access and opportunity, and heightened the risk of sexual harassment, abuse, and violence.

> Politicians, the media, and government agents have stoked fears to the highest level, and we cannot blame the public for being afraid. But we must fight to keep our businesses, communities and schools open – while also needing to recognize the importance of respectful debate and compassion.

\$2.75 Million EDD Fraud Scheme

SACRAMENTO COUNTY, CA (MPG) - On January 6, 2022, 35-year-old Jamie Williams-Major was arrested on 166 charges

(EDD) fraud scheme totaling more than \$2.75 million dollars. Williams-Major fraudulently filed 166 EDD claims in the names of state prison inmates and identity theft victims. To date, this is the largest EDD fraud scheme discovered in Sacramento County.

In April of 2021, Sacramento County District Attorney's Office, Sacramento County Sheriff's Office, and the Employment Development Department arrested Williams-Major and six other subjects

enforcement believed the subjects obtained more than \$250,000 in a fraudulent EDD scheme.

After law enforcement arrested Williams-Major in April, they obtained a search warrant and searched the contents of her cell phone. Law enforcement discovered the fraud was 10 times bigger than first suspected. Authorities obtained an arrest warrant for Williams-Major and arrested her in Las Vegas, Nevada.

Williams-Major was transported to Sacramento to face additional charges and will be arraigned on January 19, 2022.

Office of Senator Jim Nielsen

SACRAMENTO, CA (MPG) -Senator Jim Nielsen, R-Red Bluff, issued the following statement in response to Governor Newsom's proposed 2022-23 State Budget:

"Governor Newsom needs to wake up on water storage. There is an urgent need to fully-fund and immediately build large above-ground water storage

projects like Sites Reservoir, and his proposed budget falls billions of dollars short. Groundwater recharge and conservation, while important, simply aren't enough.

"As the state continues to face devastating wildfires that destroy lives, property and wildlife, the governor's budget proposes \$1.2 billion for forest health and fire prevention. Republicans have advocated for these efforts for decades. I'm glad that the Governor is slowly coming around on prevention, though much more needs to be done.

"Dangerous people are not in custody and the people of California don't feel safe. This budget proposal takes a few steps but doesn't sufficiently address the need to support law enforcement.

"The state budget has a \$21 billion surplus, so there's no reason to not provide enough money to fund these critical priorities."

Youngkin Is Right on Masks

Glenn Youngkin promised to be on the side of parents as Virginia governor, and on his first day in office, he delivered.

The Republican issued an executive order allowing parents to decide whether their kids will wear masks in school, and met an instant wall of resistance from Democratic-controlled

counties and criticism from the White House press secretary Jen Psaki. A Washington Post headline said that Youngkin is "terrifying" people.

The flak notwithstanding, his order is a sign of a growing backlash against COVID-19 restrictions that will likely only gain force as the pandemic drags on and former articles of faith, including on masking, get called into increasing doubt.

Youngkin has ventured into a legally murky area. Critics believe he doesn't have the authority to issue his order because Virginia passed a statue in early 2021 that says schools should "to the maximum extent practicable" adhere to CDC-blessed strategies for controlling spread. The Centers for Disease Control and Prevention is still recommending masks. The statue is vague, though, and doesn't mention masks. Youngkin's predecessor, Democrat Ralph Northam, felt compelled to issue an executive order specifically mandating them in K-12 schools.

of whether decisions on masking and other mitigation measures are best left to school districts. Here, it is worth noting that Youngkin's order is different from that of his fellow Republican governors in Texas and Florida, who prohibited school districts from adopting mask mandates. Instead, Youngkin is establishing a carveout for parents from mandates, should they choose to take advantage of it.

All that said, it is clearly time for mask mandates to end. The conventional wisdom on masks has gone from "don't wear them they are useless" at the beginning of the pandemic, to "you are a terrible person if you don't wear them" for about a year and a half, to now, "cloth masks don't really protect anyone."

Despite Jen Psaki saying that Arlington County, which is vowing to defy Youngkin, is standing up for kids and their safety, the case for masking kids in schools is weak or nonexistent.

We are an outlier on this question. The CDC recommends masking all kids age 2 and older, whereas other health authorities are considerably more nuanced.

for Disease Prevention and Control doesn't recommend masking for schoolchildren younger than age 12, noting – correctly – that they "may have a lower tolerance to wearing masks for extended periods of time, and may fail to wear them properly." In areas with community spread, it recommends masks for students in secondary schools, although it

There's also the question stipulates that they should "be seen as a complimentary measure, rather than a standalone measure to prevent transmission within schools."

The World Health Organization makes distinctions based on age. It says that kids age 5 and younger shouldn't be required to wear masks based on the "overall interest of the child and the capacity to appropriately use a mask with minimal assistance." It is open to the masking of 6to 11-year-olds, so long as a wide variety of conditions are met. And it says that kids age 12 and over should mask like adults.

Many European countries have avoided sweeping American-style mask mandates on school kids, and for good reason. A large-scale CDC study found no benefits from the masking of kids. Many students wear cloth masks that don't provide much protection (even if worn and maintained properly) and no sane person should want to subject a child to an N95 all day long.

Parents in Virginia who believe that masking is important can still act accordingly, and vaccines and boosters are available to provide another The European Centre layer of protection. But masks remain something more than a public-health measure for many proponents – they are a signal of virtue and a pillar of pandemic orthodoxy.

Newsom Backs Away from Single-Payer Health Care Pledge

When he unveiled a new state budget last week, Gov. Gavin Newsom crowed about California becoming the nation's first state to embrace universal health care coverage.

His budget would accomplish that goal by extending state Medi-Cal coverage to undocumented immigrants of all ages, beginning in

"I campaigned on universal health care," Newsom said a day later. "We're delivering that."

Not quite.

While running for governor in 2018, Newsom pledged to create a single-payer system for California, making the state the sole supplier of coverage.

"I'm tired of politicians saying they support single-payer but that it's too soon, too expensive or someone else's problem," Newsom said during the campaign.

That pledge won Newsom the support of single-payer advocates. The California Nurses Association decked out a bus that toured the state with a picture of Newsom's face and the words: "Nurses Trust Newsom. He shares our values and fights for our patients."

Newsom did virtually single payer but that it's too

nothing to implement the promise. Instead, as the state's finances allowed, he extended Medi-Cal coverage incrementally to undocumented immigrants and others lacking private or public coverage.

Along with mandates and subsidies from Obamacare, state actions eventually raised health coverage to 94% of Californians and Newsom's latest extension to undocumented adults would make it, at least on paper, 100%.

Newsom gets a bit testy when reporters ask him about his 2018 pledge. As he was introducing his budget this month, the state Assembly was beginning to move a single-payer bill for what's called CalCare, and asked about it. Newsom replied, "I have not had the opportunity to review that plan, and no one has presented it to me."

"I think that the ideal system is a single-payer system," Newsom said. "I've been consistent with that for well over a decade. ... The difference here is when you are in a position of responsibility, you've gotta apply, you've gotta manifest, the ideal. This is hard work. It's one thing to say, it's another to do. And with respect, there are many different pathways to achieve the goal."

The nurses' union and other single-payer advocates aren't satisfied. The San Francisco Chronicle reported union organizer Alyssa Kang told single-payer advocates on a conference call, "So we want to be absolutely clear: This is a flip-flop from a governor who said ... 'I'm tired of pol-However, once elected, iticians saying they support

soon, too expensive or someone else's problem.' This is absolutely unacceptable, and he cannot be allowed to have it both ways."


The differences between universal coverage and single-payer are more than semantic. The former includes a wide variety of public and private health insurance plans, many of which have coverage limits and patient co-pays, while the latter would provide unlimited benefits free of out-of-pocket costs, much like Great Britain's National Health Service.

Providing universal coverage, as Newsom defines it, is doable by spending a few additional billion dollars in the state budget. Single-payer, on the other hand, would require the federal government to give the state the \$200-plus billion is now spends on Californians' health care and the state to raise taxes more than \$150 billion a year.

The legislation now pending in the Assembly would create a framework but the taxes are contained in a companion constitutional amendment that would require two-thirds votes in the Legislature and voter approval.

With massive opposition from employers and much of the medical industry, chances for complete approval of the package are iffy at best and it doesn't appear that Newsom will lift a finger to help it. He's clearly content to settle for universal coverage.

Calif. Bill Would Allow Children 12 and Older to Be Vaccinated Without Parental Consent or Knowledge | 20 Jan 2022 | California Senate Bill 866, introduced by Sen. 



MyMedicare.gov Account Is Important to Processing Medicare Claims

Toni:

My husband recently retired from his job and because I am over 65, I needed to sign up for Medicare. I had to go to the local Social Security with the Request

for Employment Information signed my husband's HR department to sign up for Medicare Part B. I asked if I needed to do anything else and I was told I was all set. I received my new Medicare card in the mail with both Medicare Part A and B dates a few weeks later.

It was not until I went to the doctor in March and had my claim denied when I discovered that the old company insurance is still listed as primary not Medicare.

Now my nightmare begins...because the insurance company (Blue Cross/Blue Shield) said that I had to call Medicare to update Medicare's system. Medicare said it would take 10 days to update. What do I do...I have no coverage because the company insurance is still listed as primary and neither Medicare nor my Medicare Plan G will pay? Please advise what I need to do?

In the past few weeks, the Toni Says® Medicare hot line has been receiving questions such as yours from those past 65 and leaving employer group benefits who are having their Medicare claims denied. Incentive Program for solar electric systems, an innovative economic-based approach to incentivize installations, and a precursor to California's Million Solar Roofs Initiative.

In his current role as an Air Pollution Specialist with the California Environmental Protection Agency, Rose focuses on emerging zero and near-zero transportation technologies, and the fuels that power them, such as hydrogen, renewable fuels and electricity.

Rose is active in the community, having served as an elected Board Member of the Fair Oaks Recreation and Park District for more than eight years, including two years as Chair. In 2011, Rose was elected as the Special District Representative to the Sacramento County Treasury Oversight Committee and chaired the Committee from 2014 to 2019. He is currently an executive Board Member and Past President of the Environmental Council of Sacramento.

Rose graduated from Bella Vista High School and holds a Bachelor of Science degree from U.C. Davis in Environmental Policy Analysis and Planning, with a specialization in City, Regional Planning and Public Lands Management.



Board Approves Initial ARPA-Funded Projects

SACRAMENTO COUNTY, CA (MPG) - The Board of Supervisors approved the initial project recommendations for Phase One Funding Allocations for the American Rescue Plan Act of 2021 (ARPA). The funds come from the total of first allocation \$150 million, which the County received in May 2021.

Project proposals had to fit in one of the three Board-approved strategic investments for priority issue areas: Housing and Homelessness, Health, or Economic

HOUSING AND HOMELESSNESS

Landlord Engagement and Re-Housing Supports: \$10 million

This program will improve re-housing outcomes for people experiencing homelessness with an array of supportive services, landlord engagement strategies and incentives, and flexible rental subsidies.

Sacramento County Social Health Connect: \$5 million*

A Social Health Information Exchange (SHIE) is a countywide data infrastructure that links medical, behavioral health, social service and housing data from multiple sources.

Community Nursing Encampment Unit Pilot: \$700,000

This public health nursing team will provide outreach, client advocacy and professional case management to individuals experiencing homelessness.

Community Nursing Children and Families Unit: \$1.5 million

This Public Health Nursing team will provide nursing assessments and interventions, care coordination, linkages to health resources, and health education to pregnant and parenting families experiencing, or who are at risk of, homelessness.

Encampment Management Information Database: \$160,000

This project will allow for the development of a web-based Encampment Management Information Tracking (EMIT) database to help County staff and contractors track and manage response to homeless encampments.

River District Outreach Navigation: \$160,000

The County will dedicate two contracted outreach/housing navigators to specifically work in the River District as a one-year pilot program.

Staff are continuing to develop and scope projects with a focus on housing development projects, funding to support development of new low-barrier, housing-focused sheltering programs, and improving access to the homeless system of care, including shelter and housing.

HEALTH

Substance Use Respite and Engagement Center: \$2.6 million

Funding to support the Substance Use Respite and Engagement (SURE) Center program operated by WellSpace Health, which provides short-term (4-12 hours) recovery, detoxification, recuperation from the effects of acute alcohol or drug

Project Roomkey Medical Services: \$1 million

Provides medical services for individuals in Project RoomKey, including health education and care coordination, harm reduction, wellness and supportive care, COVID-19 testing and vaccination.

Emergency Medical Services Equipment: \$107,000

Funding will provide equipment and supplies in order to more safely and rapidly deploy temporary facilities in the event of a COVID-19 resurgence or Emergency Operations Center (EOC) activation.

Primary Health Clinic Staffing: \$2.5 million

Funding will support additional temporary staff to increase service capacity at the clinic.

Pandemic Technology Needs: \$350,000

Will fund increased contracted IT Services and staffing support to support and deploy new public health systems and adjustments to current systems to track data and provide care for the community.

Juvenile Medical Services Staffing: \$191,500

Funding will support an additional registered nurse at the Youth Detention Facility.

Employee COVID Vaccination and Testing Program: \$300,000

Add temporary help to support one current Department of Personnel Services (DPS) staff member in the administration of the County Employee COVID-19 Vaccination and Testing Program.

Academic Support and School Readiness: \$1.2 million

This project addresses the negative impact of academic disruption and remote learning due to the pandemic on foster children, families and caretakers.

Building Strong Families: \$3.9 million Funding will go toward Family Support Navigators to connect families to critical services in geographic locations that were hardest hit by COVID-19.

Sacramento County Social Health Connect: \$5 million*

A Social Health Information Exchange (SHIE) is a countywide data infrastructure that links medical, behavioral health, social service and housing data from mul-

*Total project is \$10 million, funded with \$5 million from both Housing and Homelessness and Health allocations.

Staff continue to develop and scope projects with a focus on opportunities to maximize the quality and delivery of public health services, and increasing medical care and reduce disease transmission in the Homeless community.

ECONOMIC RESPONSE

Retail Food Permit Fee Waiver: \$6.8 million

Waive the annual operating permit fees from the Environmental Management Department for approximately 7,161 retail food businesses in Sacramento County.

Chamber of Commerce Grants: \$325,000

Direct grants of \$25,000 to Chambers of Commerce located in unincorporated Sacramento County for operations dedicated to small business supportive programs related to equitable economic recovery efforts.

Property and Business Improvement District Grants: \$250,000

Direct grants of \$50,000 to Property and Business Improvement Districts (PBIDs) located in unincorporated Sacramento County for operations dedicated to small business supportive programs related to equitable economic recovery efforts

Arts and Non-Profit Cultural Grants**

Direct grants in the range of \$5,000-\$100,000 to up to 300 arts and non-profit cultural organizations throughout the County that have been negatively impacted by COVID-19. This project will be in partnership with the City of Sacramento, who will provide a match to the project.

Small Business and Non-Profit Grants: \$7.5 million**

Direct grants of \$5,000 to 1,500 Small

Business and Non -Profit organizations in unincorporated Sacramento County that have been negatively impacted by

Sacramento Metropolitan Chamber of Commerce,

Fund the Sacramento Metropolitan Chamber of Commerce for operations dedicated to providing assistance, counseling, County program outreach and other services to businesses that have been negatively impacted by COVID-19.

Business Support Services: \$660,000

Sacramento Inclusive Economic Development Collaboration, Business Support Services: \$1.8 million

Fund the Sacramento Inclusive **Economic Development Collaboration** (Sac IEDC) for operations dedicated to providing assistance, counseling, in-language support, County program outreach and other services to businesses that have been negatively impacted by COVID-19.

Business Environmental Resources Center, Business Support Services: \$200,000

Fund the Business Environmental Resource Center (BERC) for operations dedicated to providing assistance, counseling, County program outreach and other services to businesses that have been negatively impacted by

**Grant application opportunities will be announced at a later date.

In addition to approving the recommended projects, the Board asked County staff to bring back funding recommendations for chambers of commerce and property and business improvement districts outside of the unincorporated County who do not receive ARPA grants from incorporated cities, as well as projects that address food insecurity.

The County will receive the second installment of \$150 million in ARPA funds in May 2022.

American Rescue Plan Act funds provide local fiscal aid to support COVID-19 response efforts, cover increased expenditures, replenish lost revenue and mitigate economic harm from the COVID pandemic. For more information, visit the County's American Rescue Plan Act webpage. ★
