Funds from the ADD grant will help support the CHP's completion of at least 400 traffic safety presentations statewide and a minimum of 80 distracted driving enforcement operations between October 1, 2021, and September 30, 2022.

Robinson Wins MiLB's Best Feel-Good Moment "Housewarming

WEST SACRAMENTO, CA (MPG) -

Sacramento River Cats outfielder Drew Robinson's final professional baseball game, and the moving standing ovation from fans, teammates, and opponents at Sutter Health Park, was a moment much larger than baseball, and won the MiLBY Award for Best Feel-Good Moment of 2021.

With his family watching from the stands, players from both dugouts stepped out to applaud an emotional Robinson before his first at bat against the Round Rock Express on July 20.

The standing ovation celebrated an incredible comeback to the diamond that reached thousands on social media. Less than a year after losing his eye in an attempt to take his own life,

Robinson returned to baseball, making the River Cats' roster out of Spring Training.

He started for Sacramento on Opening Day against his hometown Las Vegas Aviators. In his fourth game of the season, Robinson launched a towering home run and pointed to his family in the crowd as he touched home plate on May 11.

Robinson also earned the No. 1 spot on SportsCenter's Top-10 Plays with a diving double-catch against Round Rock on July 19.

The inspirational Robinson has since transitioned into a role as a mentalhealth advocate with the San Francisco Giants.

To make it as safe and easy as possible for the community to participate, SSHH staff and dedicated volunteers will be on-hand to collect new and/or gently used items that will be distributed to hundreds of recently homeless individuals in Sacramento County.

Legislation Honors SMUD as National Climate Leader

SACRAMENTO, CA (MPG) - California is the capital of innovation and a global leader in the fight against the climate crisis. Over the past five years, Californians have witnessed two of the hottest years on record and experienced devastating wildfires that affect the health, economy, and overall well-being of our communities. As state legislators, we set policy aimed to protect our great state, and it is imperative that we collaborate with and recognize community partners that take action to move the needle toward real, identifiable, and positive change. For these reasons, we proudly authored Senate Concurrent Resolution 51 – which passed with bipartisan support – recognizing SMUD for being the first large utility in the country to adopt a Zero Carbon Plan that will completely eliminate carbon from its electricity generation by 2030.

The Sacramento area is consistently ranked as one of the dirtiest air basins in the country, as shown by the recently released American Lung Association State of the Air Report. Our children are 22 percent more likely to develop asthma than those in the rest of the country. Consequently, these challenges impact our most vulnerable populations disproportionately. Our current reality is unacceptable, and the only way to safeguard our future for generations to come is to create carbon free solutions that foster healthy outcomes and create green jobs for the benefit of us all.

Right here in our own backyard, our community-owned, not-for-profit electric utility, SMUD, recently adopted a Zero Carbon Plan to eliminate all carbon emissions from electricity generation in our region by 2030. While that timeline sounds ambitious, SMUD's track record of delivering on sustainable solutions and championing innovative action plans is exactly what is needed to create clean powered communities.

The SMUD Board of Directors has consistently championed green initiatives that support innovative solutions to renewable energy. Their leadership has achieved tangible results. For example, SMUD was the first utility to reduce its greenhouse gas emissions by nearly 50 percent from 1990 levels - the equivalent of removing 377,000 vehicles from the road. They've championed clean cars and partnered to plant more than 600,000 shade trees. They helped usher in the solar industry and now with their Zero Carbon Plan, they are ushering a new era of innovation. Today, SMUD already delivers power that is 50 percent carbon free. With its Greenergy and SolarShares programs, SMUD provides many state owned and privately owned buildings with 100% clean, carbon-free electricity. In keeping with this tradition, their new Zero Carbon plan doubles down on these efforts and would power the Sacramento region with 100% renewable

SMUD's Zero Carbon Plan includes retiring carbon emitting natural gas plants and relies heavily on the electrification of the building and transportation sectors since these are two of the largest carbon emitting sectors in the State. For example, efforts include providing support for all-electric homes through customer incentives for rooftop solar and battery storage, electric vehicles, and by providing rebates to builders and homeowners for the installation of clean water heaters, HVAC systems, and

In addition, SMUD has spearheaded and funded the California Mobility Center to bring emerging clean transportation options to the market. This innovation hub has brought federal funding to the Sacramento area and has successfully attracted startup companies in the field of clean mobility. The Center is providing the guidance, education and partnerships needed to bring these ideas to fruition, while simultaneously providing 8,500 new clean technology jobs.

SMUD's comprehensive plan to reach zero carbon emissions by 2030 is one that relies on all the tools in our toolkit. It's the most ambitious of any large utility in the nation and their commitment to our community and equity for all is one to be commended and recognized.

For these reasons, it was an honor and pleasure to come together in a bi-partisan and bi-cameral effort to recognize SMUD for leading the nation by example as it takes tangible steps to reduce the devastating effects of climate change and trailblazing the path forward for a more prosperous future.





California's Messier, but Fairer, Redistricting Process

For many decades, the decennial chore of redrawing California's congressional and legislative districts was relatively simple.

Every 10 years, following the census, legislative and congressional leaders would hire some knowledgeable number-crunchers and privately divvy up the districts for purely political purposes.

If one party controlled both the Legislature and the governorship, it would maximize its ability to remain in power. The maps that the dominant Democrats drew up after the 1980 census was the last time California saw a blatantly partisan gerrymander.

Republicans howled and persuaded voters to overturn the plan via a referendum, but the state Supreme Court ordered that the rejected maps be used anyway for the 1982 elections, in which Democrats retained their control of the Legislature and the congressional delegation.

Assembly Speaker Willie Brown publicly thanked "Sister Rose and the Supremes" for helping his party overcome the referendum, referring to Chief Justice Rose Bird. It fueled a successful drive to oust Bird and two other justices when they stood for re-election four years later.

After the 1982 election, Democrats enacted a slightly altered version of the gerrymander and then-Gov. Jerry Brown signed it just before leaving office. The congressional map was particularly slanted toward Democrats and its primary creator, San Francisco Congressman Phil Burton, laconically called it "my contribution to modern art."

Control of redistricting was the primary, if unspoken, issue of the 1990 campaign for governor and after Republican Pete Wilson won he vetoed a new set of maps drawn by Democrats, throwing the issue into the state Supreme Court. The court generated maps of its own that allowed the Republicans to make some gains in the 1992 and 1994

Democrats once again controlled the Legislature and the governorship after the 2000 census, but a partisan gerrymander was blunted by other factors, including an implicit threat of intervention by the U.S. Department of Justice under President George W. Bush.

The upshot was a bipartisan gerrymander aimed at protecting all incumbents and preserving the partisan status quo in both the Legislature and Congress, while ignoring dramatic demographic shifts, including a big surge in Latino population.

Overt gerrymandering ended a decade later, after voters approved two initiatives - hated by leaders of both parties – to shift the decennial mapmaking to an independent commission that would ignore partisan considerations,

California with a weekly draw districts to follow, where possible, city and county boundaries and preserve "communities of interest."

On the whole, the commission was faithful to its mission, but nevertheless, Democrats made big gains in congressional and legislative seats - eventually winning three-fourths of both as GOP voter strengthen plummeted.

With data from a new census - much delayed due to the COVID-19 pandemic - a new commission is working on new maps under a very tight deadline and it's been a rather messy process – a "hot mess" in the recent words of one commission member. Drafts of the new maps were released last week and it's apparent that they are likely to change quite a bit before the Dec. 27 deadline.

That said, it's obvious that Democrats will retain their overwhelming legislative and congressional supermajorities and could gain a few more seats simply because demographic trends continue to run their way.

Most of the uncertainty is in the 52 congressional districts – one fewer than before due to California's slow population growth. Democrats are struggling to retain their paper-thin control of Congress and a handful of toss-up seats in California could be the difference.

However, until the final maps are filed, no one can truly predict who will survive and whose careers will end. The process is messier than before, but also fairer.

Proposed Plans for Replacement of Water Mains

Recently I attended my neighborhood association Meeting in Citrus Heights to share my experience working with the Citrus Heights Water District to plan for the future replacement of over half of the district's water mains through 2080.

CHWD created a 24-member Customer Advisory Committee (CAC) who then worked with a technical team of engineering and financial planning experts to consider how to phase, cost and fund water main replacements. I am proud to have served on the CAC.

As a finale to a two-year long planning process, the CAC recommended a plan to replace its aging water mains before they fail causing service disruptions and adding cost to customers. It is important to note that fixing broken pipes costs more than a planned renewing or replacement.

A reliable water supply is critical to our quality of life, and failed water mains can be the cause of a lot of disruption. I support the water district's plan to replace over 70% of its aging water mains starting in 2030 and carrying through 2080 because our water is only as reliable as the pipes that supply it to our communities.

I am happy to see Project 2030 come to fruition, and I encourage my neighbors to learn more about it as well. You can learn more about the importance of Project 2030 at chwd.org/project-2030.



Dear Rusty: Social Security is deducting \$297 per month for my Medicare Part B coverage. I have what's called a "Windfall Elimination Provision" because I receive a pension from my former State employer. Prior to my 65th Birthday in July of this year, Social Security was paying me \$764 per month, but when I turned 65 they reduced my amount to \$467 per month. I read that the Part B premiums for 2021 are \$148.50, so I wonder why I'm paying double that amount? Could it be that I never enrolled in Medicare Part B and they just automatically started deducting that amount? Some sort of penalty? If so, it seems kind of high. Can you explain why I'm paying so much for Medicare Part B? Signed: **Curious About Medicare**

Dear Curious: Your Part B premium of \$297/month has nothing to do with the Windfall Elimination Provision (WEP). WEP affects (reduces) your Social Security retirement benefit amount but doesn't affect your Medicare premium. Your Medicare Part B premium is \$297/month because of a different Medicare rule \$297/month.

known as "IRMAA," which is the "Income Related Medicare Adjustment Amount." Here's how IRMAA works:

Medicare determines your Part B premium amount each year using your combined income (from all sources) from 2 years prior, so your 2021 Part B premium is based upon your 2019 income. The income amount used to set your Part B premium is called your Modified Adjusted Gross Income (MAGI), which is your normal Adjusted Gross Income on your tax return plus any other non-taxable income you may have had (including half of your SS benefits, non-taxable interest, etc.). If your MAGI is over a certain threshold, your Part B premium is more than the standard \$148.50.

The IRMAA thresholds at which you pay a higher Part B premium depend upon your tax filing status. A married couple filing jointly with MAGI under \$176,001 pays the standard premium (\$148.50 for 2021), and a single tax filer whose MAGI is under \$88,001 also pays the standard Part B premium, but income exceeding those thresholds means a higher Part B premium. How much higher depends upon how much your MAGI exceeds the base amounts above. The Part B IRMAA premium increases on a scale relative to how much your MAGI exceeds the base threshold and, from what you've only and does not represent shared, it appears that your 2019 MAGI resulted in a 2021 Part B premium of

Since you were already collecting Social Security when you turned 65, you were automatically enrolled in Medicare Part A (which is free) and Medicare Part B (for which you pay a premium), which is why your Medicare premium increased at that time. If you also have "creditable" healthcare from either your or your wife's employer ("creditable" is a group plan with at least 20 participants), you can disenroll from Medicare Part B by filing form CMS-1763 and having an interview with Social Security. That way you could save that \$297 monthly Part B premium for as long as you have other "creditable" employer coverage, and then re-enroll in Part B during the Special Enrollment Period which starts when your employer coverage ends (or shortly before to avoid a gap in healthcare coverage).

If you have retired from working and your combined income in 2020 was much lower than in 2019, Social Security will automatically adjust your 2022 Medicare Part B premium as appropriate for your combined income reported to the IRS on your 2020 tax return. If you retired in 2020, you might also wish to submit form SSA-44 (www.ssa.gov/forms/ssa-44-ext.pdf) to claim a "life changing event," which may

Is it Possible?

Of particular significance, in the spring of 2020, we met head-on the Sacramento Transportation Authority's proposal to increase the county-wide sales tax by a half percent for forty years. On July 15, 2020, after months of working on this tax increase in the middle of a pandemic, the Authority November 2020 ballot measure. Most notable to me was literally the very last comment in the report:

"(S)hould any organized opposition materialize, the measure will not be viable (on the November ballot)."

Dear co-owners of our government, we were the "organized opposition!" And, we had a resounding success.

Then in August 2020 (after pleading with the Citrus Heights City Council to reconsider placing Measure M on the November ballot to raise their sales tax by one percent with no sunset date) we faced another new battle. windmills?" Can you fight The Council was intransigent - arrogantly confident that voters would easily approve their tax increase as the Council's consultants assured them that polling showed the measure being adopted by well over 70 percent.

The City Council scoffed at us - confident in their ability to call in over \$50,000 of "pay-to-play" vendor money to push Measure M across the winning line, as well as spend thousands of public city dollars in multiple citywide mailings to every household - all proclaiming the merits of Measure M in so called "educational mailings."

It was all very daunting ... but SacTax rolled up its The result was that billions of collective sleeves and organized a "No on M" task group. With a total of about \$7,000 (from small donors) plus hundreds of coordinated hours of volunteer time and help from community leaders, in two months the citizens sent this "ugly pig" of a tax measure to its rightful grave by approximately 2,000 votes (or 52.45%).

reluctantly withdrew its with another resounding success!

In fact, if you look at all of the local tax increase and bond measures placed before Sacramento region voters in November 2020, they all passed – except for the ones SacTax actively opposed.

There is an important lesson here, we did not have to burn down buildings or destroy businesses. We did not have to deface or tear down any monuments. All we had to do was be well organized; upfront; use sound logical arguments; make our concerns known; and educate citizens. All we had to do was put leadership into practice and encourage our citizens in exercising ownership over their governments.

We had to shed light on important topics; allow government officials to realize that we must all be good stewards of public dollars; and realize that "business as usual" was not acceptable.

Lesson learned - our democratic, republican form of government works when we collectively take responsibility for it! Together, we make a difference!

Appeals court reaffirms stay on Biden workplace vaccine mandate, cites 'severe' risks - The Fifth Circuit granted a temporary stay on enforcement of the federal mandate on Nov. 6, one day after the rule was announced | 12 Nov 2021 | A federal appeals court reaffirmed its decision Friday to enact a stay on Joe Biden's workplace vaccination mandate following a legal challenge from Texas and several other states. The decision was the latest development in what is expected to be a lengthy legal battle over the mandate's legality. Texas Attorney General Ken Paxton, a vocal critic of the workplace vaccine mandate, lauded the court's decision on Twitter. "Citing Texas's 'compelling argument[s],' 5th Circuit has stayed OSHA's unconstitutional & illegal private-business vaccine mandate. WE WON! Litigation will continue, but this is a massive victory for Texas & FREEDOM from Biden's tyranny & lawlessness," Paxton wrote.

Ten States Sue Biden Over COVID-19 Vaccine Mandate for Health Care Workers | 11 Nov 2021 | A coalition of ten states led by Missouri's attorney general on Nov. 10 sued Joe Biden over his administration's COVID-19 vaccine mandate for health care workers. A federal court has blocked, for now, the regime's private employer vaccine mandate, although a stricter one focused on health care workers remains in place. The health care worker mandate, which covers more than 17 million nurses and others, doesn't include a testing opt-out. The coalition says the mandate is unlawful under federal law in part because the federal government is trying to wrest away compulsory vaccination power that has "always been the province of--and still properly belongs to--the states."

Calaveras Unified School District board votes to not 'support, enforce or comply' with vaccine mandate The vote was 5-0. | 12 Nov 2021 | (Sacramento, CA) The Calaveras Unified School District announced Wednesday it will not be adhering to the COVID-19 vaccine mandate. In a 5-0 vote, the CUSD Board of Trustees decided to "not 'support, enforce or comply with" the mandate. The decision came during a Tuesday meeting and applies to both students and staff. According to CUSD, they will discuss and possibly make a decision on mask mandates and testing protocols at a later meeting on Nov. 23.

Two million COVID-19 at-home test kits recalled over false positive results $\mid 11$ Nov 2021 | A recall of at-home COVID-19 test kits that have the potential to produce false-positive results has been expanded to include 2 million kits. The Ellume brand of test kits were manufactured between Feb. 24 and Aug. 11 and distributed from April 13 to Aug. 26. The U.S. Food and Drug Administration said 2,212,335 kits were distributed in the United States. Ellume initiated the original recall in early October saying the problem was tied to a manufacturing issue.

'I will send them to Delaware' on buses: DeSantis hits back over Biden secretly flying migrants into Florida | 11 Nov 2021 | Republican Gov. Ron DeSantis threatened this week to bus illegal immigrants to President Joe Biden's home state of Delaware should the administration continue to pay for "clandestine" flights carrying migrants into the Sunshine State. "If they're going to come here, you know, we'll provide buses and...I will send them to Delaware," DeSantis warned during a press conference on Wednesday. The governor's tough remarks came amid a lengthy polemic against the president over his handling of the ongoing immigration crisis at the U.S southern border, during which he described the secretive process that the Biden administration has reportedly used to send some 70 flights carrying illegal aliens into his state and elsewhere around the country.

City Focuses on Recovery

Continued from page 1 and staff "remain committed to serving the community."

Mayor Miller provided an overview of some highlights from the past year, such as the many safety improvements completed throughout the city. Staff completed improvements to sidewalks, curbs, and gutters on 13 streets throughout the city as part of the Accessibility and Drainage Project, in addition to major pavement repairs on 18 neighborhood streets under the Residential Street Resurfacing Program. There were also city-wide updates to more than 580 streetlights, which were converted to energy-efficient LED lamps. And traffic safety improvements, such as installing countdown pedestrian signals and replacing outdated traffic signals, were completed under the Multimodal Transportation Safety Program.

The City also finalized the design for the citywide Arcade-Cripple Creek Trail, which will connect eight local parks and provide access to other regional trails. And this summer the Citrus Heights Police Department (CHPD) launched a comprehensive program to educate the public about fireworks safety and the City's urgency ordinance on illegal fireworks.

Mayor Miller said new developments in the city saw a "huge construction boom," including the new Mitchell Village neighborhood. And construction commenced on the Sunrise Pointe Supportive Housing apartments and the 46-home Abby's Gate project on Mariposa Ave. The City also approved a deal with Woodside Homes to purchase and develop the 11-acre New Sylvan site.

This year also saw the retirement of City Manager Chris Boyd, who then agreed to stay on as interim city manager during the recruitment process for his replacement. Boyd was the

and Mayor Miller said, Mall site "the communifrom Chief of Police to City Manager is among one of the best things I believe our Council has done for the city. He came into the position with a looming budget shortfall and has met so many of our city's goals despite that challenge. Thanks to his leadership, we have weathered a pandemic while keeping all our city services open, launched economic development plans to secure a bright future for our city, and he undertook massive efforts to balance our budget and remain committed to fiscal prudence."

Interim City Manager Chris Boyd said, "We've had another robust year, and I continue to be so proud of our City Hall and Police Department staff for pushing through projects and initiatives for this community day in and day out, despite a lean budget and limitations from the pandemic."

Boyd said some of the most important concerns in the community are economic development and public safety, and he highdevelopment project that is currently underway the Sunrise Tomorrow Specific Plan. He said the plan "signifies responsible future stewardship and the funding from Phase smart growth planning." After approval, the Specific Plan will introduce new uses for site, streamline future development review, increase flexibility for redevelopment, and triple the development allowed on the site. Boyd said the "end goal" is to "attract and retain diverse and resilient industry sectors with relevant and amenity-rich development potential."

Throughout the challenges of the pandemic, Boyd said the economic development staff focused on overall business attraction and Covid recovery for local businesses. And he shared numbers that indicate a robust economic recovery in underway in Citrus Heights. The numbers of new and renewed business licenses issued in 2021 was well above the rates in both 2020 and 2019, and the City is issuing an average of 83 new business licenses each month. "This is a testament to our economic development efforts to attract, foster, and retain lighted the most exciting businesses, both big and small, but also a nod to our streamlined business license process," said Boyd.

On the topic of public safety, Boyd said that 1 of the City's federal city's first Chief of Police, called the 100-acre Sunrise used to reinstate 22 police

department positions over the next two years, and the department is launching an aggressive recruitment campaign to build staffing back to pre-pandemic levels.

Even with limited staff, Boyd said the CHPD has met the goal of reducing crime, with burglaries down about 60% and stolen vehicles down about 80%. "However, there is an uptick in violent crime as is consistent with the nation at large," said Boyd. He said the CHPD's new chief, Alex Turcotte, who was appointed in August, is focused on keeping residents safe and improving the quality of life for everyone. "I was truly honored to appoint such a hardworking, accountable, community-driven leader to usher the Citrus Heights Police Department into its next era," said Boyd.

"Our men and women in blue serve alongside our residents, working with the community in a serviceoriented, collaborative way," said Boyd, and he thanked Citrus Heights residents for their support of the CHPD.

As he works on recruiting the next city manager who will "lead the city into a new chapter," Boyd said, "I look forward to continuing to support this community in an unofficial capacity, and I have no doubt that the future of Citrus Heights is incredibly bright."

allowed on the site, creating an opportunity for the community to diversify its economy, attract quality industry sectors like medical and tech, and more; Streamlines future development review, so that projects aligned with the Sunrise Tomorrow vision can be expedited, saving developers time and money; Allows flexibility for redevelopment, empowering responsiveness to changes in the market; Fulfills CEQA requirements and mitigates development risk, which is one of the most impactful ways local government can stimulate redevelopment; Aligns market demand with community vision, building grassroots, local support in favor of re-imagining the Sunrise Mall site.

"Our specific plan lays the groundwork for transforming the Sunrise Mall site into a vibrant mixed-used community creating a destination for our residents to live, shop, work, and play," said Boyd. "And while the plan is momentous in that right alone, I also know that this project has the potential to serve as a national case study in how local government, when armed with motivated staff and an engaged community, can influence real, meaningful change when it comes to economic stewardship."

The Sunrise Mall will remain open through redevelopment, which will be completed in phases, likely starting with converting the surplus parking. The City encourages the community to continue to shop and attend events at the Sunrise Mall. The Specific Plan implementation is flexible and incremental. Sunrise Mall will continue to operate, but if/when it cannot any longer, this plan will serve as a toolbox for accelerated revitalization.

Phase 1: (Ready Now) Redevelopment of former Sears as a Dining Entertainment District, Retail, Limited-Service Hotel, Residential, and Open Space. Phase 2: (Employment Anchor) Redevelopment of Macy's Men & Home as Creative Office Campus, additional Retail and Dining, Extended Stay Hotel, Residential, and Neighborhood Park. Phase 3: (Mixed-Use Main Street) Redevelopment of Sunrise Mall as mixed-use Main Street with Retail, Dining, Office, Residential, Full-Service Hotel, and Central Open Space. Phase 4: (Longtime Opportunities) Redevelopment of JCPenney and Macy's Women as mixed-use district with Office, Retail, Open Space, and Residential.

Now that the Sunrise Tomorrow Specific Plan has been adopted, mall owners may begin redeveloping their properties in alignment with the plan's new uses and zoning. The Specific Plan was guided by "Five Big Ideas," that reflect feedback from the community and stakeholders: Community & Regional Destination, Green Network, Streets for People, Livable Neighborhoods, and Economic Engine.

When paired with in depth research and data around the types of development that are realistic for the Citrus Heights market, the Five Big Ideas evolved into a site plan, which staff refer to as a "21st Century Main Street" concept. The concept includes:

A walkable "main street" through the center of the property featuring dining, retail, and entertainment; New employment anchors, solidifying the site as an employment hub for the region; A new town square for Citrus Heights, nick-named "Sunrise Commons," with space for community events year round; Entertainment anchors to create a community and regional destination with family oriented entertainment options; Hotels providing full-service, boutique, and extended-stay hotels to serve a range of travelers; Housing with connected neighborhoods that provide a variety of choices and amenities for high quality of life; Open space featuring a network of parks, plazas, and streets that are safe, connected, green, and healthy.





Doing business with friends always comes with the risk of running into a situation that can damage the relationship. Am I saying never do business with friends? Of course, not. I

do a lot of business with friends. I just make sure all the specific requirements and expectations of the business relationship are laid out in clear detail, in writing, and fully understood by both parties before a deal is struck.

Sometimes friends have unrealistic expectations when it comes to doing business together. The friend who's renting may think the friend who is the landlord will give him a pass if the rent is late, and on a dozen other things. The friend who is the landlord may think the renter will be a perfect tenant, because they're friends, and find out the hard way his buddy's a slob who care of the property. All these things should be ironed out ahead of time and before the agreement is signed.

You might want to make sure, too, he understands the need to come talk to you if a situation arises where he may be late with a payment, or not be able to pay the rent one month. Most issues like this can be worked out, but he needs to understand - and it's your job to tell him ahead of time, in a kind-but-firm manner - you're not running a charity.

Just be friendly, straightforward and businesslike. If you have to enforce the rules, do it consistently and with fairness. Likewise, if a situation pops up where a little grace and understanding are appropriate, provide those as well.







FAIR OAKS, CA (MPG) - The Fair Oaks Recreation and Park District (FORPD) hosted a ribbon-cutting ceremony on November 4, to celebrate the opening of Jim Streng Park, located on Swallow Way off of Hazel Ave.

The new park is named for respected Fair Oaks resident Jim Streng. He and his brother Bill started Streng Brothers Homes in the 1950s, constructing thousands of mid-century modern homes through-Streng homes are characterized by their open floor plans, low-pitched roofs, and bountiful natural lighting. "Today Streng homes remain iconic, and they remain highly prized," said FORPD Director Ralph Carhart.

In addition to his successful career, Jim Streng also served on the Sacramento County Board of Supervisors from 1986 until 1992. And his unwavering dedication to improving the community and working on bipartisan issues earned him respect and admiration from both constituents and colleagues.

"He's been an advofor persons with disabilities, clean air, anti-smoking, local transportation improvements, the American River Parkway Foundation, and the UC Davis health system," said Carhart. "Moreover, Jim is highly respected as a kind, honest, and compassionate gentleman. When we built naming it for Jim Streng was with students from Meraki

District 3 County Supervisor Rich Desmond spoke at the ribbon cutting event and acknowledged the out the Sacramento Region. challenge of building a new park in such a well-established neighborhood. "This is something so wonderful, something to be proud of," said Desmond. "What a great place for this neighborhood. And to honor such a wonderful gentleman."

Supervisor Desmond complimented Streng as a "throwback to an era of a lot more collegiality and decency in politics." He said naming the new park after Streng is "just wonderful for the community, and it's so appropriate."

Jim Streng addressed the crowd at the ceremony: "I thank the Fair Oaks Recreation and Park District for all that they do for Fair cate and activist Oaks, and I'm extremely for bicycling, sports honored and pleased to have the name Streng associated with this beautiful park."

Attendees filled the new park to celebrate Jim Streng and enjoy the new playground, which offers a variety of climbing features and a natural play area. Aho said the District didn't want to build a typical pocket park in this space, so they "decided to do something a this park, it was clear that little different." They worked

High School in Fair Oaks, who conducted a community planning process and came up with a variety of ideas that led to the final design.

"It's very exciting to open an opportunity for people to play, especially for the kids. And it's really fun to be able to see the opportunity for all ages to play in a park, and that's how this park was designed. It really is designed for the kids, but yet for those adults that are a little more adventurous, it still has that element of fun or play," said District Administrator Mike Aho.

The budget for the park totaled \$881,904, with \$200,000 coming from Measure J funds, \$250,000 from California Prop. 68 funding, and the rest coming from the District's Park Impact Fees.

John O'Farrell, Chair of the FORPD Board of Directors, said, "It's amazing how many people came out here today to support the opening of the park and to recognize Jim Streng. ... He is truly a gentleman." O'Farrell also acknowledged the opportunities created by the Measure J bond, which residents approved back in the 2018 election: "Now we are investing in the future of all these little ones that are enjoying the park."
