# CHPD to Reinstate 22 Positions

CITRUS HEIGHTS, CA (MPG) - At the June 24, 2021 City Council meeting, Interim City Manager Chris Boyd and staff recommended a budget amendment to Council to allocate a total of \$5,353,210 from the City's portion of 2021 American Rescue Plan Act the Citrus Heights Police Department unanimously by Councilmembers and staff will immediately begin the recruitment process for filling the now-funded vacant positions. While \$2,541,434 in Fiscal Year 2021-22

several of these positions may be and \$2,811,775 in Fiscal Year 2022filled immediately, the extensive training may take many months to complete. A total of 28 positions were originally left unfunded in order to balance the City's two-year budget.

The City of Citrus Heights is set to receive a total of \$15,676,972 of funds to restore 22 positions within Federal ARPA funds for COVID-19 relief and economic recovery, with for Fiscal Years 2021-2022 and 2022- one-half of the funds (\$7,838,486) draft Interim Final Guidelines iden-23. The amendment was approved received in May and the remaining tify the rebuilding of public sector funds to be distributed in May 2022.

The City Council received an extensive update from staff on ARPA funding on June 10, 2021. # **Capital Improvement Construction Is Underway**

CITRUS HEIGHTS, CA (MPG) - At its July 8 meeting, the Citrus Heights City Council heard updates about capital improvement construction projects. City Engineer Leslie Blomquist highlighted projects that are underway or slated to begin soon.

The 2021 Residential Street Resurfacing Project will begin mid-July on 14 neighborhood streets: Blowing Wind Way, Carol Ave., Celestial Way, Covewood Ct., Creekmont Way, Daly Ave., Flaming Arrow Dr., Forbs Way, Glass Slipper Way, Hatfield Ct., Maidstone Way, Picnic Ct., Scribner Ave., and Three Sisters Ct. The \$1.3 million project is funded by Senate Bill 1 (SB 1) Road Maintenance Rehabilitation funds and the Gas Tax.

energy efficient models; 522 have already been completed. The total budget for the project is \$560,000, with \$540,000 funded through a low-interest loan from California Energy Commission and \$20,000 coming from SMUD rebates and incentives. After completion, there will be a \$31,200 reduction in annual energy costs. Those savings will be used to pay back the loan over the next 15 years. The project is expected to be completed this September.

Construction on the Various Signalized Intersection Safety Improvements project will include upgrades to 30 intersection signal indicators, upgraded pedestrian countdown indicators at eight intersections, ADA upgrades at two intersections, and The LED Streetlight installation of median fenc-Conversion Project will ing at the Greenback/Auburn

intersection. The new signal bike lanes, street lighting, heads will improve visibility and should help reduce the frequency of intersection collisions. After project completion, all the signals in the city will have the pedestrian countdown feature, which has been shown to reduce pedestrian-involved crashes at intersections. The project totals \$949,819 and is funded through various grants such as the Community Development Block Grant (CDBG), Highway Safety Improvement Project (HSIP), Tire-Derived Aggregate (TDA), Transit Impact funds, Measure A funds, and Storm Water Utility fund. Construction started in June and is expected to be completed in October.

Construction also started in June on Phase 4 of the which will include installation of new sidewalks,

upgraded traffic signal at Madison/Mariposa, and five new ADA accessible curb ramps. The project budget is \$1.4 million, funded by the Active Transportation Program (ATP) grant and Measure A. Work is expected to be completed this October.

A variety of county-shared projects are also underway on roads that have shared jurisdiction between Citrus Heights and Sacramento County. Road repairs and resurfacing are in progress on Madison Ave., including video detection at signalized intersections, repaving, replacing damaged median noses, and restriping. Kenneth Ave. is also being resurfaced, in addition to upgrades at the Kenneth/ Wachtel/Oak intersection Mariposa Avenue Safe such as ADA compliant Routes to Schools project, curb ramps, replacing damaged curbs and sidewalks,

# **Medication Users Need** To Know **Summer Heat Risks**

SACRAMENTO COUNTY, CA (MPG) - As the weather heats back up it's important for everyone to have a plan for staying cool and hydrated. It is especially important for those who may be extra susceptible to heat and dehydration due to certain medications.

Some medications can impair the body's ability to regulate temperature. During hot and humid weather, individuals taking medications can be at increased risk of developing excessive body temperature, or hyperthermia.

"Individuals taking certain medications, including those used to treat mental illness, need to take extra precautions to ensure they have a plan for staying cool and hydrated," says Dr. Ryan Quist, Sacramento County Behavioral Health Director.

Those with chronic medical conditions are especially vulnerable, e.g. heart and pulmonary disease, diabetes and alcoholism, etc. Heat exhaustion is the most common heat-related condition, which is most likely to occur in people who are involved in physical activity outdoors during heat waves.

Keep as cool and hydrated as possible: drink plenty of water, avoid spending time outside, especially during the hottest part of the day, and limit outside activities as much as possible. Cooling down a few hours a day will allow the body to recover and tolerate the heat better for the rest of the day.

"It is important for individuals to continue taking their medications as prescribed," says Quist. "Those with questions or concerns regarding medications and heat should contact their prescribing clinician."

Don't get caught unprepared as temperatures keep reaching into the triple digits. Have a plan to stay cool, stay hydrated and be aware of the signs and symptoms of heat-related illness.

# Get Ready for the Unexpected Celebration of Life - James N. Rounsavell with a Disaster Go Bag

SACRAMENTO REGION. CA (MPG) - Don't think you need an emergency kit? Think again, say families who needed one.

Flashlights, bottles of water, a first aid kit, and ready-to-eat meal packs line the Royal family's dining room table. The family isn't going camping—they're preparing for disaster by putting together a "go bag."

Preparing in advance with a disaster-ready kit has helped families nationwide through extreme and abnormal weather events, which experts warn are on the rise.

Having lived in California all their lives, Sacramento residents Warren and Laurie Royal know the possibility of disaster. The Royals have even seen the Sacramento Valley impacted by disasters outside of fire season. "We have had our share of surprises. In the past, floods have devastated parts of the Sacramento Valley," said

Warren. "Preparing a go bag can be somewhat daunting. Our family has found the resources regarding disaster preparedness on the website jw.org especially helpful. Practical, common sense suggestions are available to make preparation and execution of a disaster plan much

"Having a personal preparedness plan increases your chances of staying safe," according to a training program from the Columbia University's National Center for Disaster Preparedness.

easier."

Jolted awake by a neighbor's urgent knocking, Aaron and Jacqueline Pate were horrified to see the encroaching flames of the fast-moving Woolsey fire that had been miles away when they went to bed. It burned to within 100 feet of their Westlake Village home in 2018 as part of California's deadliest wildfire season on record.

"Because we had go bags, we weren't running around trying to pack things at the last minute," said Jacqueline.

"We had the time we needed to comfort our kids and get everyone safely into the car."

The Pates credited the disaster-preparedness help they received as Jehovah's Witnesses, both through periodic reminders at their congregation meetings and from tips for putting together go bags on the organization's website, www.jw.org.

"Life is precious, so we encourage all to heed the Bible's advice to take practical steps to protect ourselves from danger," said Robert Hendriks III, spokesman for Jehovah's Witnesses in the United States.

Go bags also have proven useful in the opposite circumstances as "stay bags."

Administrative Services Director Bill Zenoni, who is head of the City's Finance Department, explained that staff feel there is enough clarity on that specific element of the guidelines, which is the basis for the latest budget amendment to support the Citrus Heights Police Department.

As mentioned in previous updates, there are two phases of proposed ARPA spending in Citrus Heights:

Immediate amendment to the Police Department budget, to utilize one-time ARPA funds to restore 22 positions for Fiscal Years 21/22 and 22/23; Ongoing community engagement, including education around the Treasury's guidance as it is further defined and collecting input and ideas on applicable spending for remaining funds.

With the Police Department budget amendment approved, CHPD will begin its process of recruiting and training. "The men and women who serve the Citrus

Heights Police Department are committed to delivering the highest quality of service to our community," said Police Chief Ron Lawrence. "Our recruiting and training processes emphasize empathy, professionalism, and care. Our department has become well known for our partnerships with our community, and we continue to work with our businesses and residents to keep Citrus Heights safe." As the Police Department looks to fill 22 positions, they would like to remind the community that the recruitment and training process takes time; some positions may not be filled until the end of the calendar year, and only 22 of the 28 vacant positions are funded with the ARPA funds.

City staff will continue to provide updates on ARPA funding and engage the community, as Citrus Heights received further clarification on the Treasury guidelines and moves into the second phase of its Federal relief spend-

# Sac County EMS Leader Named Director of the Year

SACRAMENTO COUNTY, CA (MPG) - Brave, dedicated, willing and reliable - these words describe the 80,000 licensed or certified Emergency Medical Services (EMS) providers in California. They demonstrate these qualities every day by coming to the aid of others when they are most in need and working to ensure that the EMS system operates well. However, each year, due to circumstance or extraordinary effort, certain individuals among

us shine.

named as the 2020 EMS
Medical Director of the
Year for his heroic acts
and extraordinary contributions to EMS by the
California Emergency
Medical Services
Authority (EMSA) earlier
this month.

The EMSA seeks to recognize those individuals through the California Emergency Medical Services Awards Program. The awards program honors special accomplishments, meritorious and heroic acts, innovations or

fresh ideas to improve EMS in the state, or other unique and/or significant contributions by EMS personnel, physicians, nurses, EMTs, other medical providers, local officials, members of the law enforcement community, citizens, and first responders.

Dr. Garzon was selected for his tireless efforts and selfless leadership during the COVID-19 response. Through a long career in disaster response, Dr. Garzon learned how to organize a systematic approach and efficiently mitigate a large-scale incident.

During the pandemic, Dr. Garzon assisted the state by building models and predictive theories, enabling local and statewide leaders to be better prepared to respond to the approaching "storm" of patients. He continued leading one of the largest EMS systems in the state, guiding the development of an "Emerging Infectious Disease" policy that provided direction and clarity to the greater EMS community about a sensible approach to preventing transmission of the COVID-19 virus, mitigating the spread of the disease among the workforce, and safe return to work guidelines.

"I most enjoy working on EMS system-wide and quality improvement issues, because I see that as the key to ensuring the highest quality prehospital care for all people in Sacramento County," said Dr. Garzon. "I also still enjoy Emergency Department shifts and caring for patients."

When asked what a typical work day might look like for him, Dr. Garzon said "between clinical work, EMS work, and COVID-19 work with EMSA/CDPH in the last vear, I don't really have a "typical' work day. Of late, they have generally started with multiple conference calls, and a mix of Sacramento and State EMS work, as well as CDPH work for COVID-19. Several times a month I also get to throw in late afternoon Emergency Department shifts to round it out."

Dr. Garzon's Notable COVID-19 Projects: Assisted EMSA with the State EMS COVID guidelines and response; **Developed a template** for local EMS tiered response during COVID surge; Developed a Hospital COVID-19 Burden Score to rank hospital strain with COVID-19: Lead the effort to write state pandemic crisis care guidelines, Assisting with development of the Alternate Care Site (ACSs) operations guidelines; Facilitated patient inter-facility transfers to off-load over-burdened hospitals during COVID-19 patient surges; Developing a simple growth model to project ICU availability that was used to determine when the State entered and exited the Stay-At-Home-Order.

Sacramento County Department of Health Services has tremendous gratitude and thanks Dr. Garzon for all his important work. Please join us in congratulating him on this achievement.


Garrison Keillor made the Lutheran potluck famous in his "A Prairie Home Companion" stories from 1974 to 2016.

and restriping to narrow the travel lanes and install bike lanes. Residents have frequently identified that intersection as a safety concern, so other traffic calming measures have been implemented: Right-turn yields have been replaced with full stops and large sidewalk bulbs will reduce the intersection size for shorter pedestrian crossings.

For the county-shared projects, the City's portion of the costs will be a maximum of \$1.5 million, funded through SB 1. The actual amount will be billed based on the work completed in the City's jurisdiction. Construction on these projects started in May and should be completed later this month.

The Council also heard a report from the Citrus Heights Police Department (CHPD) about the response to illegal fireworks over the July 4 weekend.

CHPD Chief Ron Lawrence said, "There was a tremendous amount of fireworks, both safe and sane as well as illegal fireworks, throughout the Sacramento region." He said that the level of illegal fireworks this year far exceeded what's been seen in years prior.

The Council passed a temporary urgency ordinance in June, giving the CHPD authority to issue citations to event hosts at locations where illegal fireworks were set off. The administrative fine is \$750 for a first offense, and \$1,000 for each subsequent offense. But enforcing the ordinance is challenging; illegal fireworks explode in the air, making it difficult to determine where they originated. And tips from the public often provide general areas, leaving officers searching for a specific location after the fact.

CHPD had a dedicated enforcement team of six officers, supported by 10 additional patrol officers during the peak hours of 9:00 PM to 12:00 AM. Officers did witness one illegal firework incident and were able to cite the violator on the scene. Another 16 possible violations were also identified; these have been referred to code enforcement for review, and citations will be issued if appropriate.

Over the 48-hour period of July 3 and 4, CHPD received 457 fireworks-related calls—53% of total calls during that weekend. These calls strain 911 operations and stress an already under-manned police force.

Councilmember Jeannie Bruins said, "I'm just appalled at the volume that has more than doubled since last year." She asked if there is any information about why this year was so much worse than usual, but CHPD Acting Commander Wes Herman said he could only speculate. No one has a definitive answer about the increase and determining the source of the illegal fireworks would likely need to be a state-level operation.

Councilmember Tim Schaefer said he was "stunned" by the level of explosions in his neighborhood. He asked that CHPD update the Council about the outcome of the 16 possible citations to help inform the Council about whether the ordinance should be made permanent

Councilmember Bruins said the Council should seriously consider making the ordinance permanent to let the public know how important it is to curtail illegal fireworks. She also suggested bringing the issue to the County Supervisors as well as elevating it to the state level.

Mayor Steve Miller said, "The end game here is if we can't get a handle on these illegal fireworks, it's going to be all fireworks. And nobody's going to be happy. ... I don't want to go there. I think safe and sane have a place in our celebrations, and hopefully we can get a handle on this."

# Citrus Heights Police Crackdown on Illegal Firework Hosts

CITRUS HEIGHTS, CA (MPG) -

This year, the Citrus Heights City Council adopted a temporary social host ordinance designed to deter the use of illegal fireworks. The goal of the program was to hold event hosts responsible for allowing the use of illegal fireworks at their gatherings. Every year, the use of fireworks increases the chance for injuries to people and damage to buildings in our community.

On July 3rd and 4th, the Citrus Heights Police Department received approximately 457 firework related calls for service through our dispatch center. In addition to these firework calls, the department handled an additional 396 routine calls for service (crimes in progress, medical aids, traffic collisions, domestic disputes, etc). approximately 53% of the

received during this time frame. The community provided 264 online tips related to fireworks in their neighborhoods. Similar to Citrus Heights, reports from other neighboring jurisdictions in the Sacramento region confirmed they also experienced an overwhelming number of firework related

During the holiday weekend, Citrus Heights patrol officers seized approximately two dozen expended illegal fireworks and identified 16 social hosts who were in violation of the temporary ordinance. These hosts will be receiving an administrative citation from the city's Code Enforcement unit starting at a \$750 fine for the first offense.

the reported illegal fireworks calls were made by community members who gave general areas for aerial fireworks and were unable The firework calls represent to provide specific locations, making it difficult

853 total calls for service for responding officers to identify responsible parties. This appeared to be a common challenge throughout the region making if difficult to enforce these ordinances.

The City of Citrus Heights utilized social media platforms to communicate with the community about the new temporary social host ordinance and the permitted hours for the use of legal fireworks.

The City of Citrus Heights experienced a total of three structure, or outbuilding, fires during these two days and eight brush fires. While fireworks were a possible cause for a couple of the brush fires, none were confirmed as the source of ignition.

# **SASD** Addresses Increase in Cockroaches

Sacramento Area Sewer District

SACRAMENTO REGION, CA (MPG) - The Sacramento region has seen an increase of cockroaches this season and because these pests like dark, damp places, Sacramento Area Sewer District (SASD) is taking measures to address cockroaches in the sewer

The Sacramento Area Sewer District SASD owns and operates 4,600 miles of sewer pipelines, including 67,000 sewer area. manholes. Many dark and damp environments, including landscaping, storm drains, crawl spaces, and sewer systems, can attract cockroaches. Over the years, SASD has used several cockroach control methods to address customer concerns and discourage cockroaches from inhabiting the sewer system.

What is SASD doing to control cockroaches?

When a customer calls (916-875-6730) with a concern about cockroaches in the sewer system, SASD investigates within 2 hours. If the investigation confirms cockroach activity, SASD uses a number of proactive and reactive measures including:

Fogging and Baiting: SASD works with qualified pest control specialists to perform a pest control treatment where an insecticide fog is released that instantly kills roaches in the manhole, and bait is left behind to kill other roaches. After the treatment, we monitor for the effectiveness and re-treat when necessary; Manhole Painting Pilot Project: Recently, SASD implemented a new proactive pest control method called "manhole painting" that has the potential to be a more effective long-term cockroach control solution; Preventative Maintenance Program: In locations where SASD's sewer pipes have a repeat history of cockroach activity, SASD performs ongoing inspections and cleanings to further address the issue.

What is "manhole painting"?

Manhole painting is a pest control treatment process where latex paint that contains an insecticide is applied to the inside walls of a manhole. The goal is to provide a longer-lasting insecticide to

eliminate cockroaches over time. As part of a pilot project, 1,100 manholes were painted throughout SASD's service area, with the goal of fewer roaches in the sewer system and fewer customer concerns. Once manholes are painted, SASD will conduct ongoing inspections to determine how effective this new method is. The pilot continued through December 2020 and SASD will implement this approach on a broader scale across SASD's service

Are these cockroach control methods safe?

Yes. SASD's mission is to protect public health and the environment. As part of that commitment, SASD has worked with the Sacramento Regional County Sanitation District and others to ensure all eradication methods meet local, state, and federal requirements for the protection of public health.

What if I see cockroaches after SASD has already come out?

If fogging and baiting was performed: Please allow 7-10 days from the date this was completed before calling to report cockroaches. While this method is highly effective, it may take several days to work completely; If the manhole was painted: Please allow three weeks from the date SASD came out to perform the inspection. As the goal is to provide a longer-lasting insecticide that kills cockroaches as they continue to enter the area, allow time for the treatment to affect as many cockroaches as possible. At the threeweek mark, SASD will come back out to re-inspect the manhole and determine the appropriate next steps; SASD does not address cockroach issues on private property. If you see cockroaches on your property or in your home, please consider performing pest control treatment or contacting a pest management company, just as you might do for any other propertyinvading pest like ants, wasps, termites, or

# California has a Segregation Problem

Deeply blue California's top political figures, from the governor downward, portray the state as a model of multicultural integration.

In fact, however, as a new study from UC-Berkeley's Othering & Belonging Institute reveals, most California metropolitan areas have high levels of racial segregation in housing and it has become more pronounced over the last two decades. Oddly, too, California's segregation tends to be highest in areas most likely to lean to the left politically.

The Los Angeles-Long Beach-Santa Ana metropolitan area, the study found, is the nation's sixth most segregated region of 200,000 residents or more. Other California areas with high levels of segregation include San Francisco-Oakland (25th), San Diego (38th), San Jose (45th) and Sacramento (82nd).

Of the 11 California regions on the report's "high segregation" list, only two, Bakersfield (37th) and Fresno (72nd), hew to the right politically. The San Luis Obispo-Paso Robles area, which also is somewhat conservative politically, is one of only two regions in the nation deemed to be highly integrated, the other being Colorado Springs, which is a Republican bastion.

Okay, so California is not the exemplar of integration it often pretends to be. But isn't the state trying to make its housing patterns more inclusive?

Officially, yes. State housing guidelines and recent legislation seek more integration of multi-family housing into what have been exclusively single-family neighborhoods as determined by local zoning laws. A mixture of housing types, it's argued, would create more neighborhood diversity.

Those efforts, however, have faced stiff opposition in suburban communities where single-family homes predominate, with the fiercest resistance in suburbs dominated by Democratic voters, such as Marin County.

The outcome California's housing war remains in doubt. However, as California pursues – at least on paper - more integration in housing, it seems to be encouraging more segregation in political representation through a concept called "community of interest" or COI.

When California's Citizens Redistricting Commission, created by a statewide ballot measure, first tackled the redrawing of legislative and congressional districts in 2011, it assumed that one of its jobs was to identify COIs and make them a dominant factor in redistricting.

The commission is just beginning to do its work a journalist for nearly 60 again, using still-to-bereleased data from the 2020

more emphasis on COIs, although how to define them remains uncertain.

The current commission is staging "COI input meetings" around the state and seeking participation but admits in its latest invitation that "there are no clear rules on how to define a community of interest."

It's assumed that under federal law, redistricting plans must not inhibit the ability of ethnic and racial groups to elect representatives. To insulate the new maps from legal challenge, the commission will use data on concentrations of potential voters (over the age of 18 and citizens) to create "majorityminority" districts that, in effect, preordain the election of legislators and congressional members from the designated communities.

Although California's overall population has seen only scant growth over the last decade, whites have continued to decline proportionately while Latino and Asian populations have increased. Thus, as the state's leading redistricting expert, Paul Mitchell, has written, "it's more likely than ever that the data will tell (the commission) there are more majority-minority districts that need to be drawn than ever in light of heightened segregation within our cities and counties.'

So on one hand, California officialdom says it wants to lessen segregation in housing, but on the other hand it wants to reinforce racial and ethnic segregation in legislative and congressional districts. That's California in a nutshell.

> The calculation of Republicans supporting the deal is that a significant bipartisan package can take some of the heat off of Sens. Joe Manchin and Kyrsten Sinema in their resistance to eliminating the filibuster.

A deal that passes and shouldn't be to get on is signed into law will board a historic spending certainly be a feather in their caps, but it's hard to believe they'd change their minds on the filibuster if the deal fell apart.

They are both so extensively and adamantly on the record in favor of the filibuster that a climbdown would be politically embarrassing and perilous.

Republicans supporting the deal also think that it will make passing the subsequent reconciliation bill harder. First, the parts of infrastructure that have the widest support – roads and bridges – will be

reconciliation bill. Second, the unwelcome tax increases excluded from the bipartisan deal will be in the reconciliation bill.

This isn't a crazy calculation, although it's not clearly correct either. The higher the top-line number is for the reconciliation bill, the harder it will be to pass. By allowing Democrats to cleave off some spending into a bipartisan deal, the overall number for the reconciliation bill gets smaller. In other words, the bipartisan deal could make the partisan reconciliation easier, rather than harder, to pass.

It's not as though Biden is fiscally prudent on all other fronts except in this one area, which he considers a particularly important national investment with unmistakable returns. No, he's universally profligate. His reckless spending on all fronts (except defense) makes it more imperative for Republicans to stake out a position in foursquare opposition.

The bipartisan deal is hardly exemplary legislation, by the way. It resorts to all the usual Beltway gimmicks to create the pretense that it's paid for, when it's basically as irresponsible as the rest of the Biden spending.

Bipartisanship has its uses, but so does partisanship. Joe Biden wants to be known for his FDRand LBJ-like government spending, believing that it's the key to political success and to an enduring legacy. Fine. Let him and his party own it.

Trump easily wins CPAC 2024 GOP presidential nomination straw poll | 11 July 2021 Former Presidenty Donald Trump easily won the 2024 GOP presidential nomination poll at the Conservative Political Action Conference (CPAC) gathering this weekend in Texas. # **Social Security Matters** When Should I Claim My Survivor Benefit?

Dear Rusty: My wife passed away in 2014. I'm 60 years old and have been retired since August 2020. I know I'm entitled to survivor benefits, but my question relates to when to file for them. To say the information online is confusing is an understatement. Some background. My wife was born in 1960 and would have turned 62 next year. I was born in 1960 and turned 60 this past April. I do not plan on taking my SS until age 67 (I could wait until age 70 if it is more beneficial). I have not remarried. When should I file for survivor benefits to maximize the benefit? Signed: Surviving Husband

D e a r Surviving Husband: Survivor benefits reach maximum when you reach your full retirement age (67), but you can claim a reduced survivor benefit as early as age 60. The amount of your survivor benefit will be determined by a) the benefit your wife had earned up to the month she passed, and b) your age when you claim the survivor benefit. At age 67 you would get 100% of the amount your wife was entitled to when she passed; if you claim at age 60 you would only get 71.5% of the benefit amount your wife had earned up to her death. The reduction may,



you depending on your personal circumstances.

First, you should be aware that if you claim your survivor benefit before your full retirement age (FRA) and return to work, you'll be subject to Social Security's earnings test which limits how much you can earn before SS takes away some of your benefits. The earnings limit for 2021 is \$18,960 (changes annually) and if that is exceeded SS will take back benefits equal to \$1 for every \$2 you are over the limit. The earnings limit applies until you reach your full retirement age, although the limit is much higher and the penalty less severe in the year you attain FRA. If your earnings prior to your FRA are high enough, it could disqualify you from receiving a survivor benefit. Of course, if you are not working and do not plan to return to work, the earnings

test is not a concern. Assuming you are fully retired from working, here

are some things to consider: Claiming your survivor benefit now at age 60 would permit you to receive 71.5% of the survivor benefit for at least 7 years (until you reach your FRA), or perhaps longer until you are 70. Although the survivor benefit would be reduced, claiming it at age 60 would also permit you to delay taking your own Social Security benefit until age 70 when your personal benefit would be 24% more than or may not be, acceptable to it will be at your FRA. The

above would be prudent if your age 70 (or 67) benefit amount will be higher than the survivor benefit you would be entitled to at your full retirement age.

 If your survivor benefit at your FRA would be more than your own benefit will be at age 70, then it would be wisest to maximize your survivor benefit. To maximize your survivor benefit you must wait until age 67 (your FRA) to claim it. If your full survivor benefit will be the highest you can get, then maximizing it by waiting until your FRA to claim it is your smartest

So, as you can see, you have a choice of when to claim your survivor benefit. If your personal benefit at age 70 would be higher, it would be wise to claim your survivor benefit first (at age 60) and collect the reduced survivor benefit until you later switch to your own higher benefit. But if your survivor benefit at maximum would be more than your age 70 benefit, then waiting until your full retirement age of 67 to claim your survivor benefit would be your best choice.

Your perception is your Golden



Don't get offended by the actions of others and don't take things personally. You have no control over what others say, think, or do. You do have control over your response. You are in charge of your emotions.




While some emergency situations like Annette's can't be avoided, Darren does stress how important it is to know the health and safety of your trees. If a tree looks like it could be endangering your home/property

# What is a Retiree HRA Account?



Hi Toni:

My husband is an oil company retiree and two weeks ago, we received a letter stating that his employer is terminating current Medicare eligible retirees group

benefits with a termination date of September 30, 2021, when the plan renews.

His employer has chosen a specific HRA company to help us choose the right Medicare and Part D options and assist with administering the HRA account that pays our insurance premiums. My husband and I will want an appointment with your office to sort out what is the right option for our retiree benefits.

We do not want a major catastrophe by making the wrong decision for our future Medicare needs.

I have good news for you because I personally attended an Employer Retiree Educational Seminar recently. The seminar was professionally presented with the speaker making sure that all the Retirees questions were answered.

The insurance rep advised all that attended to discuss with their doctors, hospitals, and pharmacies which Medicare Advantage, Medicare Supplement and Medicare Part D plans, they accepted. She discussed how to prepare for the phone consultation and that the retiree and spouse will be assigned a specific benefits counselor not a random customer service rep that moves on to the next phone call.

From the meeting, I learned that for the remainder of 2021, the retiree and spouse who are in a Retiree plan will have a specified amount to help pay for Medicare and Prescription drug plans monthly cost.

A Health Reimbursement Arrangement (HRA) is an account that has been established for the employee (you) and funded by an employer. You can use the funds in your HRA to receive reimbursements for eligible health care expenses up to the allocated amount.

The HRA is tax-free if the retiree and/or spouse meets certain requirements to qualify for the HRA funding.

Once you have enrolled in a Medicare plan through employers which provide HRAs, one will then have access to the HRA and use the HRA to reimburse your costs for items listed below:

- All or a portion of the monthly premiums for individual Medicare Supplemental insurance, Medicare Advantage plans, Medicare Part D Prescription drug plan.
- Medicare Part B or D premiums (if any)
- Eligible medical out of pocket such as coinsurance, co-payments and deductibles
- Dental and/or vision premiums enrolled thru the HRA plan.
- •Your HRA can be used to pay for all IRS Code Section 213 (d) expenses.

The speaker discussed "what is a guaranteed issue" time for the retiree who is enrolled in Medicare Part A and B with health issues which prevents one from qualifying for a Medicare Supplement medically.

With guaranteed issue rights, an insurance company must:

- Sell you a Medigap/Medicare Supplement policy. "You have the right to buy any Medigap/Medicare Supplement Plan A, B, C, F, K or L that's sold in your state by any insurance company if your Medicare Part A starts prior to January 1, 2020. Those who's Medicare Part A begins after January 1, 2020 qualify for Medicare Supplement Plan A, B, D, G K or L with plans C and F no longer available.
- Cover all your pre-existing health conditions.
- Cannot charge you more for a Medigap/ Medicare Supplement policy, regardless of past or present health problems.

Carrozzella expects to have some sectional rehearsals periodically which will also help solidify the group's overall vocal sound.

"In regard to COVID, we are being very cautious. All of our members are vaccinated. We are also in discussion over how we will move forward with welcoming new members, but ensuring the overall safety of all," she said.
