You'll be ready to add low-water native plants and drip irrigation this winter - saves 90 gallons of water per day per 1,000 square feet of lawn removed each time you water; Contact your water provider about rebates to replace older irrigation equipment, fixtures and appliances with highefficiency models, including rebates on smart sprinkler timers, high-efficiency sprinklers, drip irrigation and more. Many have increased rebate amounts to help offset costs.

Fireworks Ordinance Extended, **Roadway Safety Plan Adopted**

- At the July 22 regular meeting of the Citrus Heights City Council, Sacramento Municipal Utility District (SMUD) presented information about proposed rate increases, which the utility says are needed because their operating costs are going up. Increases in service costs can be attributed to rising materials and labor costs, wildfire prevention and mitigation costs, infrastructure improvement requirements, and clean energy requirements.

A proposed 1.5% rate increase would go into effect on March 1, 2022, with another 2% increase taking effect January 1, 2023. Looking at an average monthly customer bill of \$126.44 as an example, the 2022 increase would add \$1.91 to the bill and

add another \$2.57.

Other proposed changes include updates to SMUD's solar program and the implementation of an optional residential Critical Peak Pricing rate, which will be available to customers with smart thermostats and those in the solar program. This program would be applicable June through September. In times of grid stress, such as an extended heat wave, SMUD would give advance notice of a Critical Peak Pricing Event, which would last from one to four hours (with no more than 50 total hours over the summer). During these events, customers who opted into the program would pay higher rates for power – in exchange for discounted rates the rest of the year. The program is intended to encourage energy conservation, helping to ensure there is enough power the 2023 increase would for everyone and to reduce

ronmentally friendly energy sources.

The SMUD Board of Directors have already hosted two public workshops about the proposed rate increases, and the final public hearing will be hosted through Zoom on August 31, with the Board taking the final vote at the September 16 meeting. The Council heard a presentation by the Greater Sacramento Economic Council (GSEC), of which Citrus Heights is a contributing member, about their plans for regional recovery after the COVID-19 downturn. Barry Broome, president and CEO of GSEC, said that after the 2008 recession, the region had one of the worst recoveries in the state and the nation. But Broome said the Sacramento region is now

The GSEC's three-year strategic plan for regional recovery includes the attraction and retention of both businesses and a talented workforce. Using data-driven practices, targeted marketing, and a focus on emerging industries, GSEC aims to produce a local economy that is resilient, diverse, more inclusive and dynamic, and that produces higher wages.

Mayor Steve Miller provided an update about the search for a new city manager, explaining that Interim City Manager Chris Boyd is using his "experience and knowledge of the industry" to oversee the process. The City is currently in the process of hiring a search firm to coordinate the recruitment of qualified candidates

after the development of a candidate profile. With the marketing planned for this process, Mayor Miller said they hope to have a new city manager starting sometime around December/January.

The City Council also heard information about the recently completed Local Roadway Safety Plan (LRSP), which identifies and analyzes road safety issues, facilitates local agency partnerships and collaboration, and prioritizes safety improvements. The LRSP is similar to another recent City plan, the Multi Modal Transportation Safety Program (MMTSP); but while the MMTSP focuses on improving the safety of neighborhood streets, the LRSP includes all local roadways with a focus on major arterials and areas with higher collision levels.

The development of the plan was funded by a Caltrans Highway Safety Improvement Program (HSIP) grant with a 10% local match by the City. The creation of the LRSP document will ensure that Citrus Heights remains eligible for future HSIP funding cycles in order to secure funding for local roadway improvement projects.

In developing the LRSP, crash data were reviewed from 2015-2019, revealing that 90% of collisions occur at intersections, with speeding as the leading cause of collisions. The LRSP includes a toolbox of countermeasures that can be implemented citywide. Some of the most effective low-cost changes include adding retroreflective backplates on intersection signals and red reflective posts to stop signs. These measures have been shown to increase visibility and reduce crashes.

The Council voted unanimously to approve the LRSP, which will be updated over time to address the city's changing safety needs.

The Council also considered an extension to the urgency ordinance regarding fireworks regulation and enforcement. The initial urgency ordinance (passed on June 24 and valid for a period of 45 days) added temporary changes allowing for social hosts to be cited and fined for illegal fireworks on their property, increased fines for second offenses, and time restrictions for legal fireworks.

The Council voted unanimously to adopt an extension to the ordinance for a period of 10 months and 15 days. During that time, a recommendation will be drafted for a nonurgency ordinance, which if approved by Council, will replace the extended urgency ordinance and make the changes to the municipal code permanent.

Interim City Manager Chris Boyd presented Council with a COVID-19 update from the Sacramento County Health Officer, who shared that case rates in the county have increased dramatically in recent weeks. If California's tiered system were still in place, Sacramento County would currently be in the most-restrictive purple tier. The case increase is due to reduced mitigation measures such as distancing and masking, the spread of the more-aggressive Delta variant, and the large number of residents who are not vaccinated. The County has issued a recommendation that everyone wear face coverings in indoors settings where vaccination verification is not required and the vaccination status of others is unknown.

CITRUS HEIGHTS, CA (MPG) - Renovation of a free-standing, 10,000-square-foot commercial building which formerly housed the former Dimples Records store at 7830 Macy Plaza Drive in Citrus Heights has begun.

Fencing is up as the 30+ year old building adjacent to Dollar Tree, gets a structural refresh with a new stucco front fascia. Crews from Clifford Carpentry in El Dorado Hills were seen on the property finishing up exterior carpentry in preparation for stucco work this the back of the building and

past week.

Work is expected to be completed in the next 60-90 days. The estimated cost of exterior and improvements is expected to top \$500K, said Torren Ragan, sales associate with CBRE Real Estate of Sacramento which is the listing broker.

"We began general site improvements last year," Ragan said. A new rear retaining wall built further back on the property creates additional parking for customers and makes it easier for commercial delivery vehicles to bring goods to

the Dollar Tree store next door, he said. New rooftop HVAC heating and cooling units are to be installed soon, Ragan said.

Building improvements will help make the property much more marketable, Ragan said. "We (CBRE) are hopeful we will find a single tenant for the property instead of dividing the space."

Ragan said the property has attracted the interest of a few possible national tenants "who have expressed genuine interest, but don't have an announcement yet."

Those who want voters to recall Gov. Gavin Newsom joined crime victim advocates at the state Capitol last Tuesday to accuse the governor of being too lenient on lawbreakers as the state experiences a new wave of crime.

They castigated him for unilaterally suspending executions of murderers and making it easier for felons to win release from state prisons.

"The thing that really alarms me about what the governor did, is that it's a continuation of policies to undermine the criminal justice system, and to put dangerous people back out onto the streets," said Marc Klaas, whose daughter, Polly, was murdered 25 years ago by a recently released felon. The killer, Richard Allen Davis, is one of 737 murderers benefiting from Newsom's death penalty suspension.

A few hours later, Newsom's office announced that he would hold a press conference in Los Angeles Wednesday "on state action to address crime and reduce retail theft in communities more violent crime, seemacross California."

Newsom devoted much of the event to signing

Assembly Bill 331, which purchasing and firearm extends an effort to crack down on organized shoplifting that has plagued California retailers in recent months. But he attributed the sharp increase in violent crime, particularly murders, to "a proliferation of guns on our streets" and noted that "There is not a state that's been spared."

Could Crime Surge Push

Newsom Recall?

The back-to-back events imply that crime may be a new front in the recall campaign and that Newsom feels the need to defend himself.

"In 2020, California saw a troubling rise of more than 500 homicides, the largest jump in state history since record-keeping began in 1960," the Public Policy Institute of California says in a recent report. "Victims were predominantly Black and Latino, male, and killed by guns on our streets, parking lots, or in vehicles."

Newsom's comments about "a proliferation of guns on our streets" echoes declarations by gun control advocates that California's surge of homicides results from a big jump in gun ownership. Californians legally bought a record 686,435 handguns in 2020 a nearly 66% increase from the year before – and sales of rifles and shotguns also shot upward.

However, Newsom and other gun control advocates offer no proof of the connection. In fact, a new study by University of California-Davis researchers found no evidence that increases in legal gun sales resulted in ingly refuting Newsom's assertion.

violence increased substantially during the first months of the coronavirus pandemic," the study by UCD's Violence Prevention Research Program, concluded. "At the state level, the magnitude of the increase in purchasing was not associated with the magnitude of the increase in firearm violence."

"Results suggest much of the rise in firearm violence during our study period was attributable to other factors, indicating a need for additional research," the researchers added.

A more likely scenario is that Californians are buying more guns because their fears of becoming violent crime victims have increased. In recent weeks, the residents of three Northern California homes, one in Solano County and two in Stanislaus County, have shot and killed violent home invaders.

The surge in crime, both violent assaults and thefts, is real. The videos of brazen daylight raids on pharmacies and other stores, particularly in San Francisco, by thieves unafraid of either arrest or prosecution, have become cable television and YouTube staples.

While rising crime might not sink Newsom in the recall election a few weeks hence, if it continues to rise, he could feel the backlash when he runs for re-election in 2022.

SACRAMENTO COUNTY, CA (MPG) -Sacramento County with its cities and numerous special districts is updating the Local Hazard Mitigation Plan (LHMP) looking at the risk of floods, drought, wildfires, severe weather, and other natural hazards of concern to the County. While hazards such as these cannot be prevented, a Hazard Mitigation Plan forms the foundation for a community's long-term strategy to reduce disaster losses. A FEMA-approved Hazard Mitigation Plan allows agencies to apply for pre- and post-disaster mitigation grant funding. In addition, this LHMP Update provides for lower costs of flood insurance premiums, through the National Flood Insurance Program's (NFIP) Community Rating System (CRS), to residents of Sacramento County and City of Sacramento, as the two CRS communities. The process began in August 2020 with an initial planning and public meeting and the establishment of a Hazard Mitigation Planning Committee (HMPC) comprised of representatives from the County, incorporated communities, special districts, other key stakeholders, and the public. The 2021 LHMP Update is scheduled to be finalized and submitted to Cal OES and FEMA in September 2021.

HUNTSVILLE, AL (MPG) - Angelina Demasi of Citrus Heights, CA recently attended Space Academy at the U.S. Space & Rocket Center, home of Space Camp®, Space Camp[®] Robotics[™], Aviation Challenge[®] and U.S. Cyber Camp®. Social Security Matters Should I Claim Family Benefits?

Dear Rusty: I was born in 1956 and my wife in 1961. I've got 45 years of SSA earnings, and I will have income in 2021. We have 4 minor children, the young est born in 2012. When is the best time for us to apply for benefits? Are we eligible for family benefits? My statement infers that we are. Signed: Older Dad Dear Older Dad: Born in 1956, your full retirement age (FRA) for Social Security purposes is 66 years and 4 months. If you claim your SS benefit at any time before your FRA, it will be permanently reduced. If, for example, you claimed your SS benefits now, the amount would be permanently cut by about 14%. Your wife's FRA is 67 and, similarly, she will receive a reduced SS retirement or SS spousal benefit if taken any time before her FRA. Your wife isn't normally eligible for benefits until she is 62 years old, but if she is providing full time childcare to your minor children, she is eligible for spouse benefits sooner. Child-in-care spouse benefits are available at any age for your wife if she is providing care for at least one of your minor children under the age of 16. You must be collecting your own SS benefit for your wife to be eligible for this.



Minor child benefits are available to any child under the age of 18, or 19 if still in high school. All your children who qualify under that definition would be eligible for benefits based upon your Social Security earnings record. But, because Social Security's Family Maximum, the amount each child receives would be less than half of your FRA benefit amount.


benefit before your full retirement age results in a permanent reduction to the benefit you will receive for the rest of your life. So, you should evaluate which option is financially better considering your life expectancy - claiming now and getting the full Family Maximum amount in these earlier years or waiting longer (even up to age 70) to receive a higher personal benefit for the rest of your life. You should also consider that if you die first, your wife's survivor benefit will be based upon the amount you are receiving at your death, so the age at which you claim also affects your wife's benefit as your widow Finally, if you claim before you have reached your full retirement age, Social Security's earnings limit will apply until you reach your FRA. If you work and exceed the limit (\$18,960 for 2021), Social Security may withhold your benefits for several months, and your dependents won't receive their benefits while yours are withheld. Note too that your earnings limit will go up by about 2.5 times during the year you attain FRA. Once you start collecting your Social Security, your minor children will become eligible for benefits also.

The Family Maximum amount is different for everyone because it is computed using each person's Primary Insurance Amount, or "PIA," which is the amount you are entitled to at your FRA. The Family Maximum normally computes to somewhere between 150% and 180% of the primary beneficiary's PIA, and that amount is shared by all those collecting. So, in your family's case, your PIA amount is first deducted from your Family Maximum amount and the remaining 50% to 80% is equally apportioned among all those collecting benefits on your record (including your wife if she receives child-in-care benefits). If all 4 of your children are minors, and your wife is collecting child-in-care benefits, those 5 individuals would each receive an equal portion of the remaining family maximum amount after your PIA is deducted.

It's probable that your family would get the entire family maximum amount, for as long as your wife and minor children are eligible for benefits. But remember that claiming your own





Not Knowing Medicare Rules Costs Americans Millions!



Toni: sold our house to move into a senior community. Now, both of our Part B premiums have increased drastically in 2021 from around \$145 a month to over \$475 for Part B and

an additional increase for Part D to over \$70. We still are receiving the same Social Security check and I really don't understand where this change came from.

Could you please explain what has happened?

Thank you Meredith from Nashville

Meredith:

In the past few weeks when clients are meeting with us at the Toni Says® office, we are seeing those on Medicare not understand Medicare rules which are not clearly explained in the Medicare and You handbook.

Below are a few examples of how Americans are paying more for Medicare Part B and Part D premiums:

1. Part B and D monthly premiums are based on what income amount was reported on your last filed tax return: Meredith, your current question about why your Part B and D premiums increased even though your Social Security checks remained the same tells me that your income 2 years was raised from the year before due to selling your house. When your Part B premium was the average premium of \$144.60 for 2020, your income on your joint tax return was \$176,000 or less. The amounts you gave of over \$475 for Part B and over \$70 for Part D tells me that your income on your 2019 joint tax return was over \$330,000 and this increase could have been from selling your house. Americans need to know that in 2021 when your income increases about the threshold of \$88,001 as an individual or \$176,001 as a couple, then both your Parts B and D premiums


will be increased to their limits. I In 2019, we 2. Should one enroll in Medicare Part B when either you or your spouse is "still" working with employer health coverage? Everyone should discuss enrolling in Part B with their company's HR or benefits administrator to find out how their group health coverage coordinates with Medicare. It may be to your or your spouse's advantage to delay Medicare Part B. The Medicare & You handbook states, "You can sign up for Part B without paying a penalty anytime you have health coverage based on your or your spouse's current employment." Once employment or health coverage based on employment ends, then one can receive a SEP (special enrollment period) and have an 8-month period to enroll in Part B without receiving a Part B penalty. Don't wait too long to enroll.

> 3. Always have each employer's HR sign Social Security form "Request for **Employer Information**" when there is an employment change past turning 65? Kathy consulted a Toni Says® agent regarding enrolling in Part B when she was retiring from her current employment only to discover that she never had her other two (2) other companies that she had worked for after turning 65 sign Social Security form CMS L-564. Because Kathy is now 69 and only one employer signed CMS L-564. Her Part B penalty from not having the other 2 companies sign off, will be 68 minus 65 which is 3(full12 month periods) times 10% or 30%. Not for one month, but for as long as she is enrolled in Medicare Part B.
