## Chamber Launches "Reopen Local"

- The Citrus Heights Chamber of Commerce announced that it has launched a grassroots advocacy campaign that will draw public attention to COVID-19 safety guidelines that use imprecise data to determine whether communities can begin the process of safely rebuilding their economies. The campaign entitled "Open Citrus Heights" began by sending a letter to Sacramento County's health director questioning the rationale of state social distancing guidelines that shut economies down based on where a city is located, not whether they have reduced the number of COVID-19

In a letter to the county health director, the Citrus Heights Chamber of Commerce's Interim Executive Director wrote, "When so many residents are out of work and our children do not have the benefit of in-class instruction, we believe that our State has reached a point when healthcare authorities should have greater flexibility to consider smaller geographical or political boundaries that better reflect local health conditions".

Recent press counts reveal that Citrus Heights neighbor El Dorado County was awarded the state "Orange Tier" designation, allowing businesses to expand and reopen, while Citrus Heights and surrounding cities are held to a stricter standard, but only because they are located in Sacramento County.

Reflecting the concern of small business owners who believe they will be shut down for the foreseeable future, Ebbitt also wrote, "while not by design, the state's new tier system is essentially picking winners and losers in the marketplace, resulting in Citrus Heights businesses being partially or temporarily closed, and others have gone out of business for good. Essentially, the economic sustainability of our community is not based on conditions within our city boundaries but conditions elsewhere in the county that are beyond the control of our city's political leadership.'

With the winter and holiday season quickly approaching, several Citrus Heights small business owners are underscoring the urgency of the Chamber's request.

The Christmas holiday season is a major source of revenue for Citrus Heights

## SJWD Division Map Sparks Debate over Fair Representation

SACRAMENTO REGION, CA (MPG) - On October 14, the San Juan Water District (SJWD) Board of Directors held the fourth and final public hearing to approve a division map and election sequencing for their transition to division-based elections.

In response to a threatened lawsuit claiming the established at-large election system violated the California Voting Rights Act (CVRA), the District is now working to meet the legal requirements of the CVRA: the new divisions must be compact and contiguous with reasonably equal populations, and communities of interest must be considered. Racial gerrymandering is prohibited.

During previous public hearings, multiple residents of Granite Bay expressed concern that the reasonably equal population requirement would lead to a lack of representation for their area, and for rural properties and retail customers generally. They asked that their area be combined with other similar communities of

According to the staff report, the California Constitution defines a community of interest as a contiguous population with "common social and economic interests." Urban, rural, industrial, and agricultural areas are also considered communities of interest.

According to the Board, they considered the following communities of interest: city/county boundaries, zip codes, existing election boundaries, urban and rural areas, official community associations, special districts, and the retail service area. The staff report cited an "imperfect ability to keep all portions of all identified communities of interest compact, contiguous, reasonably equal divisions. But District Legal

Counsel Jennifer Buckman said the proposed map met all the legal requirements. The map also met the Board's priorities of respecting community associations and following the rural/urban divide. The map also refrains from packing the retail customers into one division, which would have diluted the voting power of this group.

Ahead of the meeting, the Citrus Heights Water District (CHWD) and the Fair Oaks Water District (FOWD) submitted a opposition to the proposed map. The letter stated that the map "ignores any

existing county, city, or neighborhood boundaries. These communities of interest, especially the City of Citrus Heights, together" while creating are divided to the maximum extent possible," which they said was "bad policy."

The letter stated that 'Constituents have the right to expect clean district lines that make sense in relation to the community," and they saw "no obvious reason for the oddly shaped" divisions.

In an interview prior to the meeting, Ray Riehle, president of the CHWD Board of Directors, said that while the proposed map is likely legal under the CVRA, it "missed the spirit of the law dramatically.'

## **Over 2 Million California Voters** Signed Up to Track Their Ballot

SACRAMENTO, CA (MPG) - More than 2 million registered California voters have now signed up for California's ballot tracking service "Where's My Ballot?" to receive automated notifications about their vote-by-mail ballots by email, text (SMS), or voice call.

'Signing up for 'Where's My Ballot?' is one of the most prudent steps Californians can take to protect their vote," Secretary of State Alex Padilla said. "Every active, registered voter was sent a vote-by-mail ballot for the General Election, and ballot tracking will play a critical role in strengthening transparency, accountability, and voter confidence during this unprecedented election. All California voters can quickly and easily sign up to track their ballot at WheresMyBallot.sos.ca.gov."

"Ballot tracking has only been available statewide for a few months, and

we are seeing an incredible adoption rate. Nearly 1 in 10 registered voters has already signed up for the "Where's My Ballot?" tool. If you've already signedup, encourage your friends and family to do the same," Padilla added.

Voters who sign up for "Where's My Ballot?" will receive automatic updates when the county elections office: mailed the voter's ballot, received the voter's ballot, counted the voter's ballot, and has any issues with the voter's ballot.

Voters who sign up for "Where's My Ballot?" will also receive communications from their county elections office about important election deadlines and critical updates such as polling place

AB 2218, signed 2018, required the Secretary of State's office to provide a ballot tracking service to county elections offices. In response to the COVID-19 pandemic, Governor Newsom signed legislation to expand the ballot tracking tool statewide.

## **CHP Grant Improves Motorcycle Safety**

- The California Highway Patrol (CHP) is stepping up motorcycle safety awareness statewide as part of Get Educated and Ride Safe (GEARS) III, a yearlong, federally funded program focused on educational and enforcement efforts.

The primary goal of GEARS III is to reduce the number of motorcycleinvolved crashes and victims.

In federal fiscal year (FFY) 2017-18, the number of motorcycle-involved crashes increased approximately 3 percent within CHP jurisdiction. However, provisional FFY 2018-19 data show a 10 percent decrease.

"The ultimate objective is to improve not just motorcycle safety, but highway safety overall," CHP Commissioner Warren Stanley said. "The additional education and enforcement funded by GEARS III helps our officers meet this objective."

During the grant period, the CHP will increase motorcycle safety activities in regions with a high number of motorcampaigns such as "May is Security.

Motorcycle Safety Awareness Month." The campaigns will promote the use of U.S. Department of Transportationcompliant helmets for all riders and raise motorists' awareness of sharing the road with motorcyclists. The campaigns will also focus on the most dangerous traffic violations, including speeding, improper turning, and driving under the influence of alcohol and/or drugs.

Funding for this program was provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration.

## **Pedestrian Fatally Steps into Van's Path**

SACRAMENTO REGION, CA (MPG) - On October 16, 2020 at approximately 355 pm, The California Highway Patrol (CHP) received a call of a collision involving a van and a pedestrian on Watt Ave., south of Navajo Dr. CHP officers responded to the collision scene and learned that a white Ford Econoline van was traveling north on Watt Ave. at approximately 40 MPH. in the left lane. At this time, an adult male, stepped from the right sidewalk and attempted to cross the roadway, while out of a crosswalk, directly into the path of the van. The male driver attempted to avoid the pedestrian but was unable to avoid the prevent the van from colliding with the pedestrian. The pedestrian was subsequently hit and came to rest in the roadway. Sacramento Metropolitan Fire Department (SMFD) responded to the scene of the collision and pronounced the pedestrian deceased on scene. The identity of the pedestrian has yet to be determined. The driver remained on scene and was cooperative with investigators.

Alcohol and/or drugs were not determined to be a factor and the cause of the collision is currently under investigation.

## **Social Security Matters**

#### I Need Guidance on Social Security and Medicare

Dear Rusty: I am turning 67 in October and as of today am still employed full time. I really do not plan on retiring unless I am forced to. But how do I arrange my Social Security and Medical care stuff. It seems this subject is like a color, and everyone has a different color they like. Is there any way for me to figure this out with help or on my own? I could really use some guidance. Signed: Perplexed

Dear Perplexed: Okay, let's look at your Social Security and your Medicare two totally independent programs.

You do not need to do anything about Social Security until you are ready to start collecting your benefits. Since you have already reached your full retirement age (FRA) of 66, you are now earning Delayed Retirement Credits (DRCs) at the rate of .667% per month. That means that your benefit in October, if you were to claim it then, would be 8% more than it would have been at age 66. If you continue to delay applying for SS benefits, you will continue to earn those DRCs



benefit amount would be 32% more than it would have been at your FRA. The choice of when to claim your Social Security is yours to make, considering your need for the money, your health, and your expected longevity. The longer you wait (up to 70) the more your benefit will be, and if you expect at least average longevity (about 84 for a man your current age) then you'll get both a higher benefit amount and more in cumulative lifetime benefits by waiting to claim your Social Security.

As for Medicare, if you are now covered by your employer's "creditable" healthcare plan, you can delay enrolling separately, because they're in Medicare until your current employer coverage ends (when you stop working). "Creditable" is a group plan with more than 20 participants. If you now have "creditable" employer healthcare coverage (including drug coverage) you won't be liable for a Late Enrollment Penalty for enrolling in Medicare (or a drug plan) later. If you are still working and know your creditable employer coverage will end soon, you can enroll for Medicare benefits to start coincident with the end of your employer coverage. Or, after you stop working, you can up to age 70, when your enroll in Medicare during

a "Special Enrollment Period" (or "SEP" for those transitioning from employer coverage to Medicare coverage). Your SEP for Medicare will last for 8 months after you stop working, but you only have 63 days after the end of your employer drug coverage to enroll in a Part D prescription drug plan.

The bottom line is this you don't need to enroll in Medicare until your creditable employer healthcare coverage ends. And you don't need to apply for Social Security until you wish to start receiving benefits (just don't wait beyond 70).

One final point because you were born in 1953: if you are now married and your wife is already collecting her SS, you can file a "restricted application for spouse benefits only" and collect only a spouse benefit from your wife, while still allowing your own benefit to continue to grow until you are 70. But this option is only available to you because you were born

## **Out-of-Work Californians Urge Governor** to Expedite Unemployment Benefits

SACRAMENTO, CA (MPG) - Standing in front of California's Employment Development Department (EDD) headquarters, seven residents of Northern California urged Governor Newsom to be more hands-on with helping those in need. Like millions of Californians, these residents lost their jobs after the Governor triggered a shutdown of businesses and ordered a shelter-in-place for all Californians.

"The experiences of out-of-work Californians and EDD's lack of action are shameful," said Senator Jim Nielsen (R-Tehama). "The Governor and his Administration must do better to serve the people who elected him. Californians deserve better."

Waiting for unemployment benefits has been a shared frustrating, infuriating and devastating experience.

Phone calls are cut off after hours of waiting on hold. Mails and emails gone unanswered. Endless requests for legal documents that are not always related to the applicant's claims, has resulted in a nerve-racking game of waiting.

With the support Senator Jim Nielsen. Sacramento area residents spoke up for the 1.6 million Californians who are still waiting for their benefits.

"Action must be taken now to help those who are waiting for their benefits," said La Toya Horne of Sacramento. "I don't want anyone else to deal with the humiliation and bureaucratic obstacles I had to endure. I lost my home. No one should have to lose their home while waiting for a benefit they have earned and deserved."

Ms. Horne owned a thriving salon in an upscale part of town. She applied for unemployment in March when salons were forced to close. Months later, a stranger contacted Ms. Horne through social media to inform her that mail from EDD arrived at his house. She had lived at that address 10 years ago. When she amended her application and updated her identification, EDD told her she needed a judge to resolve the issue. They later reversed their

Resolved in her passion to help others, Ms. Megan Williams drove nearly 100 miles to urge the Newsom Administration to act swiftly to get benefits to applicants.

"It is very disheartening to see the lack of urgency. I feel bad for the people who are not as lucky to have others to lean on financially, or who have landlords that are not as understanding as mine. The stress of having to call phone

companies, credit cards companies, etc. to work out payment plans or shifting debt from one credit card to another, just to maintain on time payments, or keep things turned on, is unnecessary," Ms. Williams stated.

EDD just emerged from a two weeks closure that left an estimated 100,000 people unable to apply for benefits. The hiatus was supposed to "reset" its operations and implement a new system. However, Senator Nielsen's office was informed Tuesday that the backlog to review claims went from eight weeks to 11 weeks.

Understanding the financial and mental toll of waiting for EDD's sloth-like movements, Mr. Rick Walters of Yuba City joined the call to ask the Governor to immediately take action to help those who have lost their jobs due to the government-imposed lock-down.

"Government is supposed to work for us when we need help. We are law-abiding taxpayers. This experience was beyond stressful. As Governor, you need to act now to protect our citizens of this state," Mr. Walters appealed.

Like the 1.6 million residents still waiting for their benefits, Ms. April Carlton of Citrus Heights has been able to meet most of her financial obligations thanks to her close-knit


As an office manager and bookkeeper at a small business, Ms. Carlton's hours were reduced and she was later furloughed. EDD denied her claim based on a name change in 2018. Ms. Carlton provided EDD with judgment orders for the name change, immigration papers and proof of residence. Despite providing all legal documents, Ms. Carlton is still waiting for her backdated benefits.

"Thank God for the support of my family. Without them, I would not have been able to handle this financially straining and emotionally infuriating process," said Ms. Carlton.

Sherri Bailey of Rancho Cordova, along with her 82-year-old mother, joined the group to remind EDD officials of their commitment during the Great Recession to the public and lawmakers.

"They are not keeping the promise they made in 2008. They owe it to Californians to tell us what they did do to serve the public. Clearly, their system is still broken."



#### Hollywood's Shameful Kowtow to Beijing

Hollywood is accommodating a new era of McCarthyism, imposed this time by Red China.

It involves everything that Hollywood tells us that it hates – censorship, pressure to conform and blacklists. Yet the studios have seamlessly absorbed China's dictates into their operations.

This most iconic American business is now, literally, an agent of Chinese influence.

The latest outrage is Disney's live-action remake of the animated movie from the 1990s, "Mulan," based on Chinese folklore about a girl enlisting in the army. Disney filmed parts of the movie in China, and in its credits, thanks Chinese propaganda departments as well as a public security bureau in the province of Xinjiang, where Beijing is carrying out its hideous campaign against the Uighurs.

If you think Hollywood would be sensitive about associating itself with an ongoing atrocity, you haven't paid much attention to its priorities lately, which are all about pleasing Beijing.

Hollywood hasn't dared

to Beijing in more than two decades. A trilogy of such movies came out in 1997, most famously "Seven Years in Tibet," starring Brad Pitt. Ever since, Hollywood has considered kowtowing to Beijing the better part of valor.

In a chilling report released a few weeks ago about Hollywood's subordinate relationship to Beijing, PEN America described the forces that have given China the whip hand.

First, there's sheer market power. China went from having a market about the size of Peru in the late 1990s to a behemoth box office. Money talks, even if it is the money of a country hostile to the United States.

Then, there's China's comprehensive system of censorship that very much applies to foreign movies. It is rare that a studio or producer says "no." To his credit, Quentin Tarantino refused to cut a comic scene featuring Bruce Lee from "Once Upon a Time in Hollywood."

Otherwise, the changes are exacting. "Mission: Impossible III" cut a scene United States than one of the where tattered clothes hung from a clothesline in Shanghai. Chinese villains are out of the question. Notoriously, Paramount changed the invaders in a remake of "Red Dawn" from Chinese to North Korean.

Since Beijing can delay the release date of a movie

to make movies offensive or demand that a scene be reshot, and studios don't want to deal with the uncertainty, Hollywood preemptively accedes to Beijing's wishes. PEN America notes that producer David Franzoni has said, "They have a lot of power so you want to try to be sure you have it all down the

first time." Paramount removed patches with the Japanese and Taiwanese flags from Tom Cruise's bomber jacket in the sequel to "Top Gun." As PEN America points out, the changes had already been made when the trailer was released, meaning Paramount didn't wait for Chinese censors to object.


The director of "Seven Years in Tibet," Jean-Jacques Annaud, subsequently released a letter expressing slavish regret. He "solemnly declared" that he never supported Tibet independence and never had contact with the Dalai Lama. "Moreover," he added, "becoming friends with him is out of the question."

The upshot is that Hollywood is much more comfortable criticizing the most reprehensible regimes on the planet. The repression of the Uighurs? As far as Hollywood is concerned, it doesn't exist and, at this rate, never will.



## Misusing Taxpayers' **Money for Campaigns**

California voters are not only voting on presidential, congressional, legislative and local government offices and a dozen statewide ballot measures but deciding the fate of 234 local tax and bond measures.

The California Taxpayers Association estimates that if passed, the local tax measures would raise about \$1.5 billion a year in new revenues. The proposed bond issues, mostly for schools, total nearly \$15 billion and their passage would automatically trigger increases in property taxes to repay lenders.

These are hefty financial stakes and the local officials that placed measures on the ballot have reason to worry about their passage. Voters rejected 62% of the 239 local measures on the March 3 primary ballot and that was before the COVID-19 pandemic struck home, the state's economy plummeted and more than two million jobs were

The recession that's still raging is a two-edged sword for local government and school officials. It has cut their tax revenues sharply and also tends to make voters even more leery about

paying higher taxes.

City council members, county supervisors and school trustees are tempted, in their zeal to persuade voters to vote for new taxes and bonds, to violate a state law prohibiting them from using taxpayer funds for campaign purposes.

Government Code Section 54964 forthrightly declares, "An officer, employee, or consultant of a local agency may not expend or authorize the expenditure of any of the funds of the local agency to support or oppose the approval or rejection of a ballot measure, or the election or defeat of a candidate, by the voters.'

In fact, such violations have become commonplace in recent years. Under the guise of providing "information," local officials routinely hire campaign management firms to design advertisements, mailers and other material aimed at persuading voters to pass the proposed taxes and bonds.

They have done so because they know that state and local prosecutors just as routinely refuse to prosecute violations of Section 54964 by their fellow officeholders.

The only investigative agency to interest itself in such violations is the California Fair Political Practices Commission and while the FPPC lacks authority to enforce Section 54964, it can treat agencies that step over the line dividing information from advocacy as campaign contributors.

FPPC targeted the County of Los Angeles, which in 2017 spent a million dollars for an ill-disguised, but successful, campaign to pass Measure H, a quarter-cent increase in the sales tax. The campaign included broadcast commercials in English and Spanish that used the slogan "Real Help. Lasting Change."

County officials, without admitting liability, agreed to pay the FPPC a \$1.35 million penalty for failing to report their spending as a campaign contribution. However, that pales in comparison to the estimated \$355 million a year that Measure H's passage will generate.

Last week, the FPPC invited the public to use its "AdWATCH" program to monitor the materials local officials are using to promote their tax and bond measures and upload questionable items to the agency for examination and perhaps investigation.

"The public can play a vital role in helping our enforcement division in making sure campaigns and public agencies are following the rules and ensuring a level playing field," FPPC Chair Richard C. Miadich said in a statement.

The FPPC's efforts are welcome, despite being an indirect and relatively weak way of discouraging improper use of taxpayer funds for campaigns, but it's likely to be the only way as long as prosecutors refuse to enforce the law.

population for people farther away." But Riehle pointed out that most of Granite Bay is included in Division 2, except for a small urban area that is excluded. But Division 2 then extends down into Sacramento County to include parts of Orangevale, including the more densely populated areas along Greenback Lane. Bypassing nearby urban populations for far-away urban populations doesn't seem to meet the spirit of the compactness requirement, and Riehle said "the geography doesn't make sense."

Riehle said that people living in rural areas of Granite Bay probably don't have a whole lot in common with people living along Greenback, so he is skeptical of the claim that the Board prioritized the urban/ rural divide.

According to Riehle and the Citrus Heights and Fair Oaks water districts, the eastward projection of Division 1, which cuts into central Granite Bay in Division 2, is an obvious sign the map has been gerrymandered in an effort to protect at least two seats for Granite Bay – where four of the current Board members reside. Riehle believes "political calculus" was involved in the decision-making process.

Legal Counsel Buckman responded to the joint letter at the October 14 meeting: "The commenter is incorrect when they indicate that the map ignores existing neighborhood boundaries. In fact, the commenters would just prefer some different boundaries to have been selected."

Regarding the claim that the map

attempts to protect incumbent seats, Buckman said, "There's absolutely no evidence in the record to support that statement." She further stated that she "expressly advised" that the Board not take incumbent addresses into account, and that the Board followed her advice.

Mike McRae, a director on the FOWD Board and a candidate in the upcoming election for SJWD Board, spoke at the October 14 meeting, stating that the map is "designed to bring long-term disharmony to the San Juan family." He said the primary communities of interest in SJWD are the water districts (CHWD, FOWD, Orange Vale Water Company, and the San Juan retail division): "This map appears to be purposefully created to fragment across those retail water agencies.'

McRae pointed out that while Placer County makes up only 13% of the SJWD population, it will have a shot at two Board seats - or 40% of the Board under the new division boundaries.

Two Granite Bay residents, Amber Beckler and Sandy Harris, both spoke in support of the proposed map. Beckler said, "It preserves the community of interest and representation."

The Board voted unanimously to move forward with the proposed map and the election sequencing - elections for Divisions 1, 3, and 5 will be held every four years starting in 2022 and for Divisions 2 and 4 starting in 2024. The final vote for official approval will be held at the November 9 regular meeting.

Rep. Ken Buck demands DOJ investigate removal of big tech protections after censoring of NYPost Biden article | 14 Oct 2020 | Rep. Ken Buck, R-Colo., sent a letter to the Department of Justice on Wednesday, asking the attorney general to look into accusations of censorship by Twitter and Facebook, after the big tech giants took steps to limit the exposure of a New York Post article critical of Hunter Biden. "I write to express my concerns regarding Twitter and Facebook's recent actions to censor a prominent American news outlet," Buck began. 



## Vote No on Measure M

Coronavirus disruptions are inspiring governments to employ every tactic available to ward off a Great Depression-style economic collapse. Whether it's stimulus funds, Paycheck Protection Program loans, increased unemployment benefits, or rent forbearance, all the policies share the same goal of putting more money into consumer or business pockets so our weakened economy can regain its strength. Why is Citrus Heights doing the exact opposite with its proposed tax increase, Measure M?

The short answer is the City is facing a two-year budget problem. The good news is, despite today's fiscal challenges, in two years, the City will begin to receive six million a year in additional, annual property tax revenues that currently go to the County. That money, if used wisely, should put Citrus Heights back on solid fiscal ground.

In the meantime, Measure M is not a wise solution and it is definitely not a twomoney grab, a tax with no sunset. This additional sales tax burden will fall on businesses and consumers indefinitely and will permanently diminish the City's competitiveness.

M would double the city's share of sales tax from one to two percent, with the intent of raising \$12 million annually. That's a lot of money out of the pockets of residents and local business. And, with the city budget currently at \$34 million, that would be a massive 35-percent increase!

It's no secret that California businesses. crushed by high taxes and costly regulations, are leav-

can relocate, fleeing to lowertax, lower-cost-of-living, and more simply regulated states. That's a government failure that's driving out entrepreneurs and weakening our

The same phenomenon can happen among cities. With Measure M. Citrus Heights would saddle its businesses with higher taxes than Roseville or Folsom, for example, making it more difficult for the City's merchants to keep customers at home, and making it more likely that business owners would relocate or expand in those competing areas, instead of Citrus Heights. Measure M would also fly directly counter to Sunrise Mall revitalization efforts, which are important to the City's economic vitality.

To climb out of the COVID crater, Citrus Heights should be lowering taxes. They should be taking every step to make the City more attractive to businesses and more affordable to consumers. A healthy City budget starts with a powerful private-sector economy.

Even a healthy econyear solution. It is an endless omy is not enough on its own, though. No amount of tax revenues will balance a municipal budget without spending discipline. Citrus Heights, a city of about 89,000 residents, has an estimated 10 or more public employees with annual compensations packages above \$200,000, including one employee whose pay and benefits add up to more than \$400,000 per year. That is a troubling sign for a city in economic distress. Lavish public employee salaries are an immediate budget problem but they portend higher pension spending for decades to come.

go to core city services, the truth is the money goes directly to the City's general fund and could be spent on salary increases or the inevitable increases in pension payments that will flow from today's inflated salaries. And, whatever promises local politicians make now, with no written guarantees in the measure, those promises won't be enforced by their successors...one or two years from now, much less 20 years down the road.

The City needs to realize that its residents are already overtaxed. Californians already pay the highest gasoline taxes, highest state sales tax, highest personal income tax, and some of the highest property taxes in the nation, despite Prop. 13. Measure M is an unneeded pile-on, putting pressure on businesses and pushing consumers to neighboring cities.

And, with a sales tax being the most regressive of all taxes, hurting the poor and disadvantaged disproportionately, the NAACP and others strongly oppose Measure M. More than 12-percent of Citrus Heights residents live below the poverty level, and that was before the pandemic drove up unemployment and reduced worker hours.

Don't sacrifice the City's long-term future for a short-term problem. Don't sacrifice your fellow residents. Don't sacrifice your local businesses. Vote NO on Measure M.

Hole discount on the total cost of their **brand-name** drugs purchased while in the Donut Hole. The discount includes, a 70% discount paid by the brand-name drug manufacturer and a 5% discount paid by your Medicare Part D plan. The 70% paid by the drug manufacturer, 5% Part D

D enrollees will receive a 75% Donut

plan discount combined with the 25% you pay, count toward your TrOOP or Donut Hole exit point. Generic Drug when one reaches Medicare Part D Donut Hole: pay a maximum of 25% co-pay on generic drugs

purchased while in the Coverage Gap (receiving a 75% discount). For example: If you reach the 2021 Donut Hole, and your generic medication has a retail cost of \$100, you will pay \$25. The \$25 that you spend will count toward your TrOOP or Donut Hole exit point.

Lower costs when one comes out of the Donut Hole and enter Catastrophic coverage until December 31 and then a new year begins. Then the Medicare Part D cycle begins again with a new deductible on January 1 of every year.

#### Toni's Tips:

- 1. During Medicare's Annual Enrollment Period from October 15 th to December 7 th be sure that all your prescriptions are covered by a new standalone Medicare Part D plan or a Medicare Advantage plan with prescriptions which will begin January 1st.
- 2. Remember you will pay 100% of the cost if any prescriptions (generic or brand name) are not covered on your Medicare Part D plan.
- 3. Talk to your doctor or doctors about which brand name drugs can be changed to generics.
- 4. Get samples from your doctor.

**Do not forget** ... There is a penalty for not enrolling in a Medicare Part D Prescription Drug plan when you first become eligible to enroll.

learning with parental support.

"There's an hour between when the morning session is dismissed, and the afternoon session arrives." The morning session receives a grab-and-go lunch.

"It's an absolutely fantastic feeling to see their young faces," she said. "They're excited to be coming to school."

"We worked on the school site plan early [o]n," she said. "Our students and staff are encouraged to wear masks and we've had success with that." Teachers wear full protective personal protective equipment (PPE) in the classroom. Students are required to socially distance themselves in the classroom and seating is spaced six feet apart.

"They've adapted very well to what we've asked of them," Smith said. "In addition, plexiglass barriers are in place between student workspaces and adequate classroom ventilation is maintained."

"We've worked closely with the families who've enrolled their children on all these requirements as we keep them safe.

Students are provided a nutritional and recreational break during each daily session at school. While the academy doesn't have a grade K-1 specific play structure, it does provide individual sports equipment which is cleaned thoroughly after each class use. All staff model hand washing and proper personal hygiene habits throughout the day.

Parents may view the school's specific 2020-21 Comprehensive School Safety plan which is published on the school web site. Information includes additional health and safety measures in place for the entry and exit of students, teachers, and visitors, and additional requirements for all people when on the school campus.

American River Collegiate Academy (K-1) learning program is based around a core knowledge curriculum, Smith said.

"Our first-grade students are starting to learn about ancient Egypt and are involved in individual music and arts projects," she said.

Emphasis is placed on math, reading and language arts, science and history, character education, social emotional learning and music, art, and the performing arts.

The Orangevale Charter school encourages participating parents to become part of its Parent School Partnership (PSP) and volunteer a minimum of 30 hours per family per school year.

"We are committed to moving the school into Citrus Heights as soon as we can," said Jillayne Anton, director of growth and community engagement for the Rocklin Academy Family of Schools.

"We're working with a development company to build a campus on a piece of land in Citrus Heights, and with the city's Planning Department as we go through the entitlements process."

"We want to get the word out there that we're here for the children of Orangevale and Citrus Heights," she said. "We're here for the kids."

## **Proposition 16 Promotes Racial Discrimination**

Commentary by Bill Bird, Parents and Students for Racial Equality

Parents and Students for Racial Equality in California is opposing a measure that would result in legal racial discrimination in California. Proposition 16, an initiative on this November's ballot, threatens to introduce institutionalized and legal race-based admissions in our public universities, as well as contracting and hiring policies in all California government settings.

"Although recent polling shows that this measure is struggling to gain traction with California voters, organizations opposed to racial discrimination must remain vigilant," said organization spokesman and former California State Senate Minority Leader Bob Huff. "Proposition 16 represents a step backwards to the darkest days of this country, when racial discrimination was openly tolerated and encouraged. This is contrary to the fundamental principles upon which this nation was built and for which so many fought to secure. The Declaration of Independence tells us all men are created equal. Proposition 16 tells us that some are more equal and deserving than others."

Proposition 16 would allow supporters to impose across the board, racial guidelines for all California public school and public university admissions and settings. It would also allow schools, colleges and other government agencies to discriminate in employment, promotions and contracting. The measure seeks to overturn Proposition 209, which appeared on the November 1996 ballot and passed with a strong 54 percent majority in support. Proposition 209 amended the state constitution to prohibit state government institutions from considering race, sex, or ethnicity, specifically in the areas of public employment, public contracting or public education.

Recent polling conduction by the Public Policy Institute of California (PPIC) revealed that barely one-third of the state's voters appear to support the idea of racial discrimination. Nearly half are opposed to the proposal and some remain unopposed. A second poll conducted by the Berkeley Institute of Governmental Studies divulged nearly identical findings.

"No person in California should ever be told that they cannot be admitted to a university or not awarded a job or contract because they are the wrong color or sex," said Huff. "Discriminating on the basis of race, color, sex or religion represents the darkest part of California's history. Measures like Proposition 16 only serve to divide our state at a time when everyone is needed to work together to heal wounds and create a brighter future.'

Parents and Students for Racial Equality is an organization that fights for the rights of all California citizens, regardless of race or color, and believes that government must judge all people equally, without discrimination.



However, Sacramento County Public Health has important guidance to help ensure safer trick-ortreating for everyone to reduce the risk of spreading COVID-19. Follow the guidance below to have a fun and safe Halloween!

#### **FACE COVERINGS**

Firstly, you will need to wear a face-covering – so why not make it fun! Have your child select their own face covering, and then decorate it together to match their costume.

#### SOCIAL DISTANCING

When you are out trickor-treating, travel only with your household members (don't forget – wear your face covering), be sure to maintain 6 feet of social distance from others, and make interactions brief with others outside your household.

#### **HYGIENE**

Keep from transferring the virus with your hands. When you touch objects or your face, the virus may be lurking, so wash your ity. In an outdoor area, such hands often and have hand sanitizer handy. Be sure to clean/disinfect hightouch surfaces. Also, have everyone wait to dig into the candy until hands are clean before unwrapping the candy, and then again before eating the candy. Do not share costume props or food. And, of course, if you feel sick or could be contagious, you must stay home and away from others.
